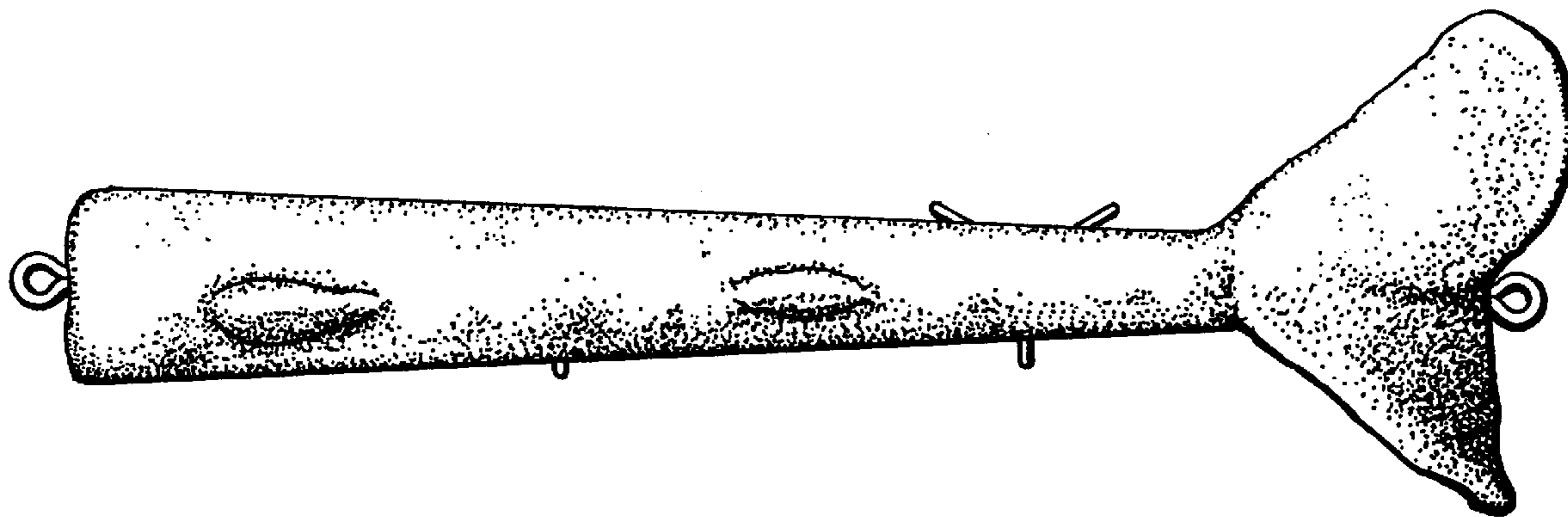
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a top plan view of a fishing lure, showing my new design;

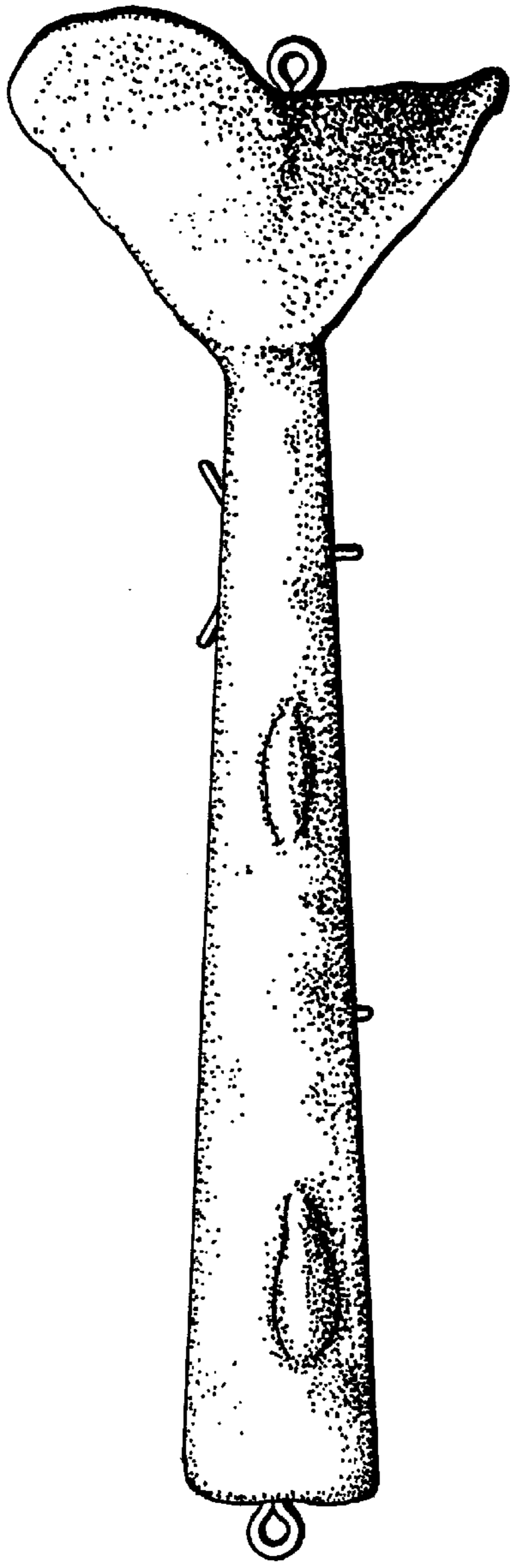

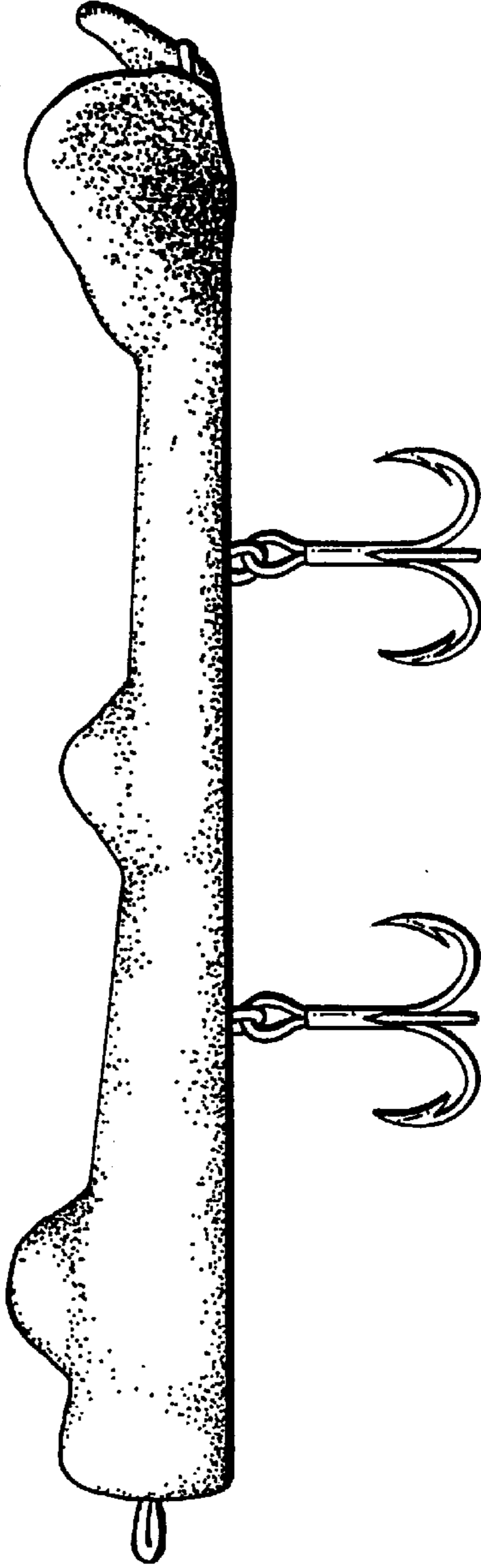

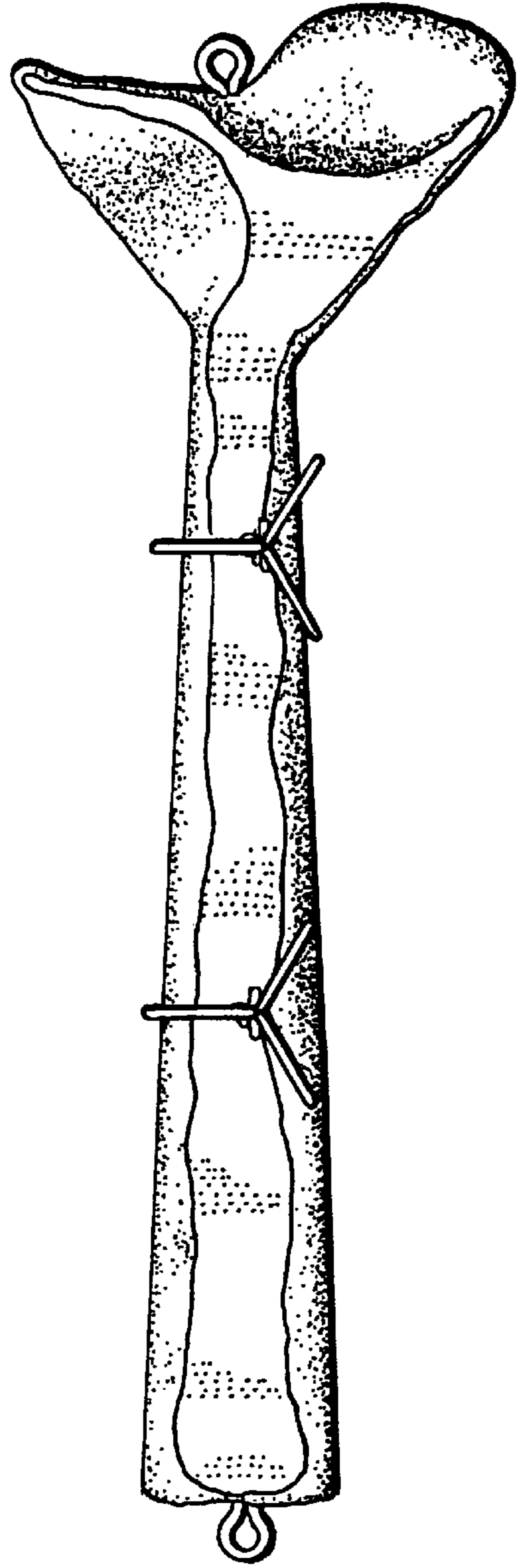

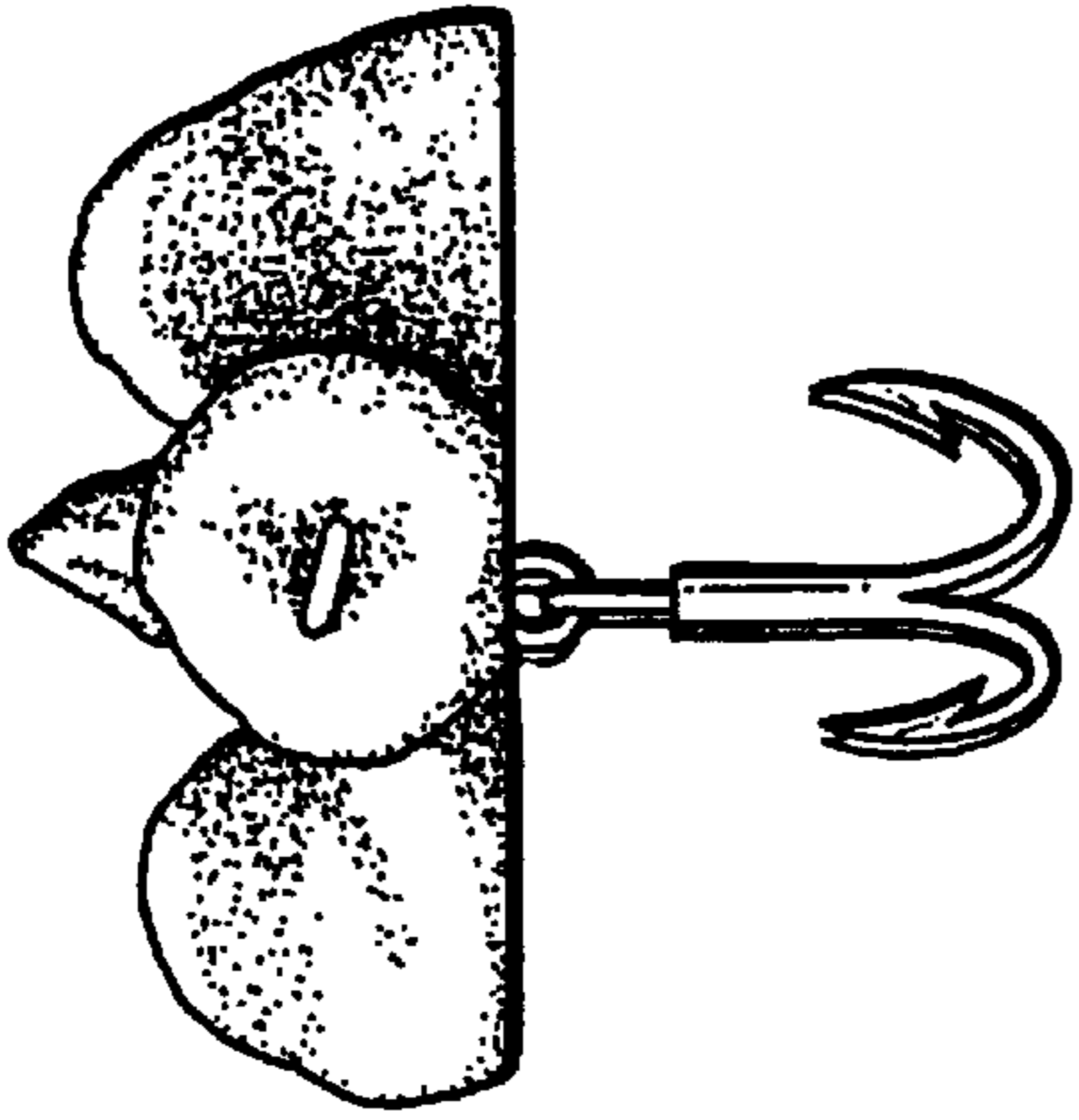

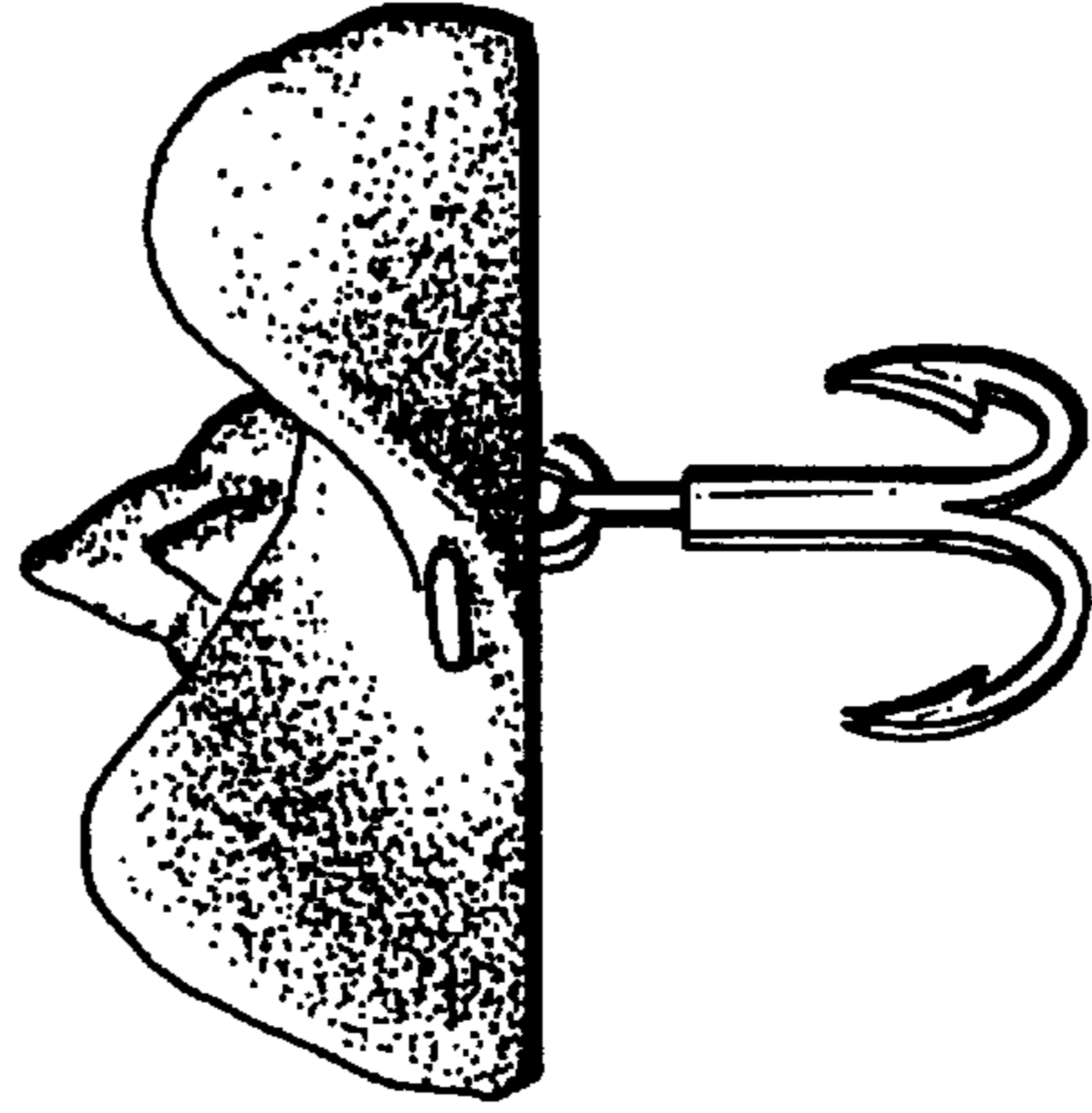

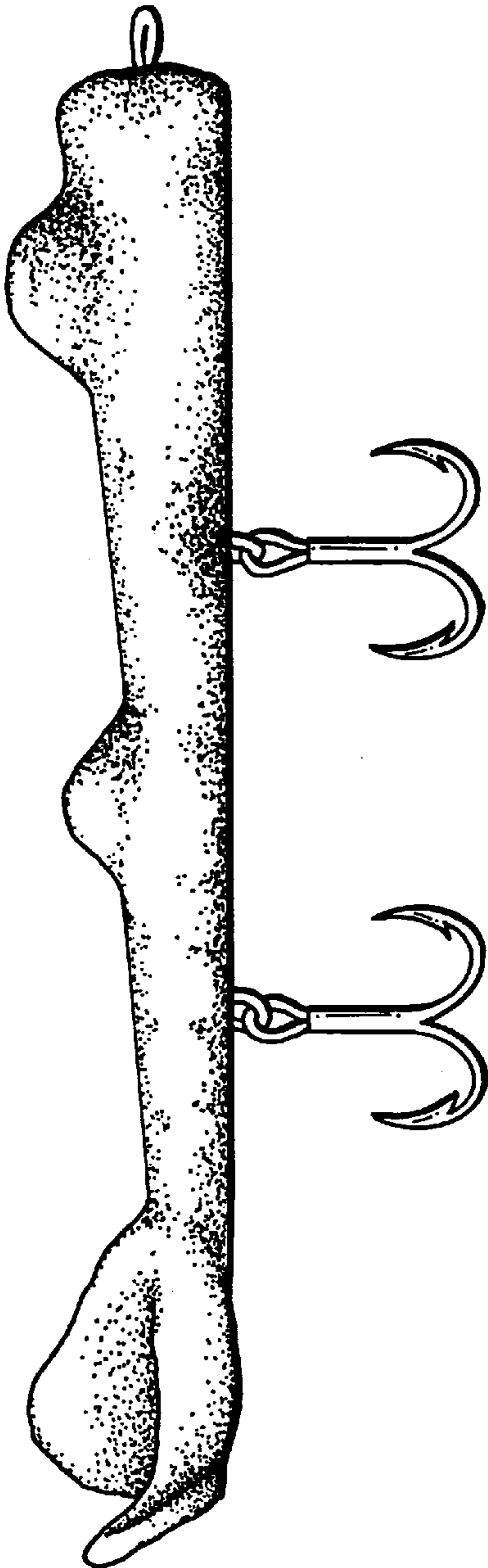
