DESCRIPTION

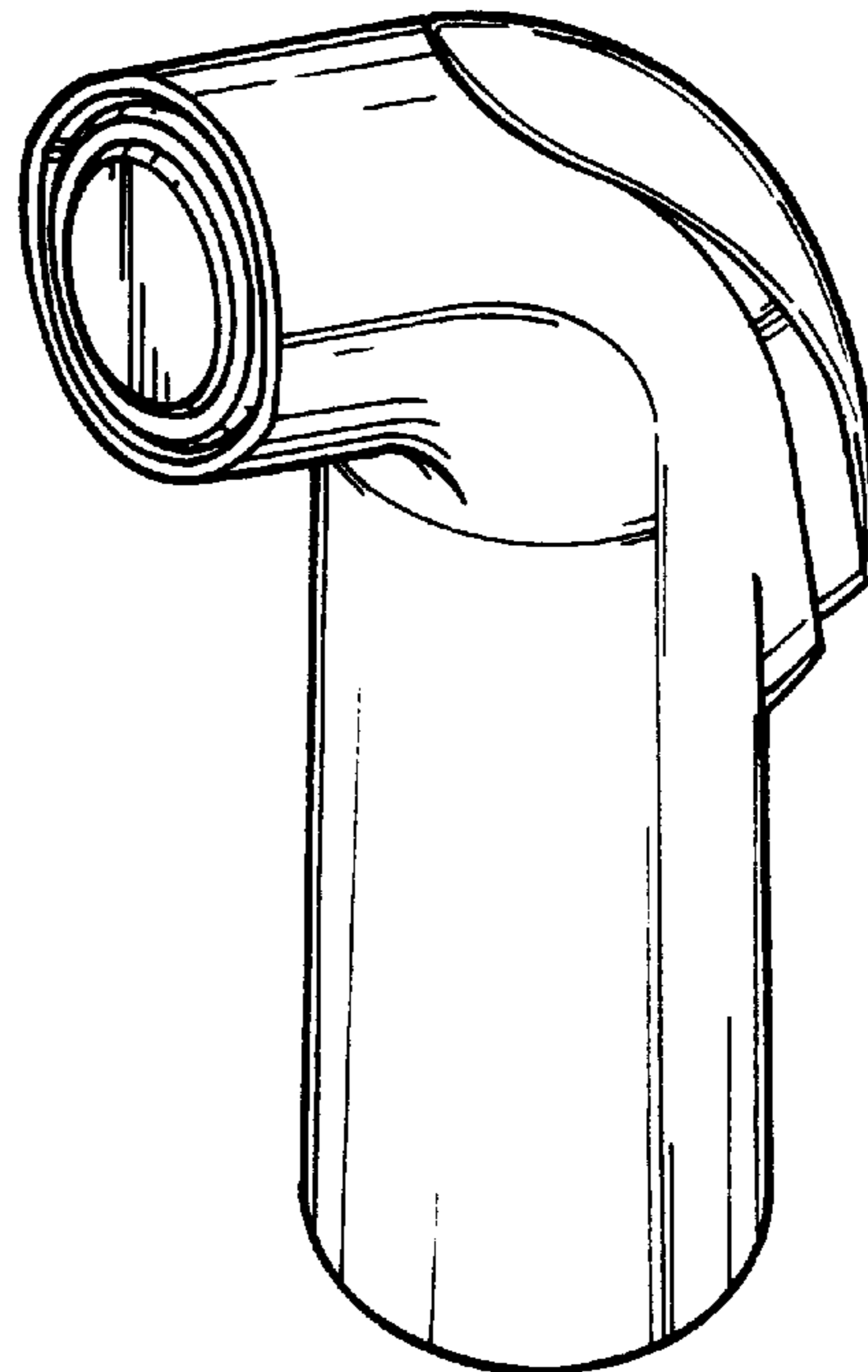
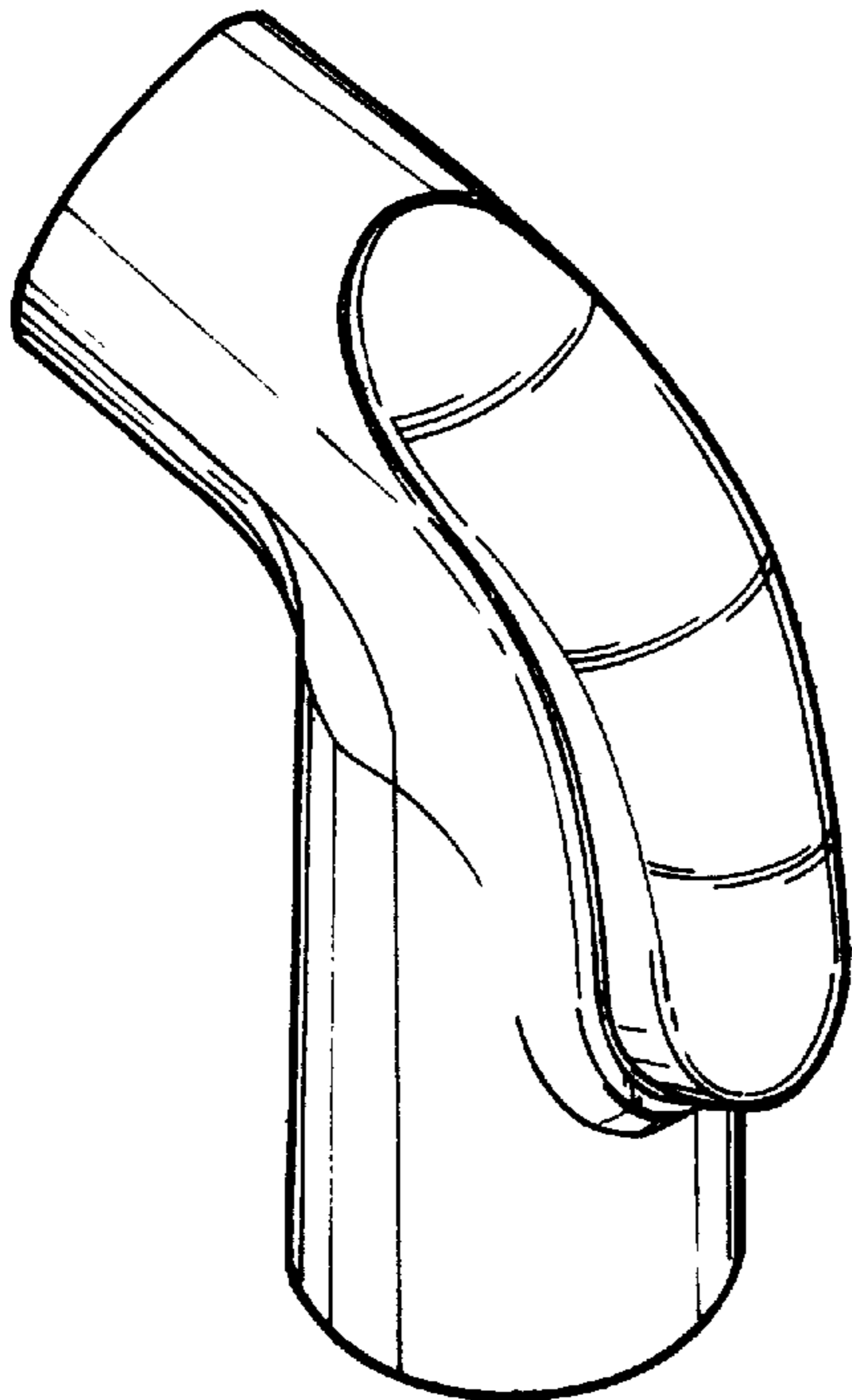
FIG. 1 is a rear perspective view of a spray head showing our new design;

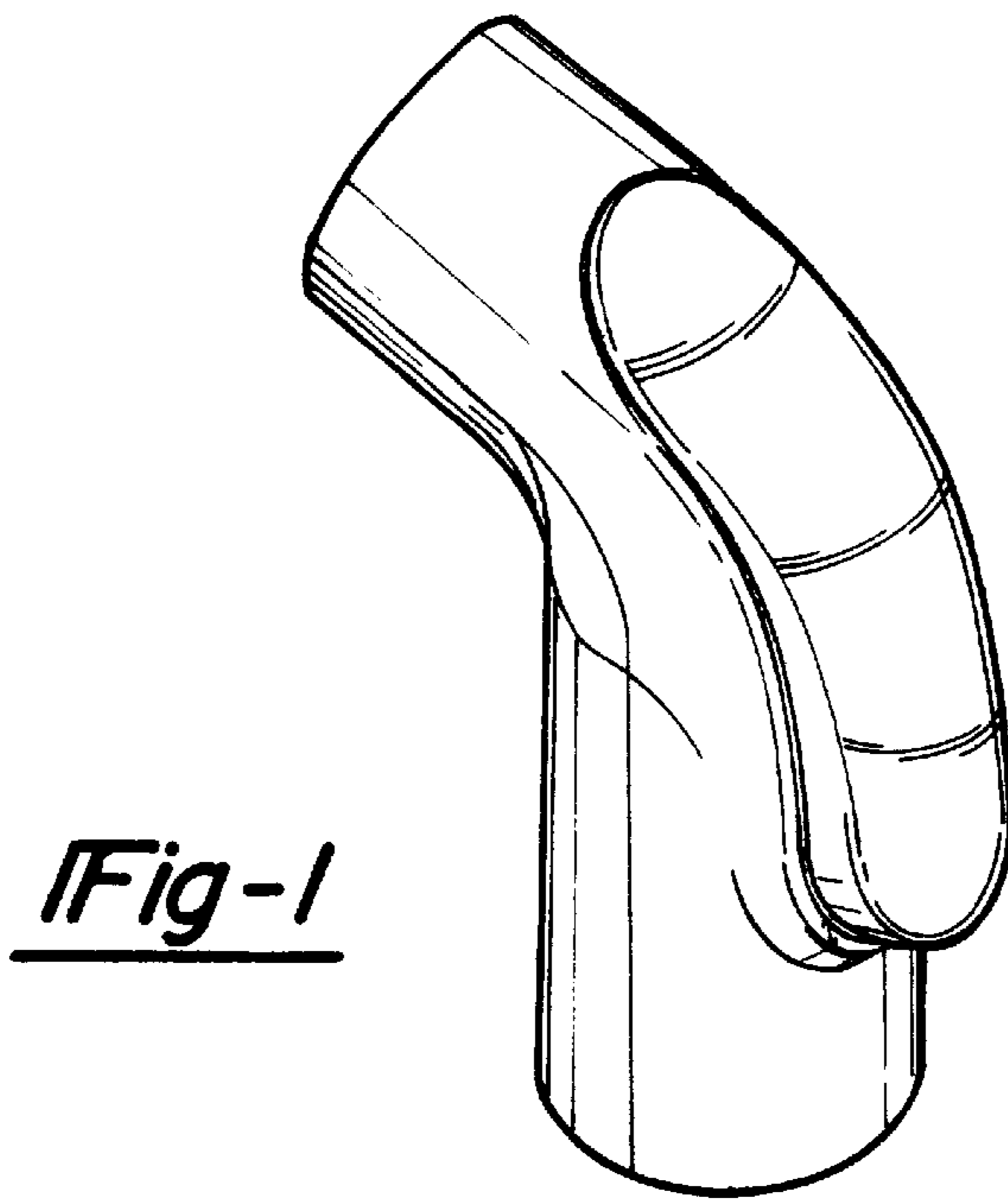

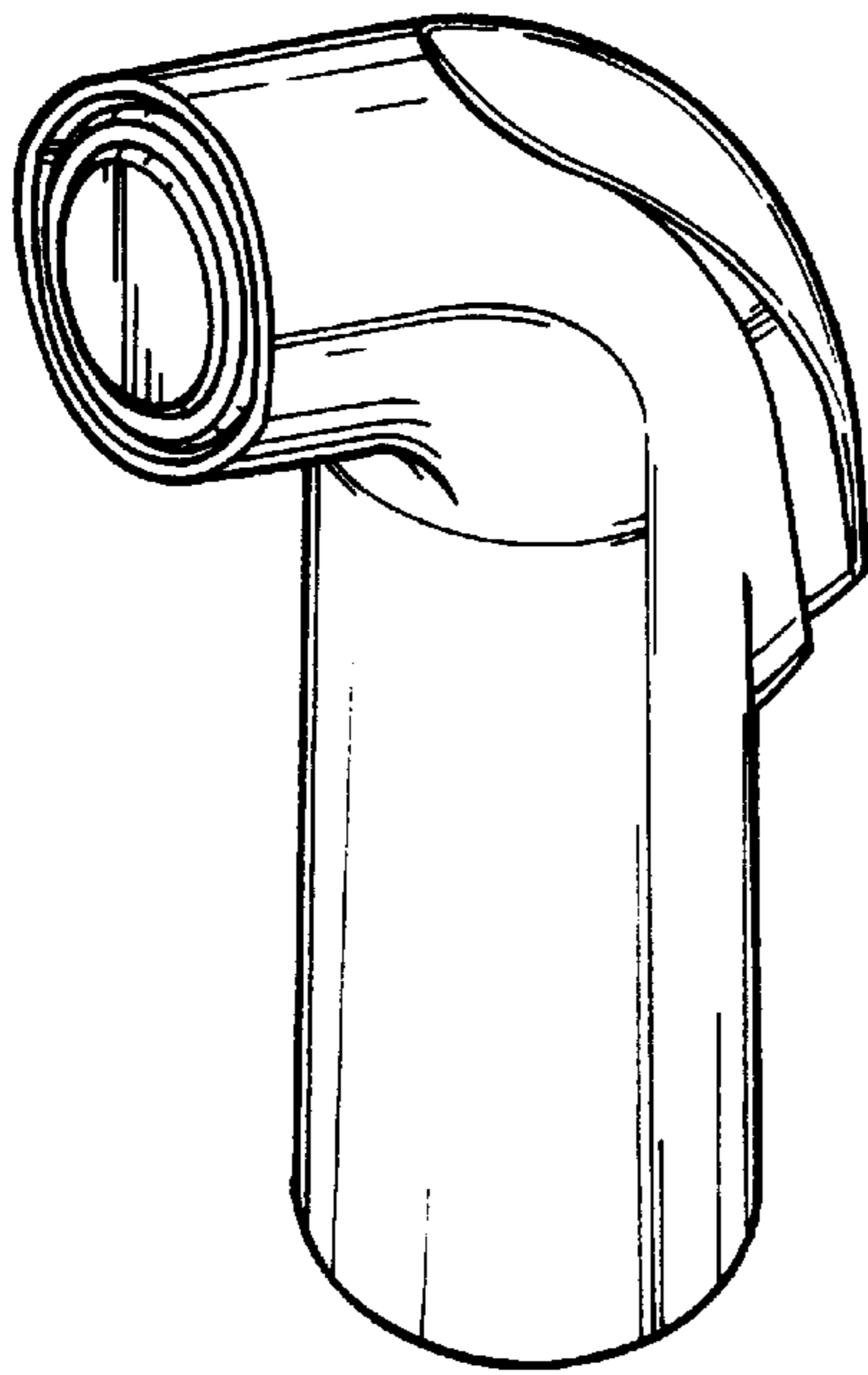

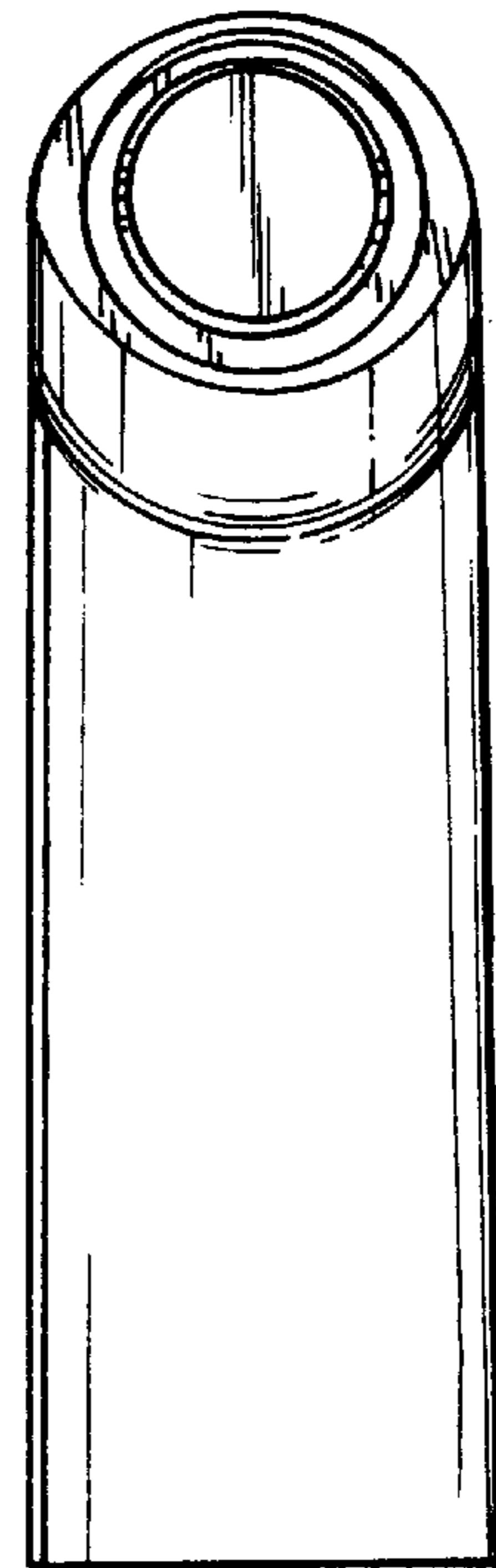

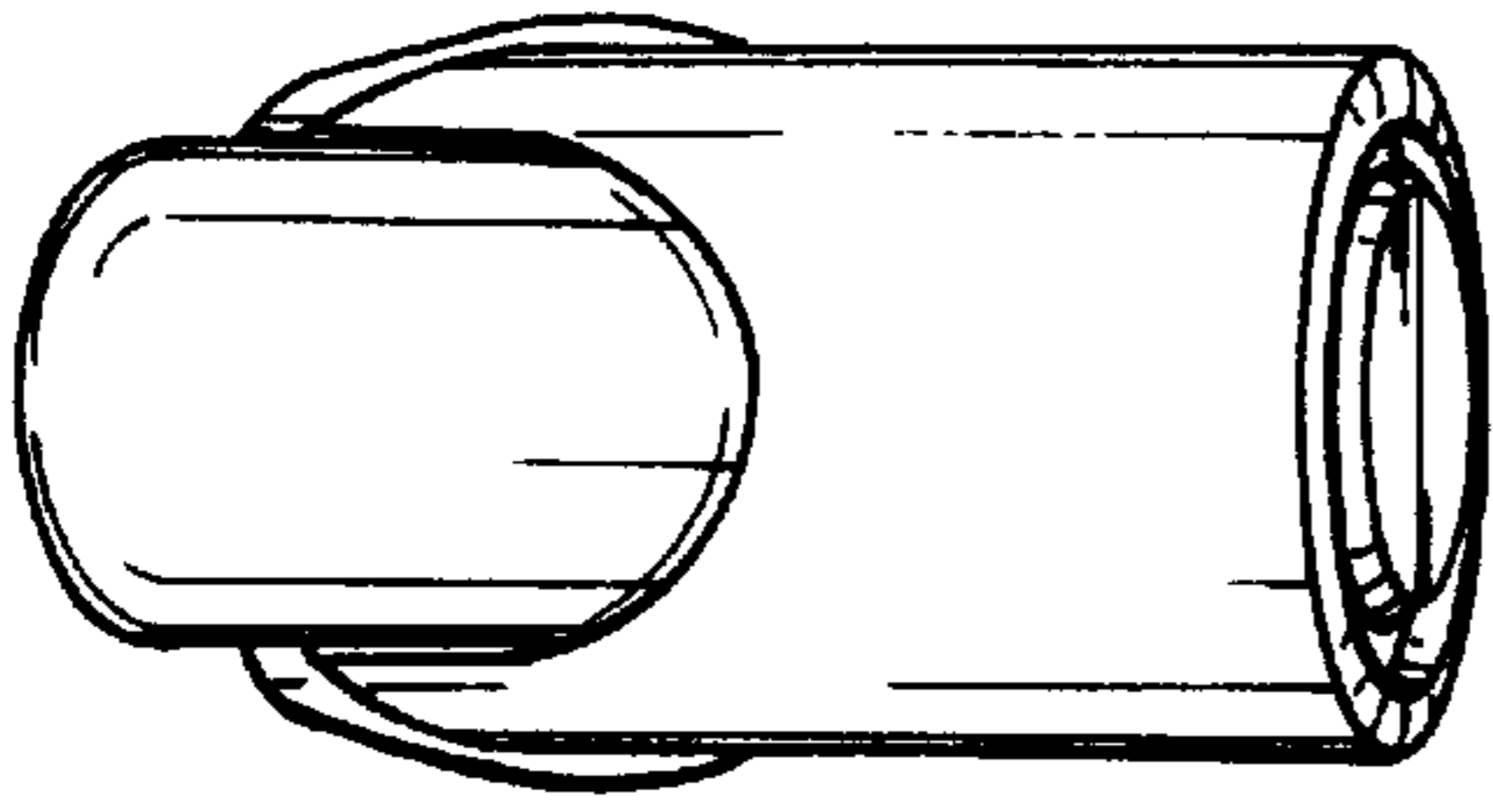

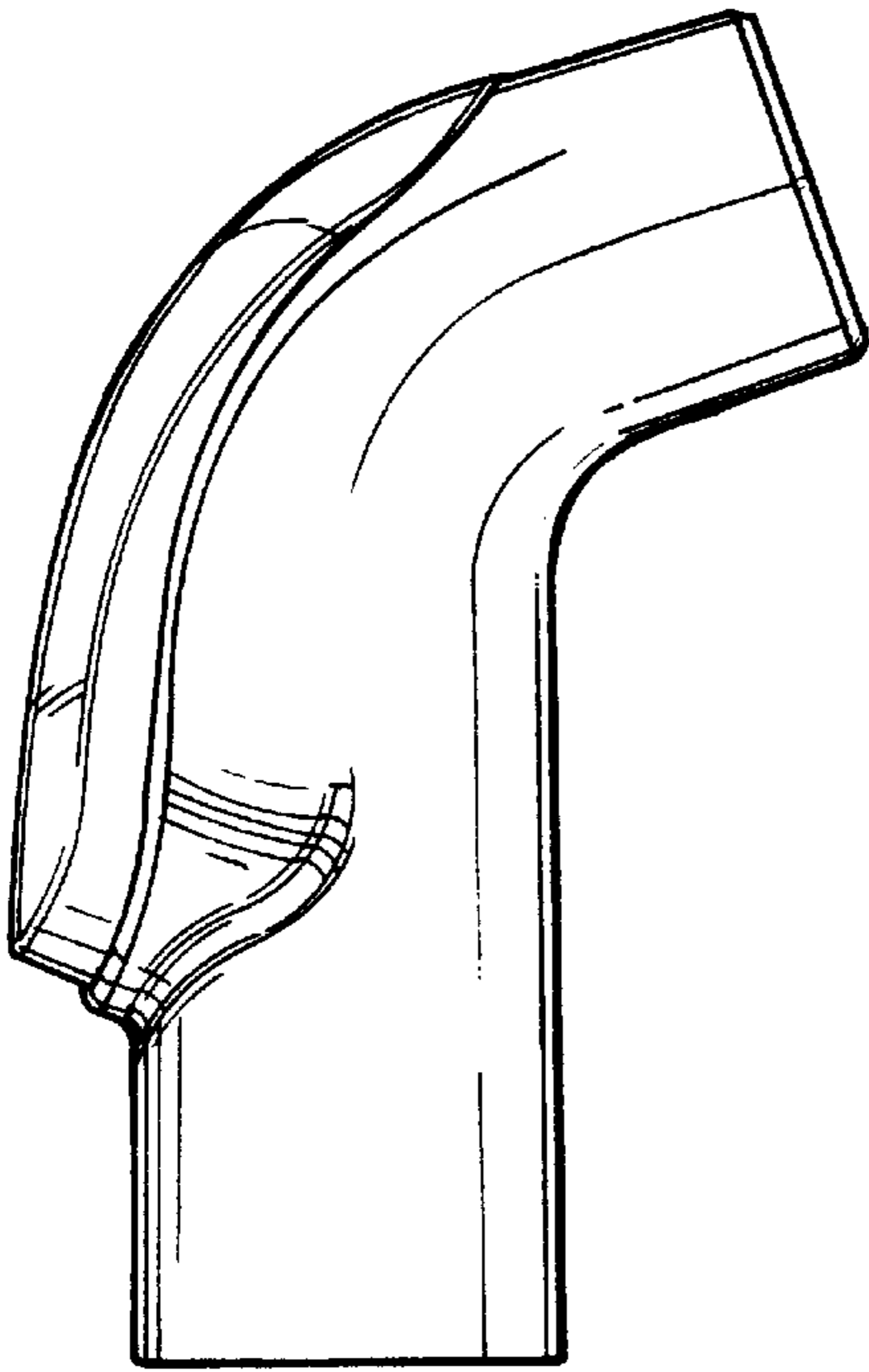

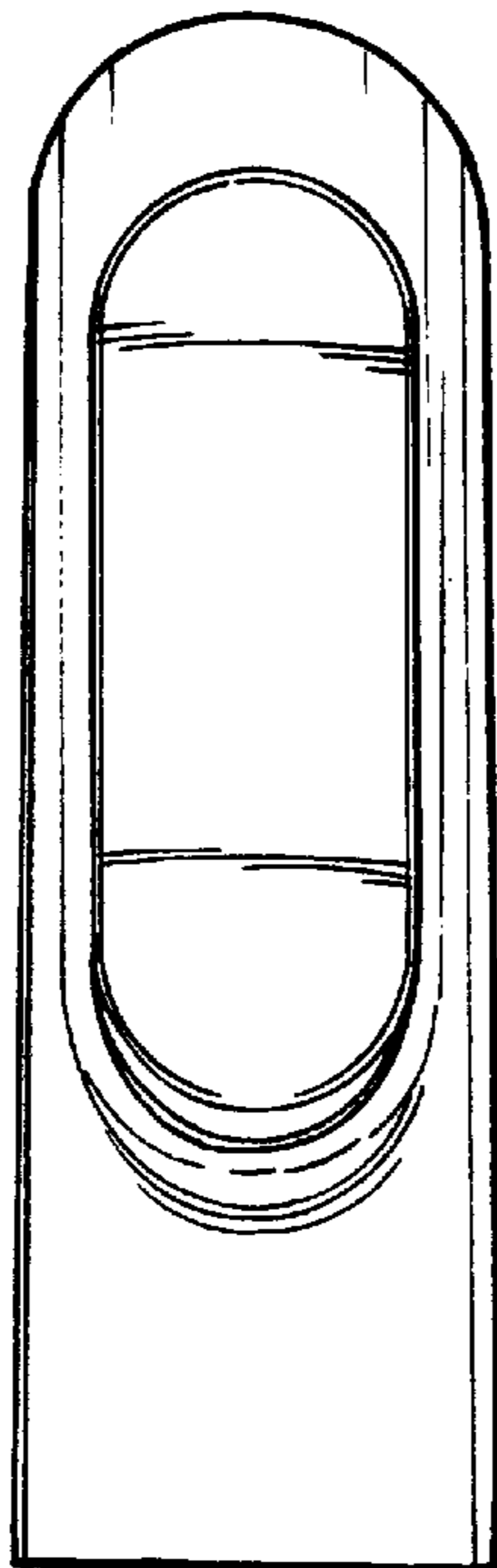

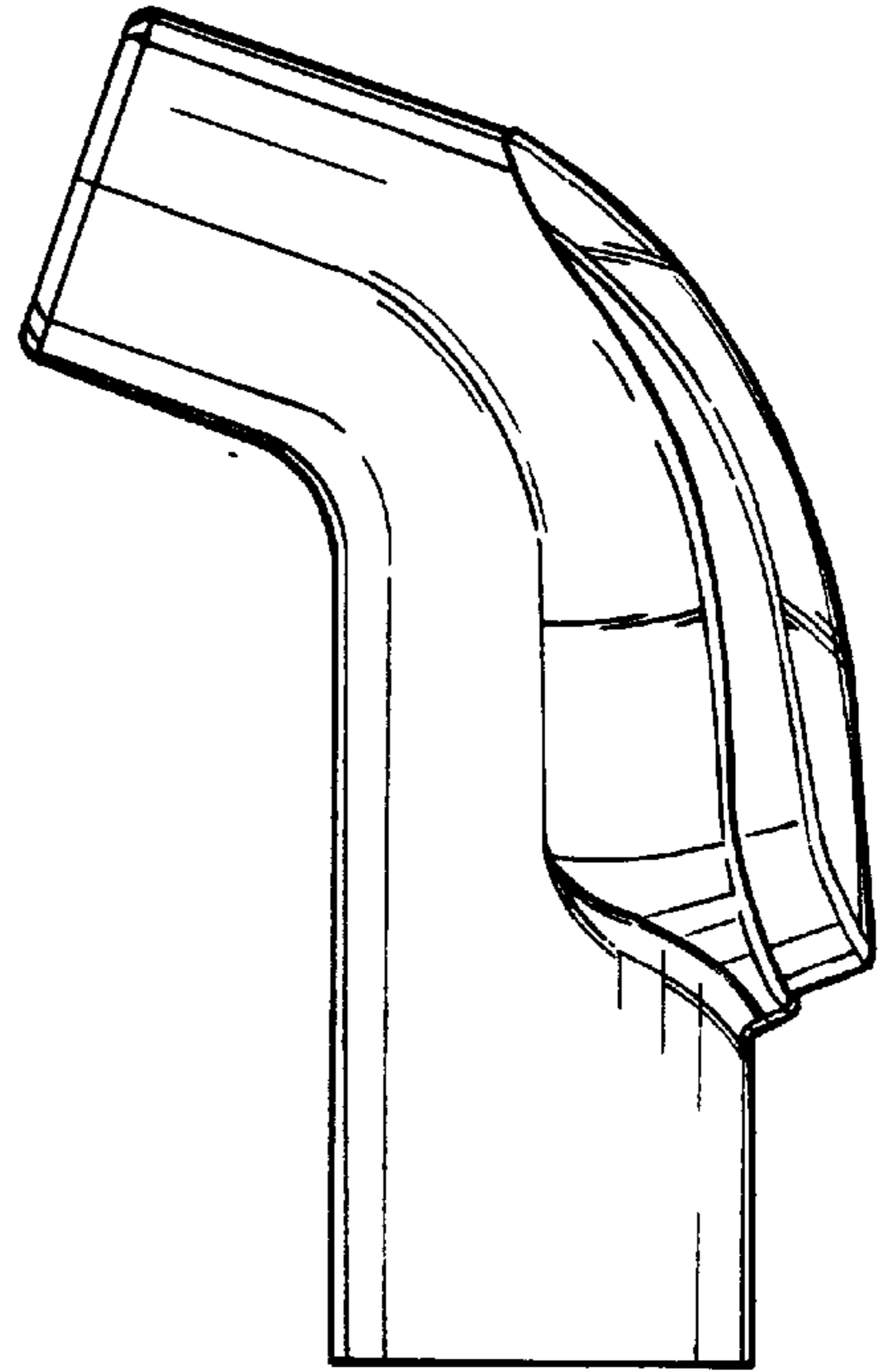
