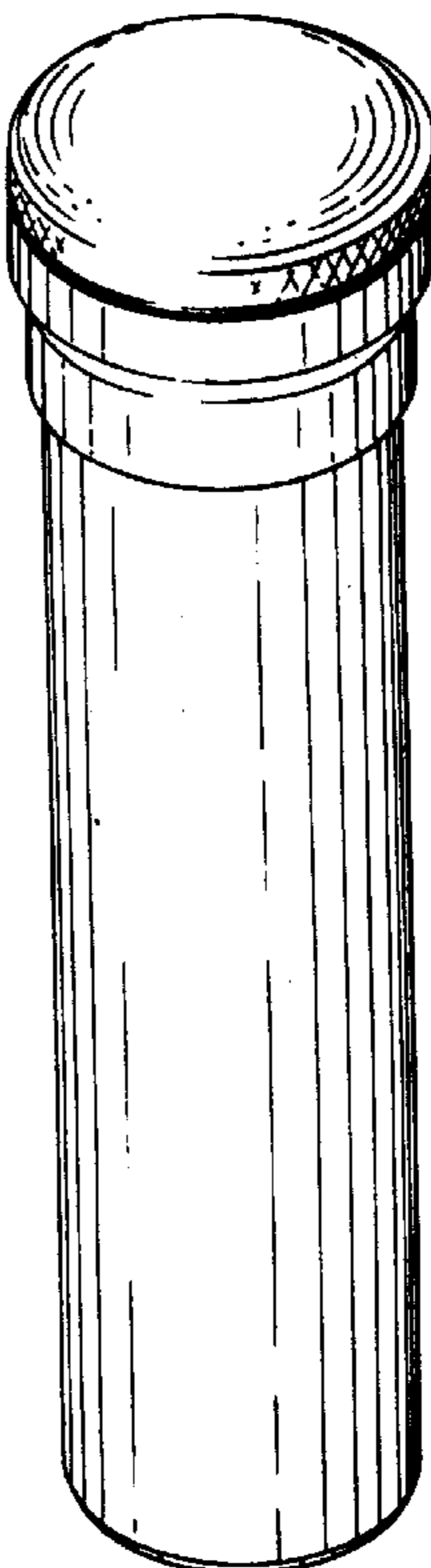
[57] CLAIM

I claim the ornamental design for a humidor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the humidor;
FIG. 2 is a perspective view of the humidor with the cap removed;
FIG. 3 is a side elevation view of the humidor, all other side elevation views being identical;
FIG. 4 is a side elevation view of the humidor with the cap removed;
FIG. 5 is a top plan view of the humidor;
FIG. 6 is a bottom plan view of the humidor; and,
FIG. 7 is a bottom plan view of the cap of the humidor.

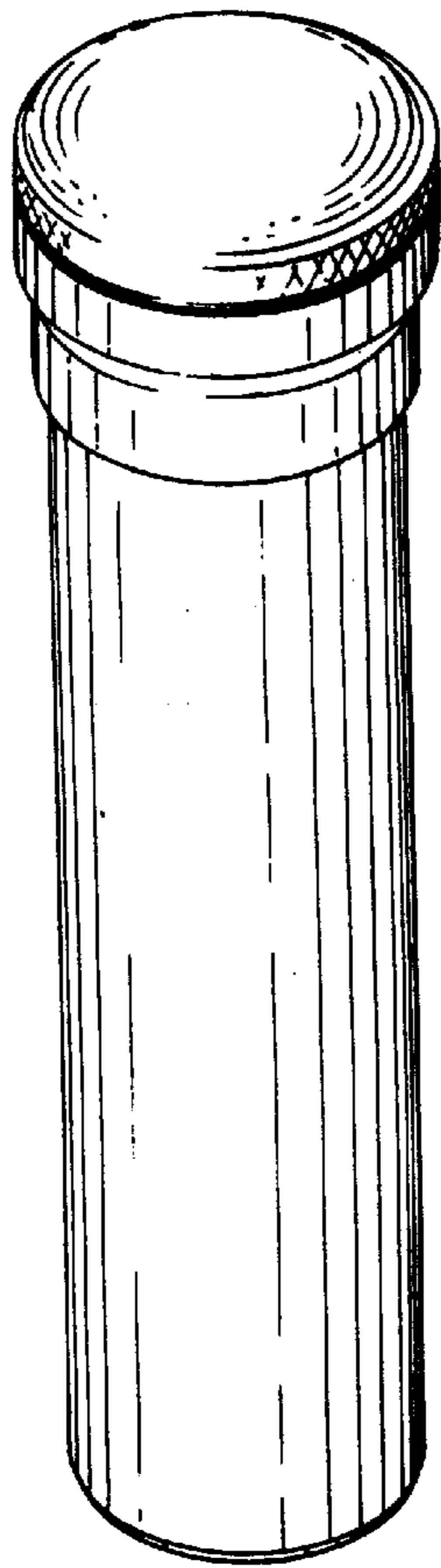

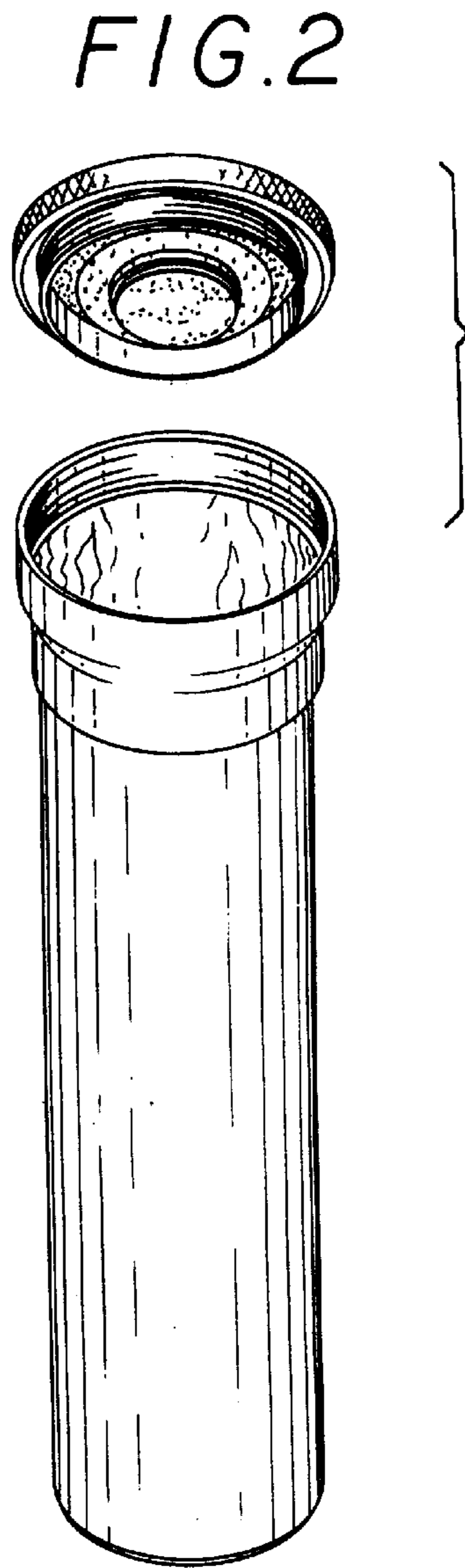

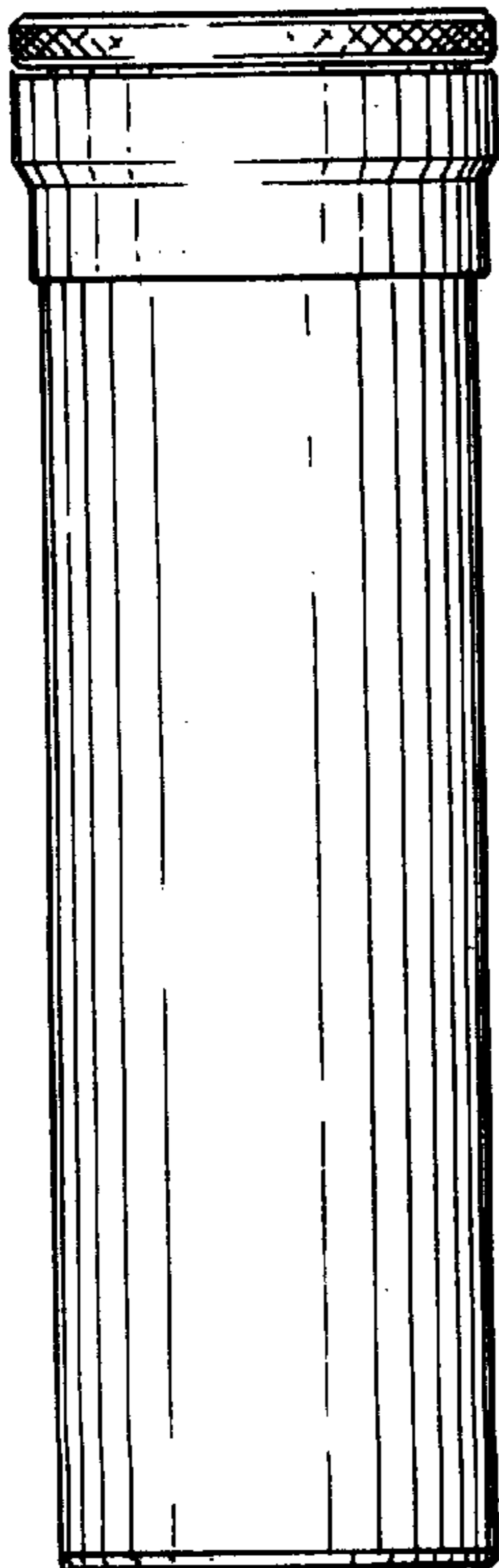

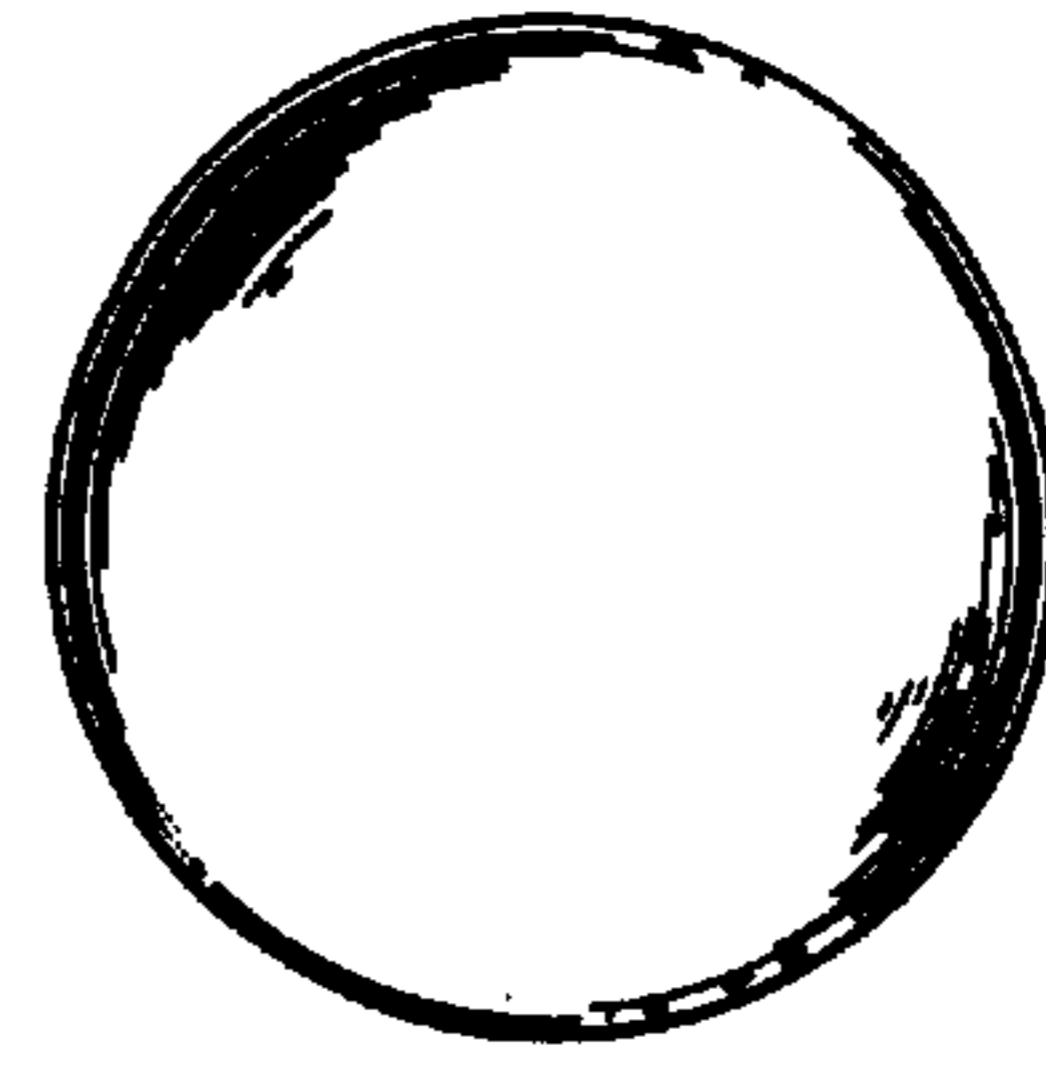
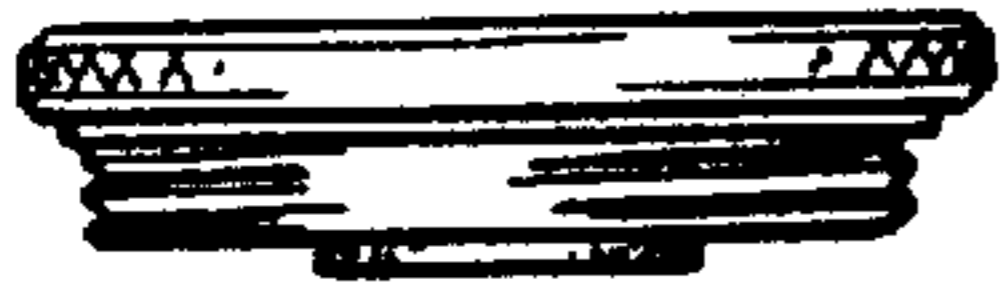

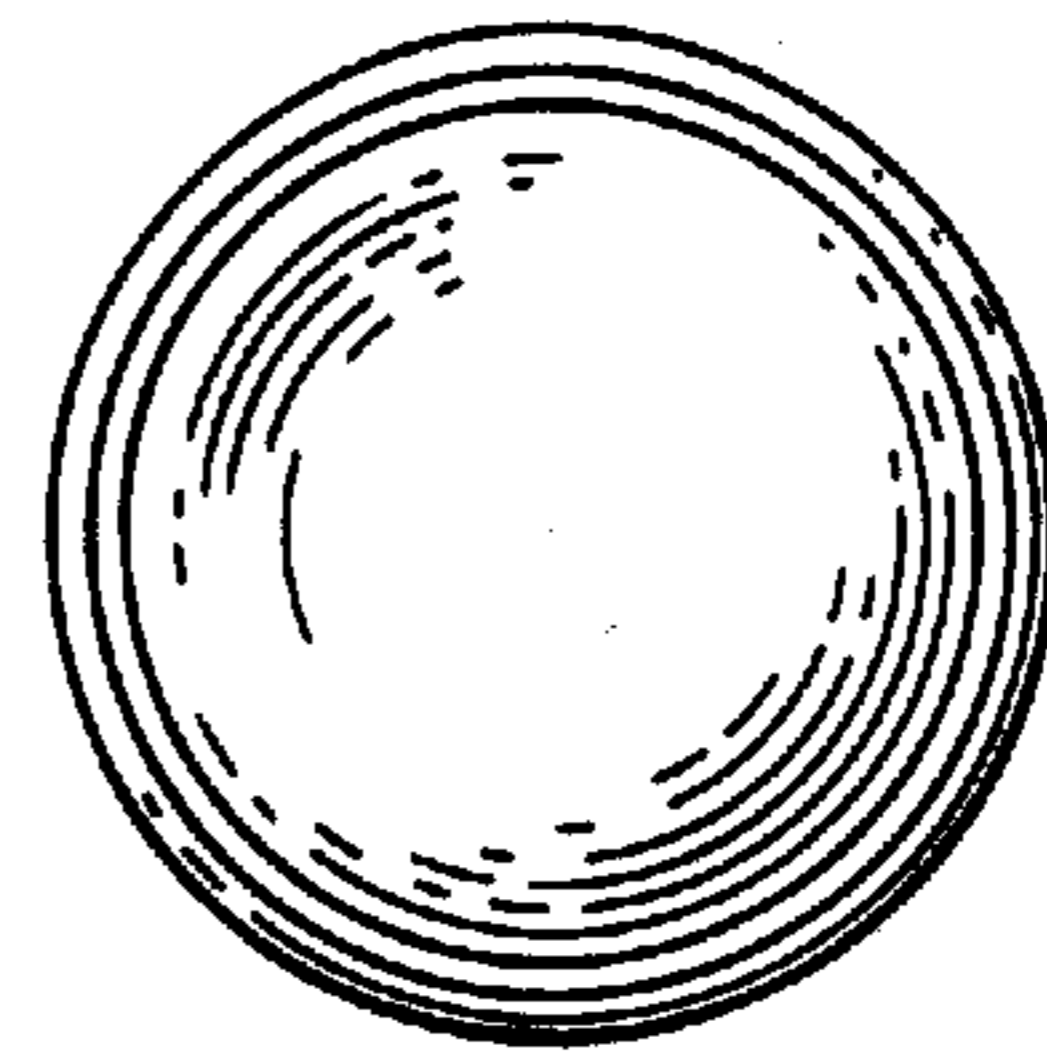
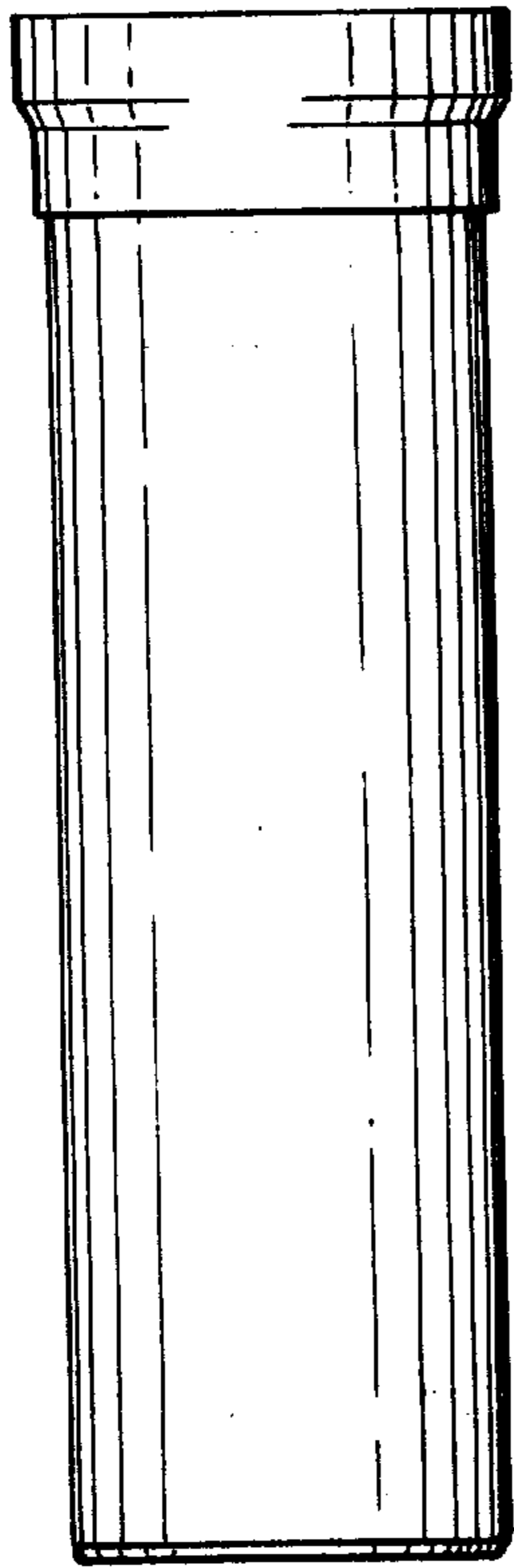
