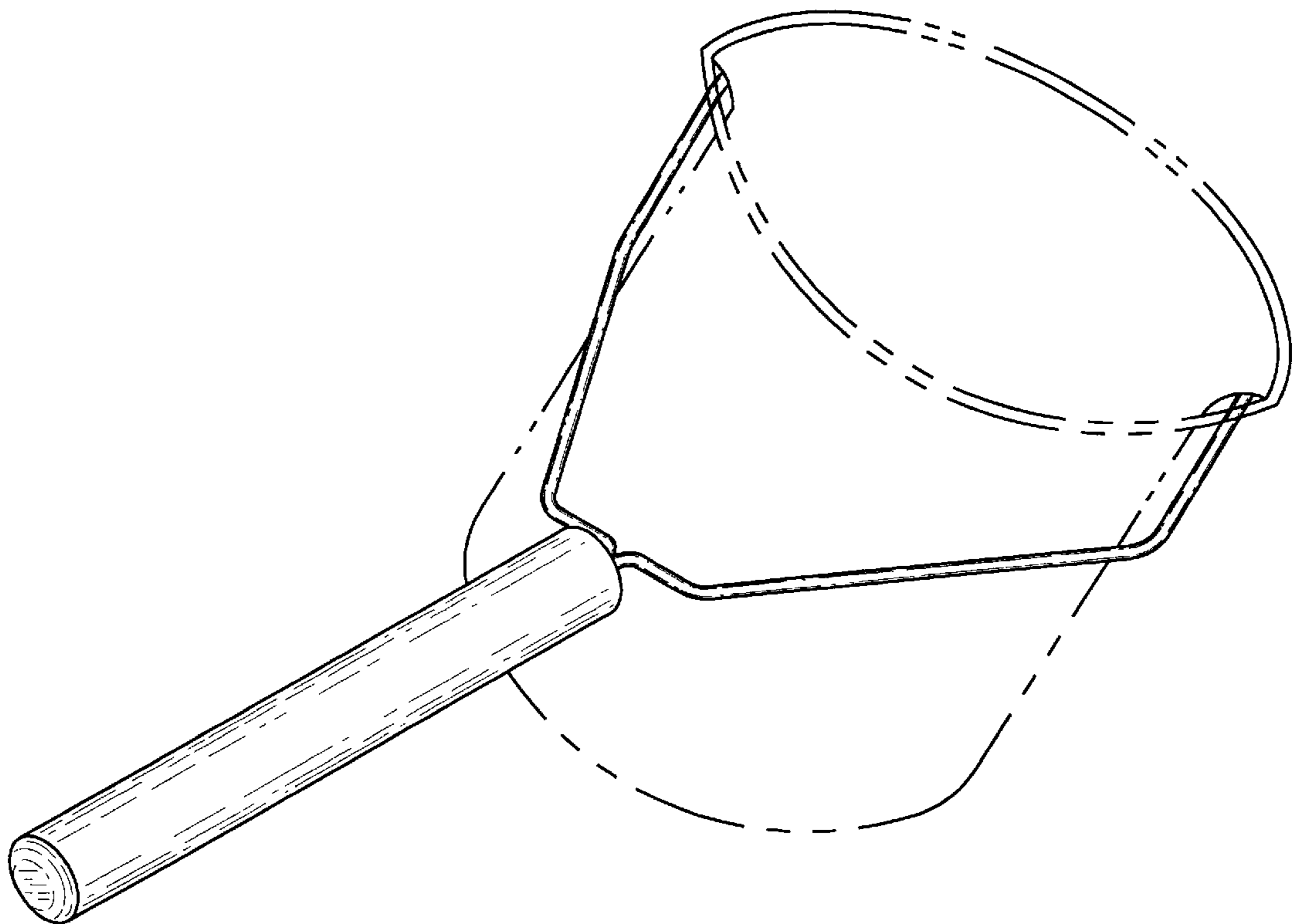
[57] **CLAIM**

The ornamental design for a sanitary animal waste collection bag holder, as shown.

DESCRIPTION

FIG. 1 is a top plan view of a sanitary animal waste collection bag holder showing my new design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a top, rear and left side perspective view thereof. The broken lines showing a bag in FIG. 7 are for illustrative purposes only and form no part of the claimed design.

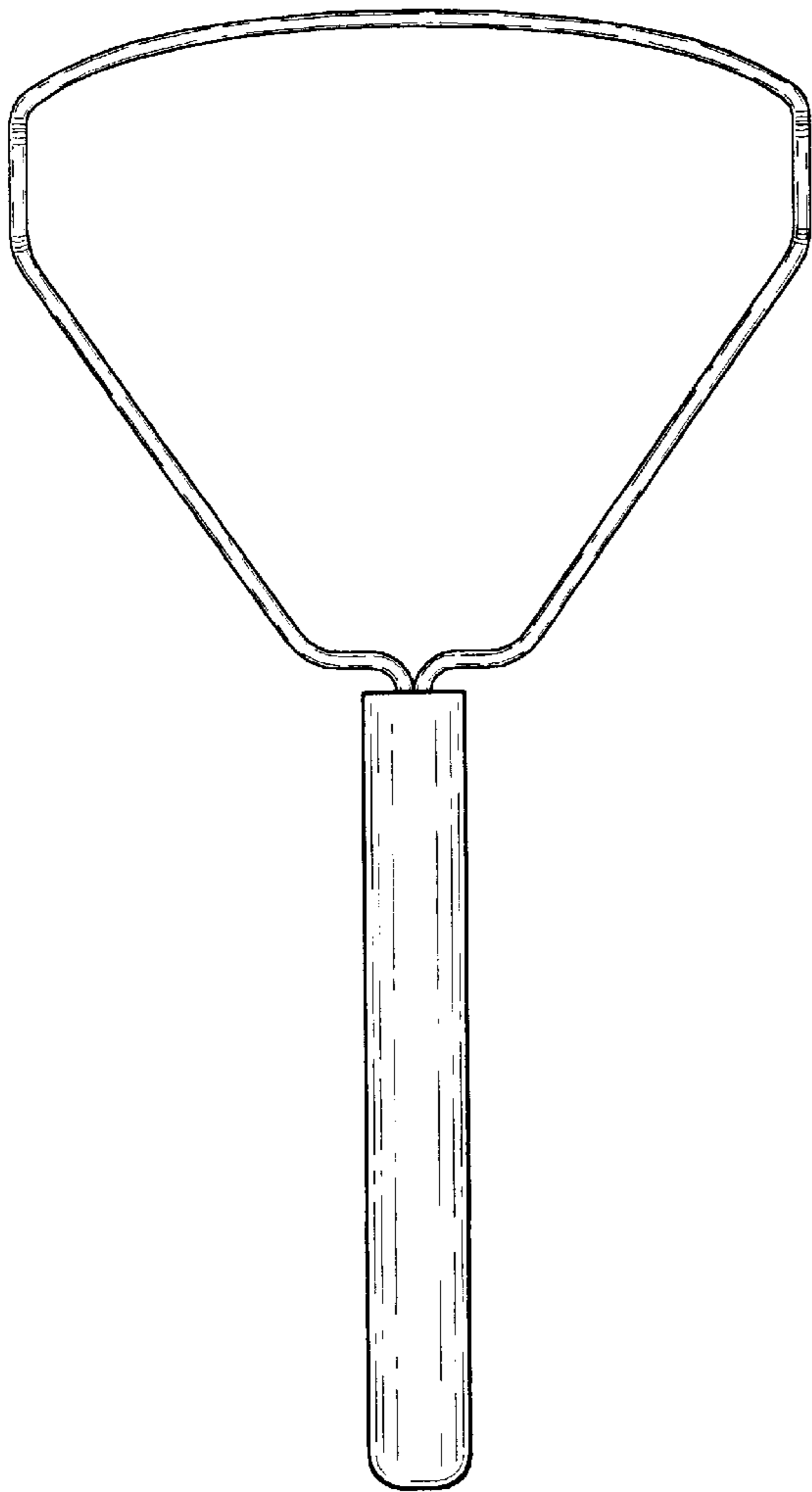

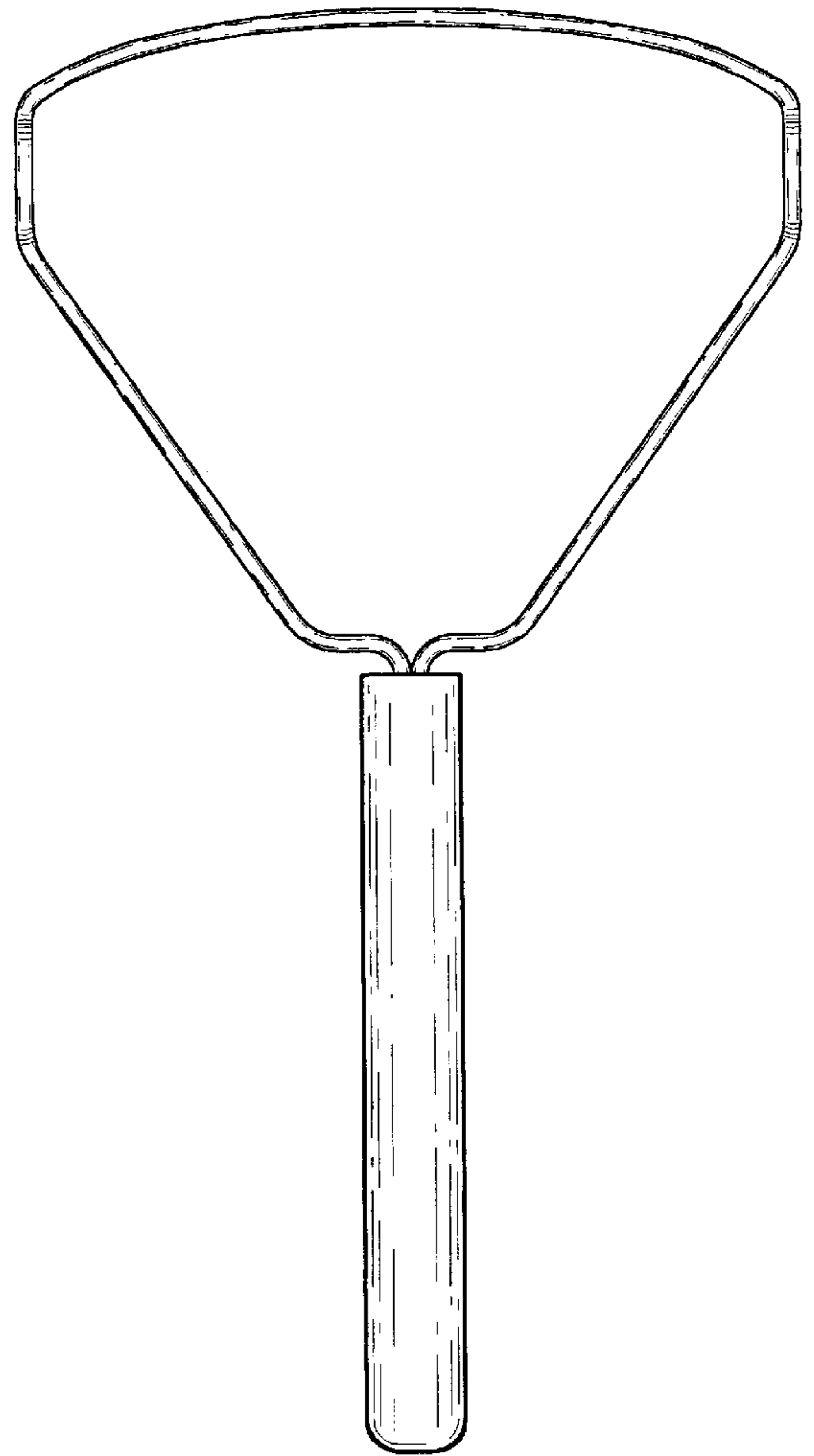

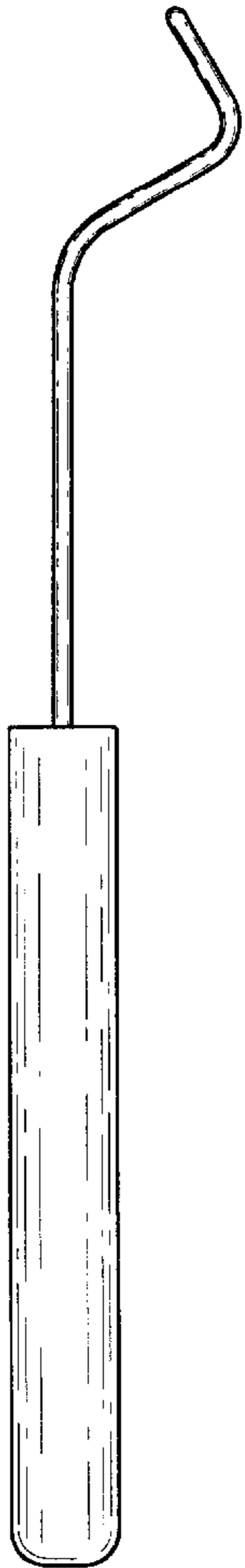

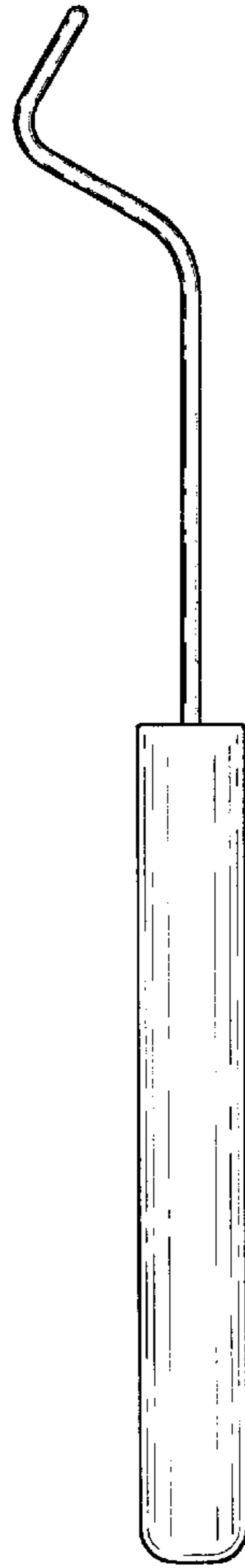

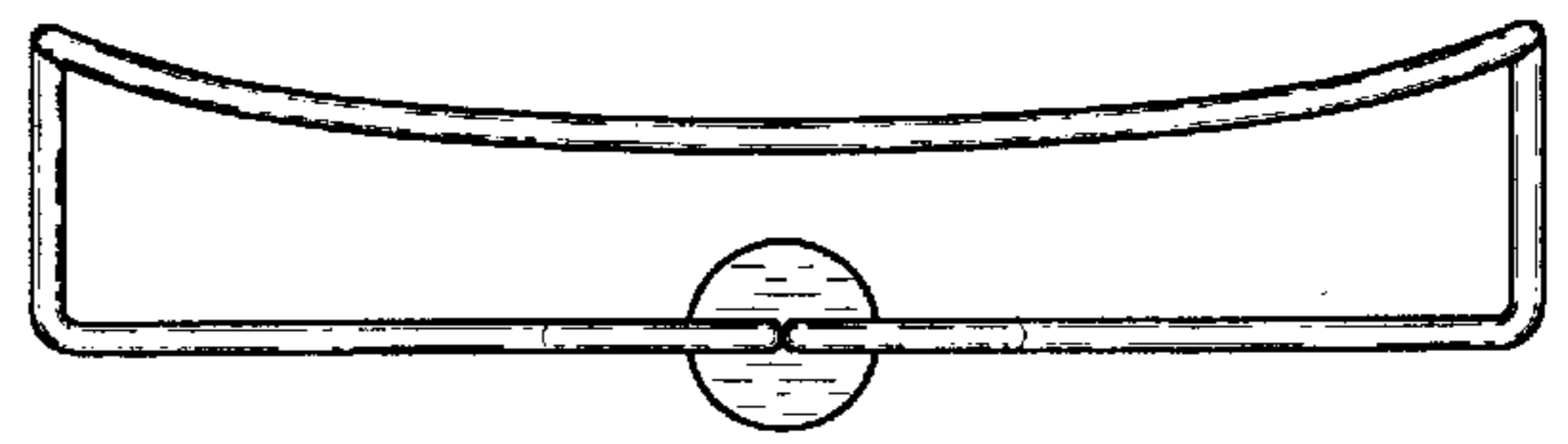

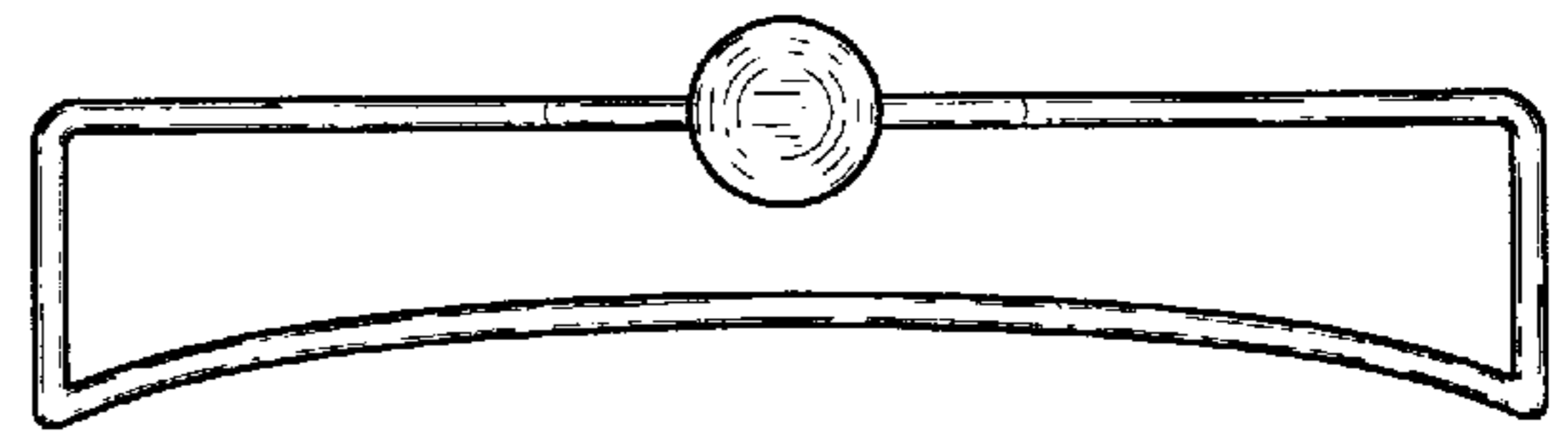

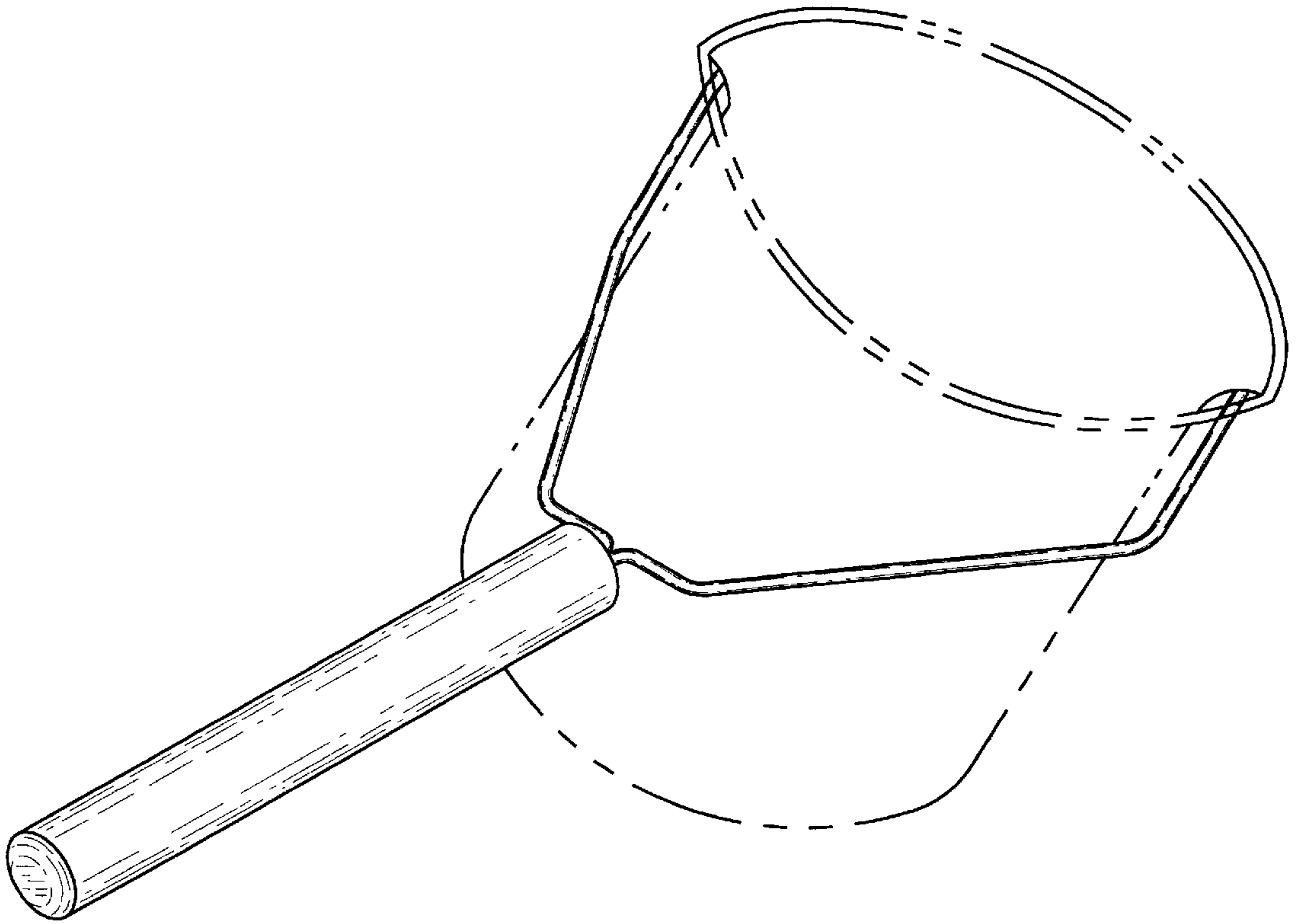
