The ornamental design for a handle for a vacuum cleaner, as shown.

### DESCRIPTION

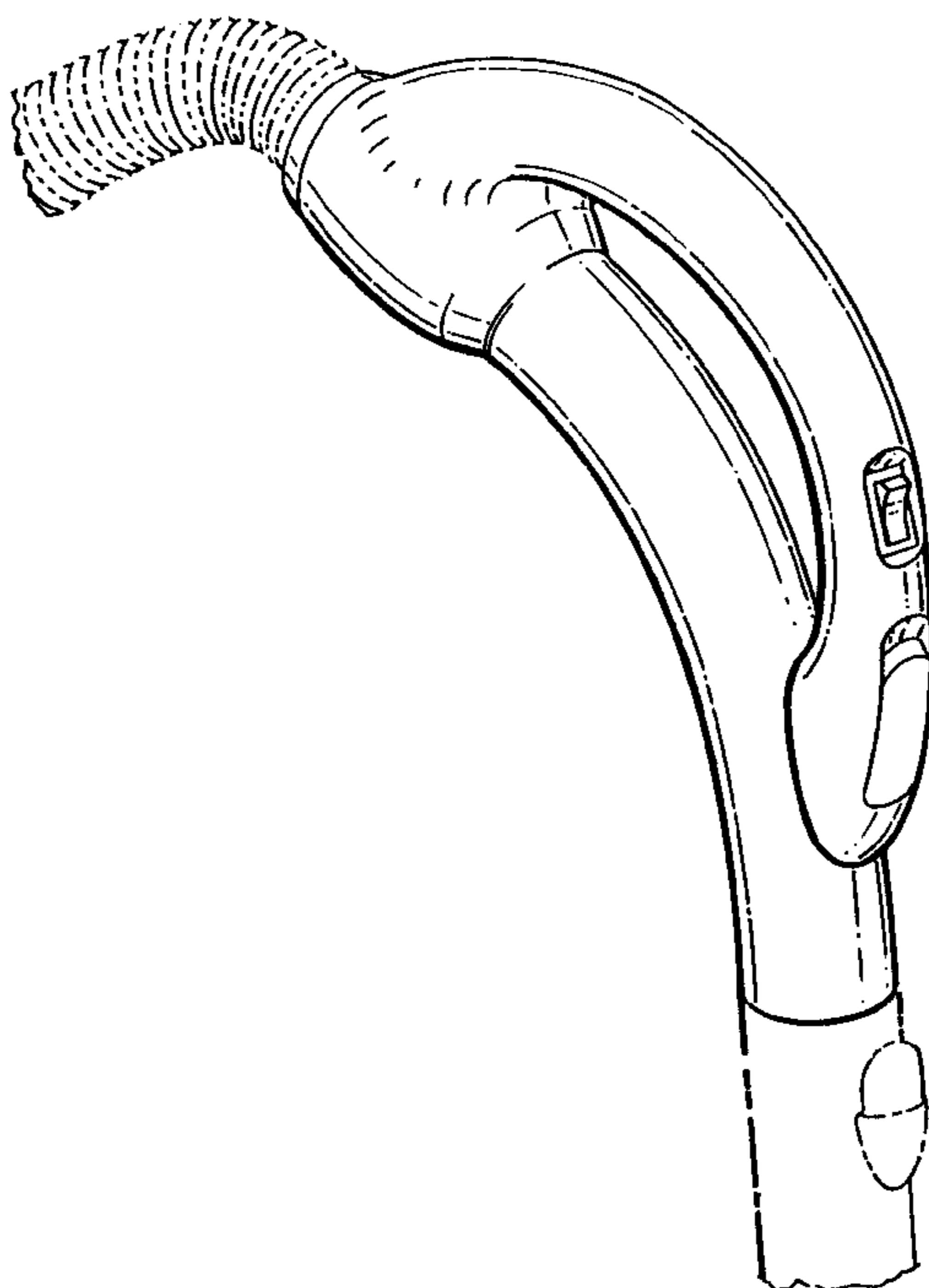
FIG. 1 is a front and side perspective view of a handle for a vacuum cleaner showing our new design;  
FIG. 2 is a side elevational view thereof, the opposite side being a mirror image;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.  
The details shown in broken lines on either side of the handle in FIG. 1 are shown for illustrative purposes only and form no part of the claimed design.

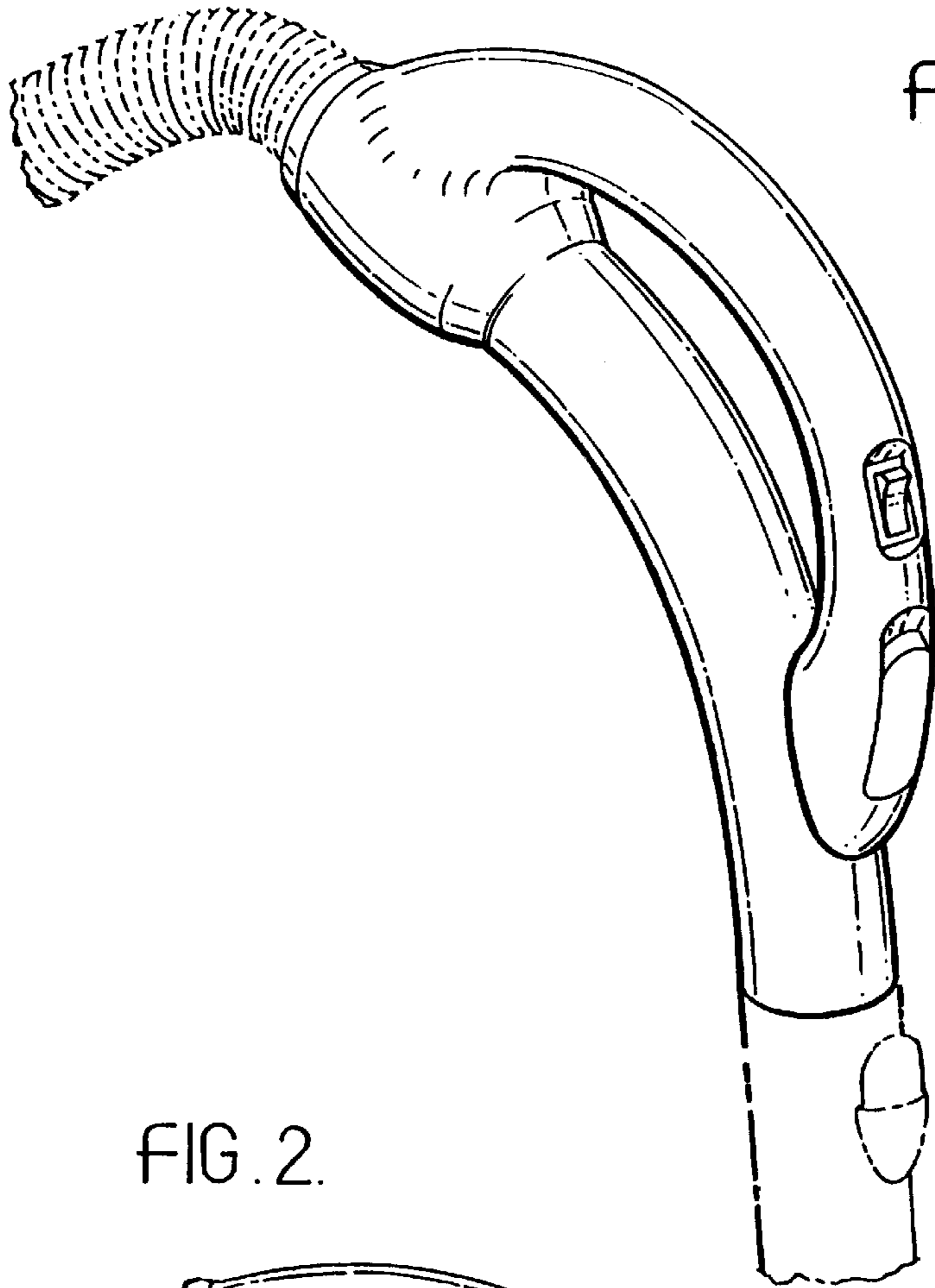

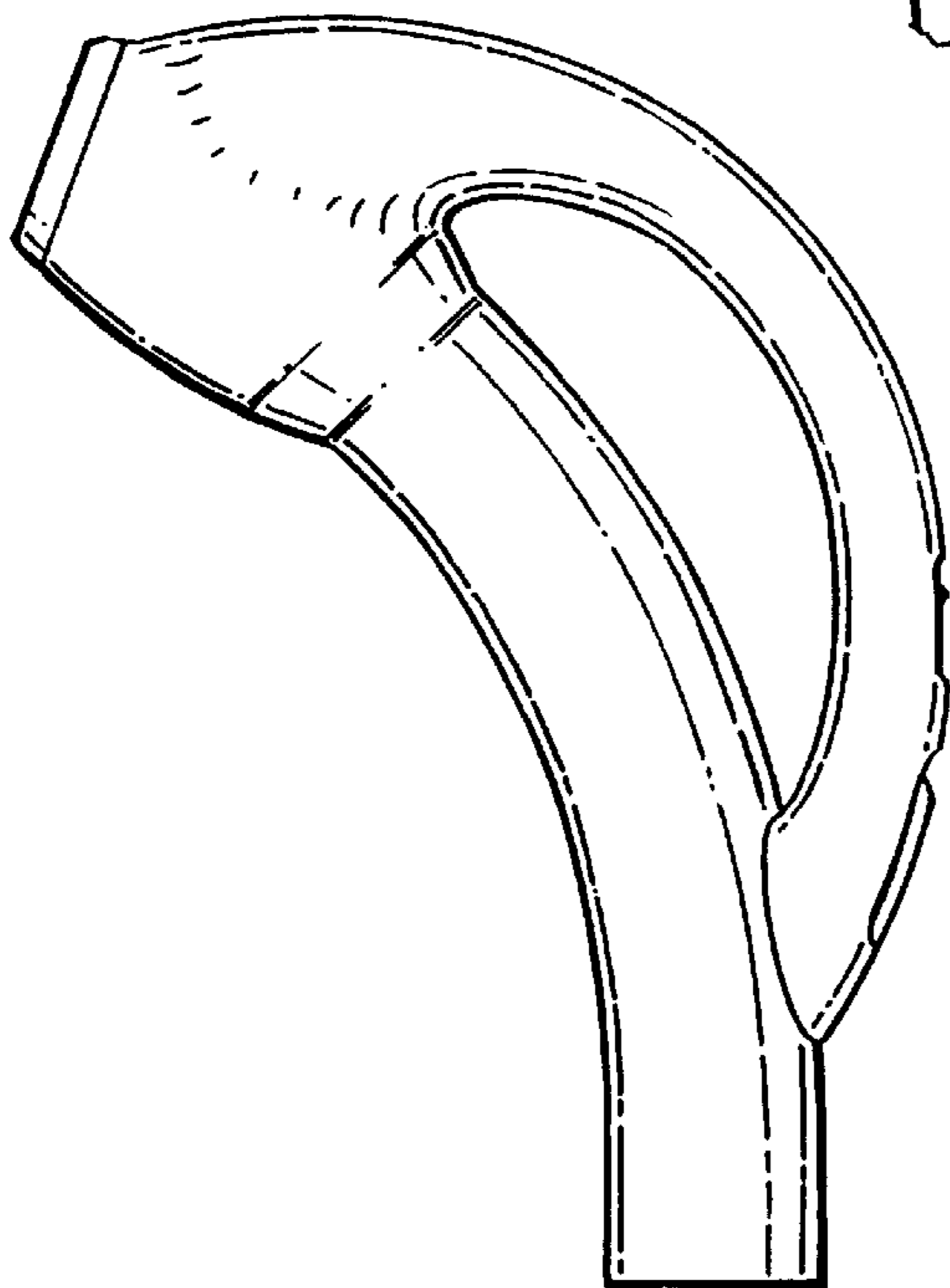

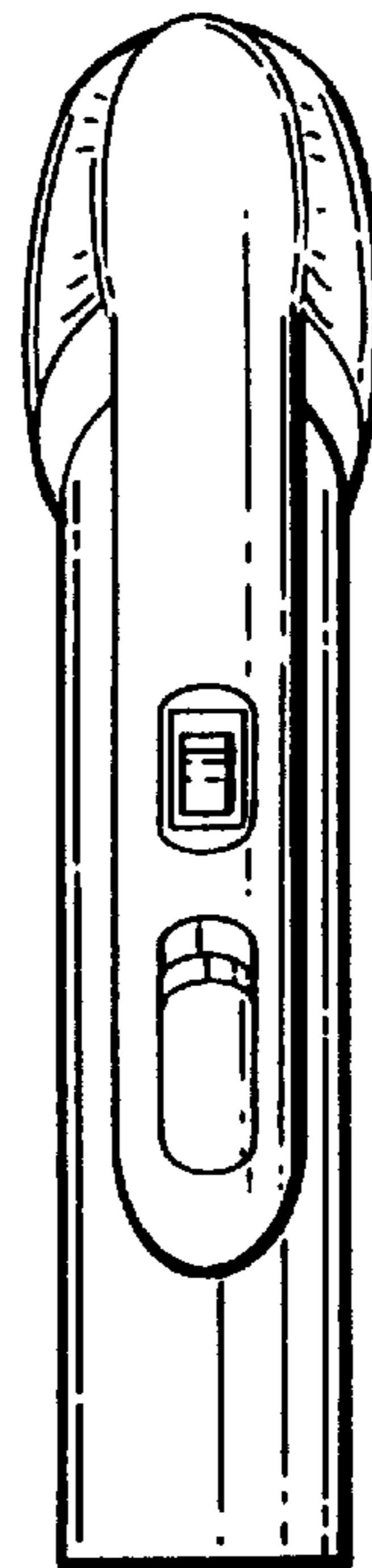

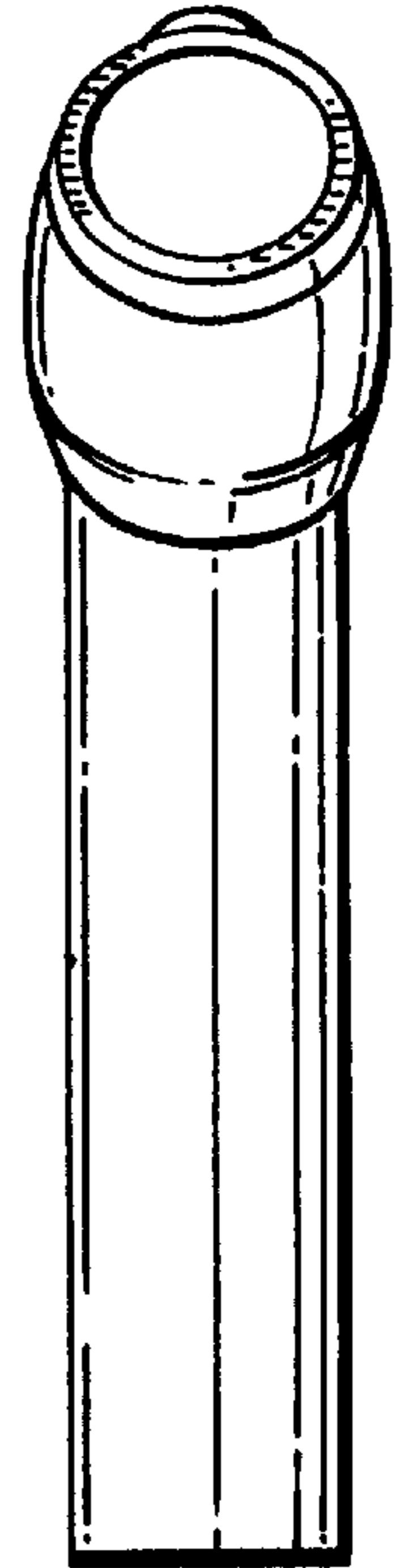

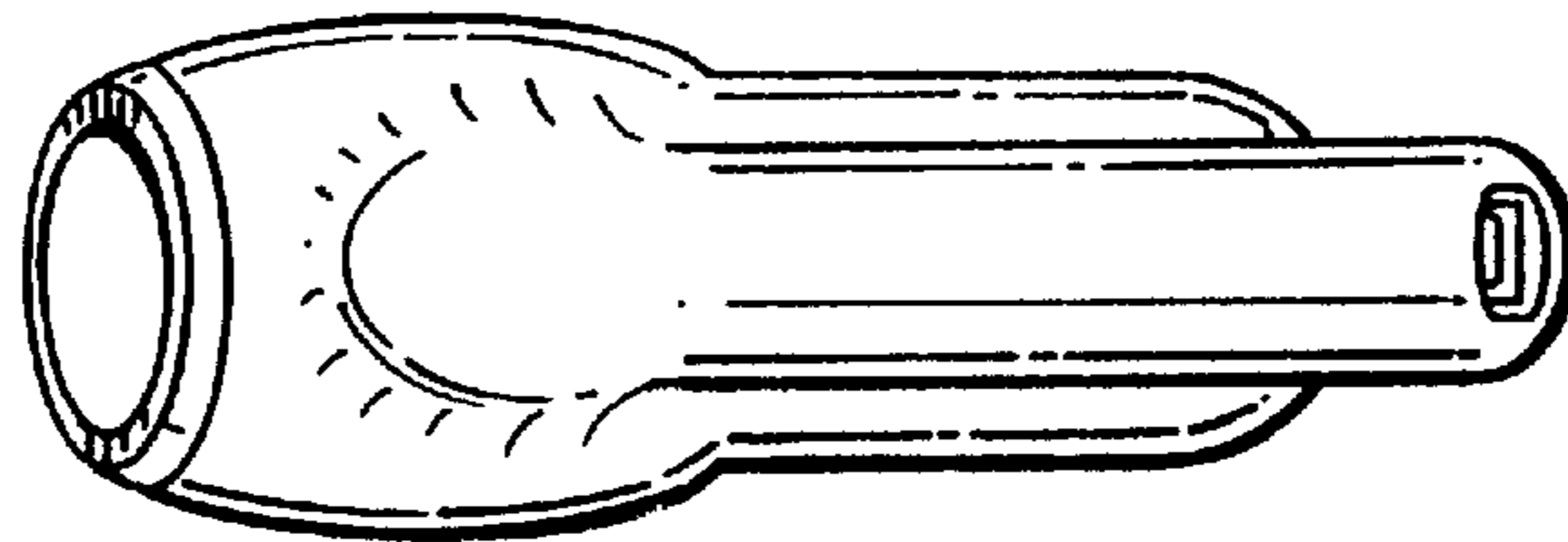
