### CLAIM

The ornamental design for a bottom surface of a shoe outsole, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a bottom surface for a shoe outsole showing my new design;

FIG. 2 is a bottom plan view thereof;


FIG. 3 is a cross section taken through line 3—3 of FIG. 2;

FIG. 4 is a cross section taken through line 4—4 of FIG. 2;

FIG. 5 is a cross section taken through line 5—5 of FIG. 2; and,




