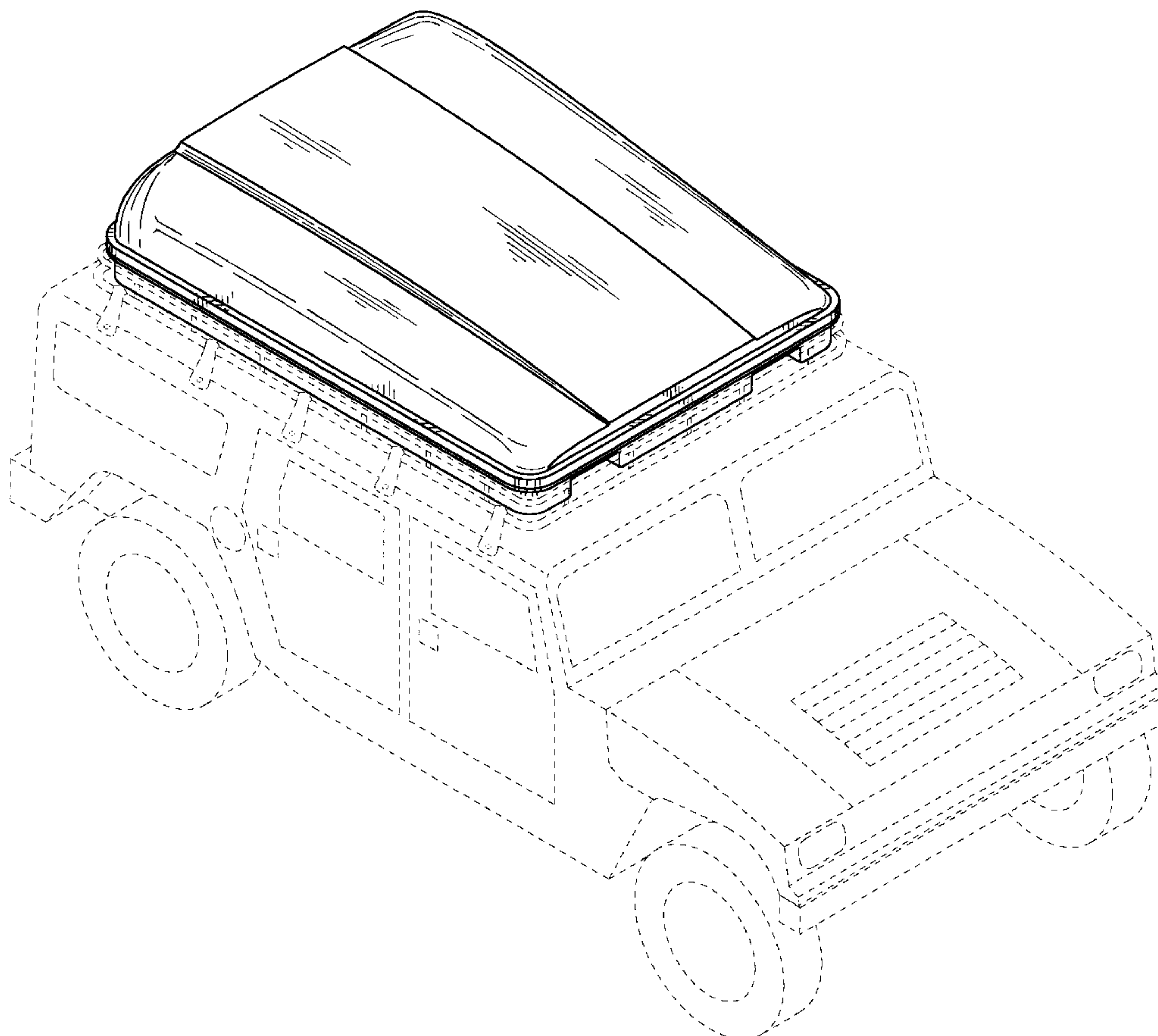
[57] **CLAIM**

The ornamental design for a vehicle-top cargo carrier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view, taken from the left and slightly above, of a vehicle-top cargo carrier showing my new design, and showing a vehicle in broken lines;
FIG. 2 is a top plan view taken from FIG. 1;
FIG. 3 is a bottom view taken from FIG. 1;
FIG. 4 is a right side elevational view taken from FIG. 1;
FIG. 5 is a rear elevational view, taken from FIG. 1;
FIG. 6 is a front elevational view, taken from FIG. 1; and,
FIG. 7 is a perspective view taken from the left and slightly above, of a vehicle-top cargo carrier according to my new design, shown in an open configuration.
The portion of the interior not shown in FIG. 7 forms no part of the claimed design.
The broken line showing of environment is for illustrative purposes only and forms no part of the claimed design.
The left side elevational view of the vehicle-top cargo carrier is partially shown in FIG. 1 and is understood to be a mirror image of the right side elevational view.

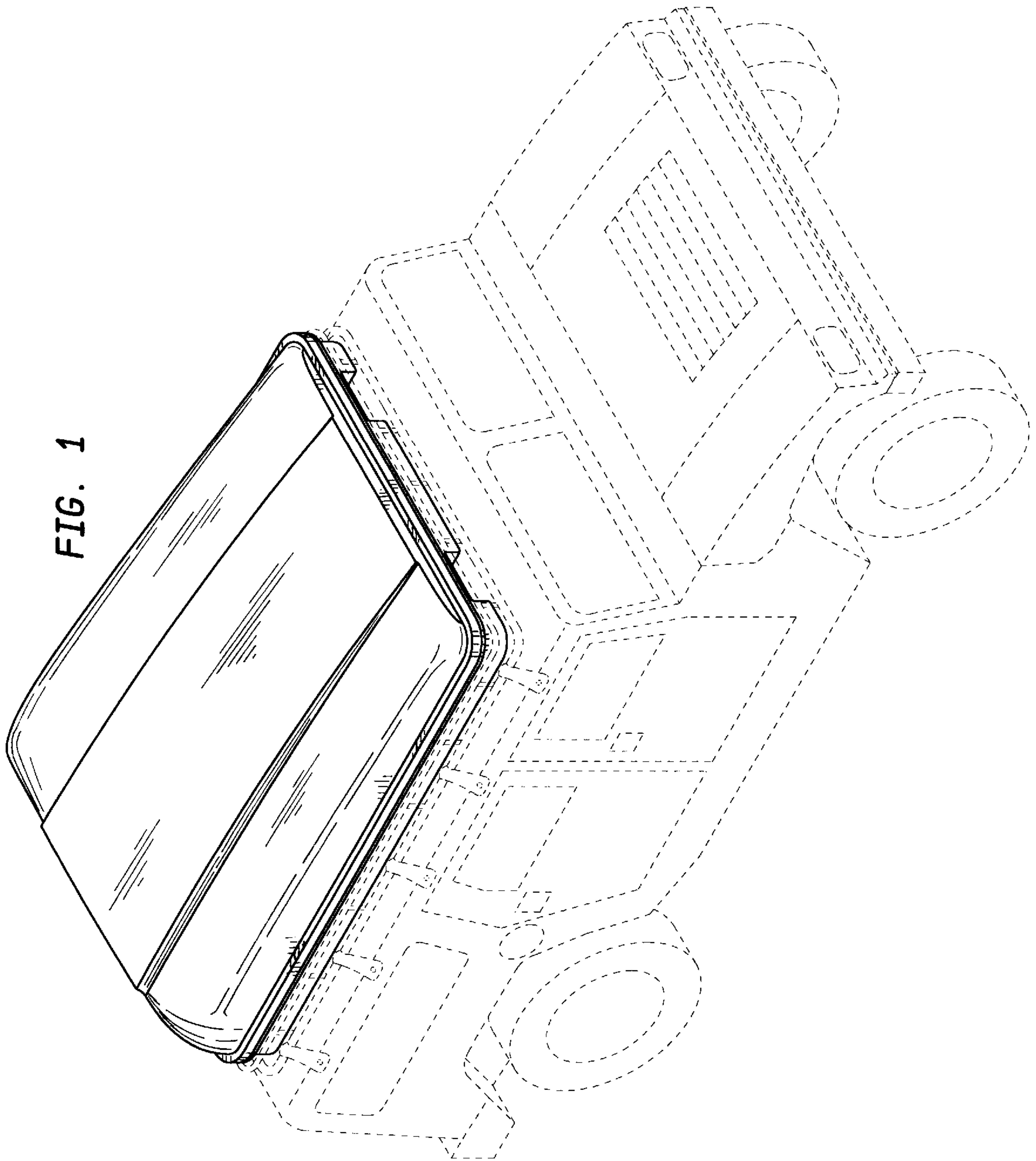

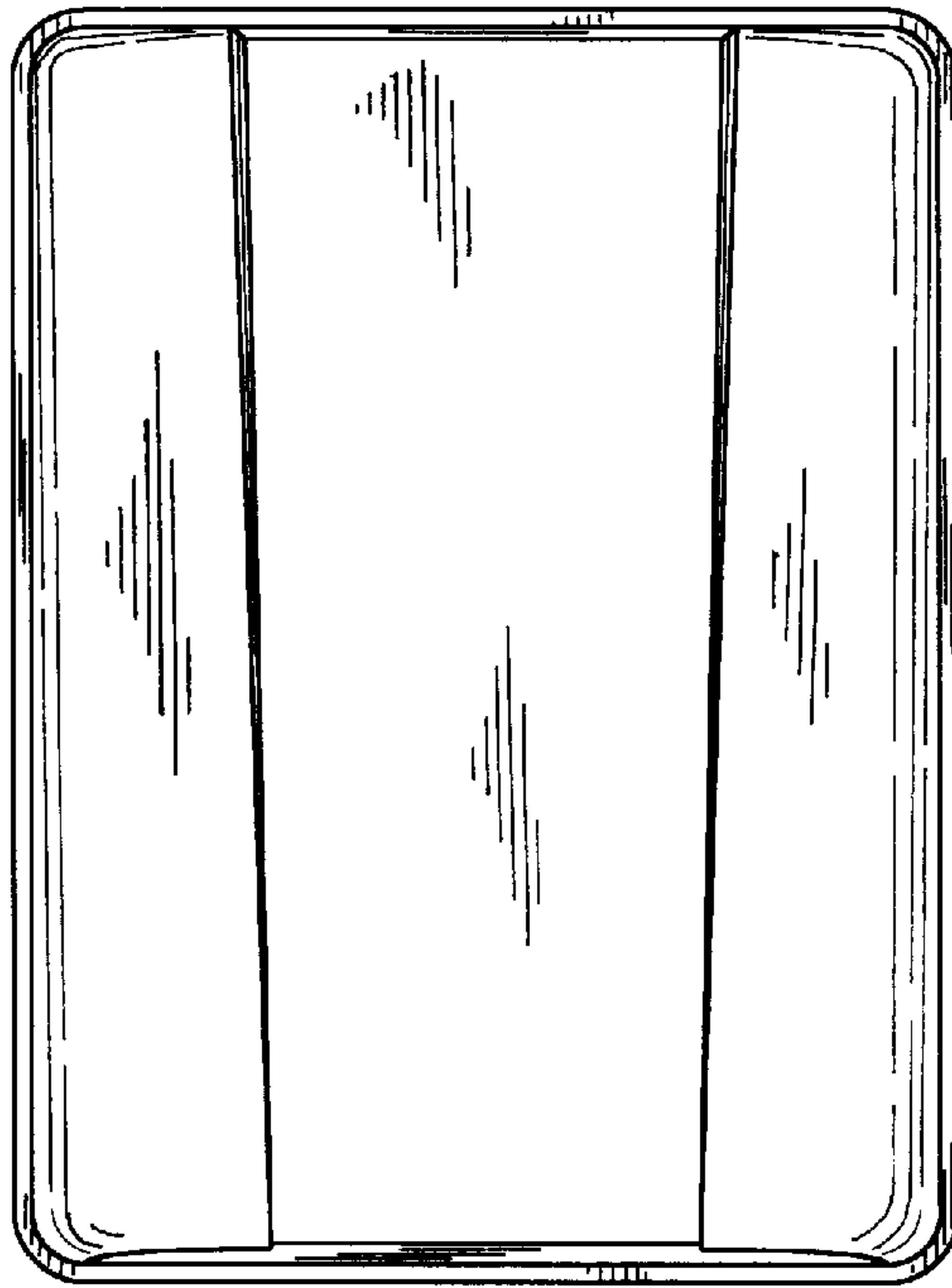

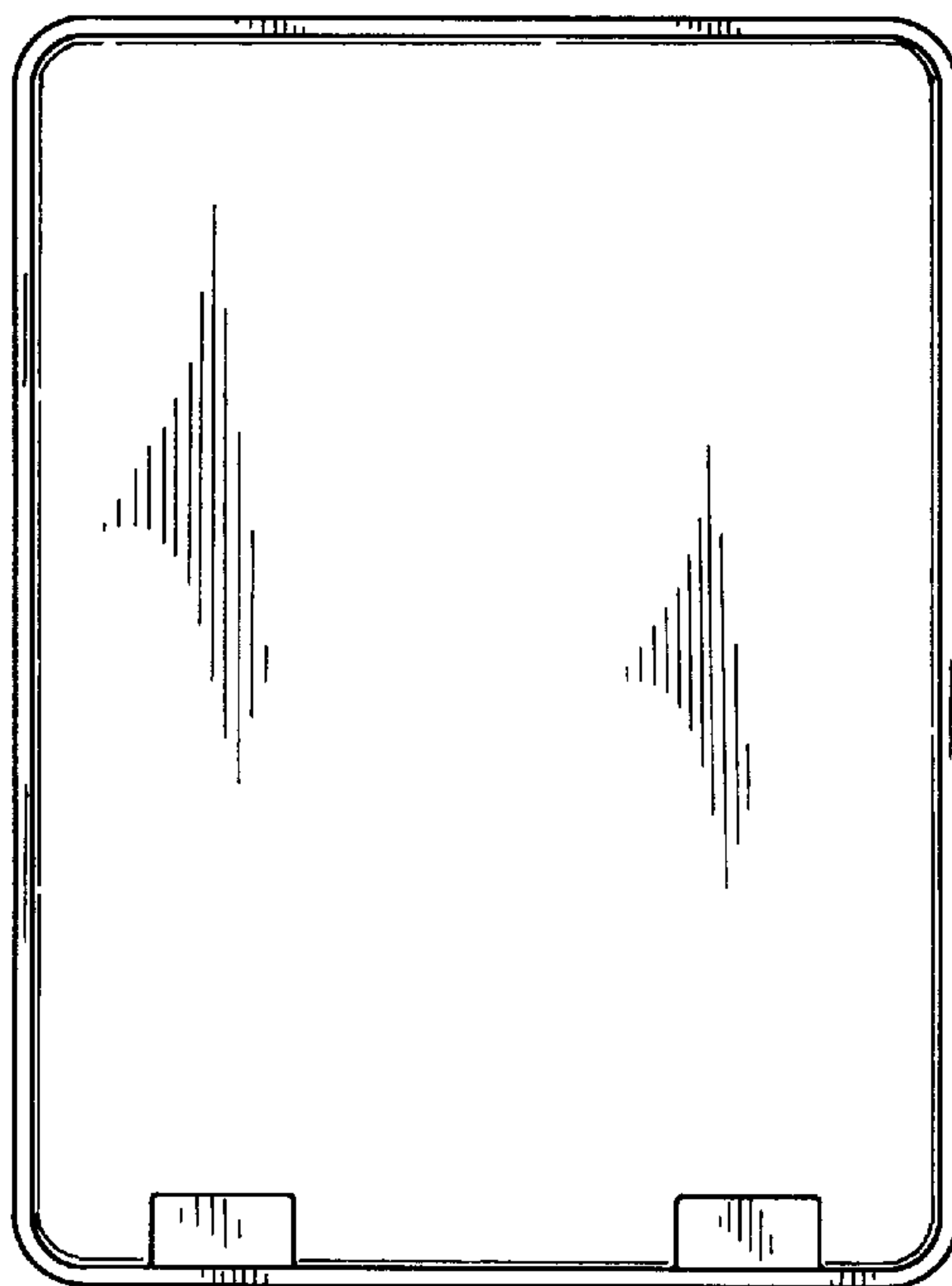

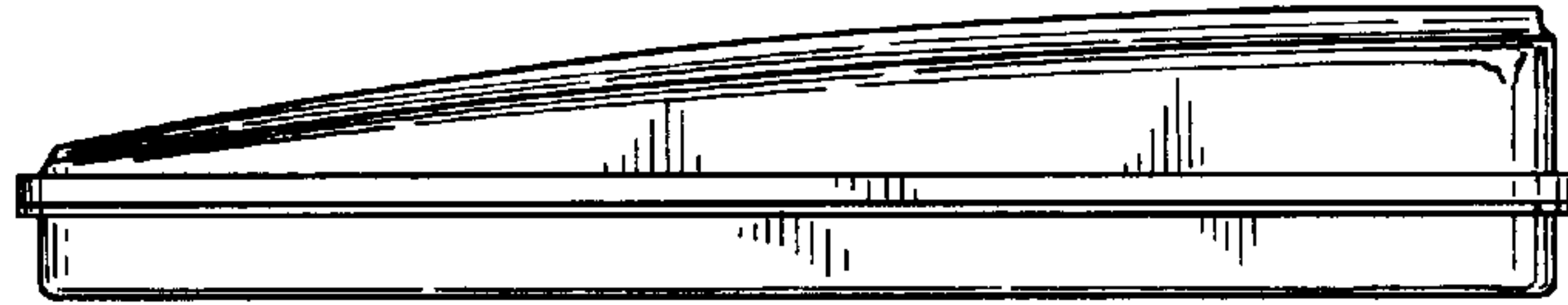

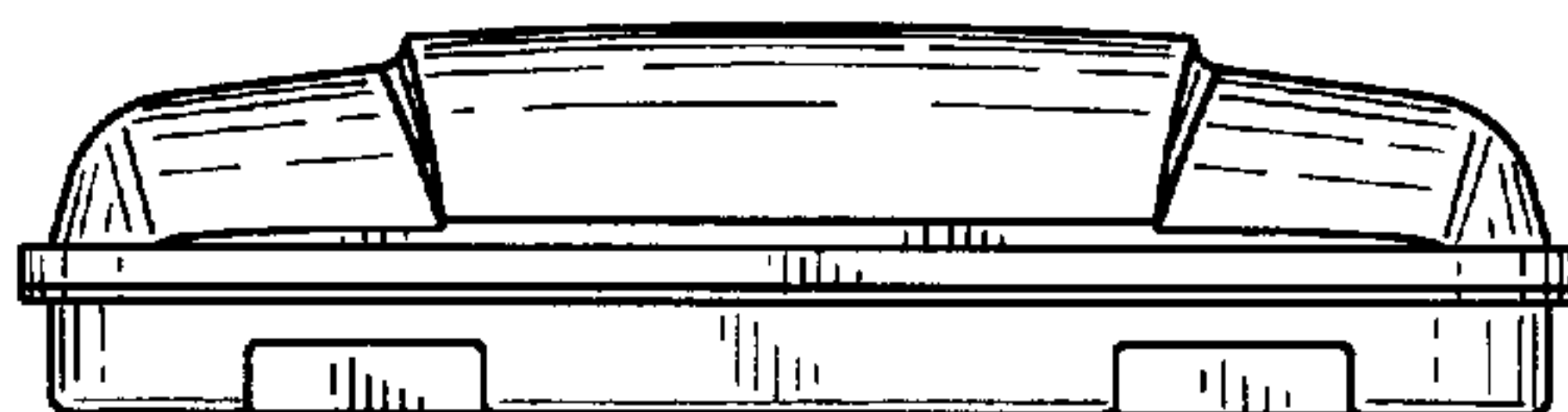
