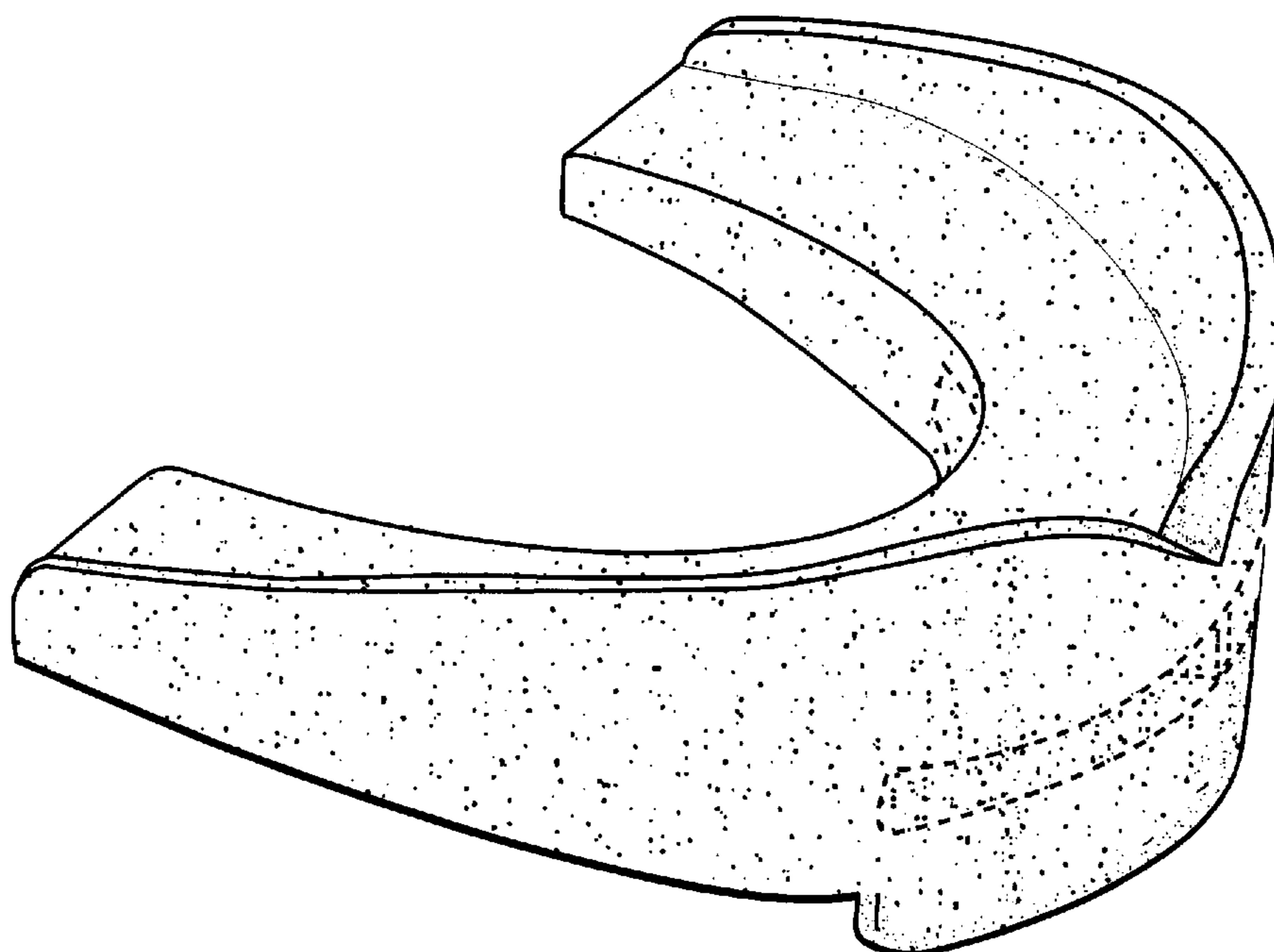
[57] **CLAIM**

The ornamental design for an anti-snore appliance, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an anti-snore appliance showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a sectional view thereof, the same being taken along the line 6—6 of FIG. 5; and,
FIG. 7 is a bottom view thereof.
The left side elevational view is a mirror image of the right side elevational view shown in FIG. 4 and the air passages shown in dashed lines do not form part of the design.

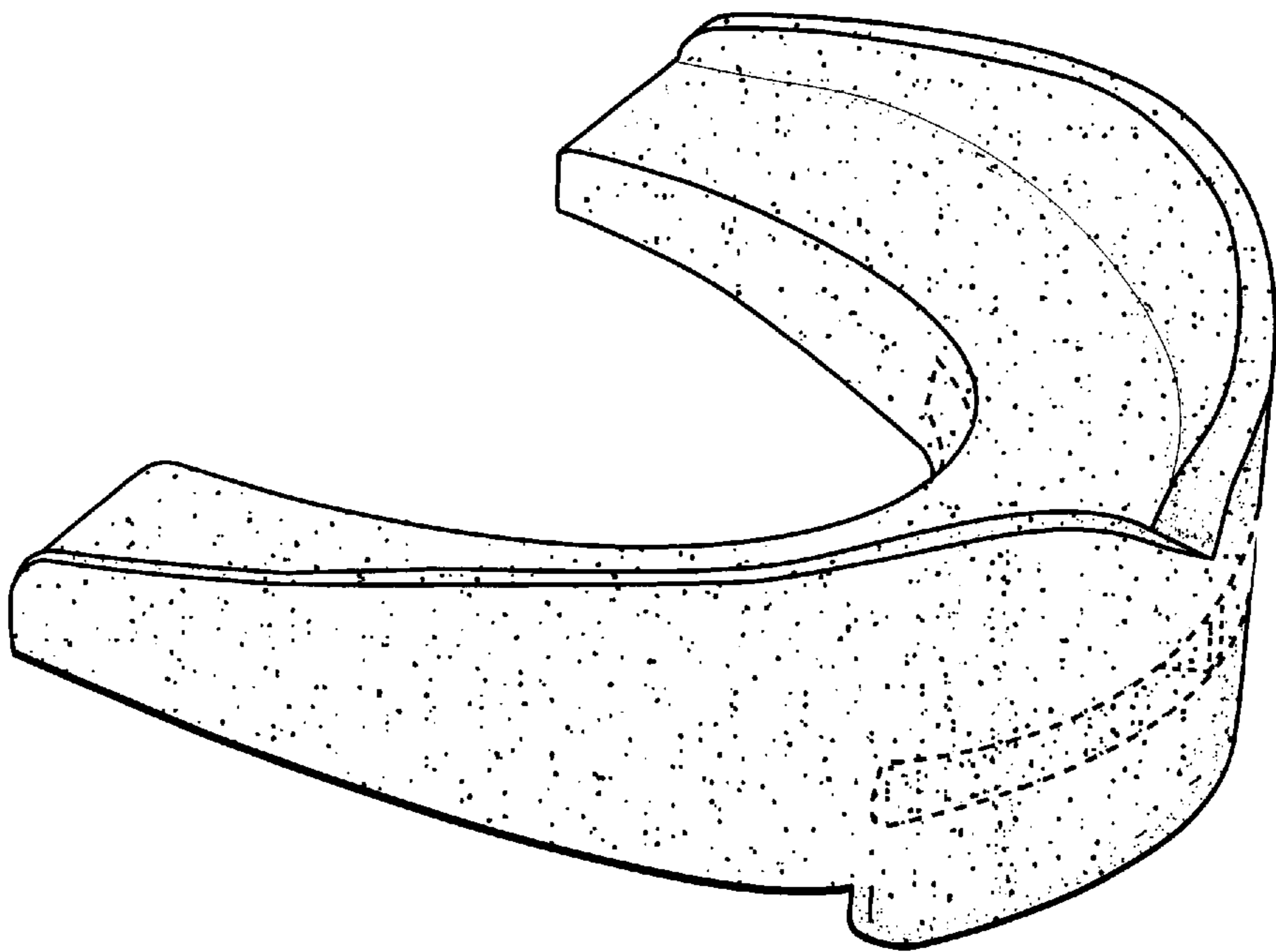

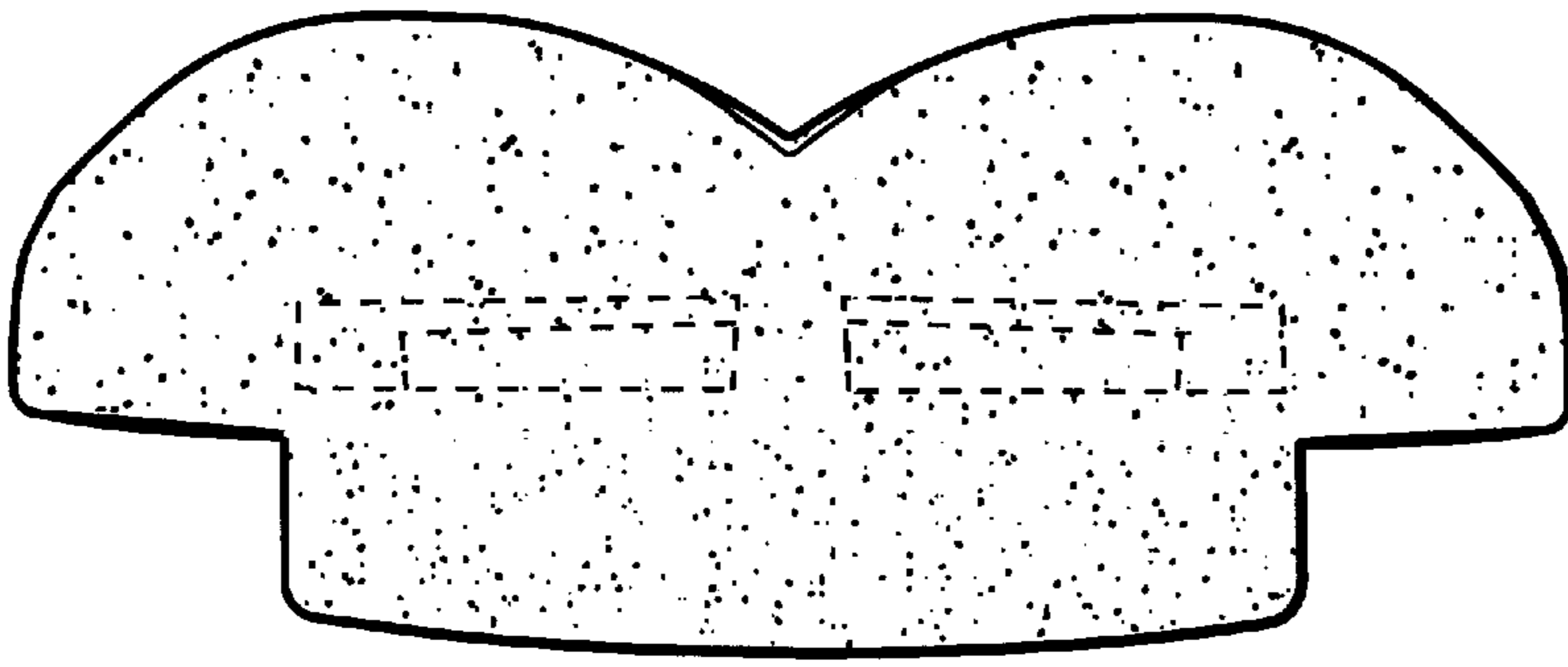

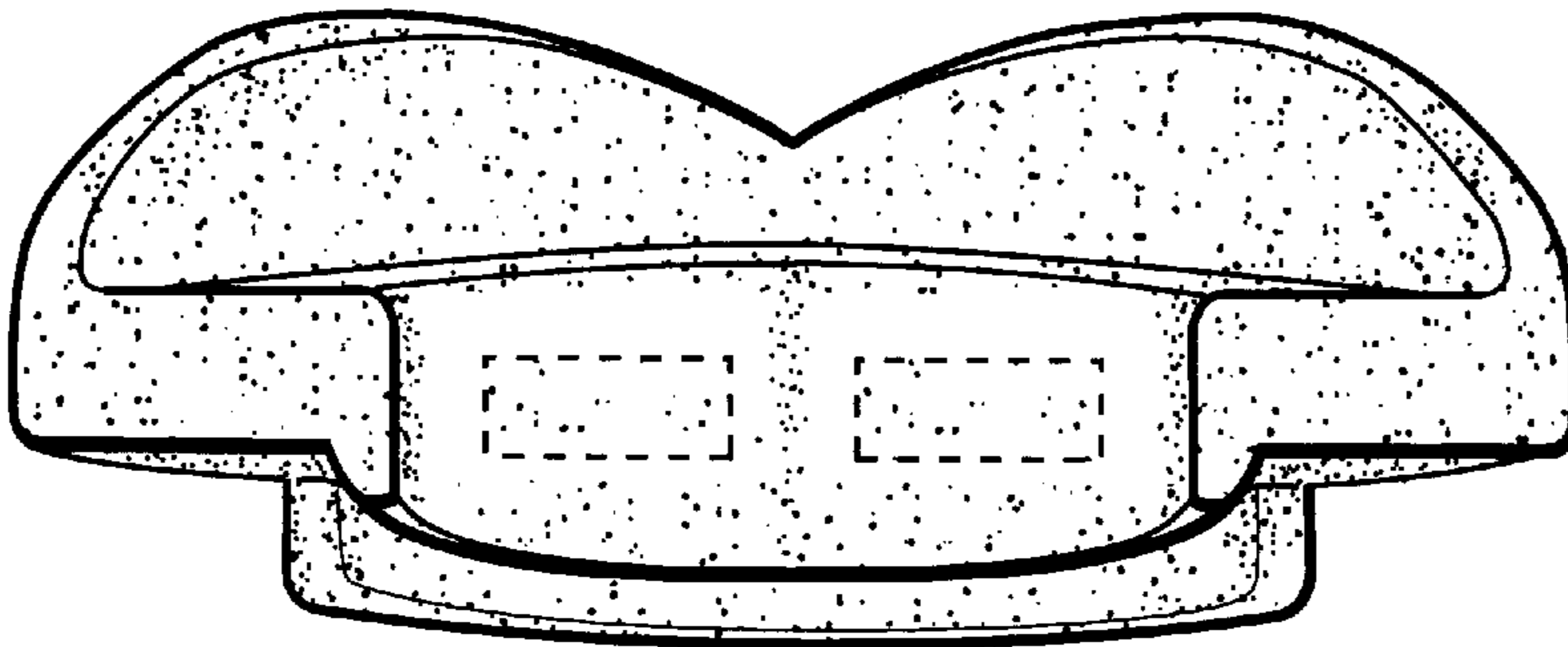

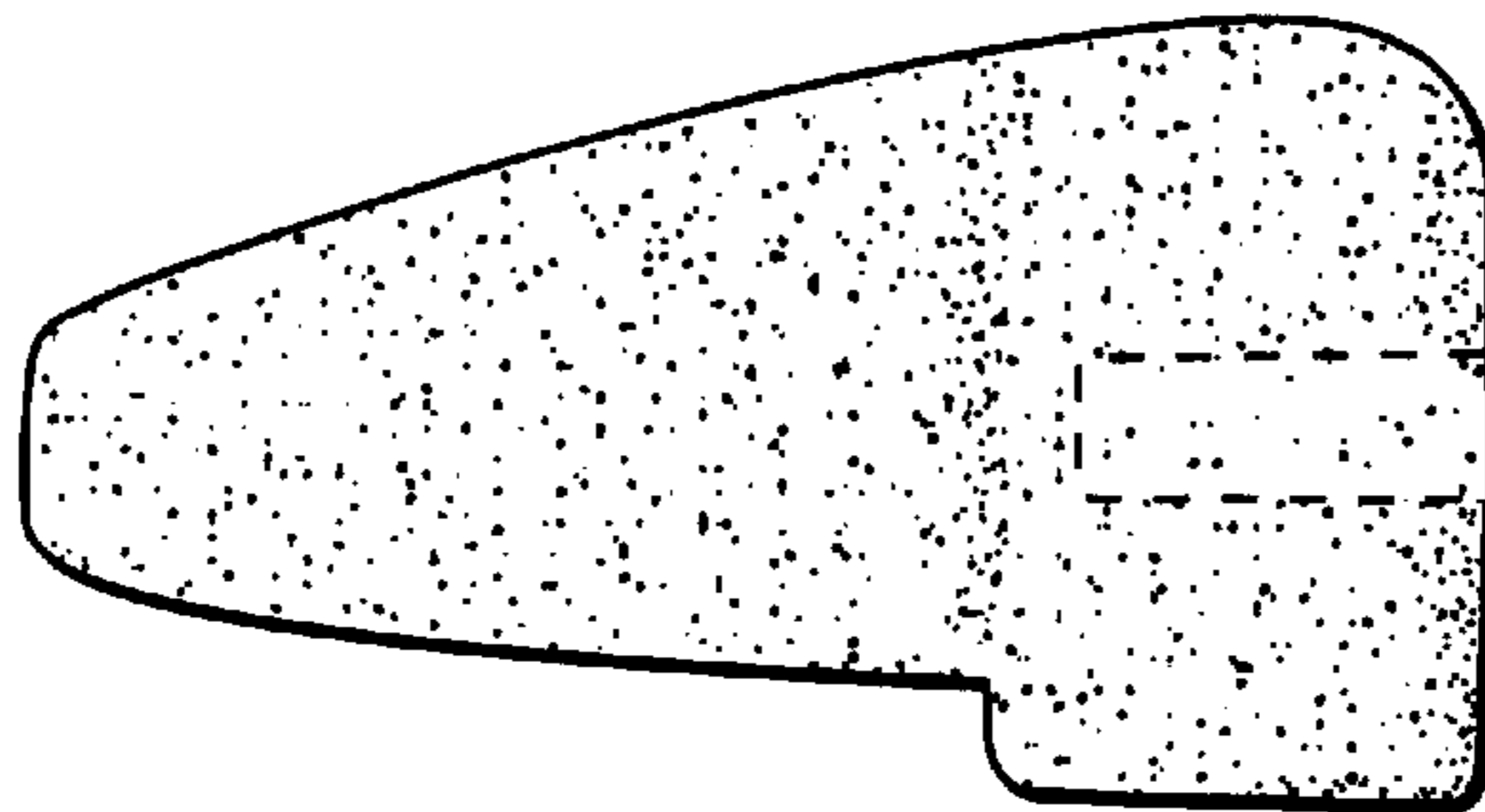

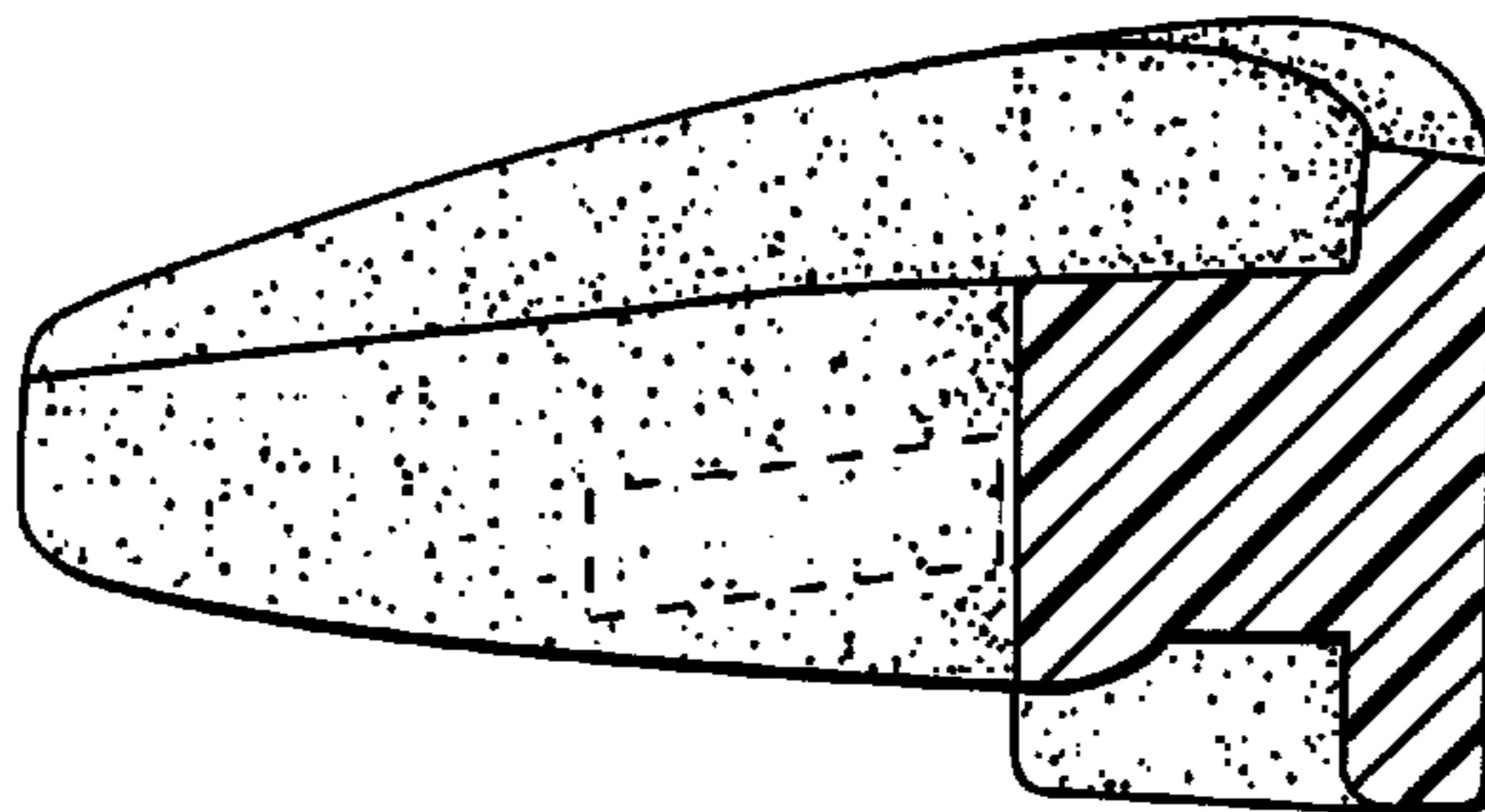
