[57] **CLAIM**

The ornamental design for a mechanic's creeper, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a creeper showing our new design;  
FIG. 2 is a top plan view of the creeper of FIG. 1;  
FIG. 3 is a side elevation of the creeper of FIG. 1;  
FIG. 4 is an end elevation of the creeper of FIG. 1;  
FIG. 5 is a bottom plan view of the creeper of FIG. 1;  
FIG. 6 is an opposite end view of the creeper of FIG. 1 opposite from the end of FIG. 4;  
FIG. 7 is a cross sectional view of the creeper along the line 7—7 in FIG. 1;  
FIG. 8 is a cross sectional view of the creeper along the line 8—8 in FIG. 1; and,  
FIG. 9 is a cross sectional view of the creeper along the line 9—9 in FIG. 1.

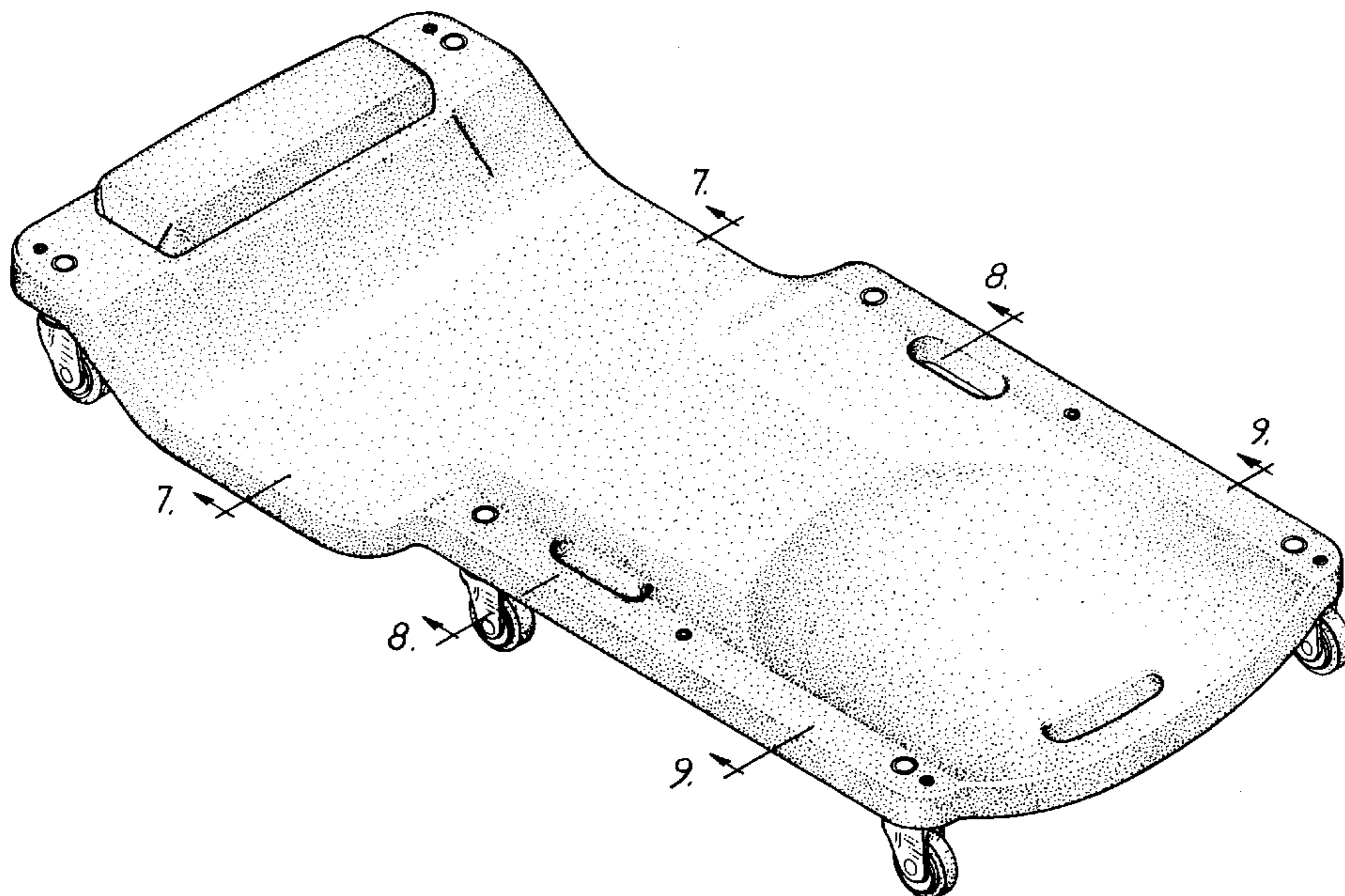

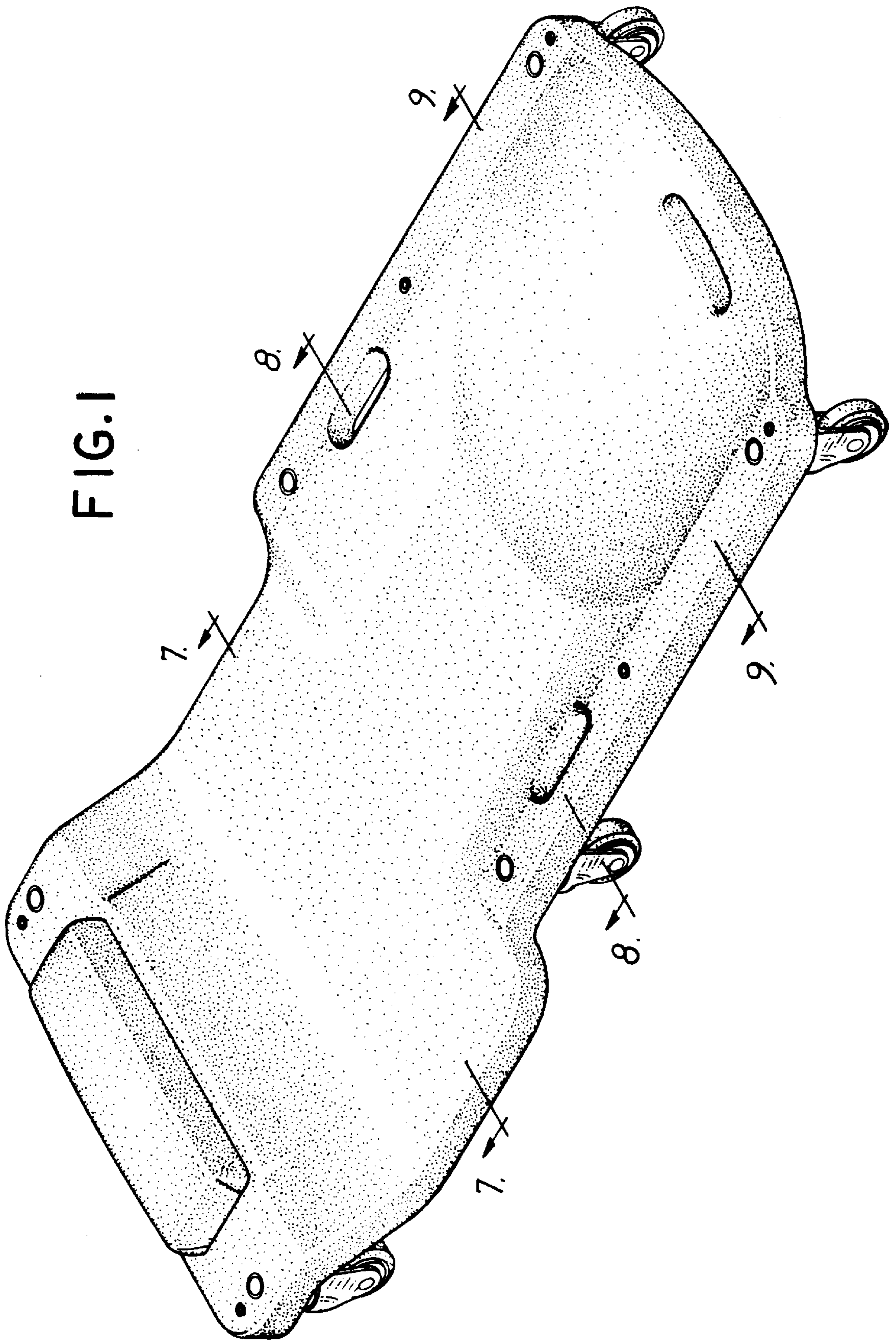

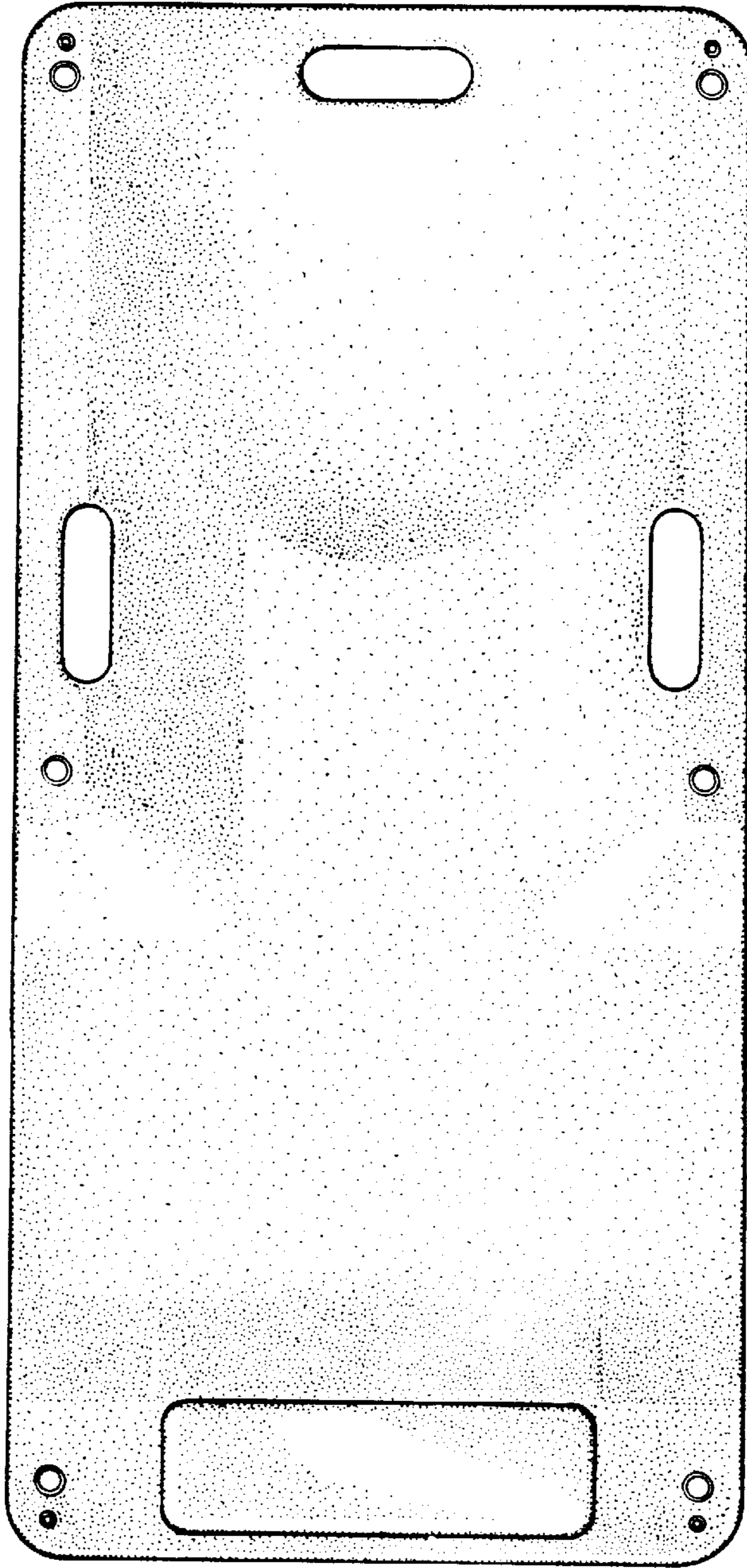

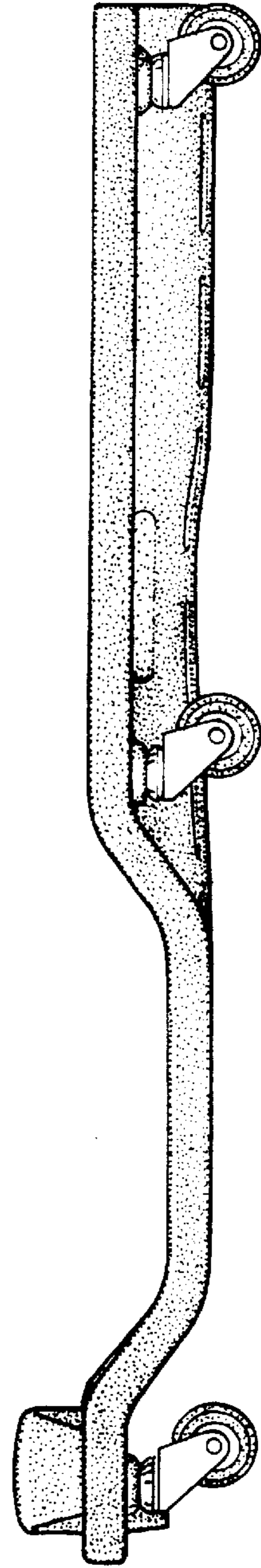

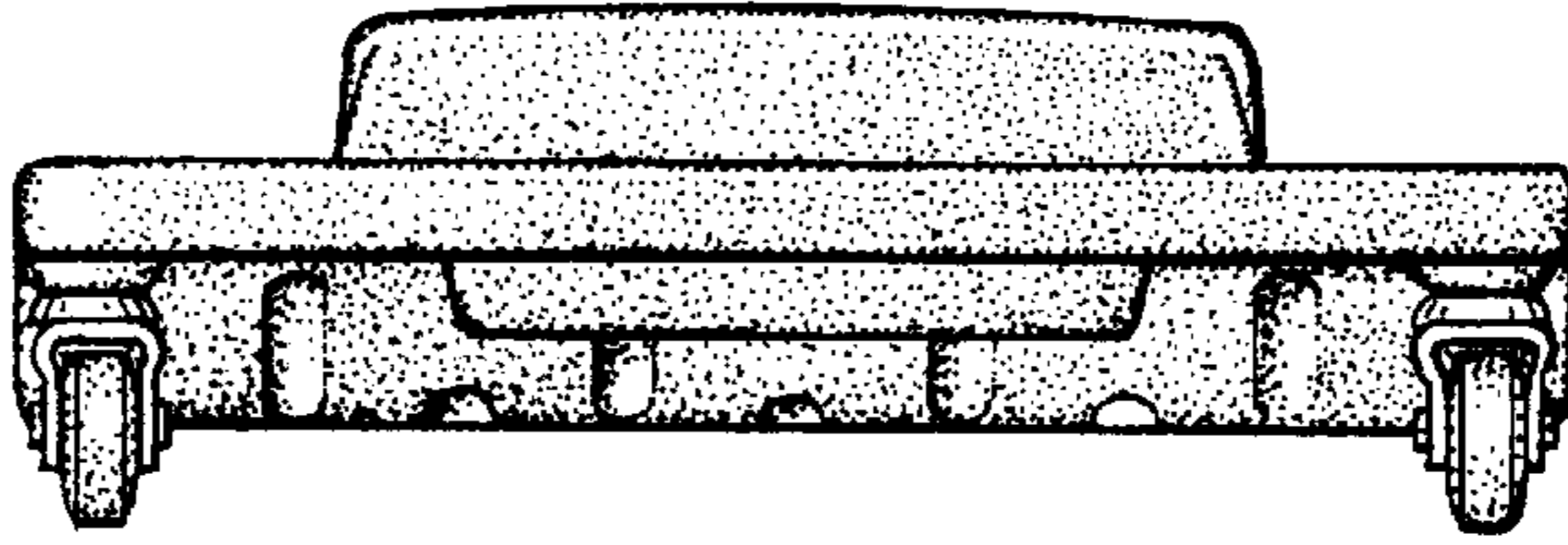

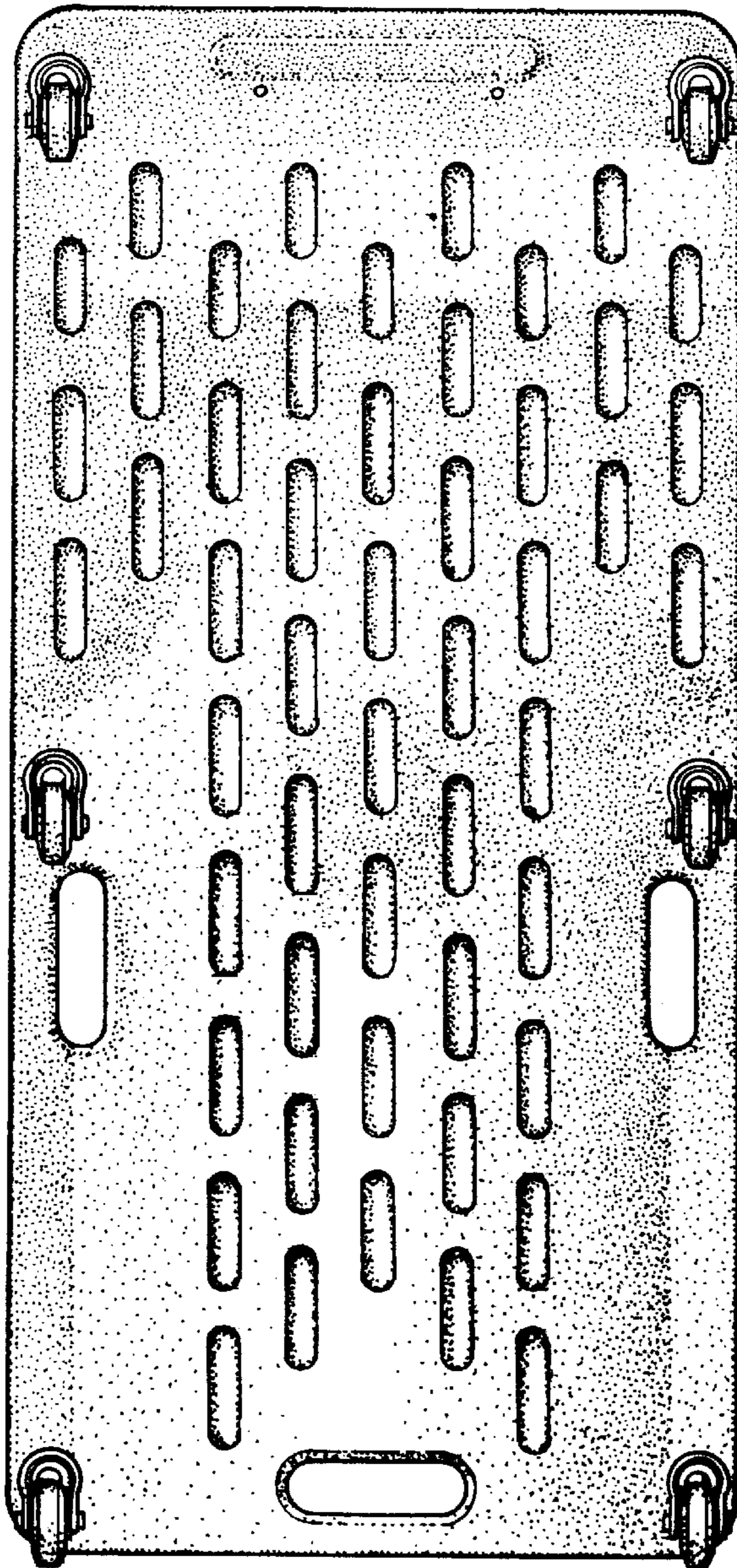

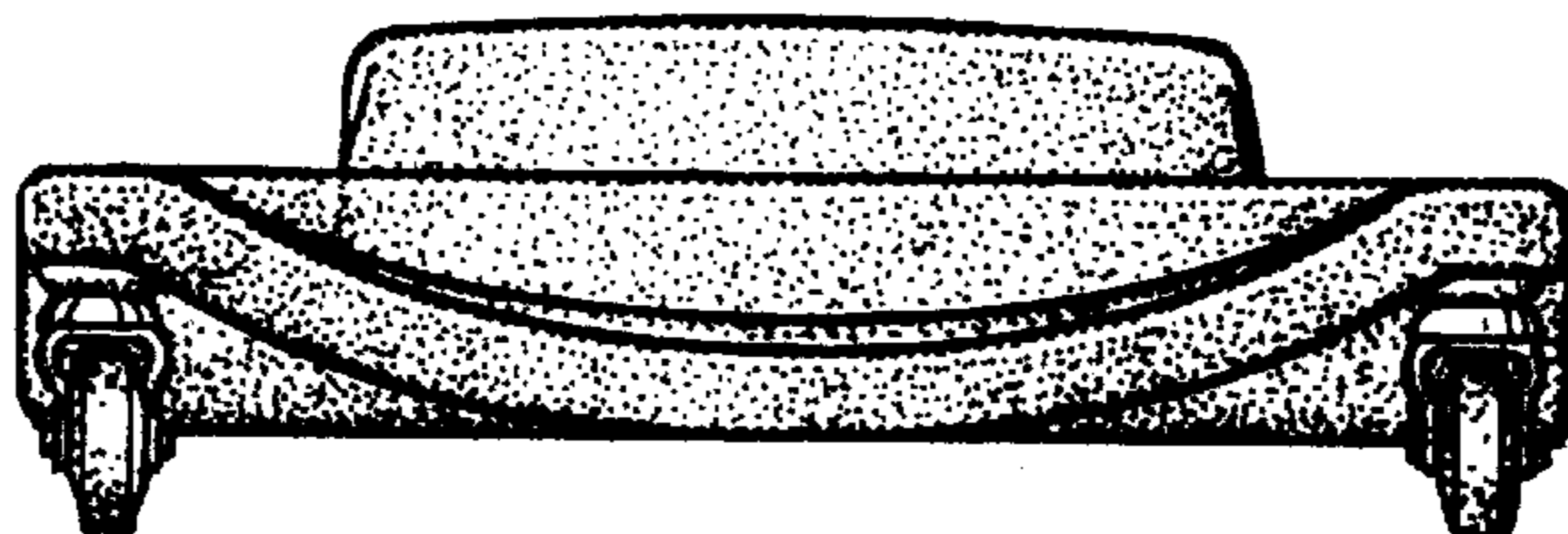

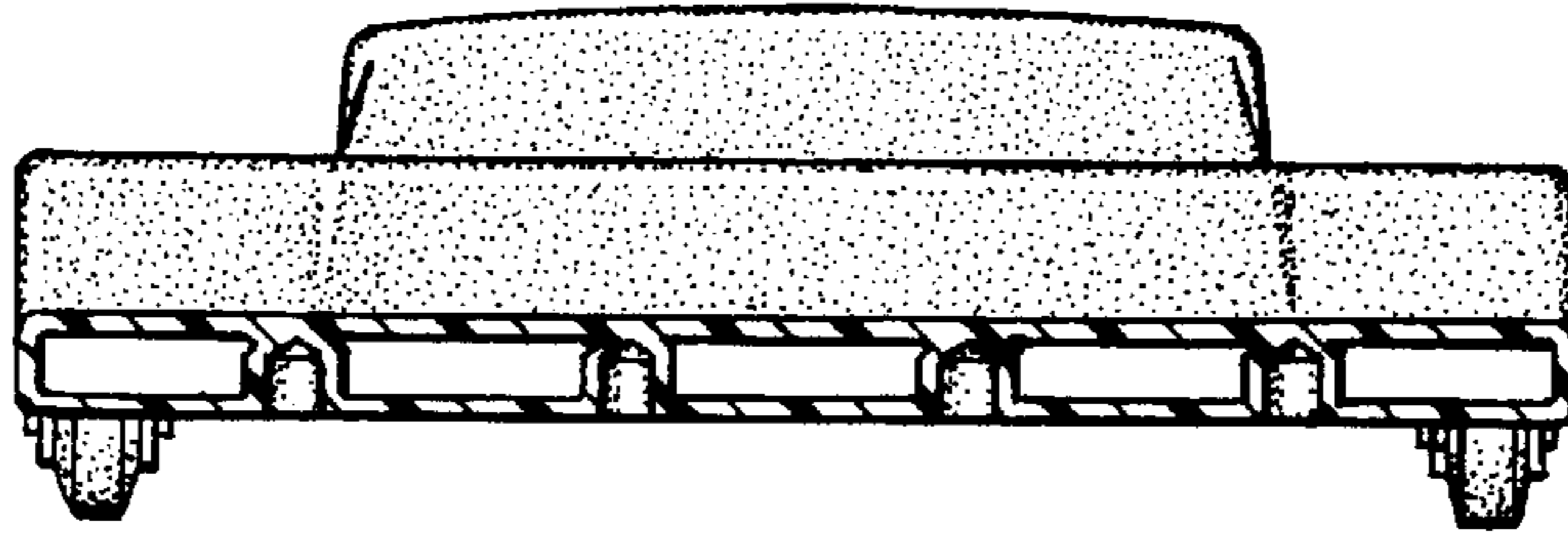

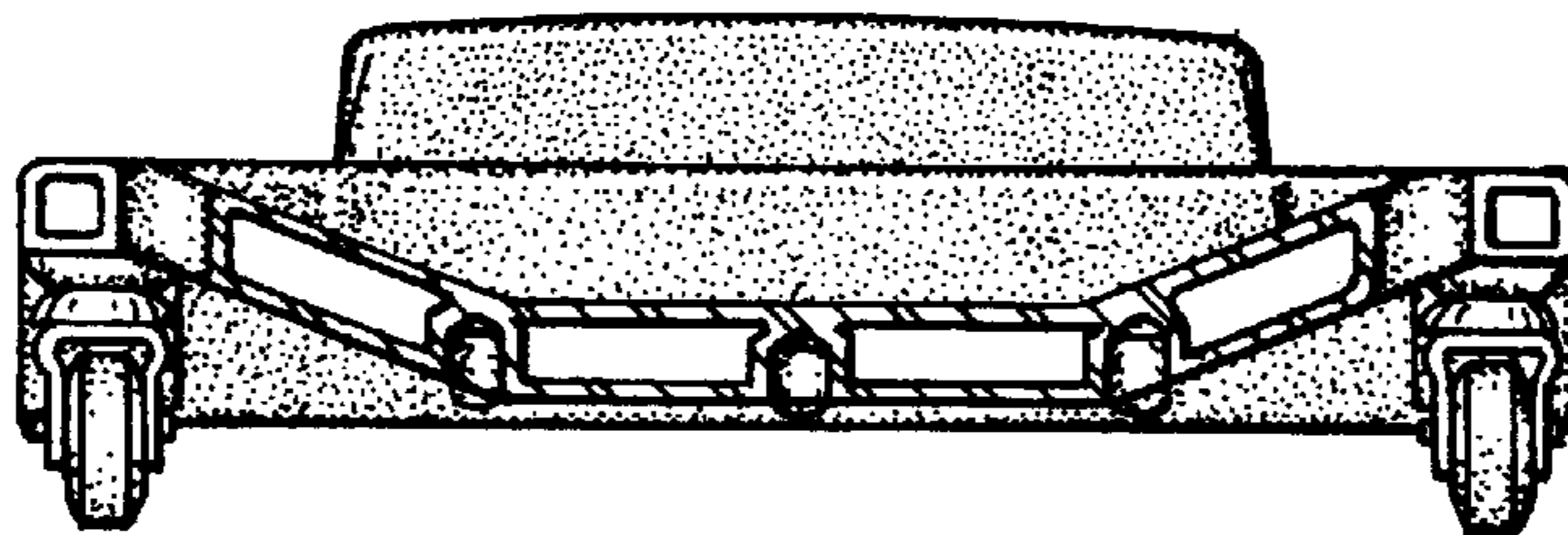
