The ornamental design for a zipper puller, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a zipper puller showing my new design;
FIG. 2 is a right side elevational view thereof, the opposite side is a mirror image;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

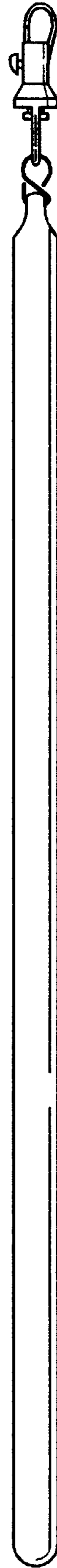

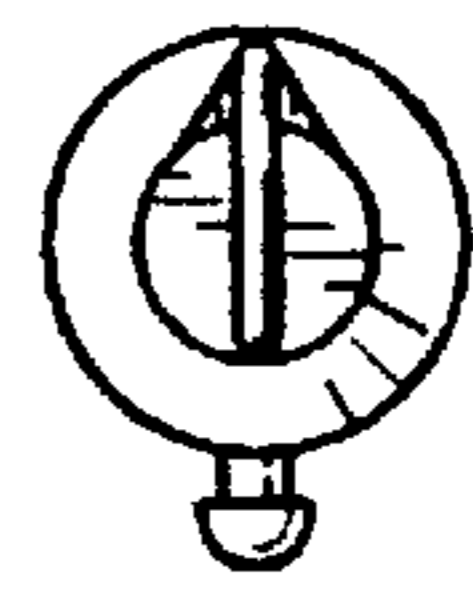
