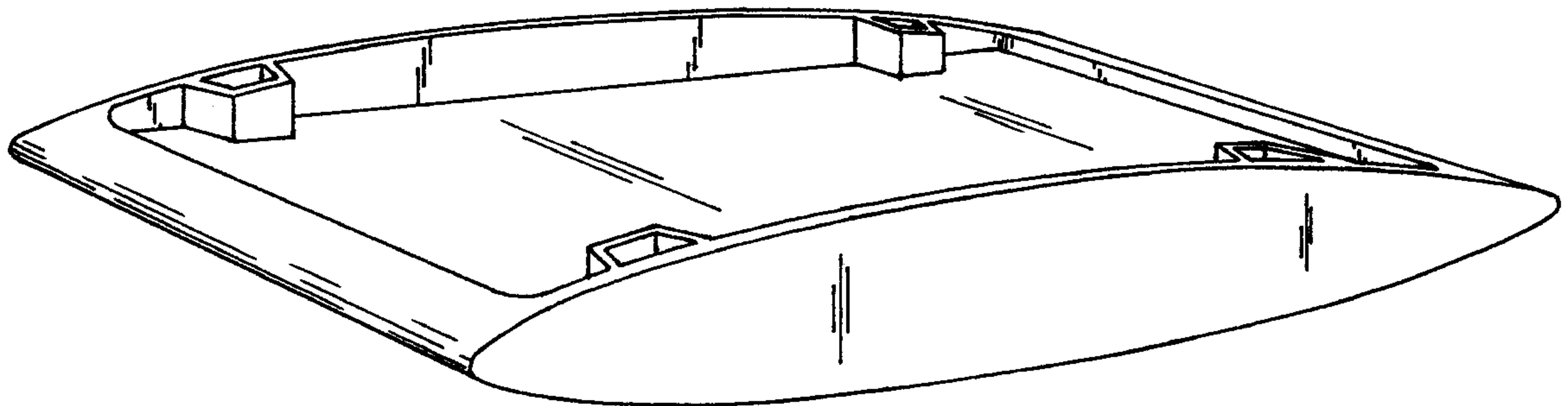

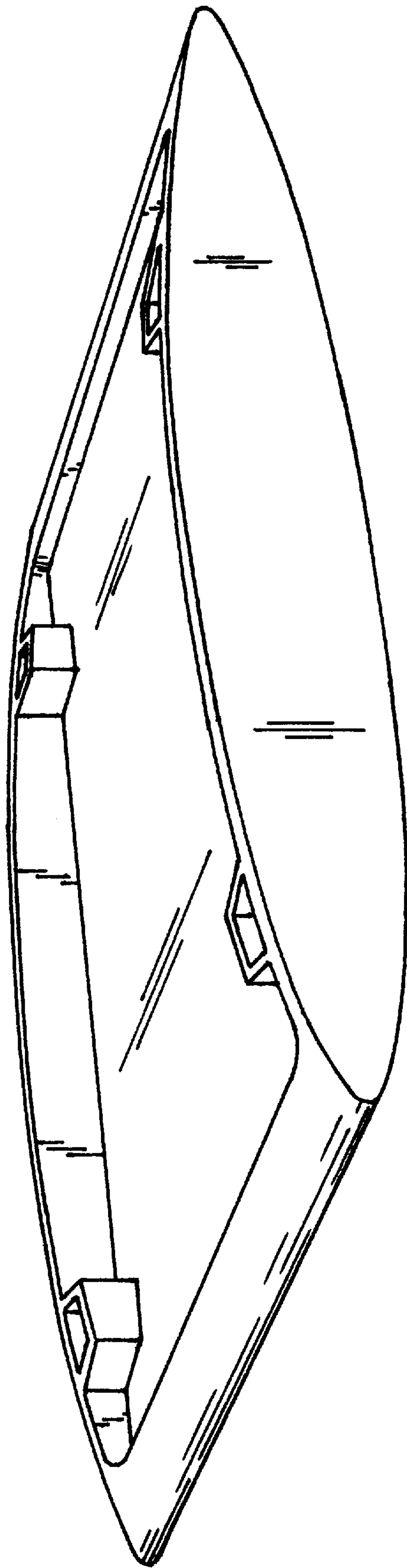
The ornamental design for a product merchandising unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a product merchandising display unit showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image thereof;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a left side elevational view thereof, the opposite side being a mirror image thereof.

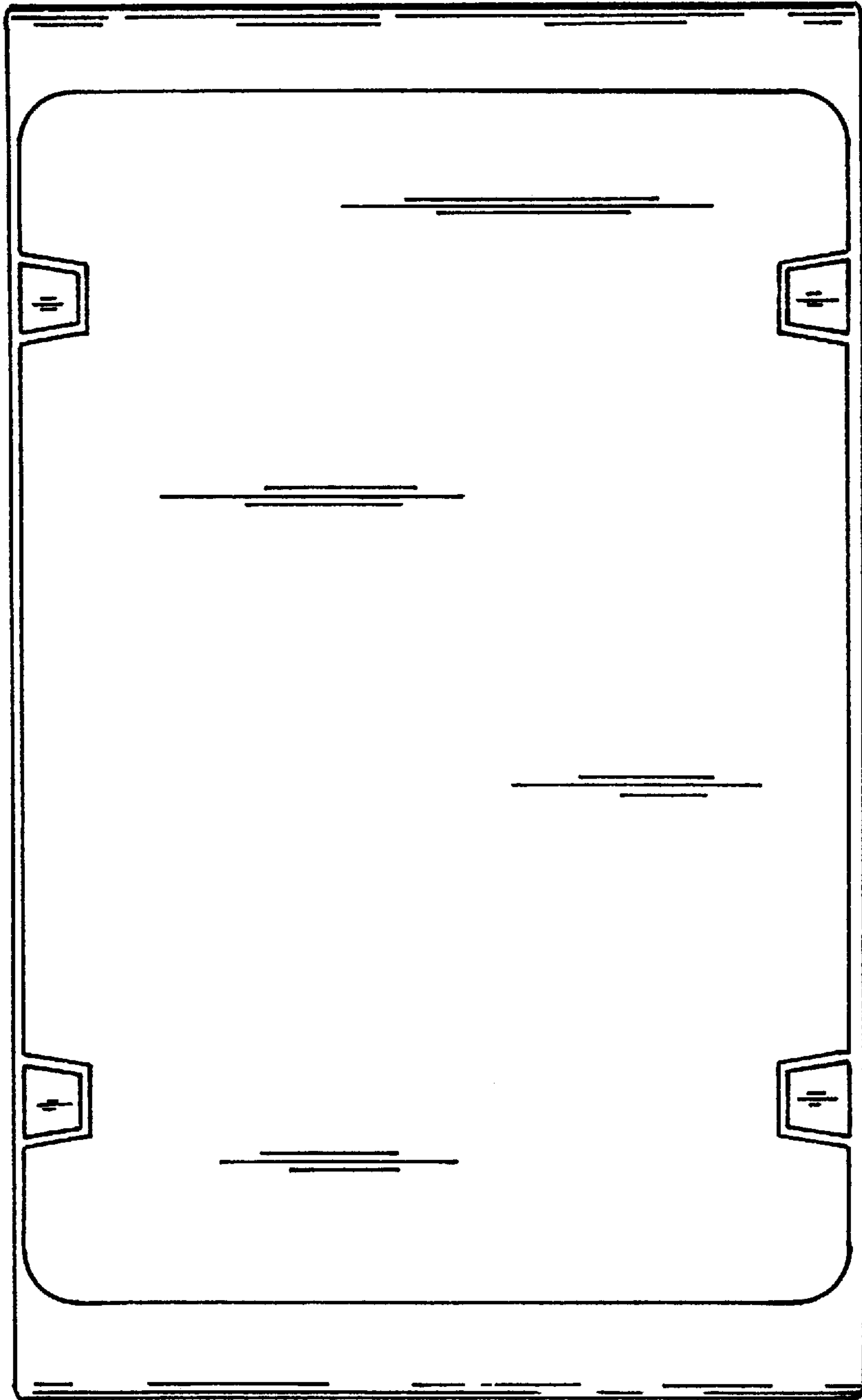
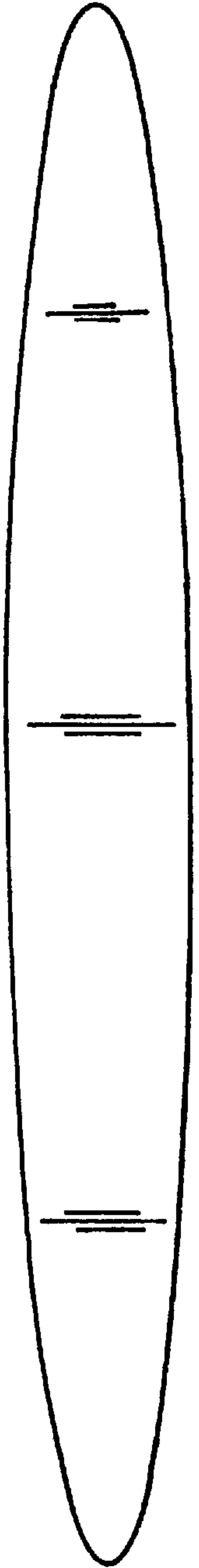

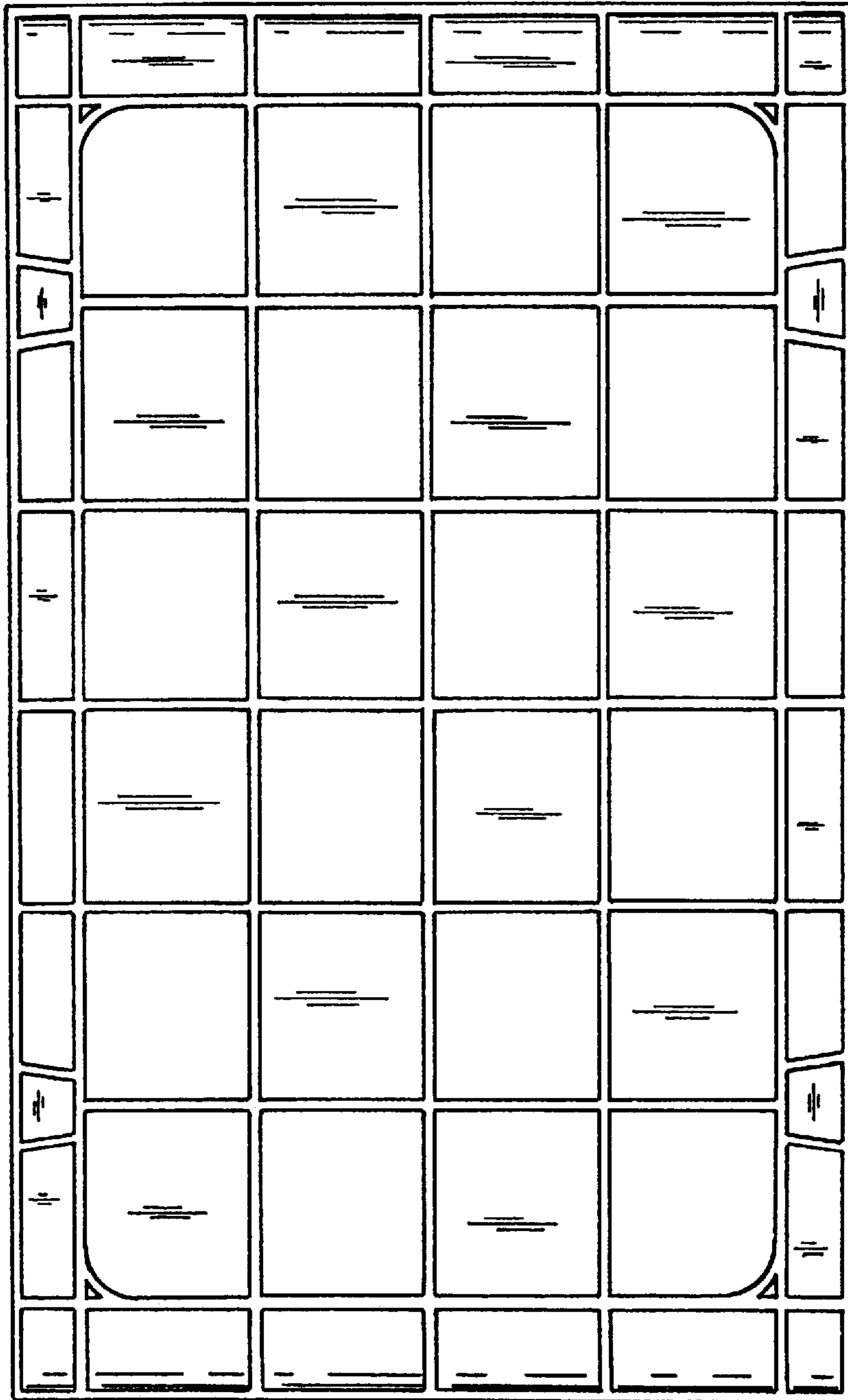
