[57] **CLAIM**

The ornamental design for a pizza snack carrier, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pizza snack carrier showing my new design, the broken line drawing of a cup is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a front perspective of a pizza snack carrier showing my new design with snack access door open, the broken line drawing of a cup is for illustrative purposes only and forms no part of the claimed design;

FIG. 3 is a top elevation thereof;

FIG. 4 is a front elevation thereof;

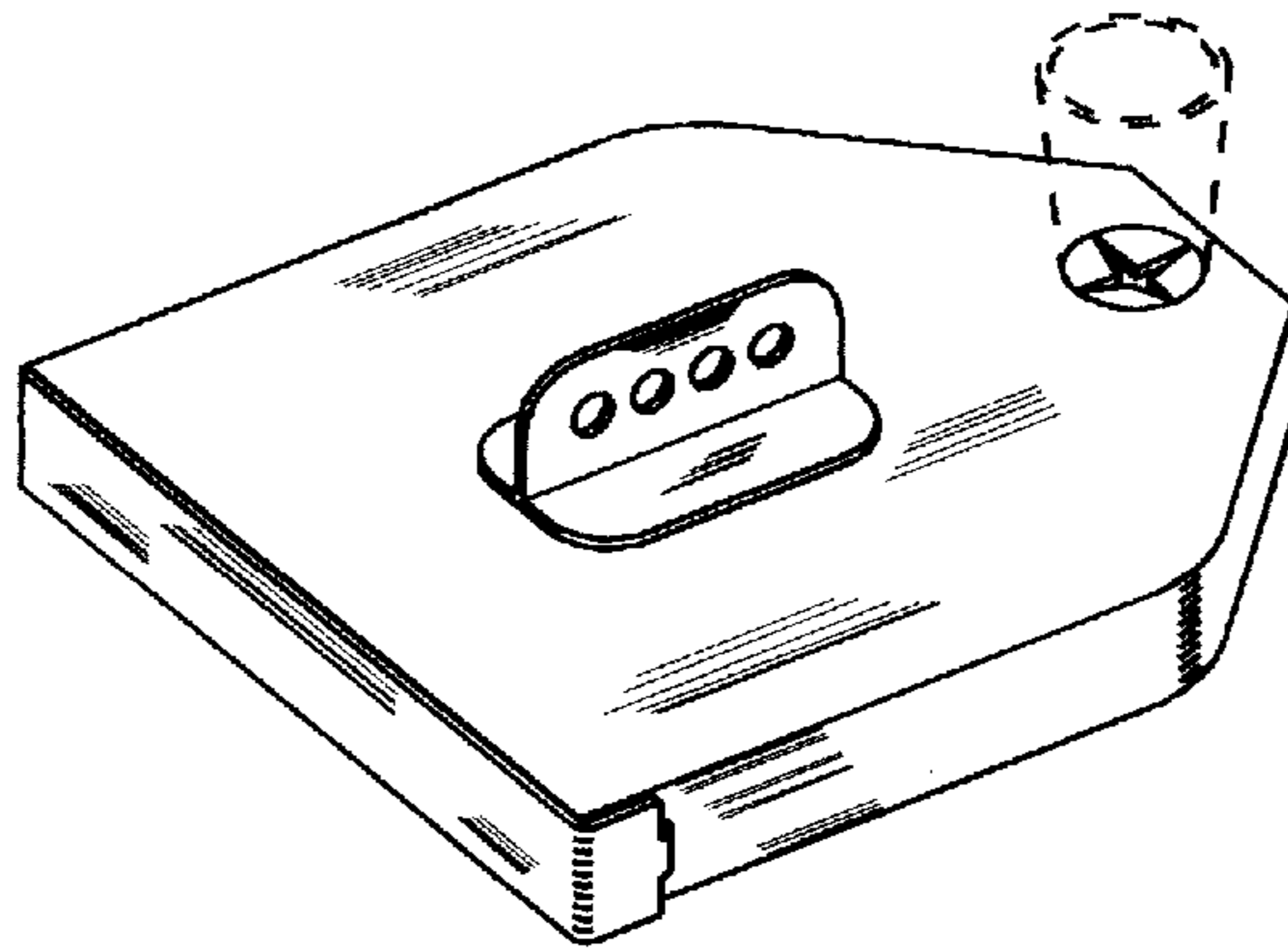
FIG. 5 side elevation thereof, the opposite side being a mirror image;

FIG. 6 is a bottom elevation thereof;

FIG. 7 is a view along lines 7—7 of FIG. 4 the broken line drawing of a cup and snack is for illustrative purposes only and forms no part of the claimed design.

FIGS 3-6 are drawn and smaller scale while FIG. 7 is drawn in a larger scale.

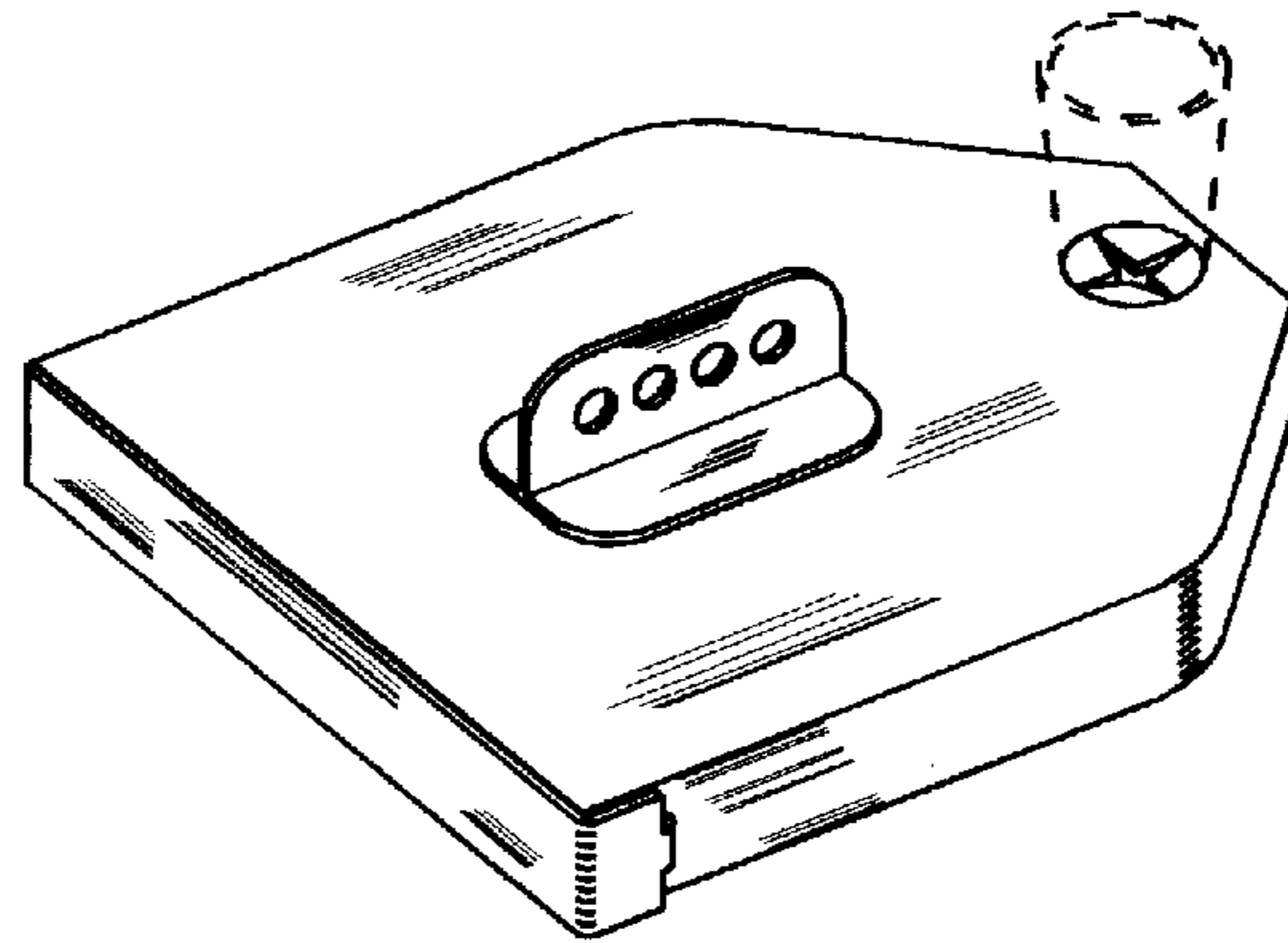

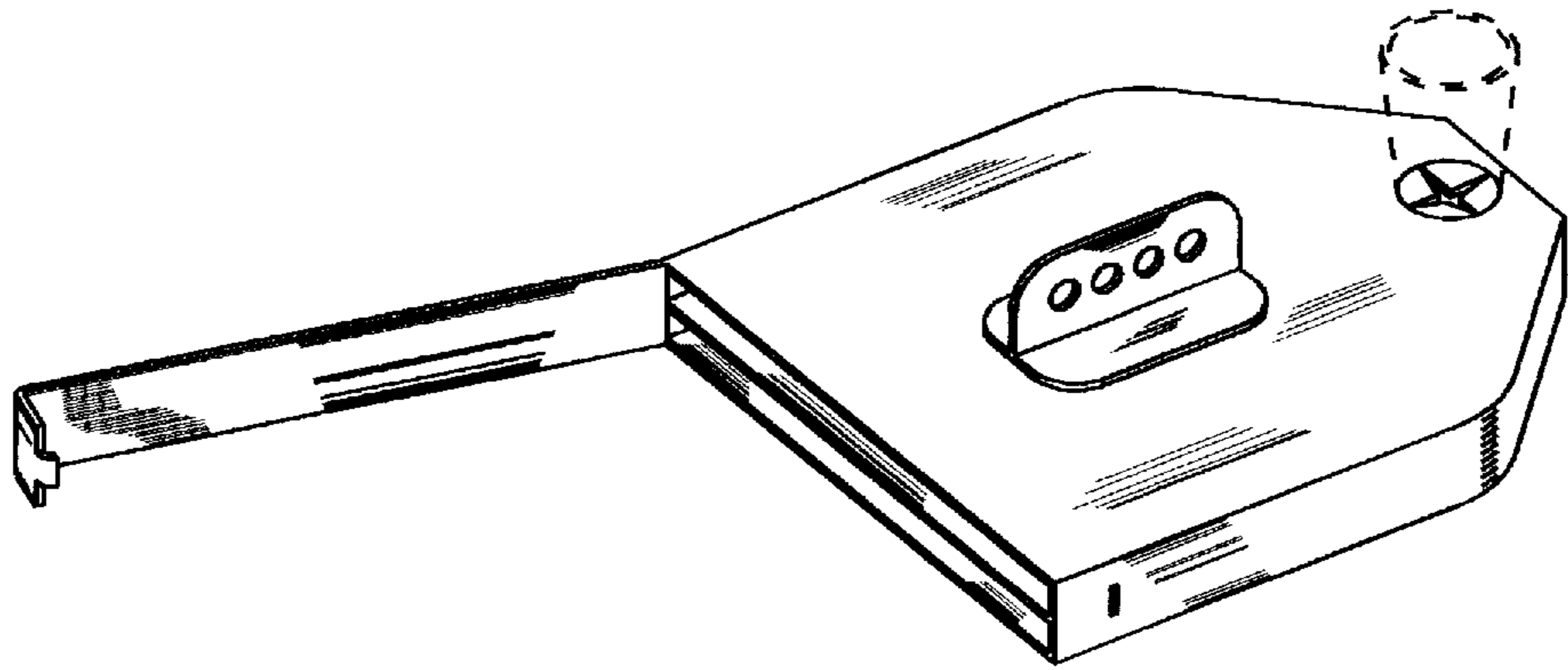

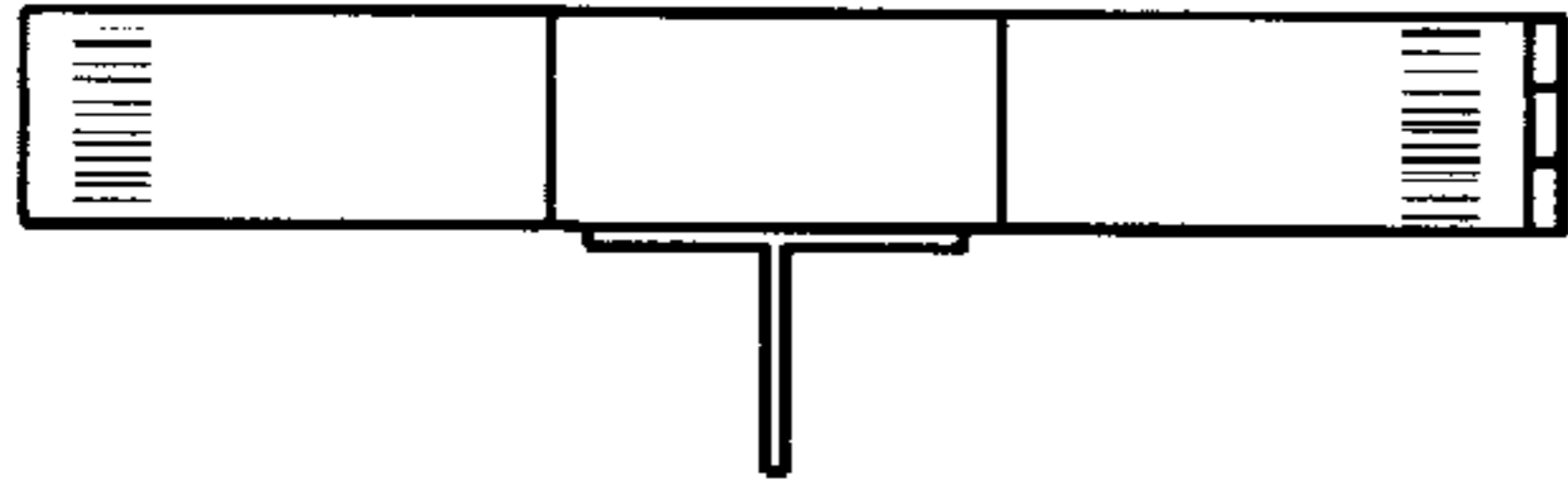

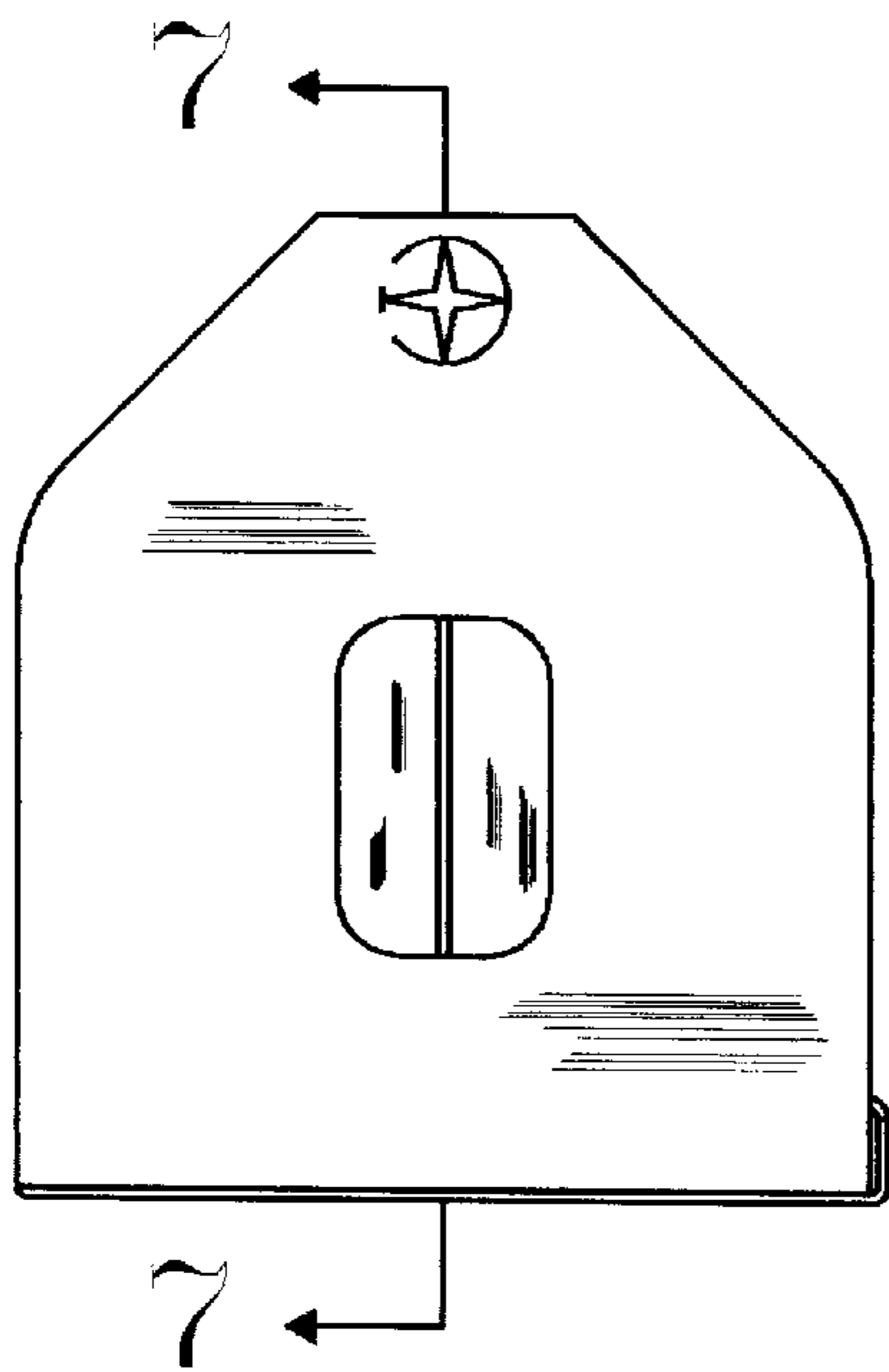

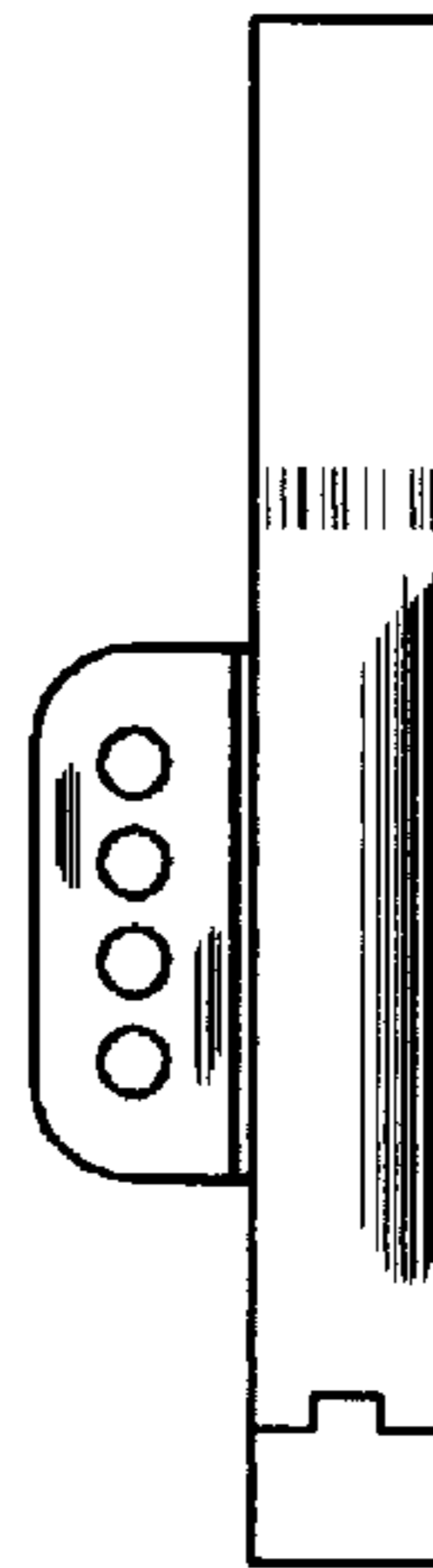

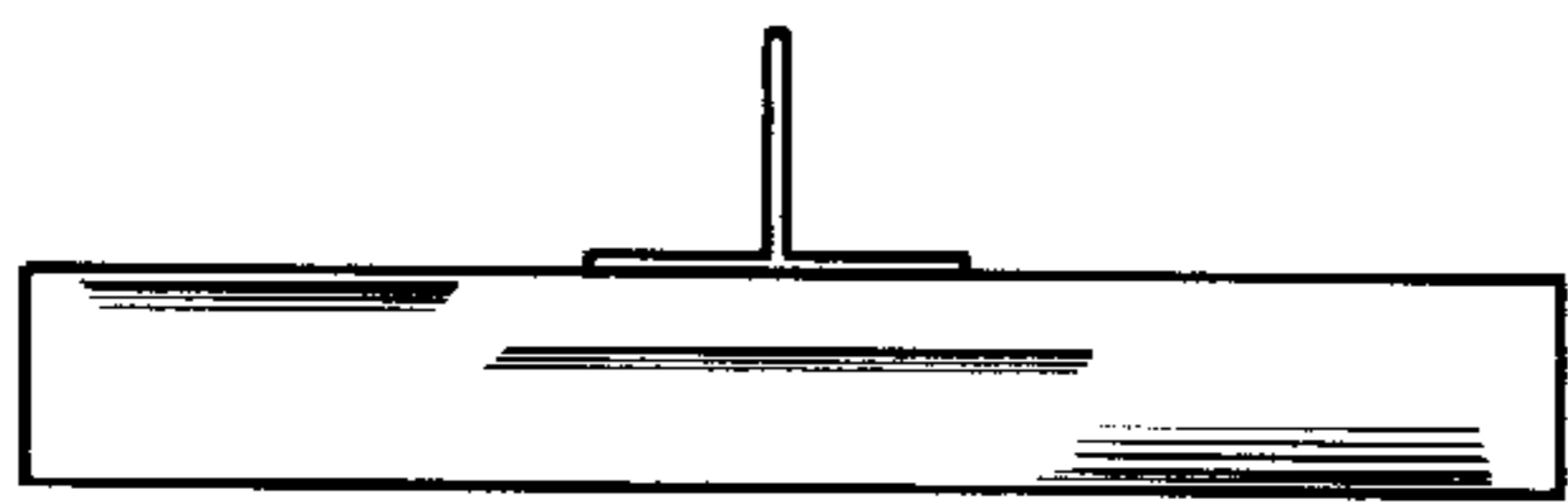

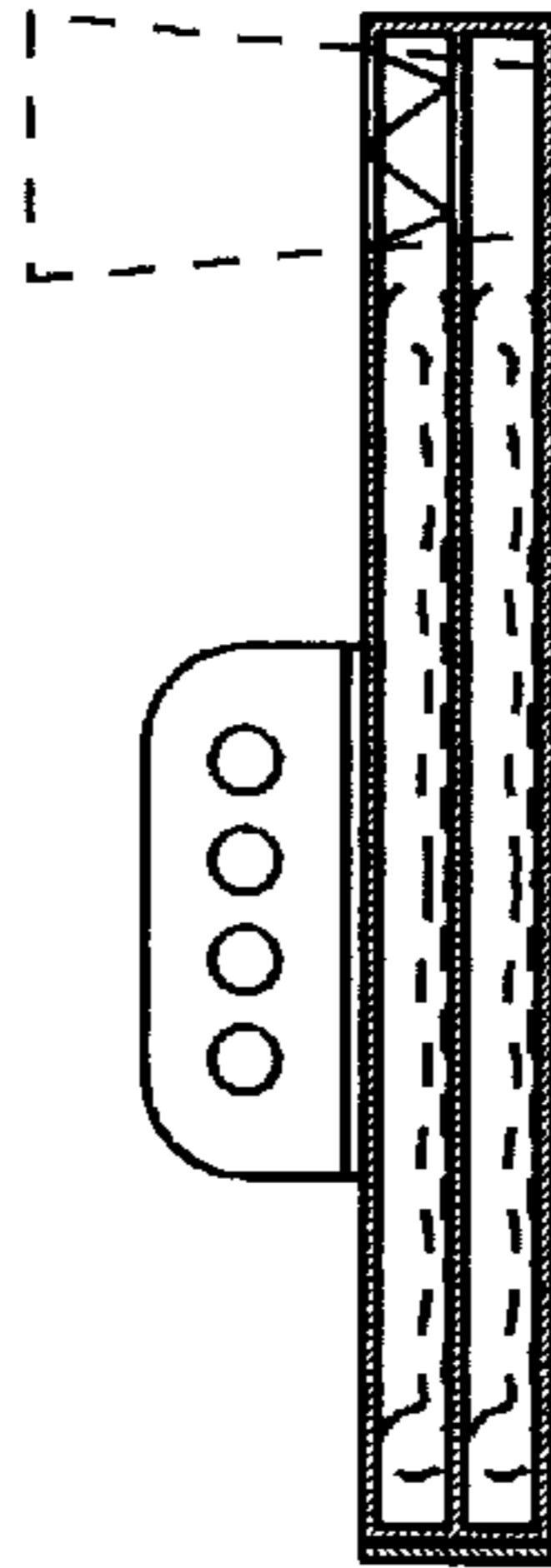
