[57] CLAIM

The ornamental design for a housing of a hand-held type portable telephone, as shown and describe.

DESCRIPTION

FIG. 1 is a front, top, and left side perspective view of a housing of a hand-held type portable telephone showing my design, in a state where a lid portion thereof is closed.

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a cross-sectional view thereof, taken along a V—V line in FIG. 2;

FIG. 6 is a cross-sectional view thereof, taken along a VI—VI line in FIG. 2;

FIG. 7 is a right side elevational view thereof, showing a state where the lid portion thereof is partially opened;

FIG. 8 is a front elevational view thereof, showing a state where the lid portion thereof is fully opened;

FIG. 9 is a left side elevational view of that shown in FIG. 8;

FIG. 10 is a right side elevational view of that shown in FIG. 8;

FIG. 11 is a top plan view of that shown in FIG. 8;

FIG. 12 is a bottom plan view of that shown in FIG. 8;

FIG. 13 is a rear elevational view of that shown in FIG. 8;

FIG. 14 is a front, top, and left side perspective view of a second embodiment of the housing of the hand-held type portable telephone shown in FIGS. 1-13, in a state where a lid portion thereof is closed.

FIG. 15 is a front elevational view of that shown in FIG. 14;

FIG. 16 is a right side elevational view of that shown in FIG. 14;

FIG. 17 is a bottom plan view of that shown in FIG. 14;

FIG. 18 is a cross-sectional view thereof, taken along a XVIII—XVIII line in FIG. 15;

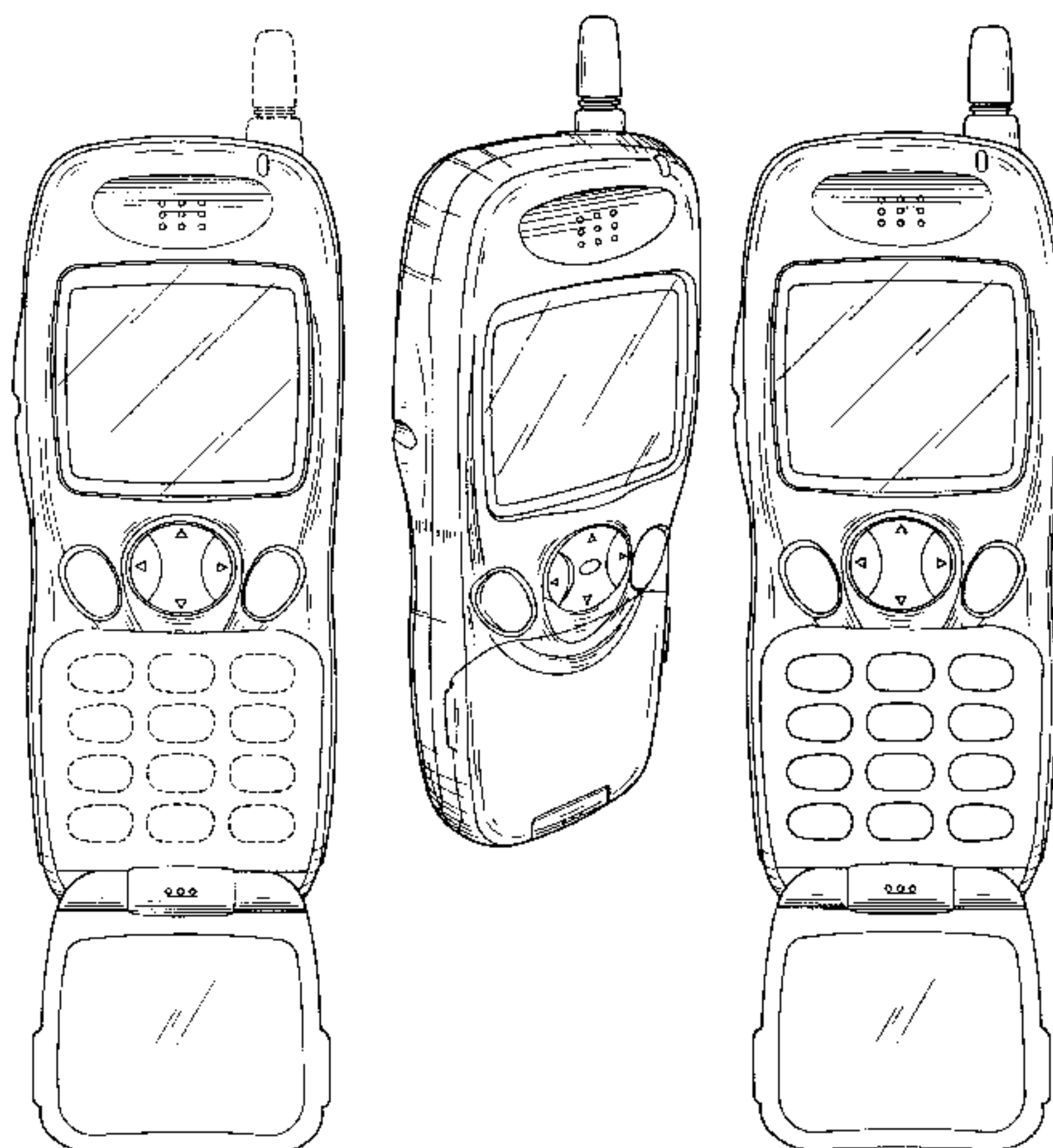


FIG. 19 is a right side elevational view thereof, showing a state where the lid portion thereof is partially opened;

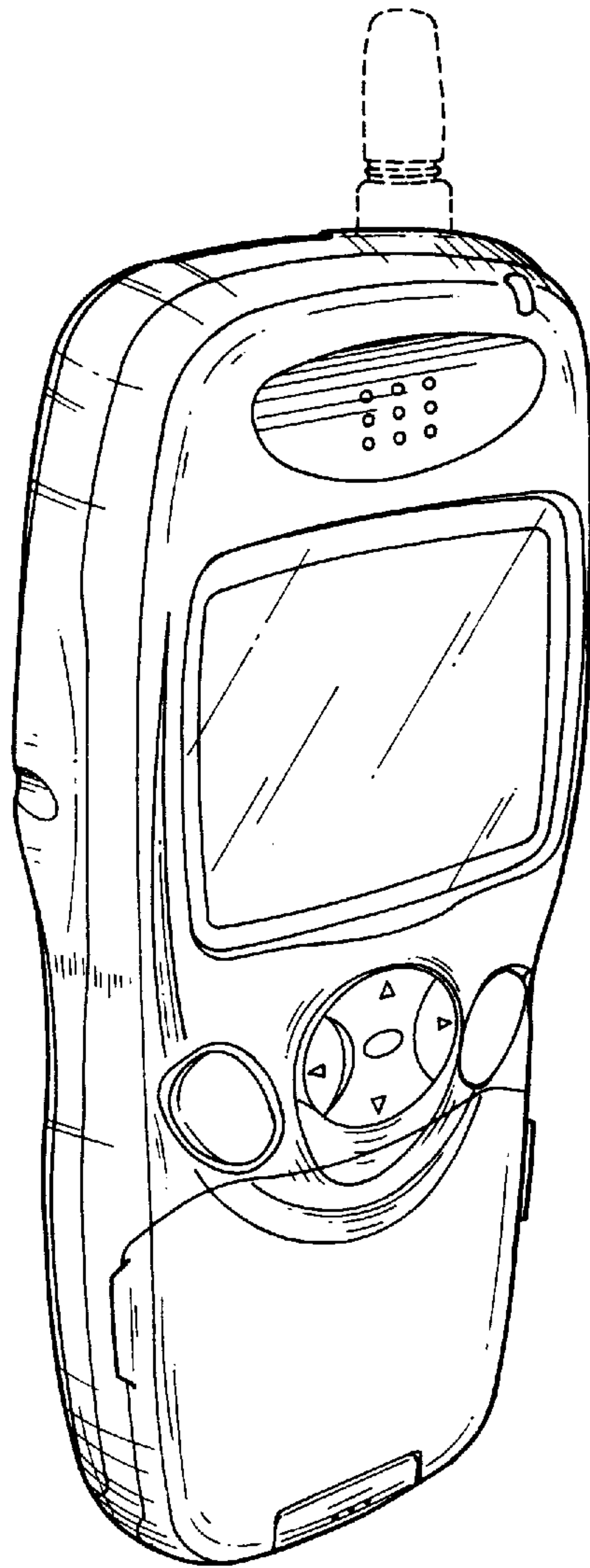

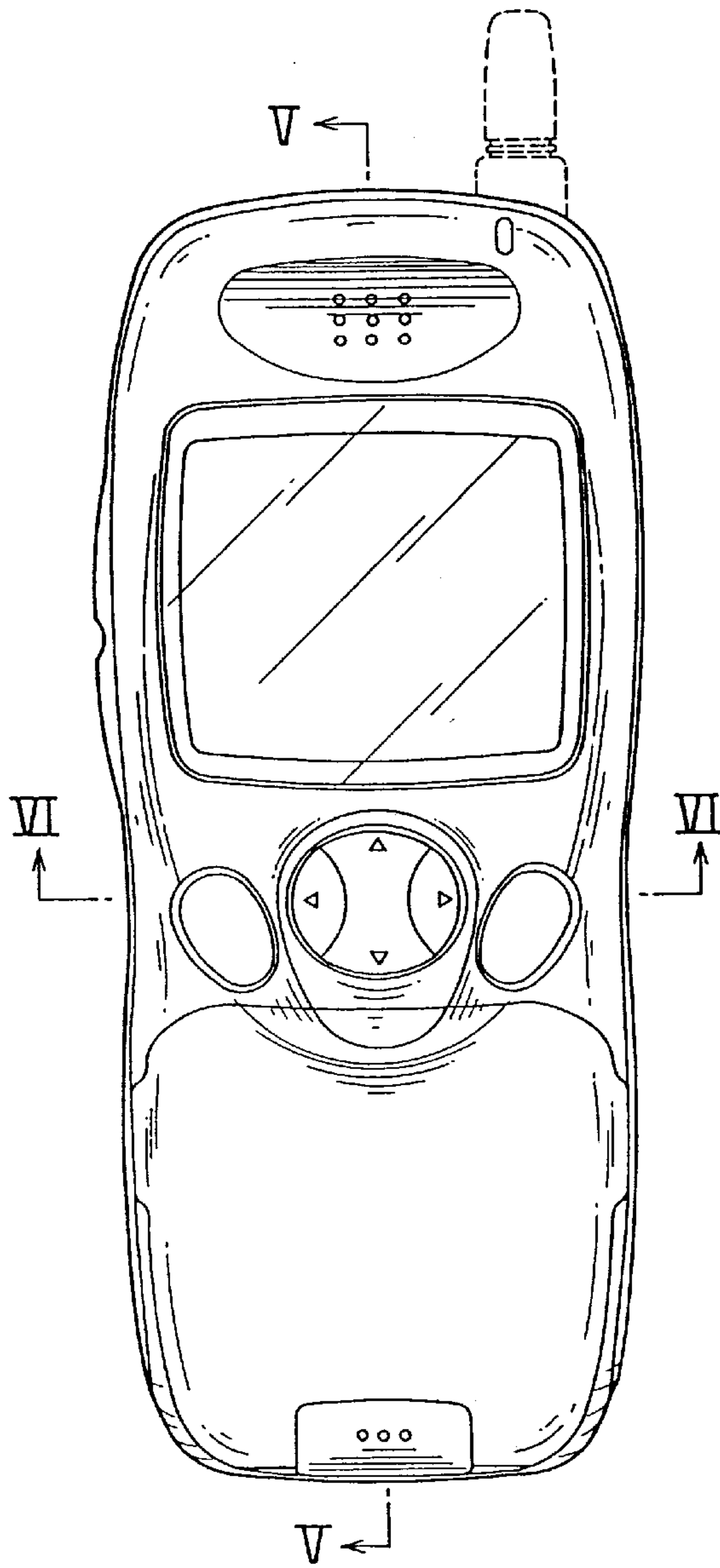

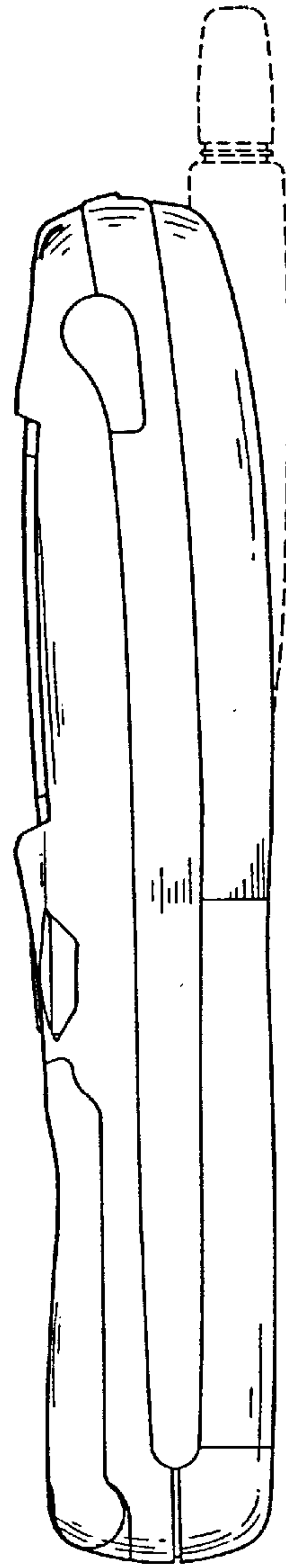

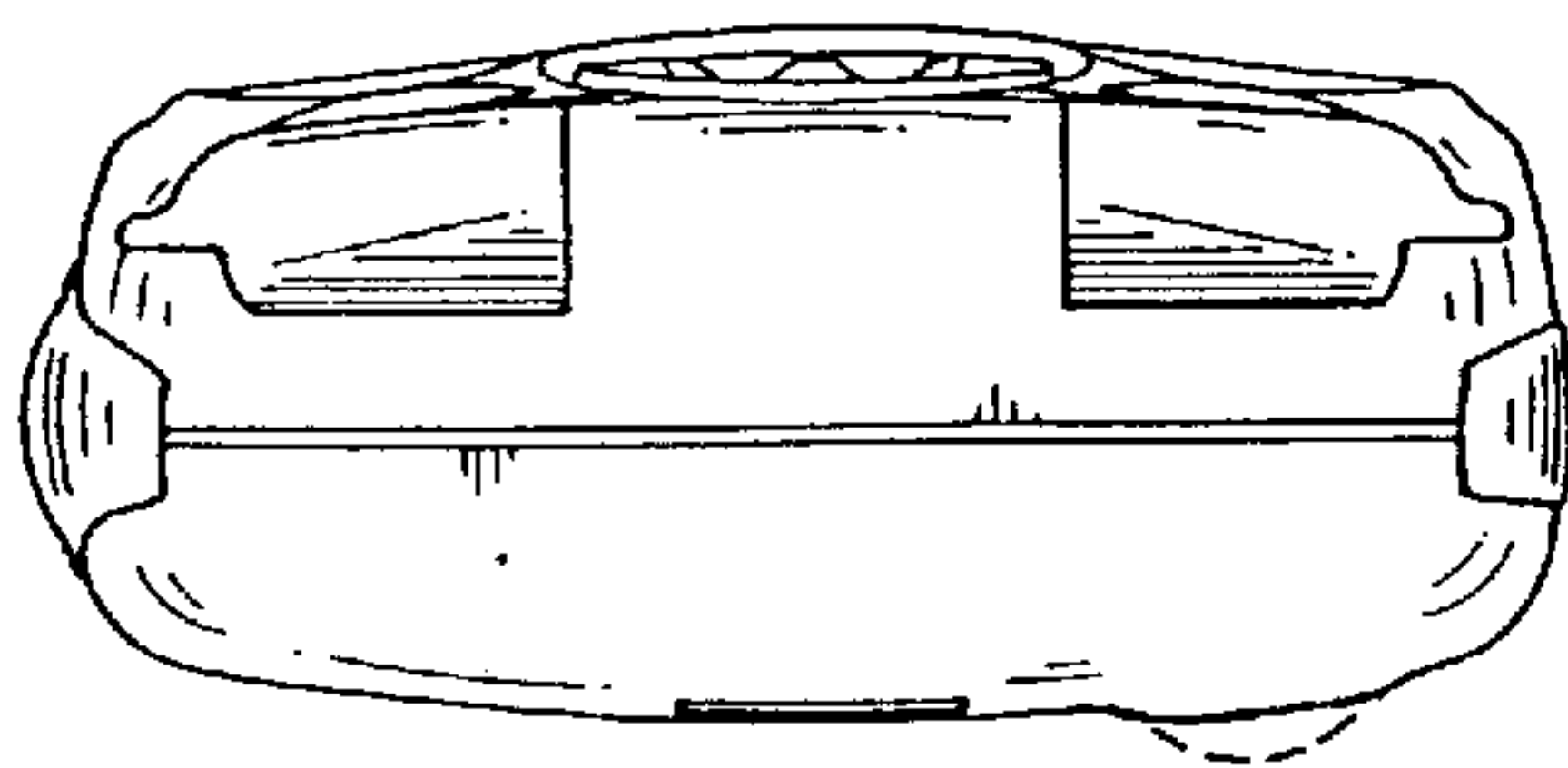

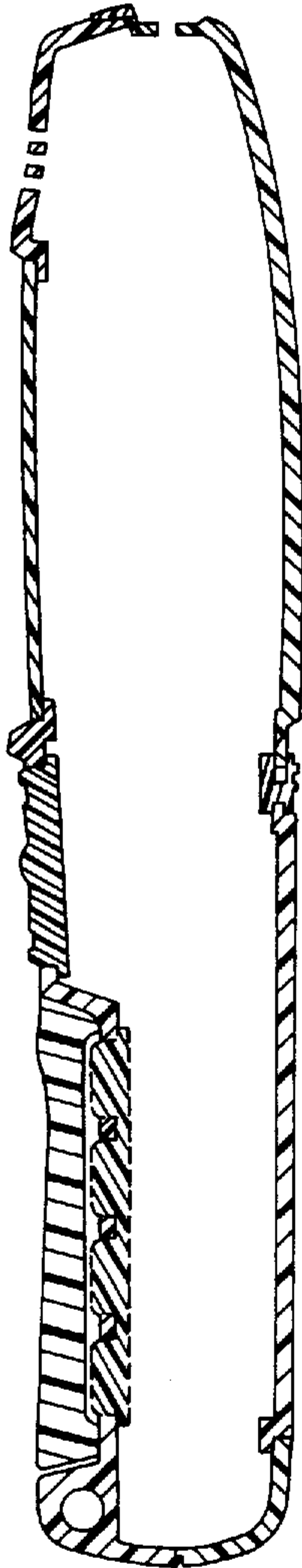

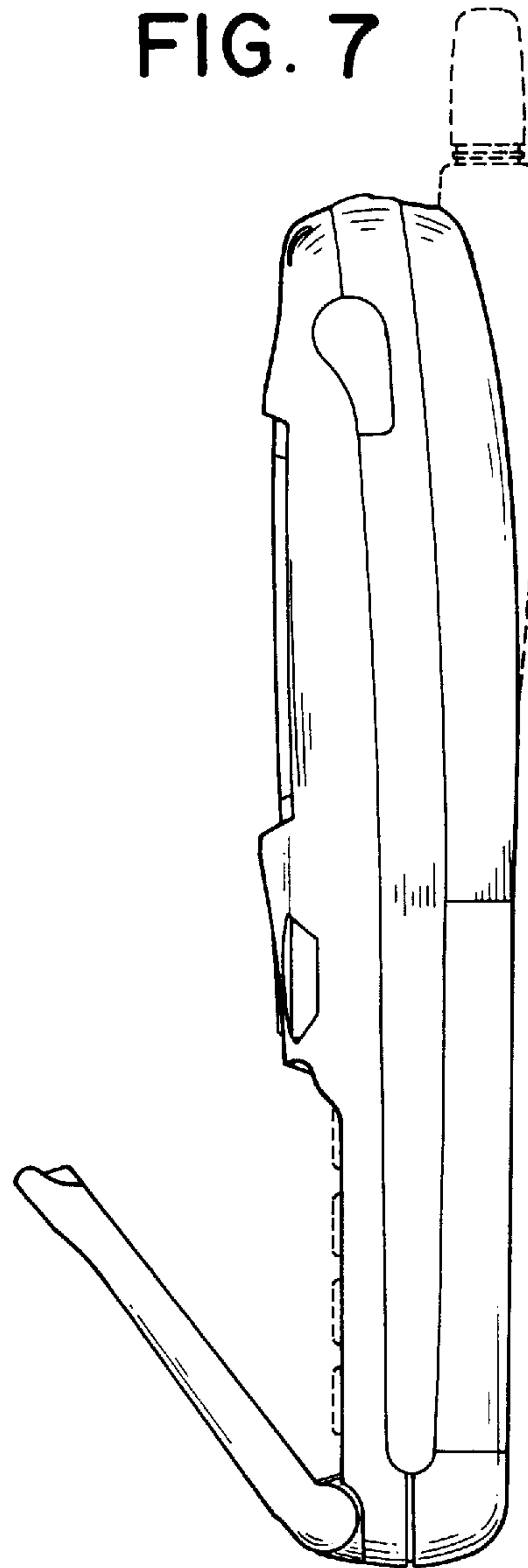

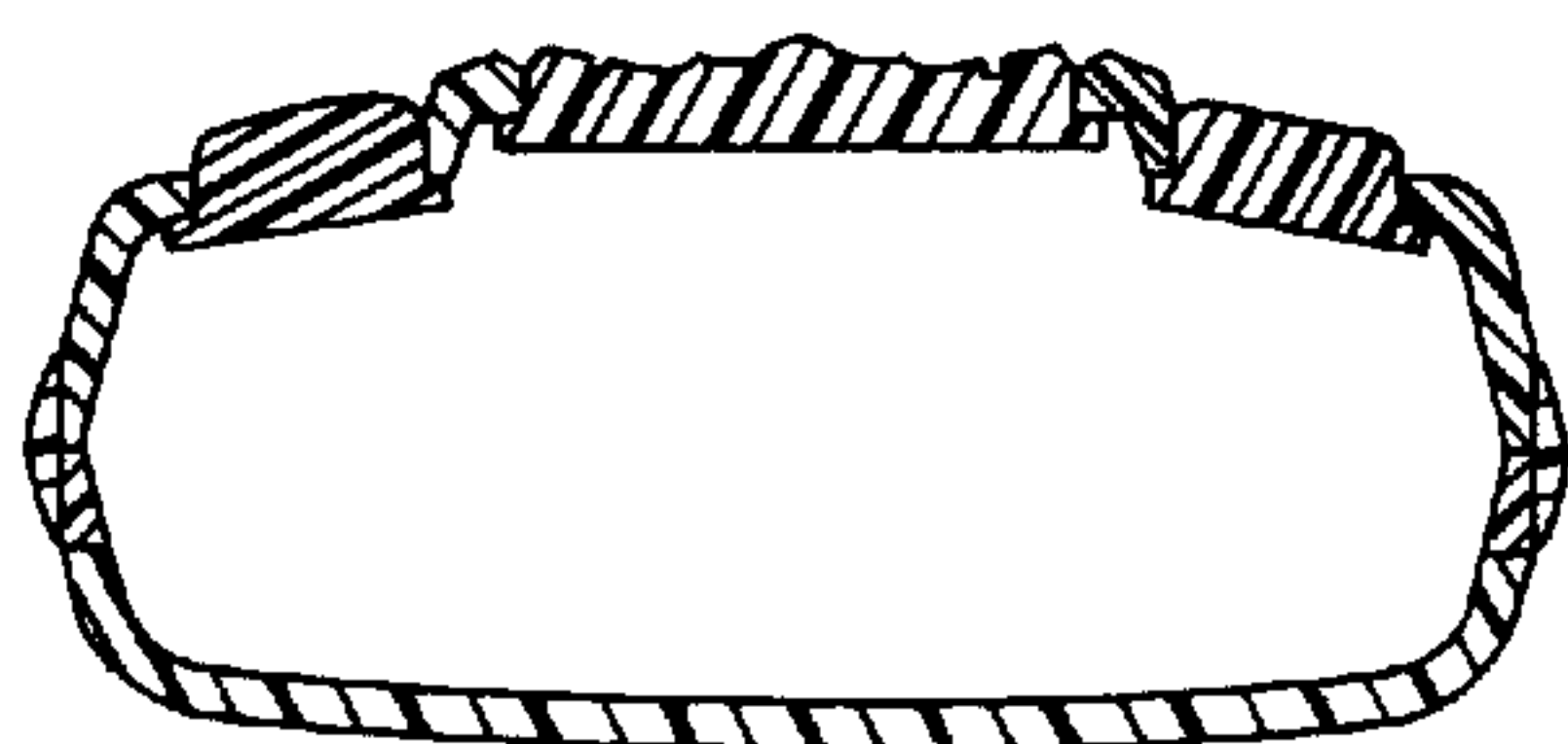

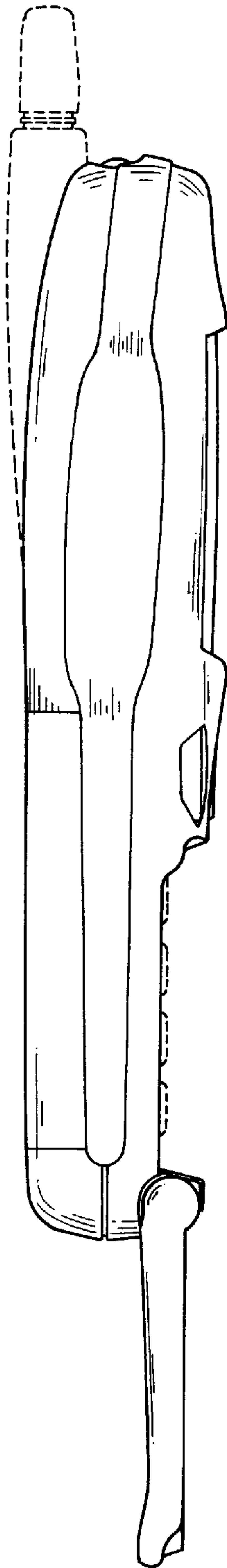

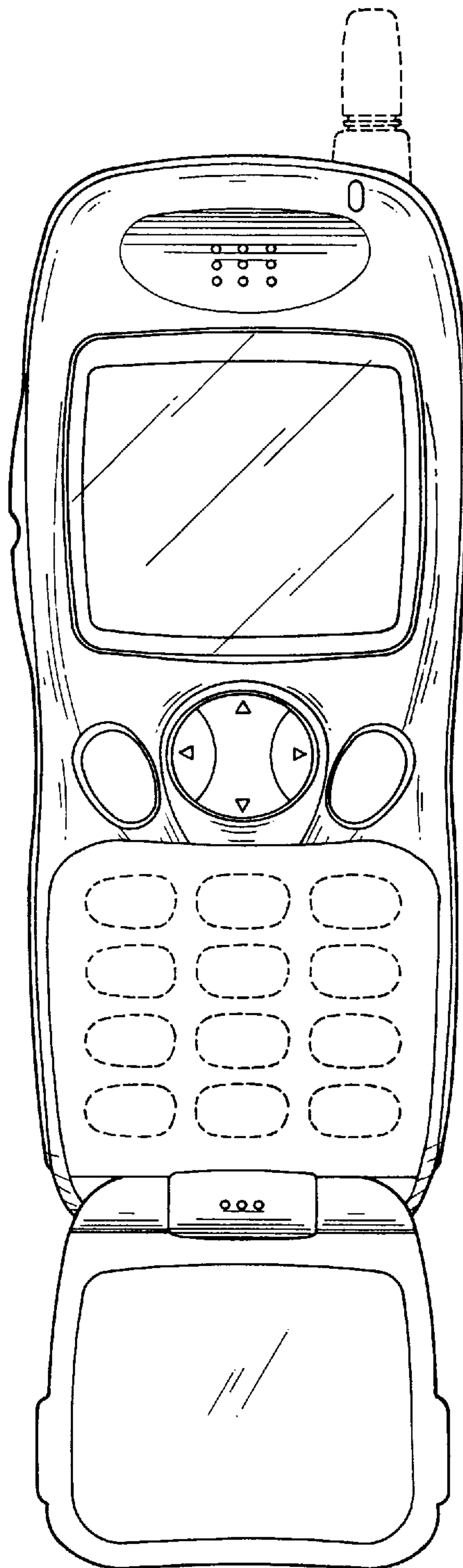

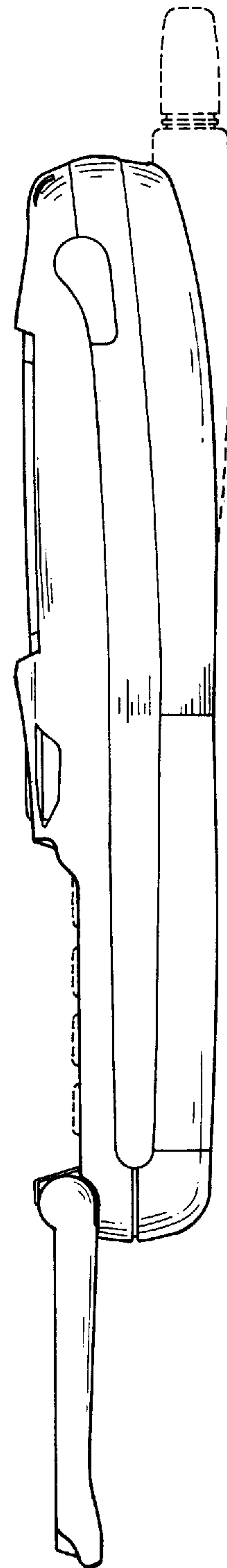

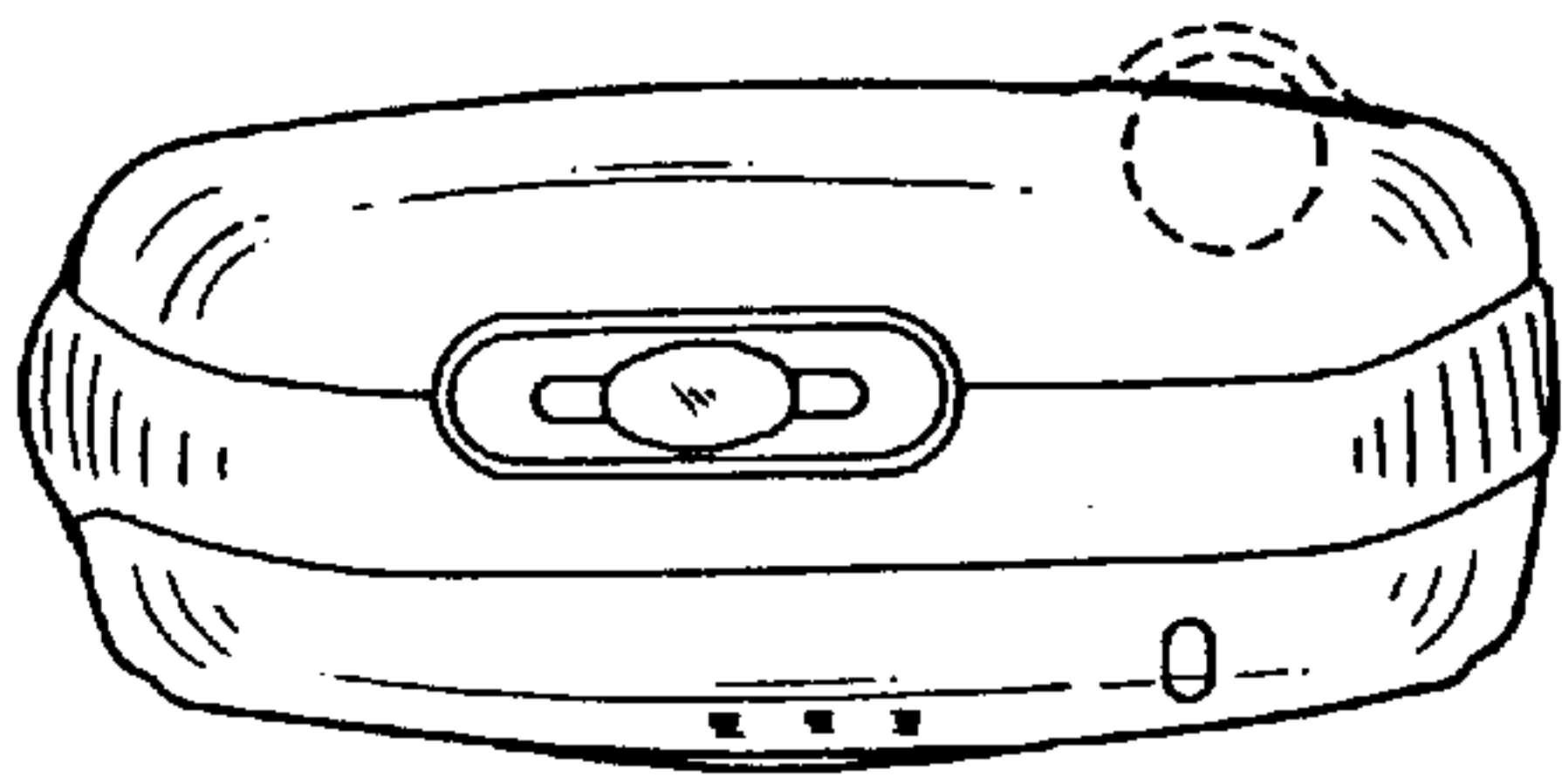

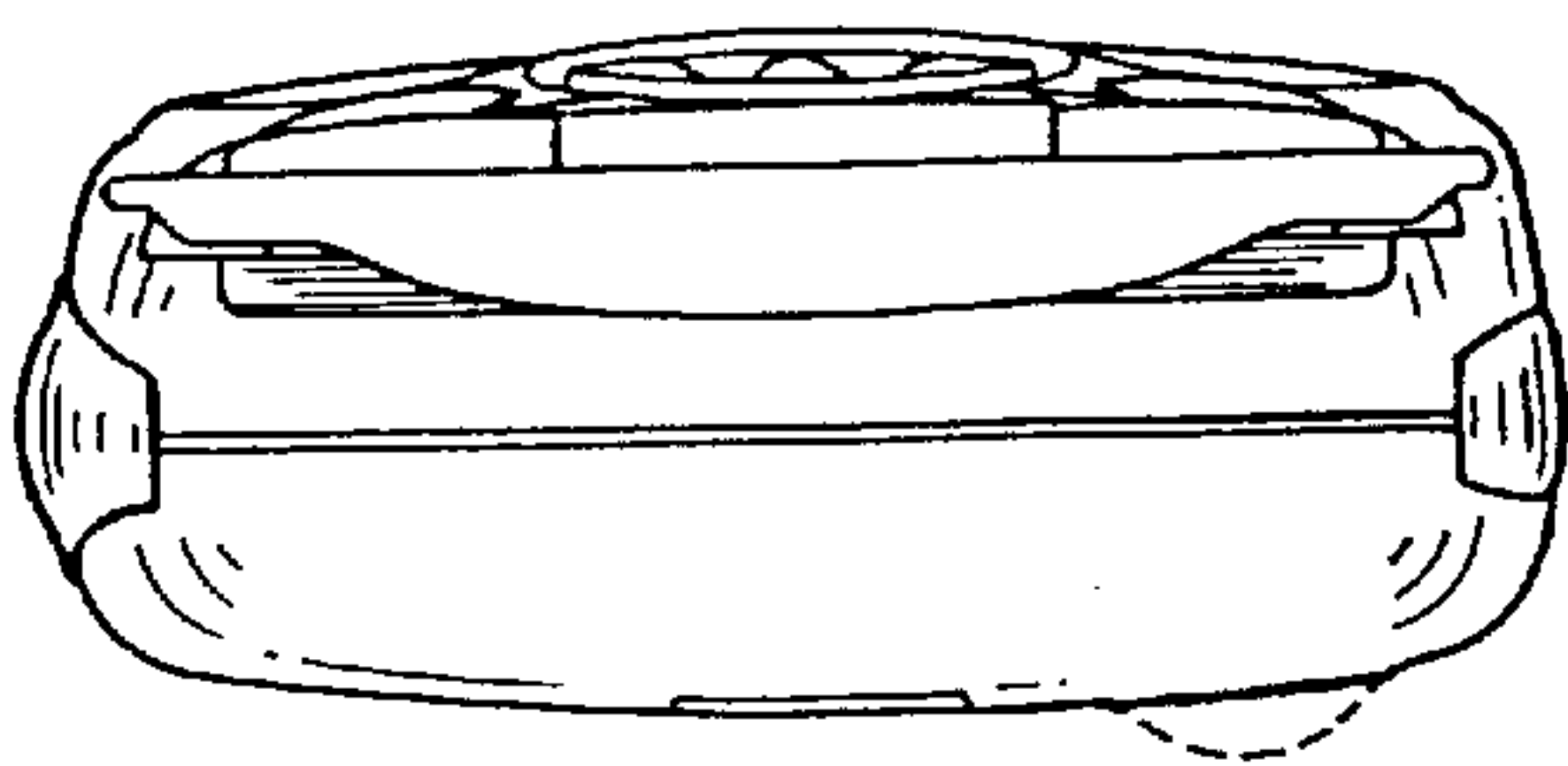

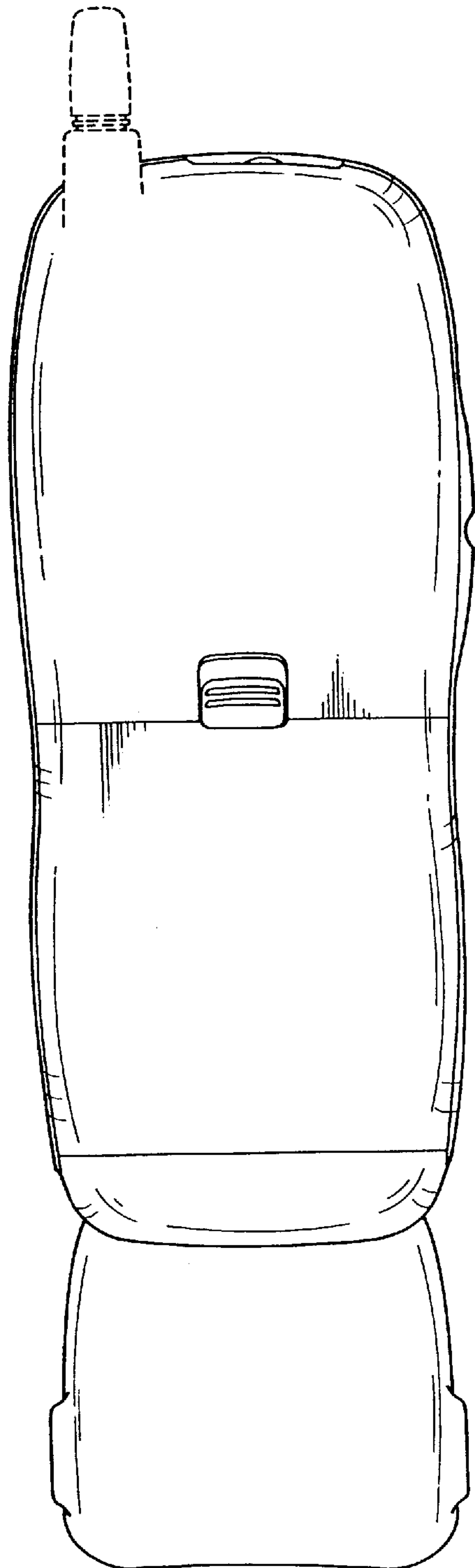

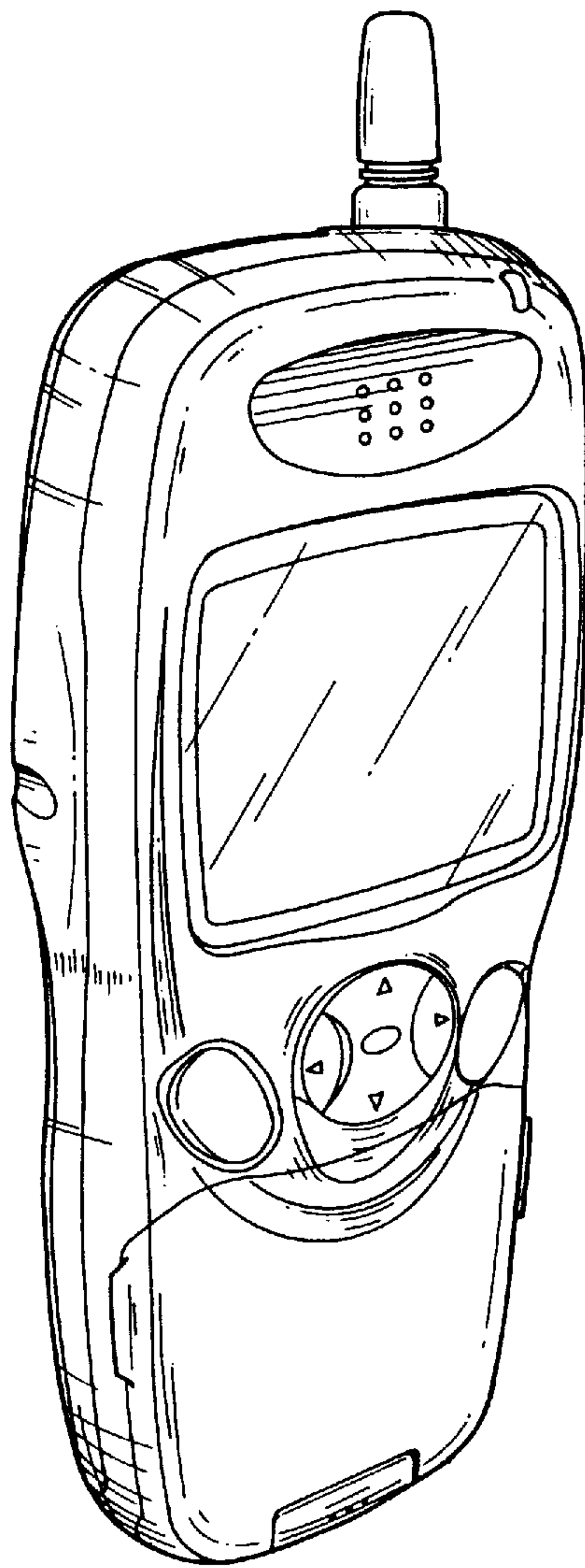

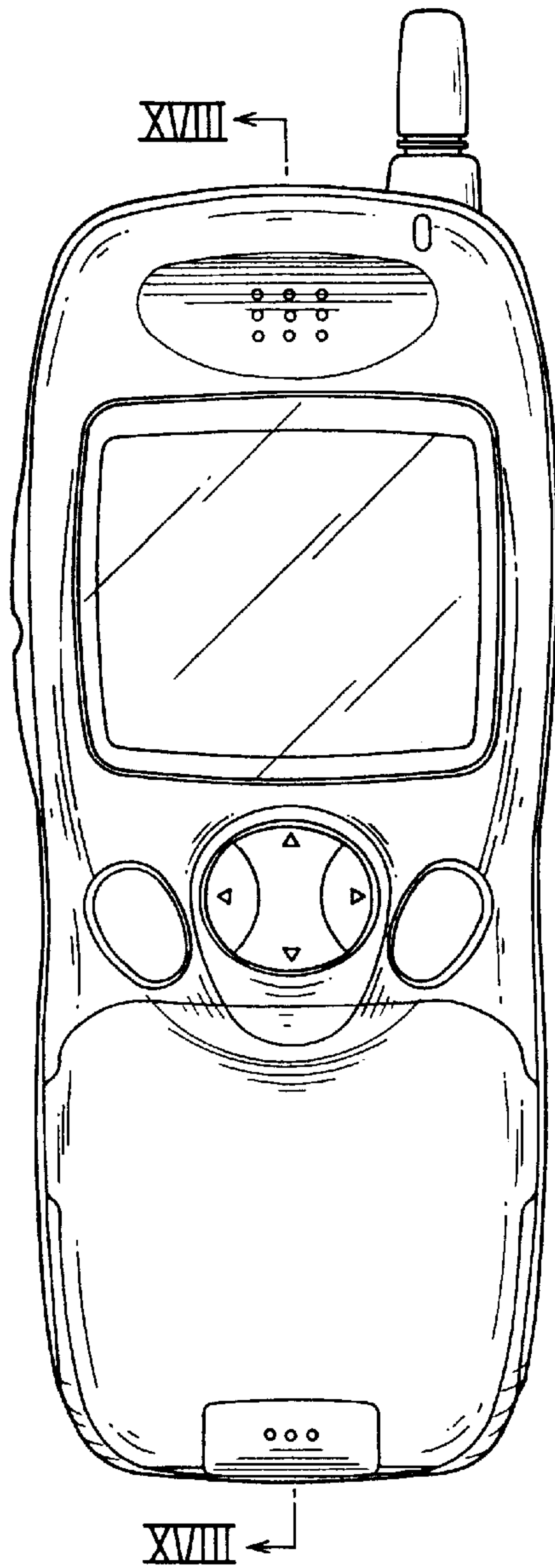

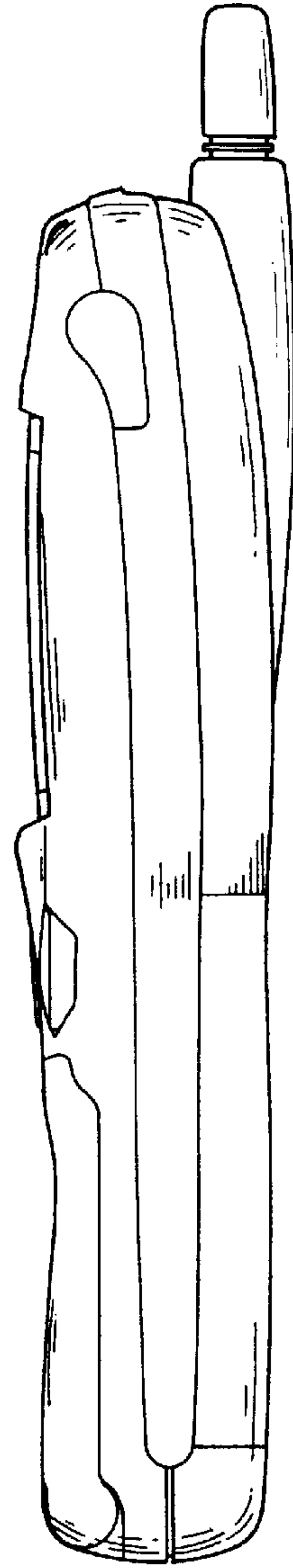

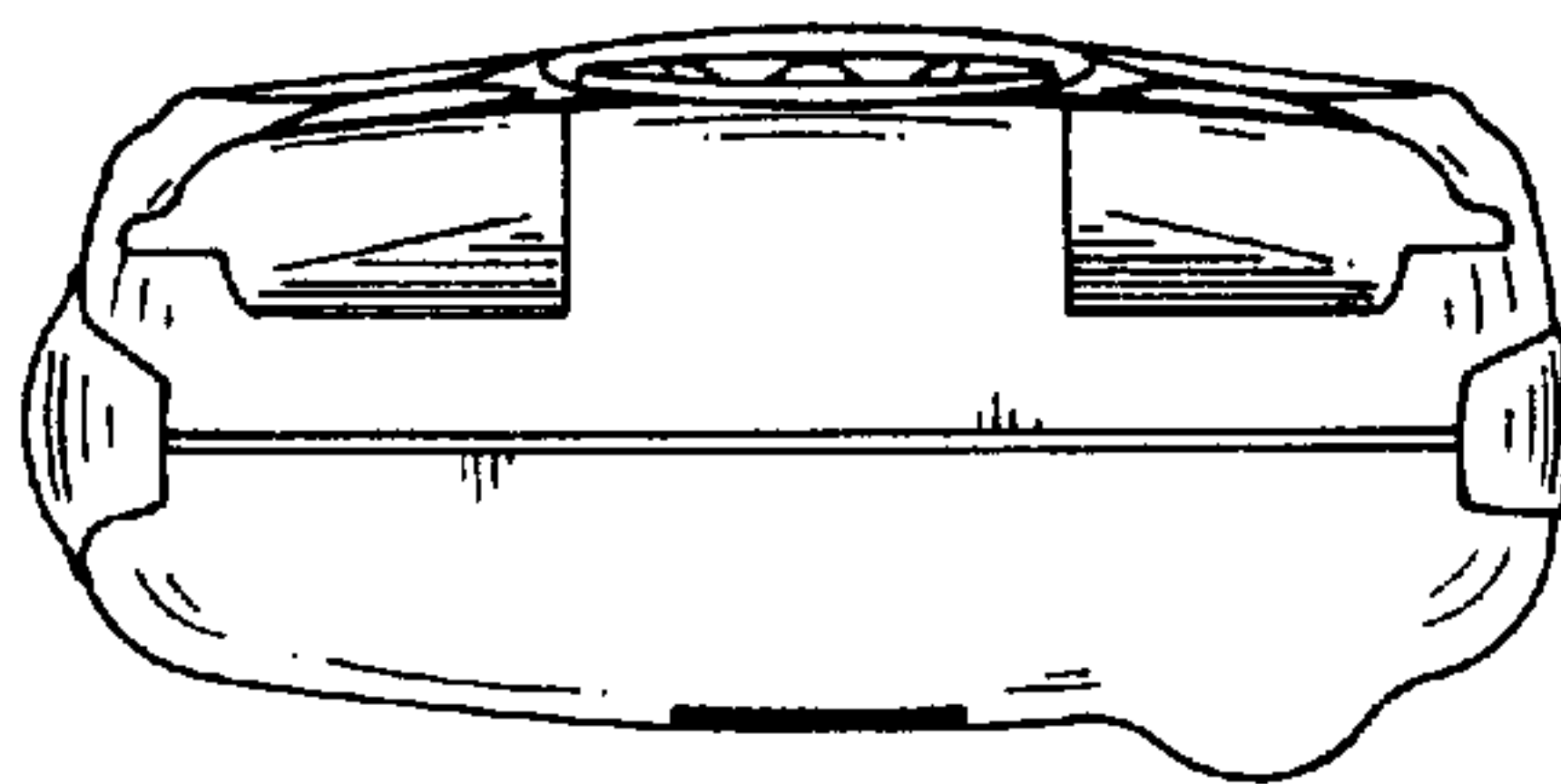

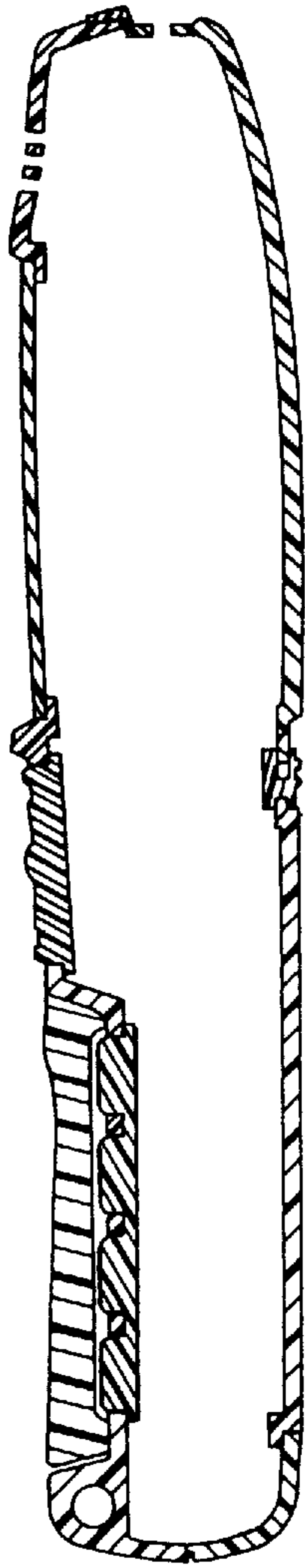

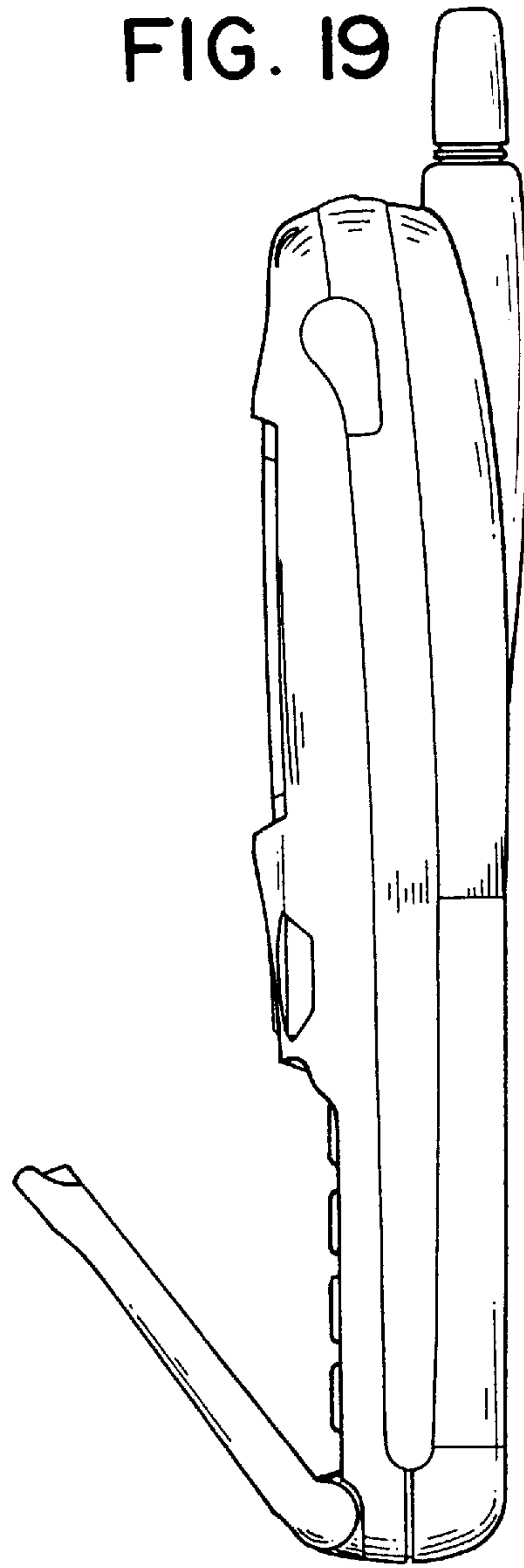

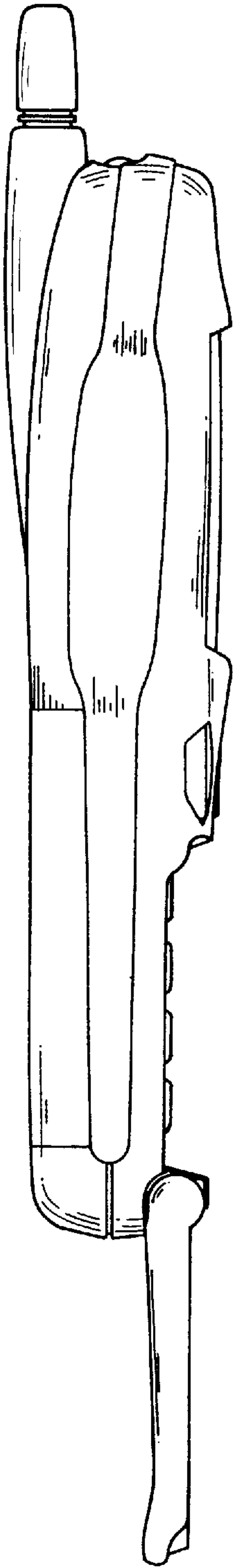

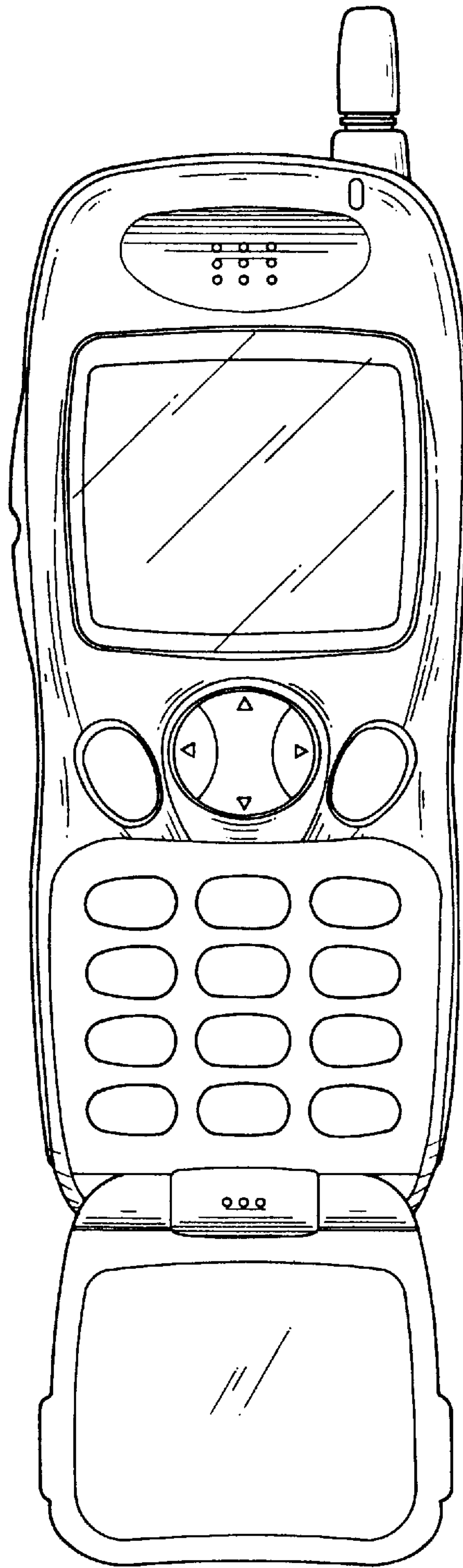

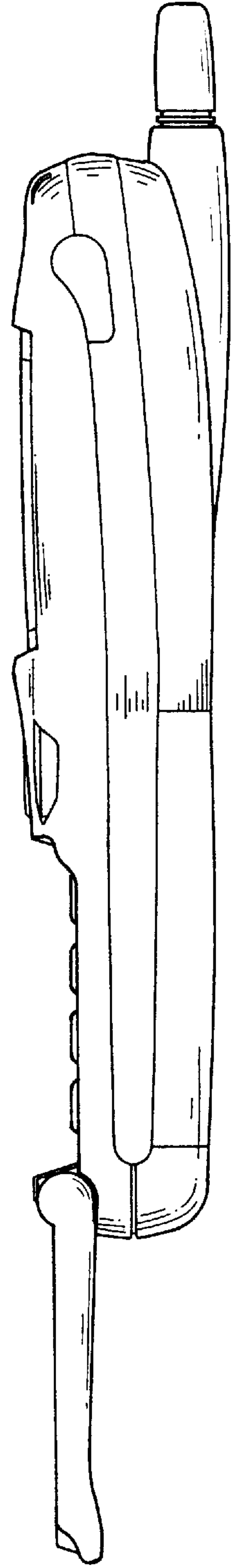

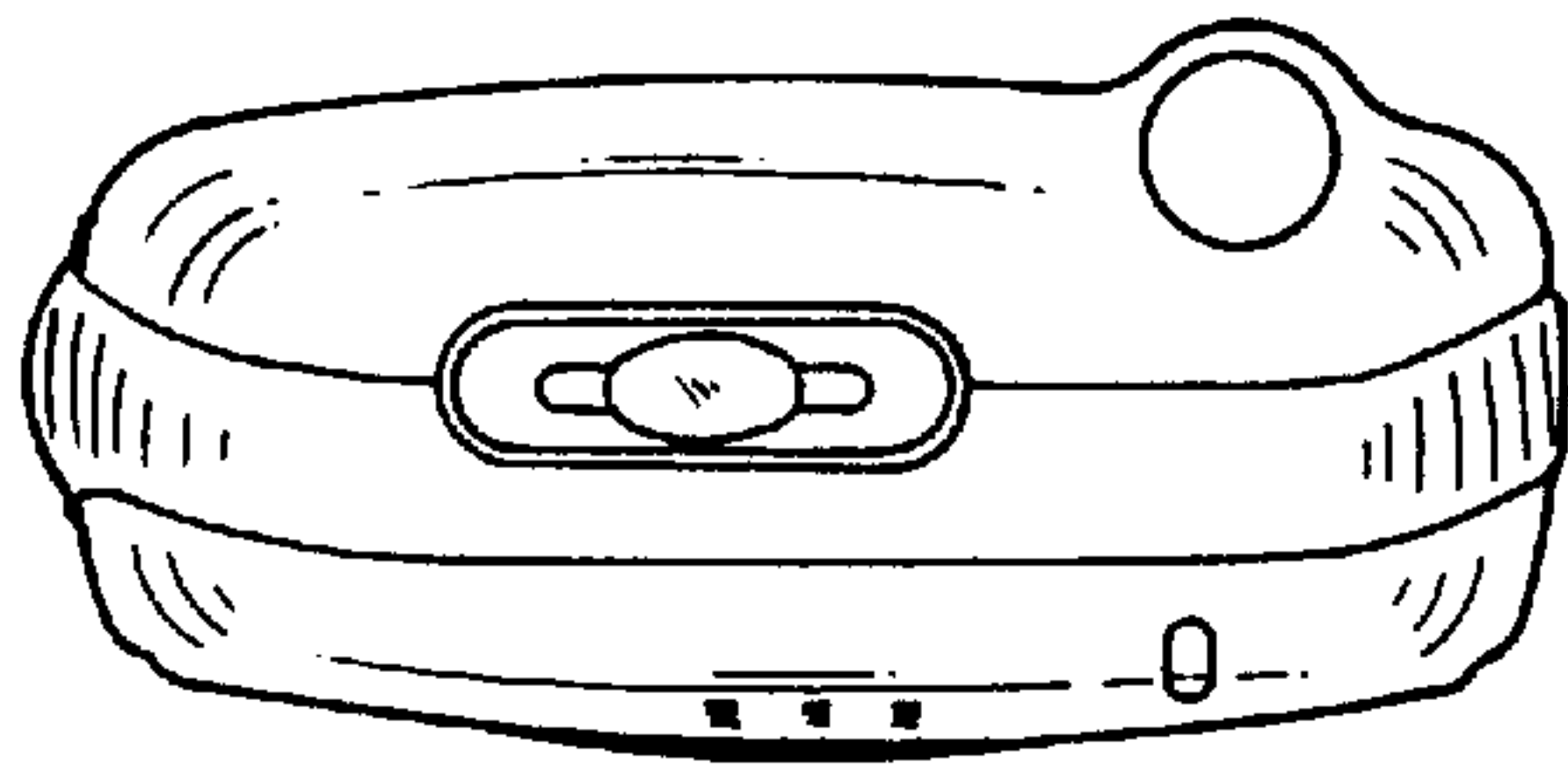

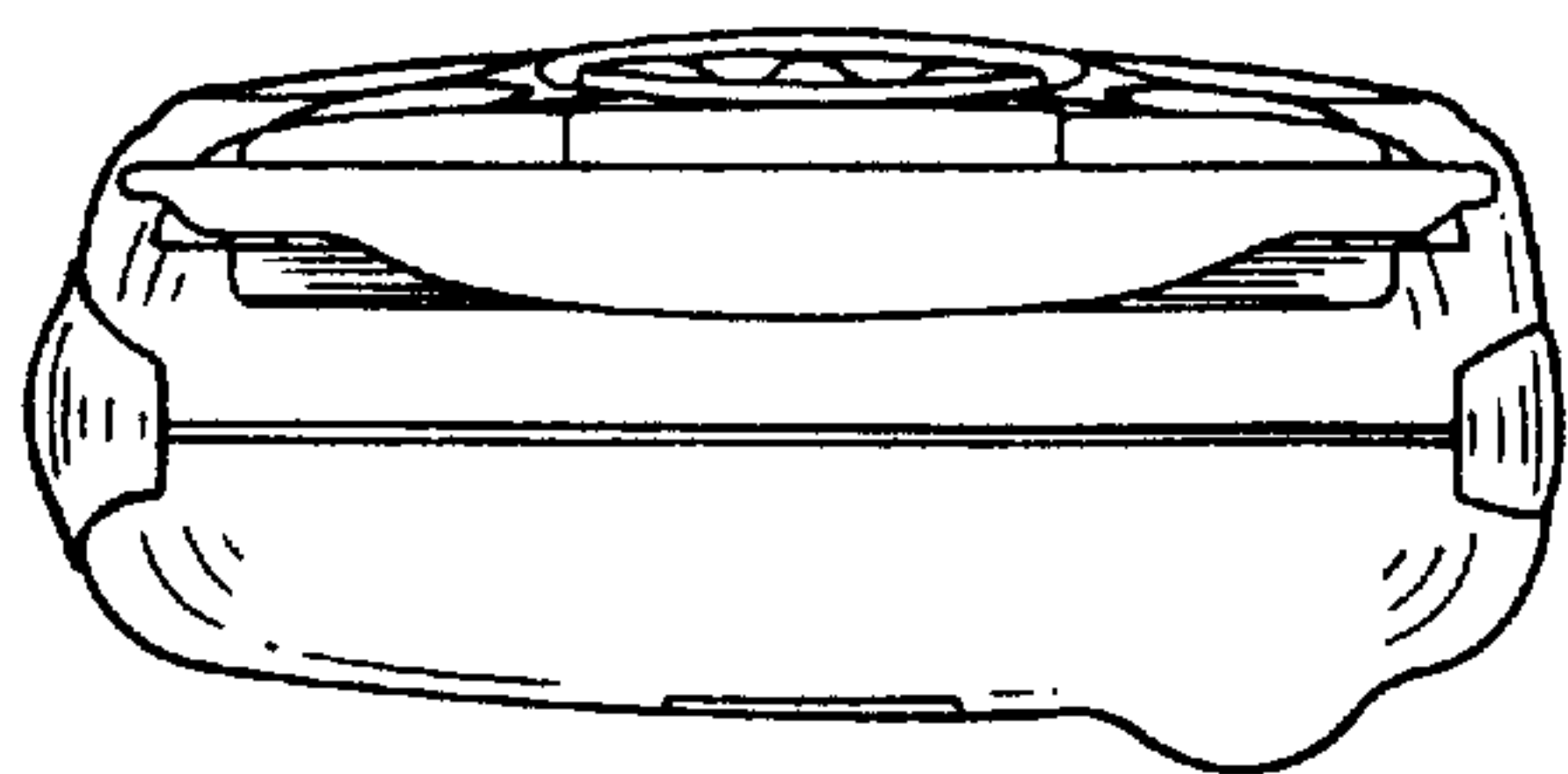
