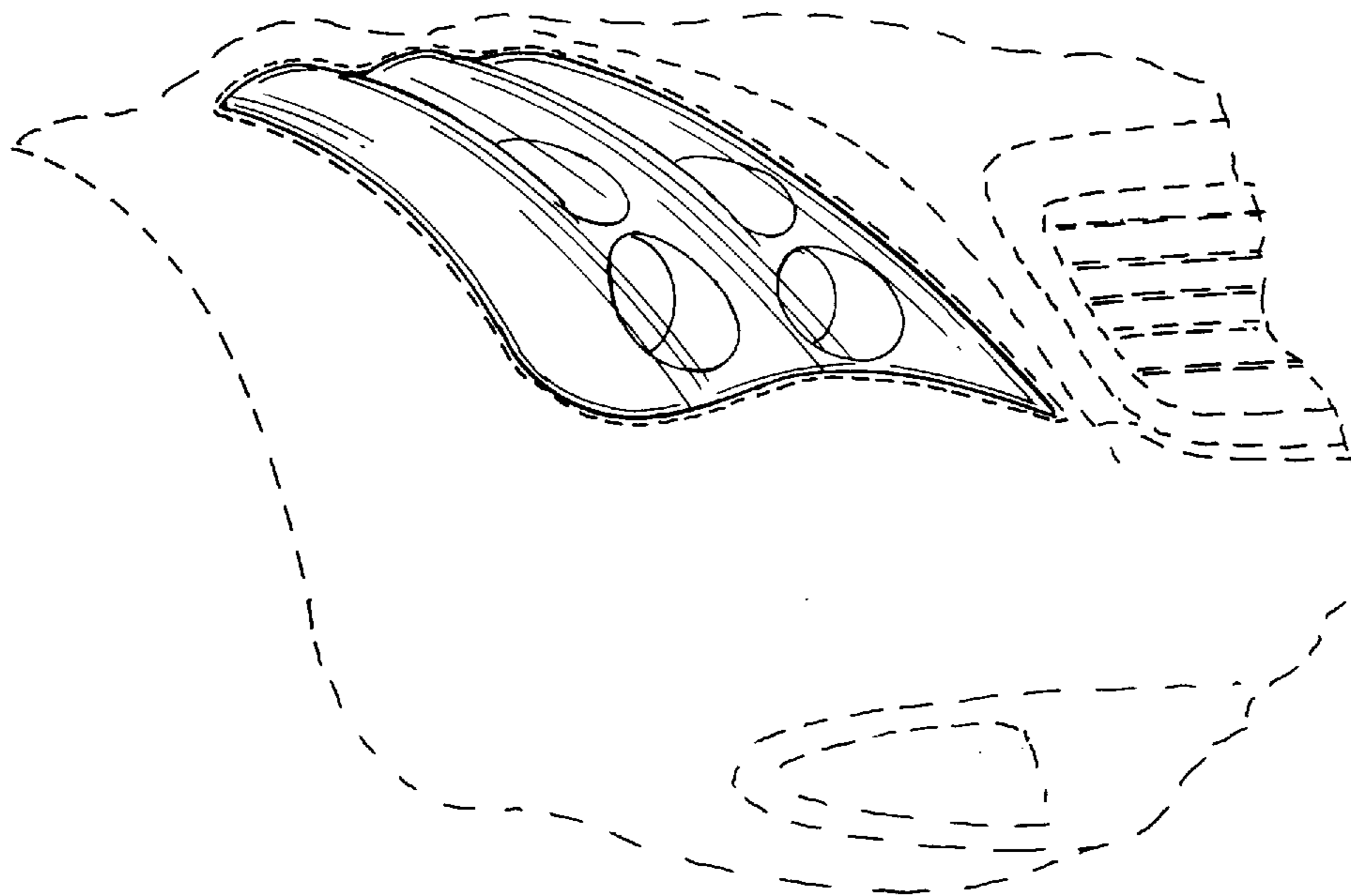
[57] **CLAIM**

The ornamental design for an exterior surface configuration of a front vehicle headlight, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an exterior surface configuration of a front vehicle headlight according to our novel design; FIG. 2 is a top view of an exterior surface configuration of a front vehicle headlight according to our novel design; FIG. 3 is a right side view of an exterior surface configuration of a front vehicle headlight according to our novel design; and, FIG. 4 is a perspective view from the front right of an exterior surface configuration of a front vehicle headlight according to our novel design; This design represents one embodiment of a design for exterior surface configuration of a front vehicle headlight. The drawings and descriptions represent the right side embodiment. The design also contemplates a mirror symmetrical embodiment on the left side of the vehicle. The dash line included denotes environment and is not part of the claimed design.

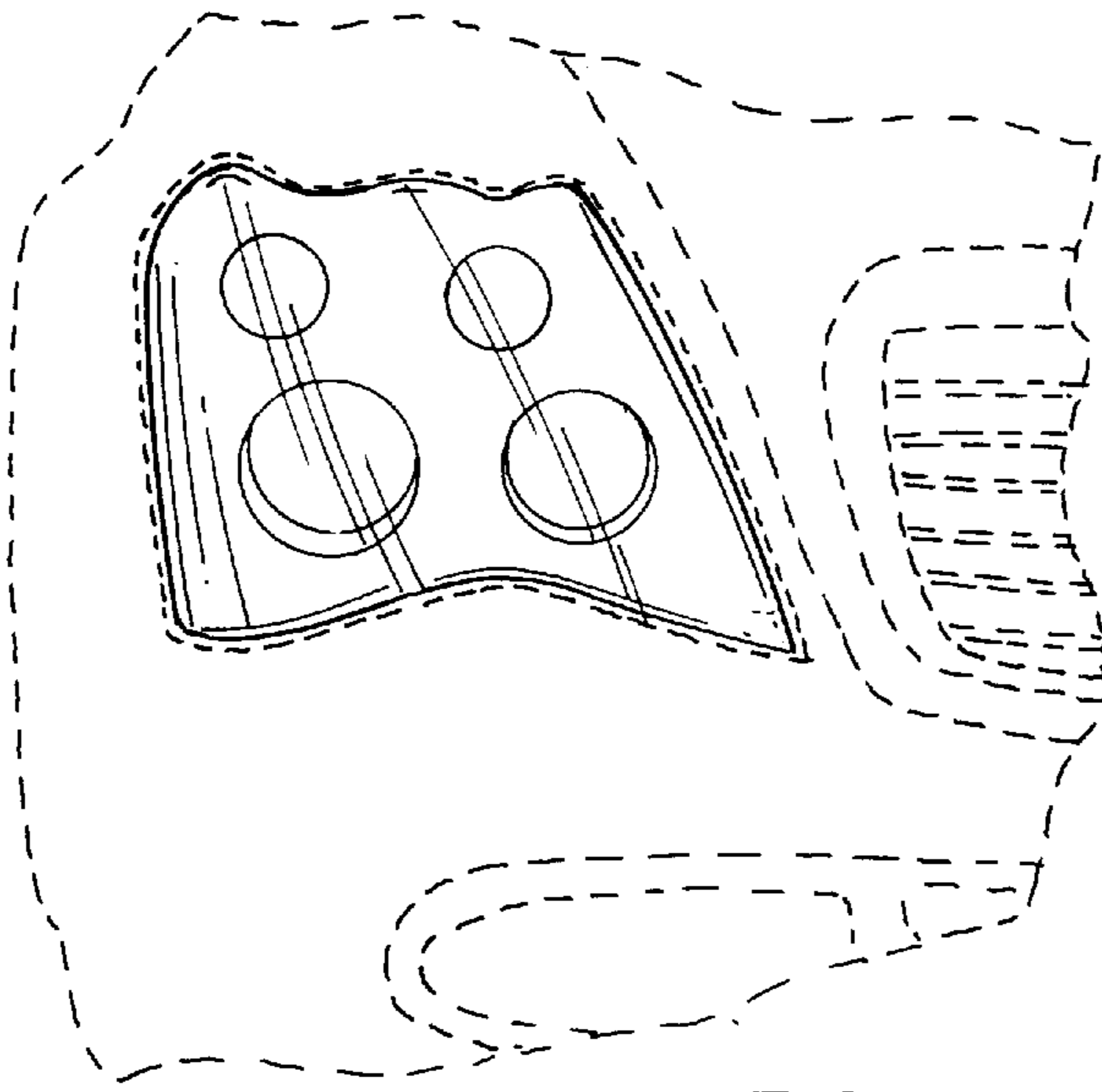

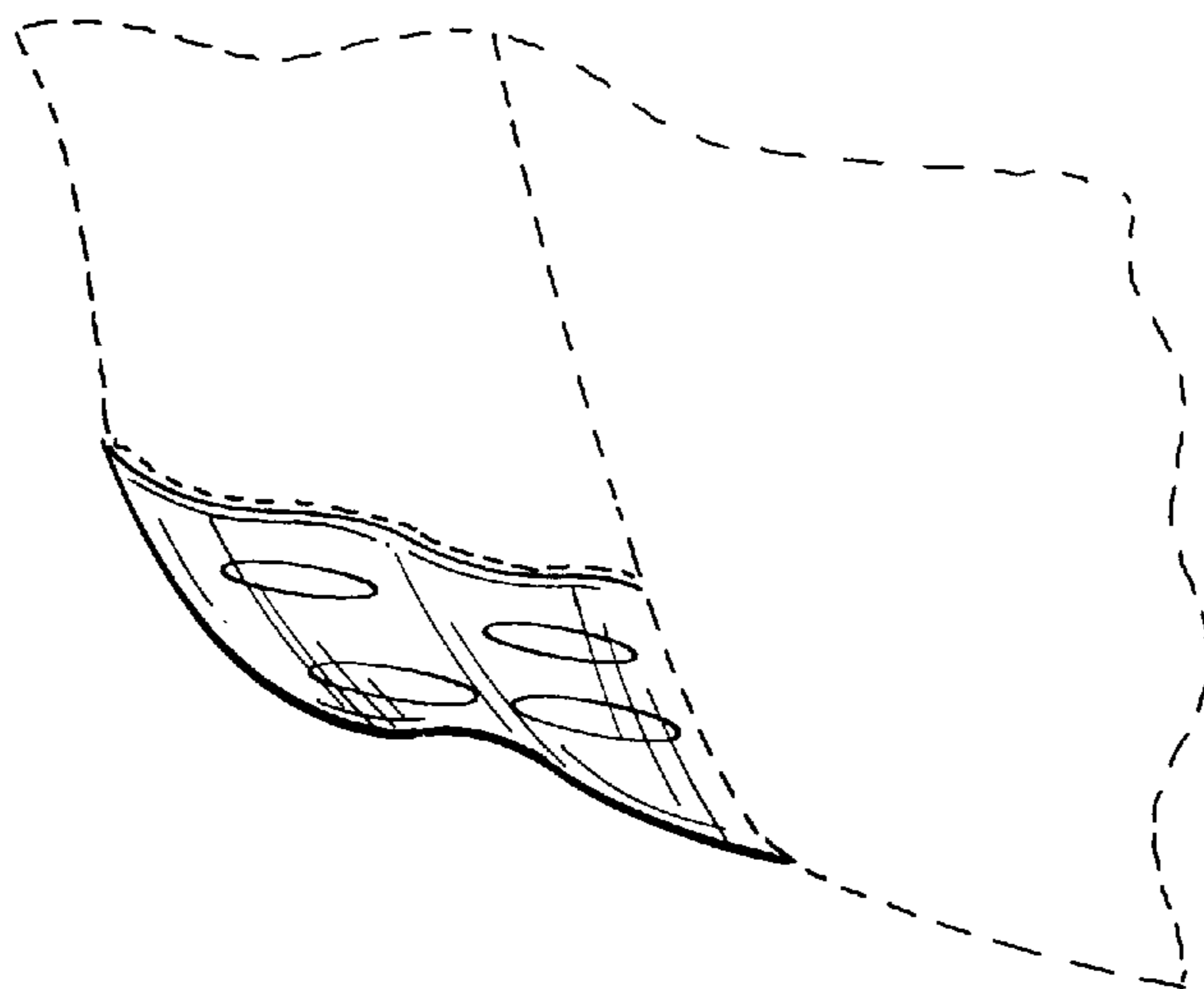

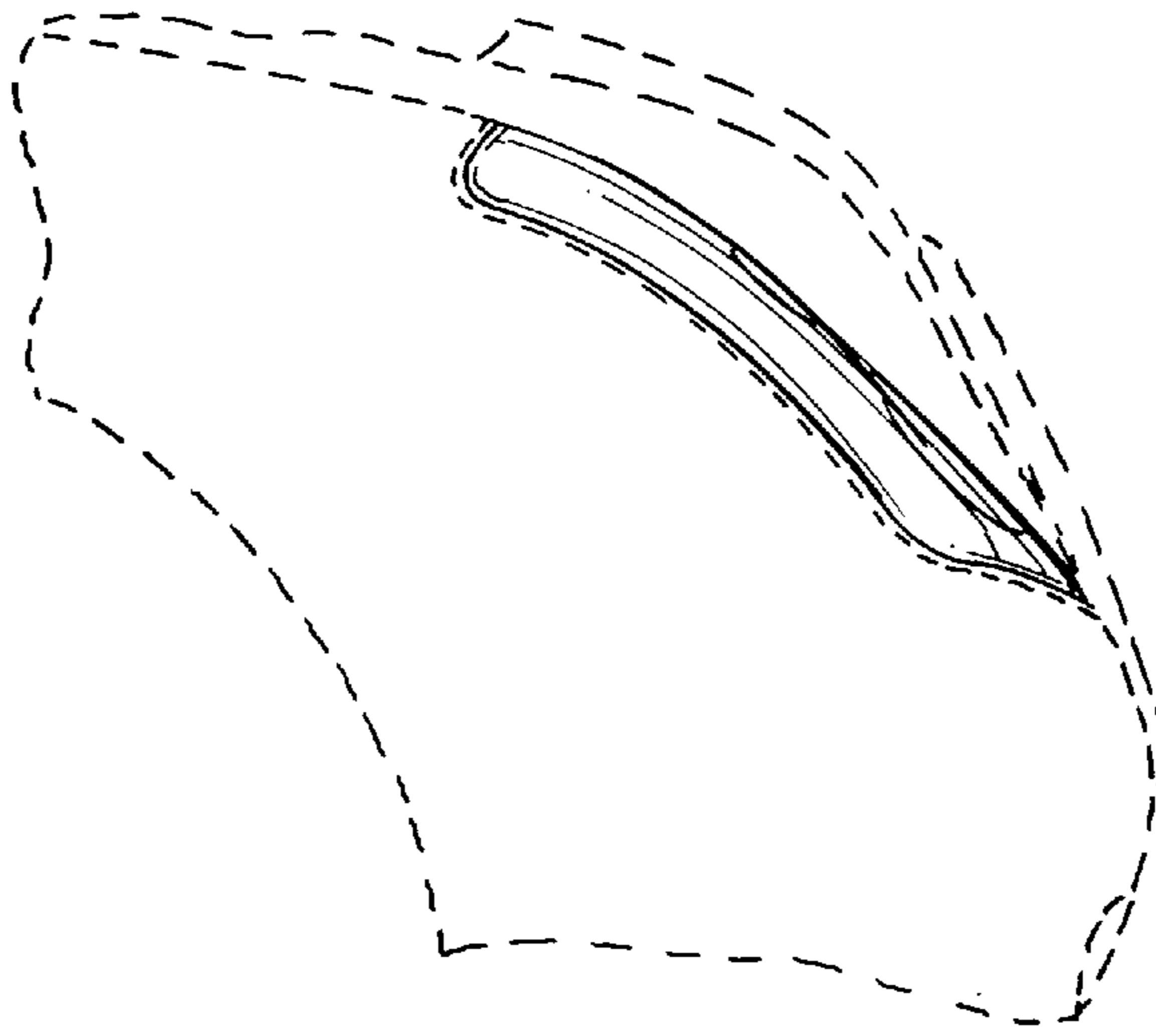

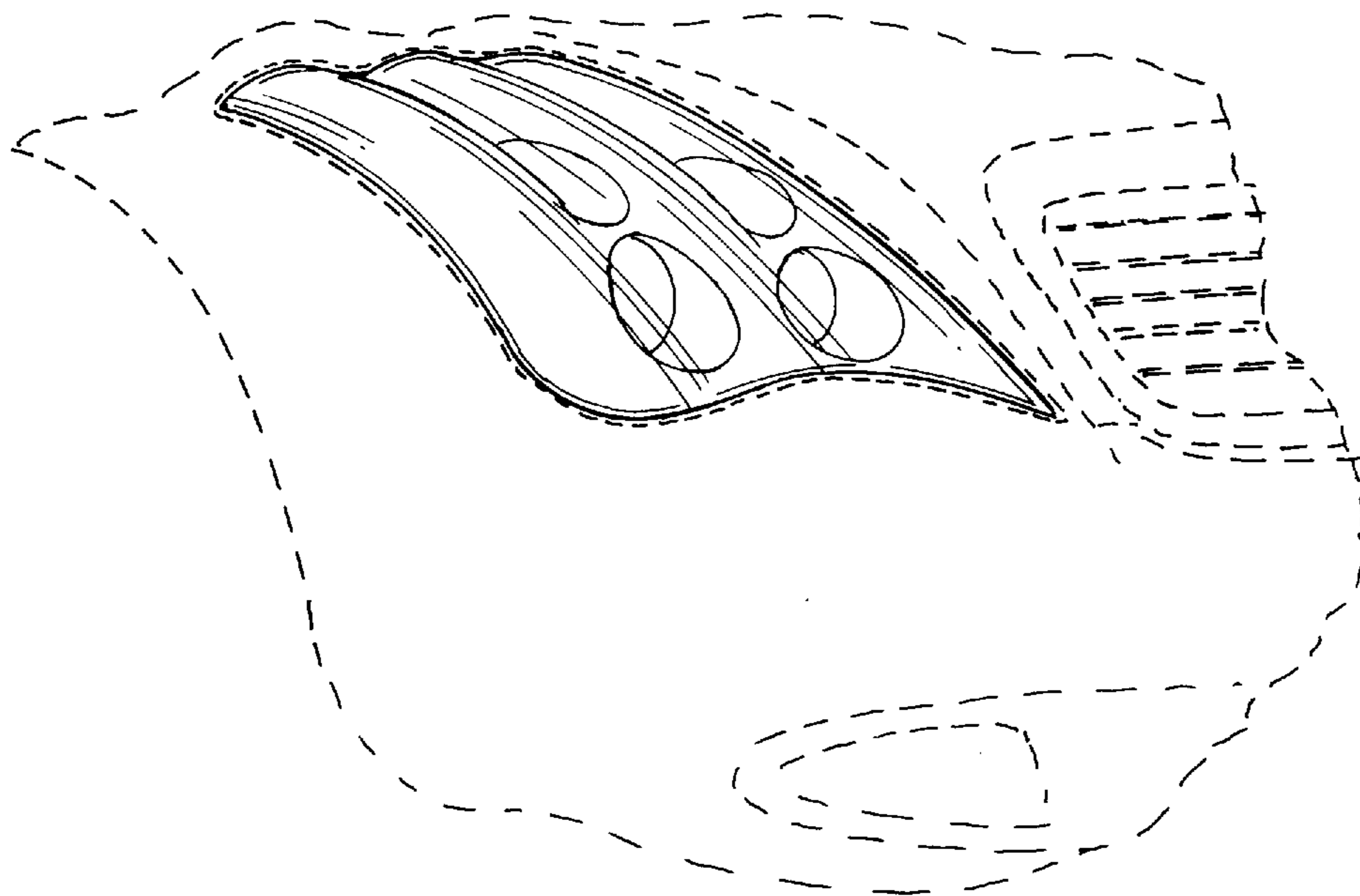
