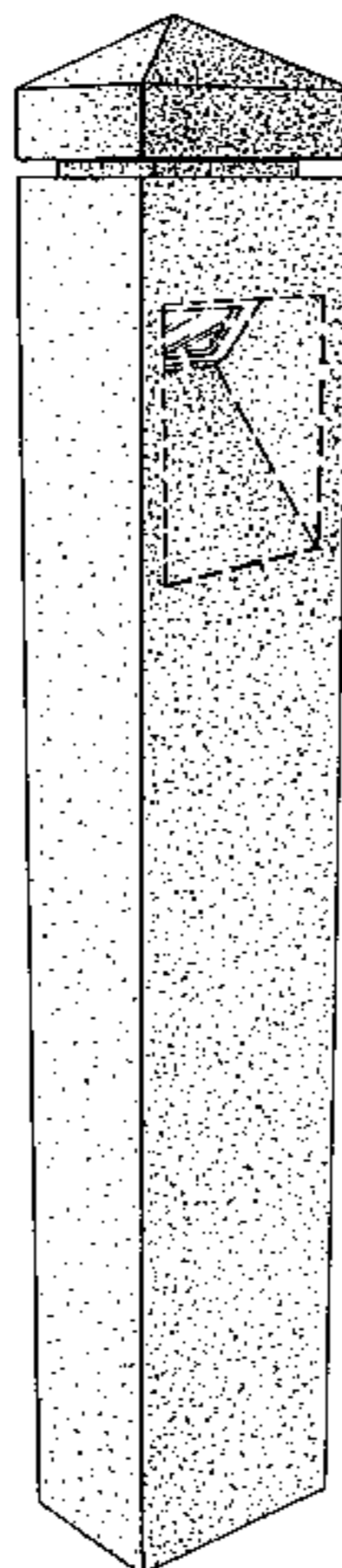

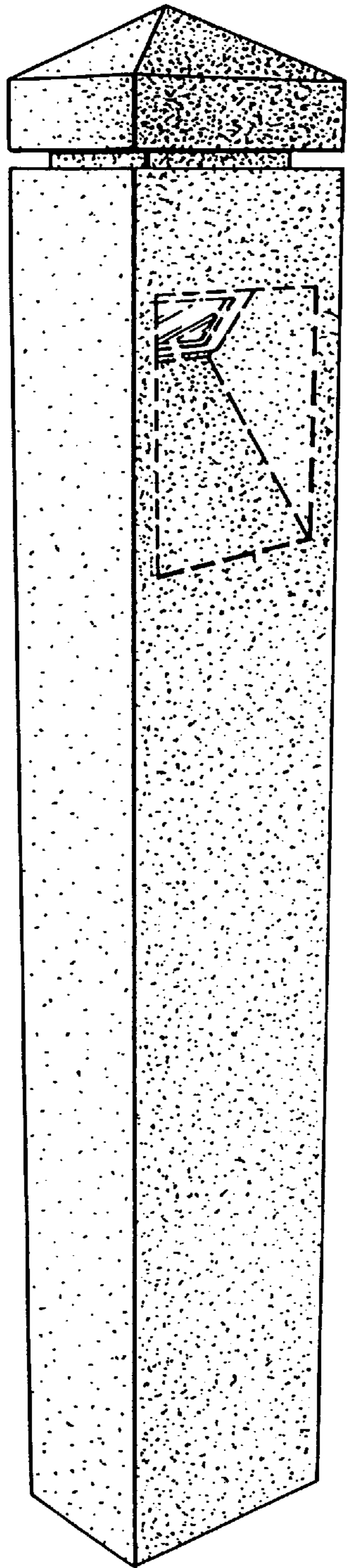
FIG. 15 is a top plan view of the fifth alternative embodiment of a cap detail of my new design.

The broke lines are shown in FIGS. 1 and 4 for illustrative purposes only and form no part of the claimed design.

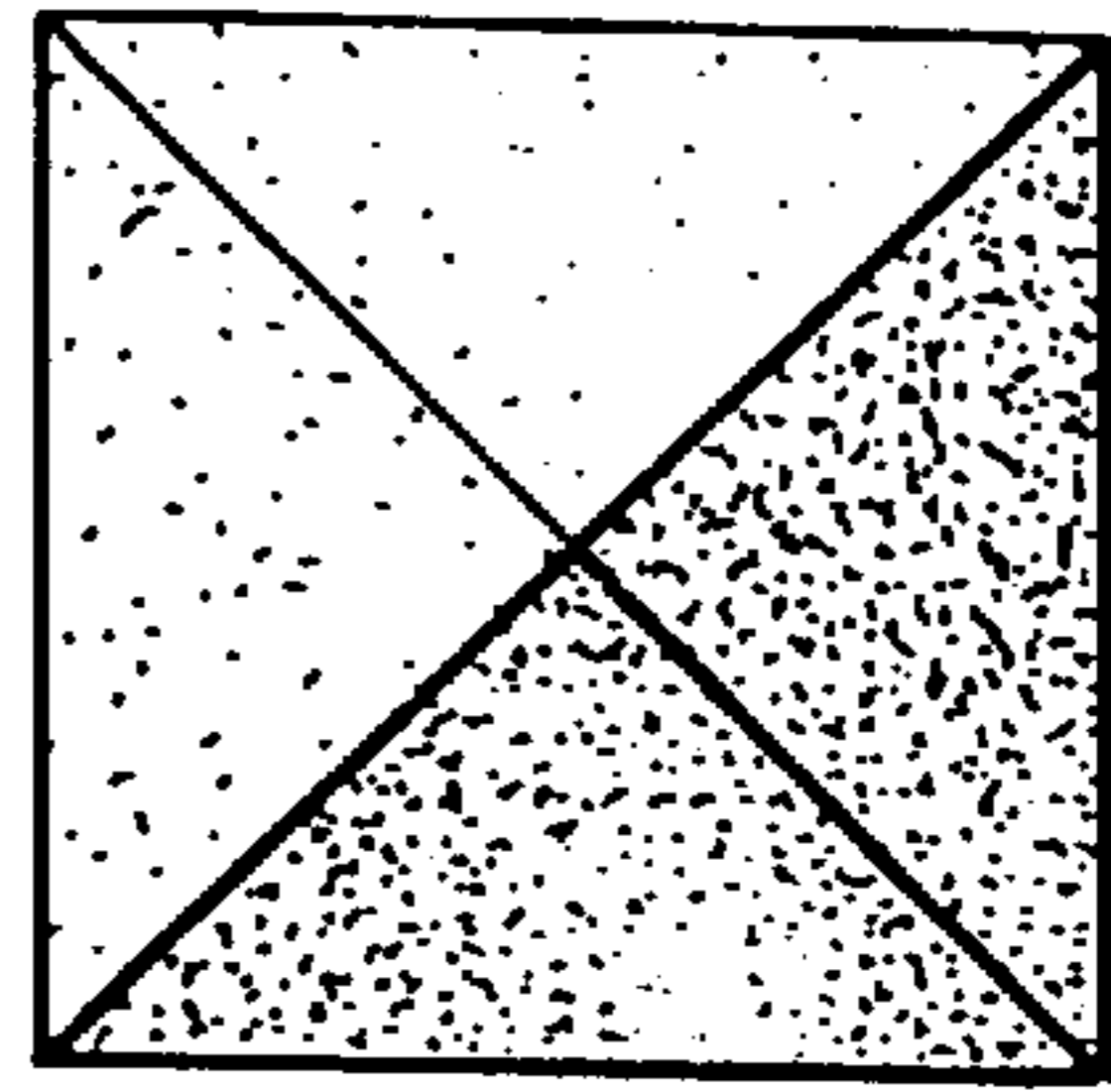

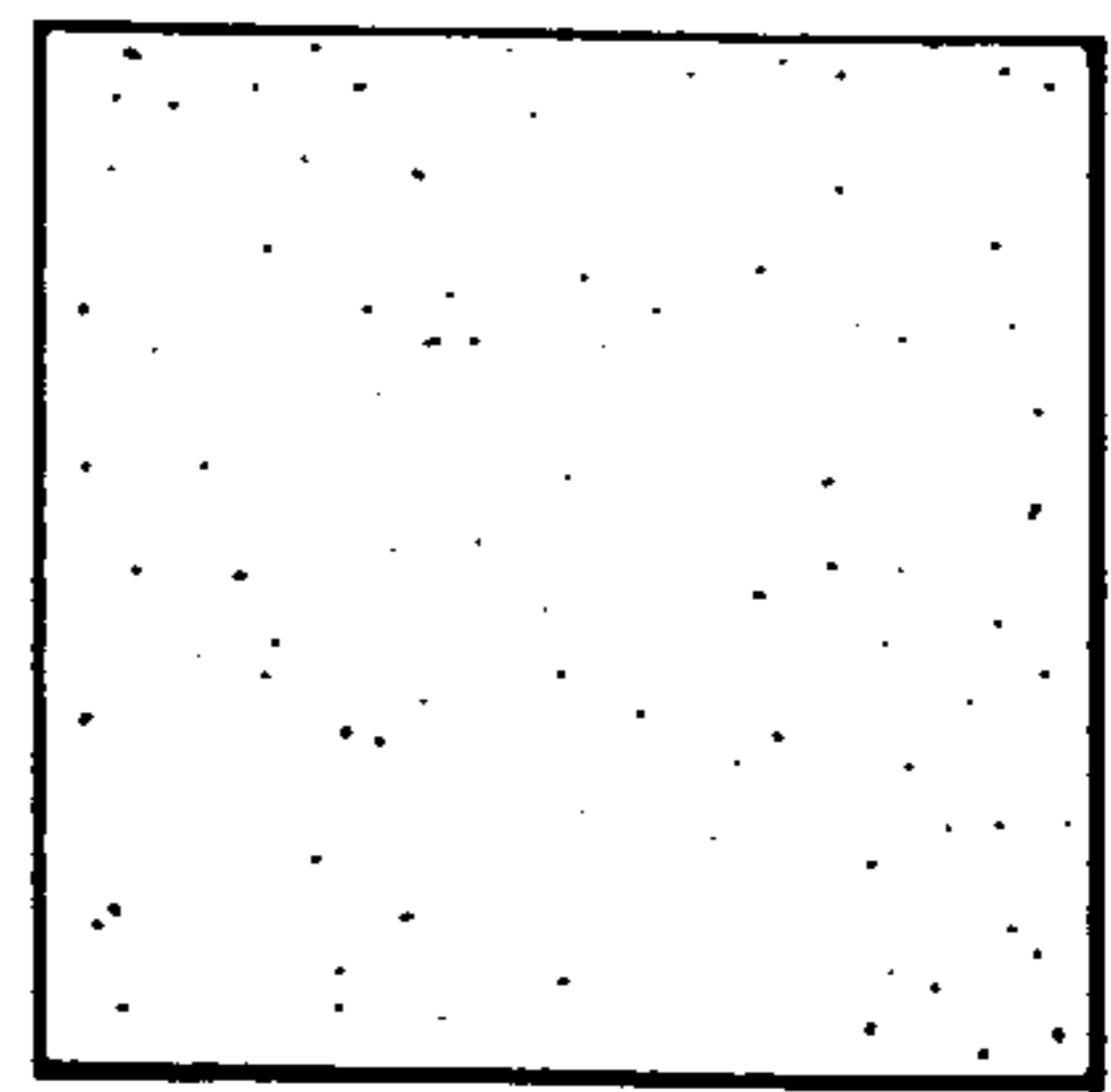




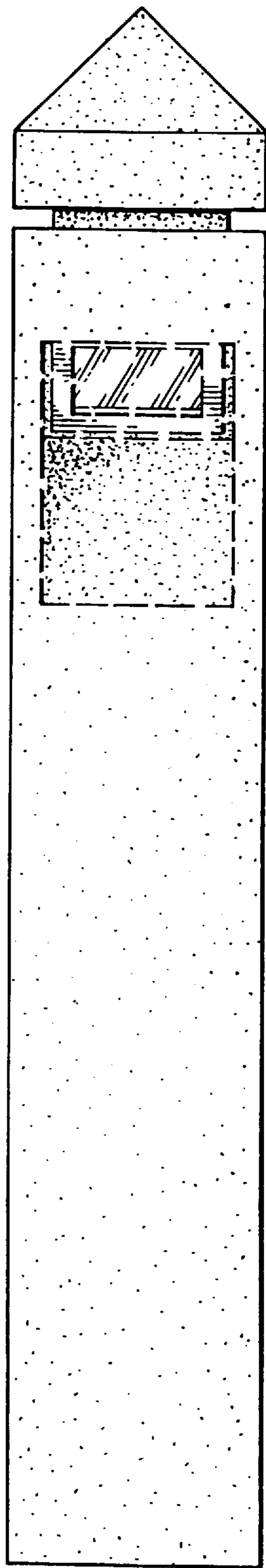

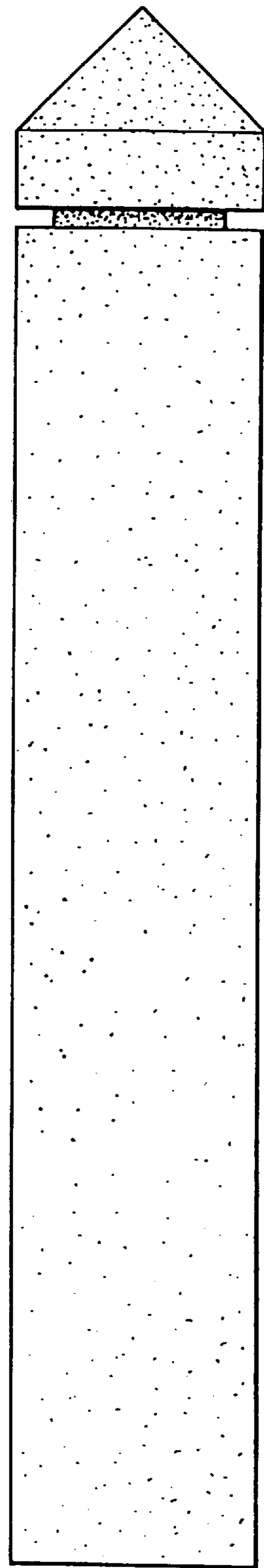

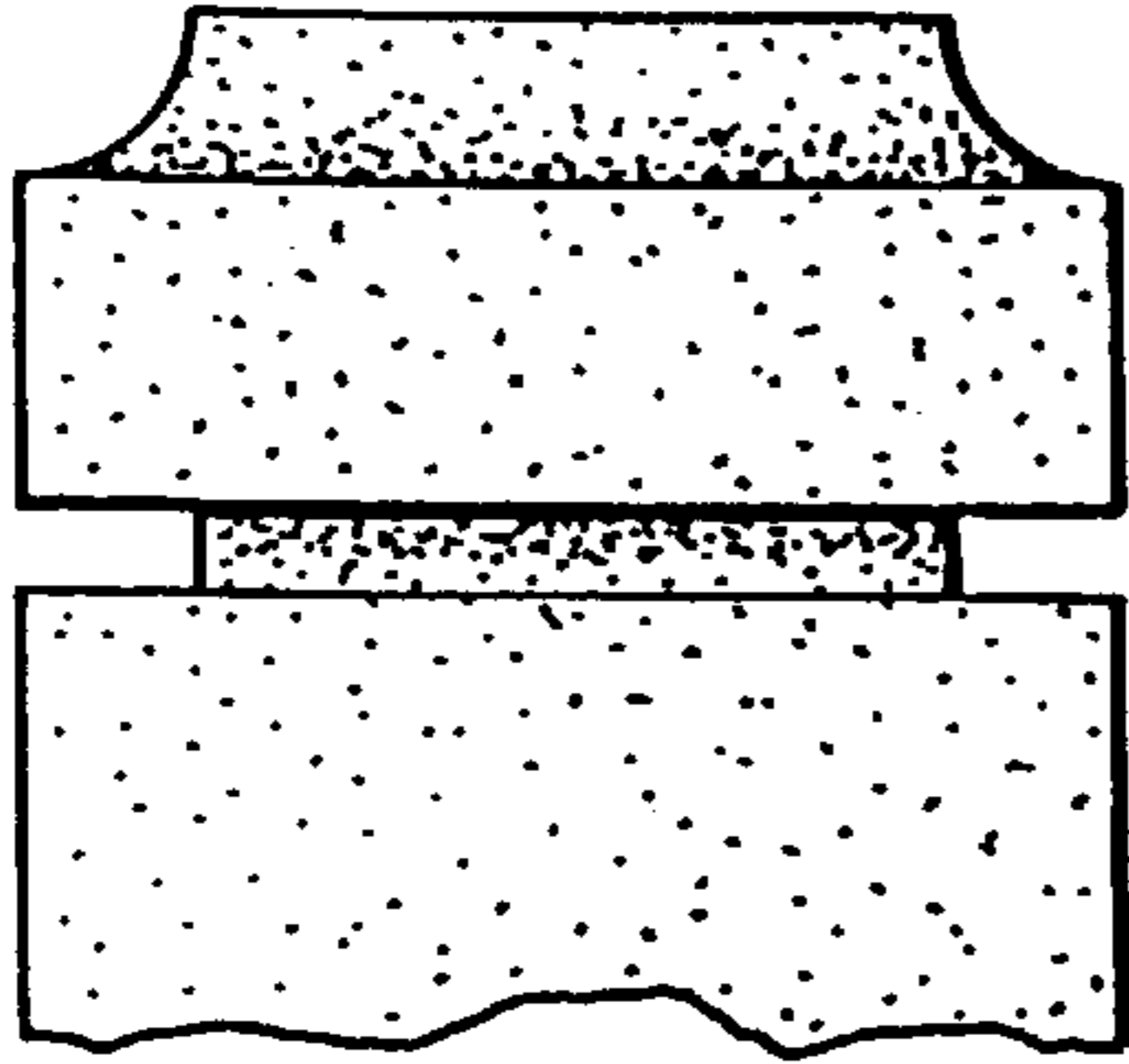

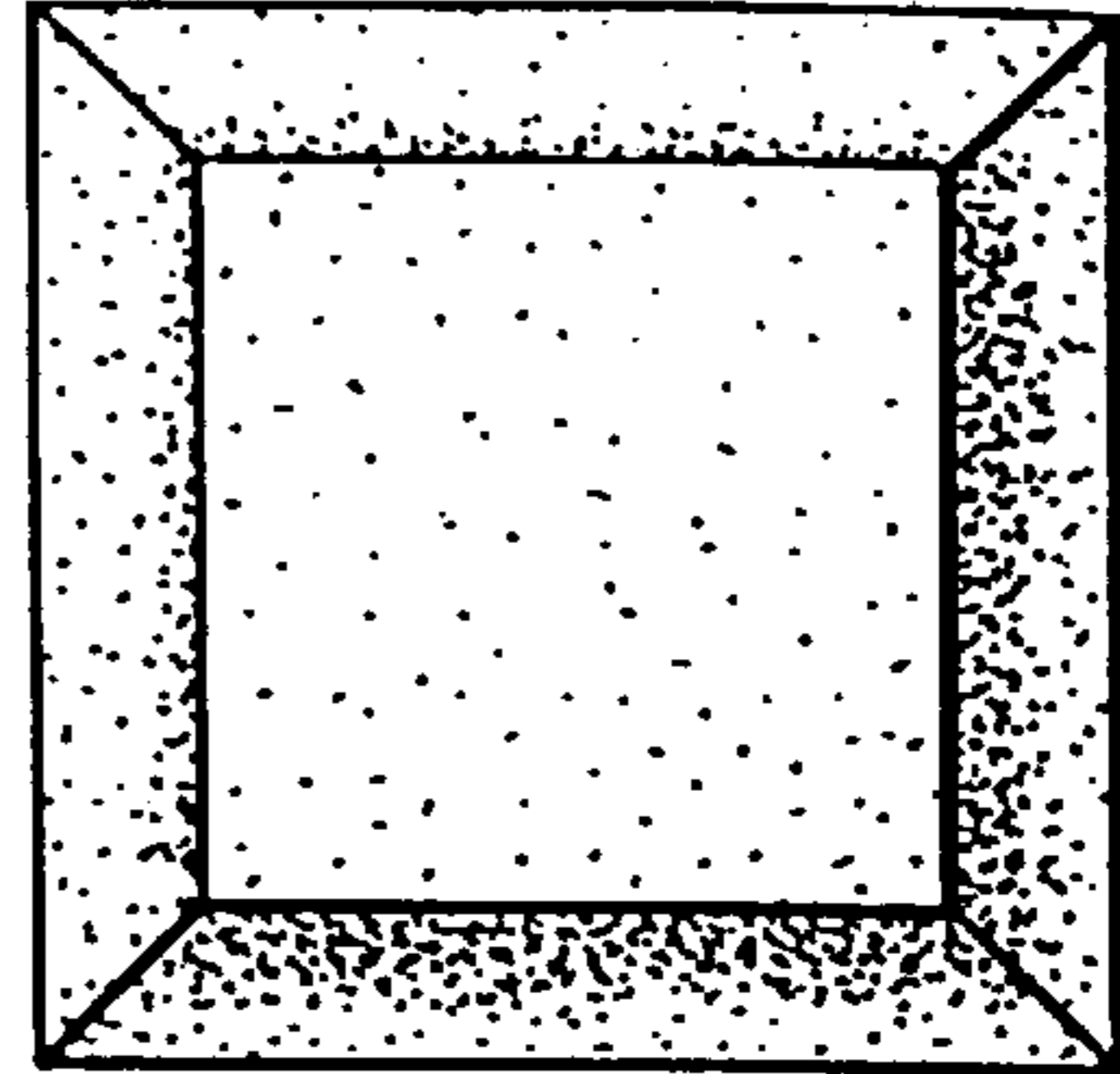

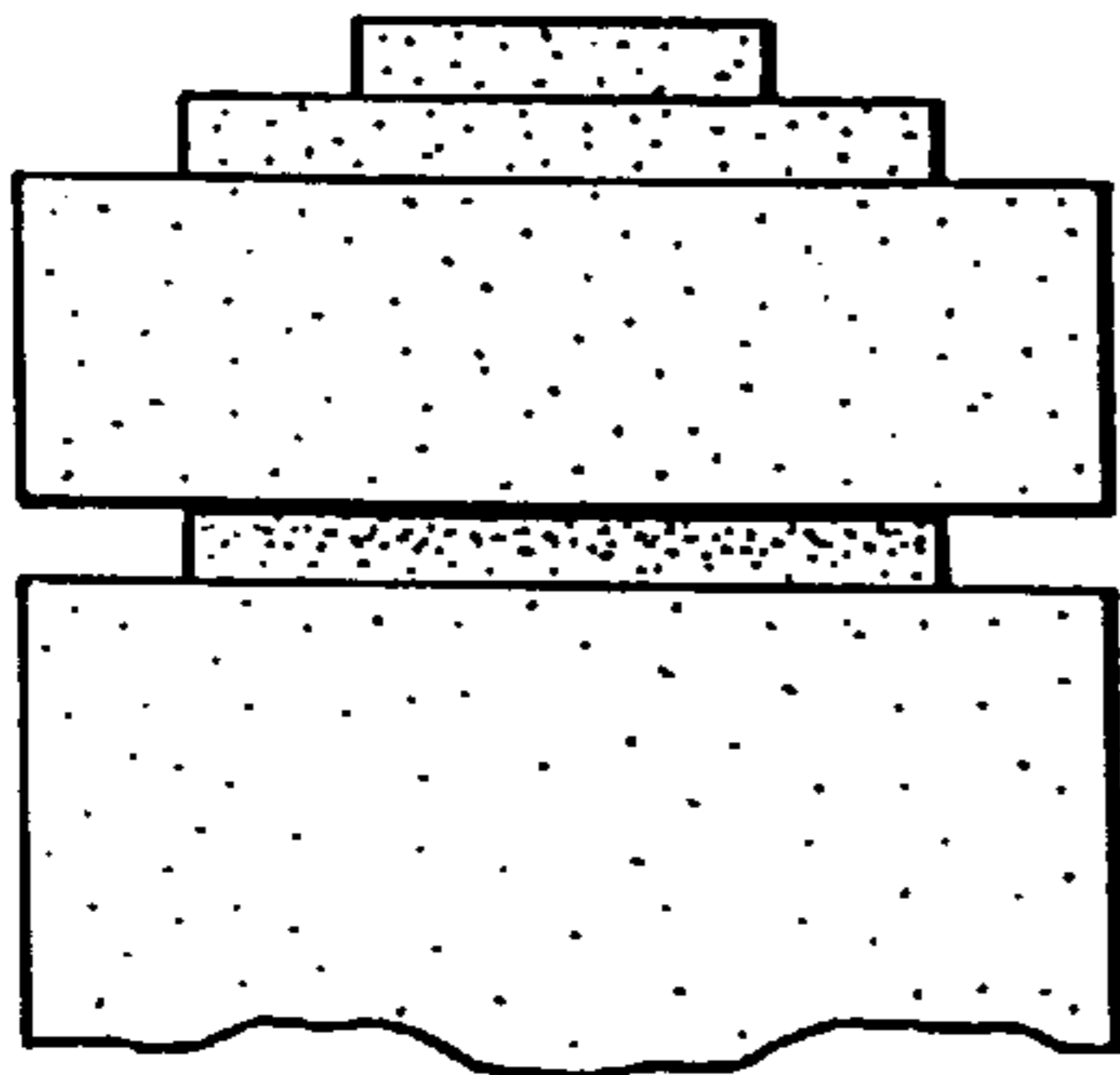

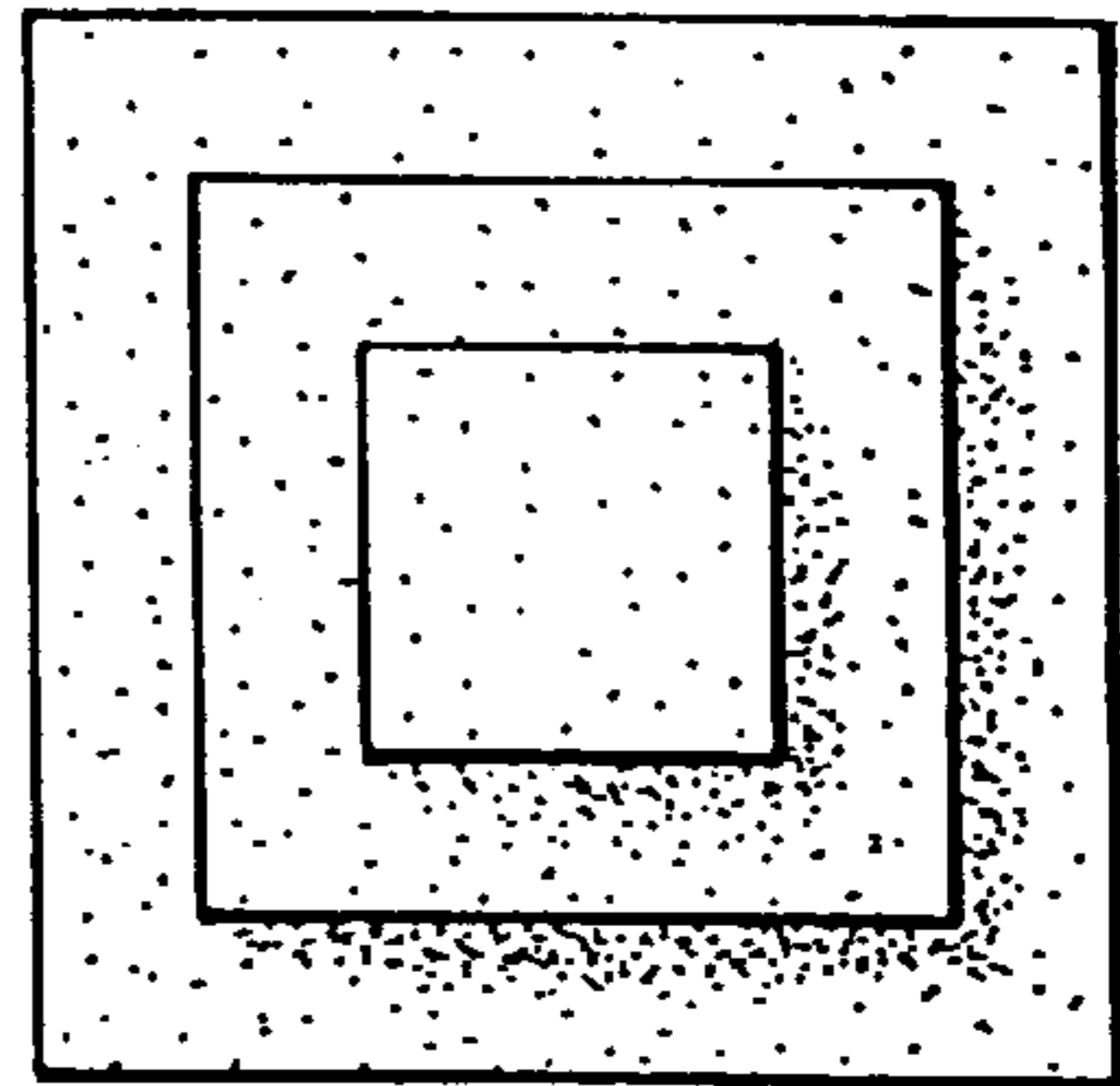

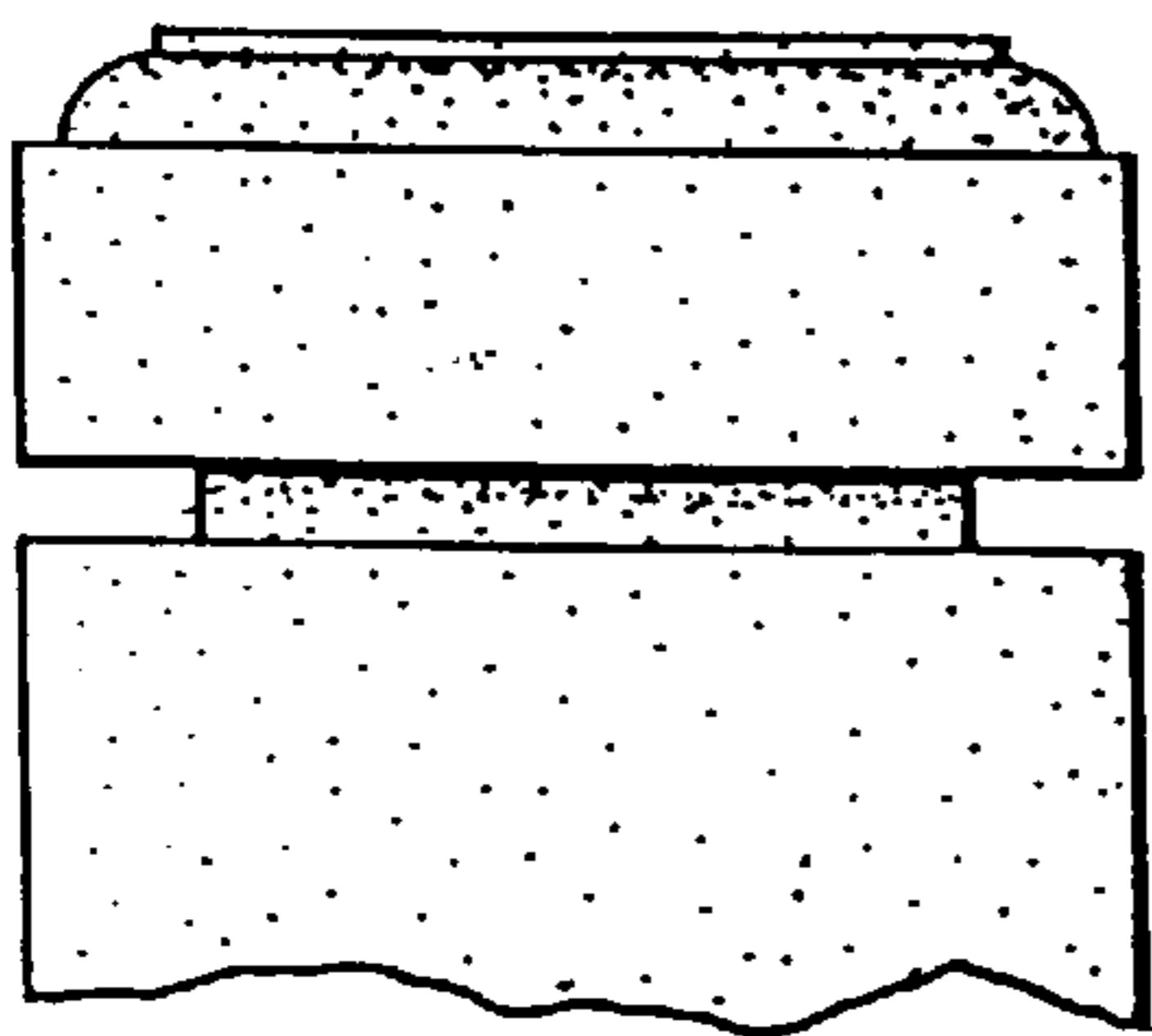

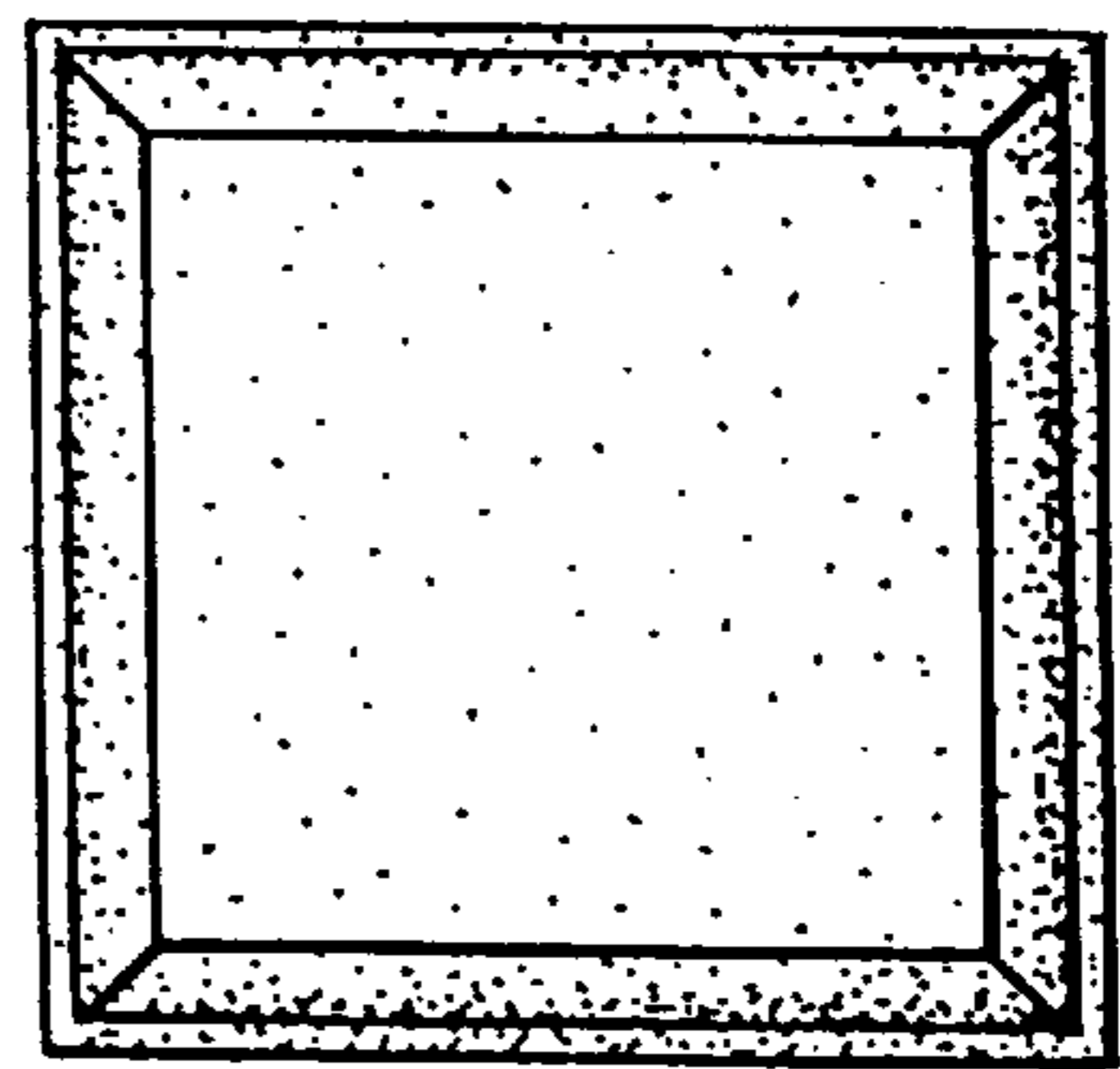

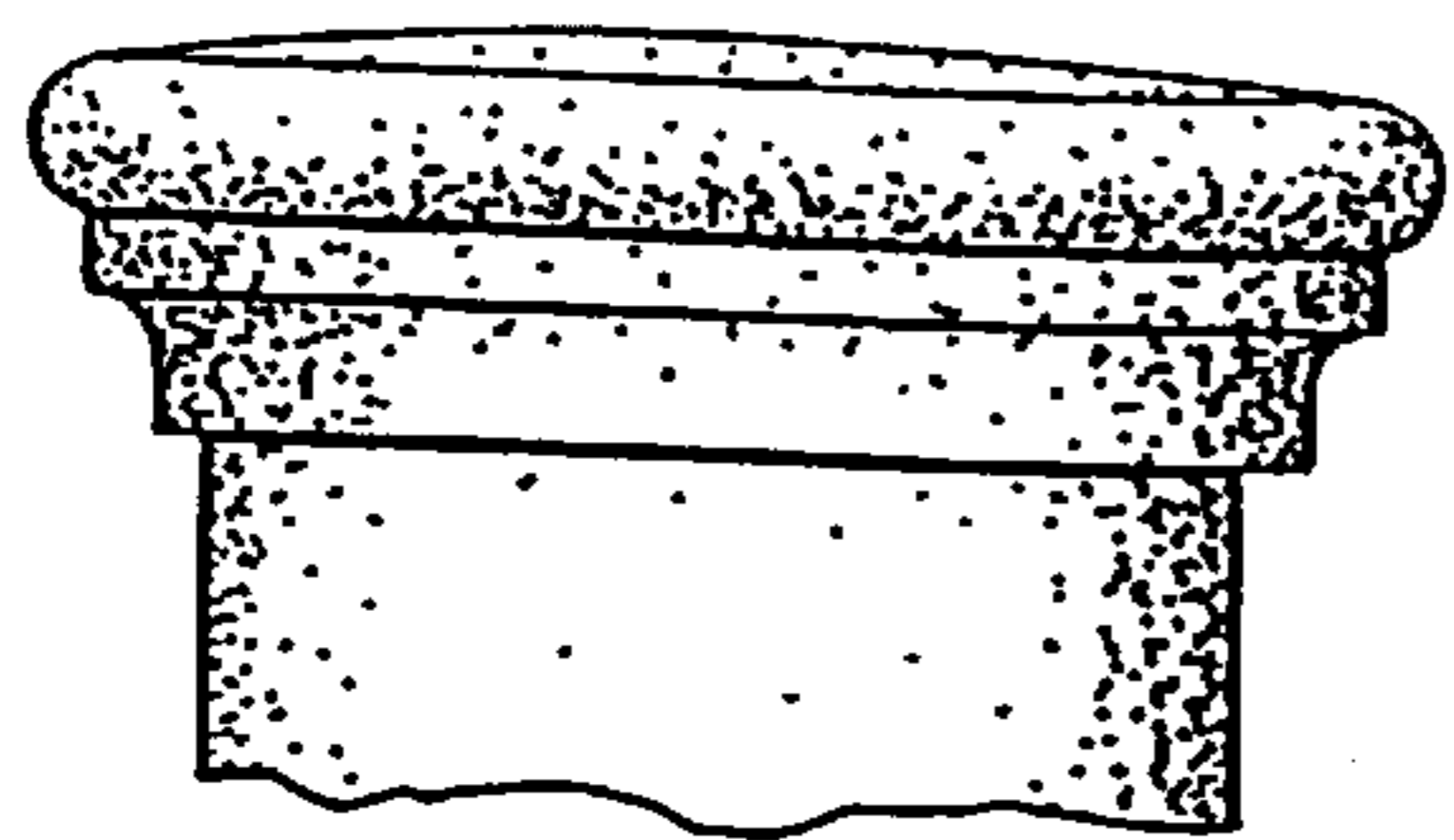

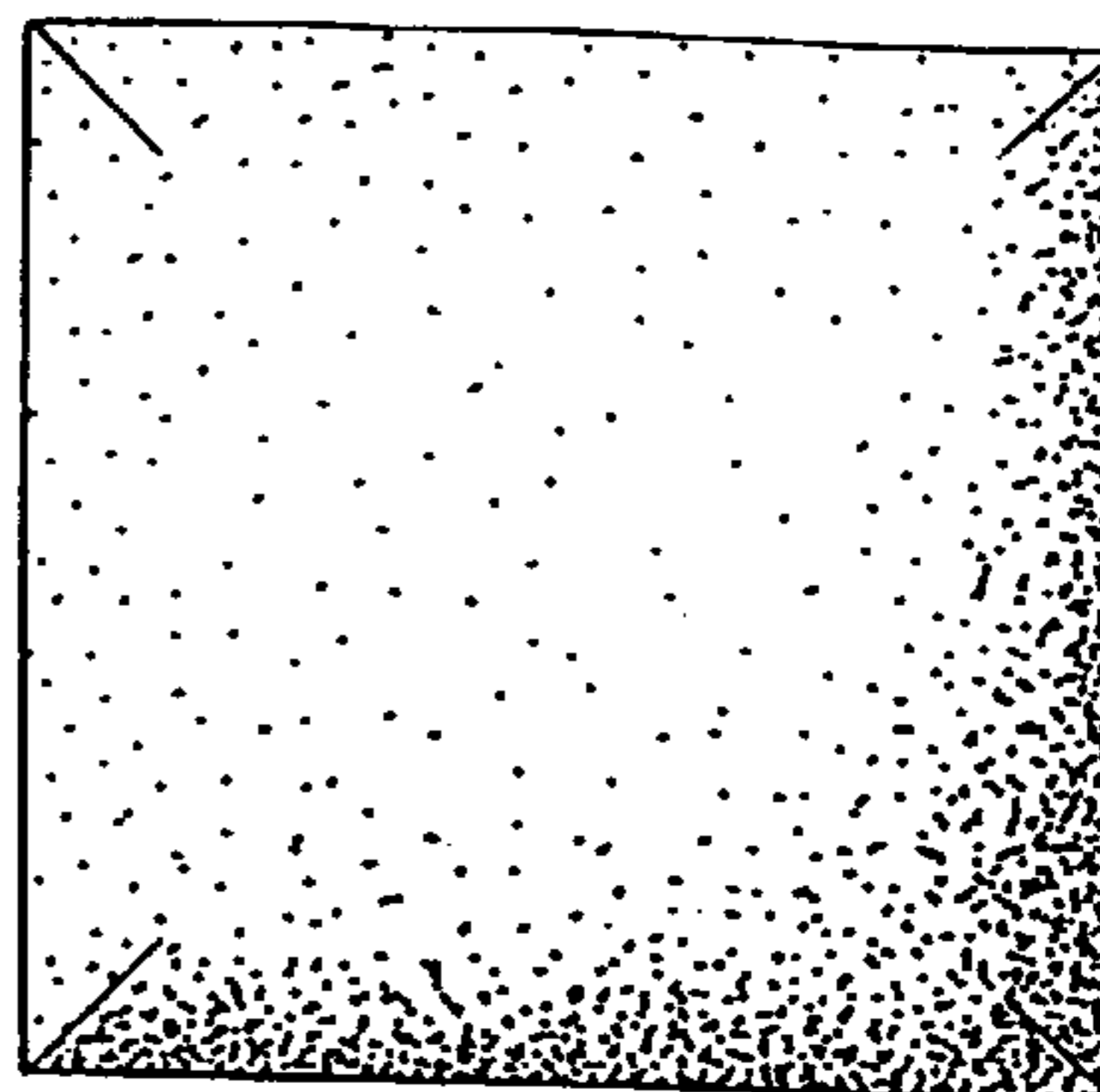

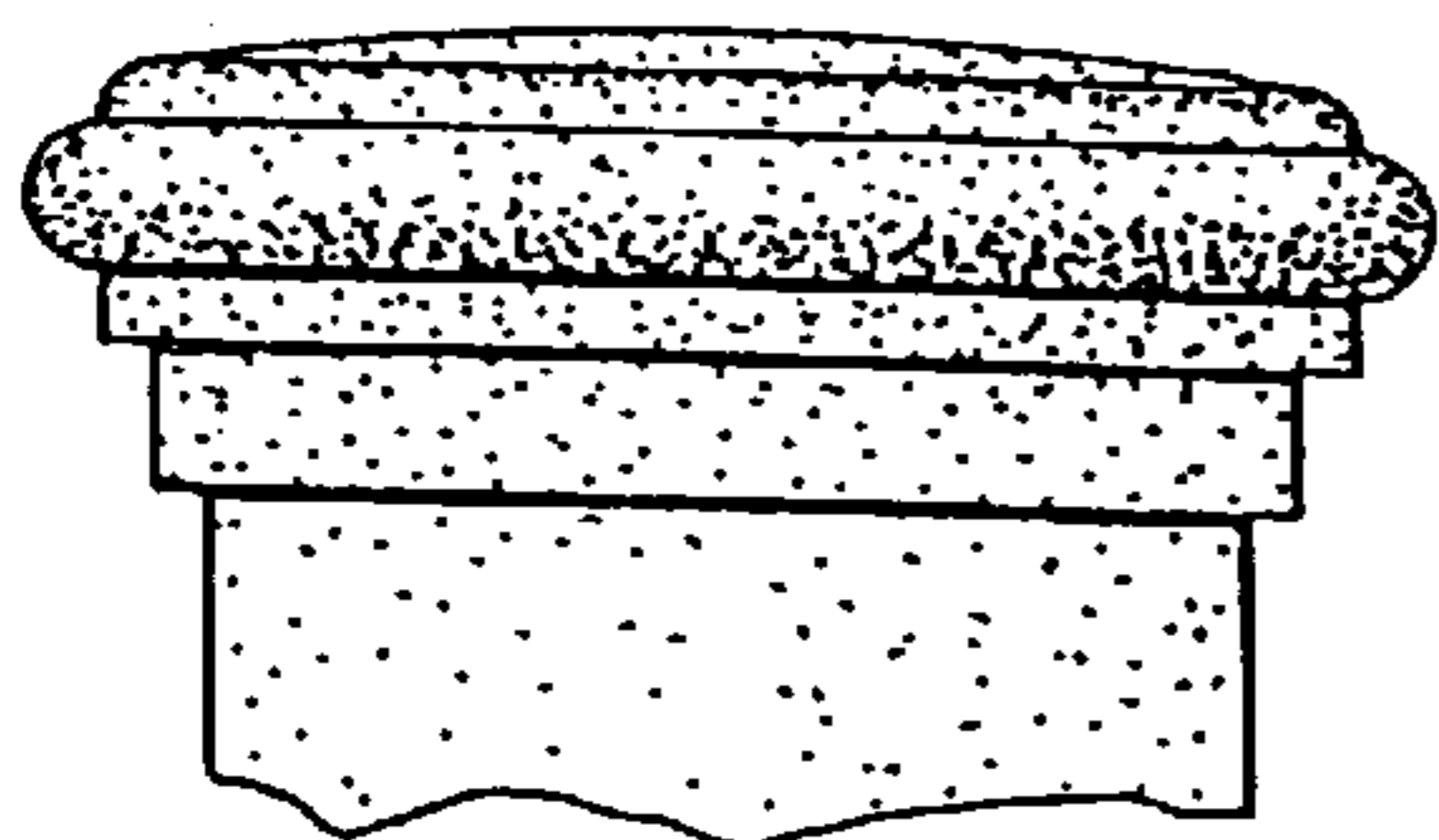

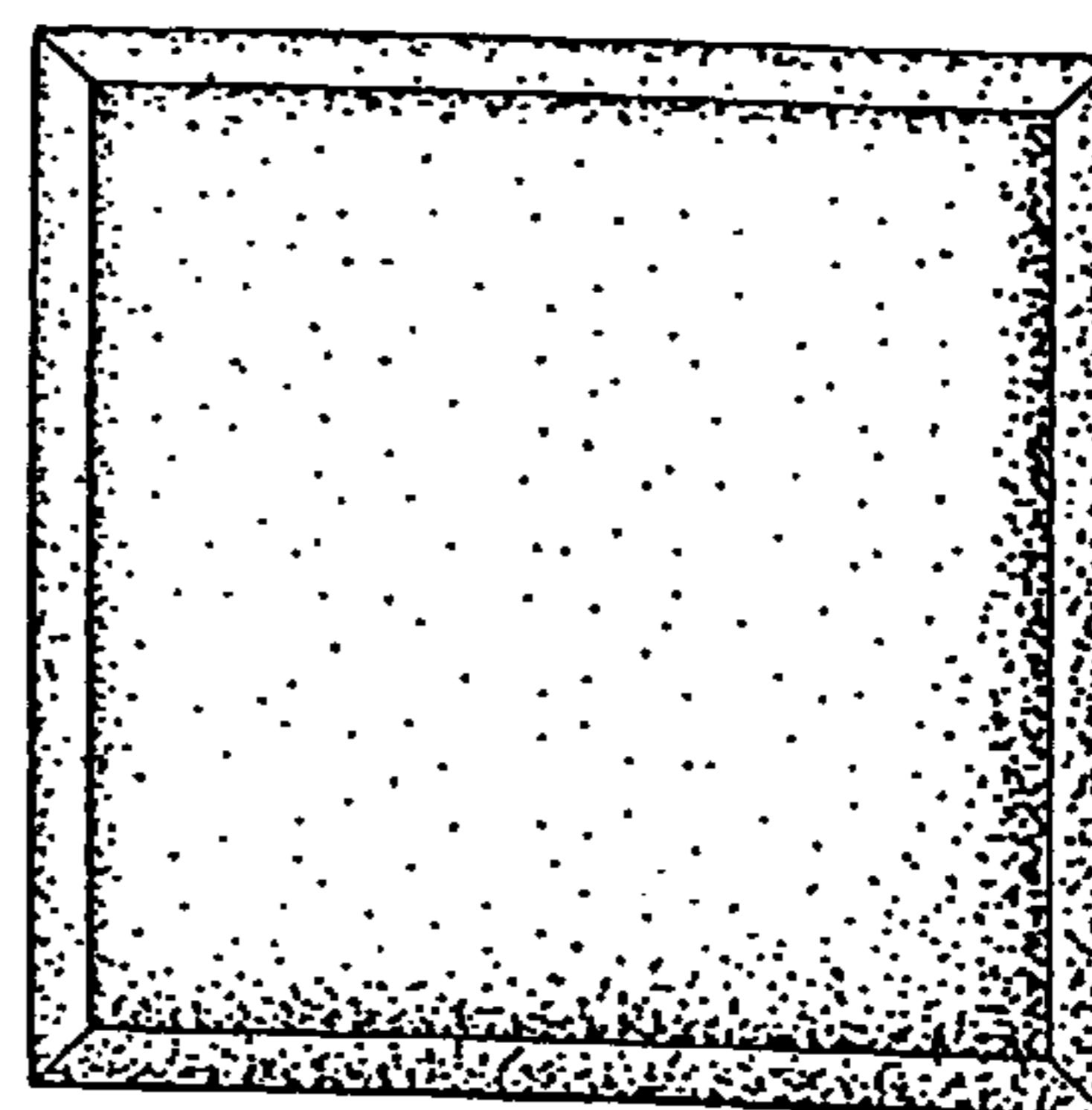
