 FIG. 7 is a top plan view thereof.

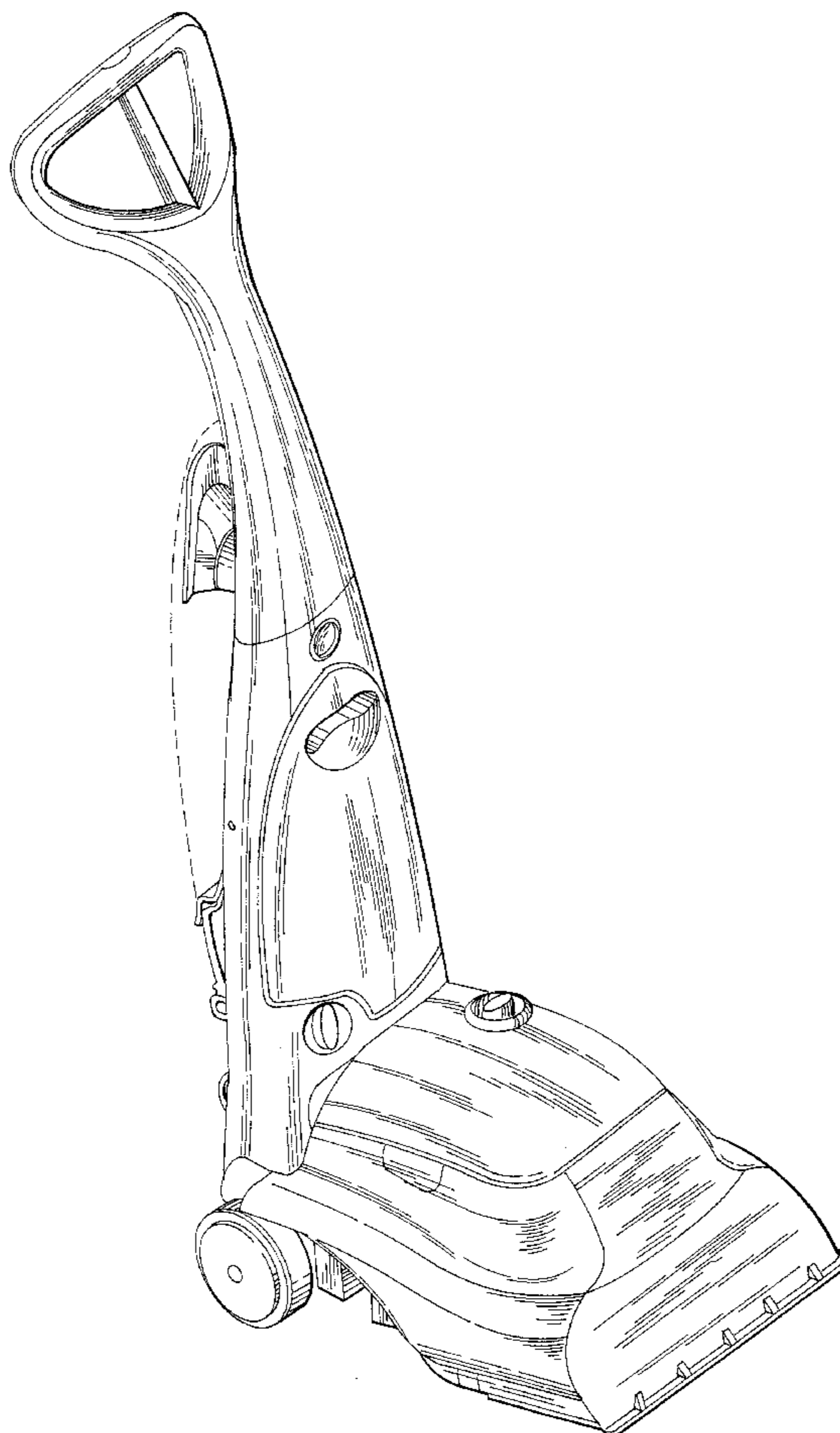

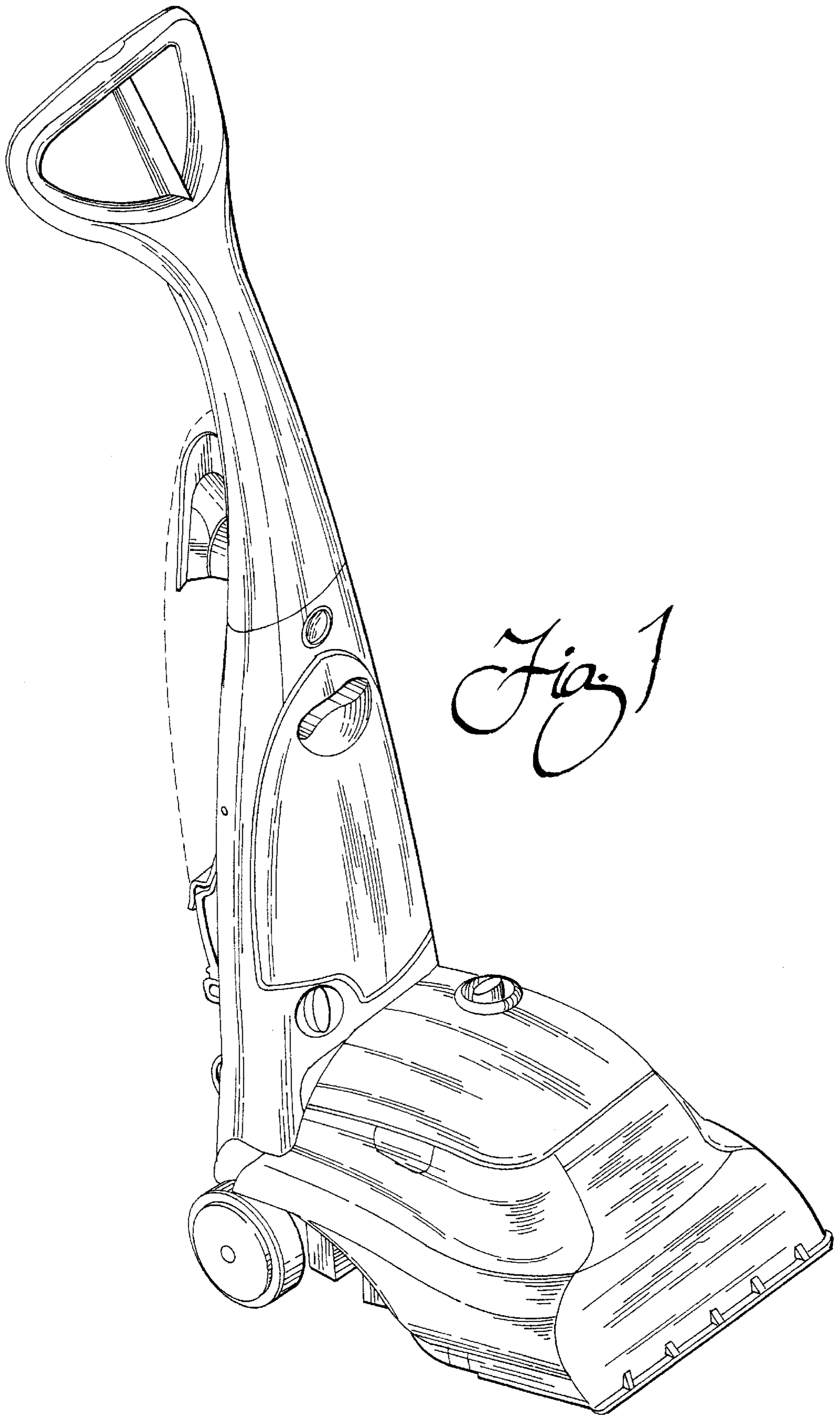

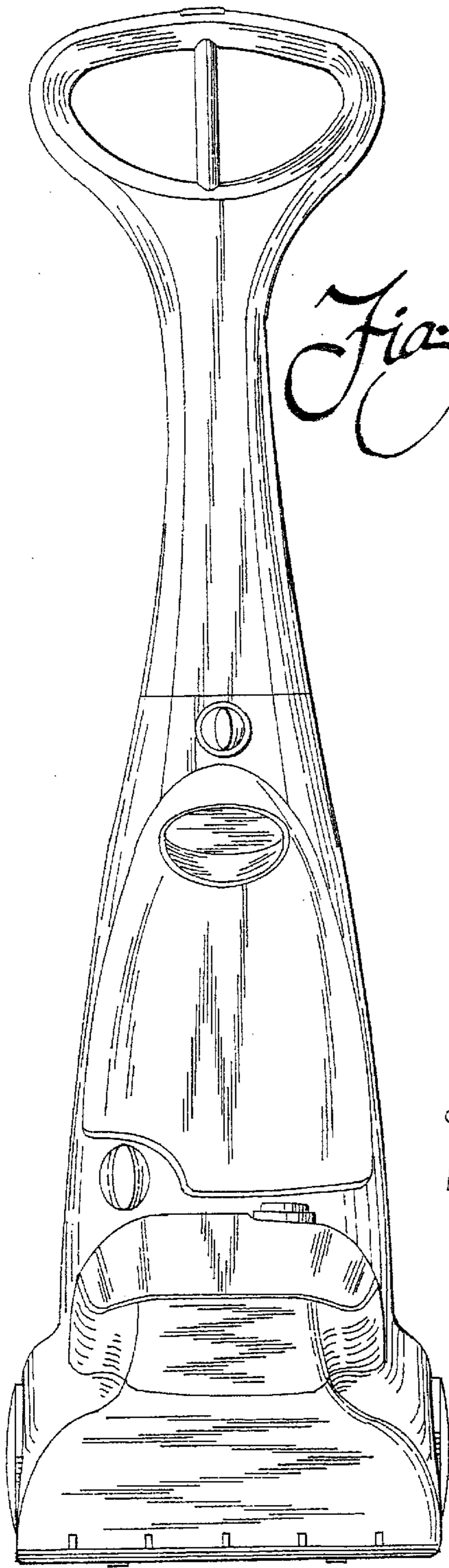

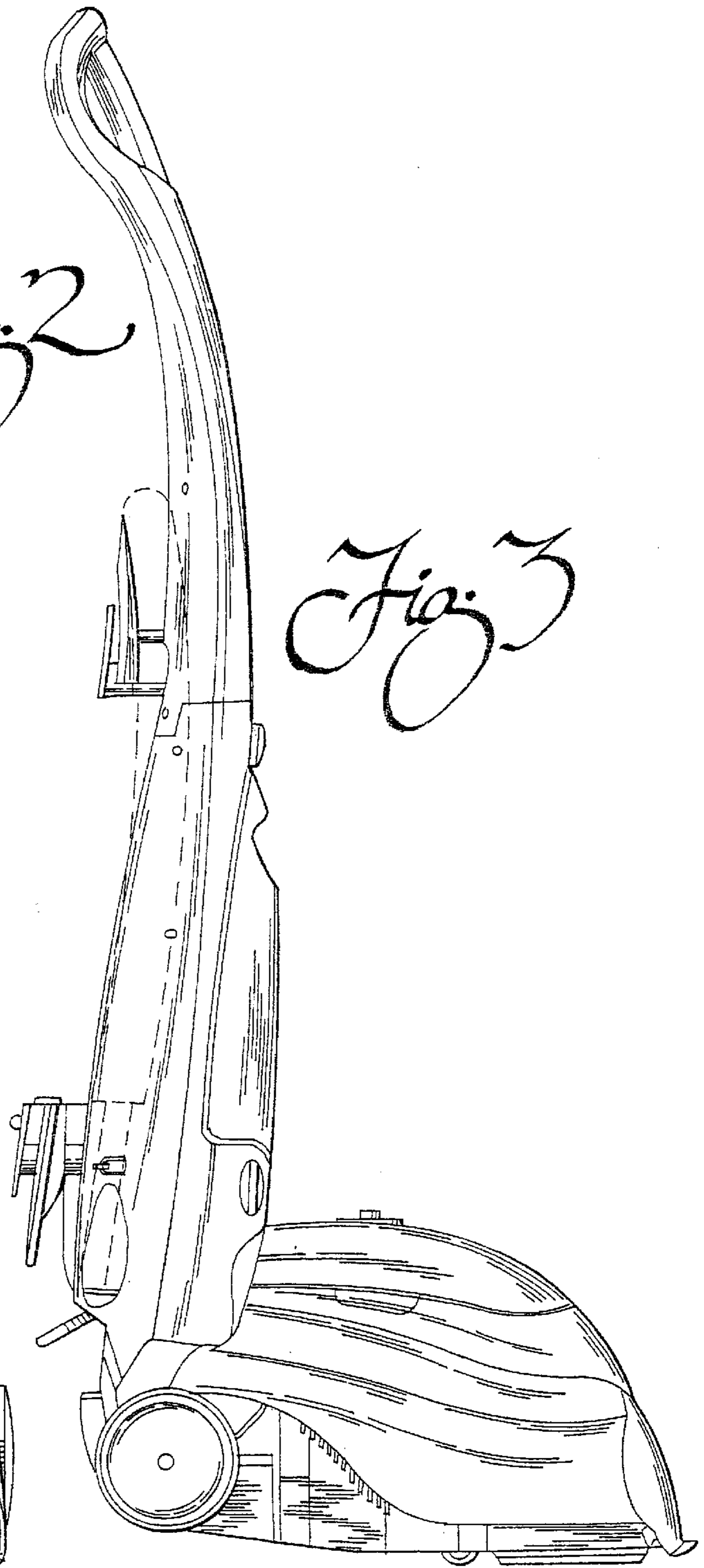

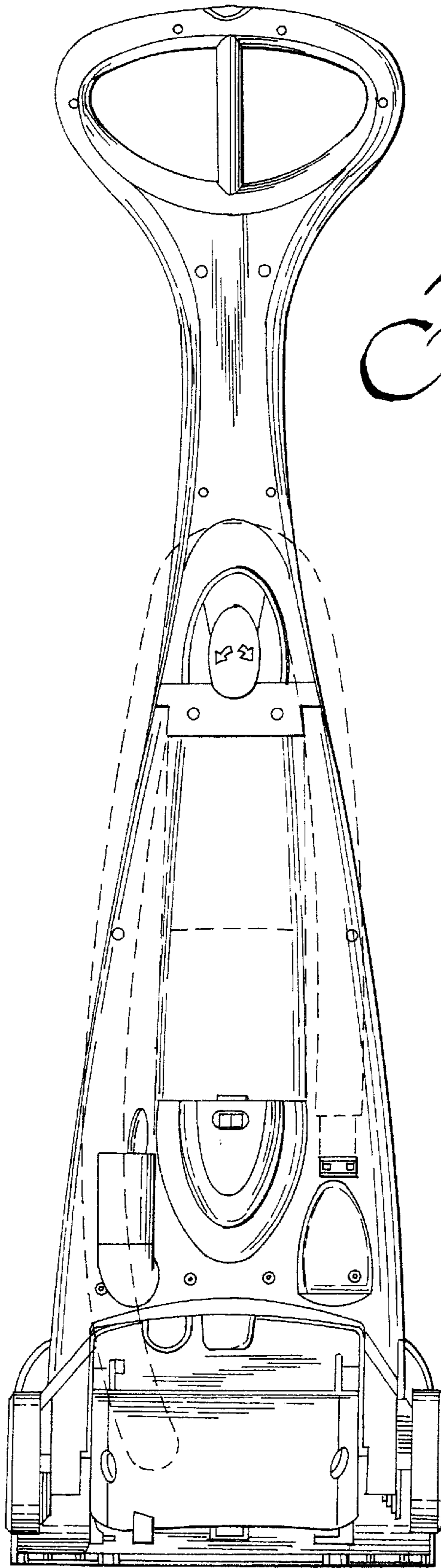

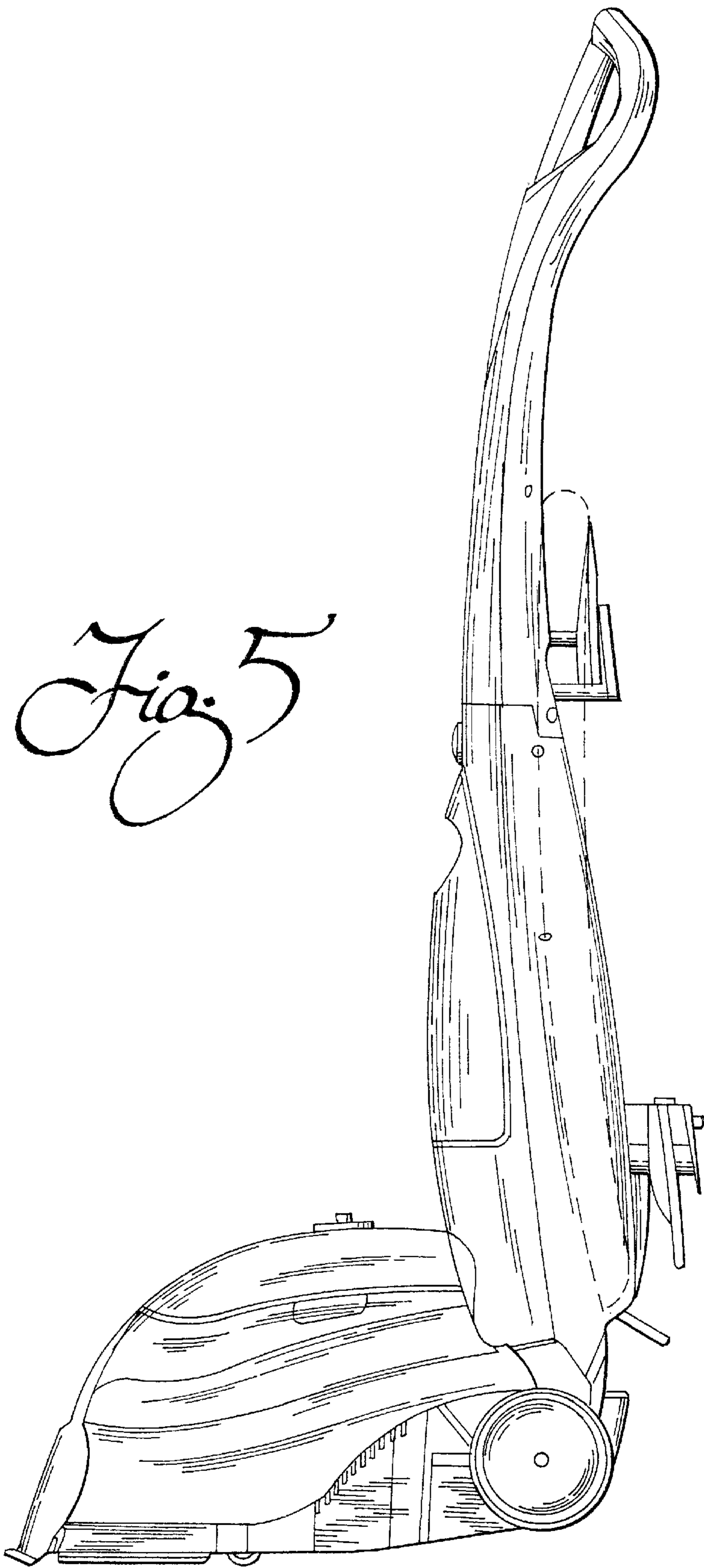

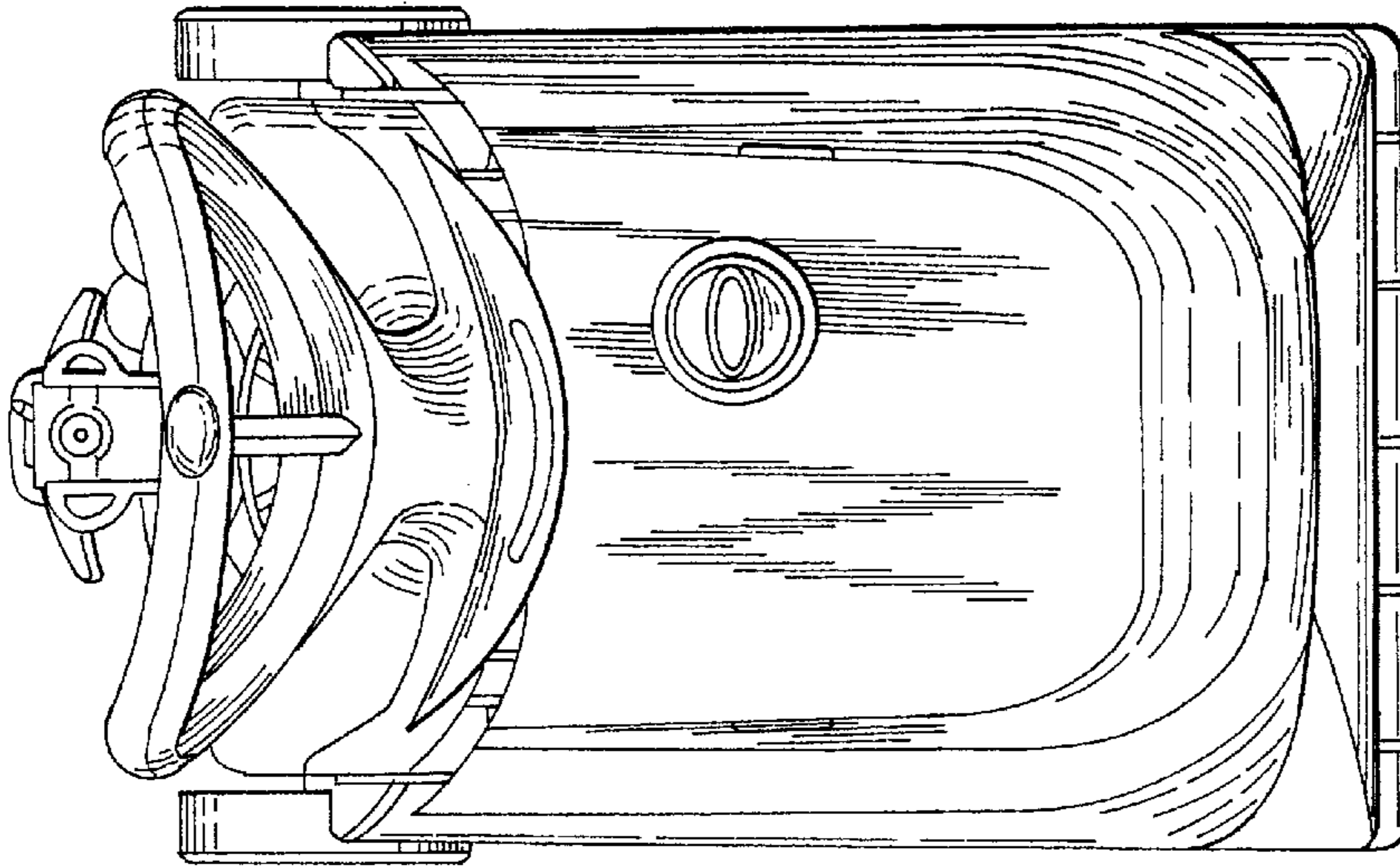

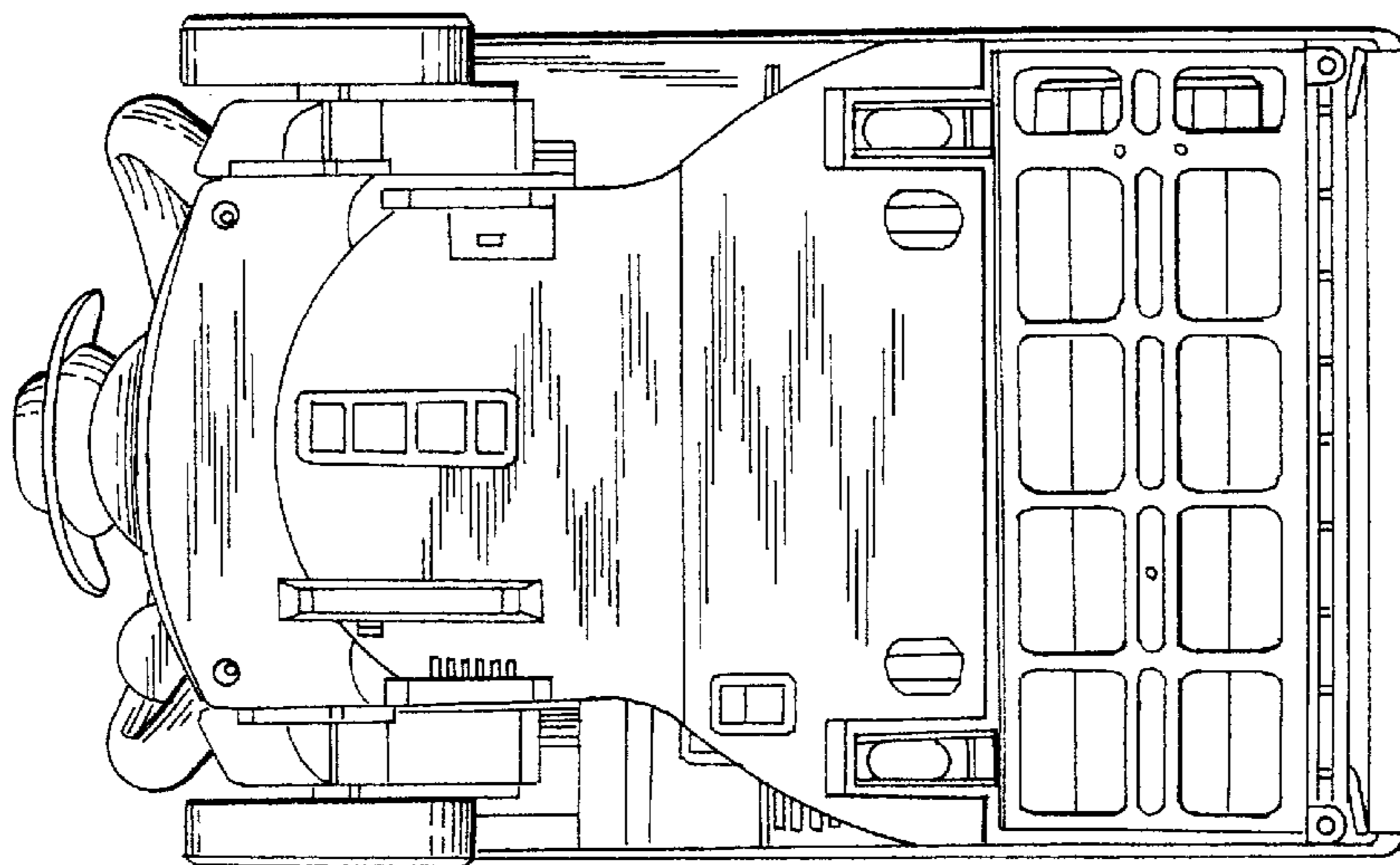
