[57] **CLAIM**
The ornamental design for a slipper for walking by toe only, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a slipper for walking by toe only showing my new design, the broken line showing of the human form is for illustrative purposes only and forms no part of the claimed design;
FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image of FIG. 2;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevational view thereof; and,
FIG. 6 is a rear elevational view thereof.

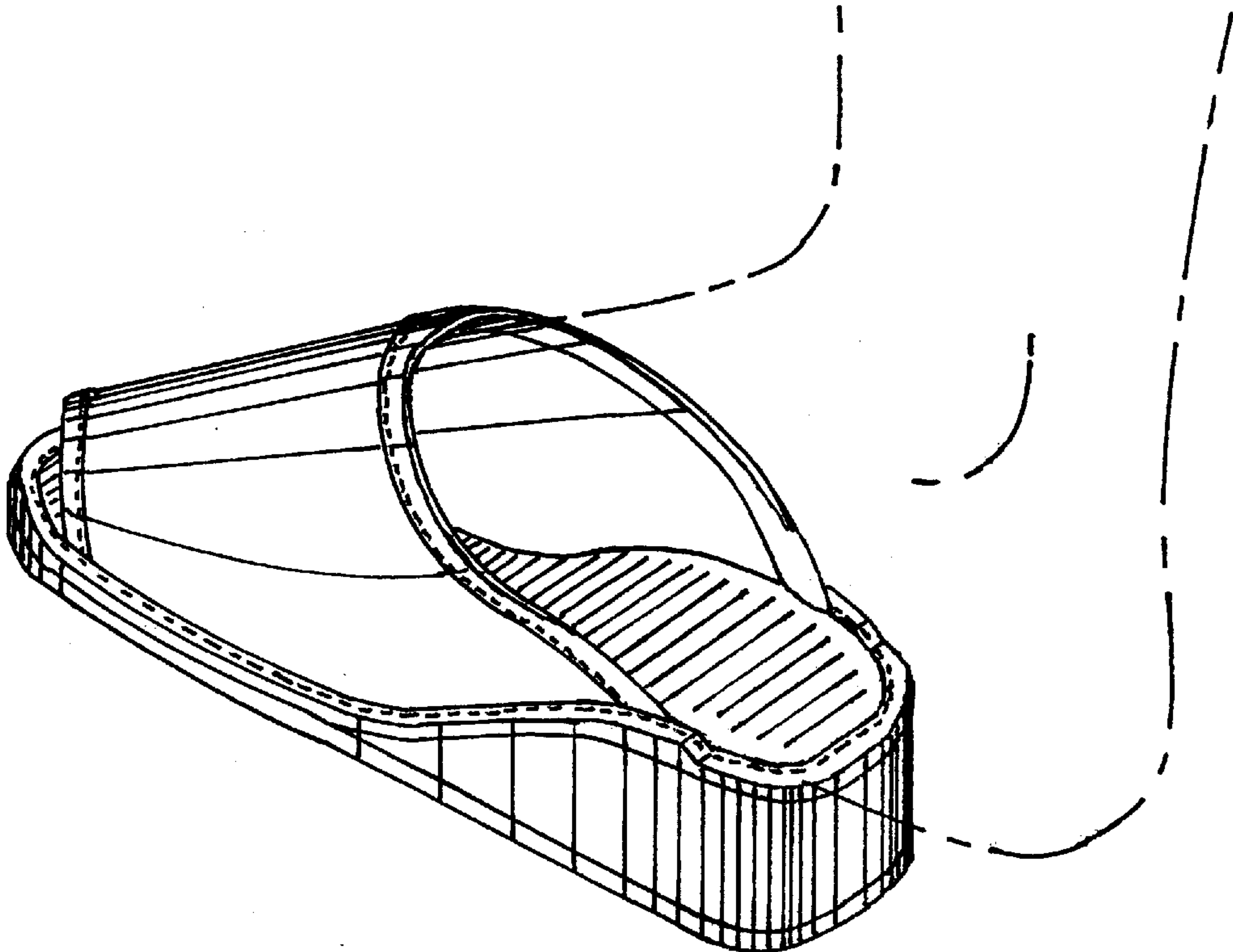

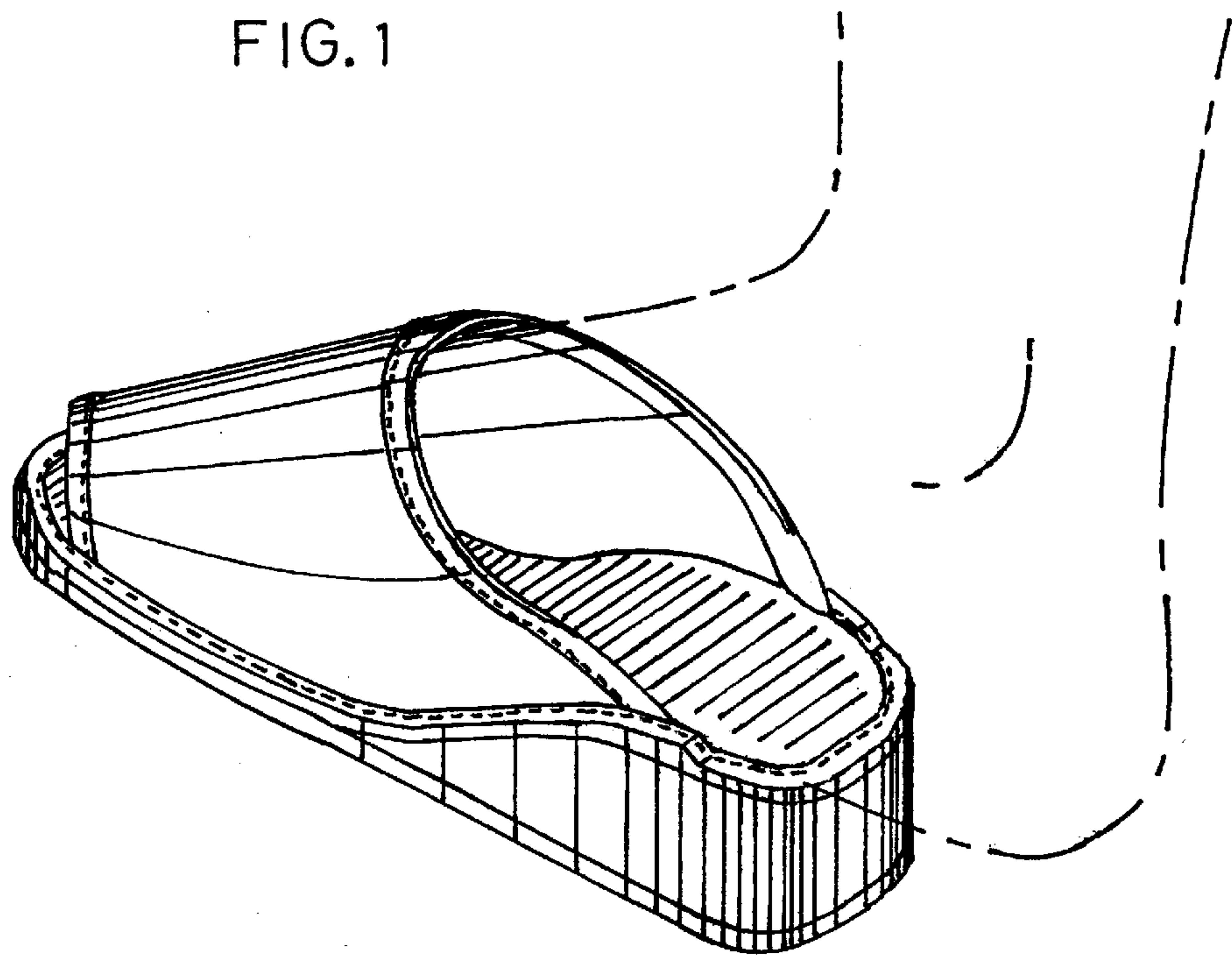

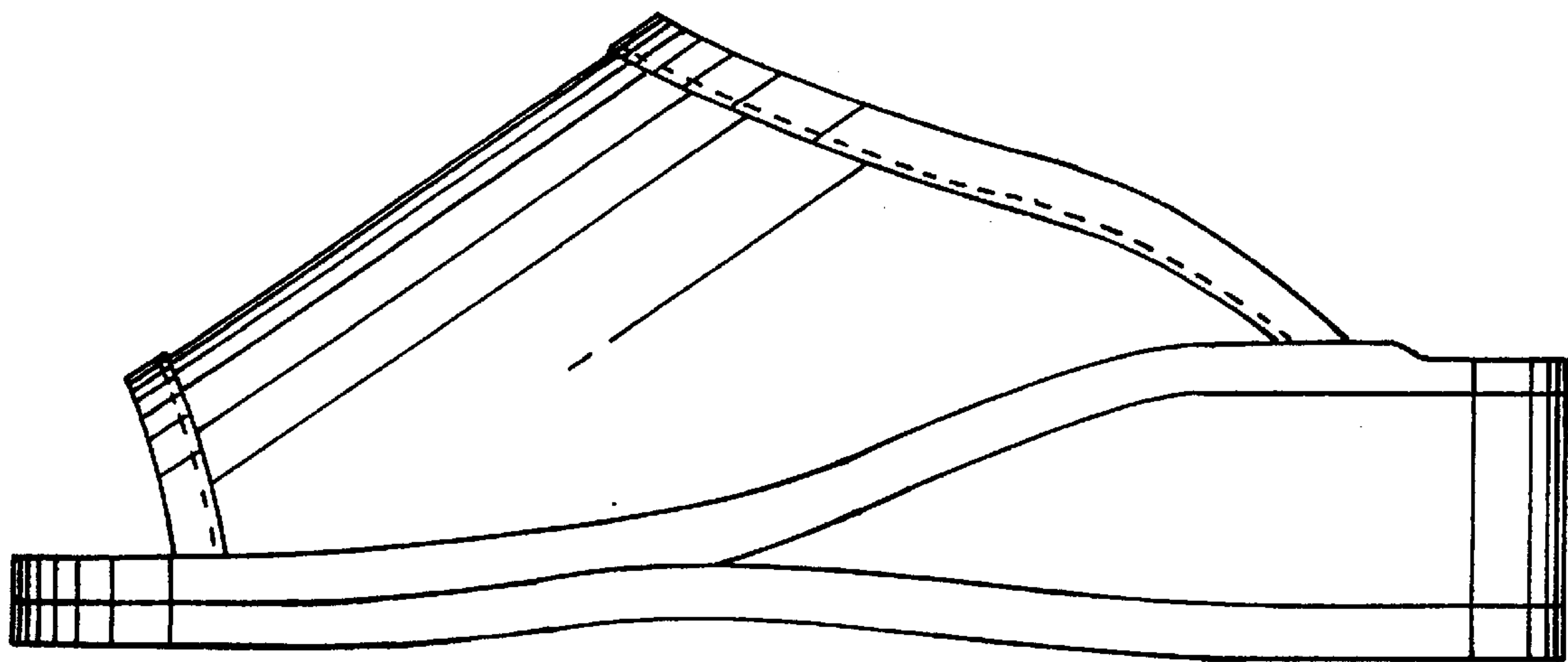

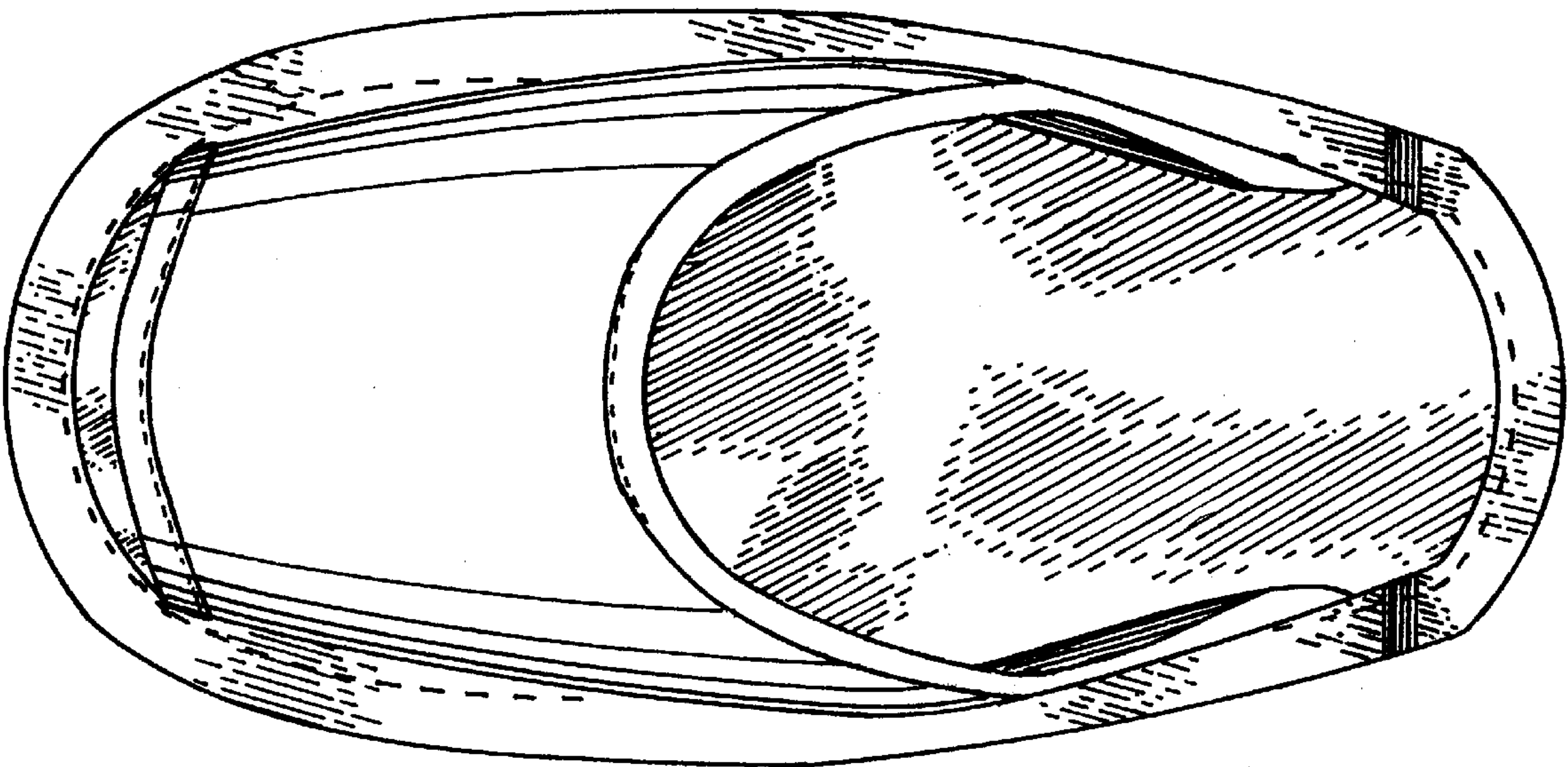

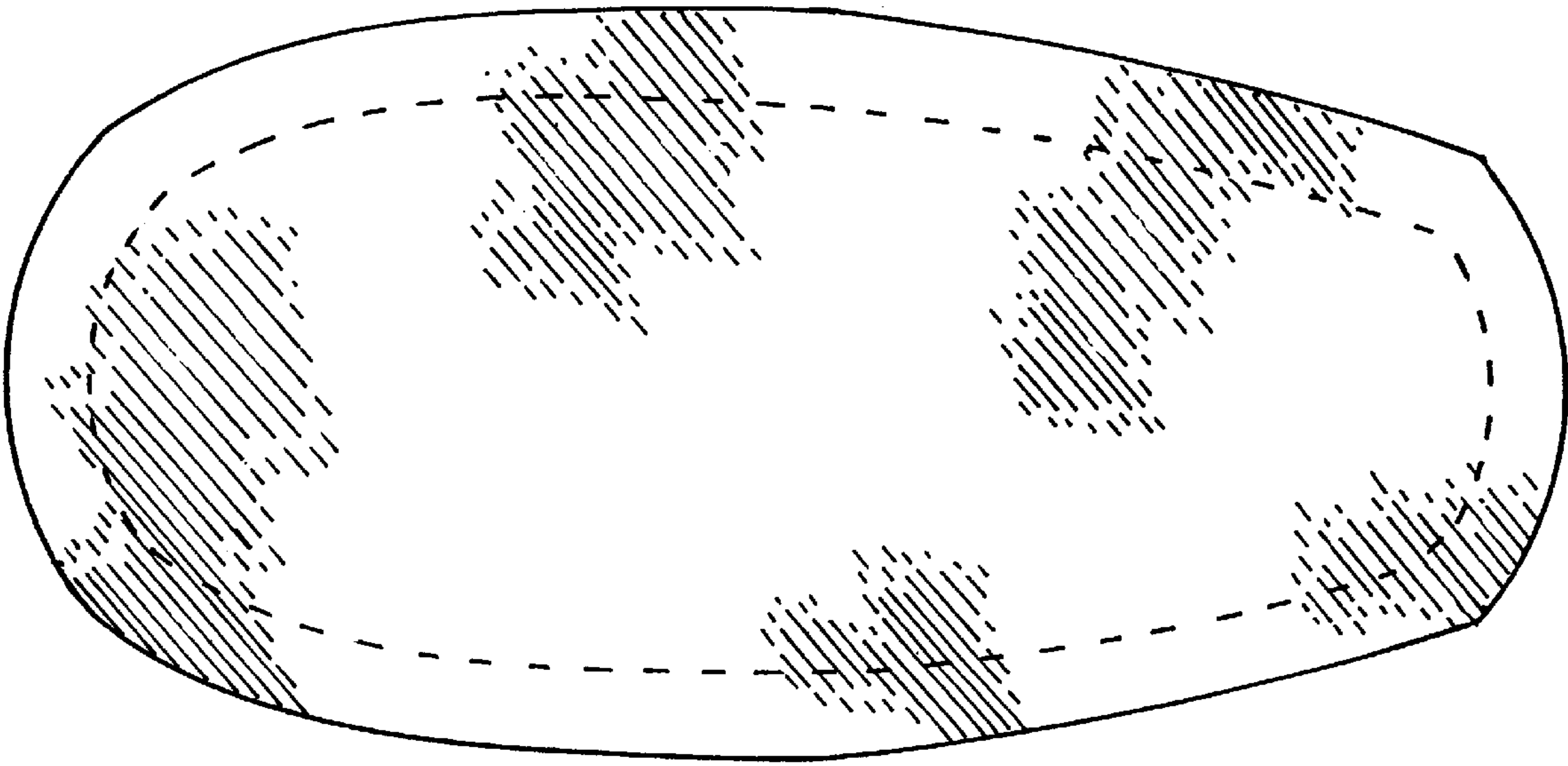

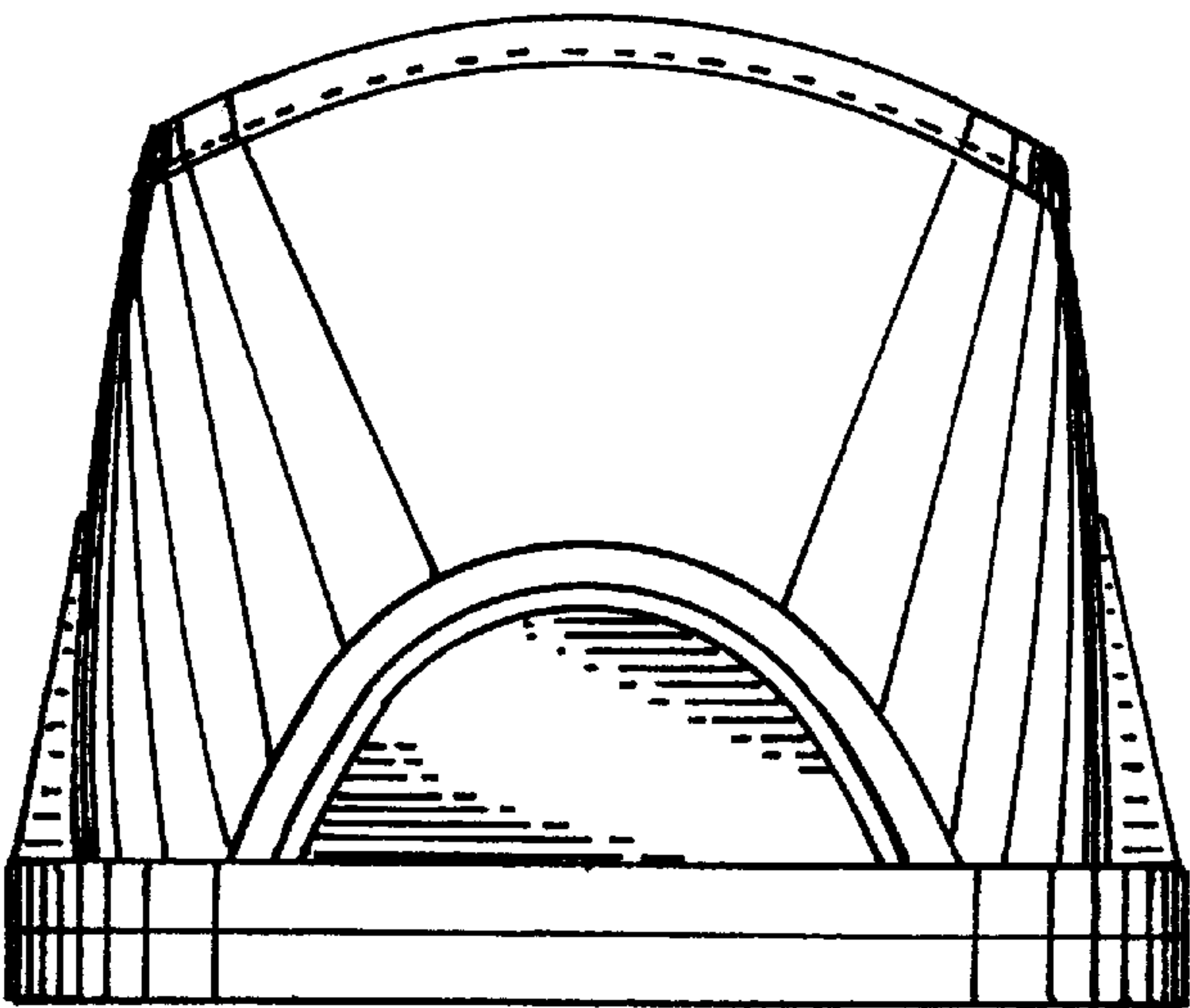
