[57] **CLAIM**

The ornamental design for a vehicle wheel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle wheel, showing my new design;
FIG. 2 is a side view, in enlarged scale, of the wheel shown in FIG. 1, the right side being a mirror image thereof; and,
FIG. 3 is a front view, in enlarged scale, of the wheel shown in FIG. 1.

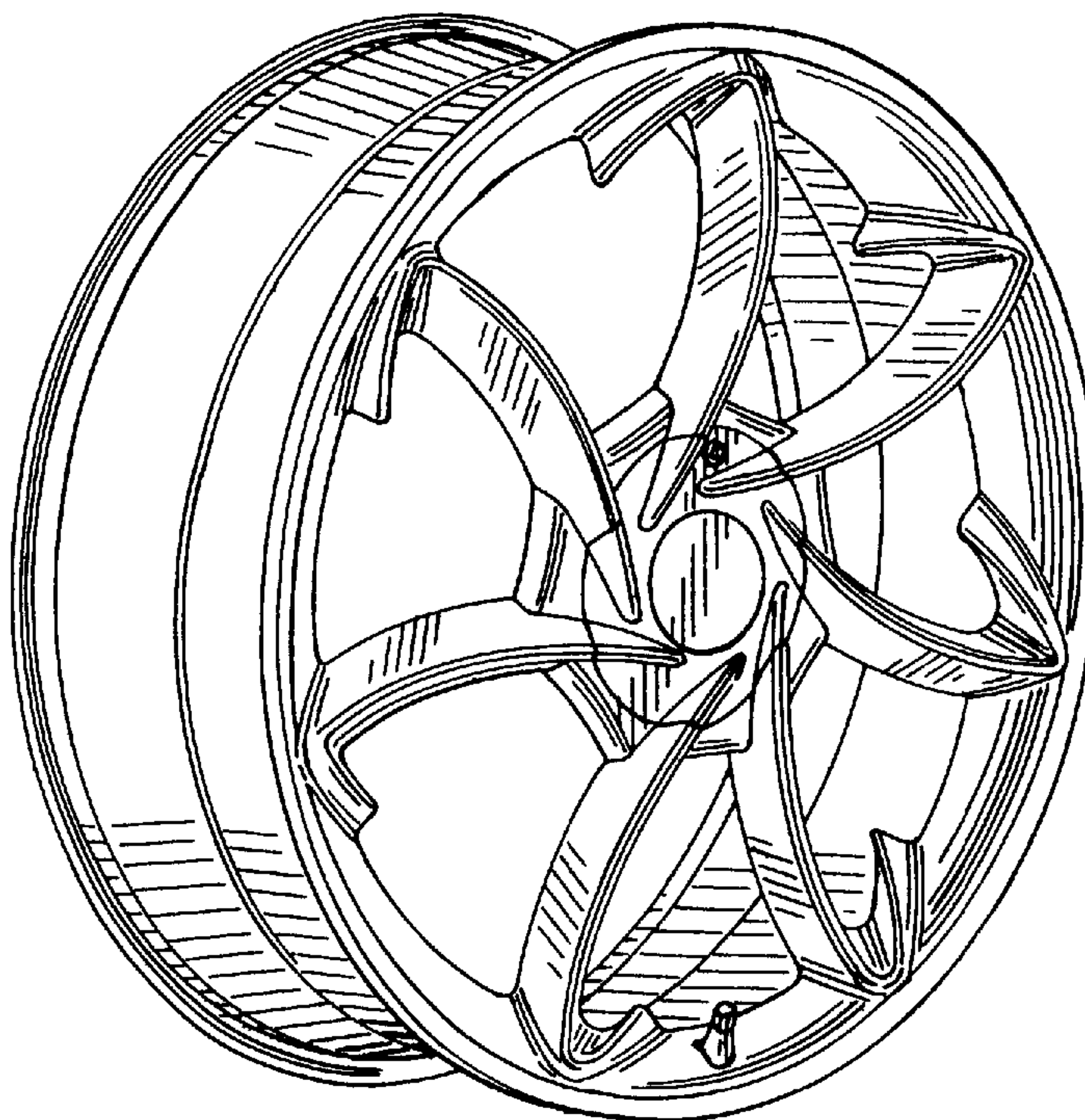

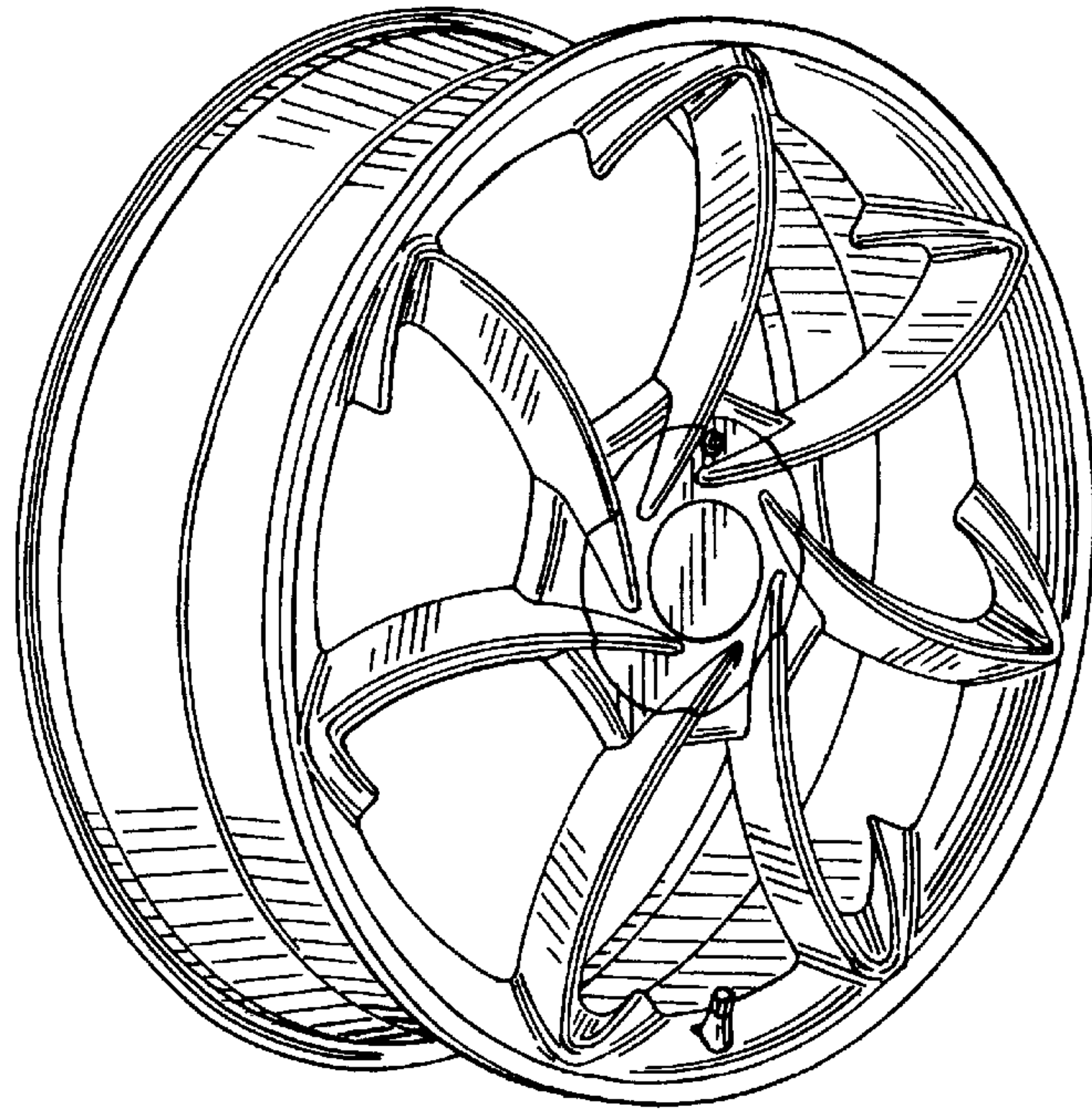

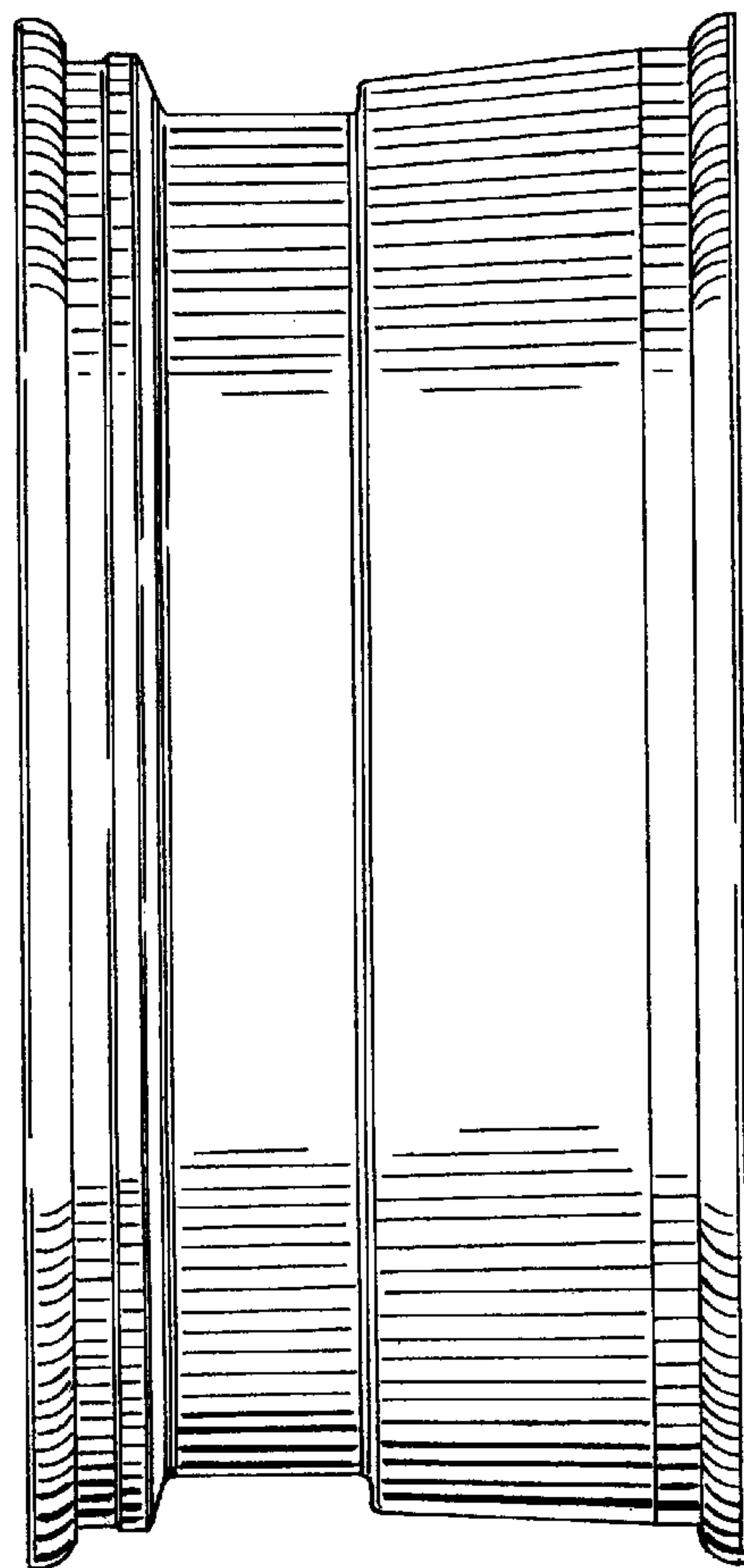
