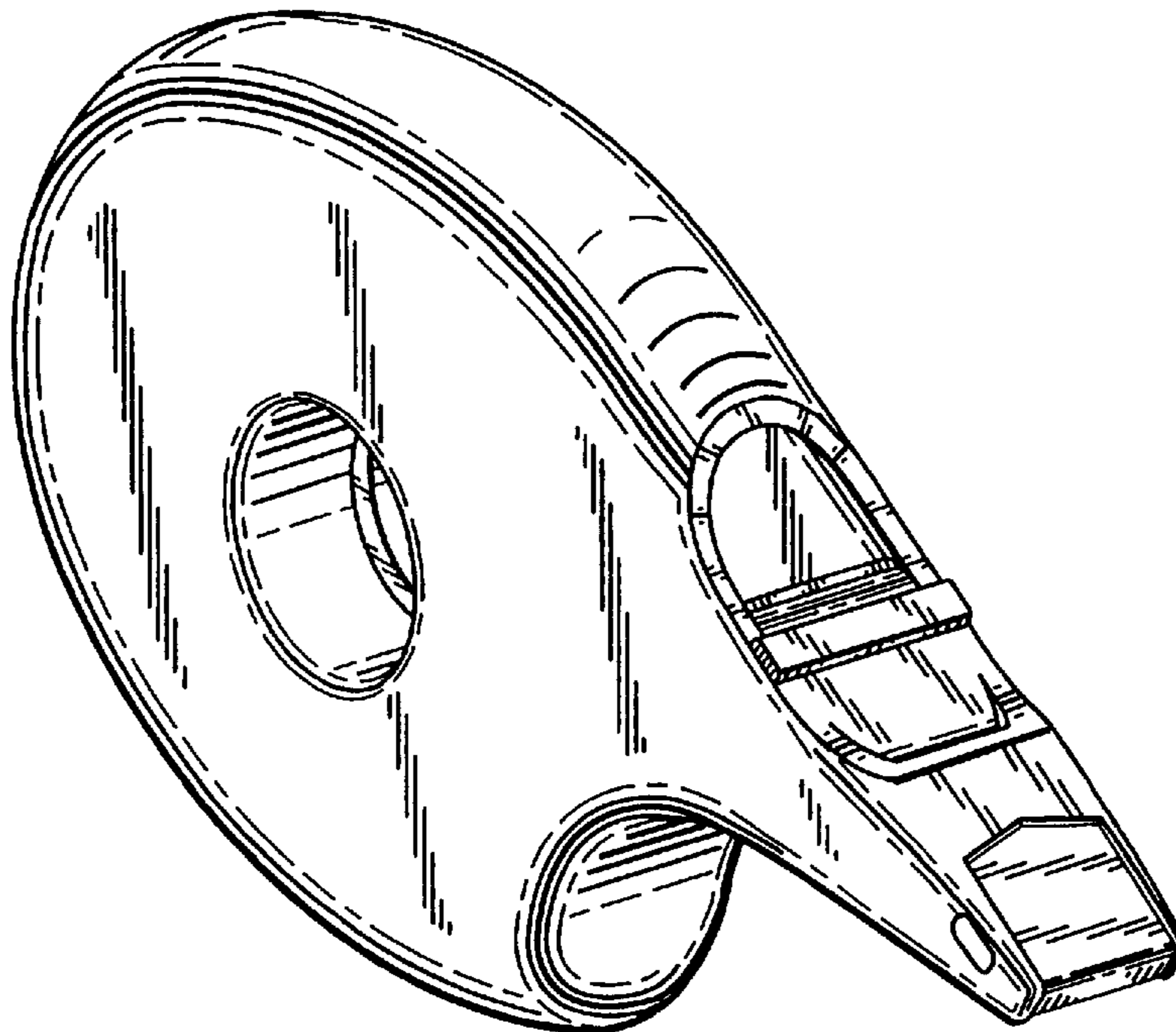

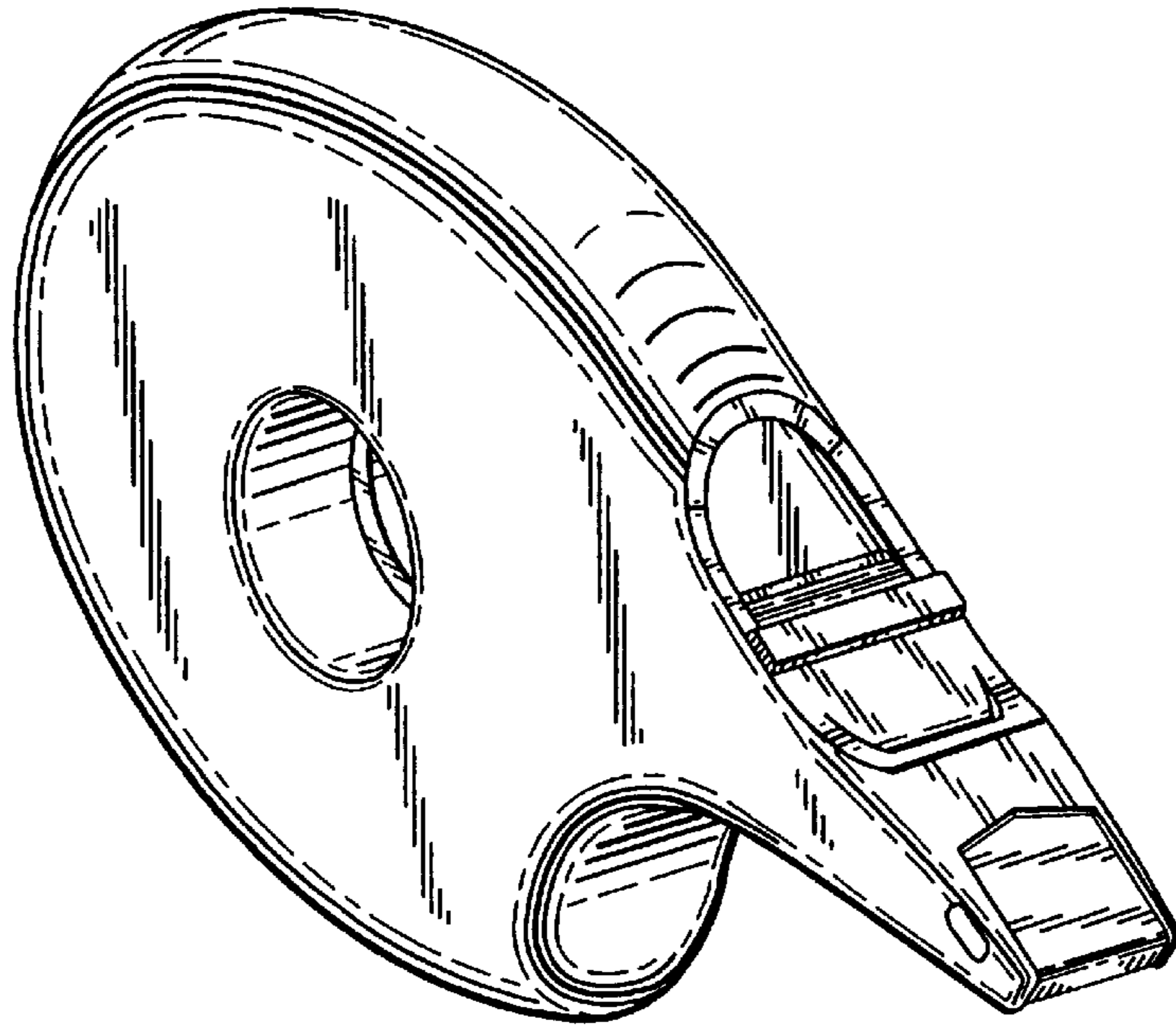
The ornamental design for a tape dispenser, as shown.

**DESCRIPTION**

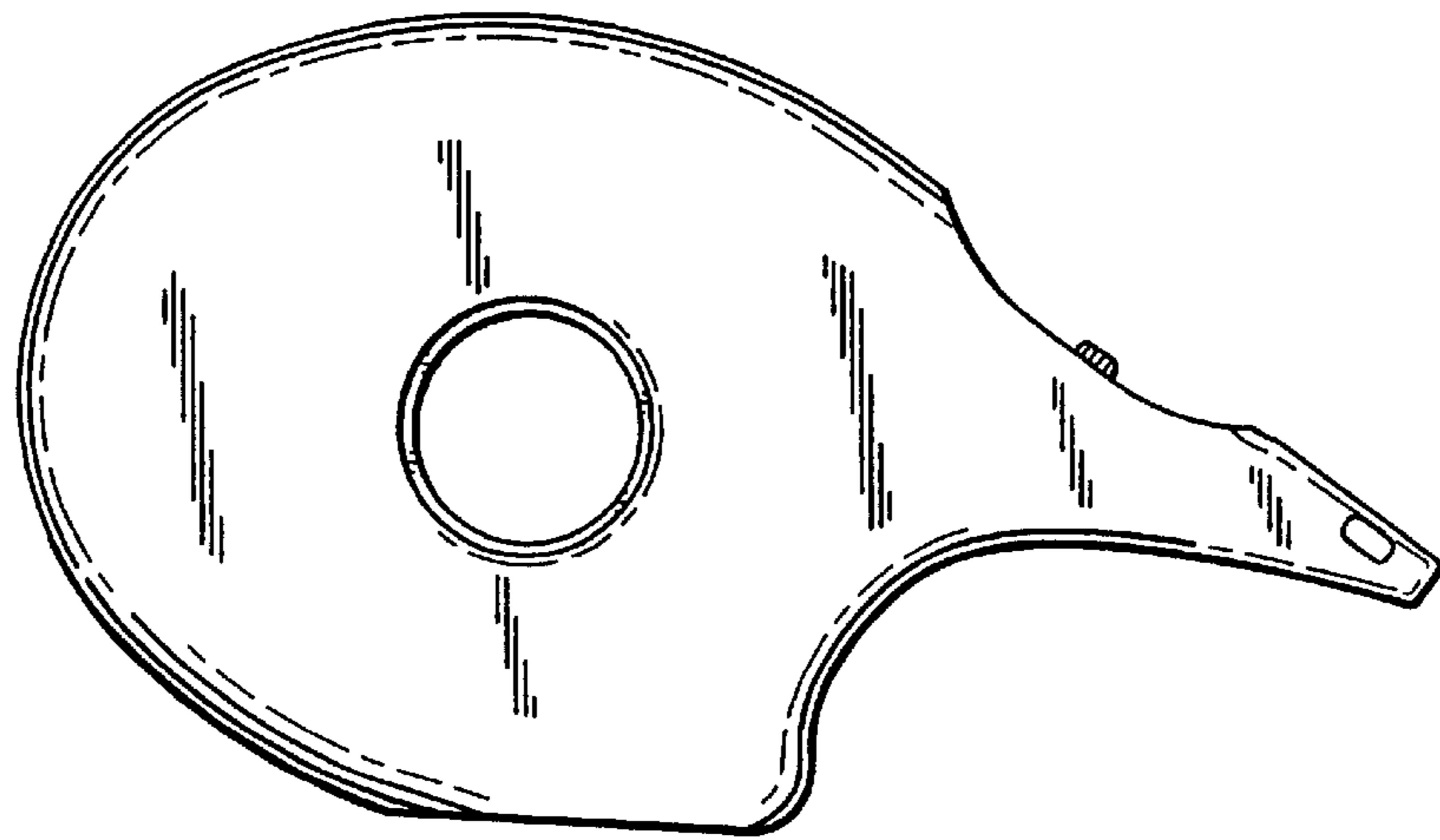
FIG. 1 is an isometric view of a tape dispenser according to the present invention;

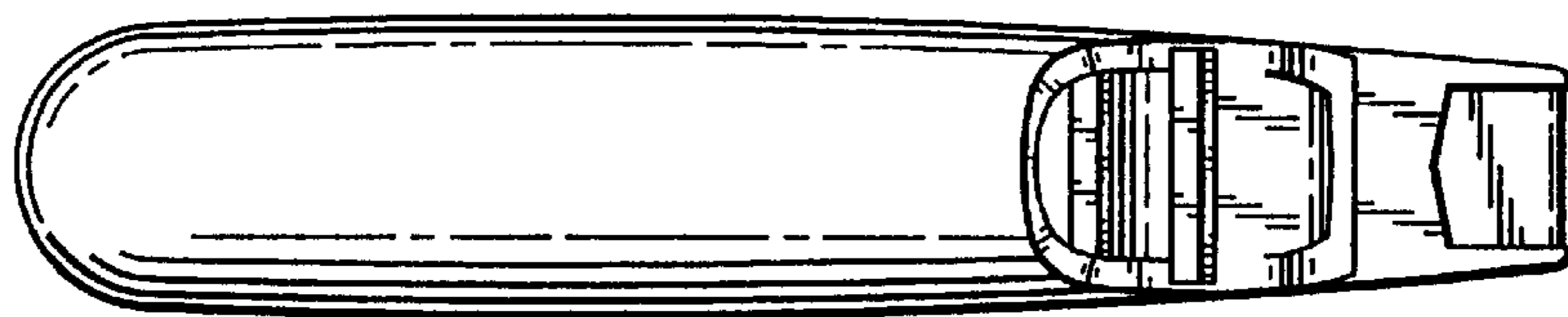




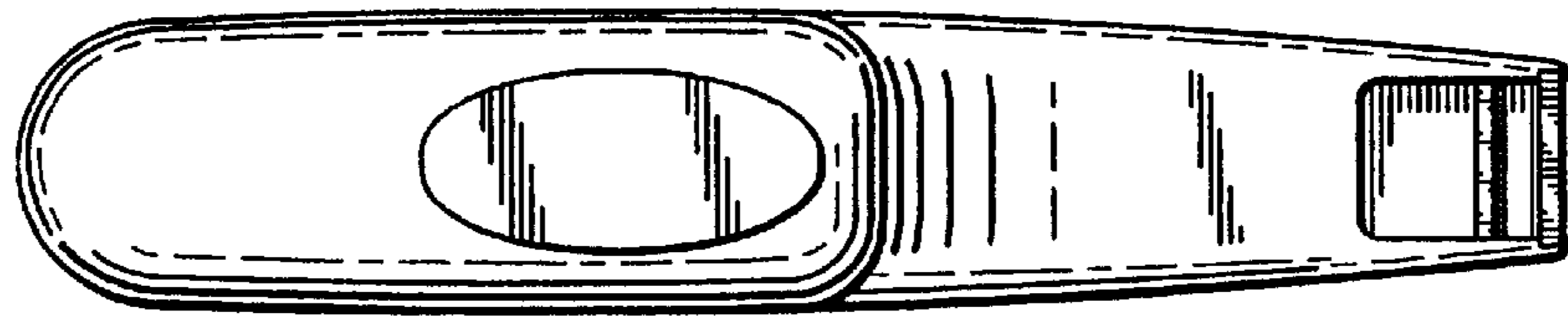

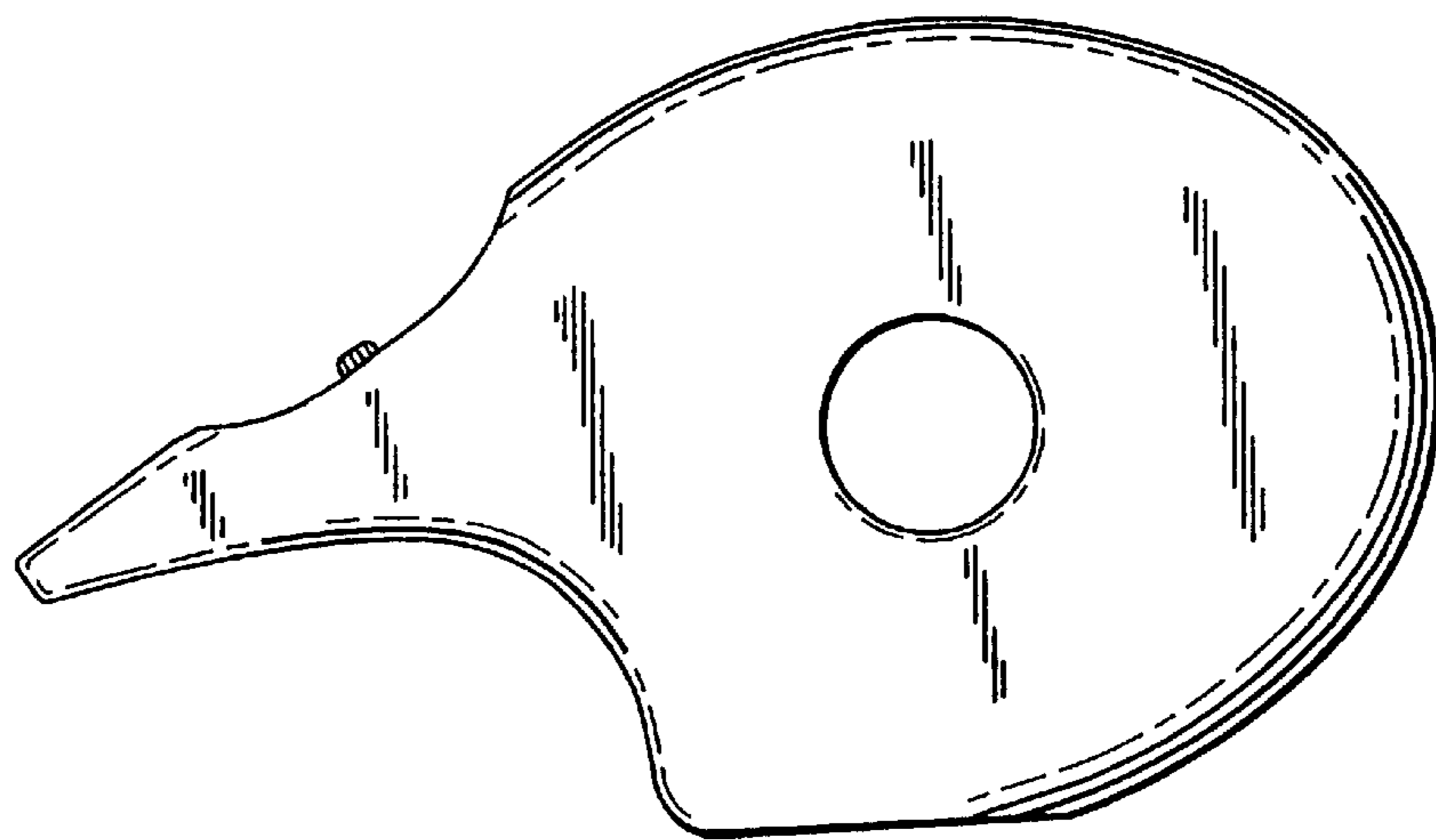

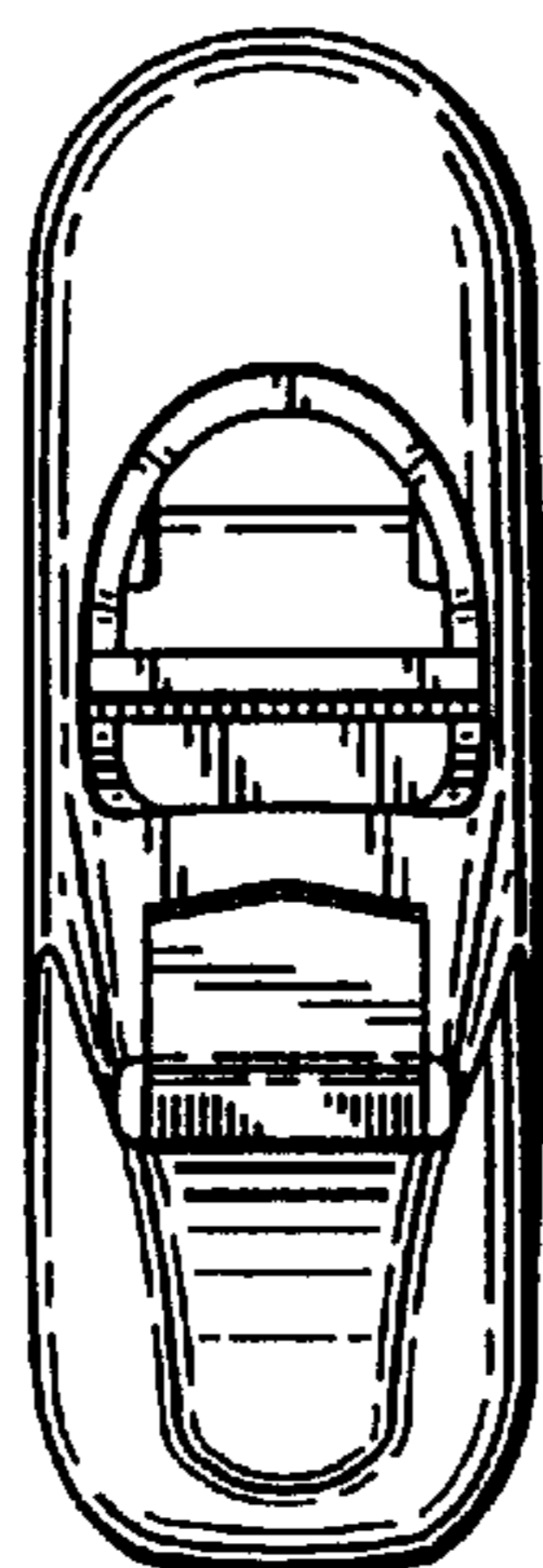

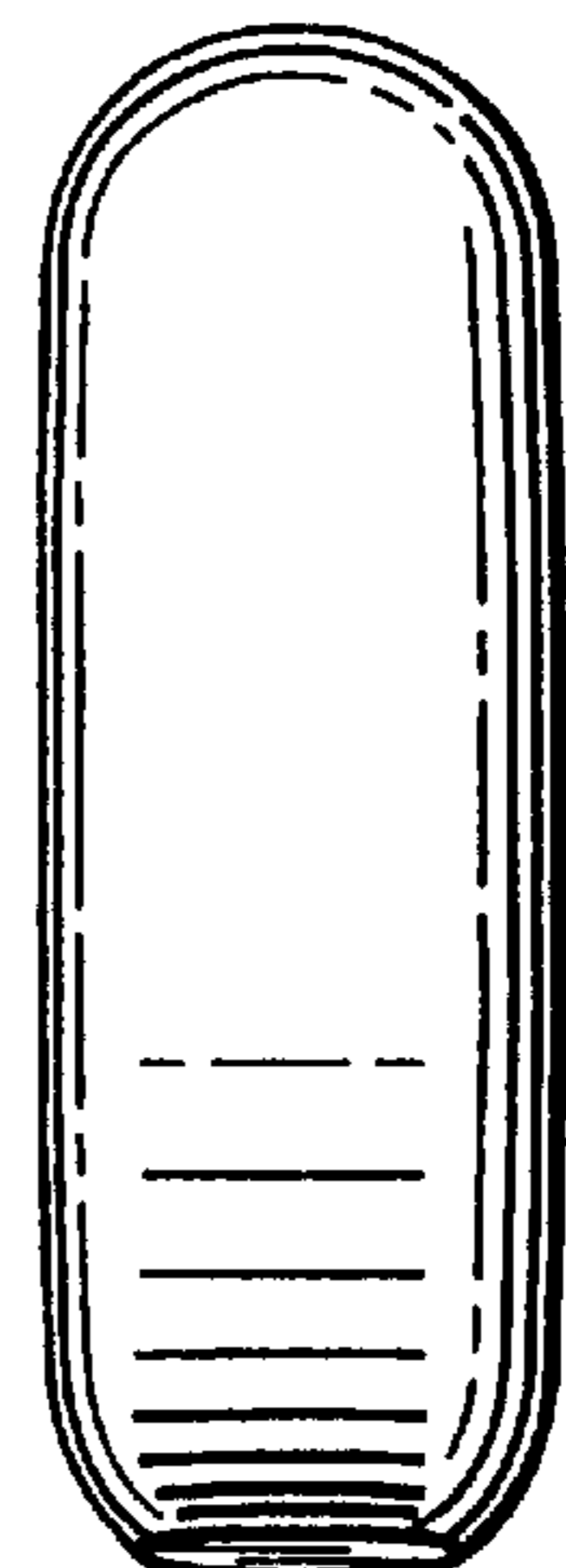
