[57] **CLAIM**

The ornamental design for a candle with a pearl like appearance, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a candle with a pearl like appearance showing our new design, shown in form of an intended use;

FIG. 2 is a side elevational view of the candle shown in FIG. 1;

FIG. 3 is a top plan view of the candle shown in FIG. 1;

FIG. 4 is a bottom plan view of the candle shown in FIG. 1;

FIG. 5 is a perspective view of the candle shown in another form of intended use;

FIG. 6 is a side elevational view of the candle shown in FIG. 5;

FIG. 7 is a top plan view of the candle shown in FIG. 5;

FIG. 8 is a bottom plan view of the candle shown in FIG. 5;

FIG. 9 is a perspective view of the candle in yet another form of intended use;

FIG. 10 is a side elevational view of the candle shown in FIG. 9;

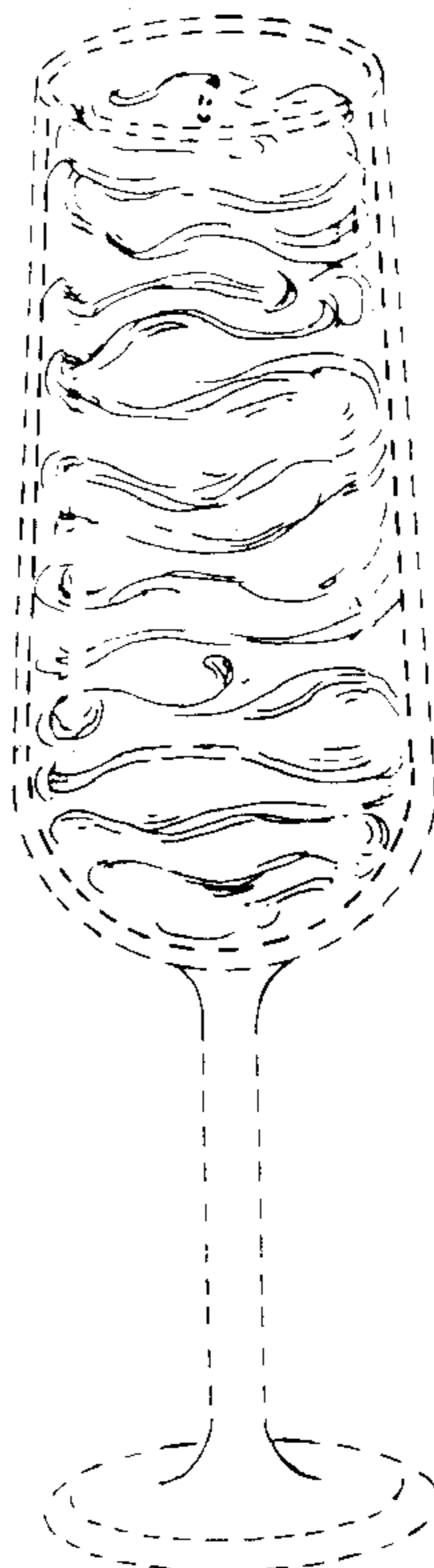
FIG. 11 is a top plan view of the candle shown in FIG. 9; and,

FIG. 12 is a bottom plan view of the candle shown in FIG. 9.

The characteristic feature of the gel candle design resides in its pearl-like appearance.

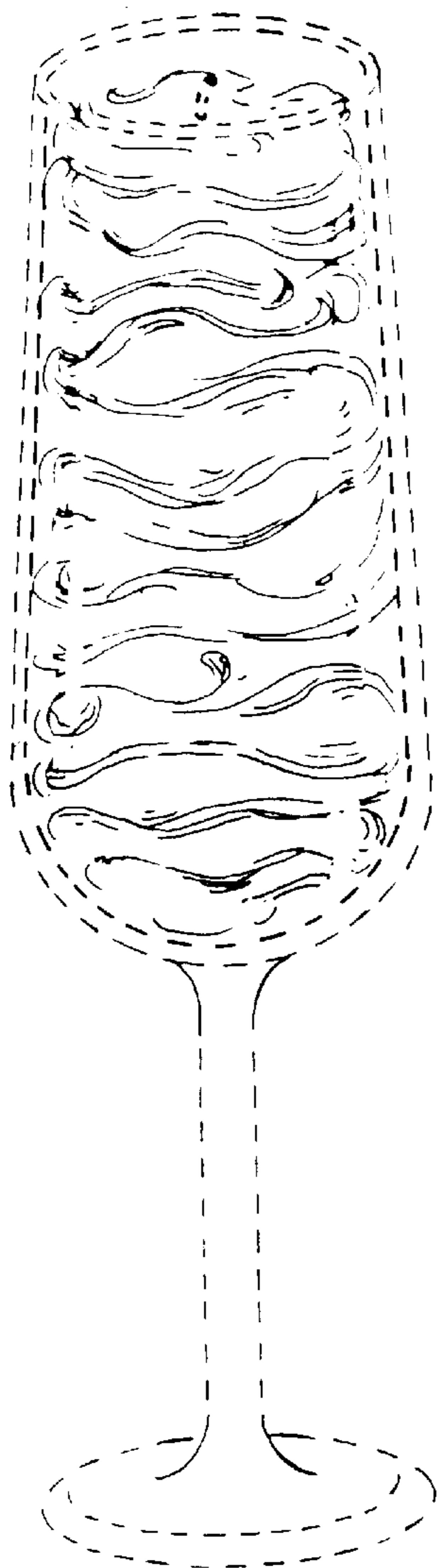

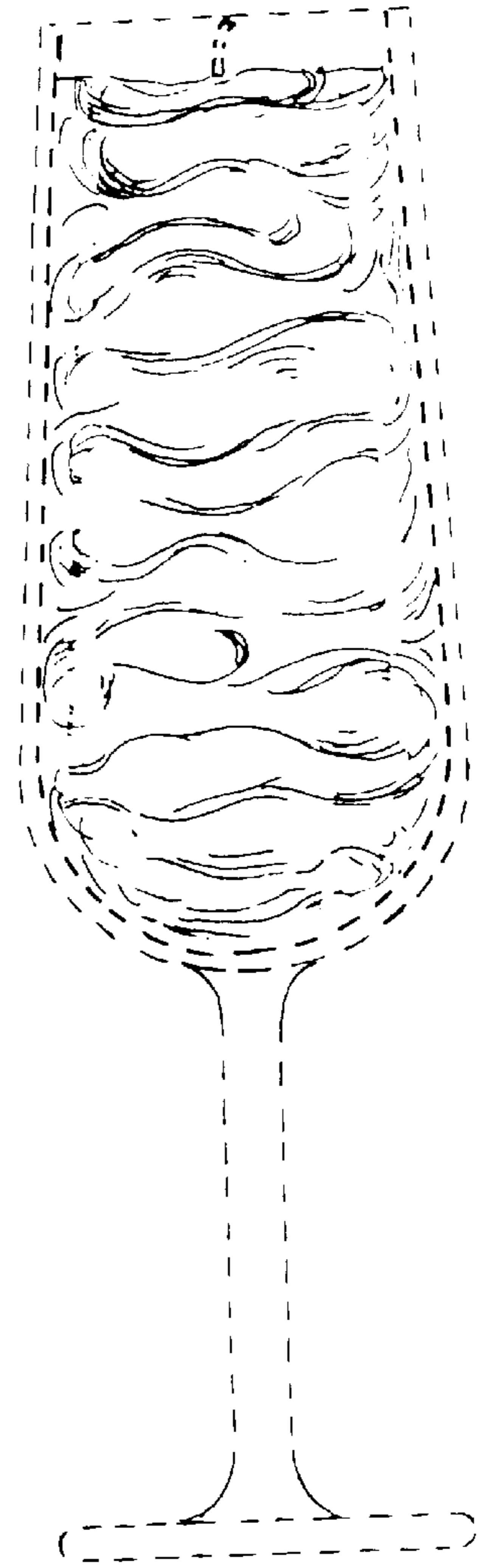

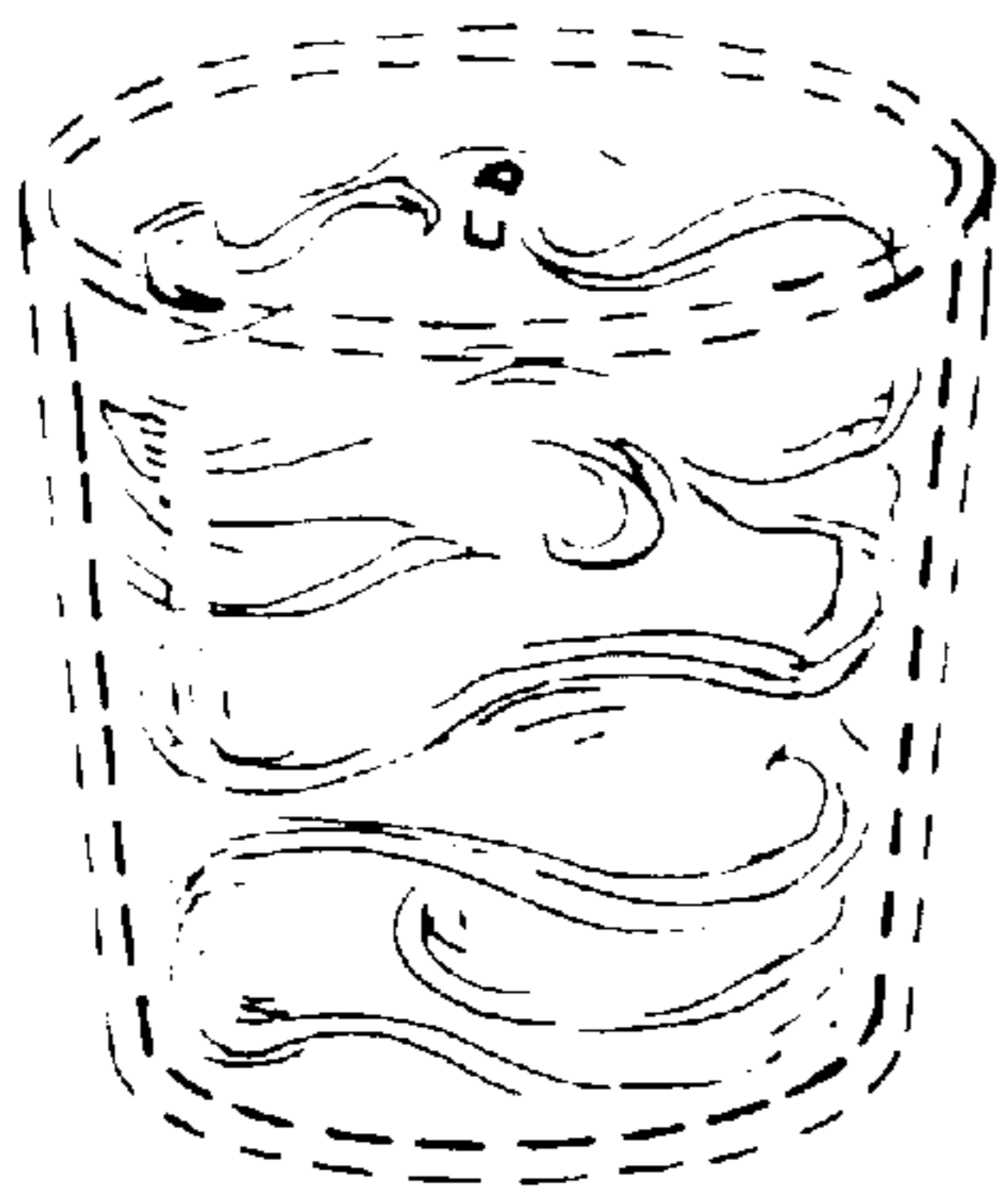

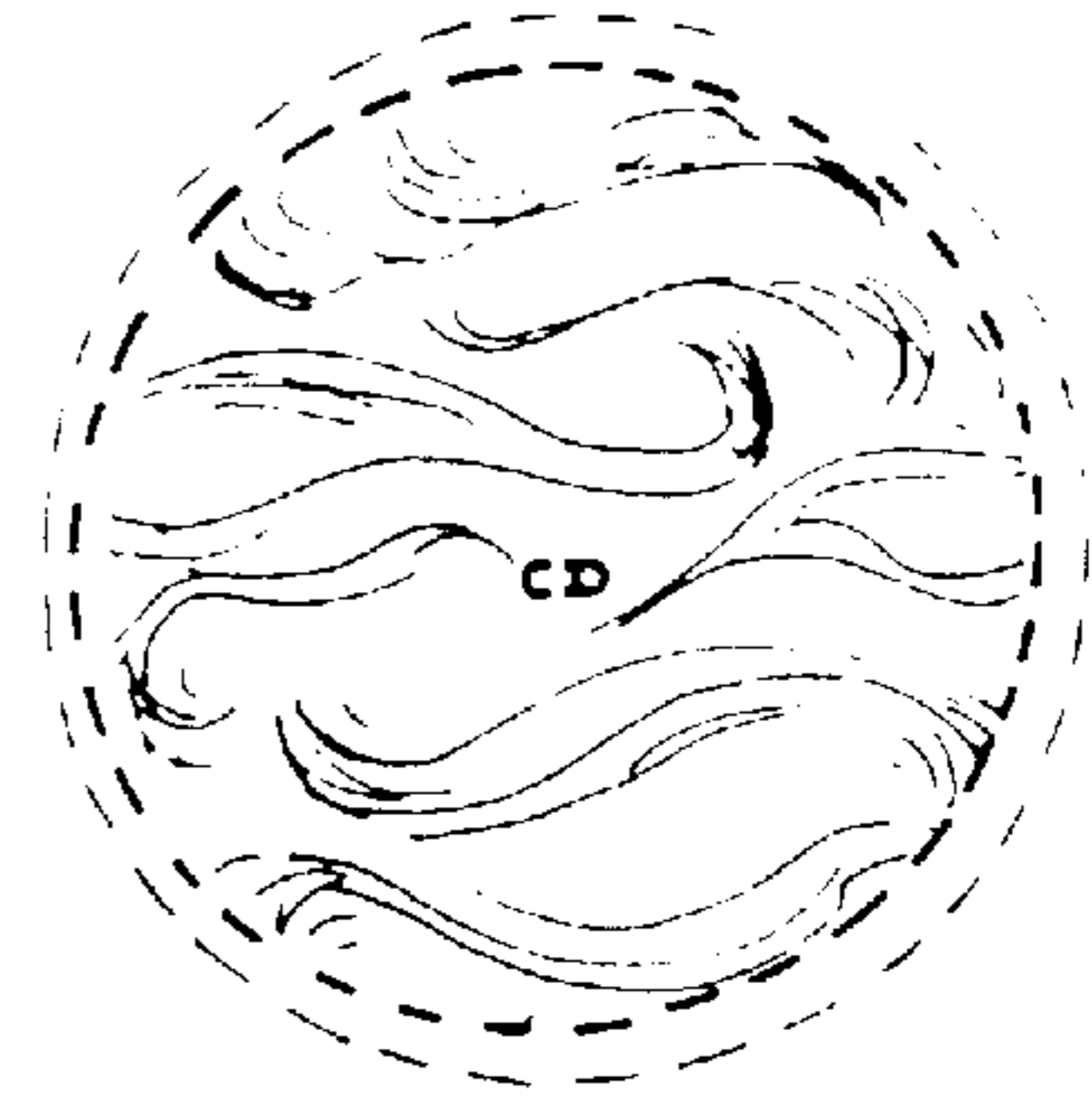

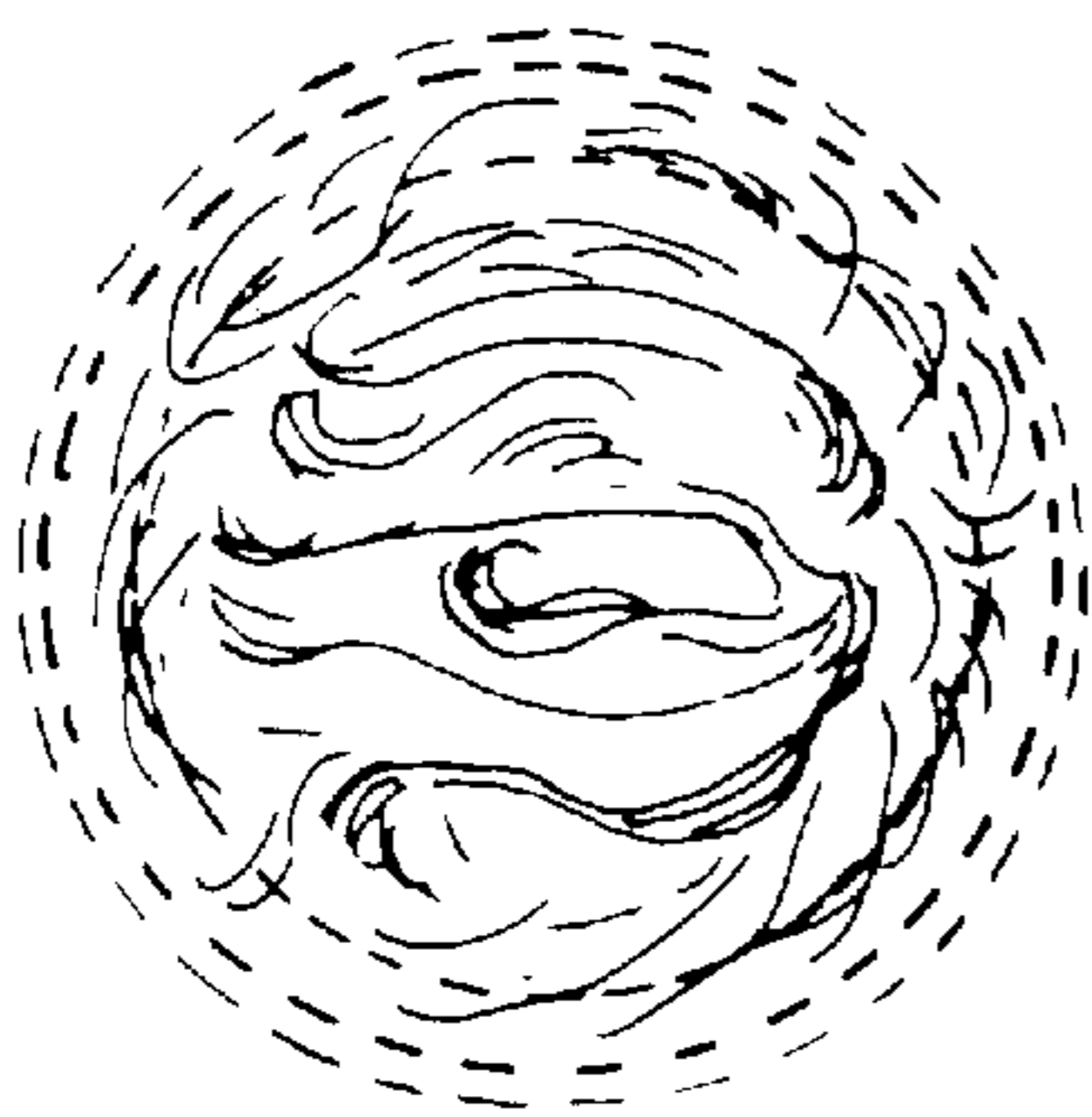

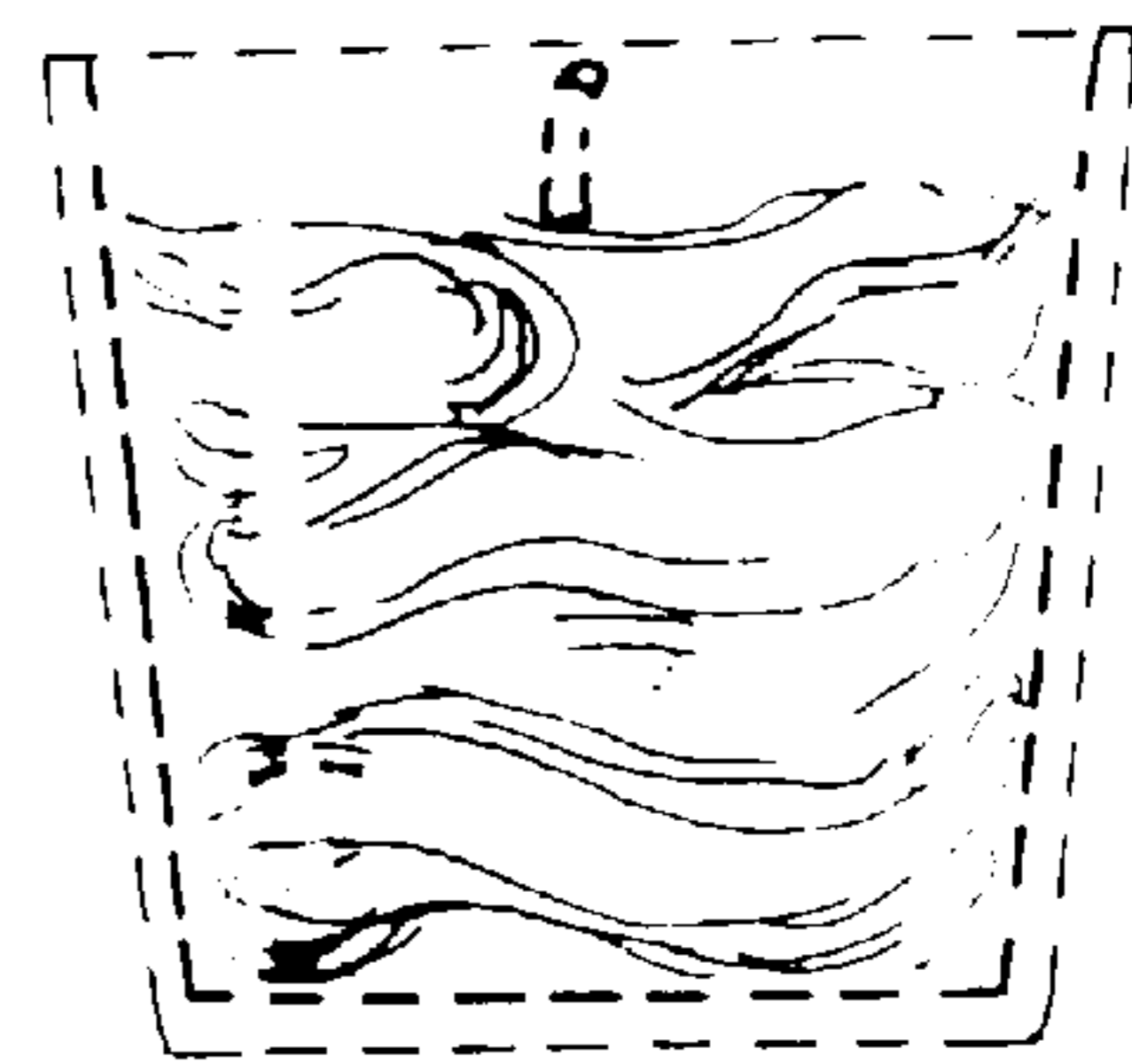

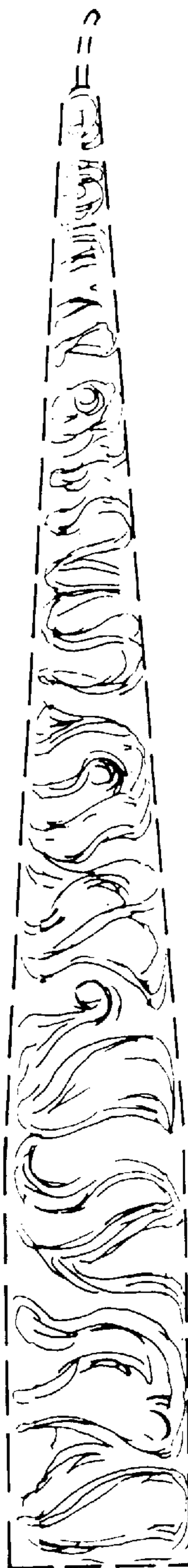
