[57] **CLAIM**

I claim the ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a shoe outsole showing my new design, the opposite side being a mirror image, and the broken lines showing a shoe being for illustrative purposes only and forming no part of the claimed design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevational view thereof; and, FIG. 5 is a rear elevational view thereof.

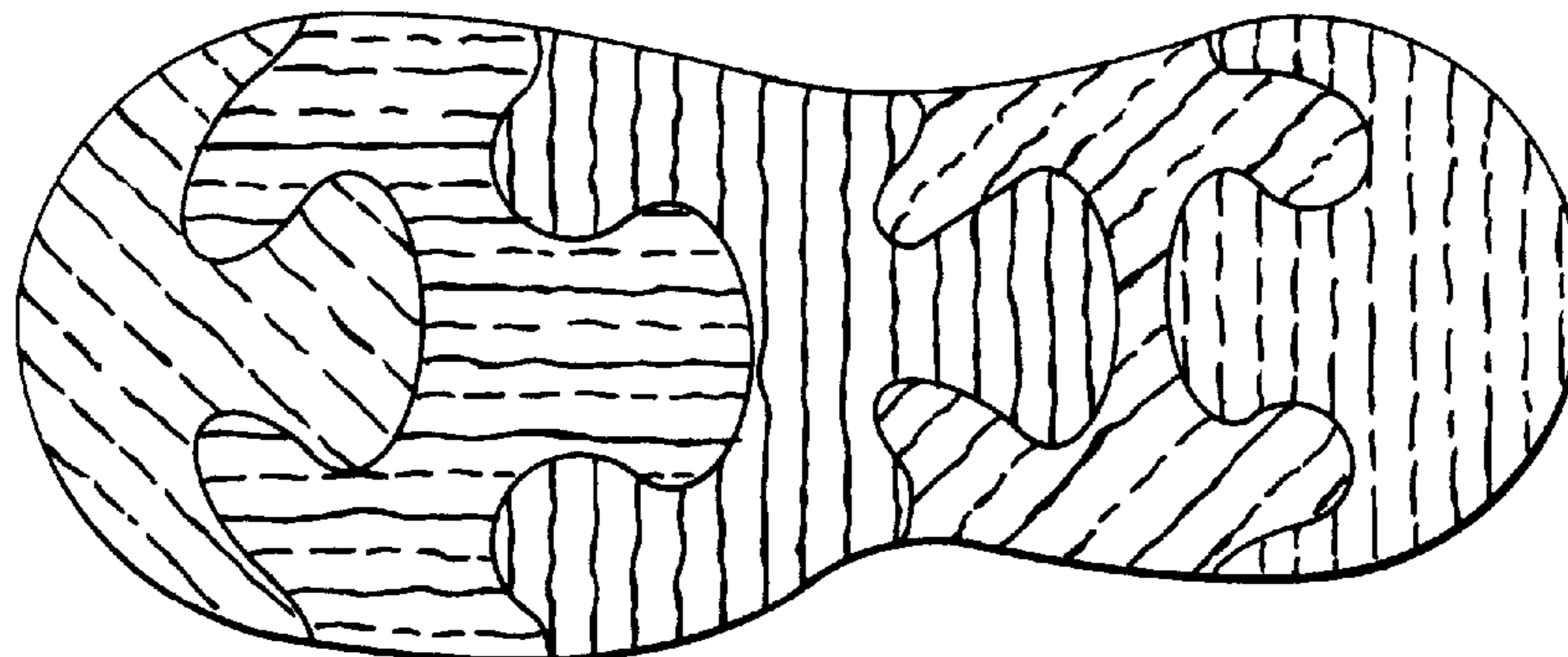

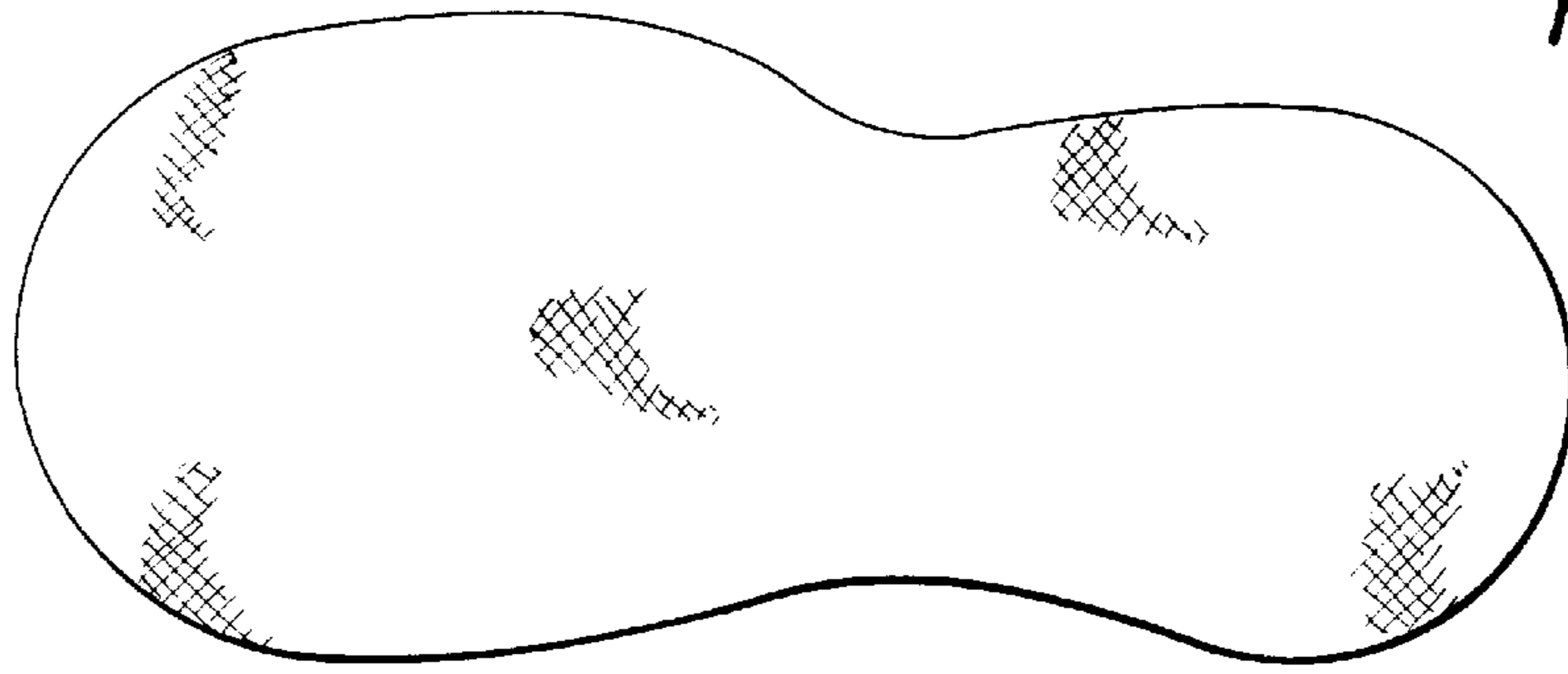

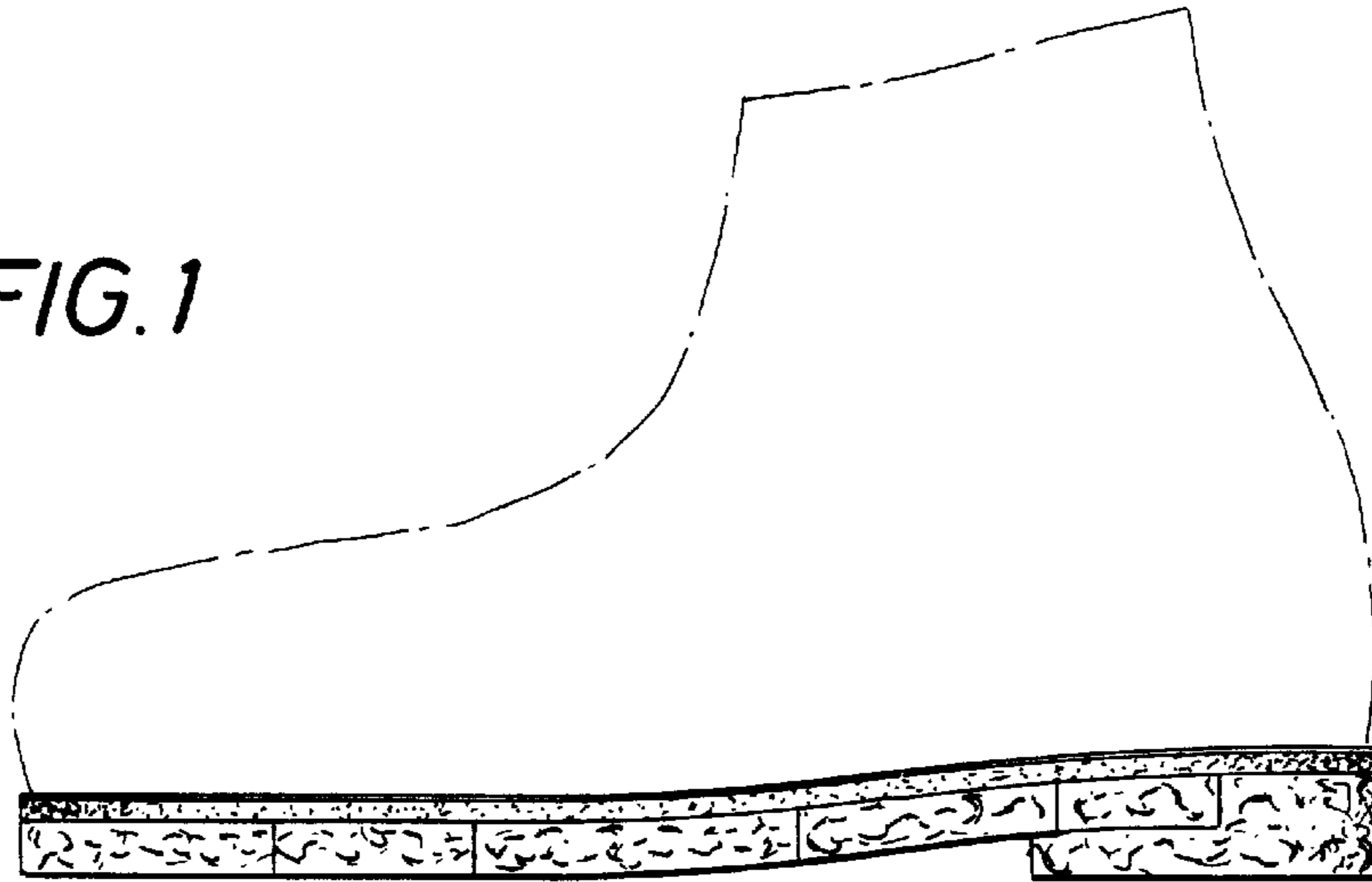

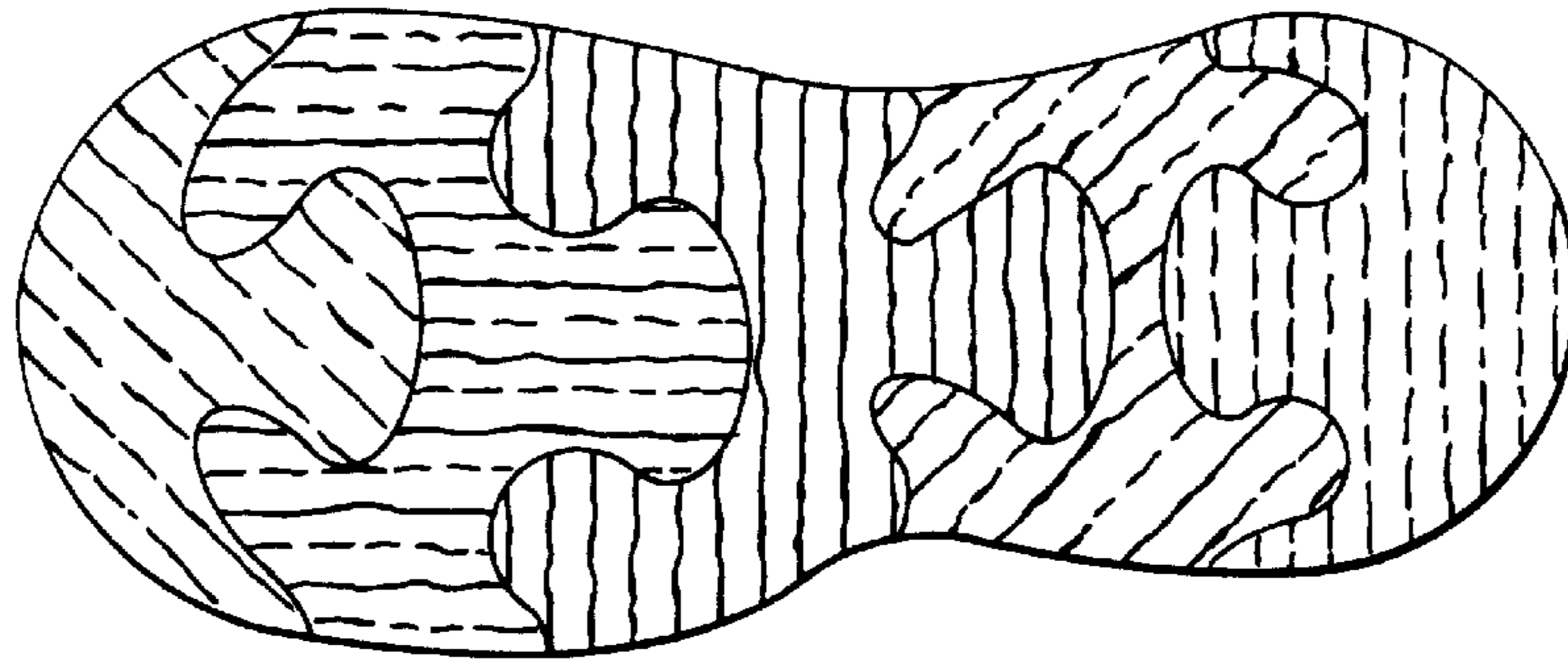

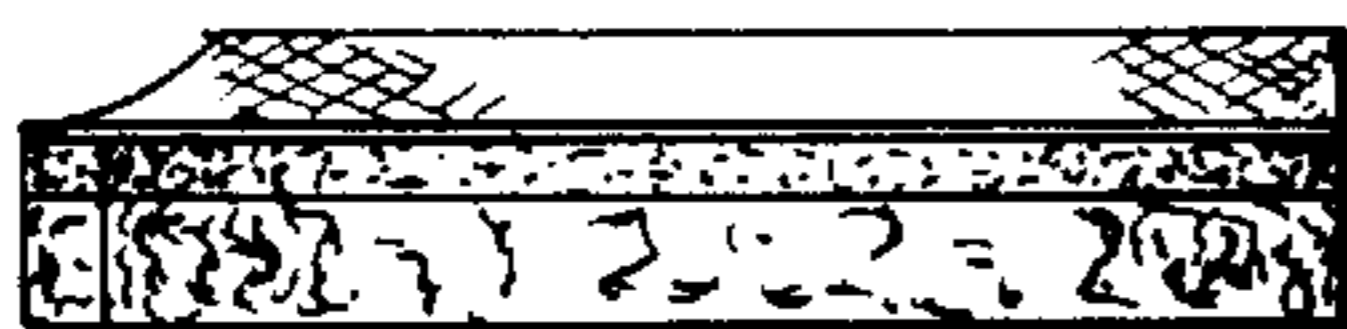
