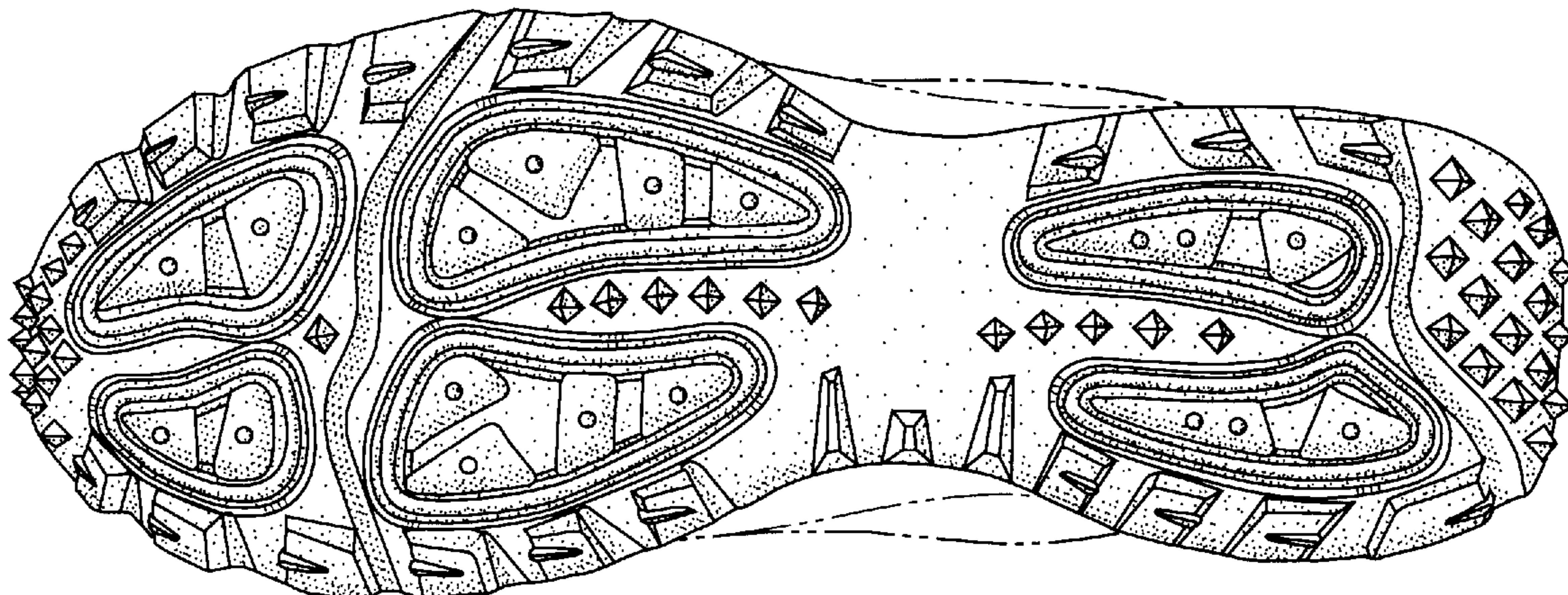
[57] **CLAIM**

The ornamental design for an outsole of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the outsole of a shoe showing my new design;
 FIG. 2 is a front elevational view of the outsole of a shoe shown in FIG. 1;
 FIG. 3 is a rear elevational view of the outsole of a shoe shown in FIG. 1; and,
 FIG. 4 is a bottom plan view of the outsole of a shoe shown in FIG. 1.
 The phantom line showing of a shoe upper and midsole shown in FIGS. 1-4 is for illustrative purposes only and forms no part of the claimed design.

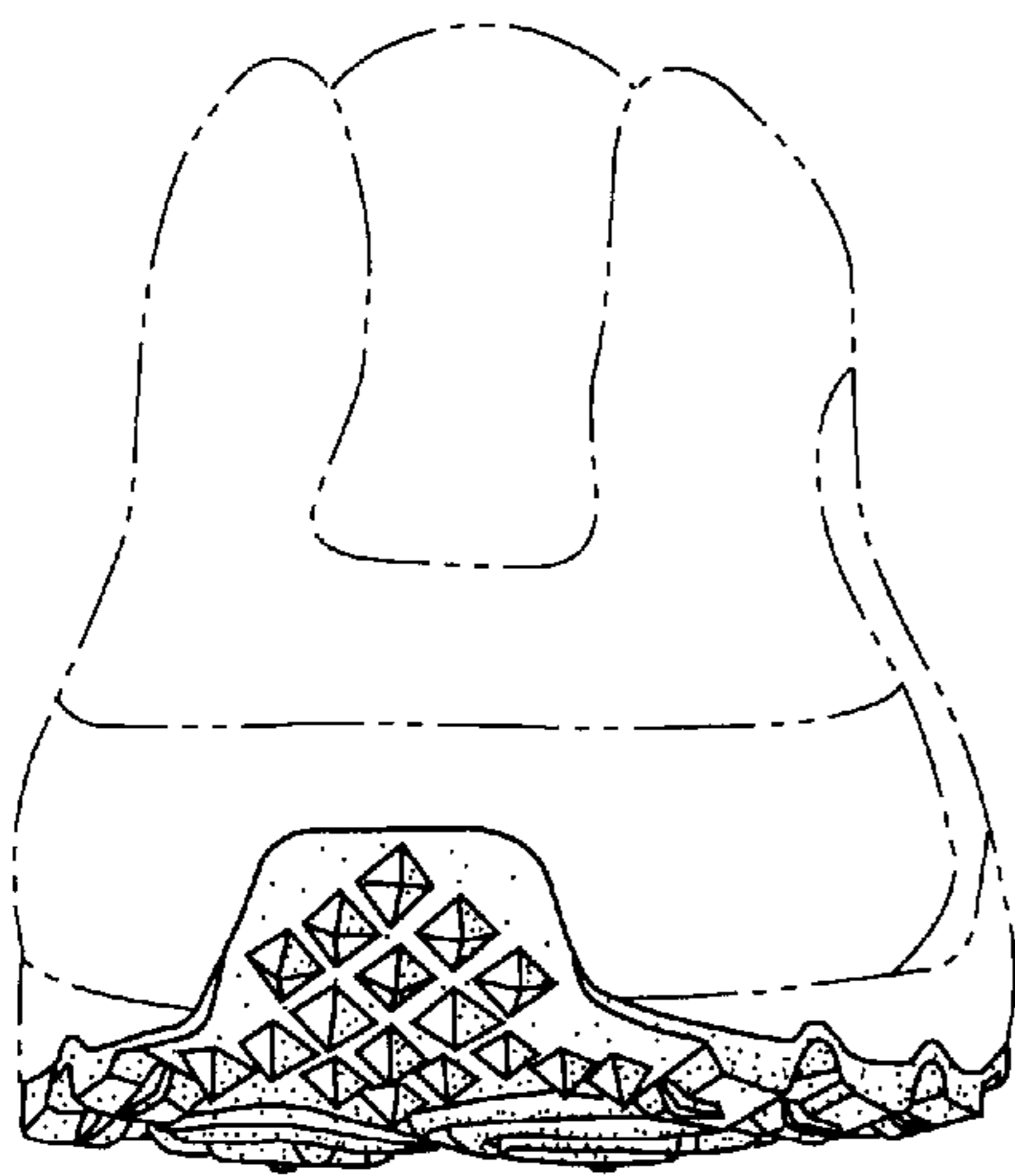

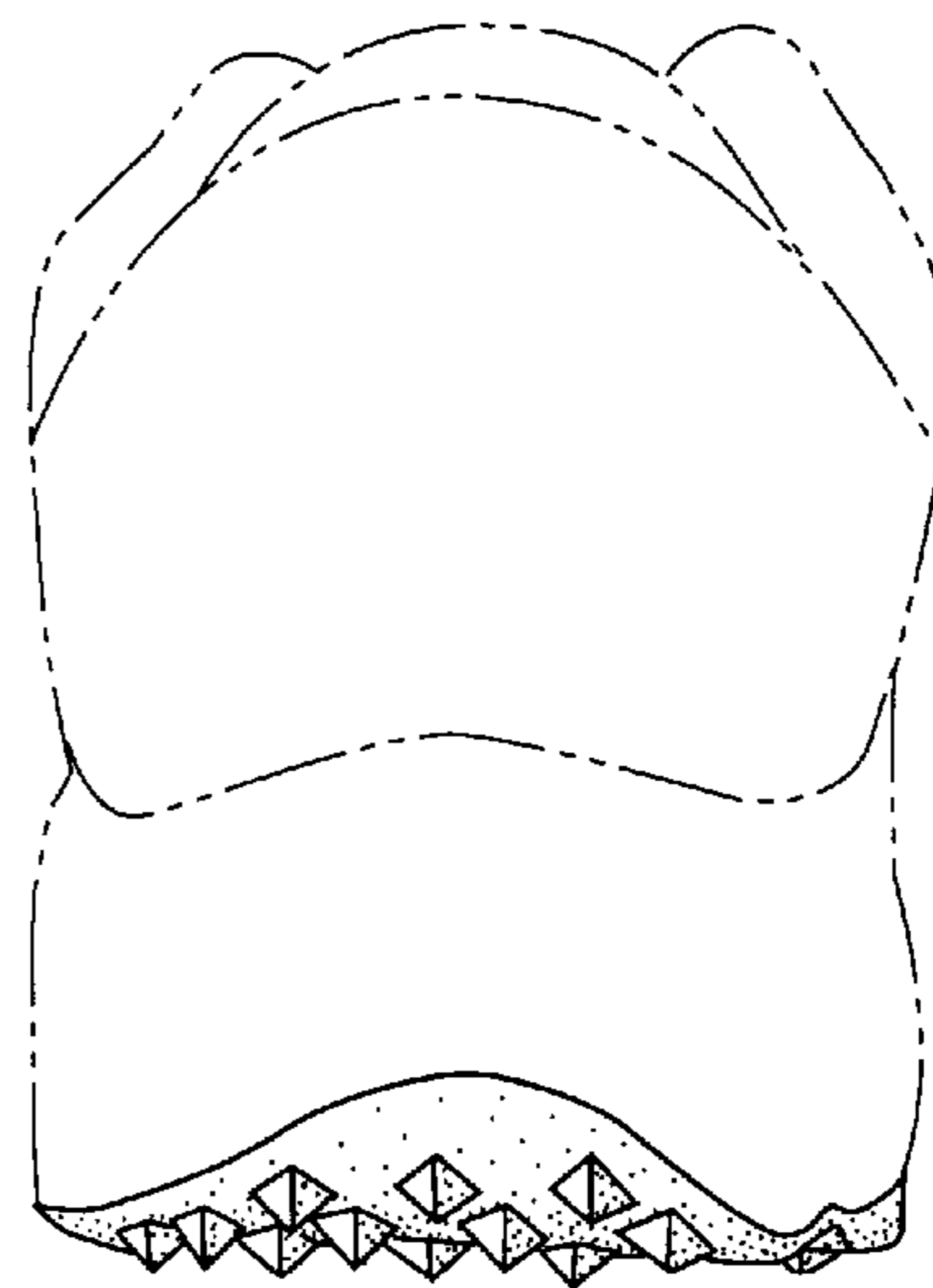

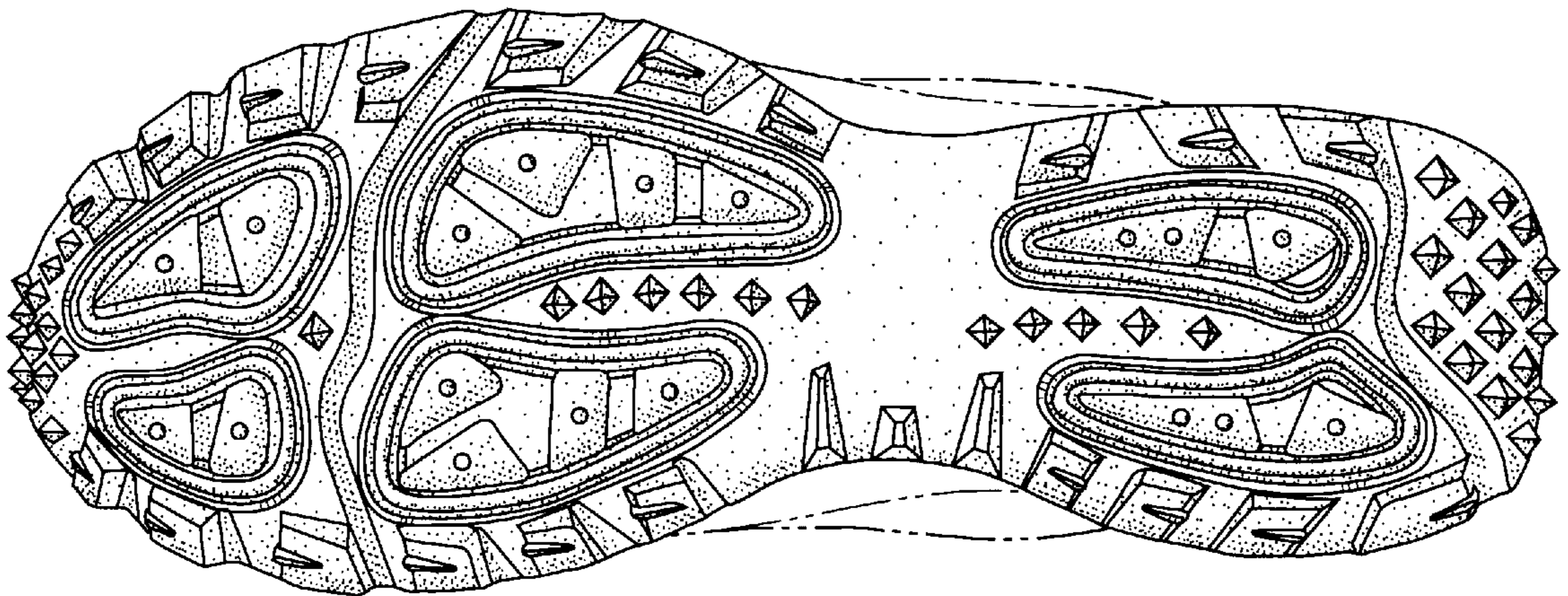
