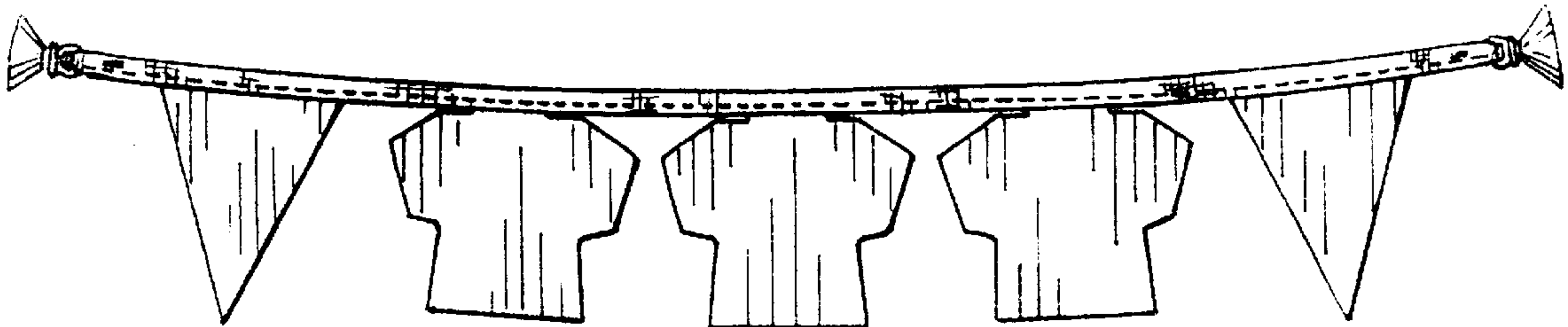
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of a pennants display, according to our invention;  
FIG. 2 is a rear elevational view thereof;

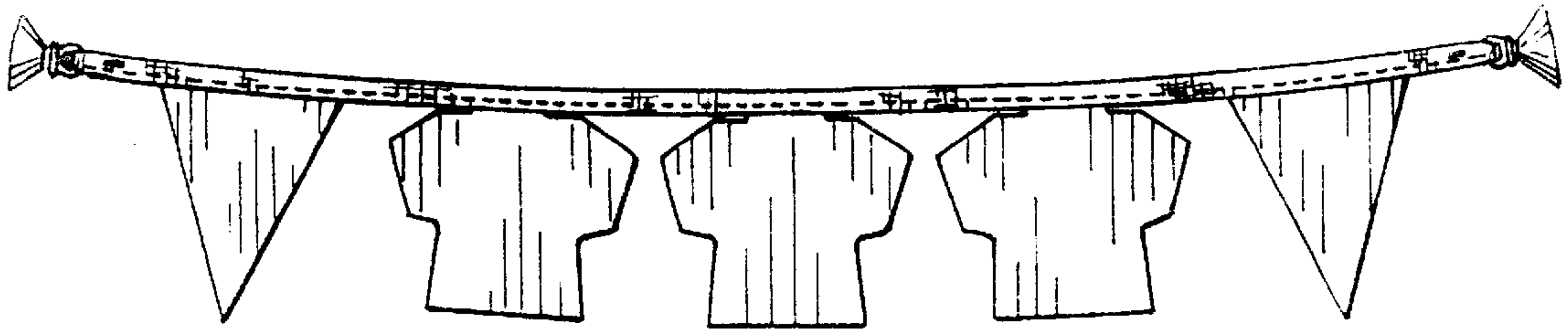

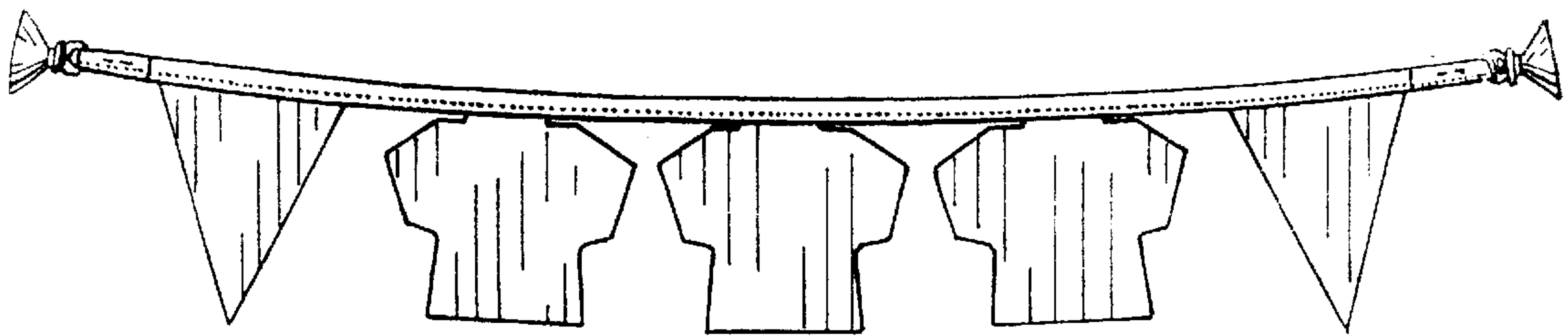

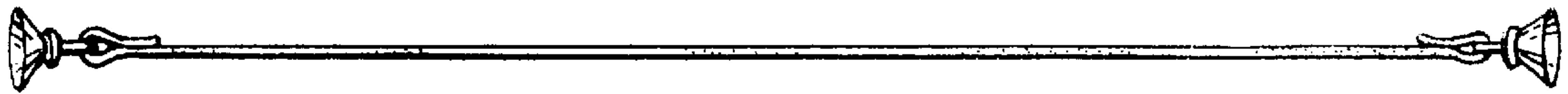
