DESCRIPTION

mounting assembly showing my new design in a position of
use;

position of use with a third mirror and mirror housing;

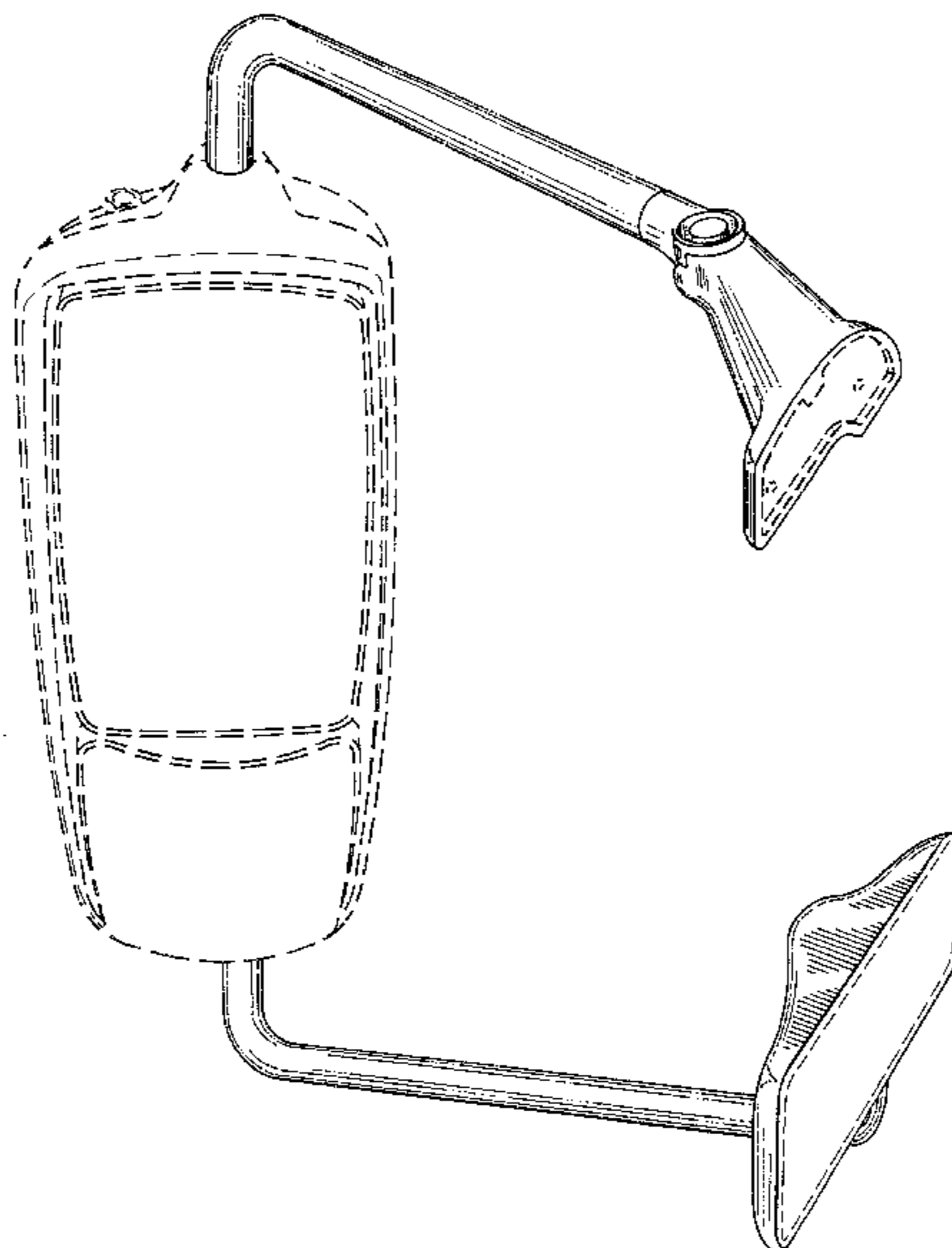
FIG. 10 is a top front perspective view of FIG. 1 shown in

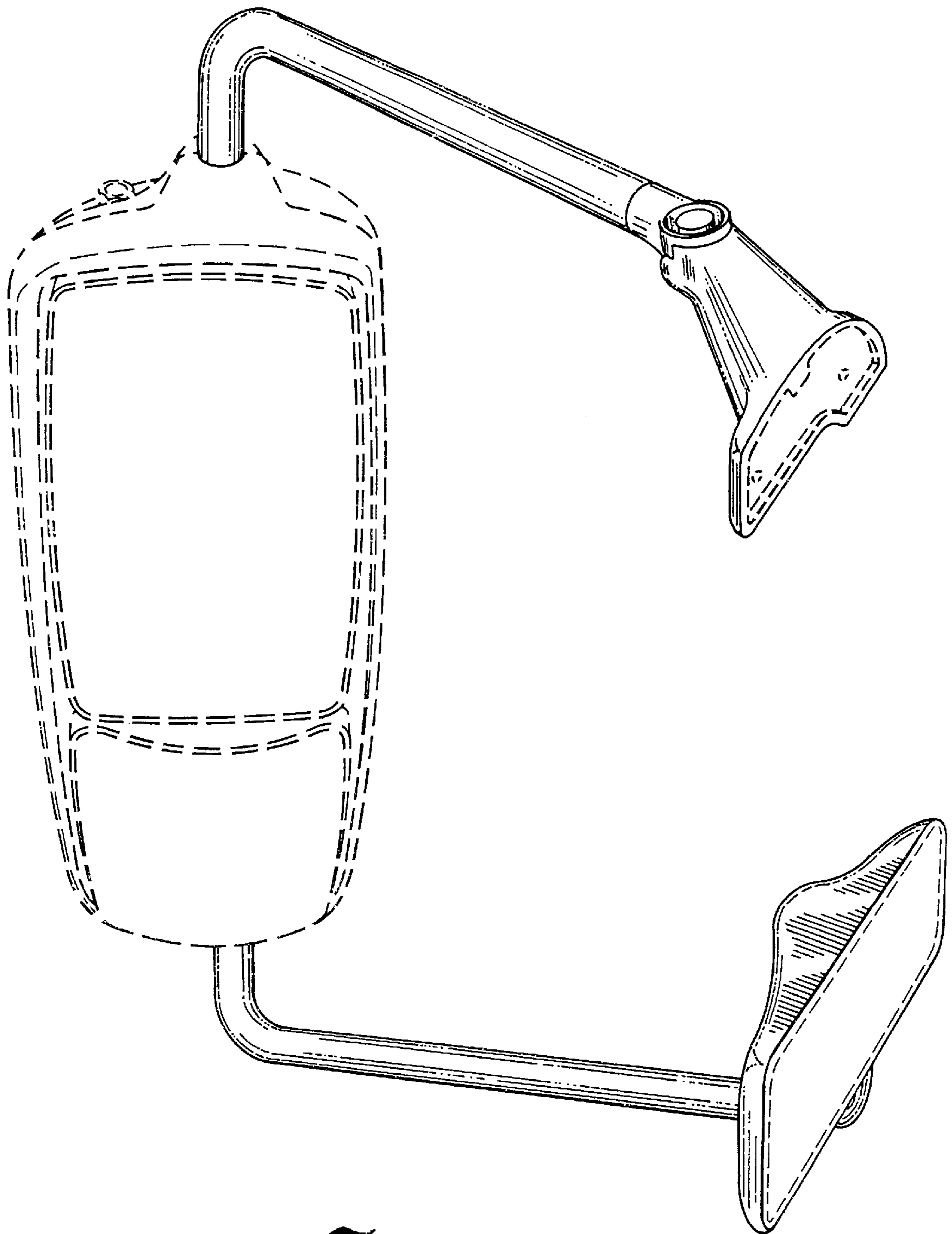

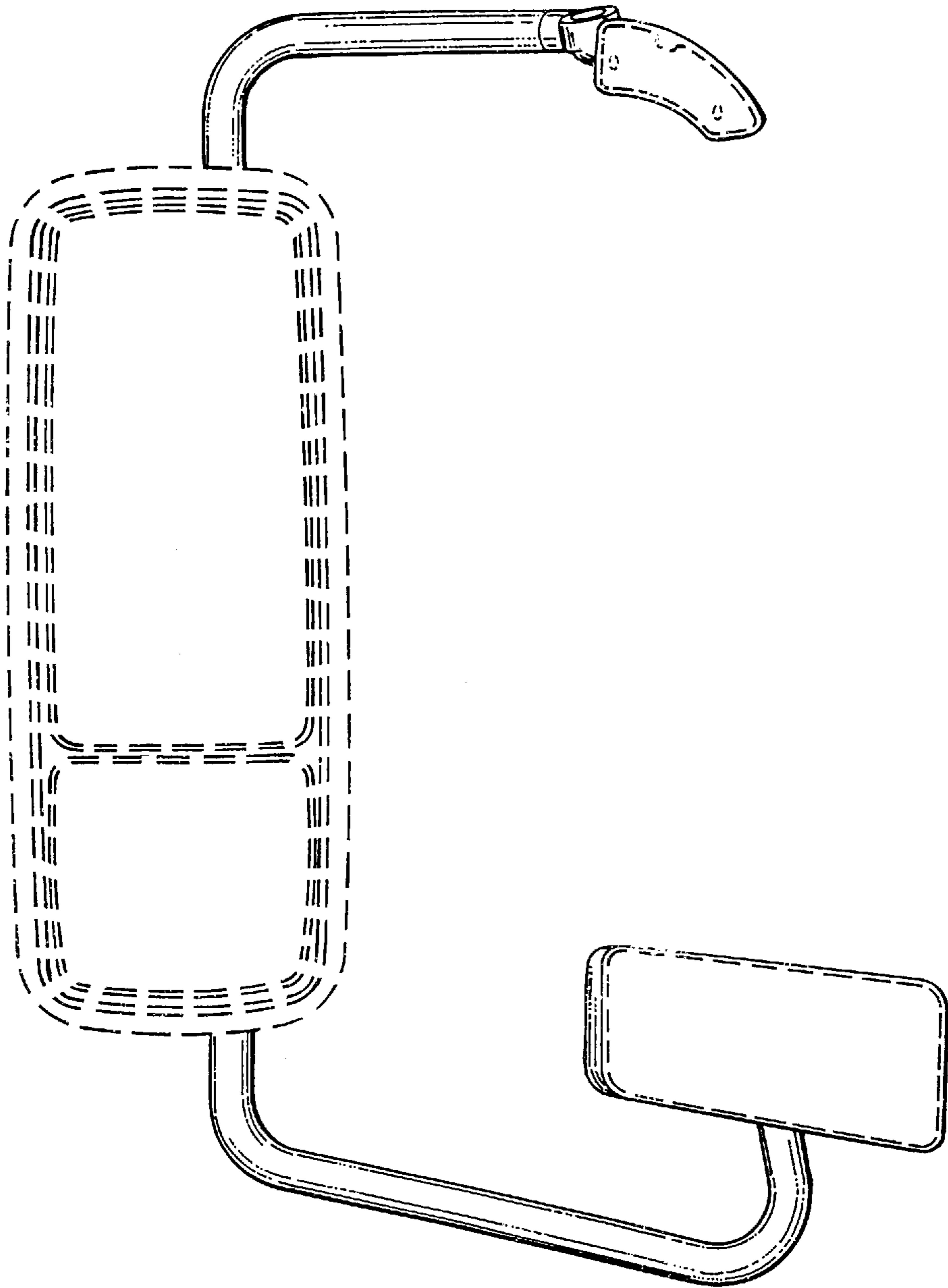

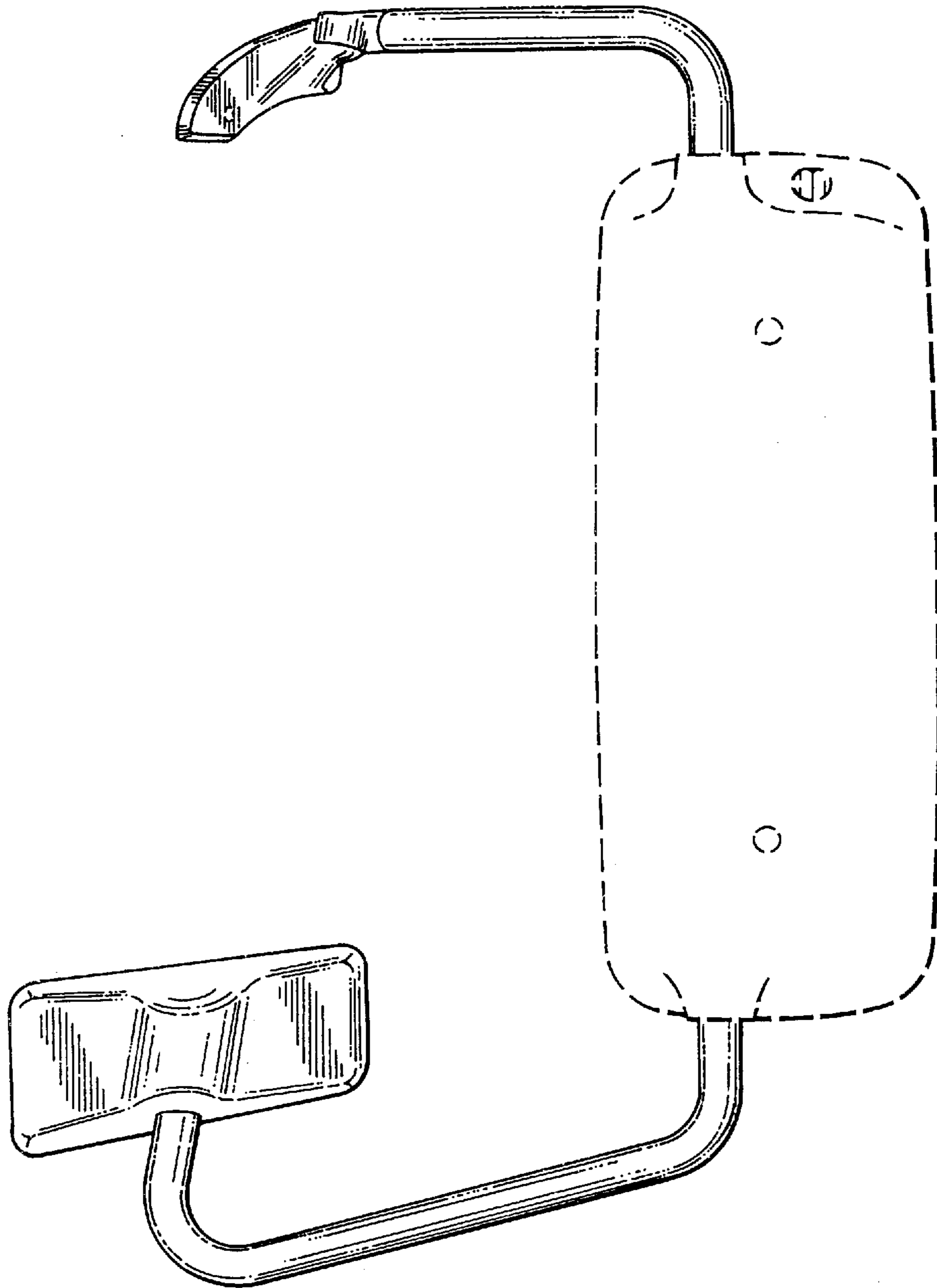

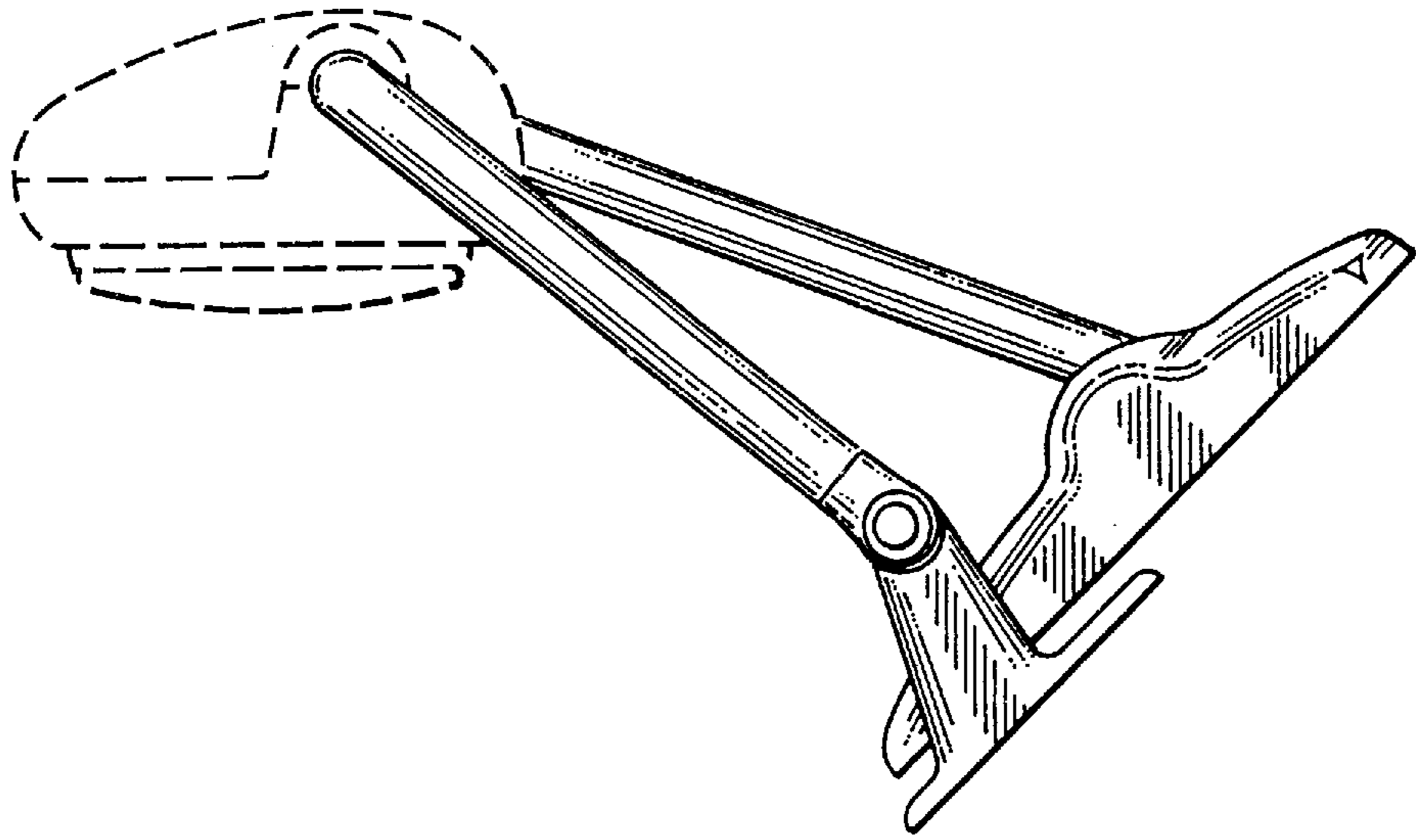

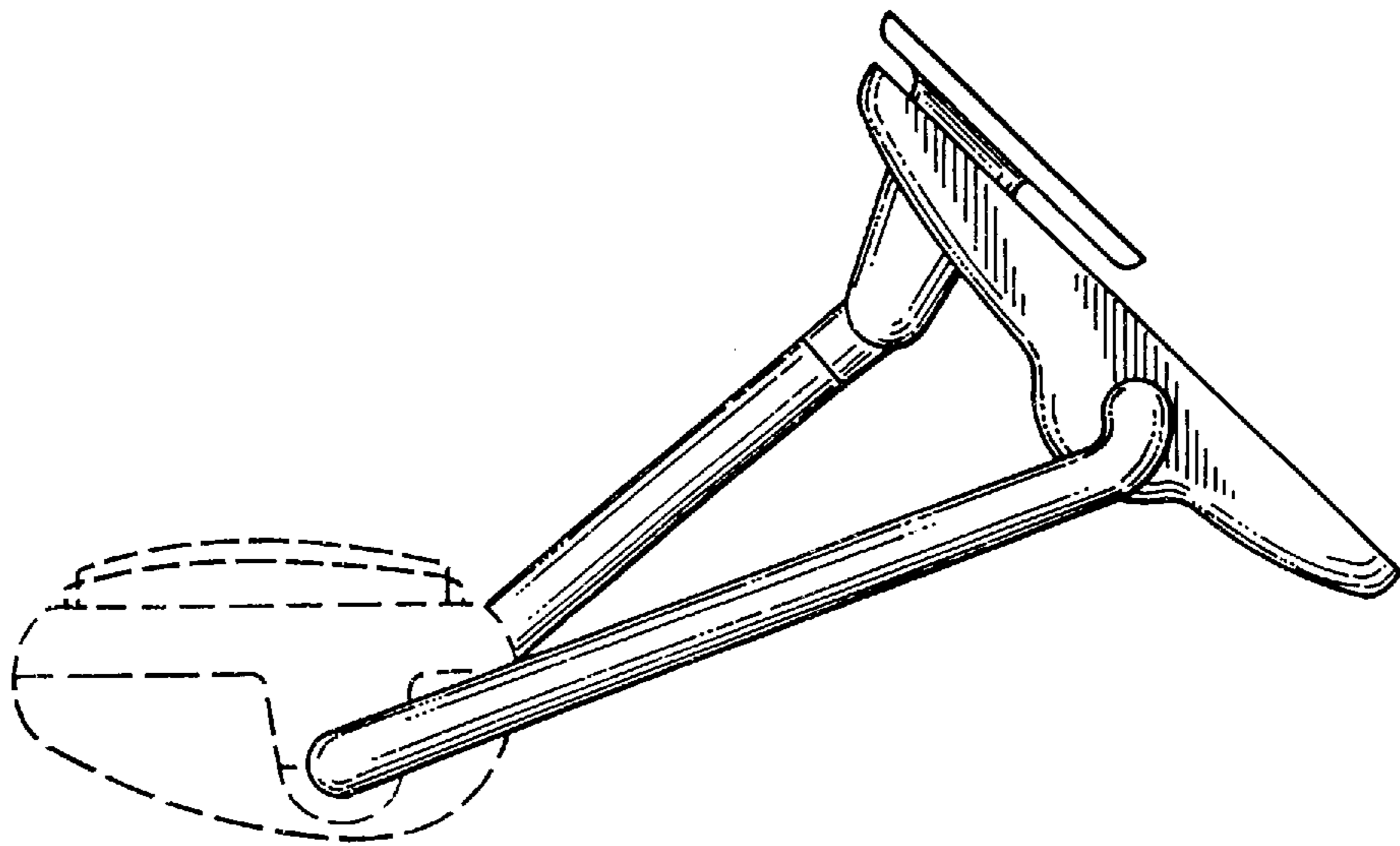

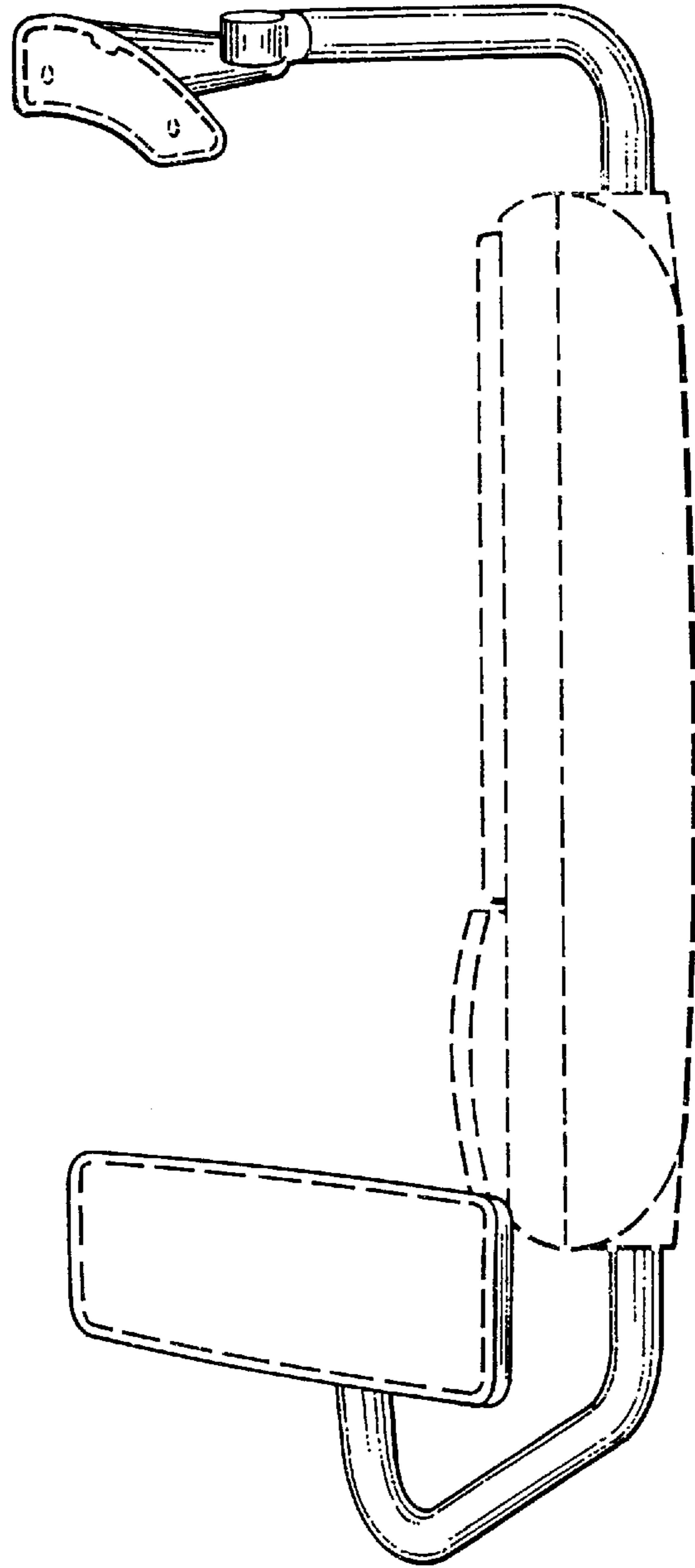

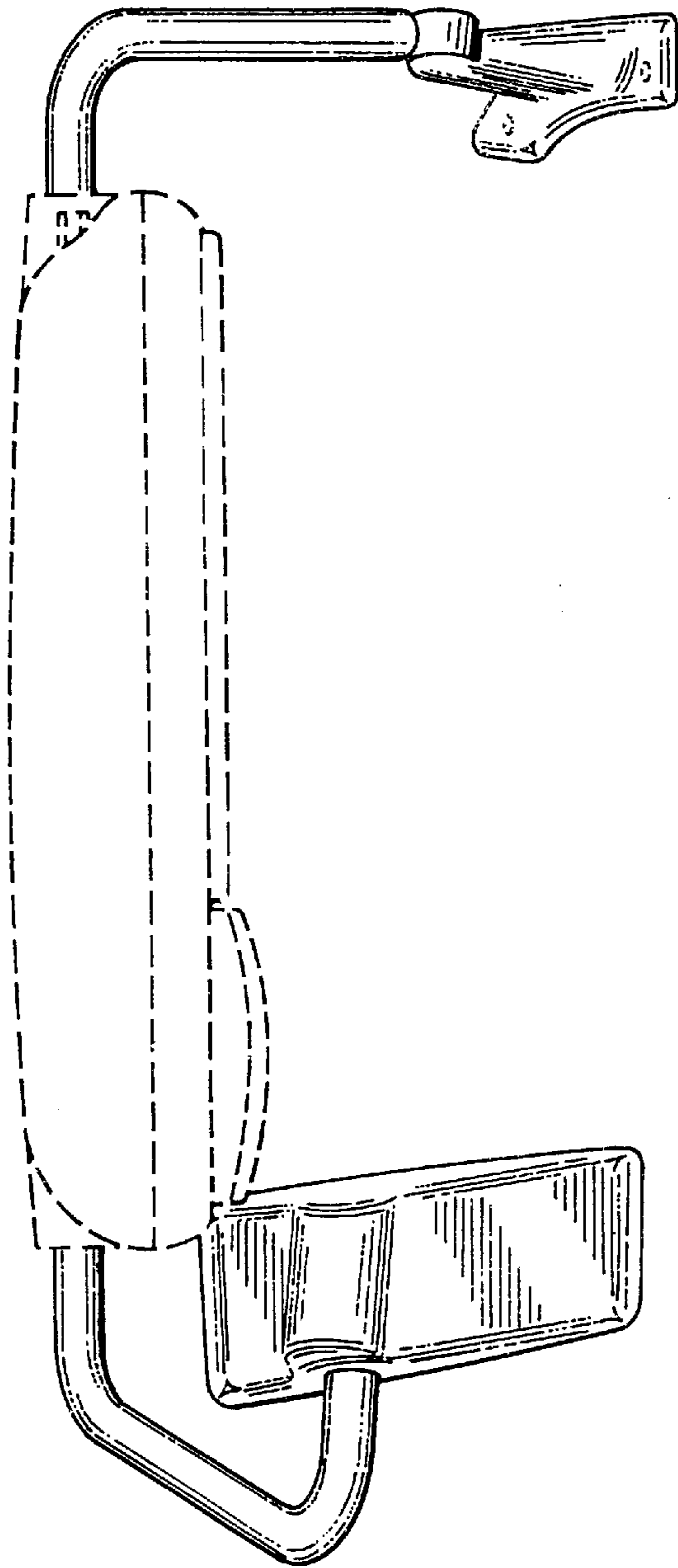

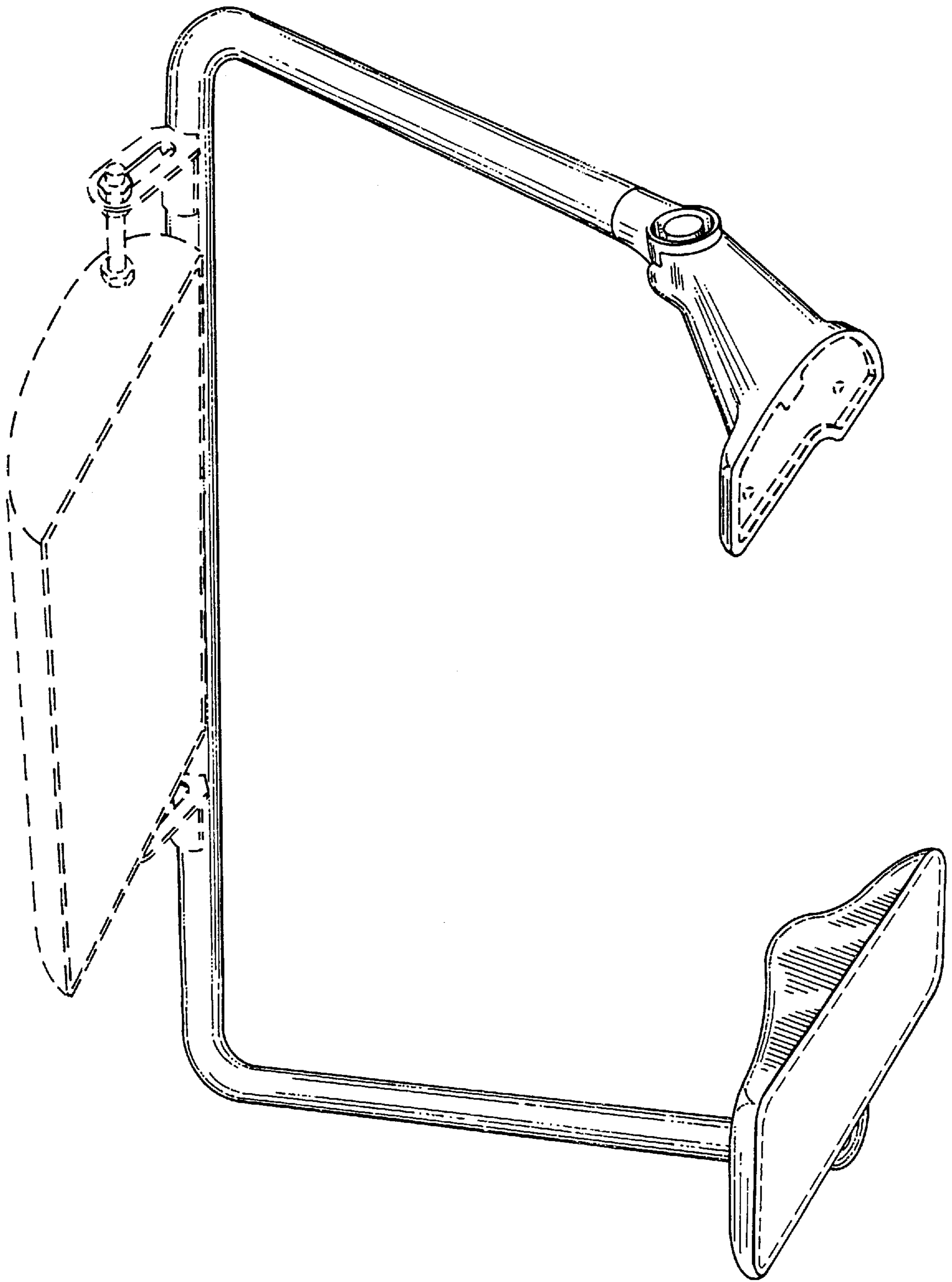

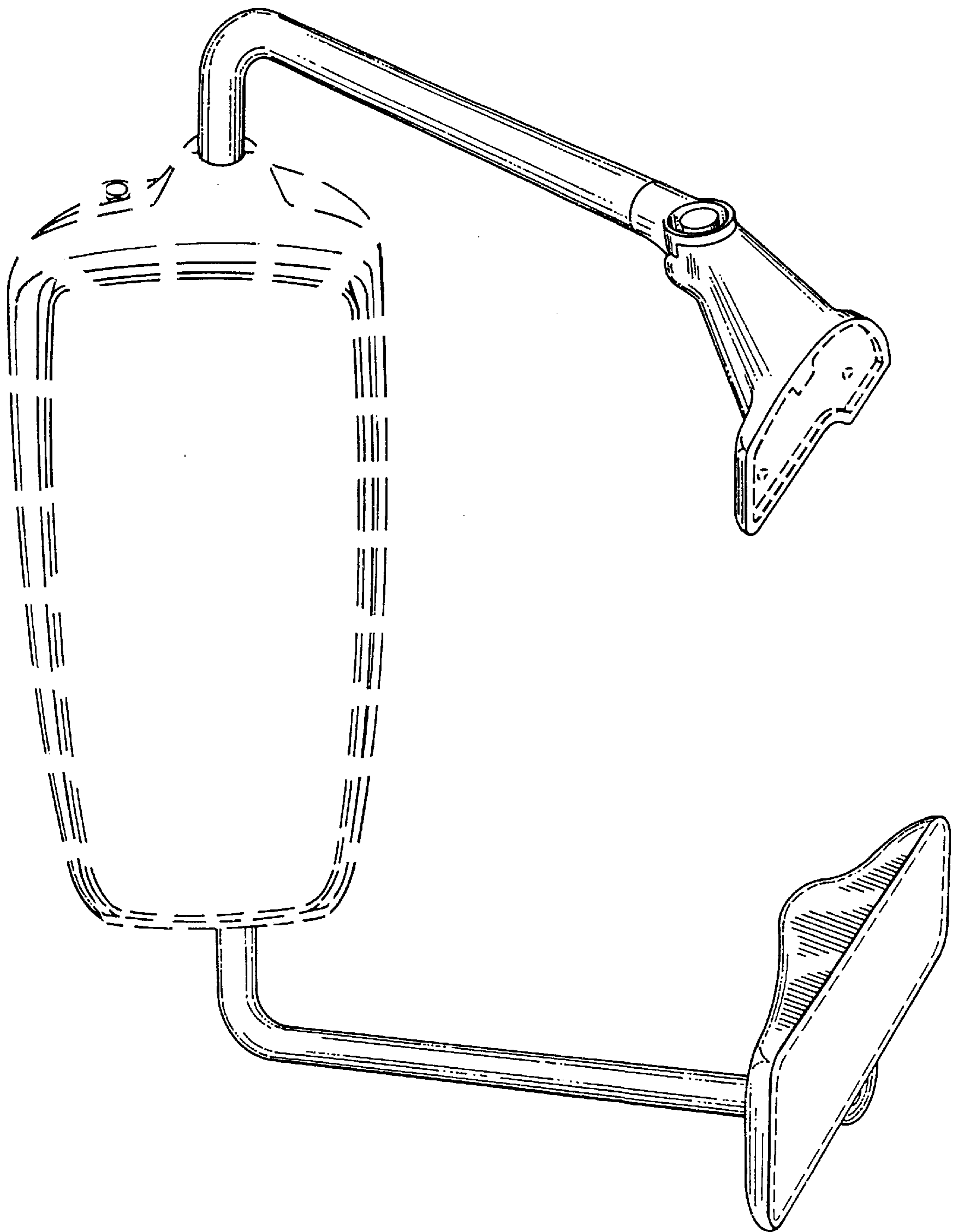

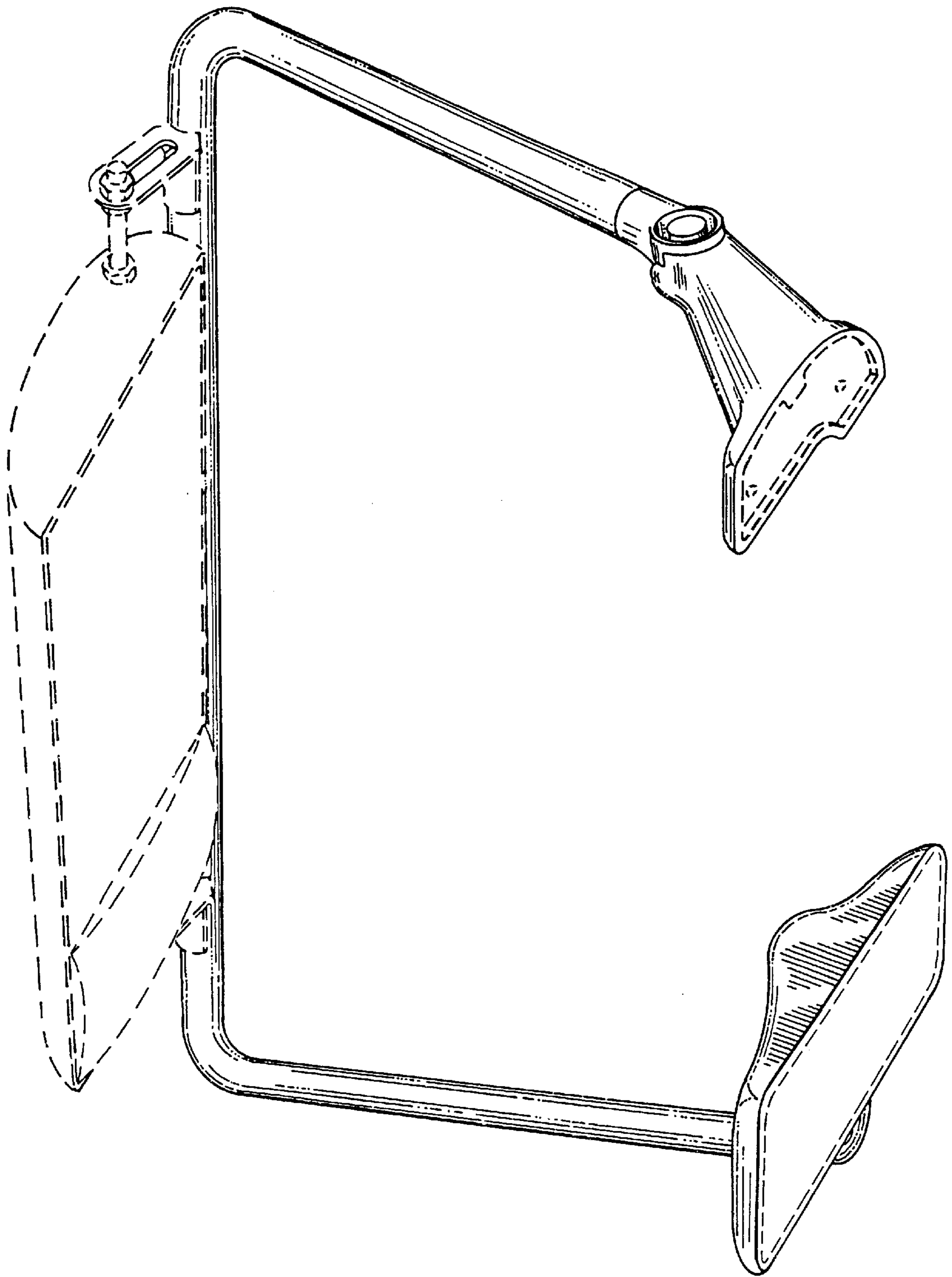

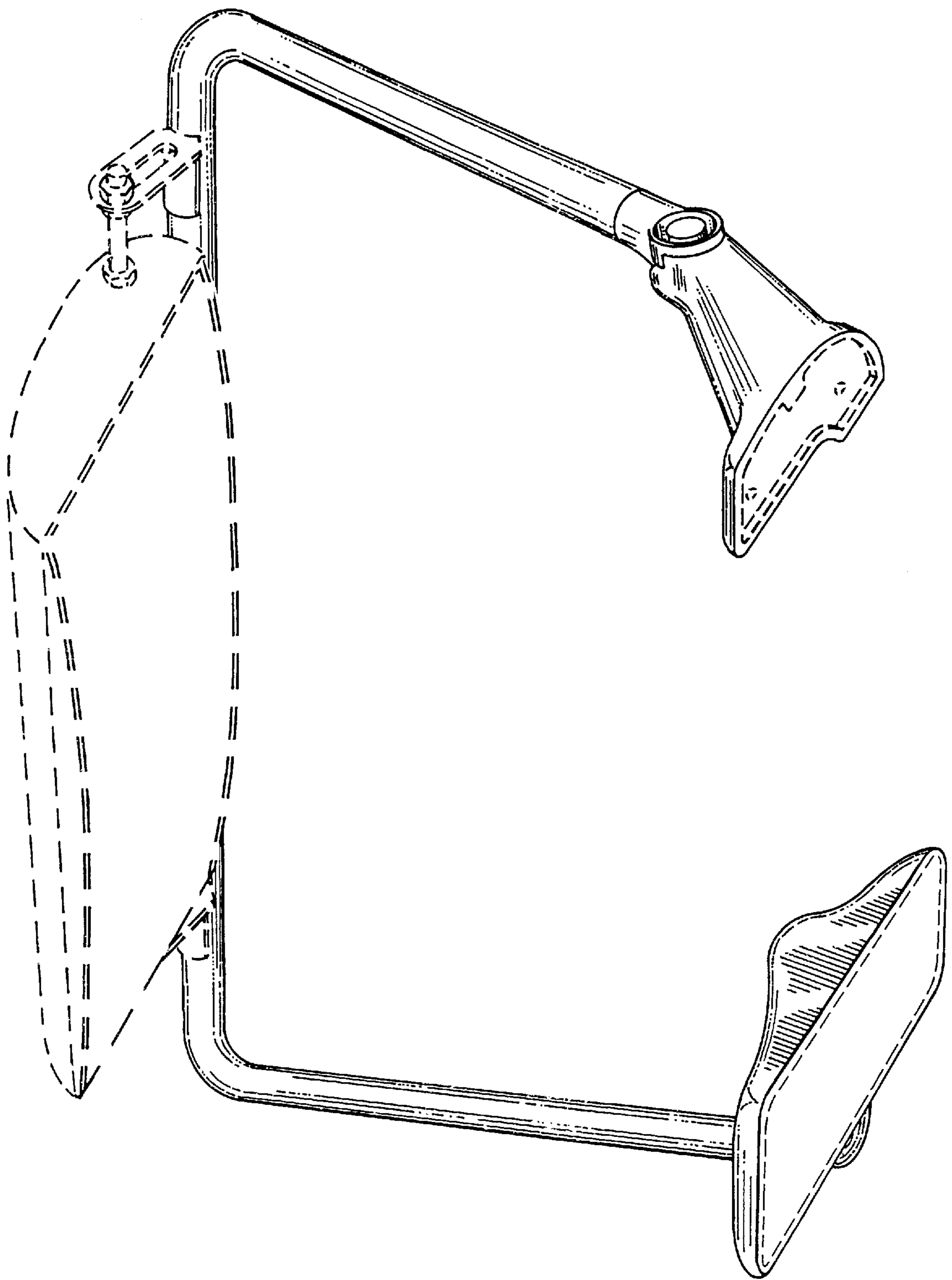

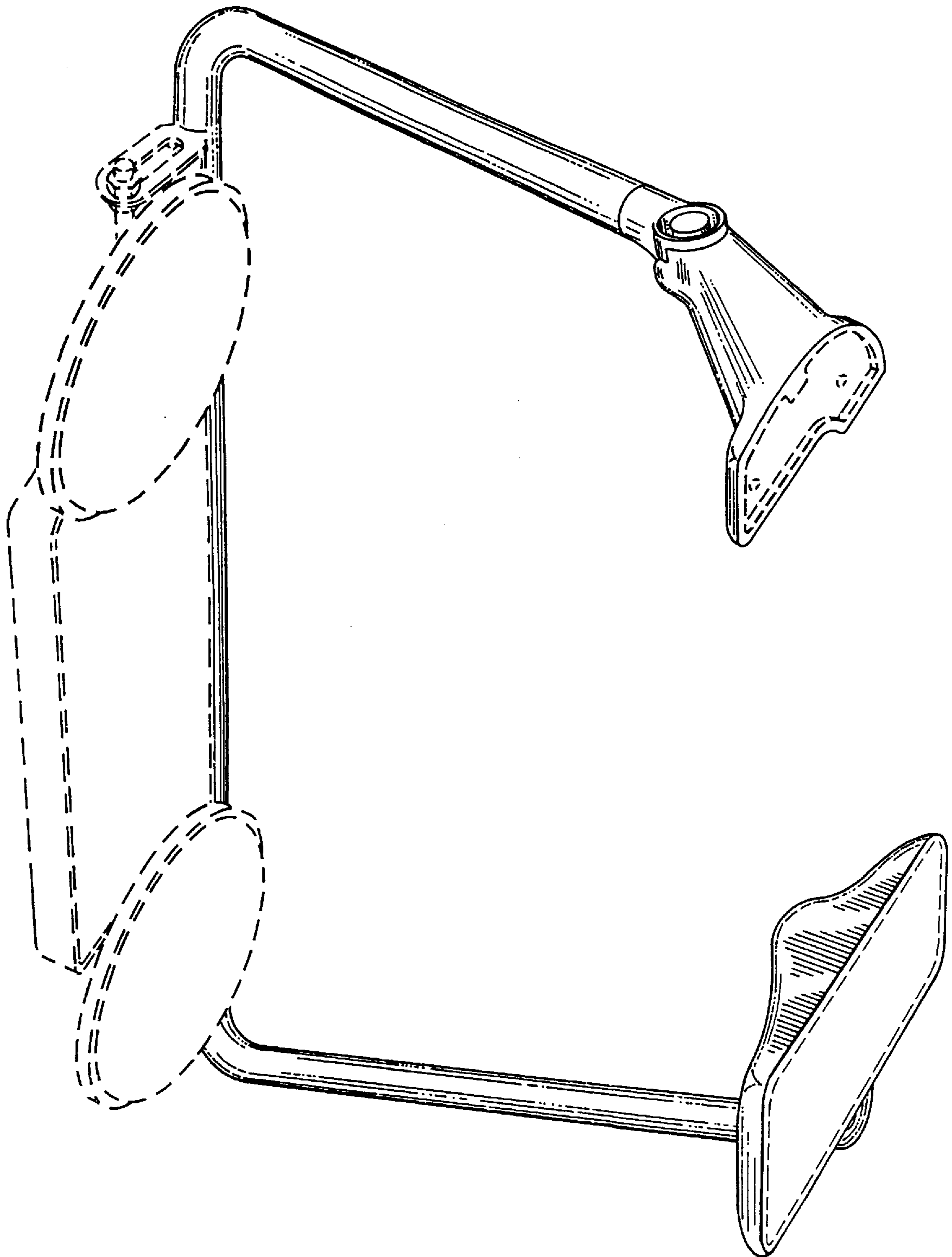

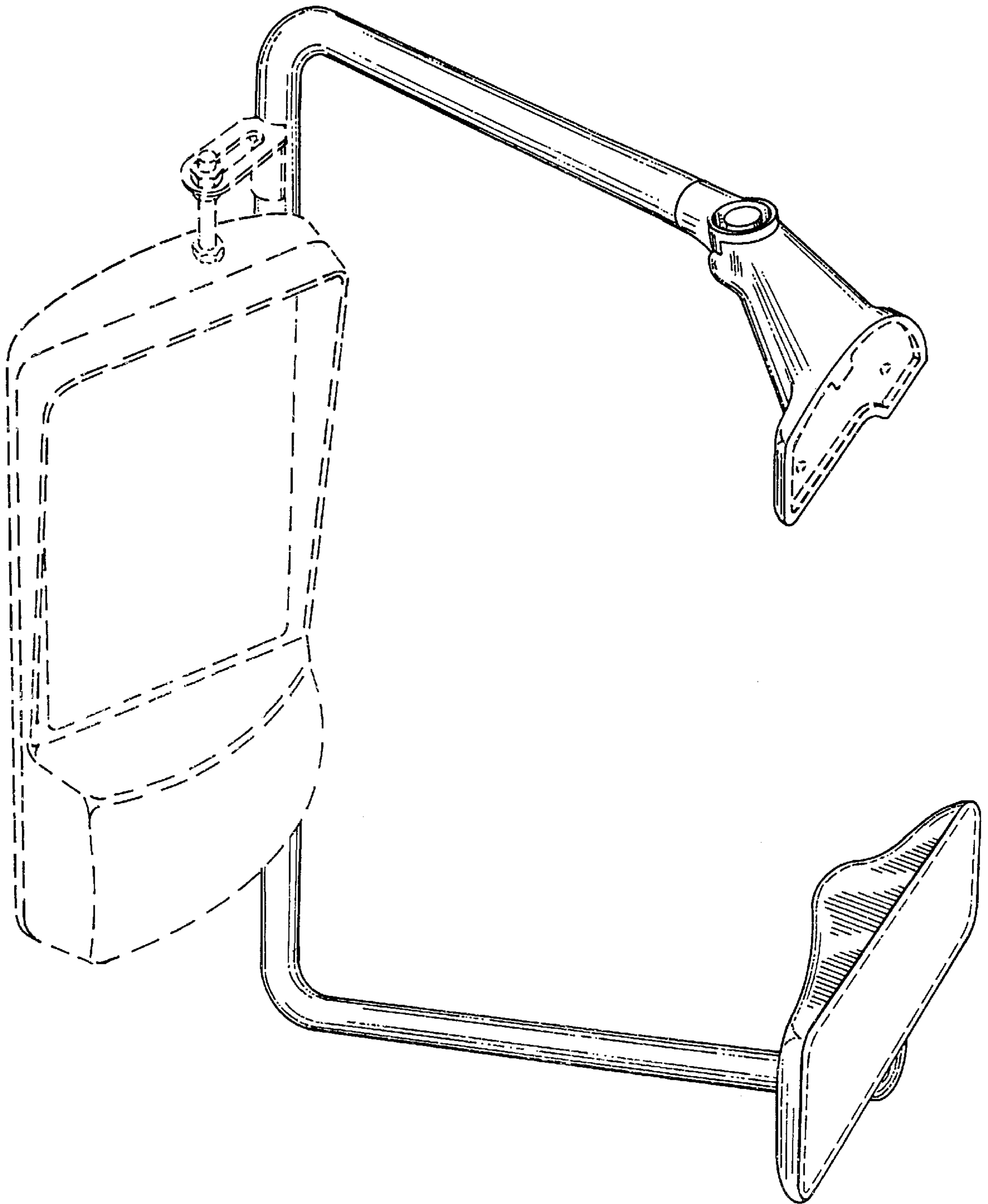
