[57] **CLAIM**

The ornamental design for a wireless telephone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a wireless telephone, which is in use, showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a rear elevational view thereof; FIG. 8 is another perspective view thereof wherein the wireless telephone is not in the extended position for use; FIG. 9 is a perspective view of a second embodiment of a wireless telephone showing my new design; FIG. 10 is a top plan view thereof; FIG. 11 is a left side elevational view thereof; FIG. 12 is a front elevational view thereof; FIG. 13 is a bottom plan view thereof; FIG. 14 is a right side elevational view thereof; FIG. 15 is a rear elevational view thereof; FIG. 16 is another perspective view thereof wherein the wireless telephone is not in the extended position for use; and, FIG. 17 is a front elevational view thereof wherein the keypad is shown with broken lines for illustrative purposes only, forming no part of the claimed design.

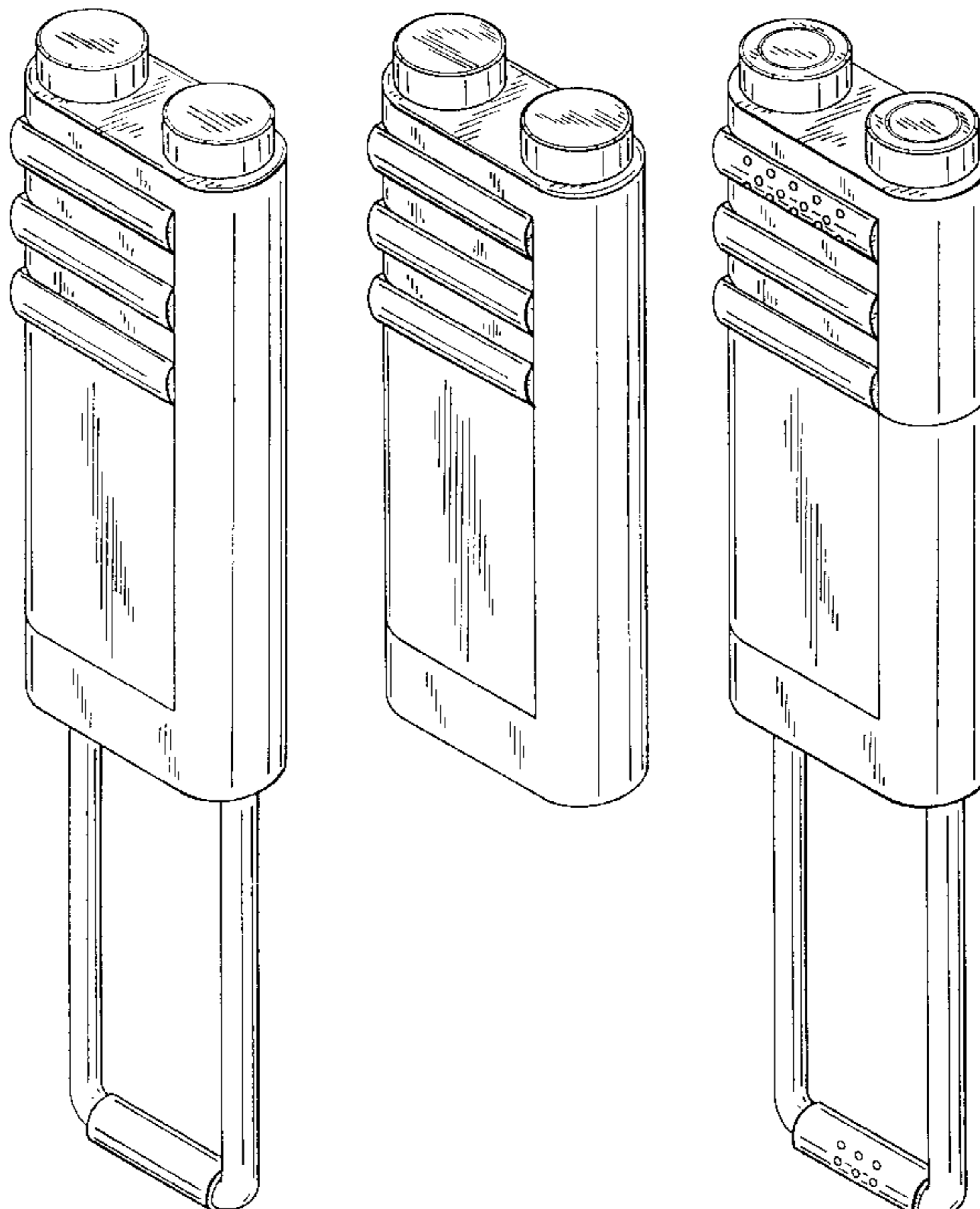

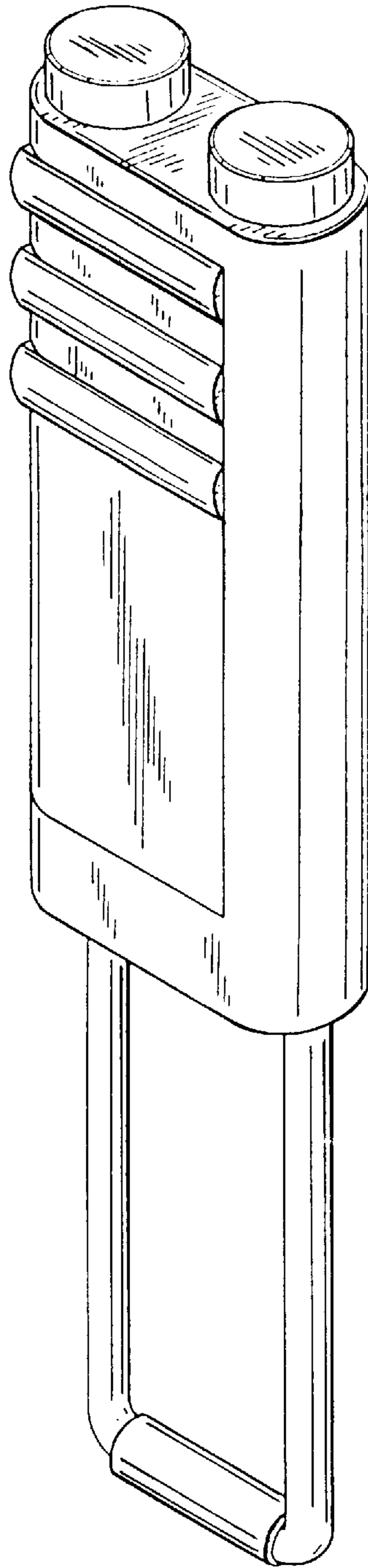

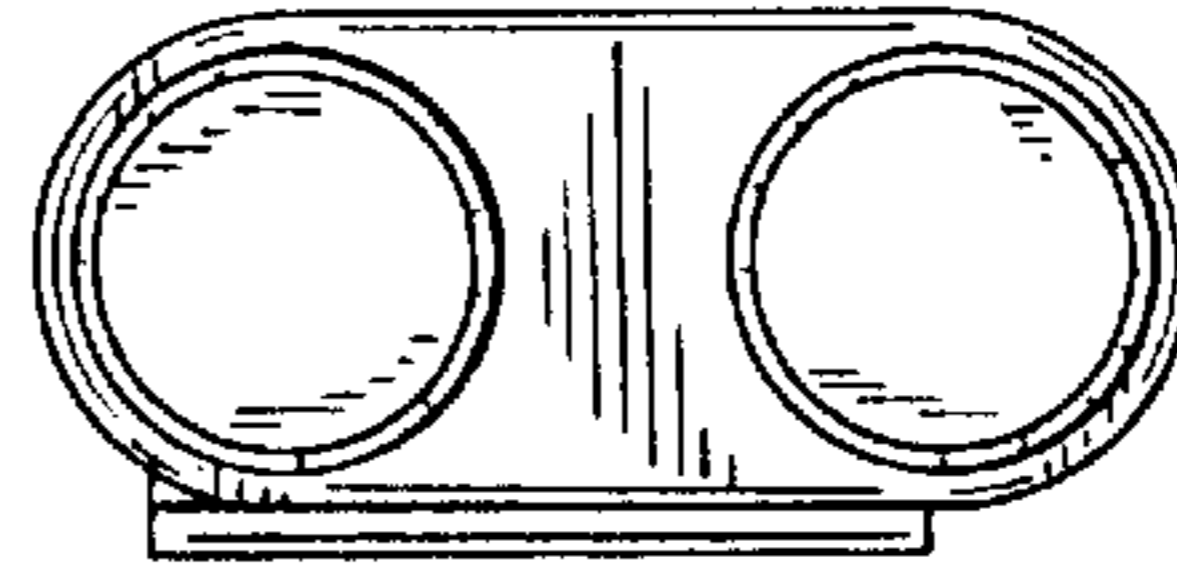

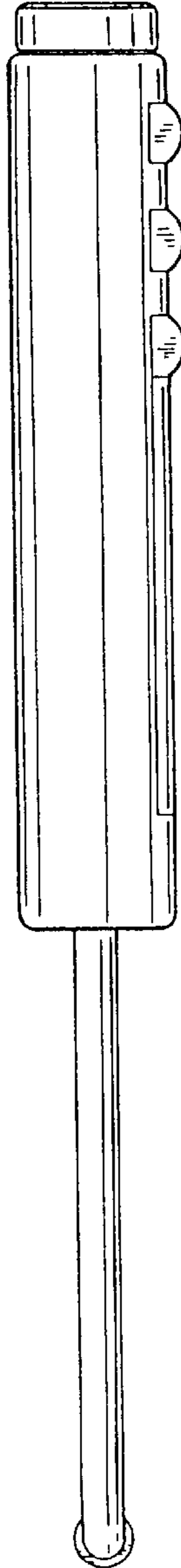

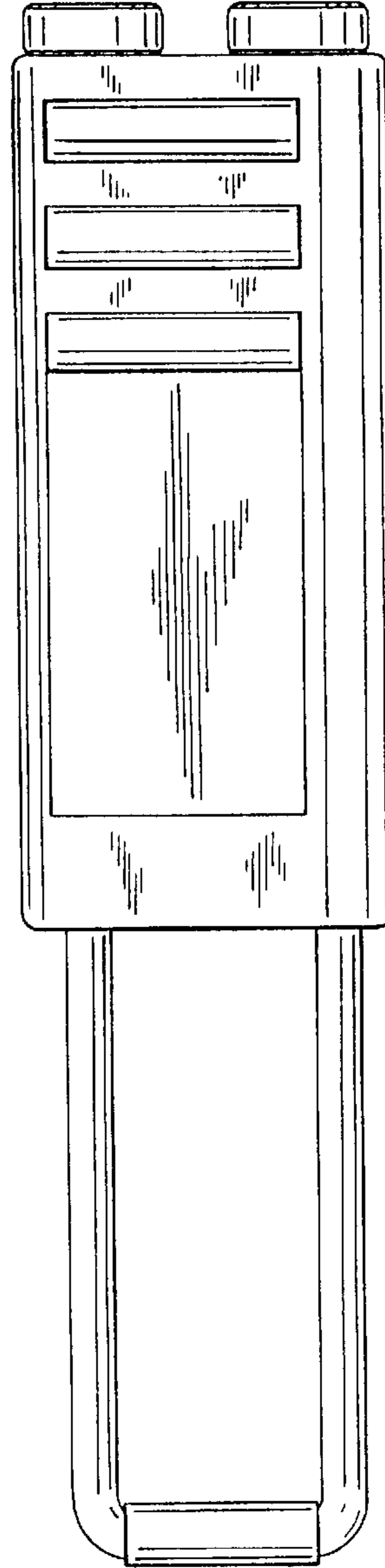

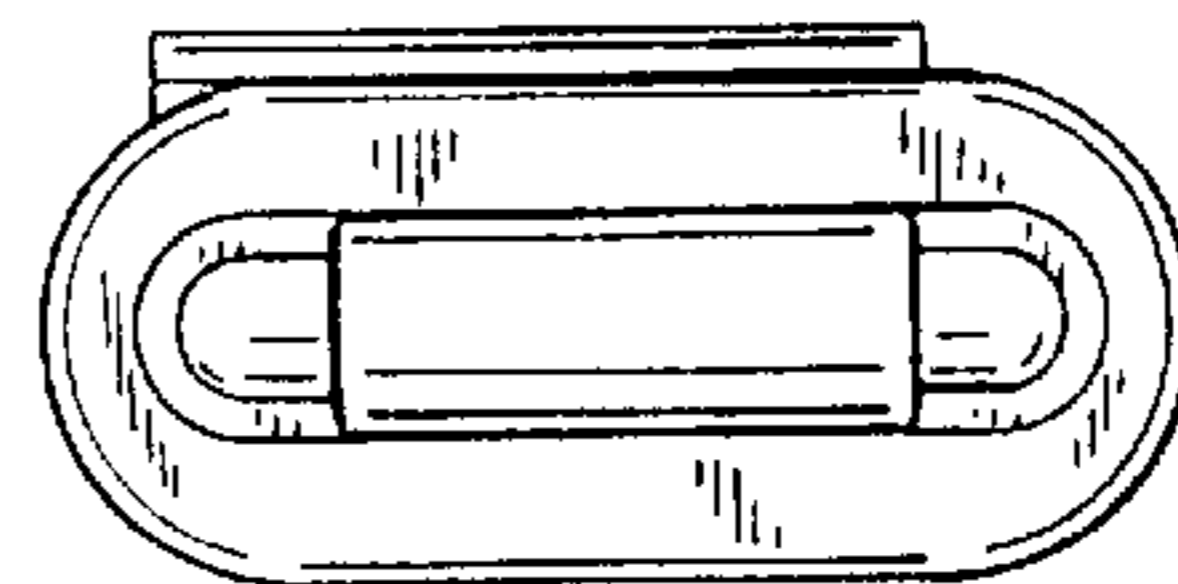

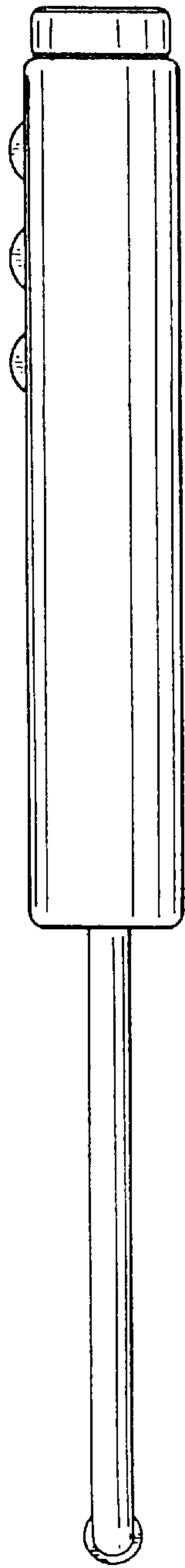

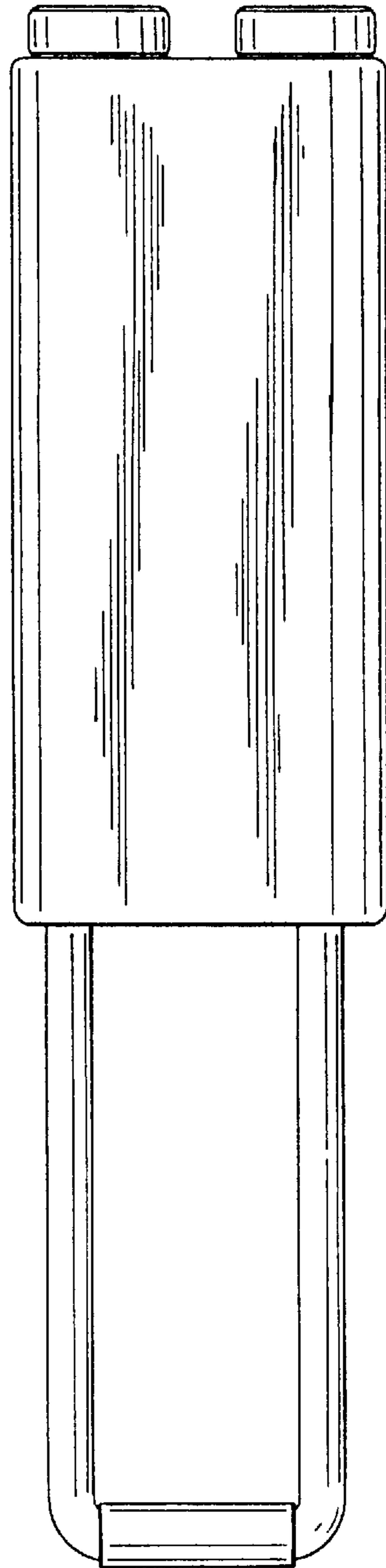

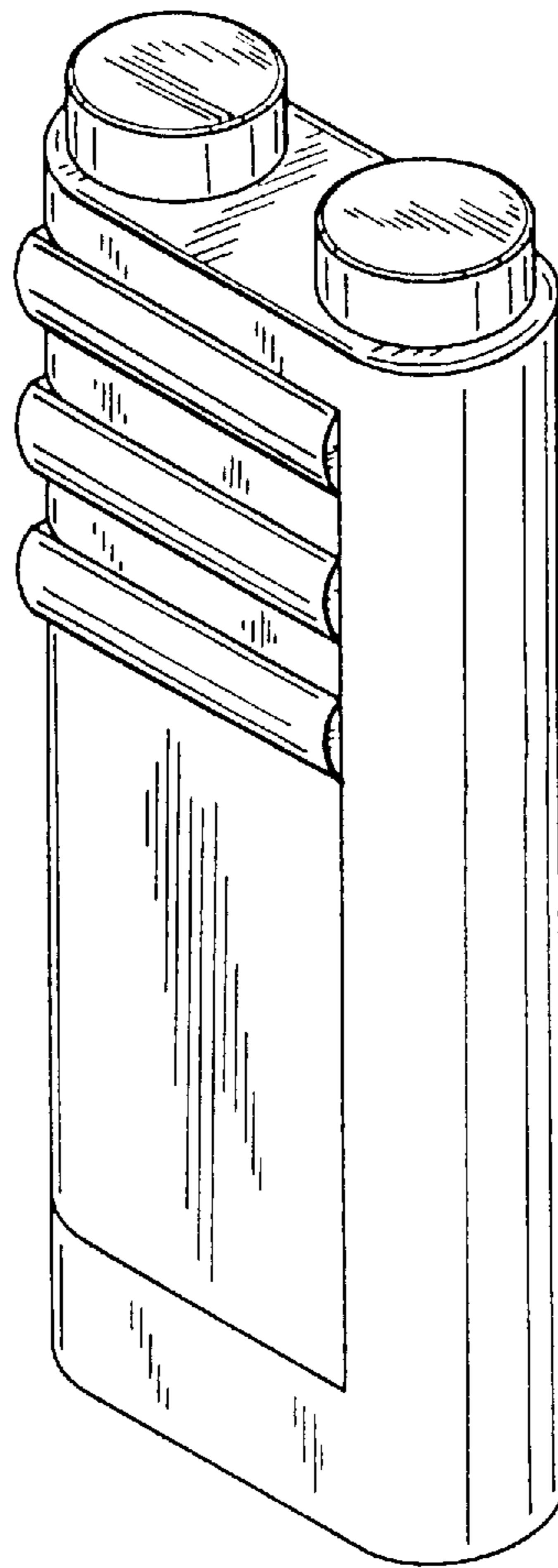

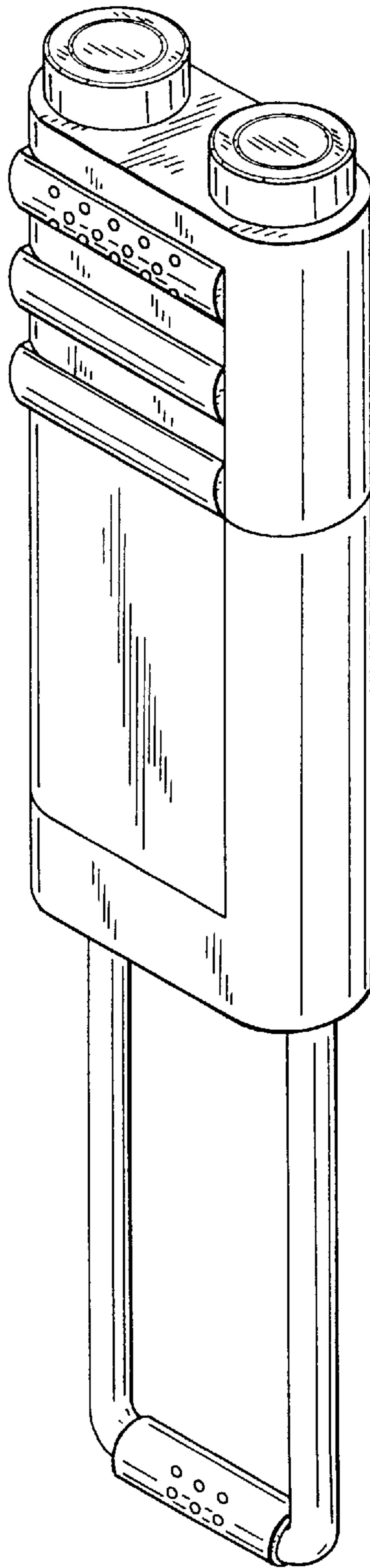

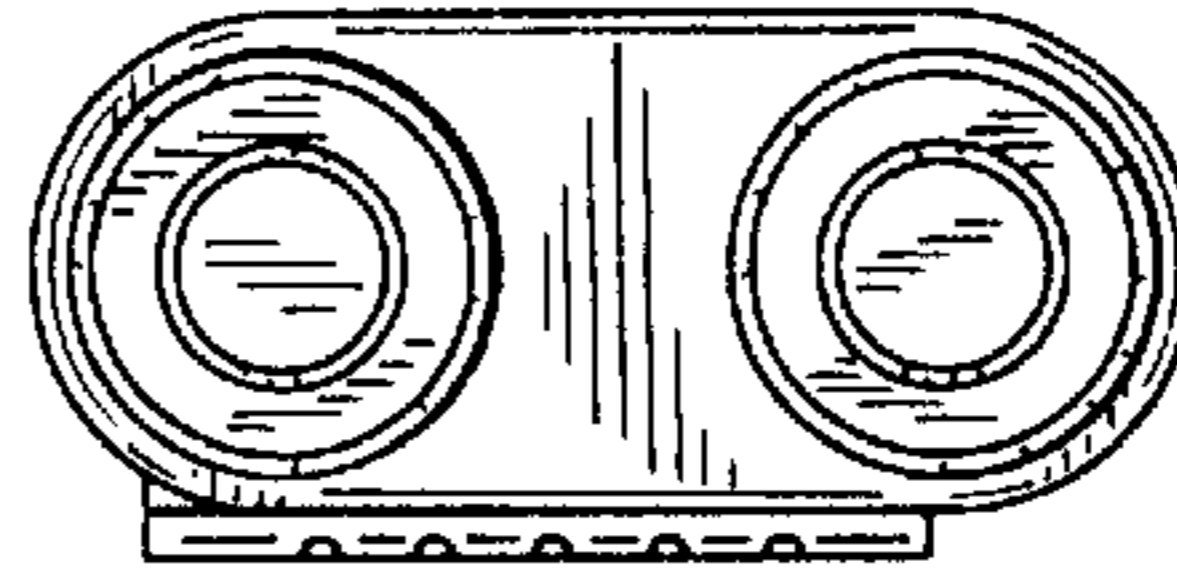

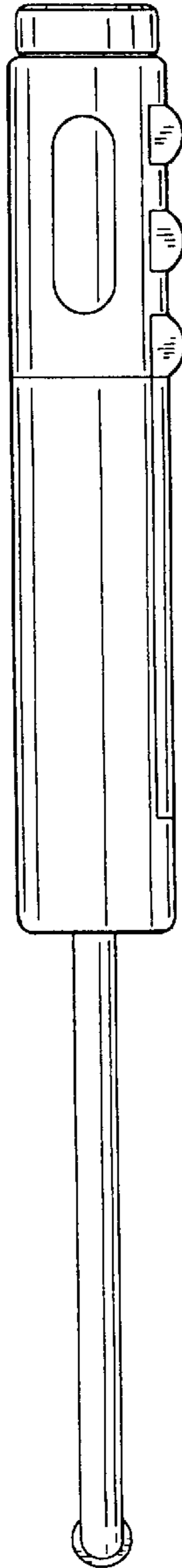

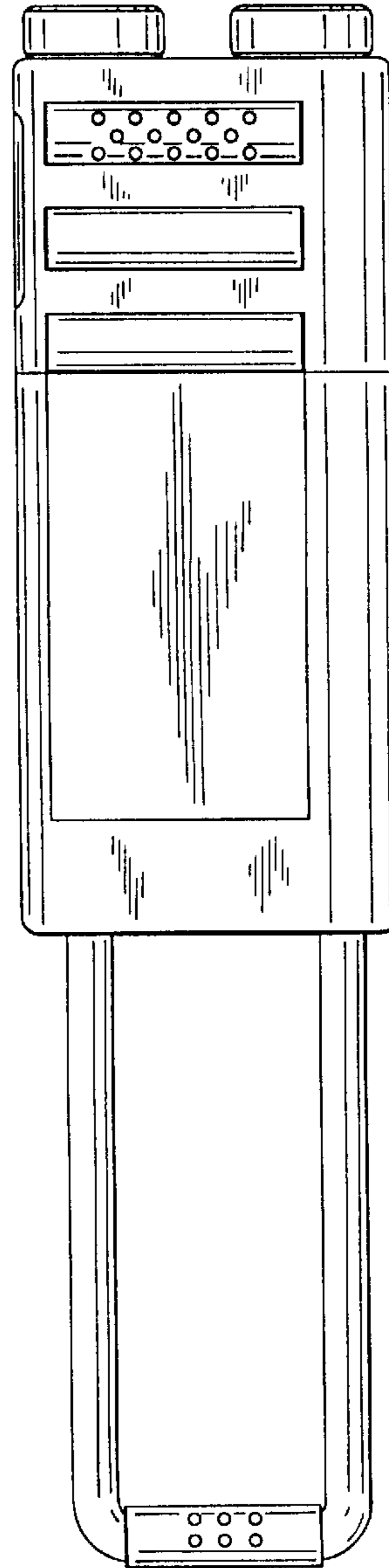

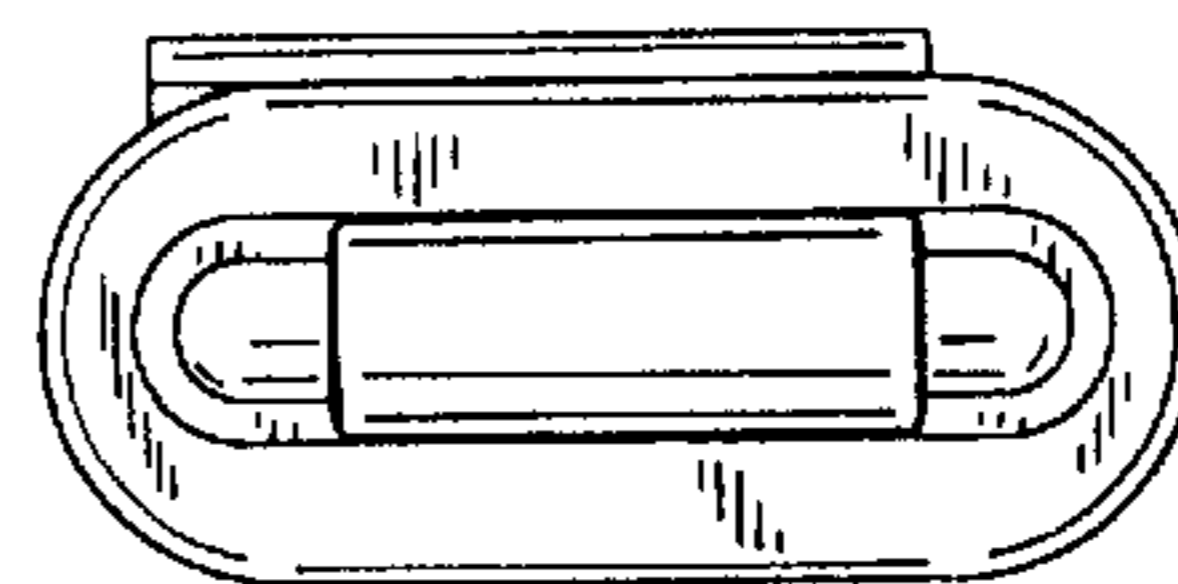

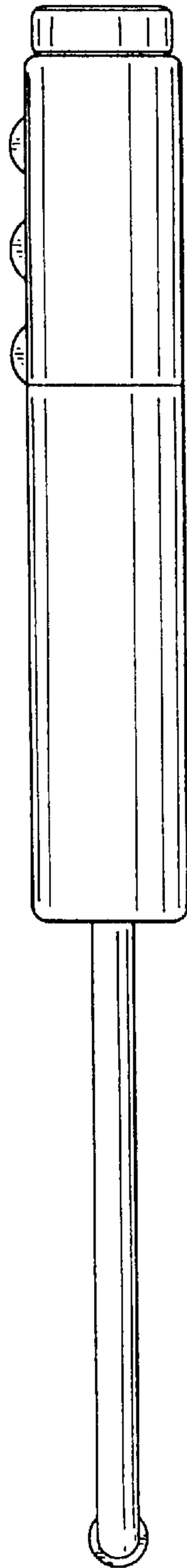

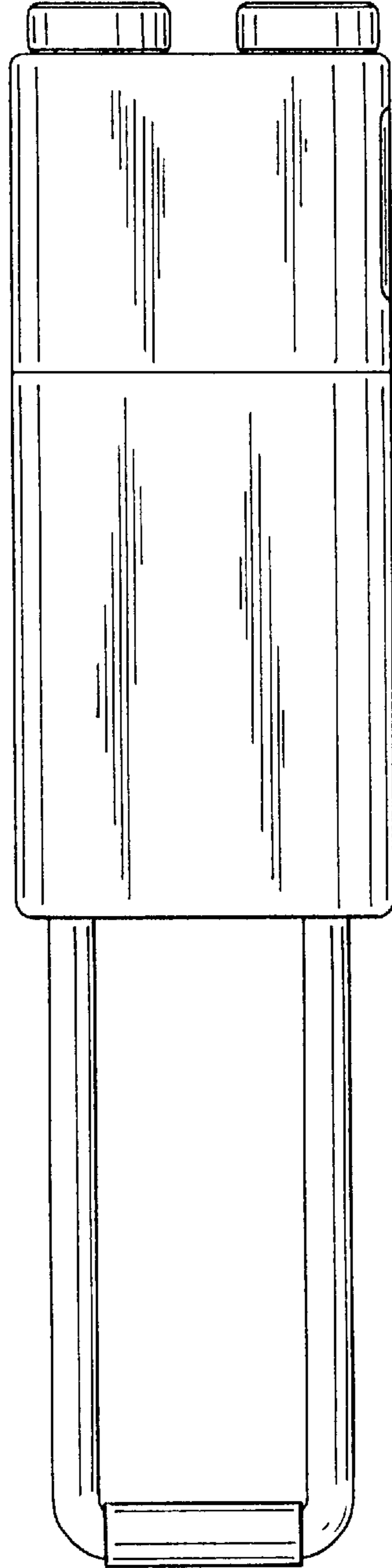

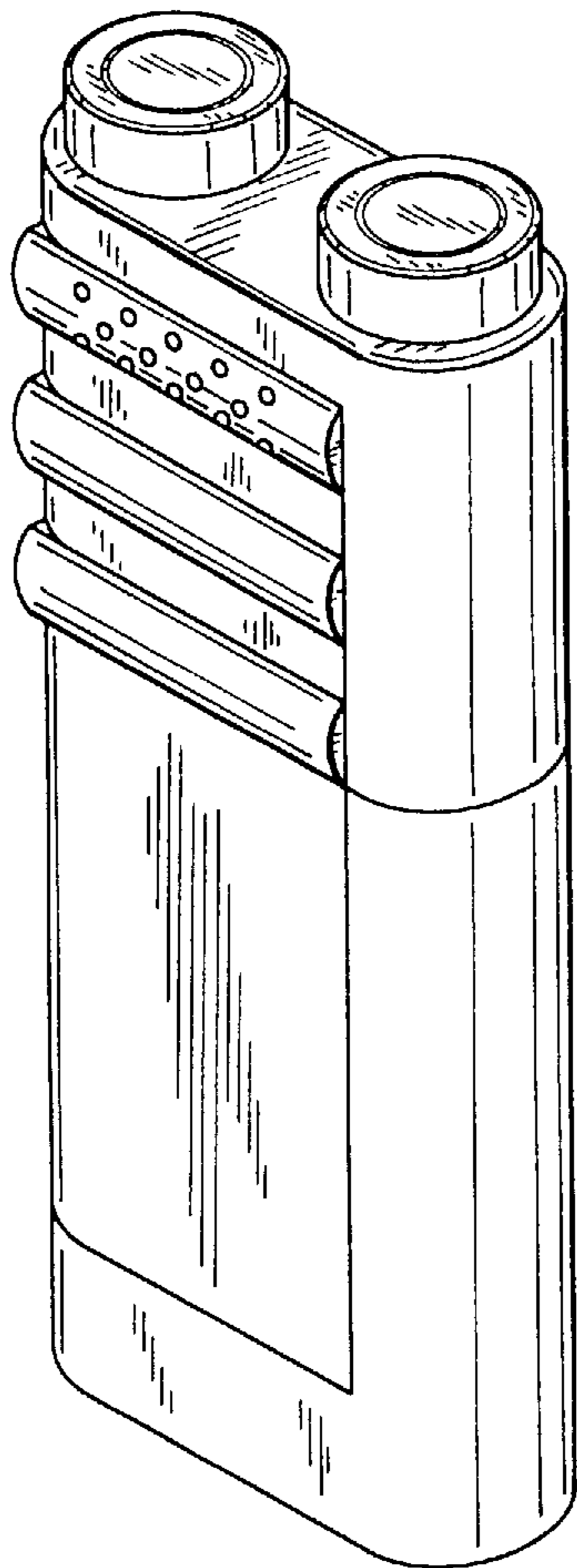
