The ornamental design for a “front cover for a telephone handset,” as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a front cover for a telephone handset with the cover closed showing our new design;

FIG. 12 is a left side elevational view thereof;

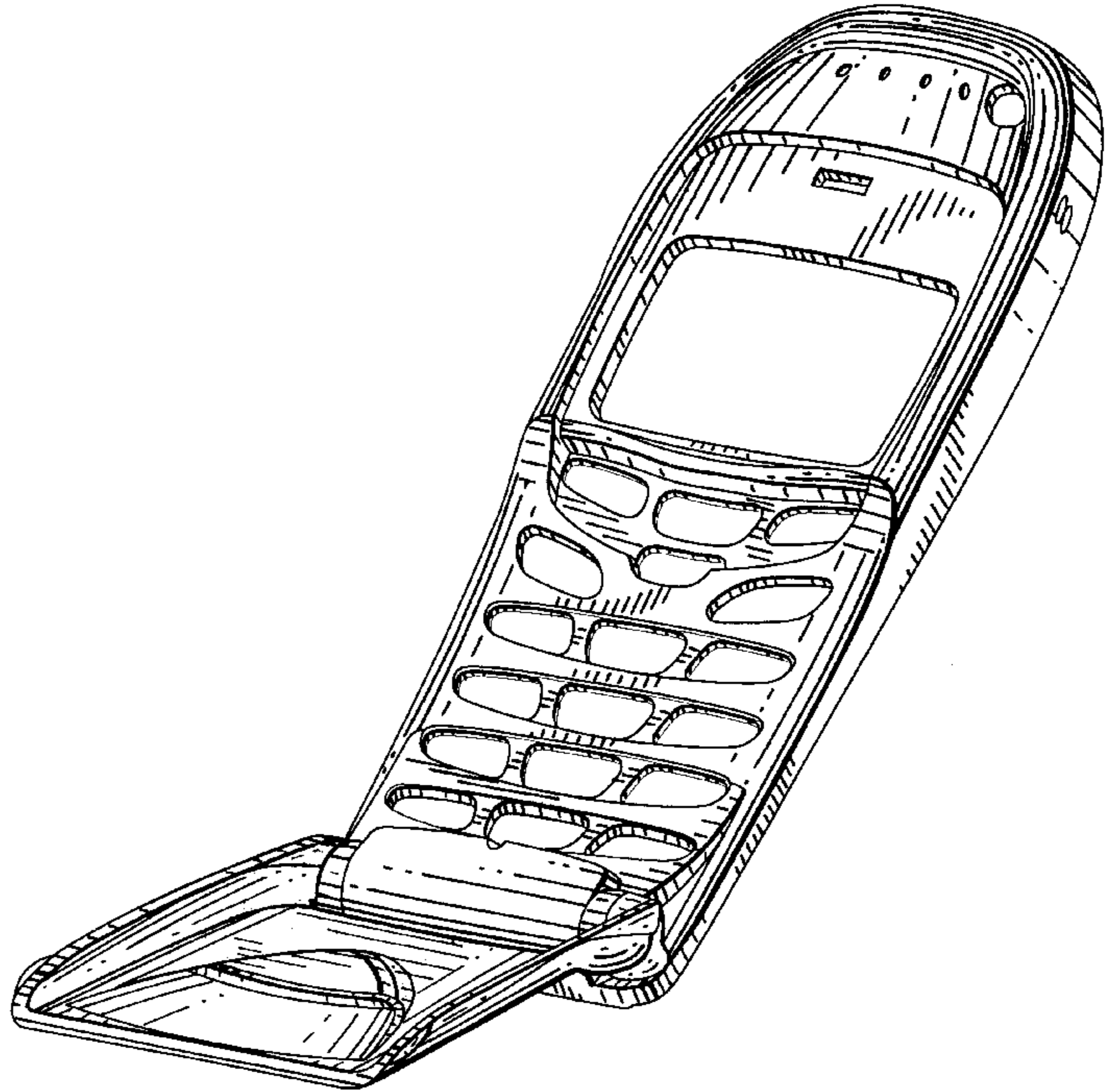
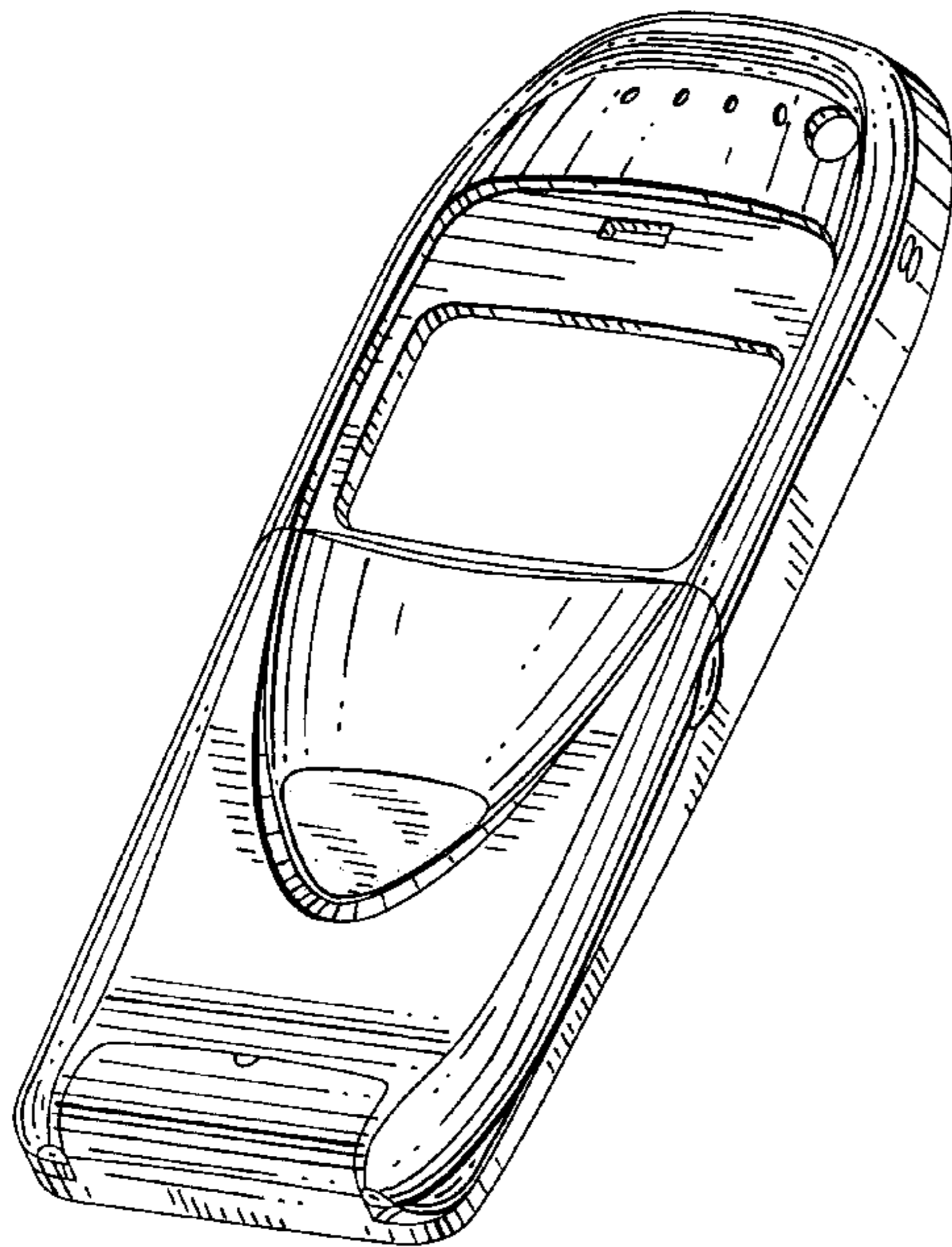
FIG. 13 is a rear elevational view thereof;

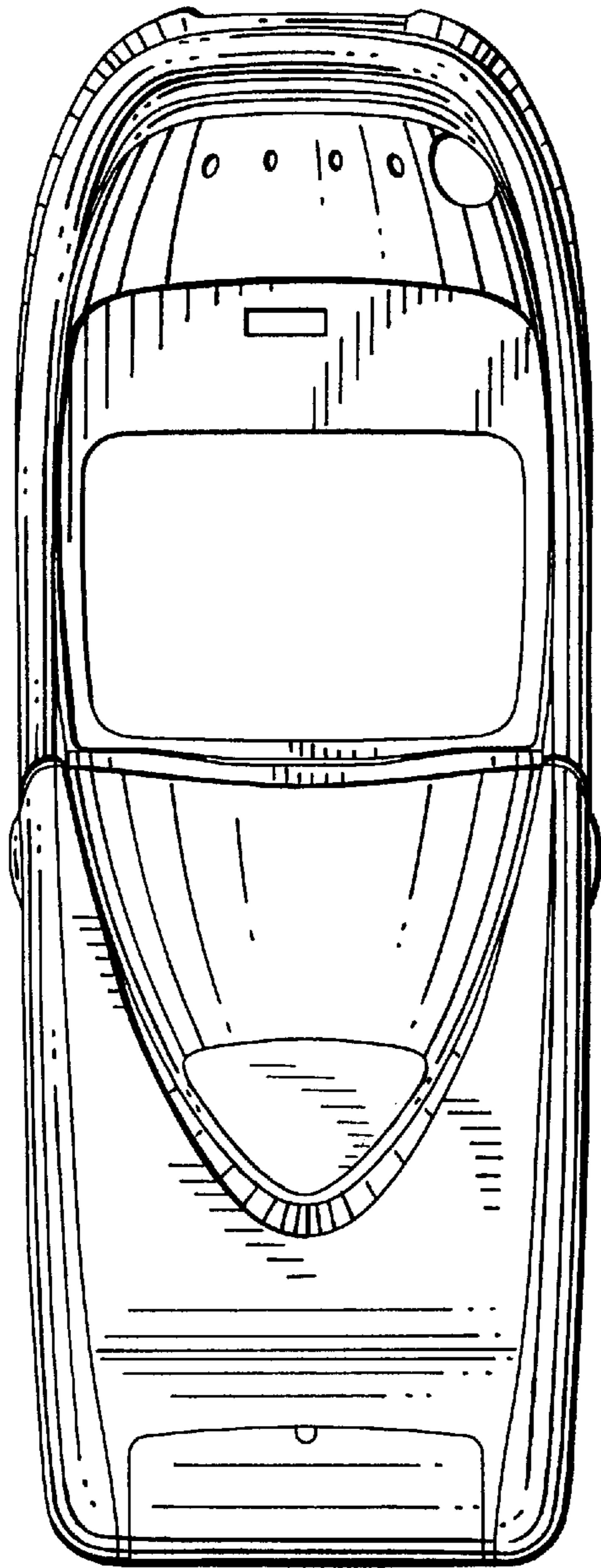

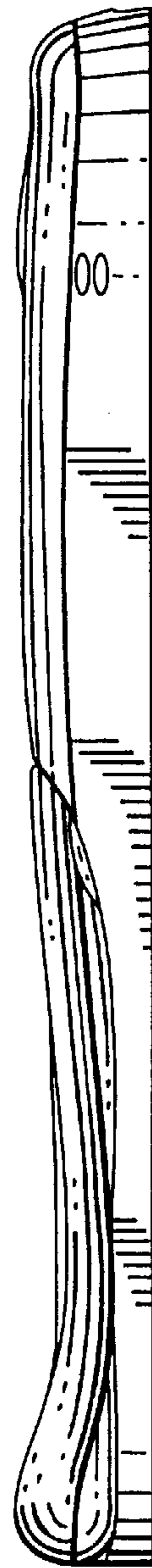

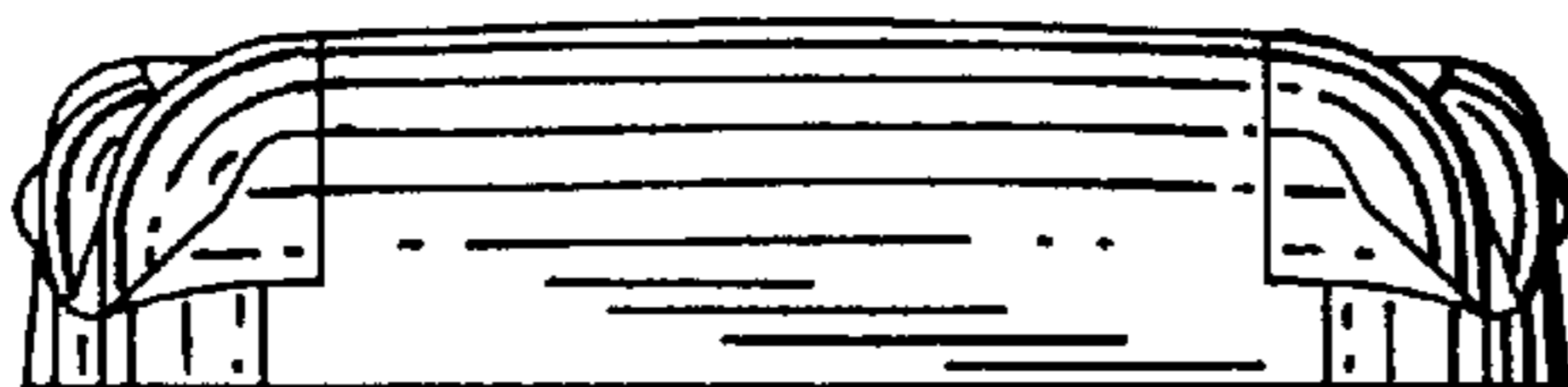

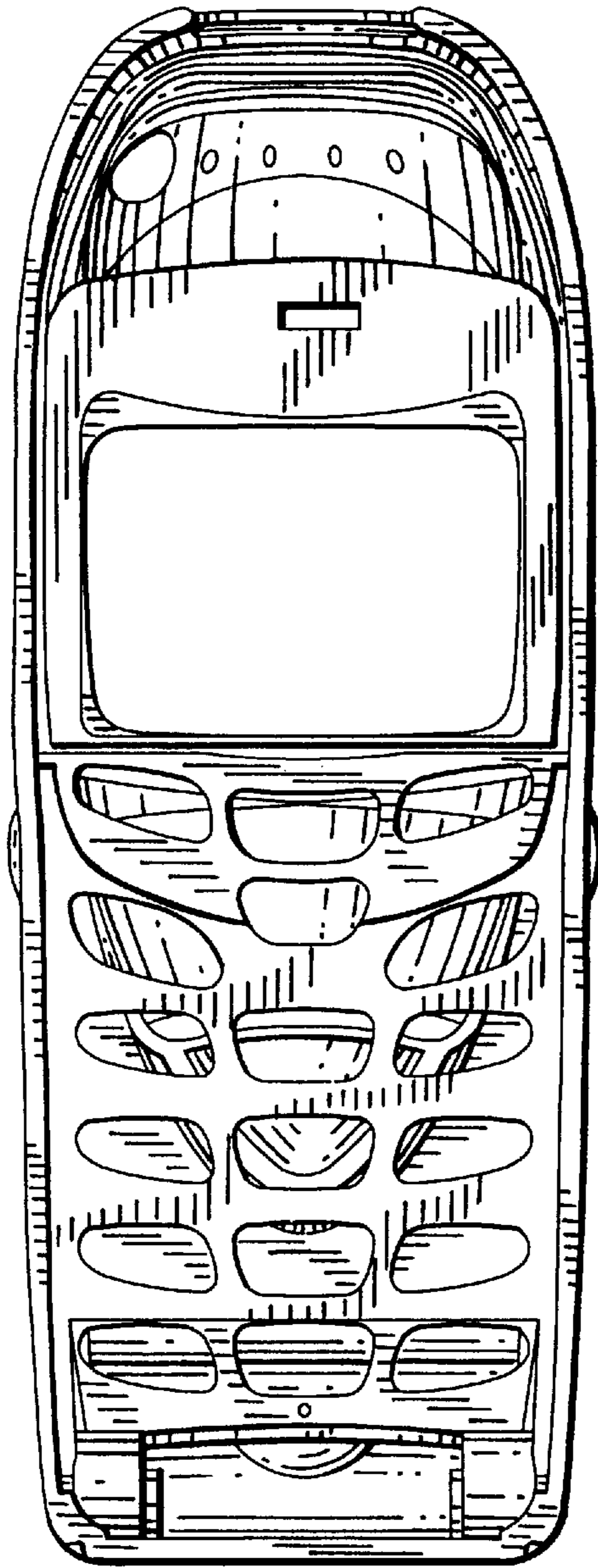

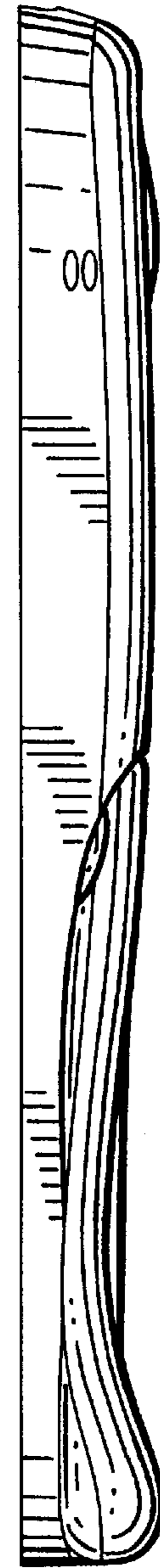

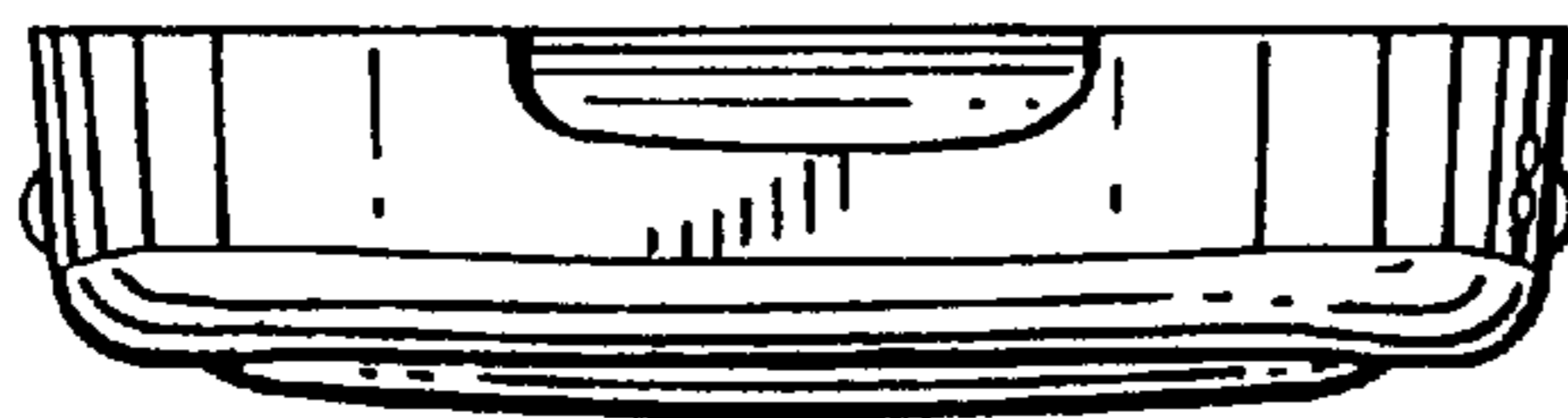

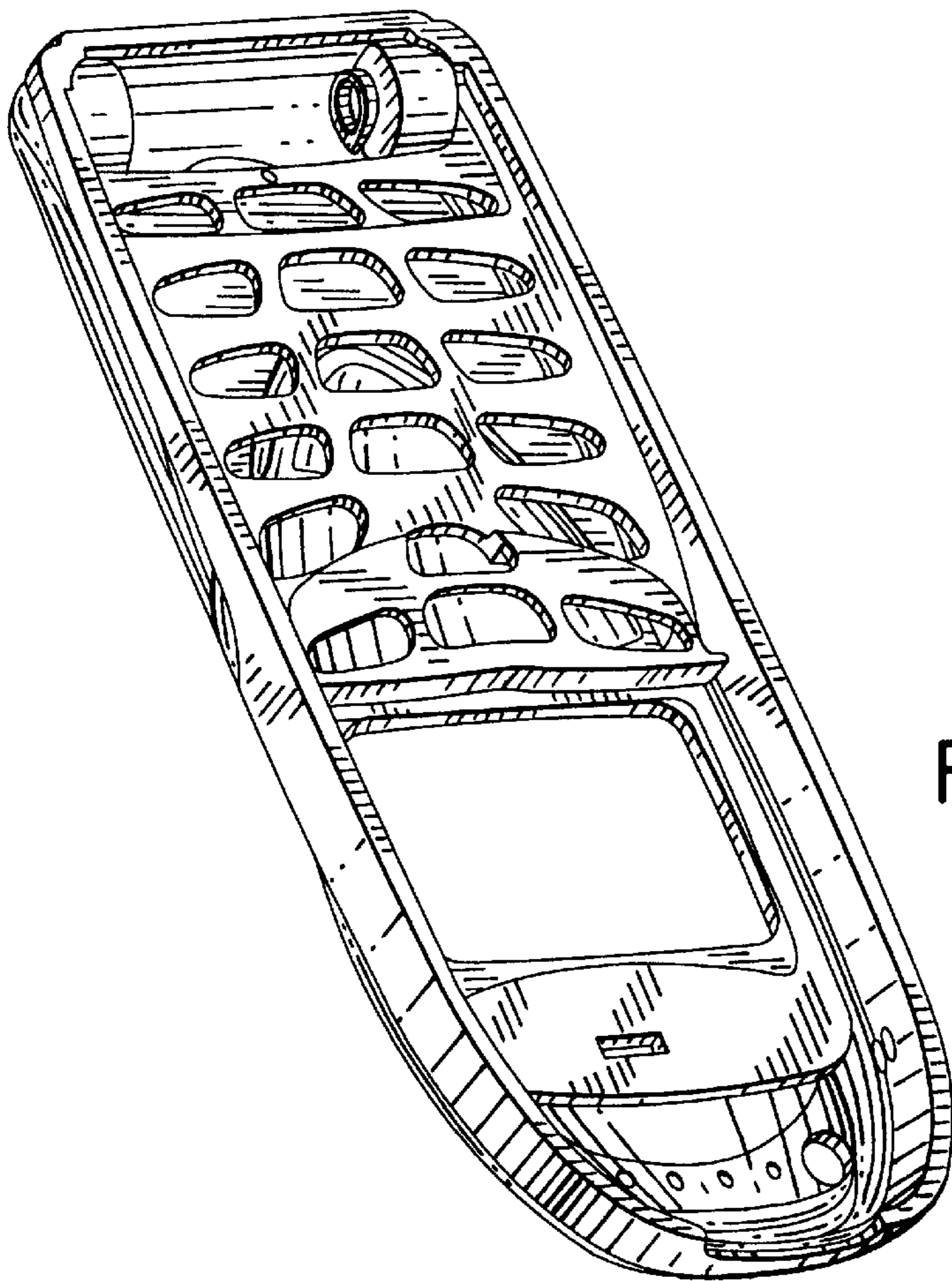

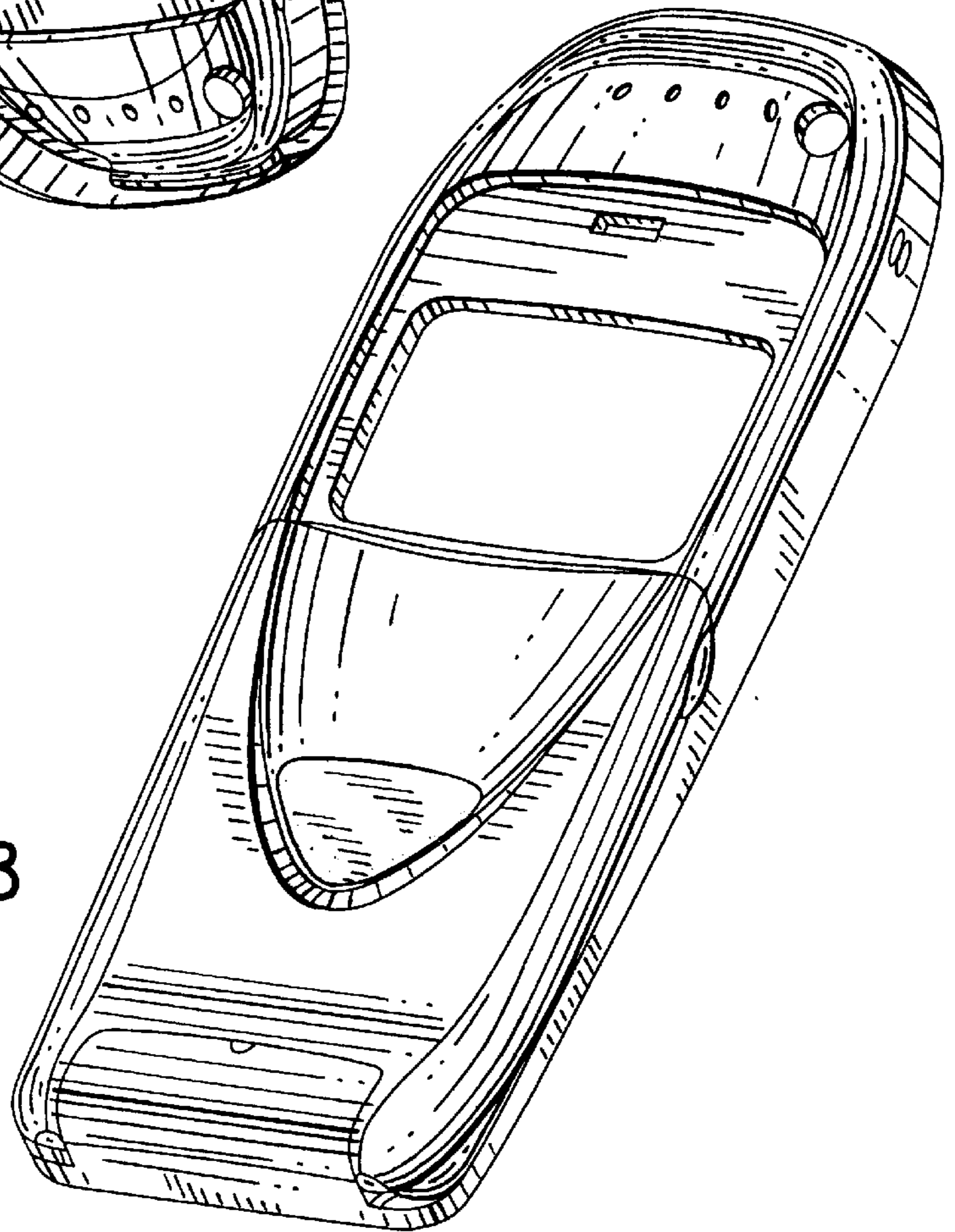

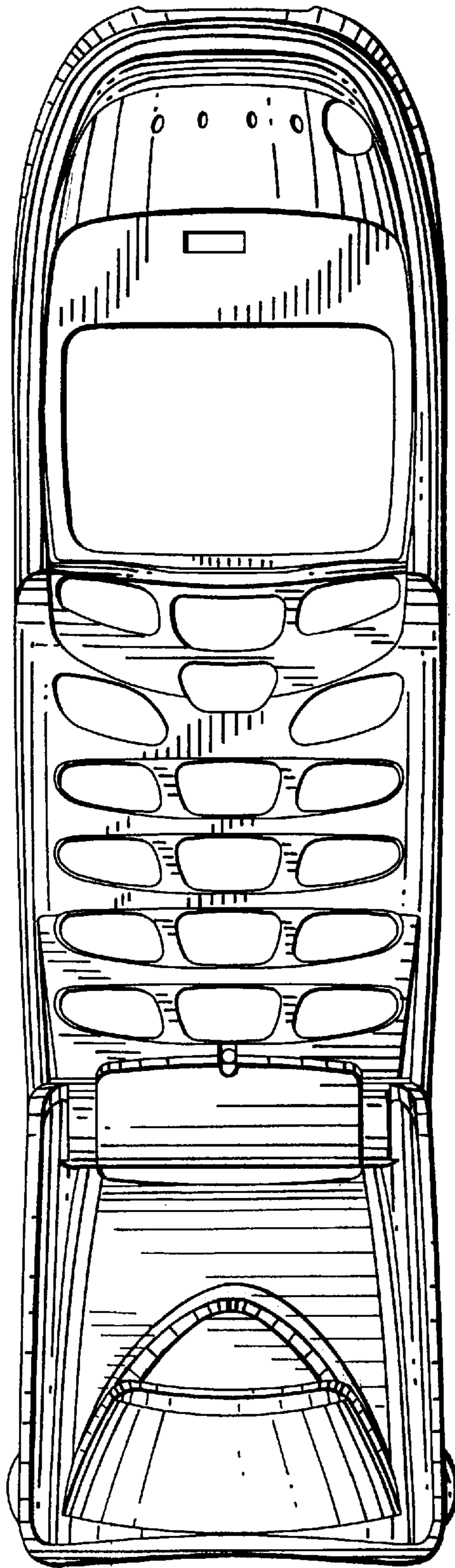

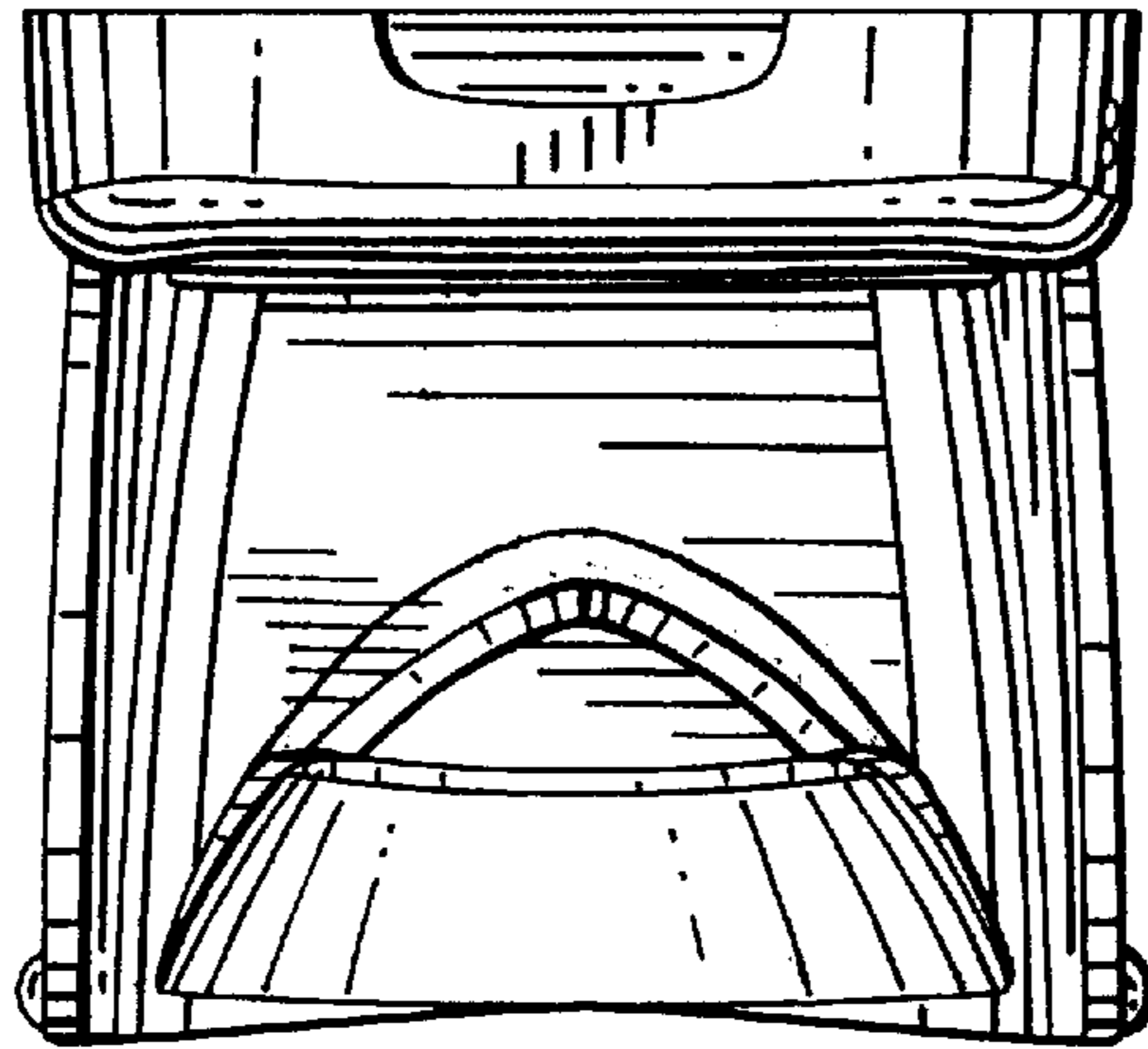

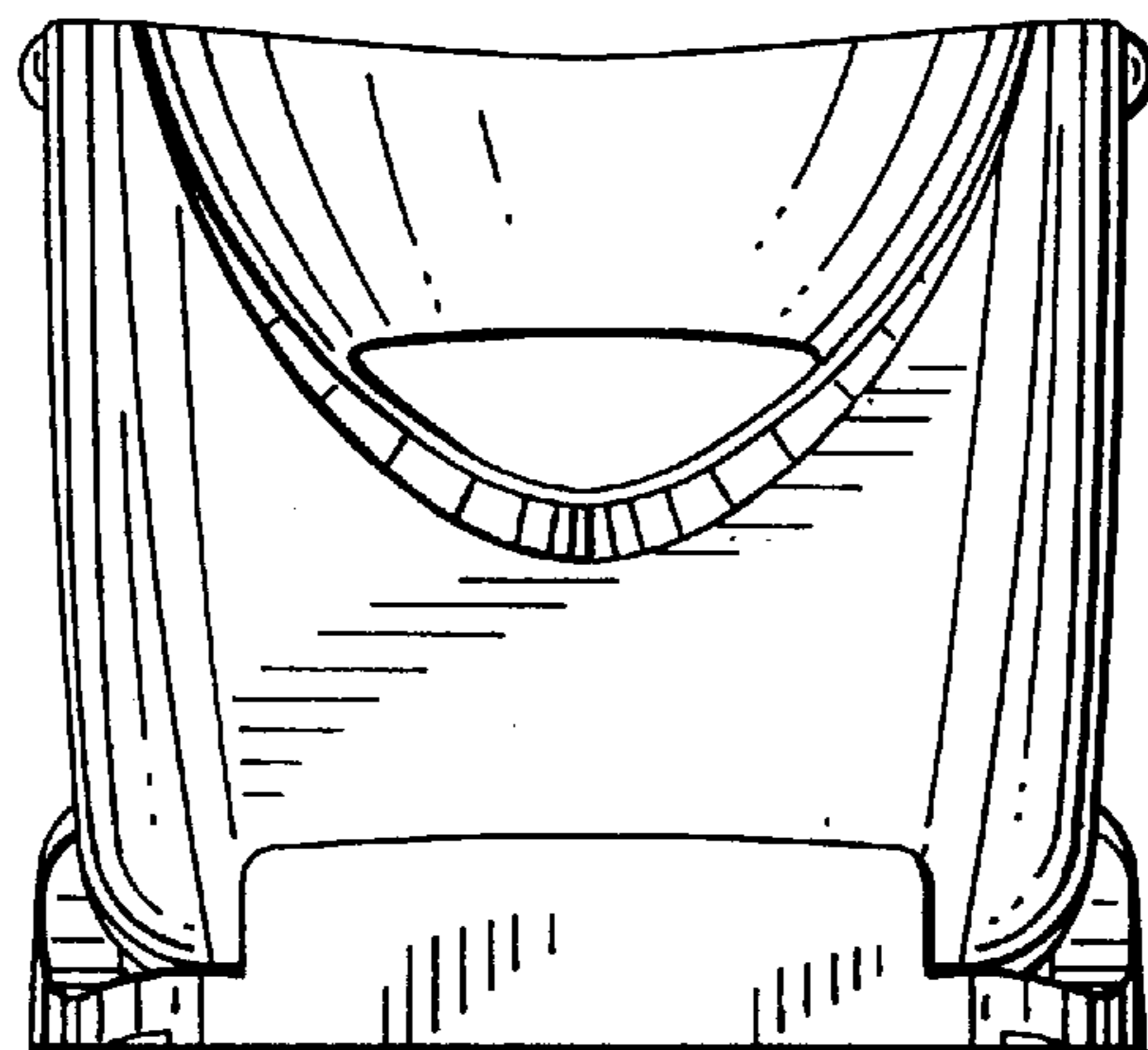

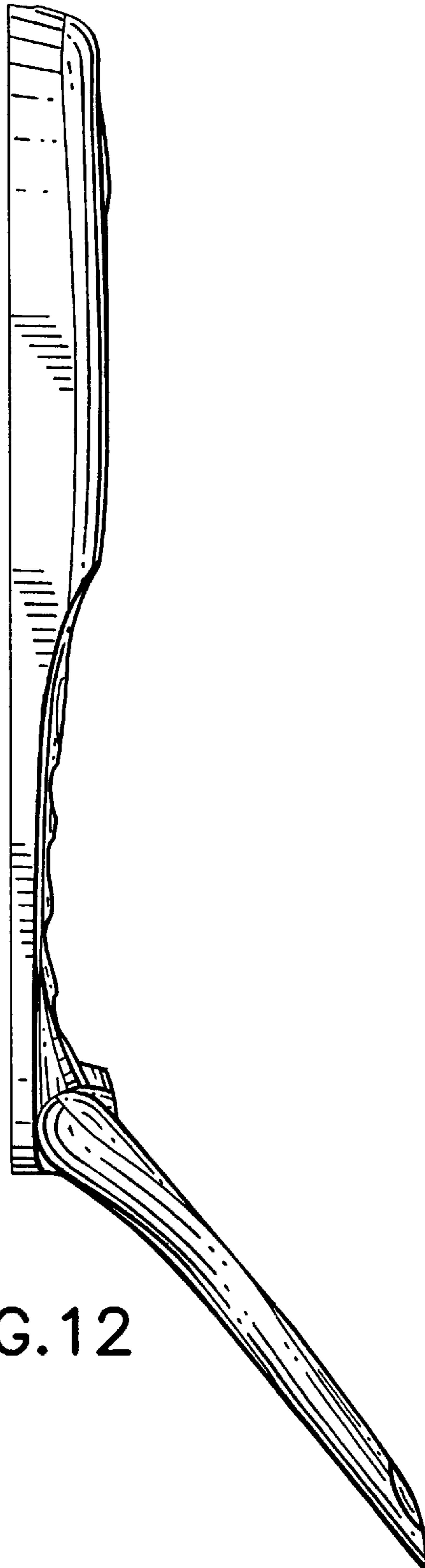

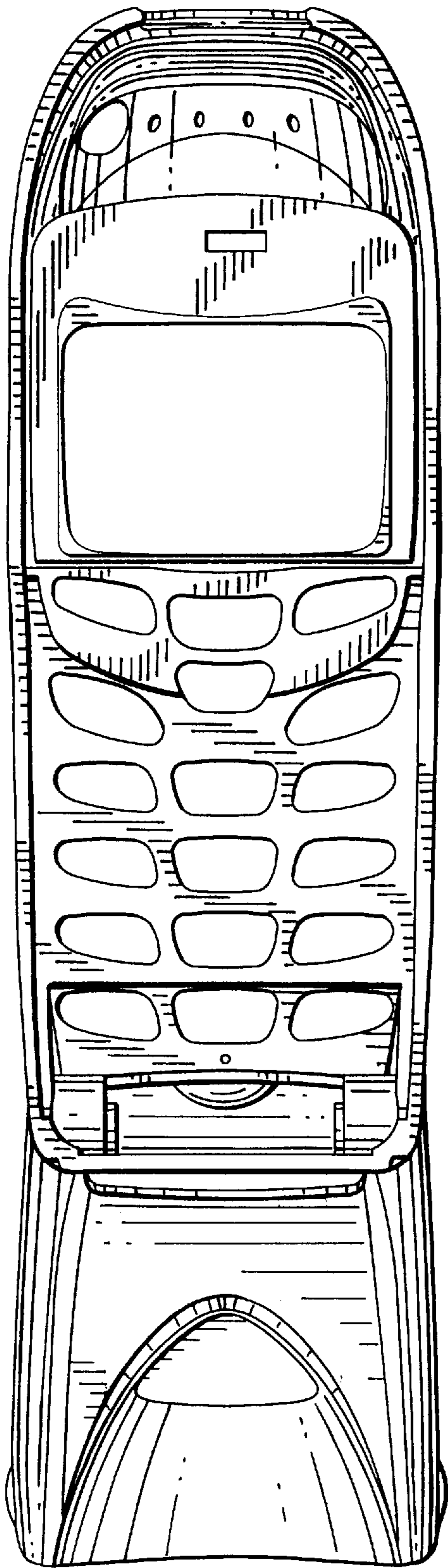

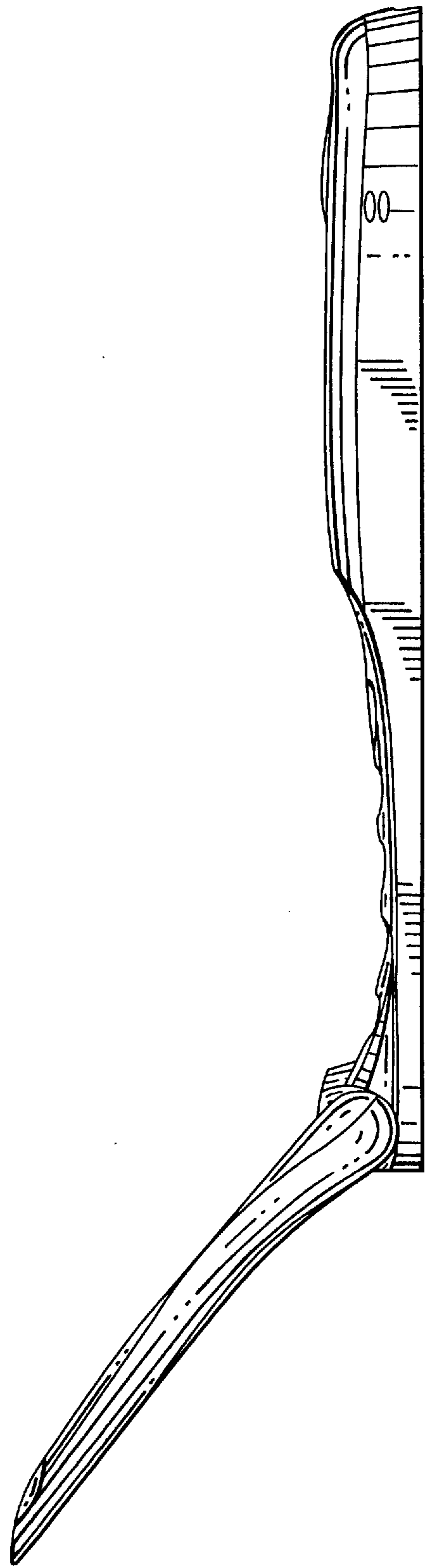

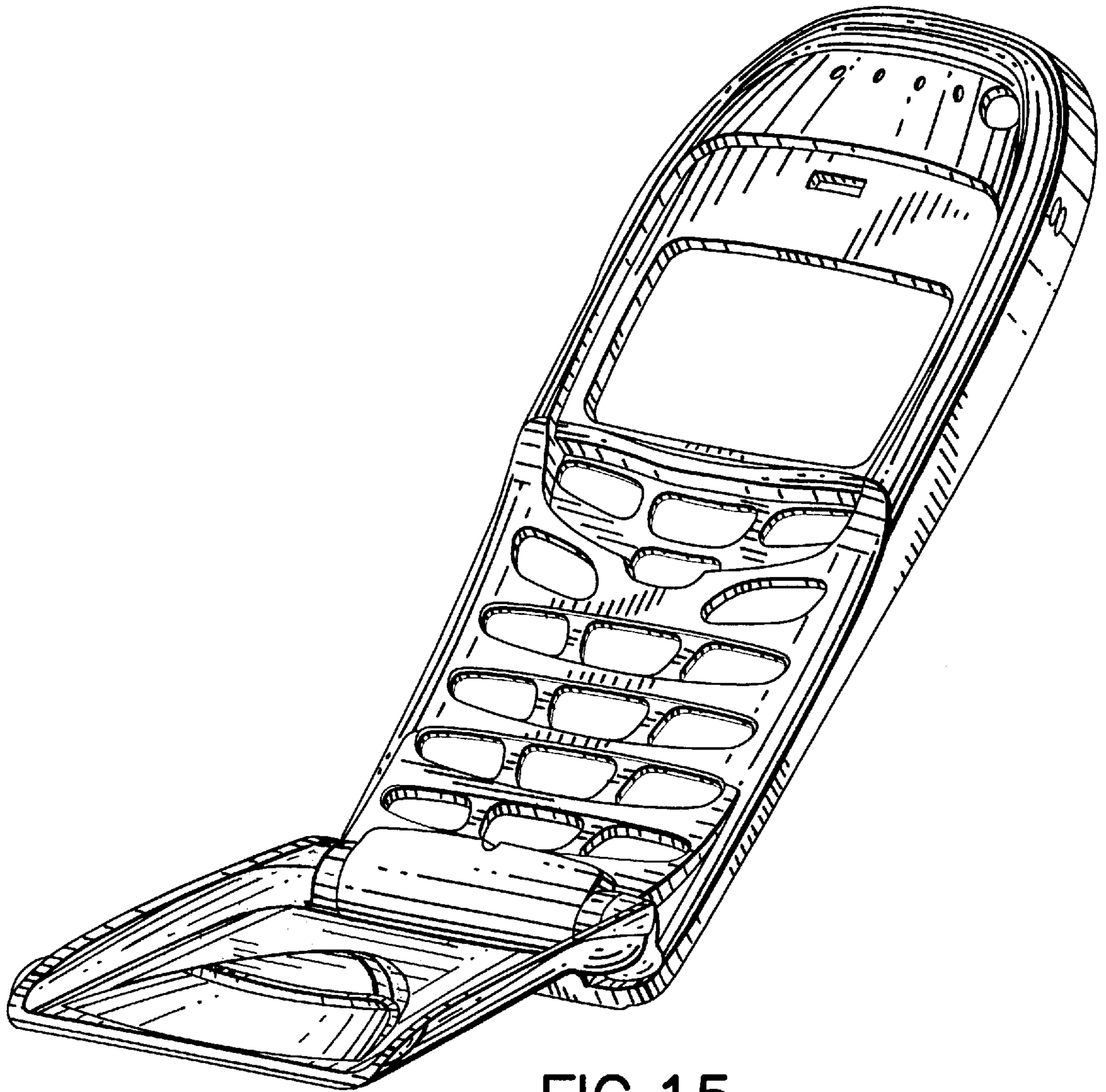

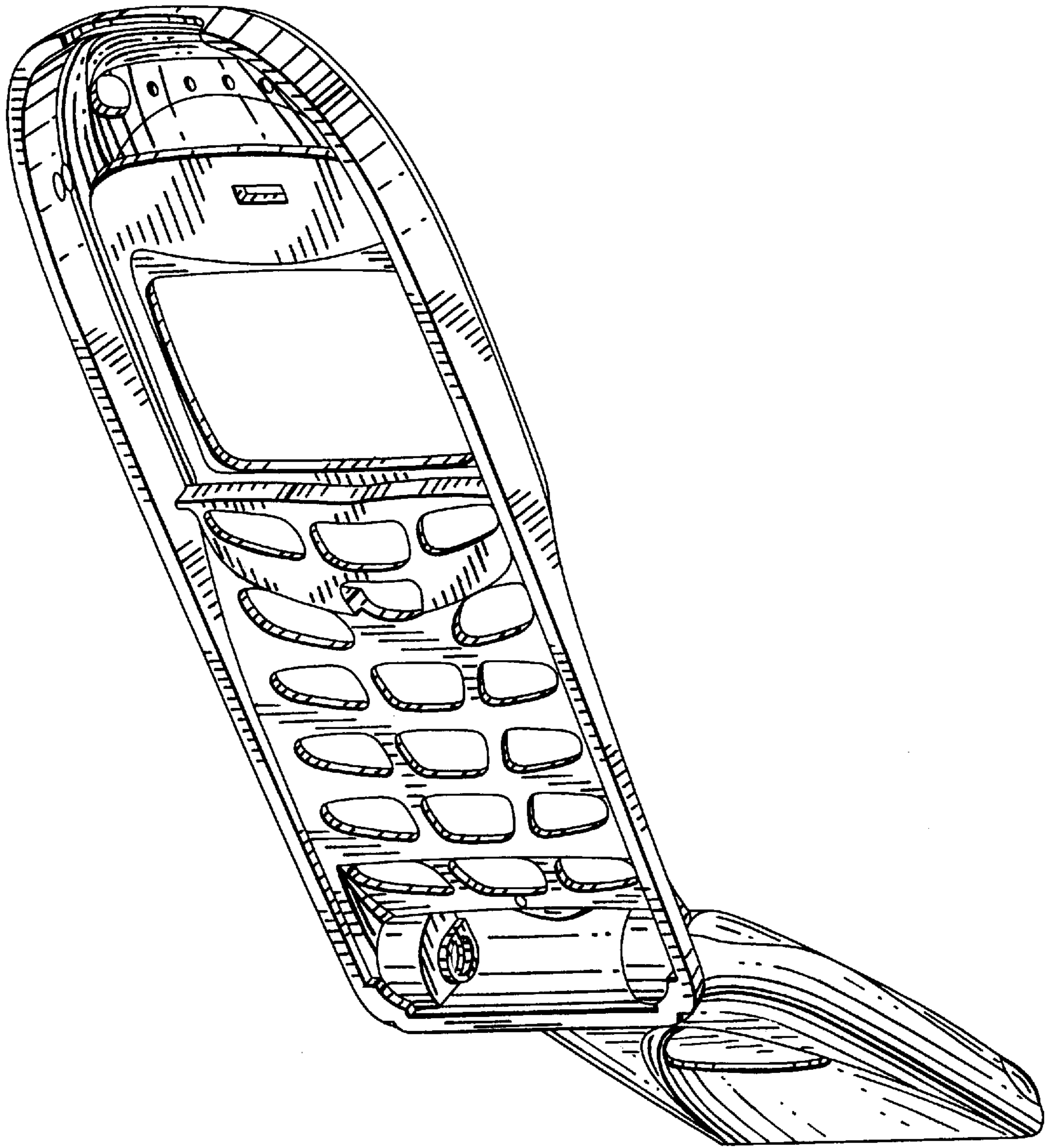
