FIG. 7 is a longitudinal cross-section view of one of the handles.

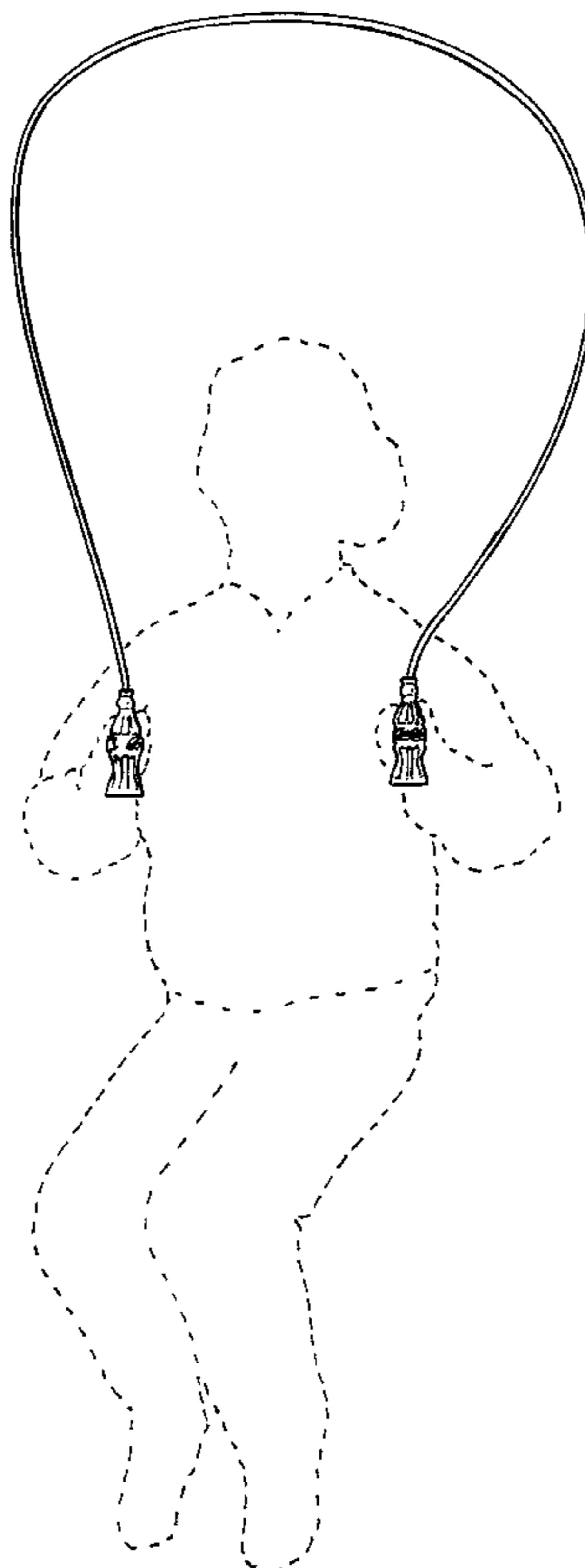

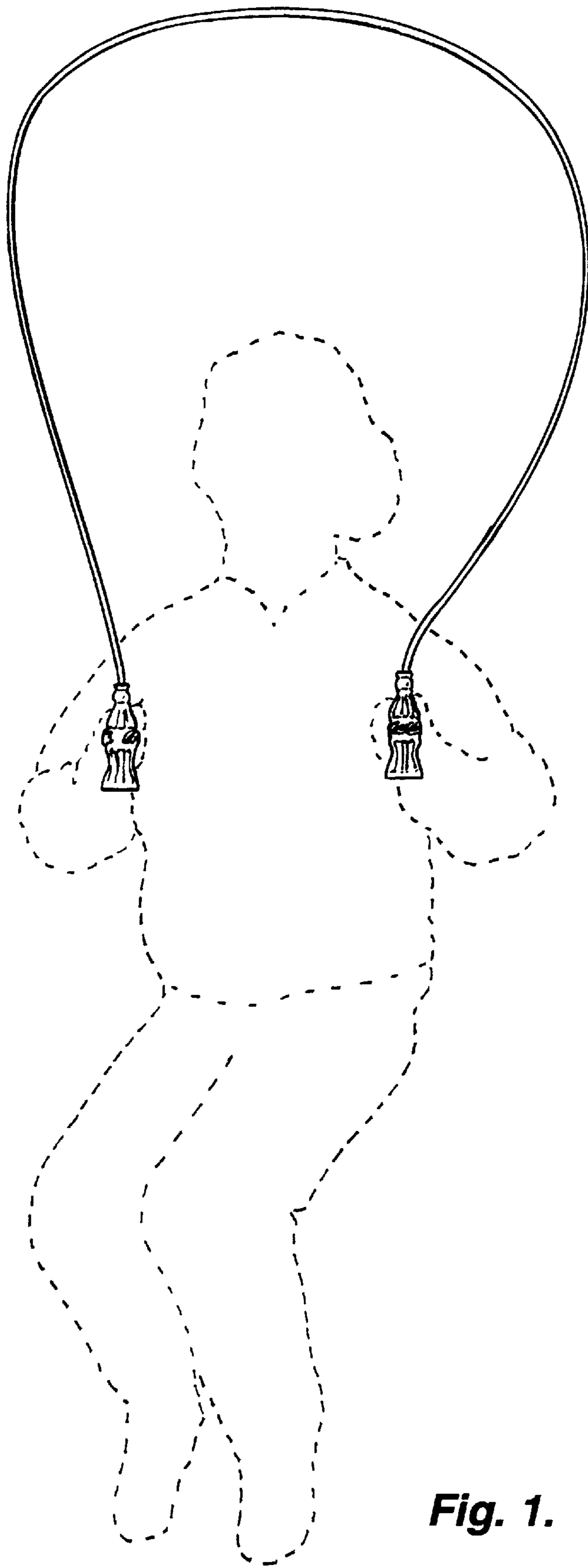

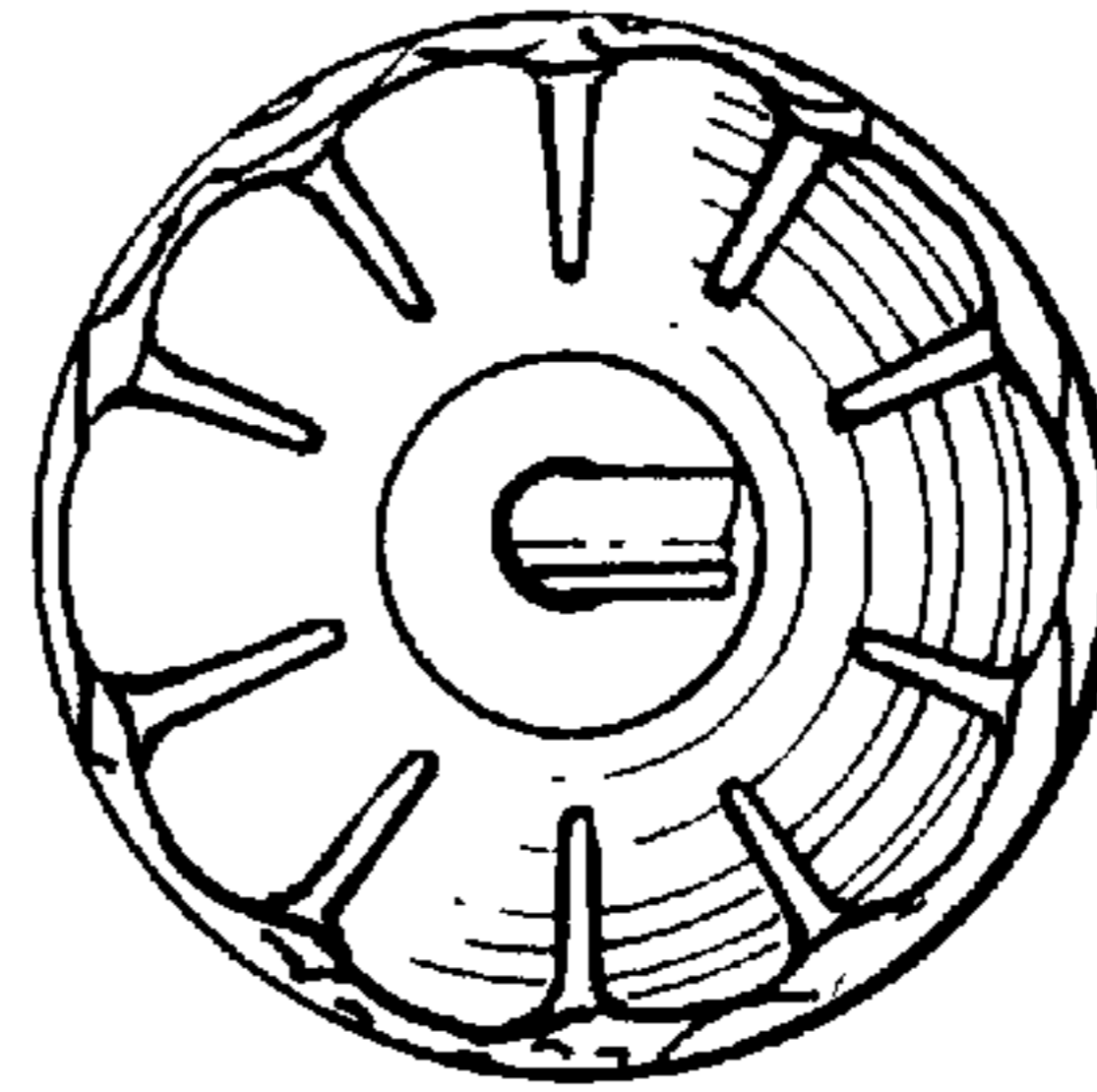

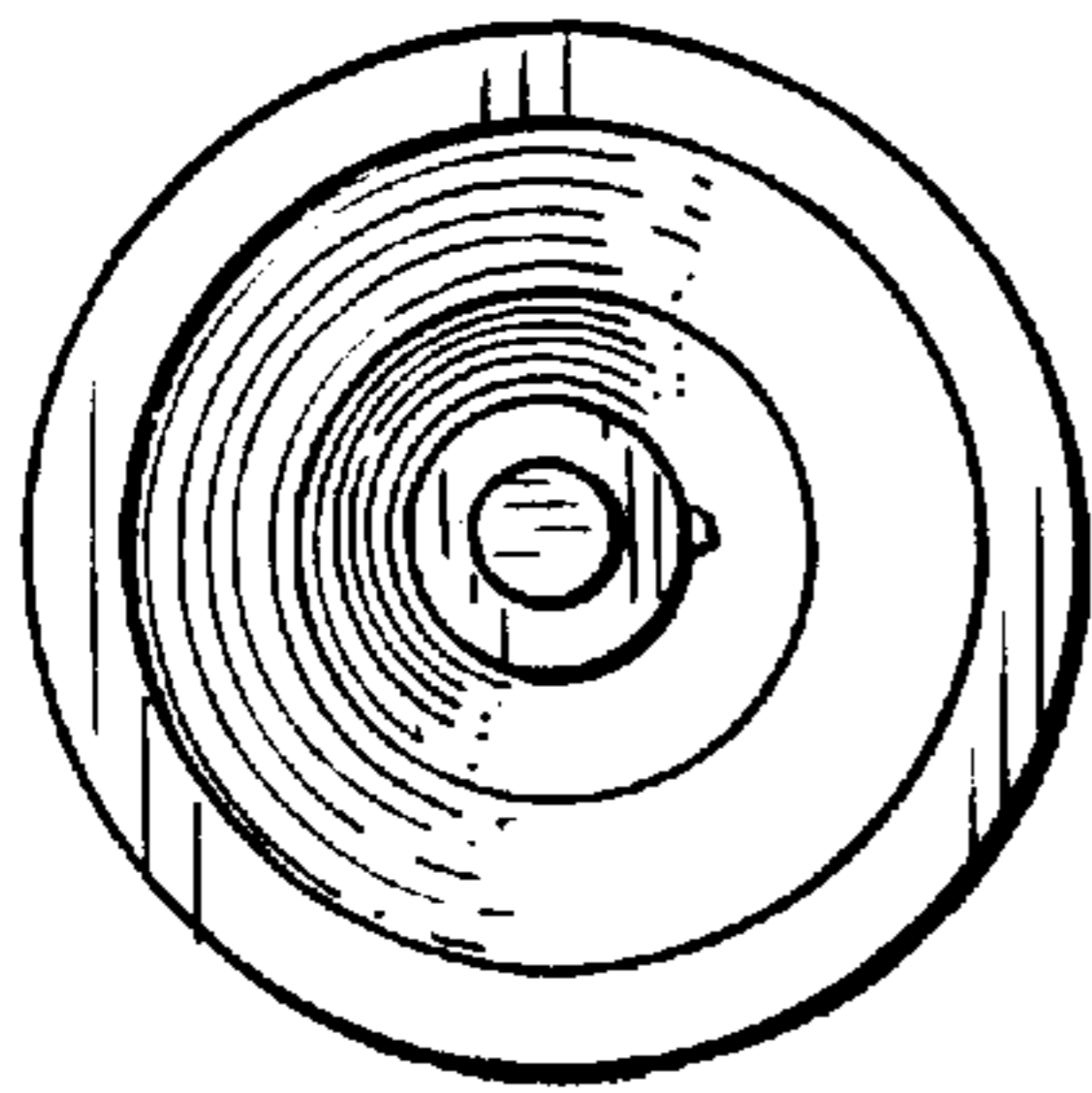

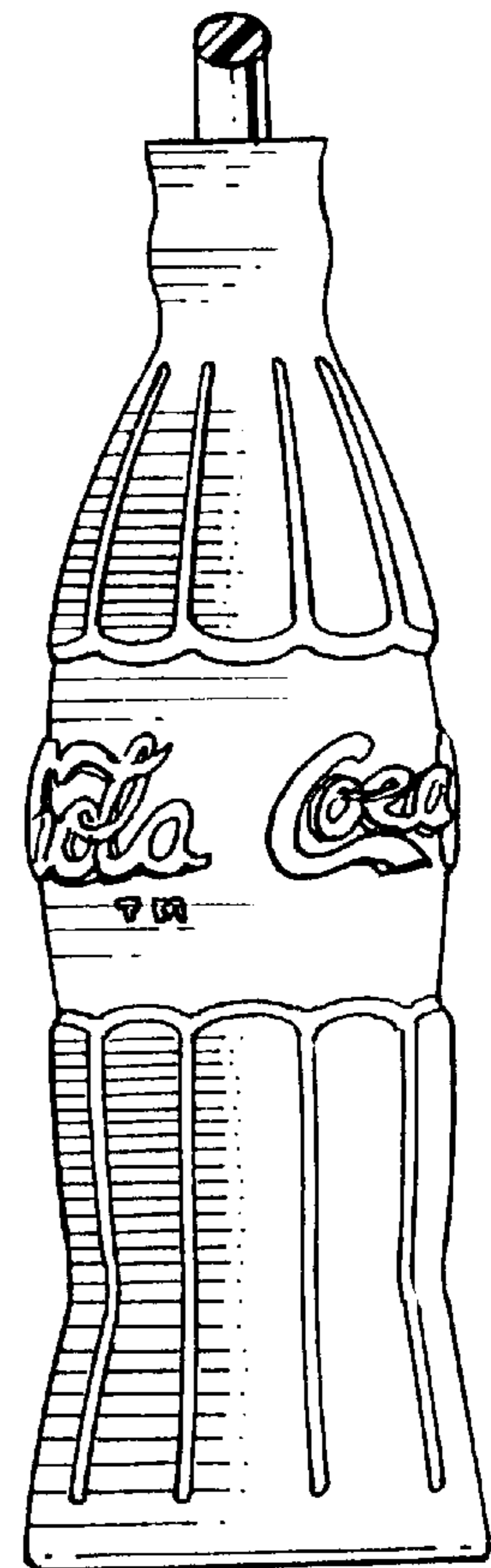

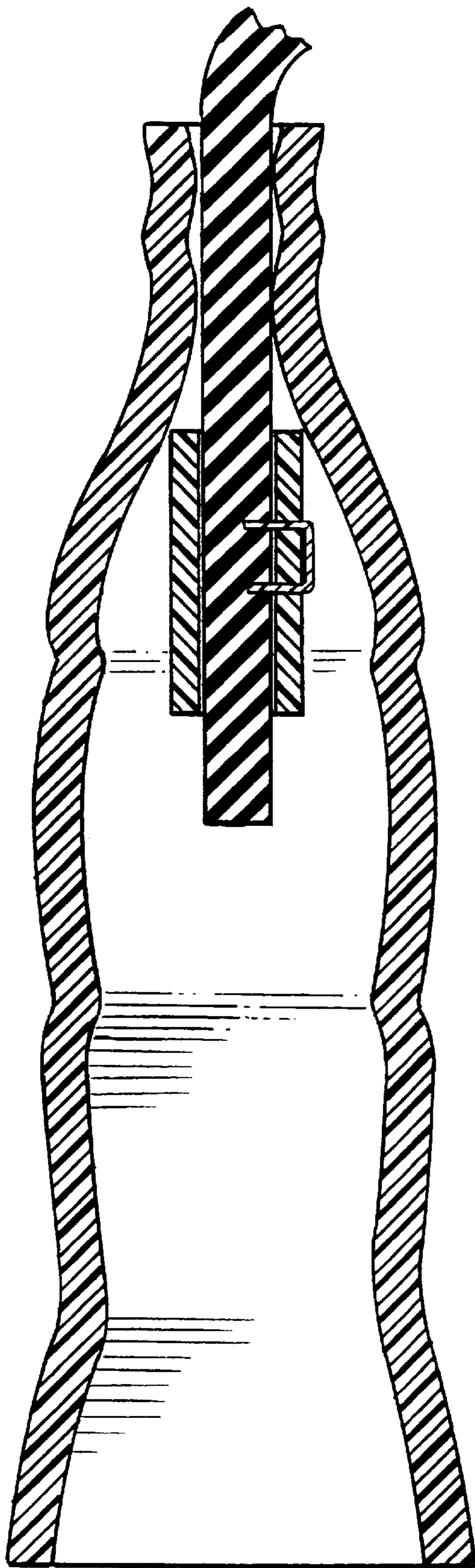
