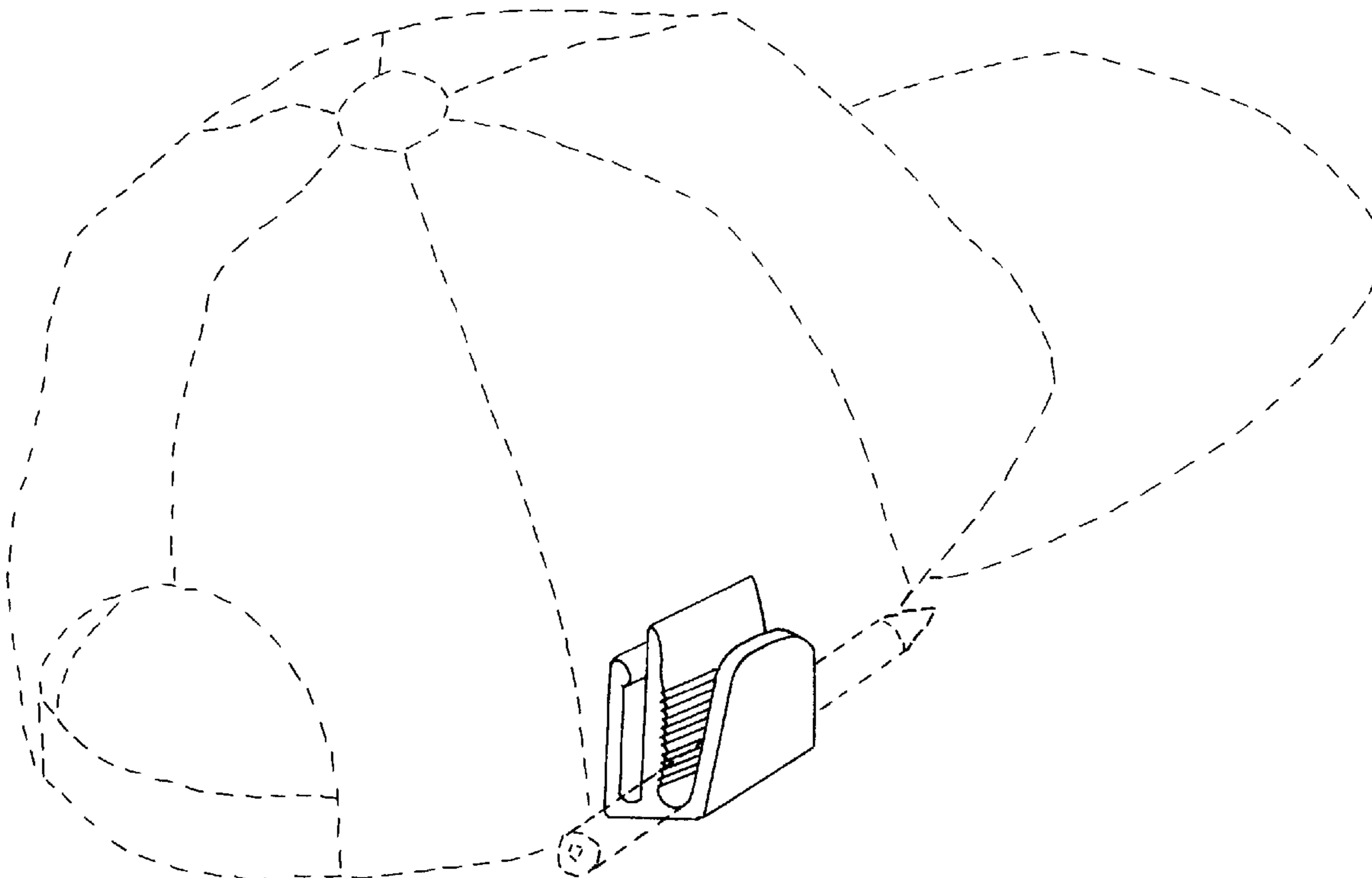
[57] **CLAIM**

I claim the ornamental design for the implement holder for a hat or cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an implement holder for a cap or hat showing my new design, the broken line showing of the cap and pencil is for illustrative purposes only and forms no part of the claimed design;  
FIG. 2 is a perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof;

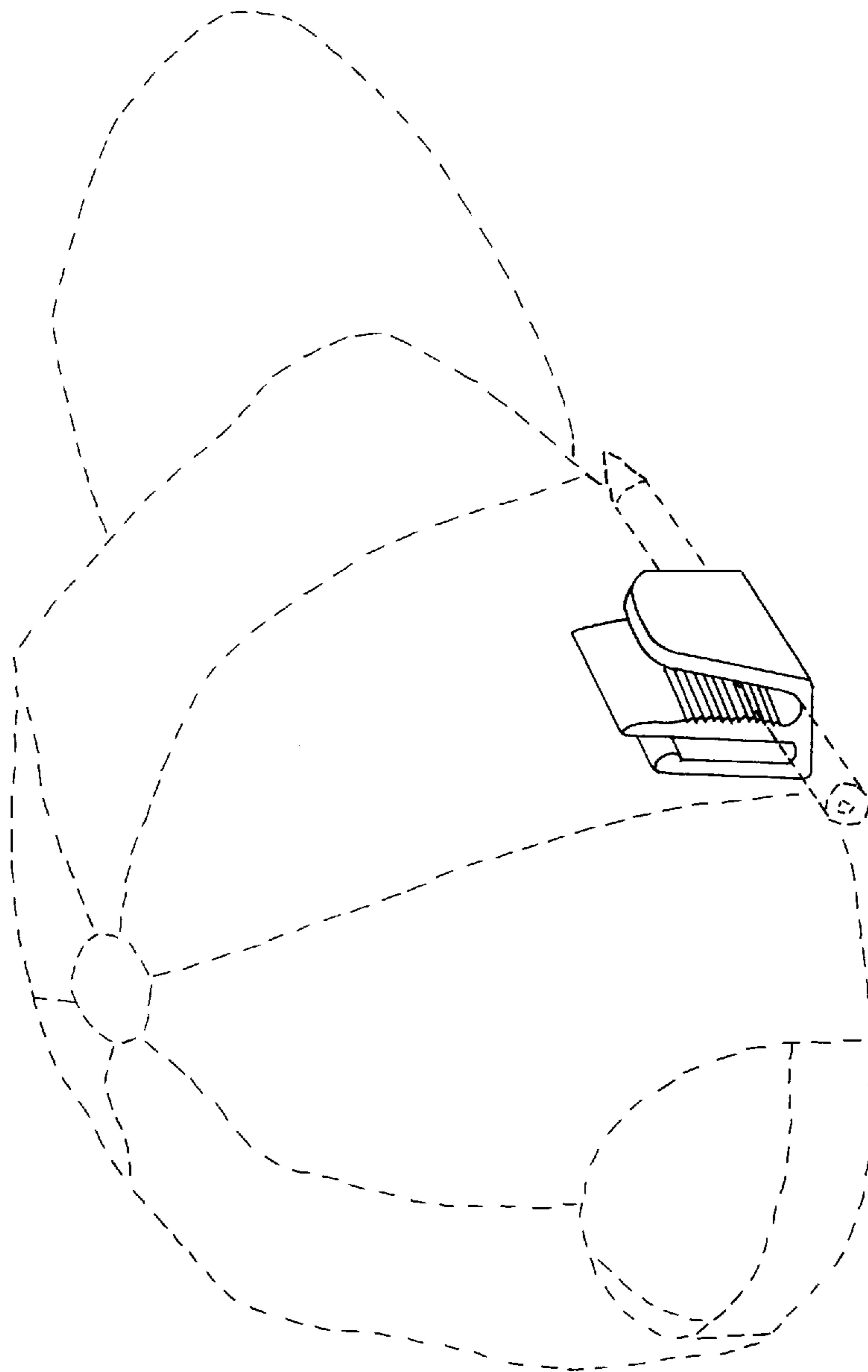

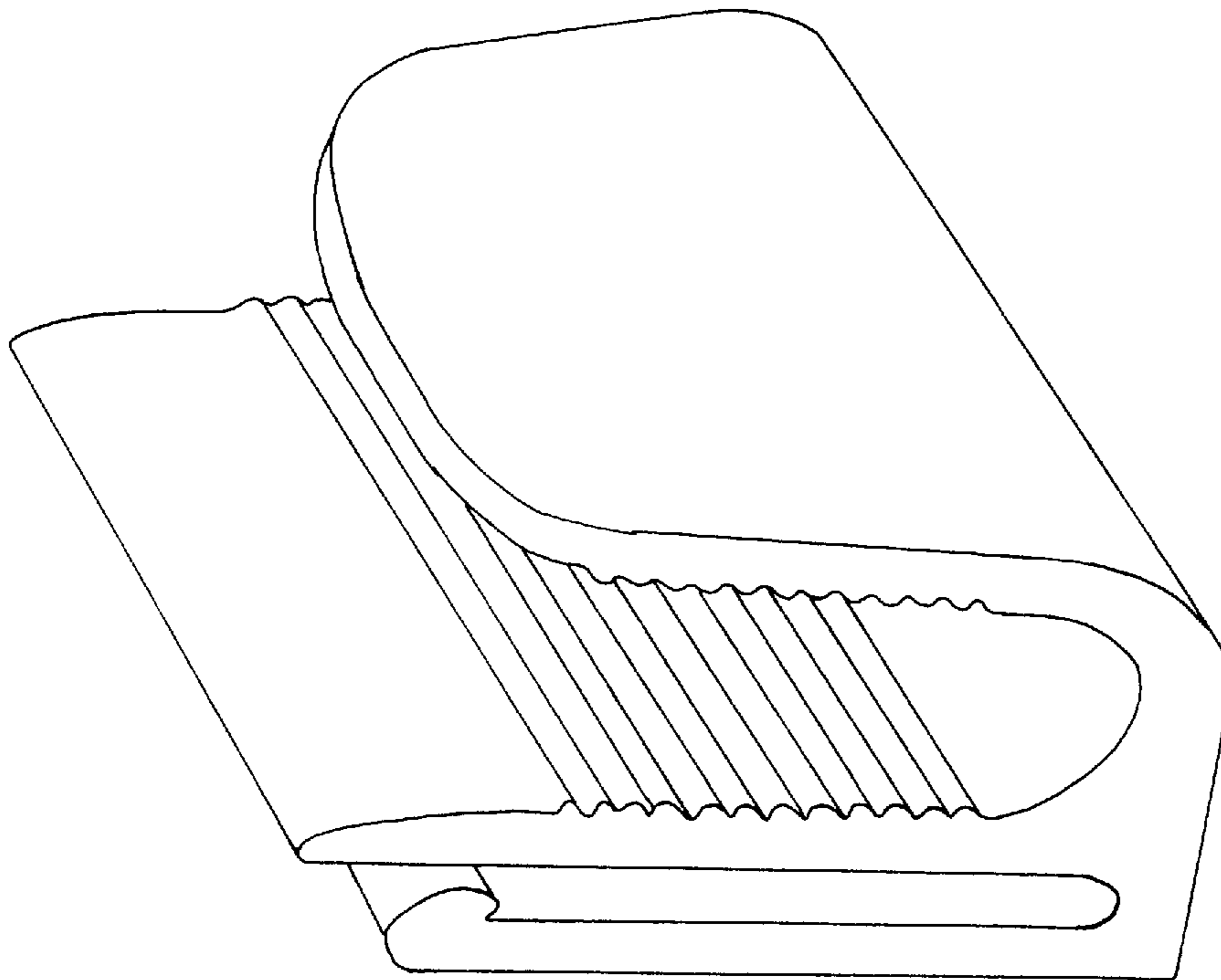

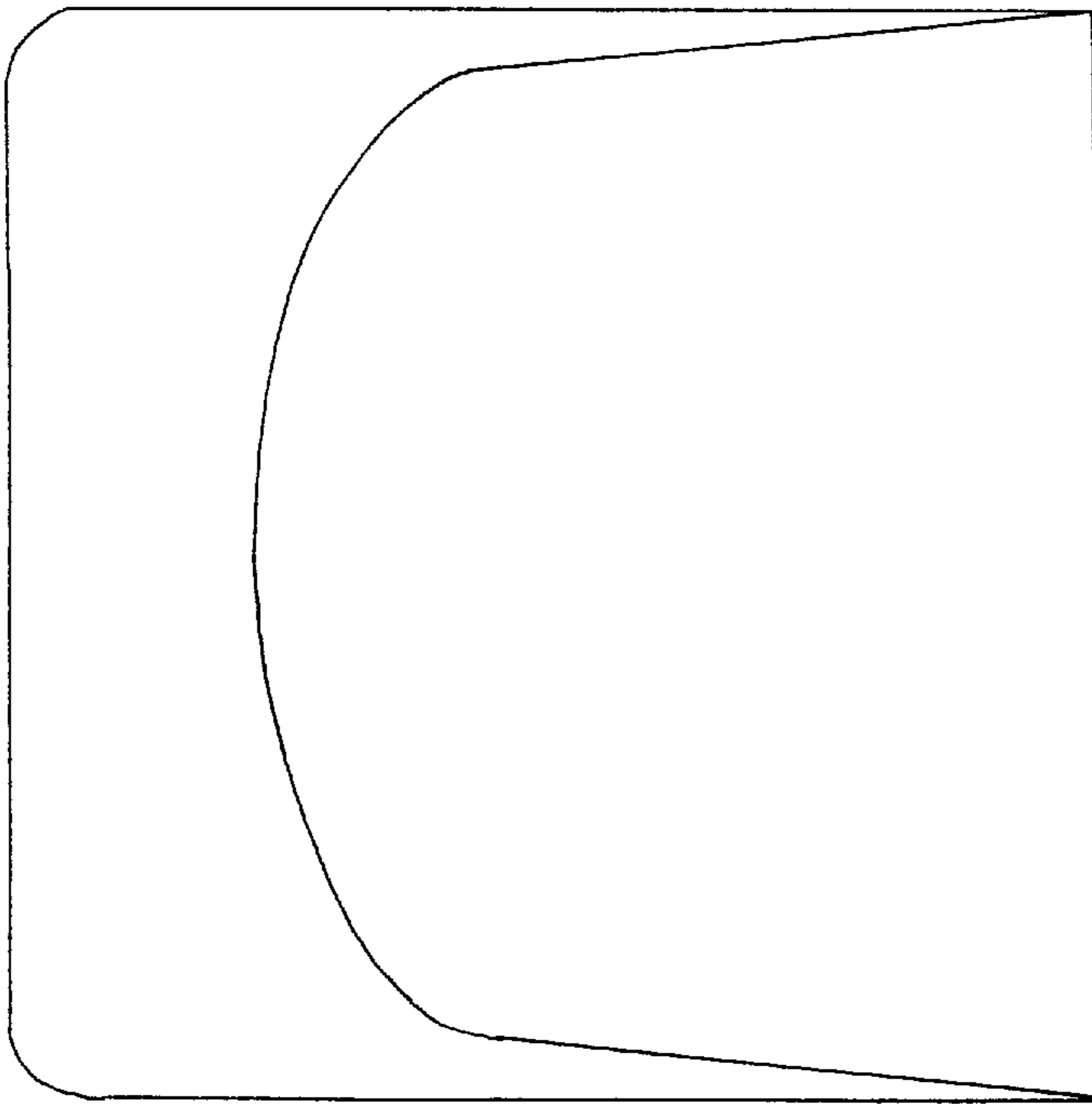

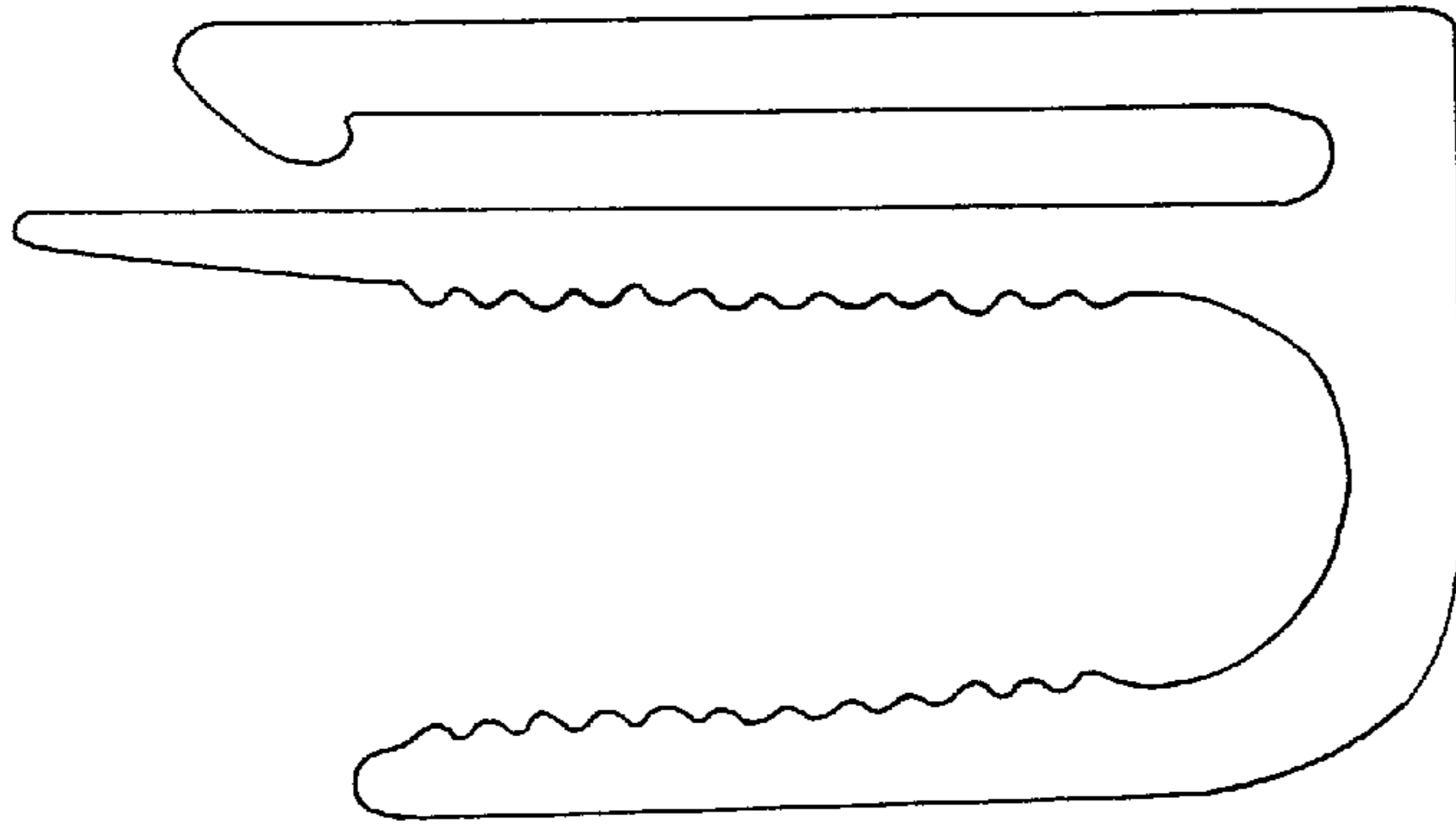

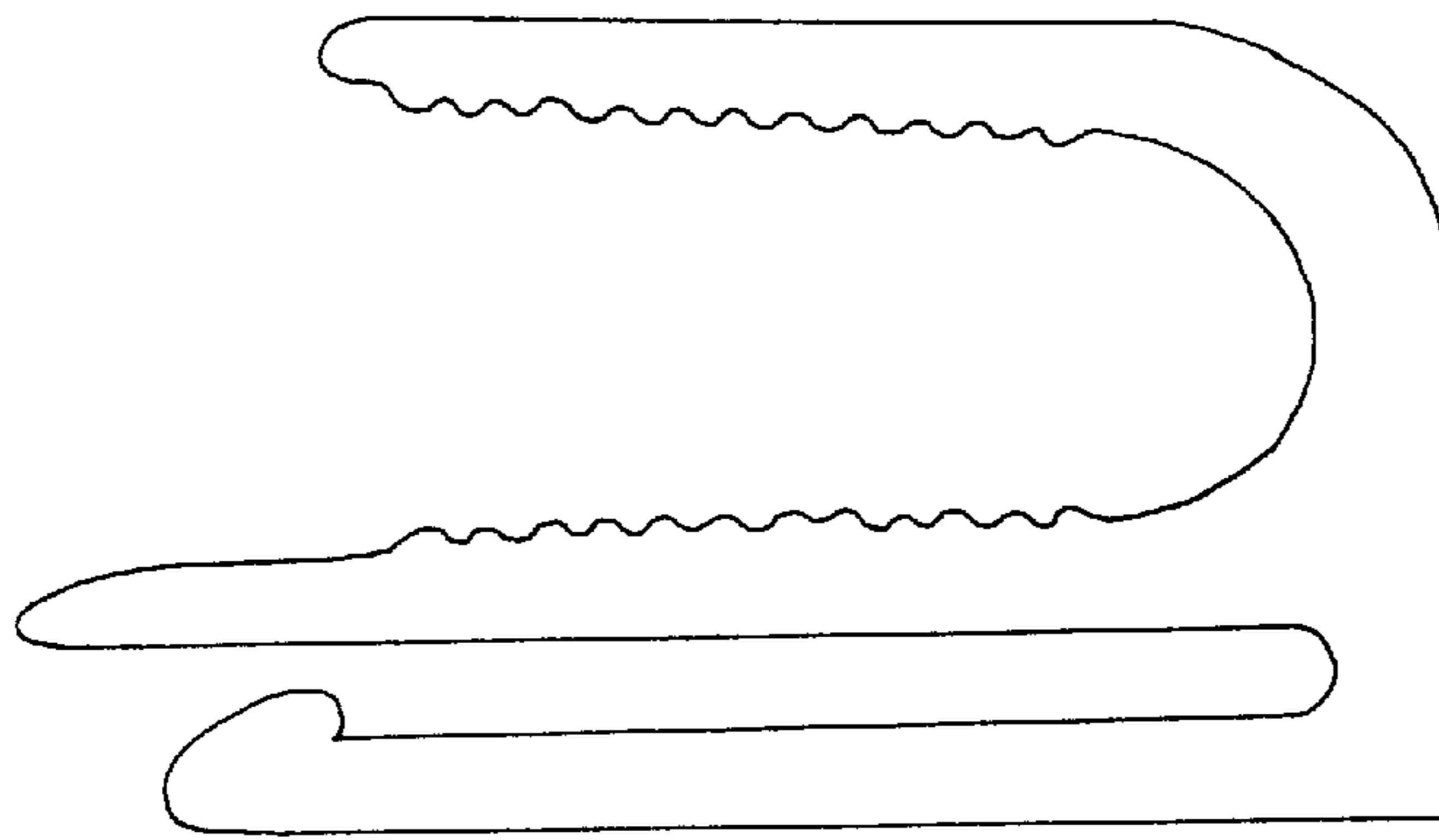

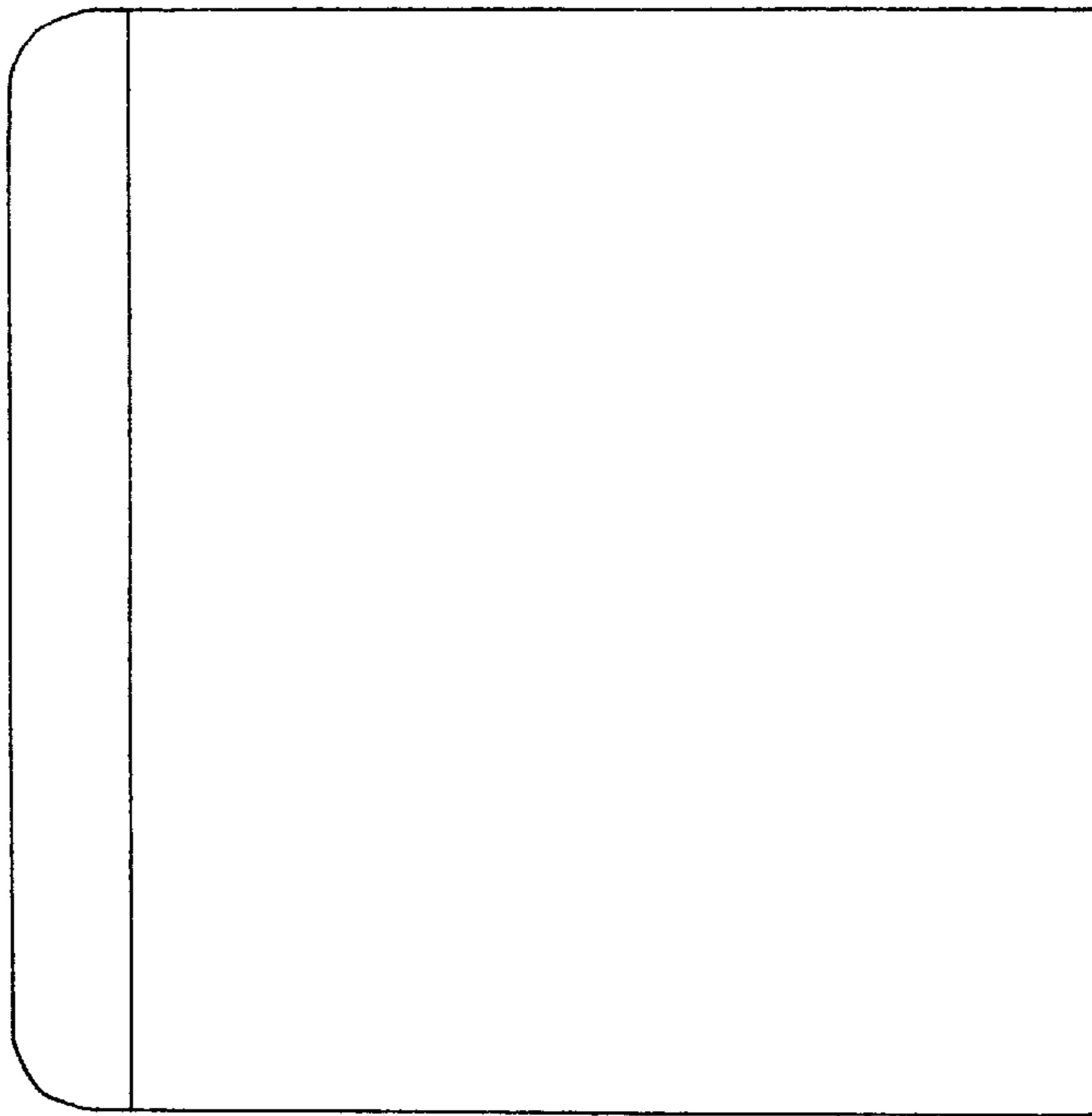

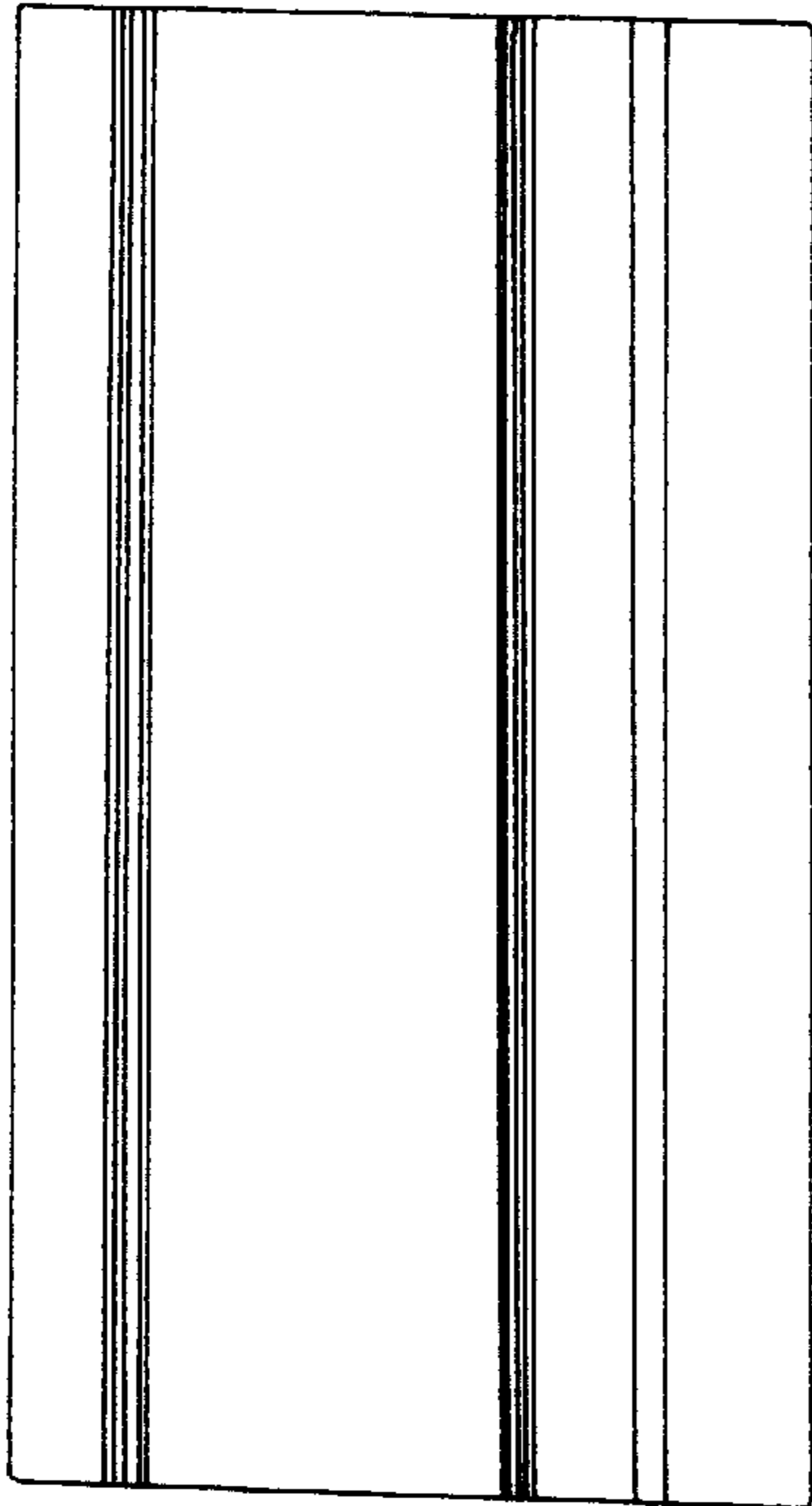

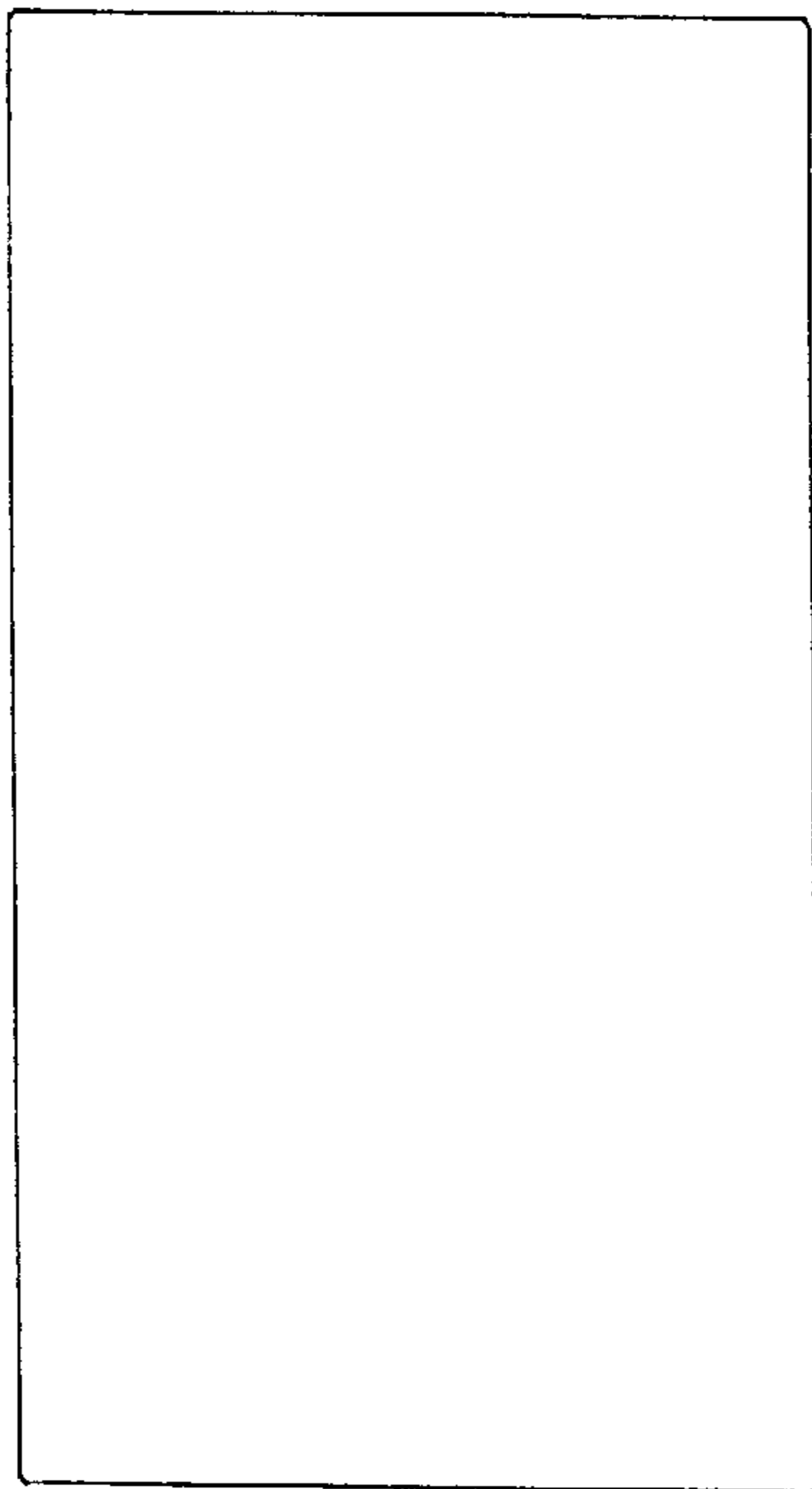
