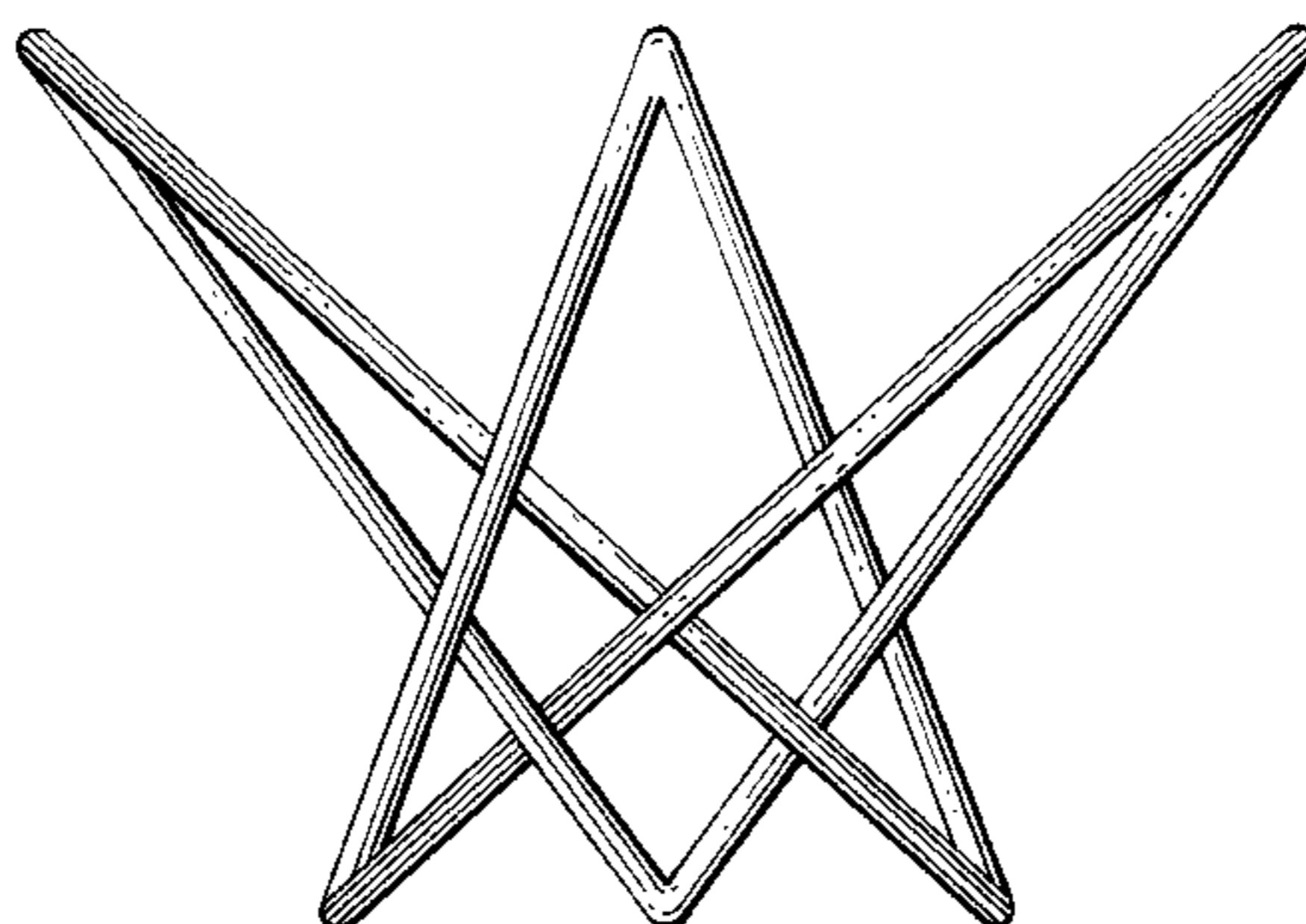
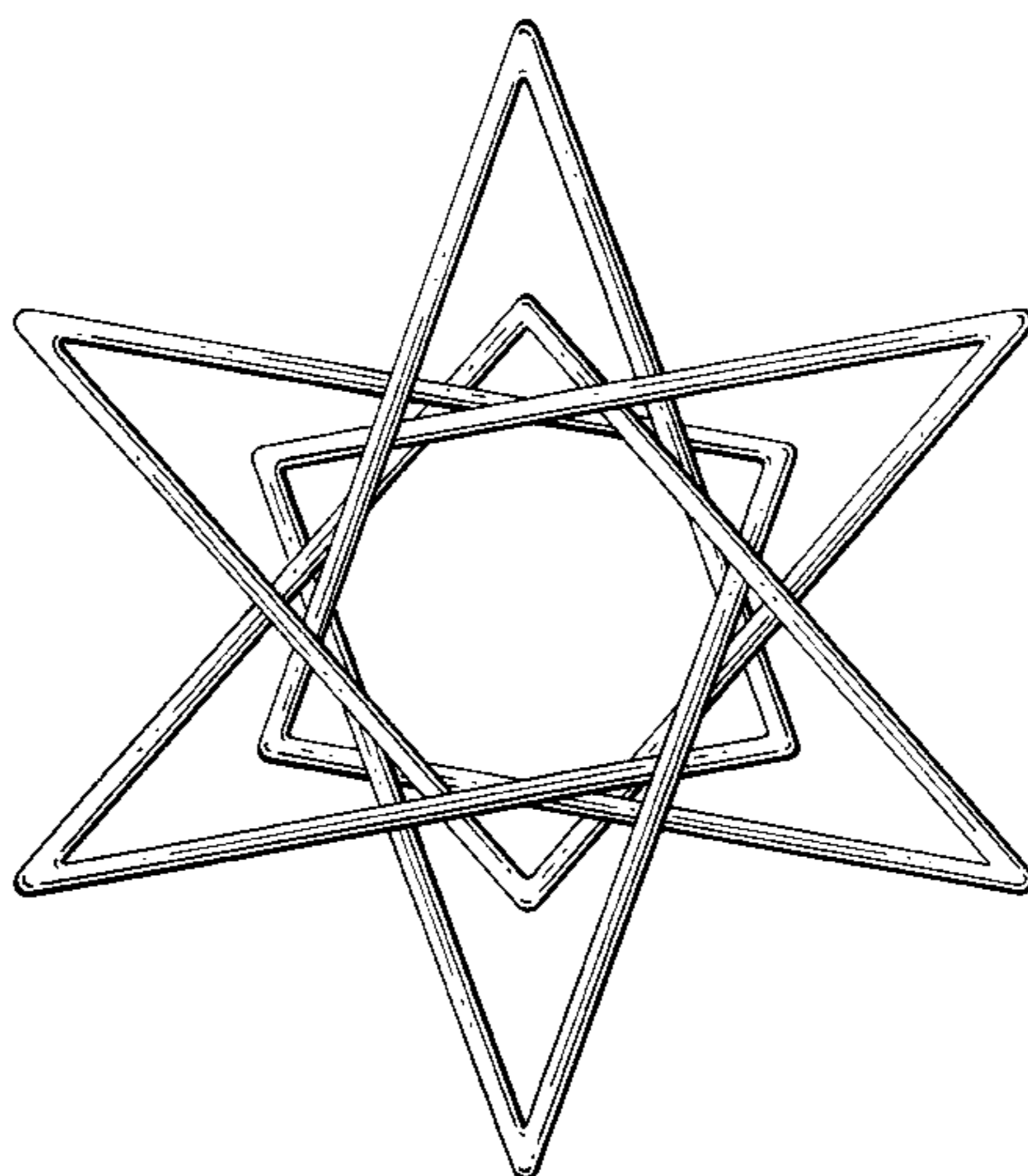
The ornamental design for a stand, as shown and described.

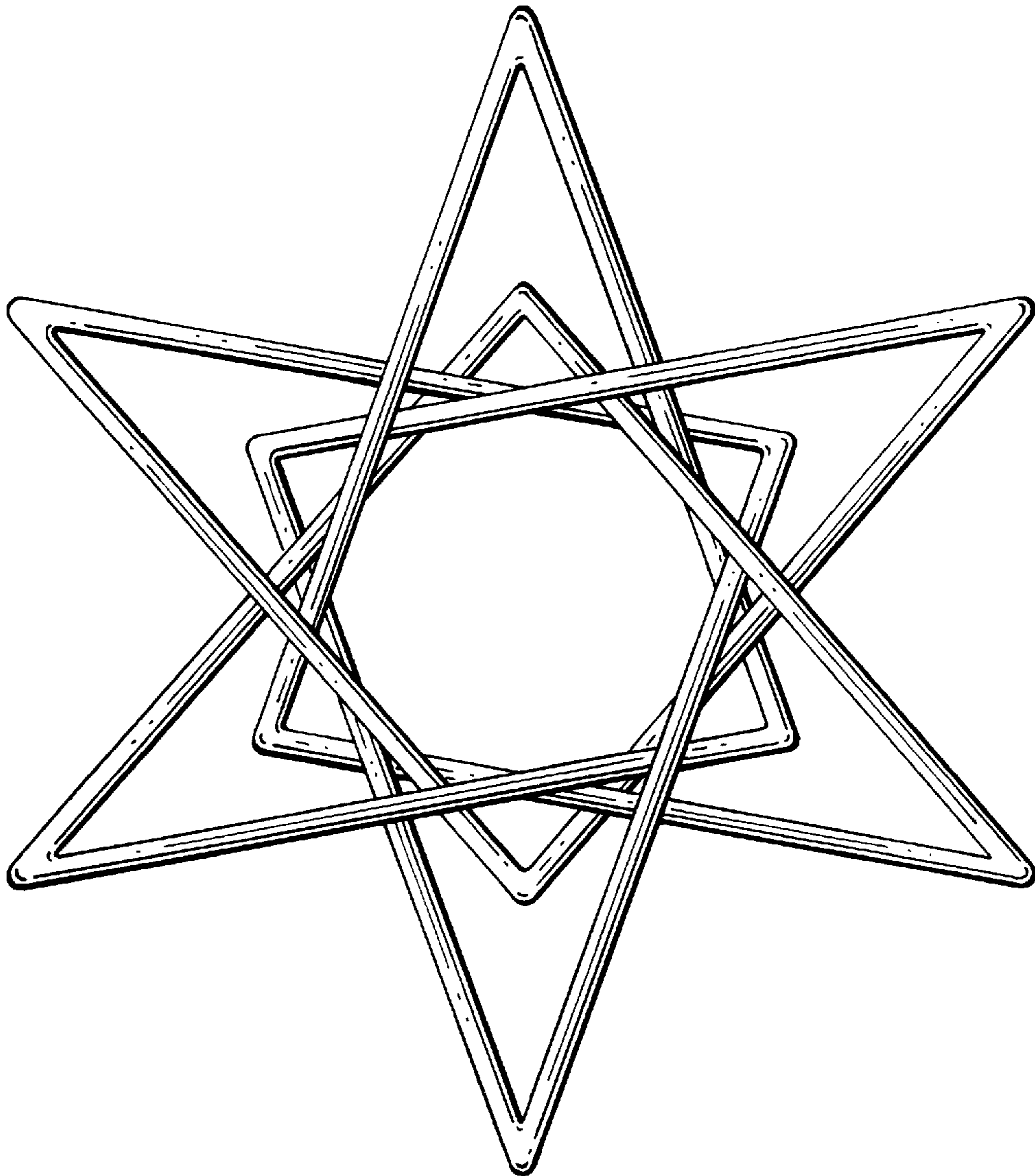
### DESCRIPTION

FIG. 1 is a top plan view of the stand;  
FIG. 2 is a front elevational view of the stand shown in FIG. 1, the rear view being a mirror image; and,

The stand may also be positioned turned upside down.

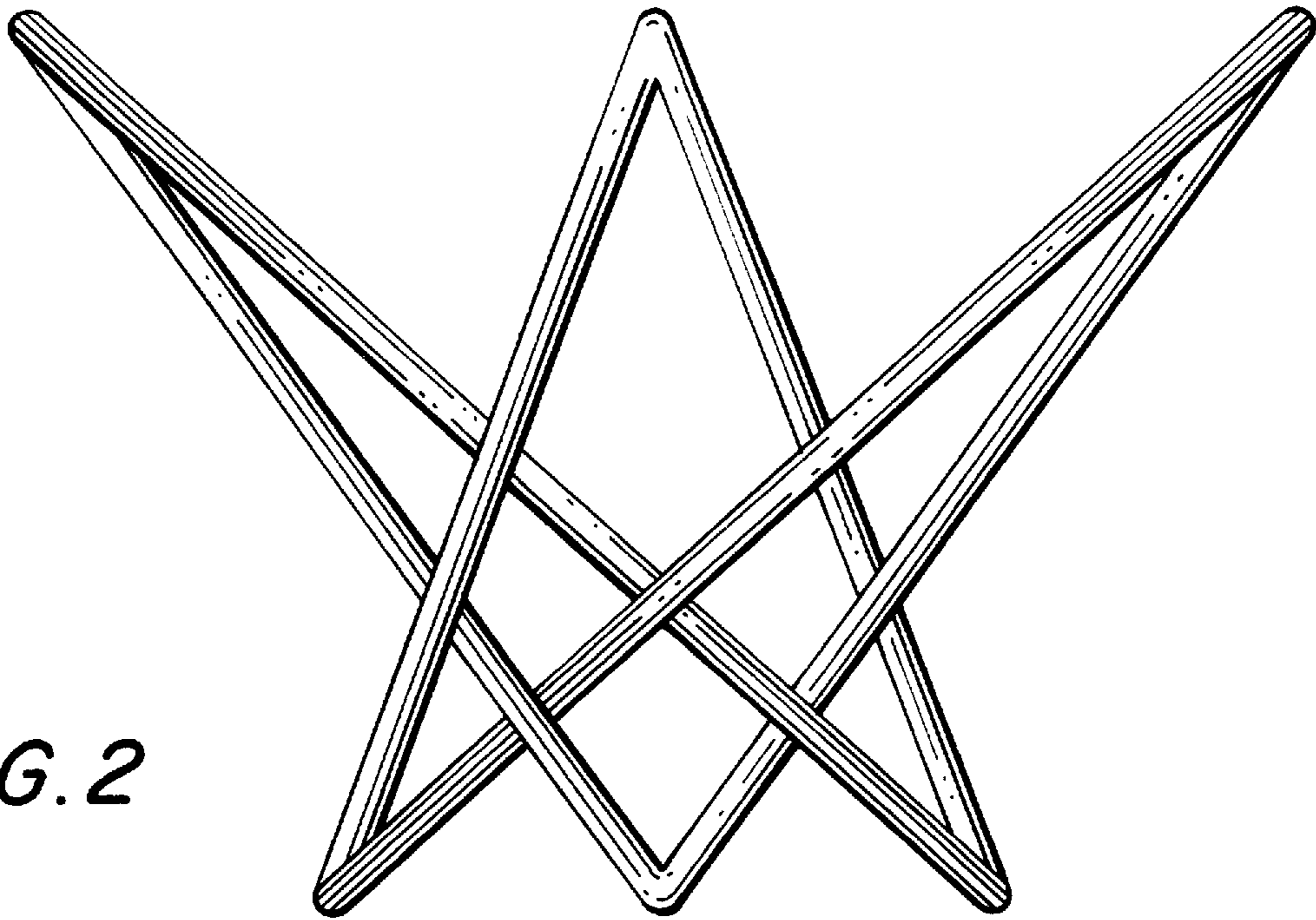
