The ornamental design for a combination tool, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a combination tool with the handles in the folded close position;
FIG. 2 is a bottom view thereof;
FIG. 3 is a left elevational view thereof;
FIG. 4 is a right elevational view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a back elevational view thereof;
FIG. 7 is a top view of the combination tool with the handles in the folded open position;
FIG. 8 is bottom view thereof;
FIG. 9 is a left elevational view thereof;
FIG. 10 is a right elevational view thereof;
FIG. 11 is a front elevational view thereof;
FIG. 12 is a back elevational view thereof.

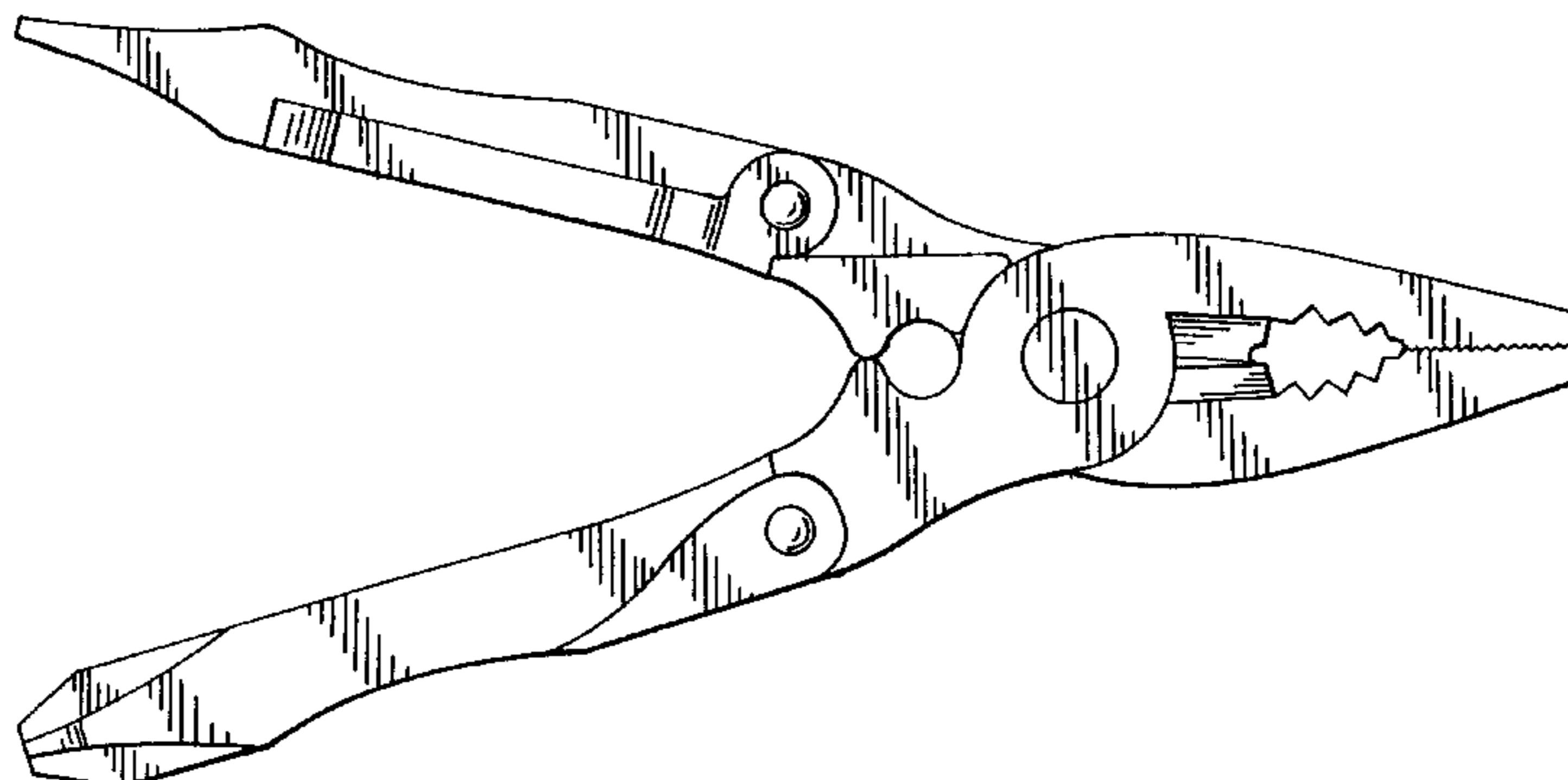
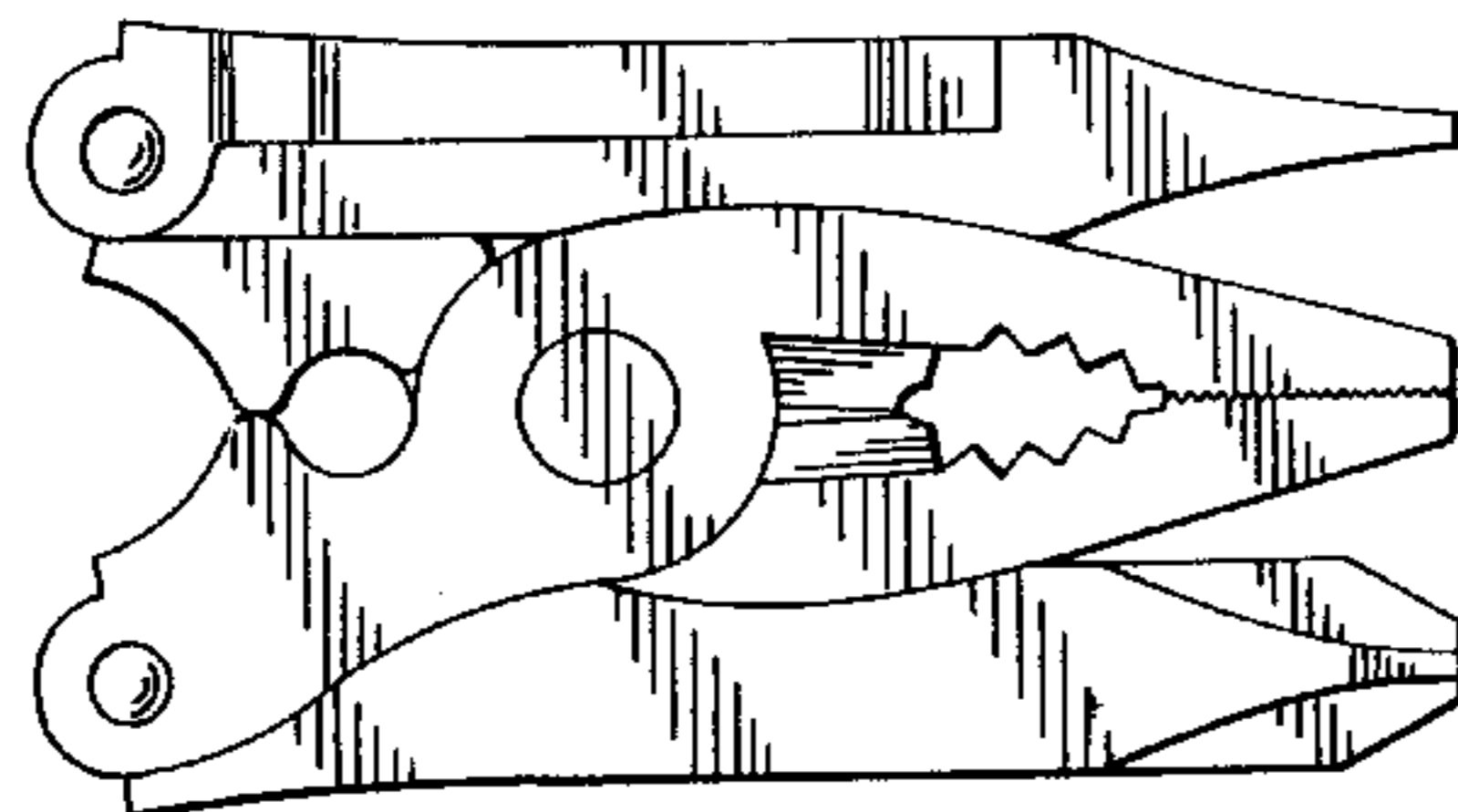

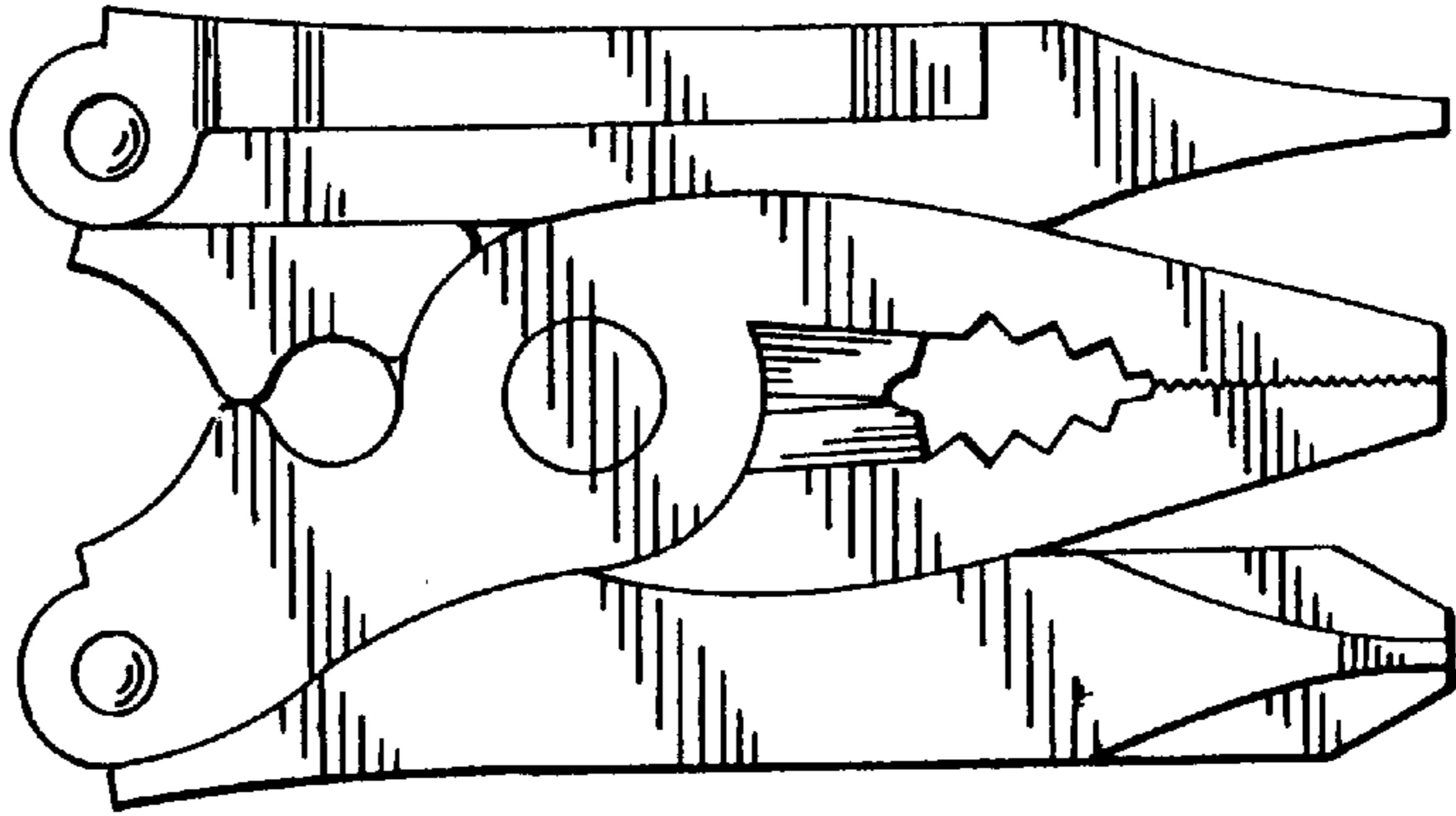

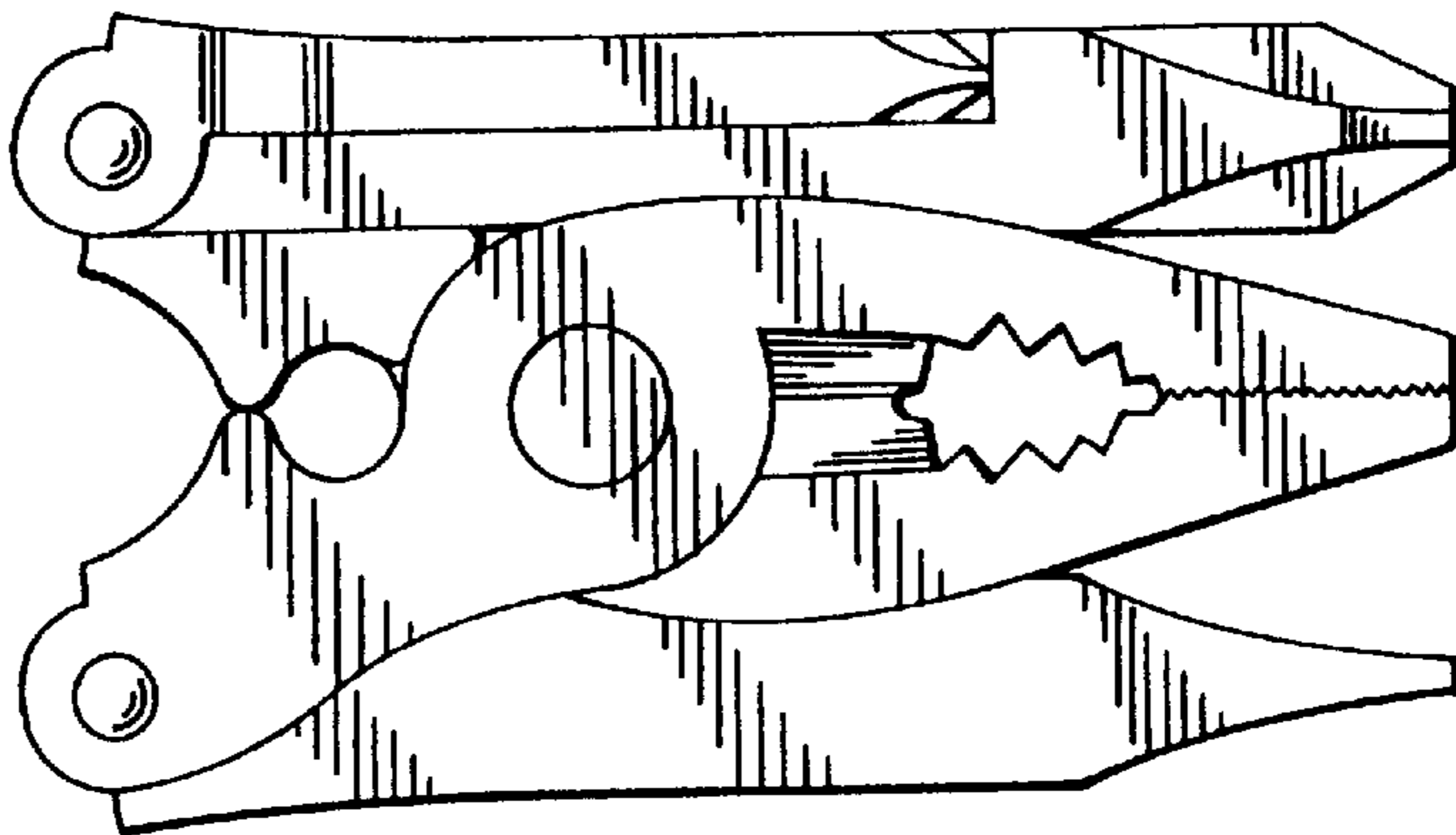

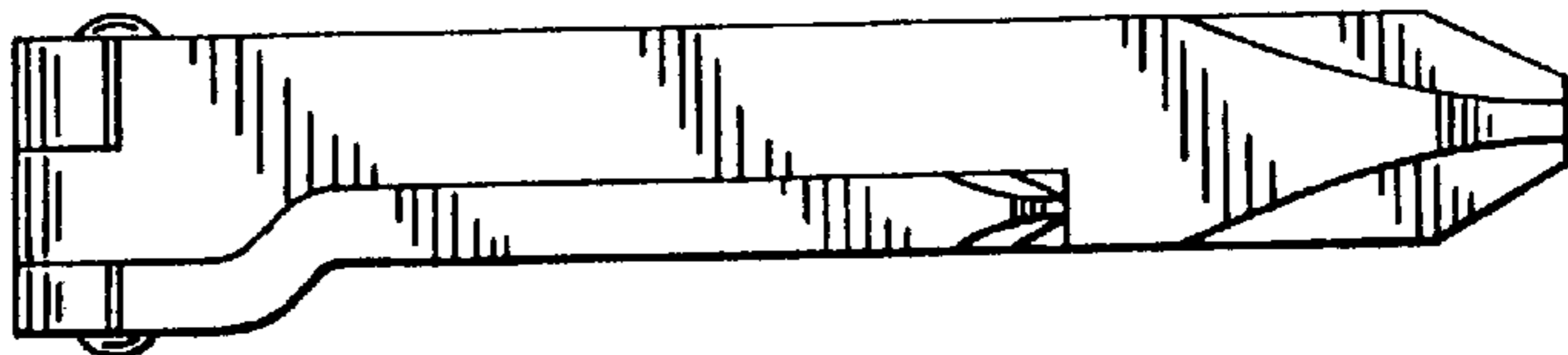

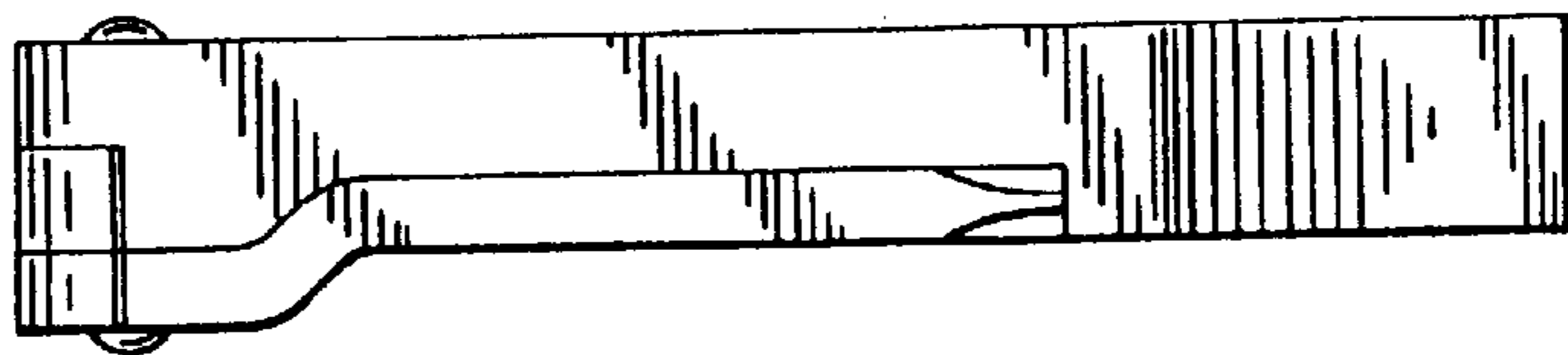

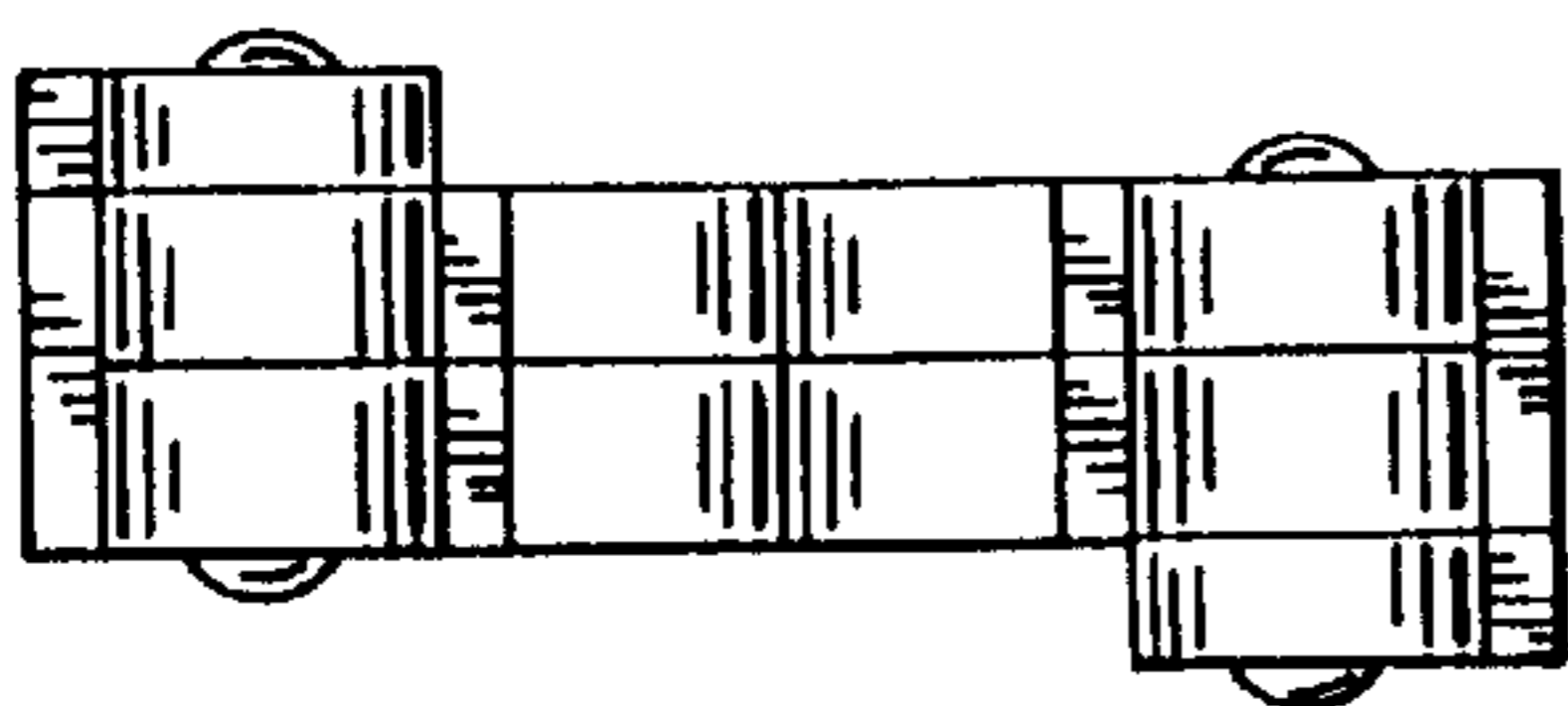
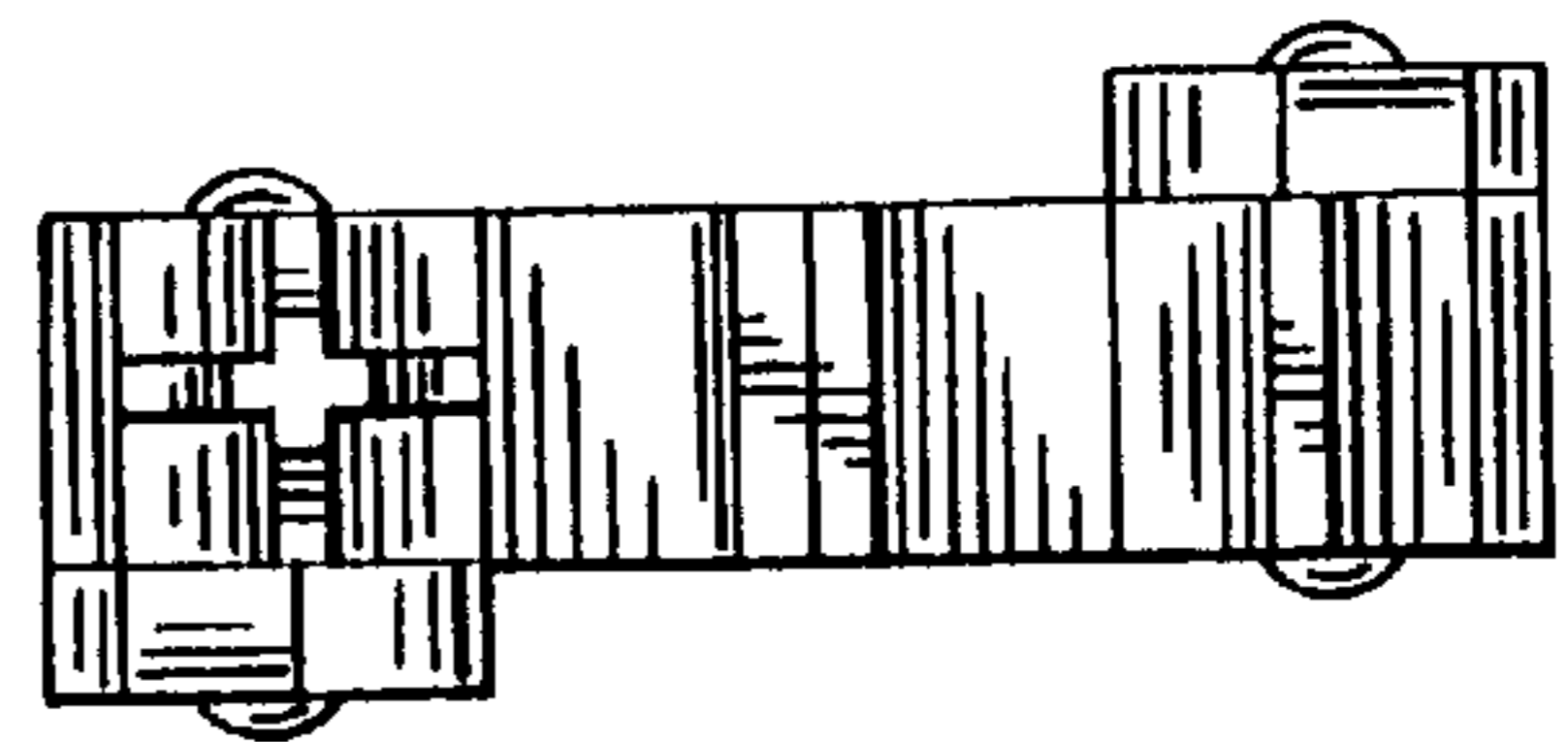

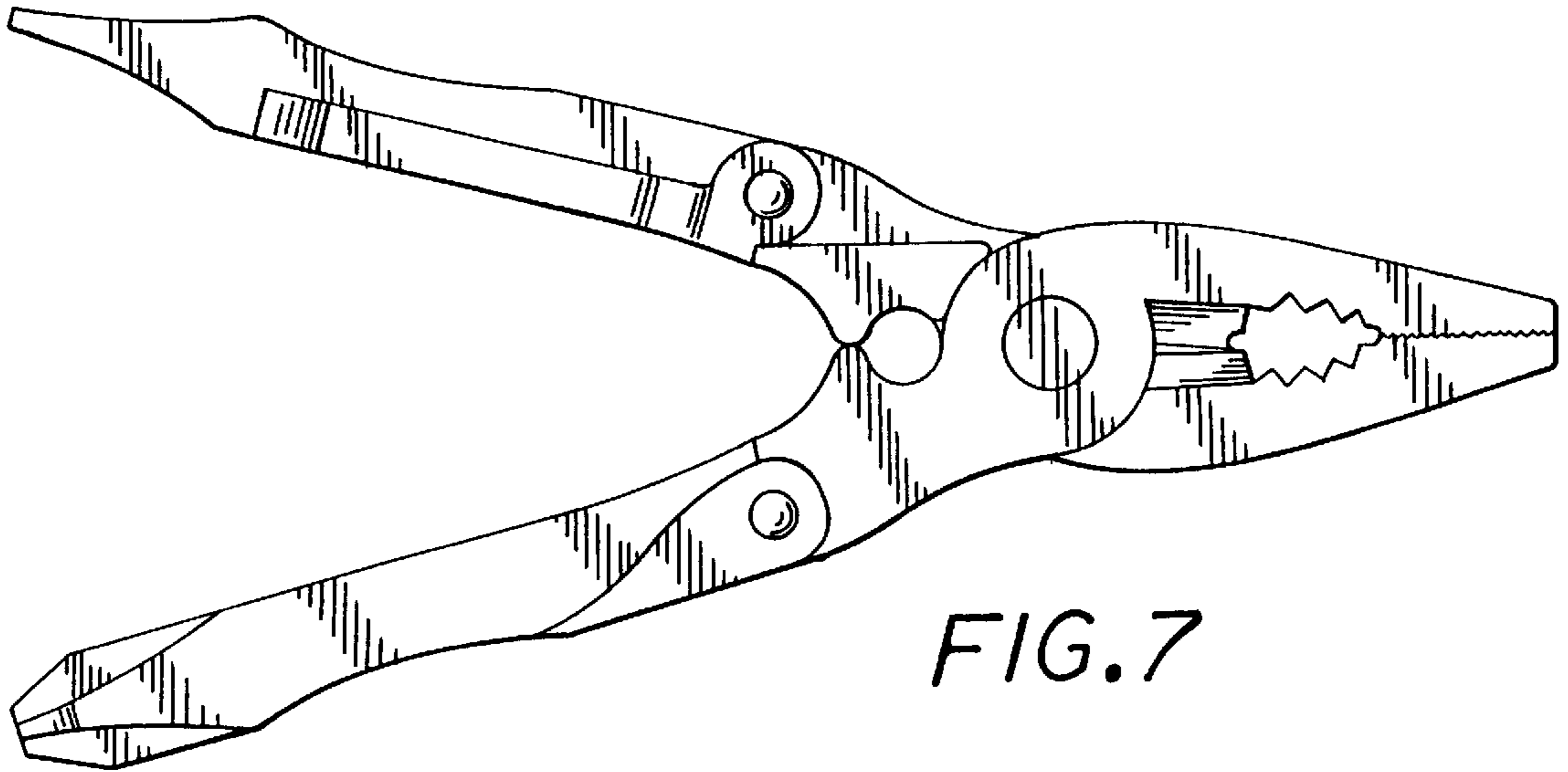

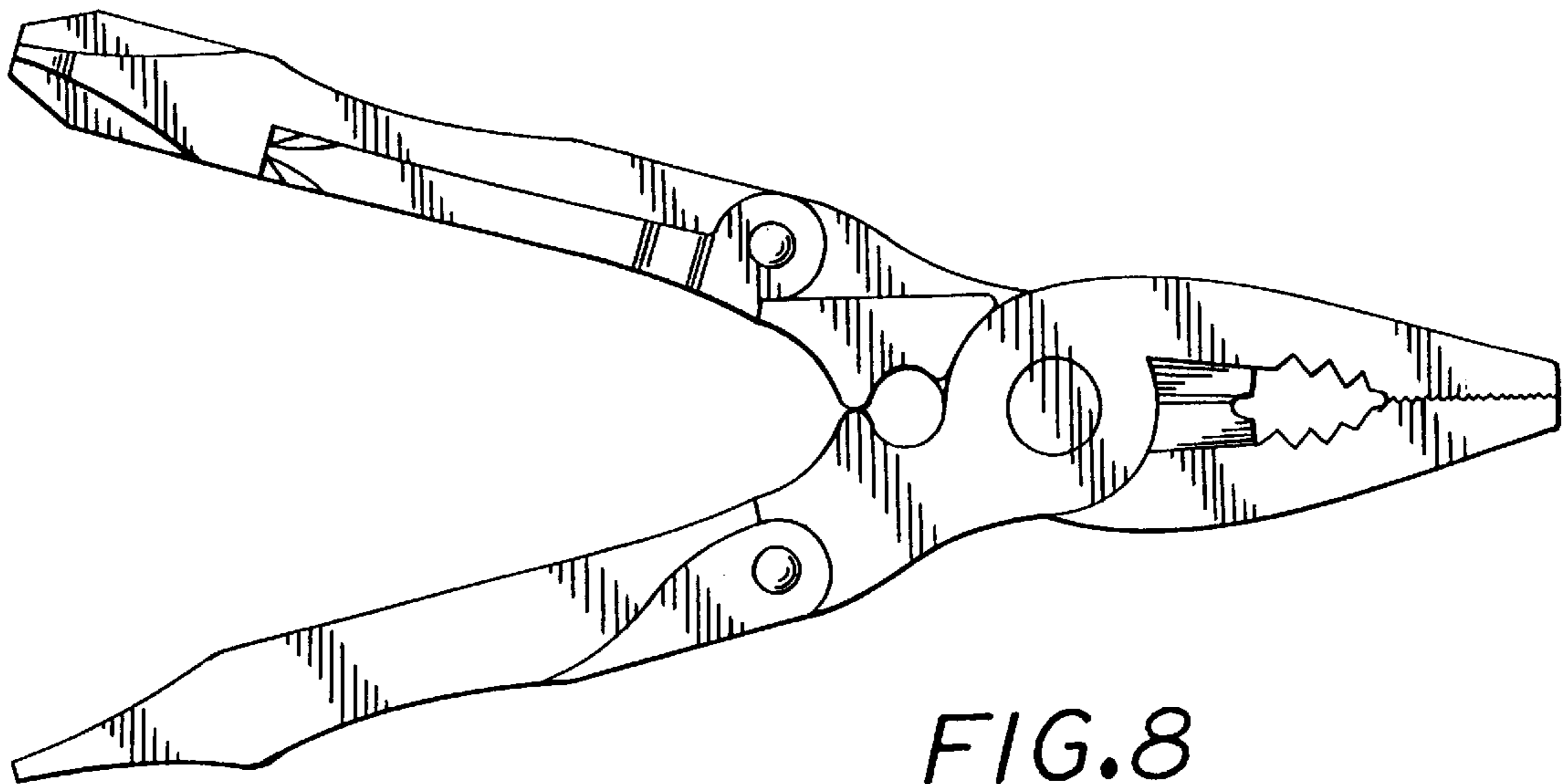

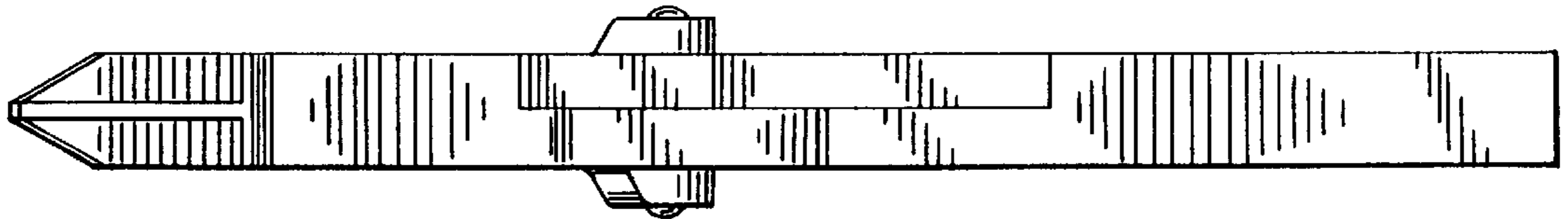

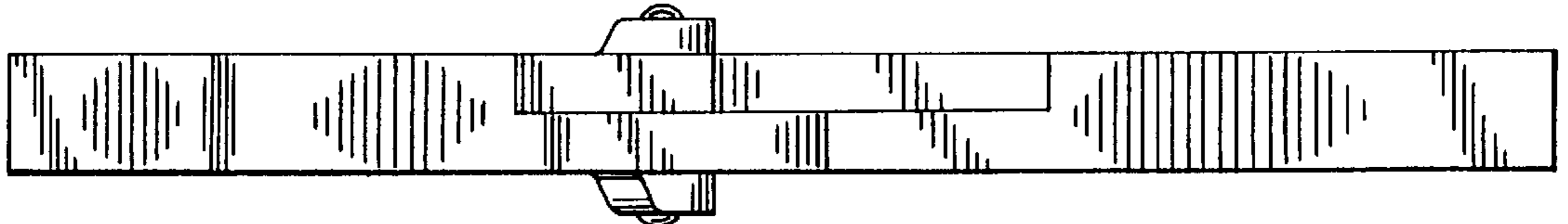

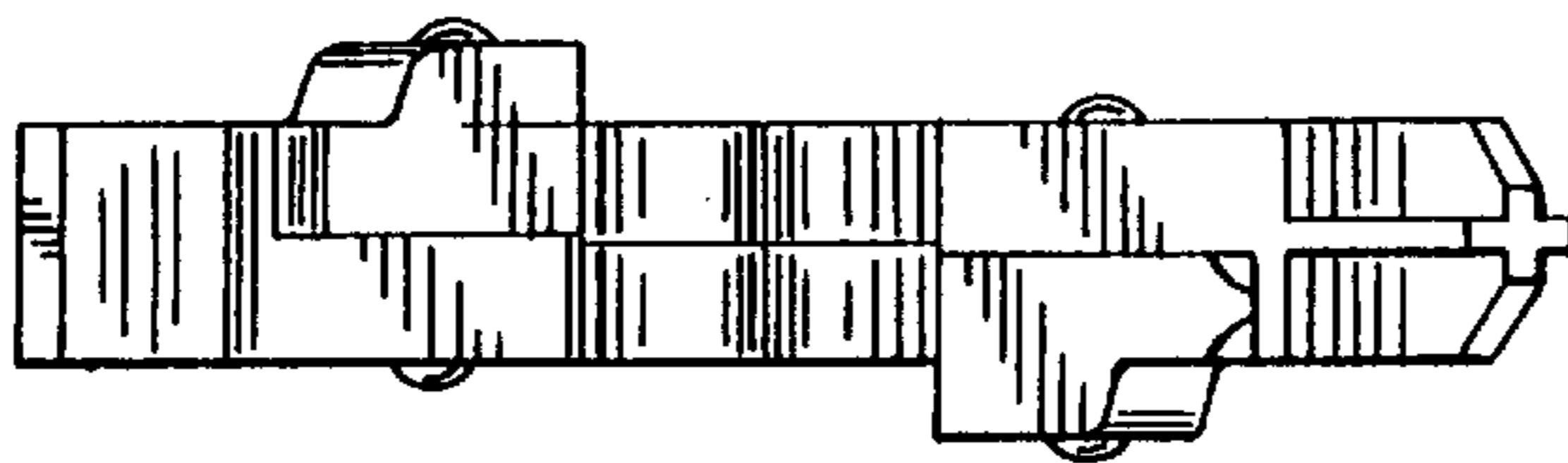

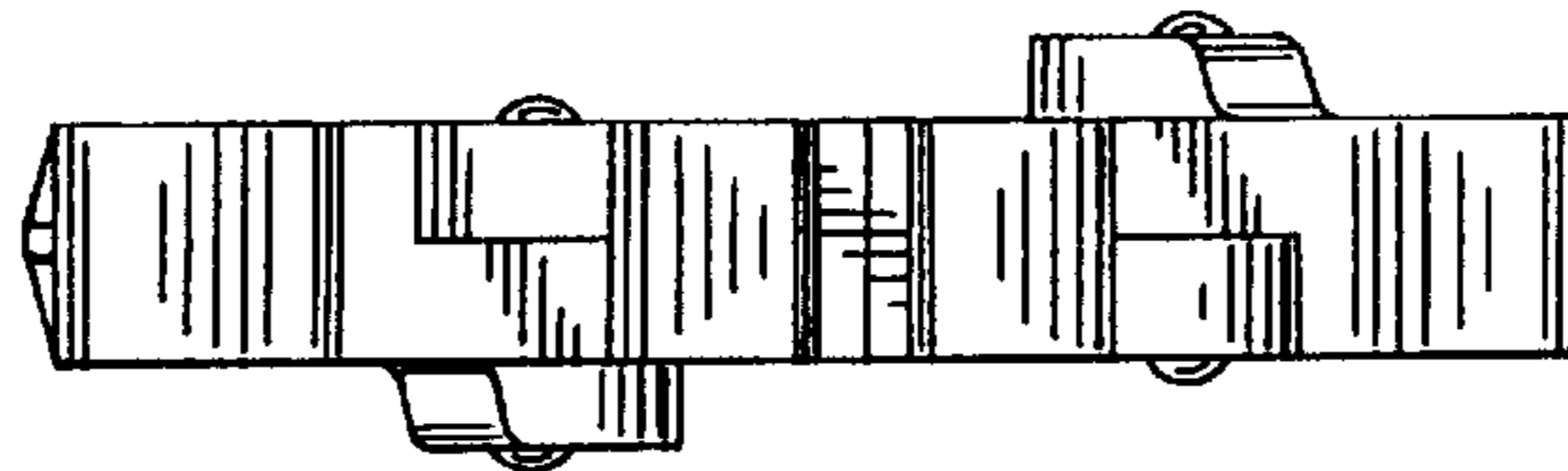
