### DESCRIPTION

FIG. 10 is a left side elevational view thereof;

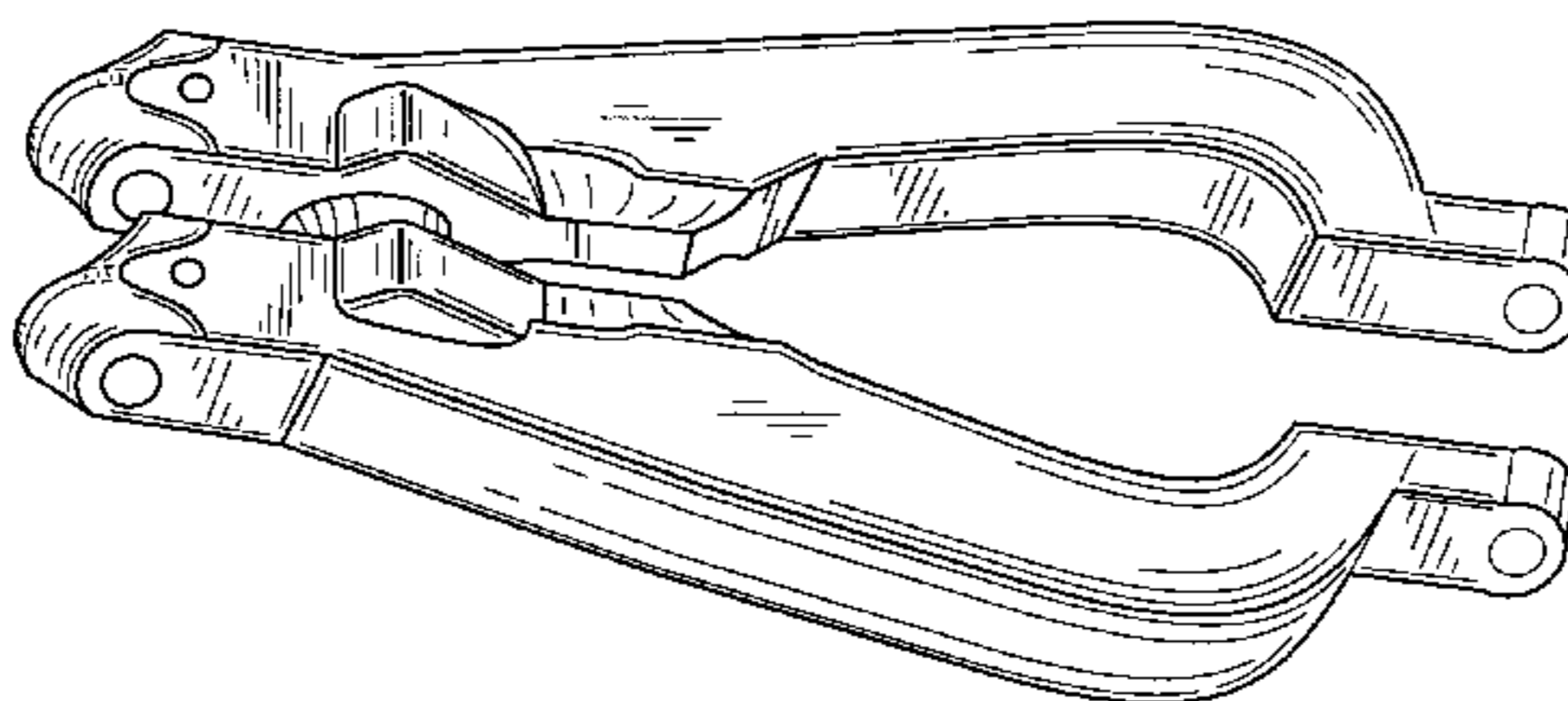
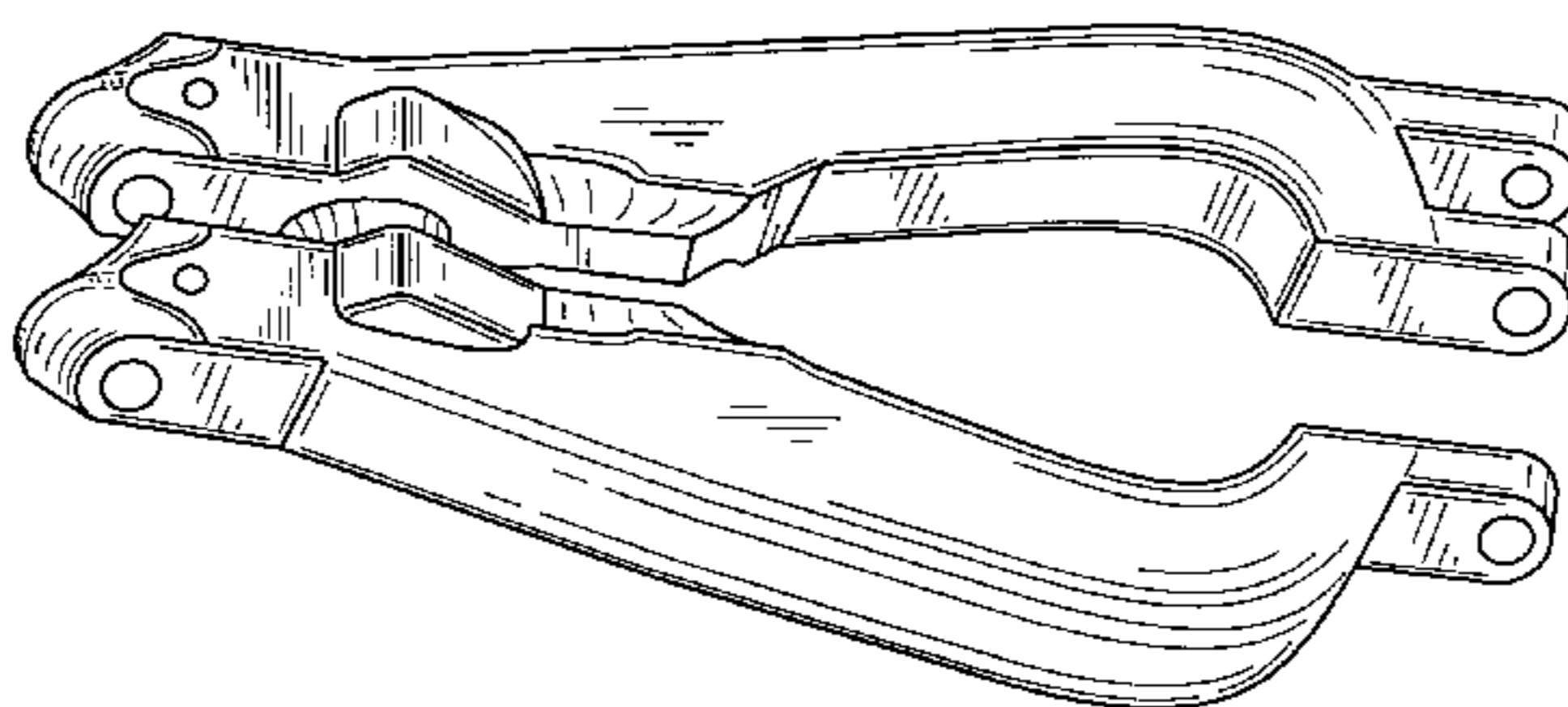
FIG. 11 is a top plan view thereof;

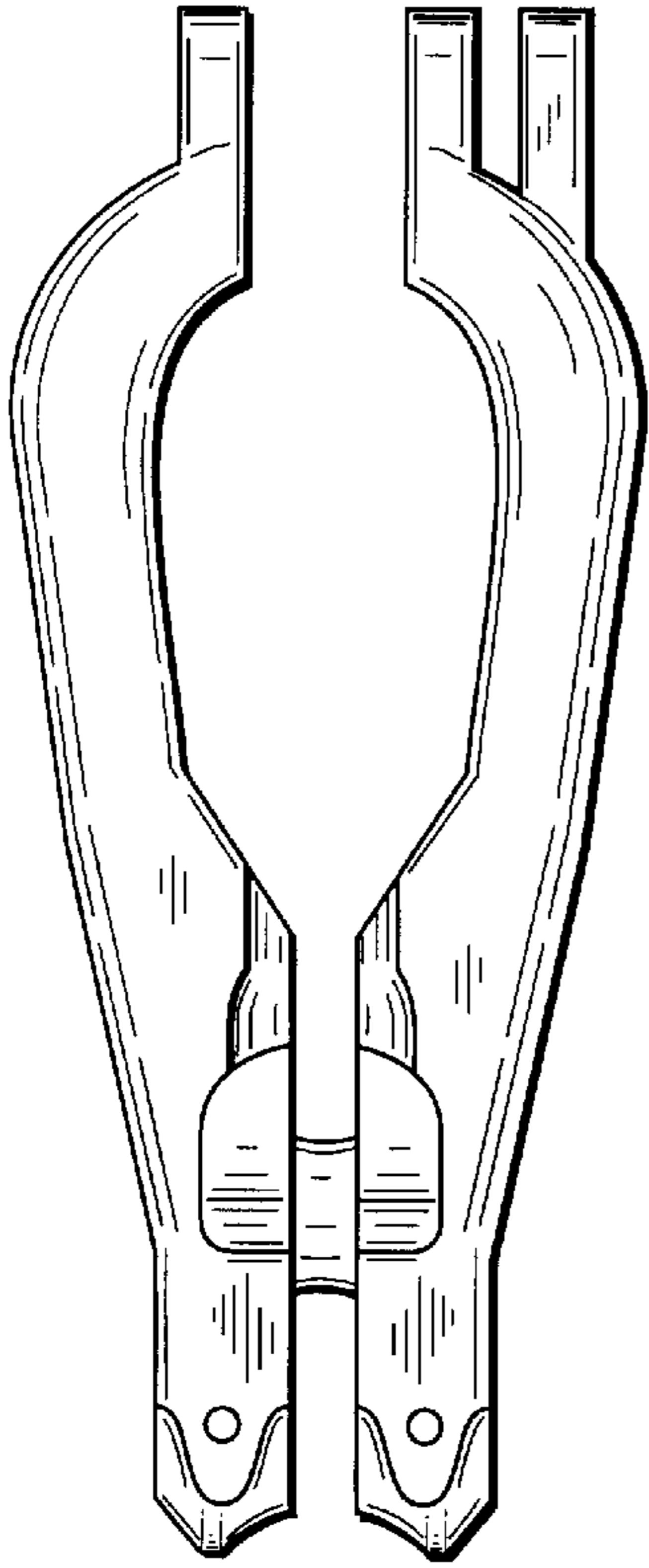
FIG. 12 is a bottom plan view thereof;

FIG. 13 is a right side elevational view thereof; and,

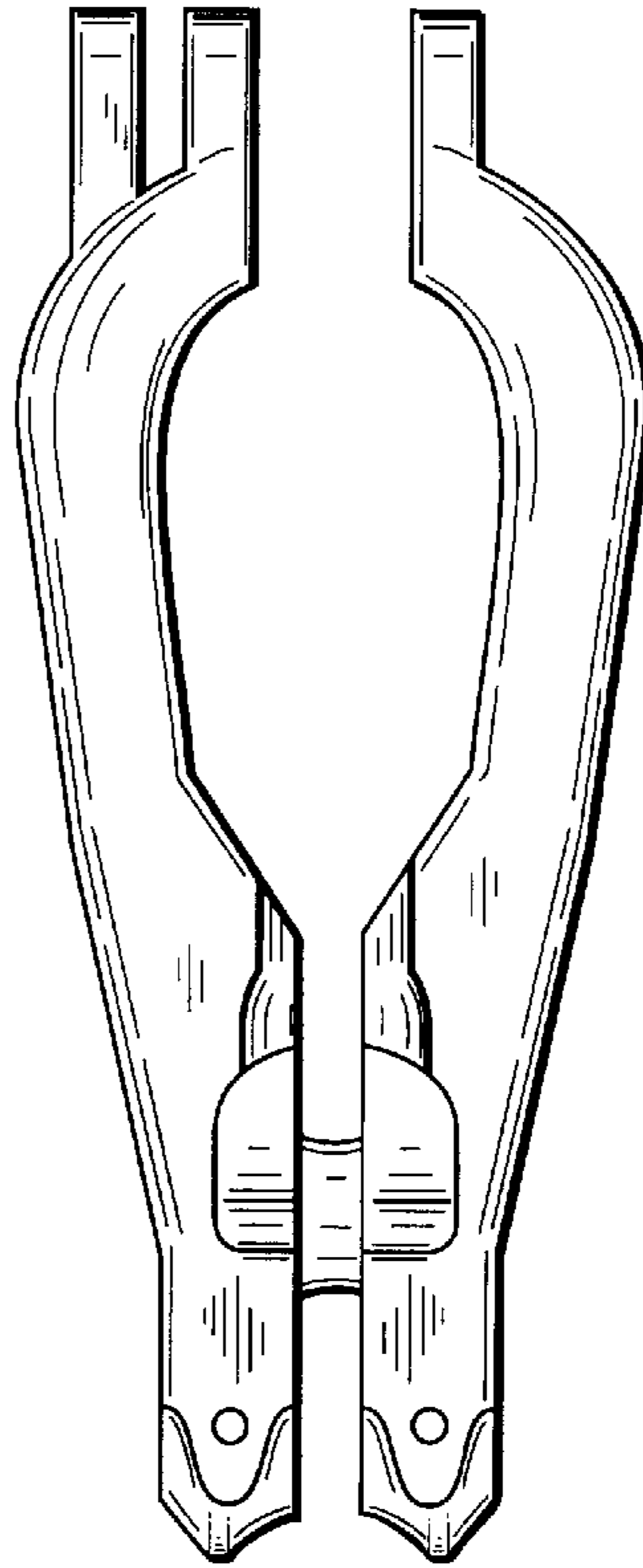
FIG. 14 is an isometric view of the embodiment illustrated in FIGS. 7-12.

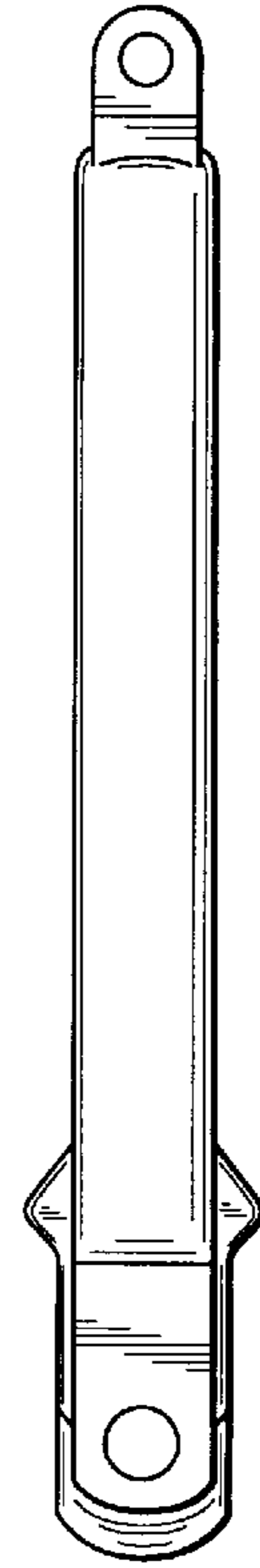




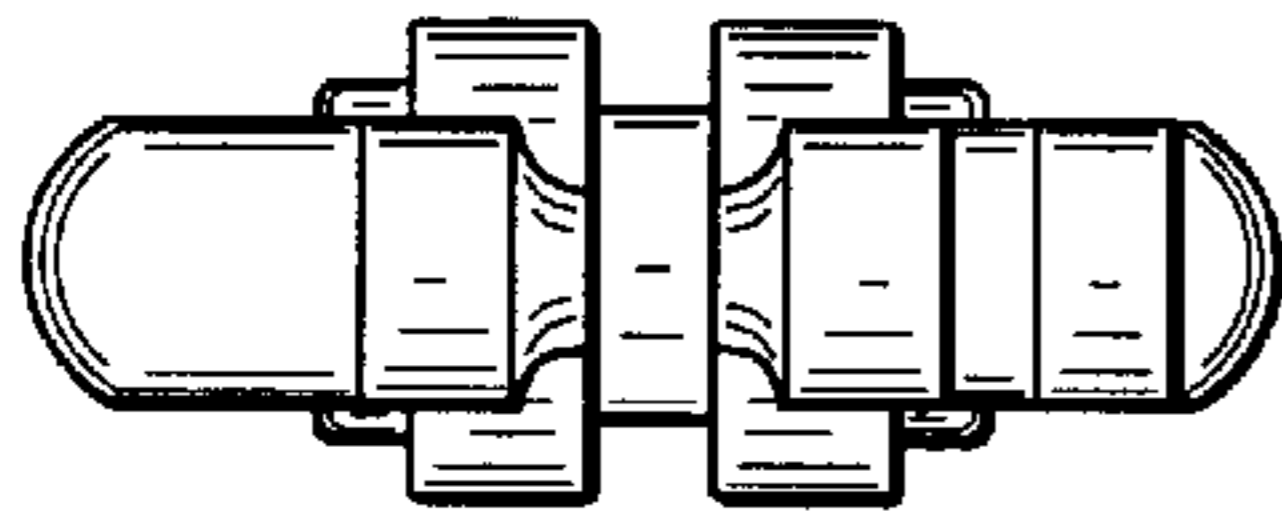

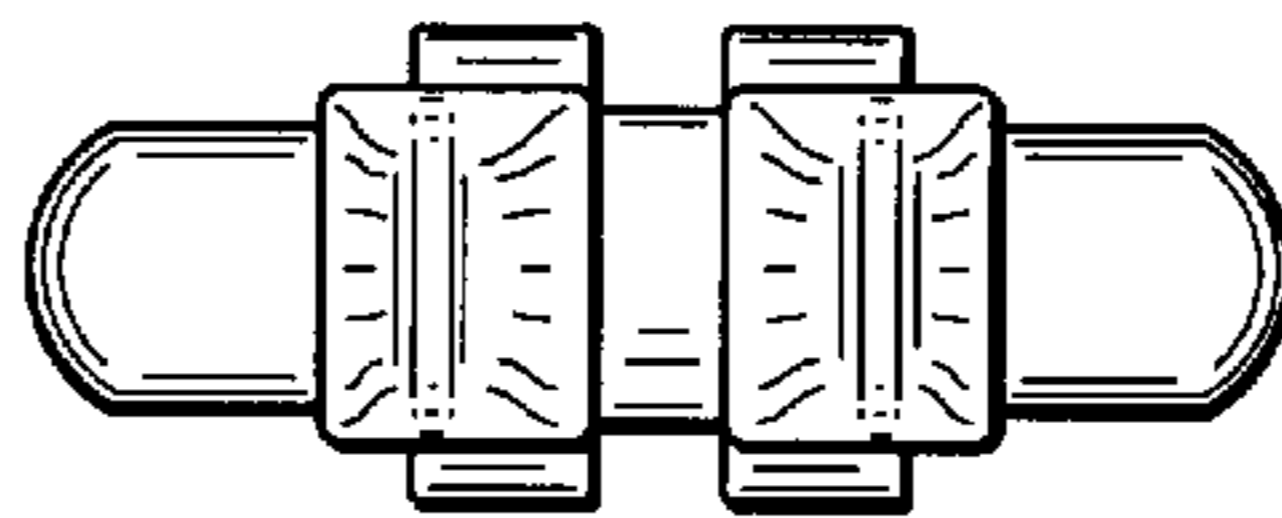

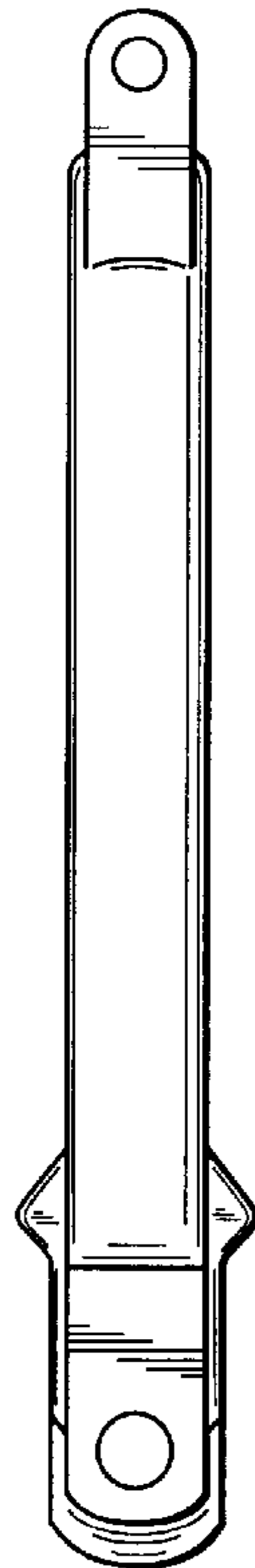

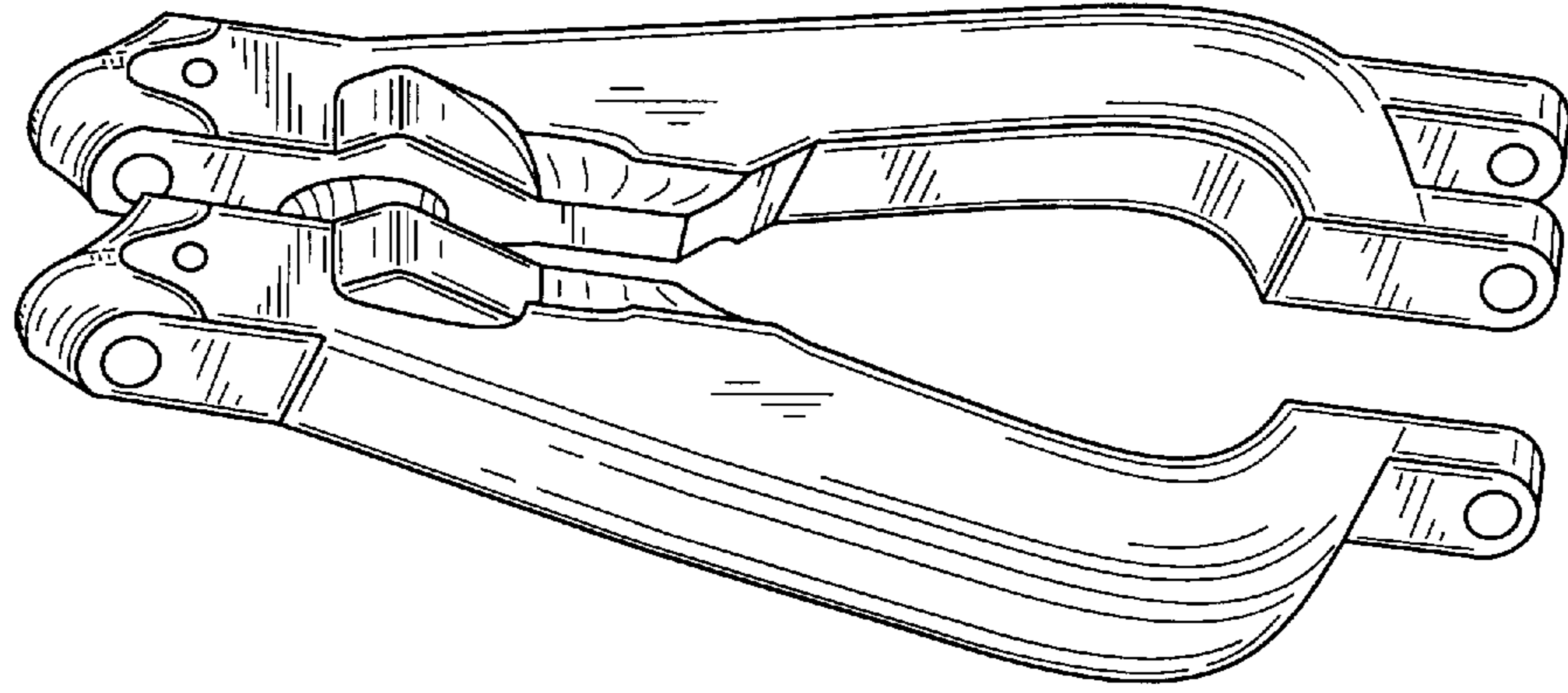

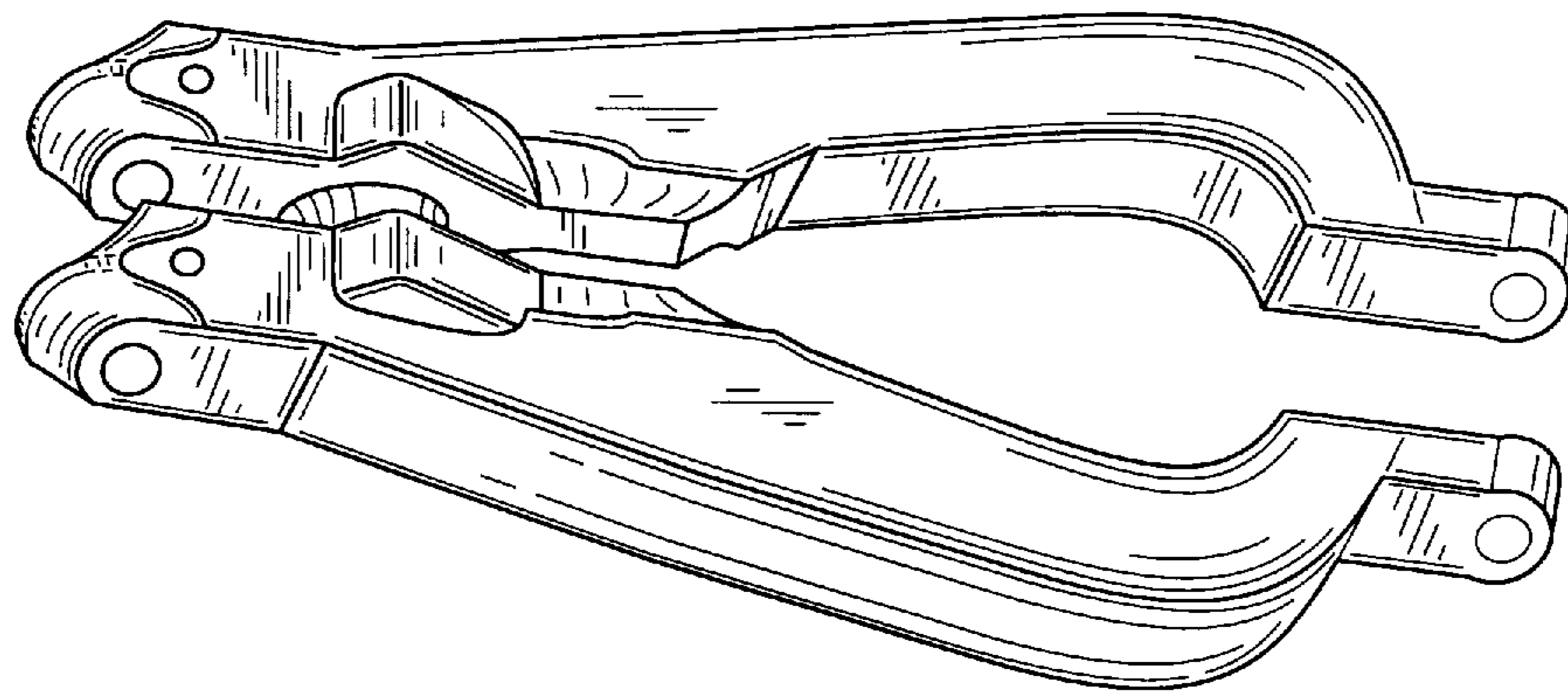

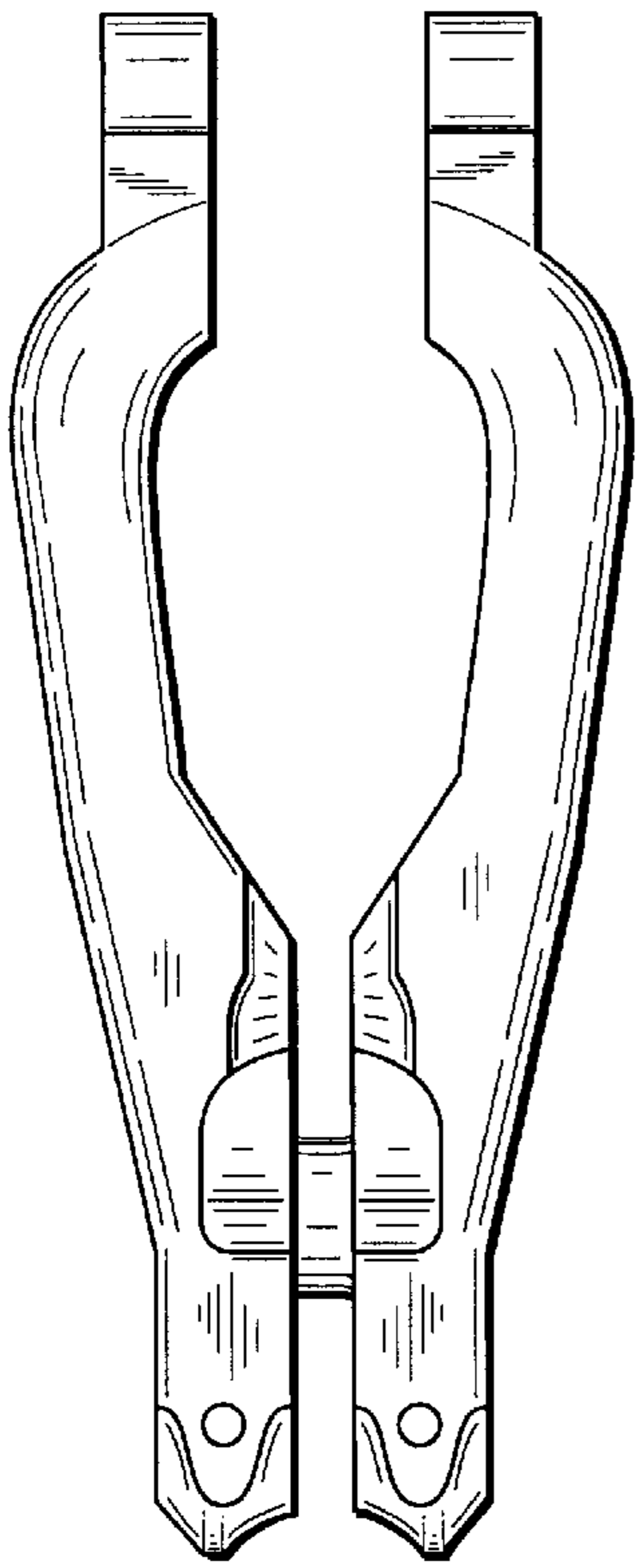

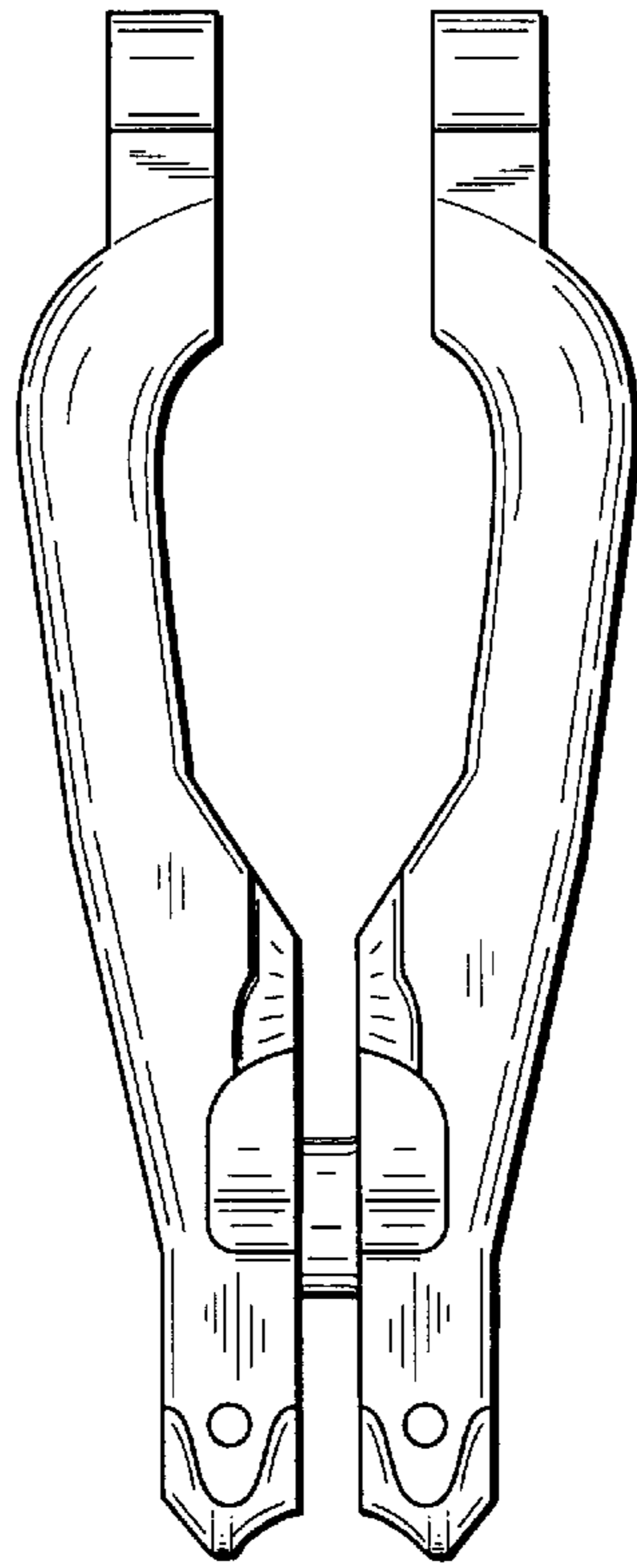

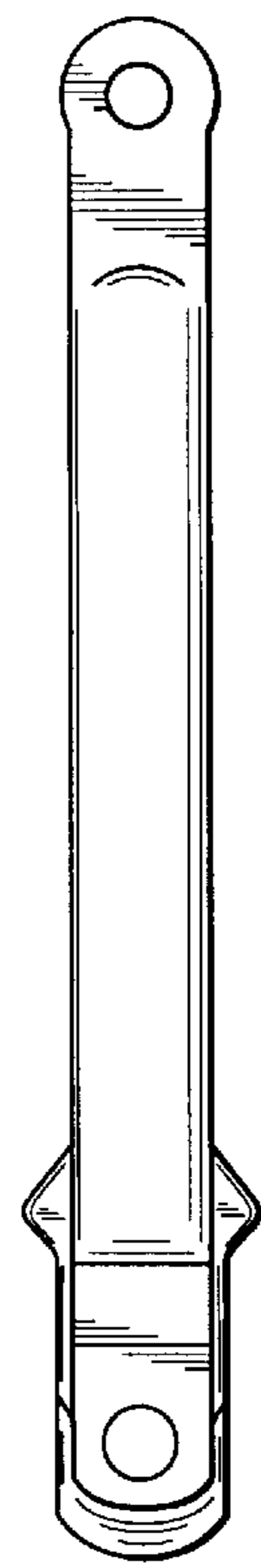

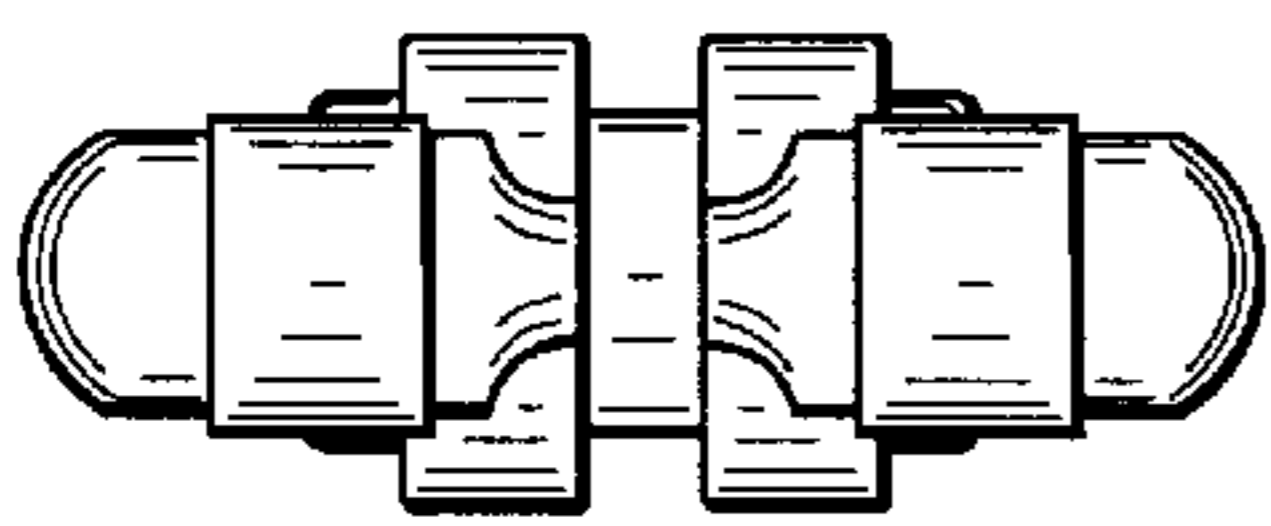

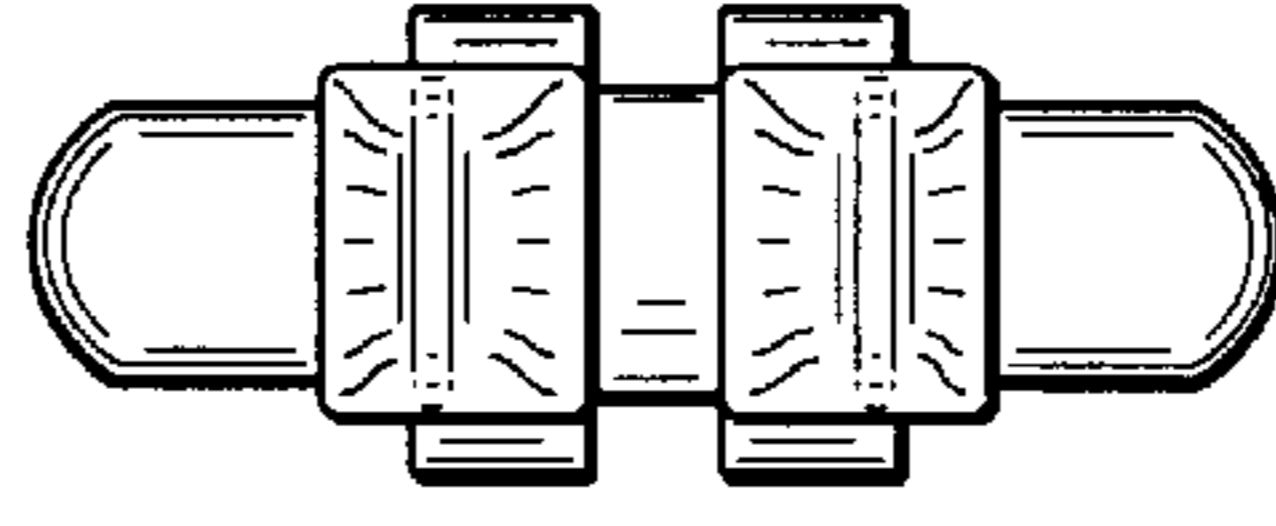

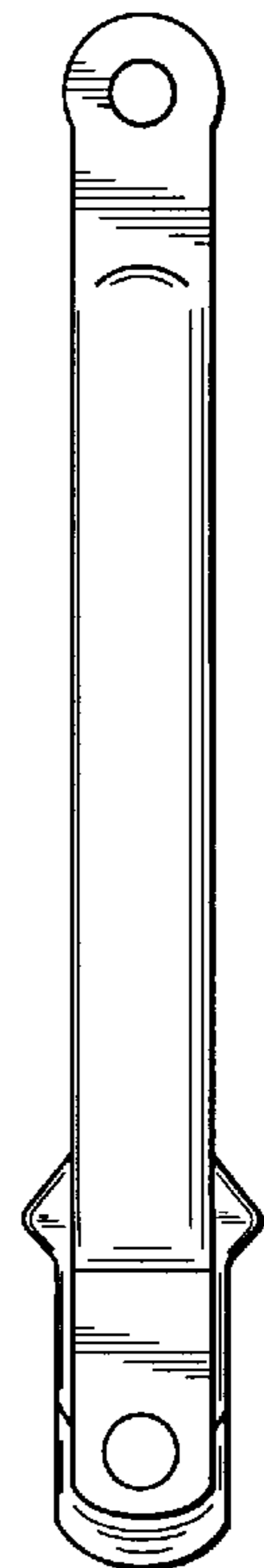
