The ornamental design for a container package for solid ink, as shown and described.

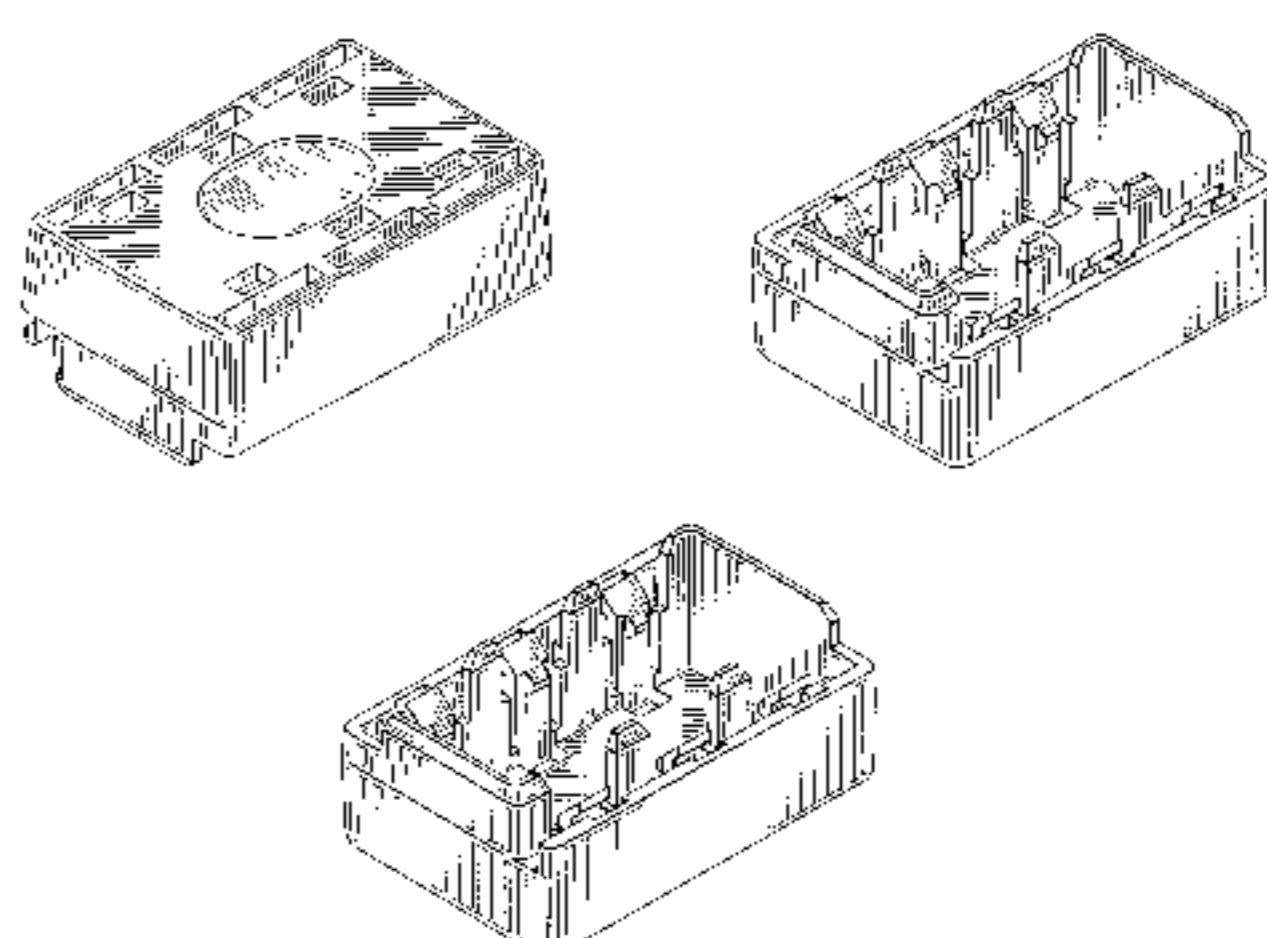
DESCRIPTION

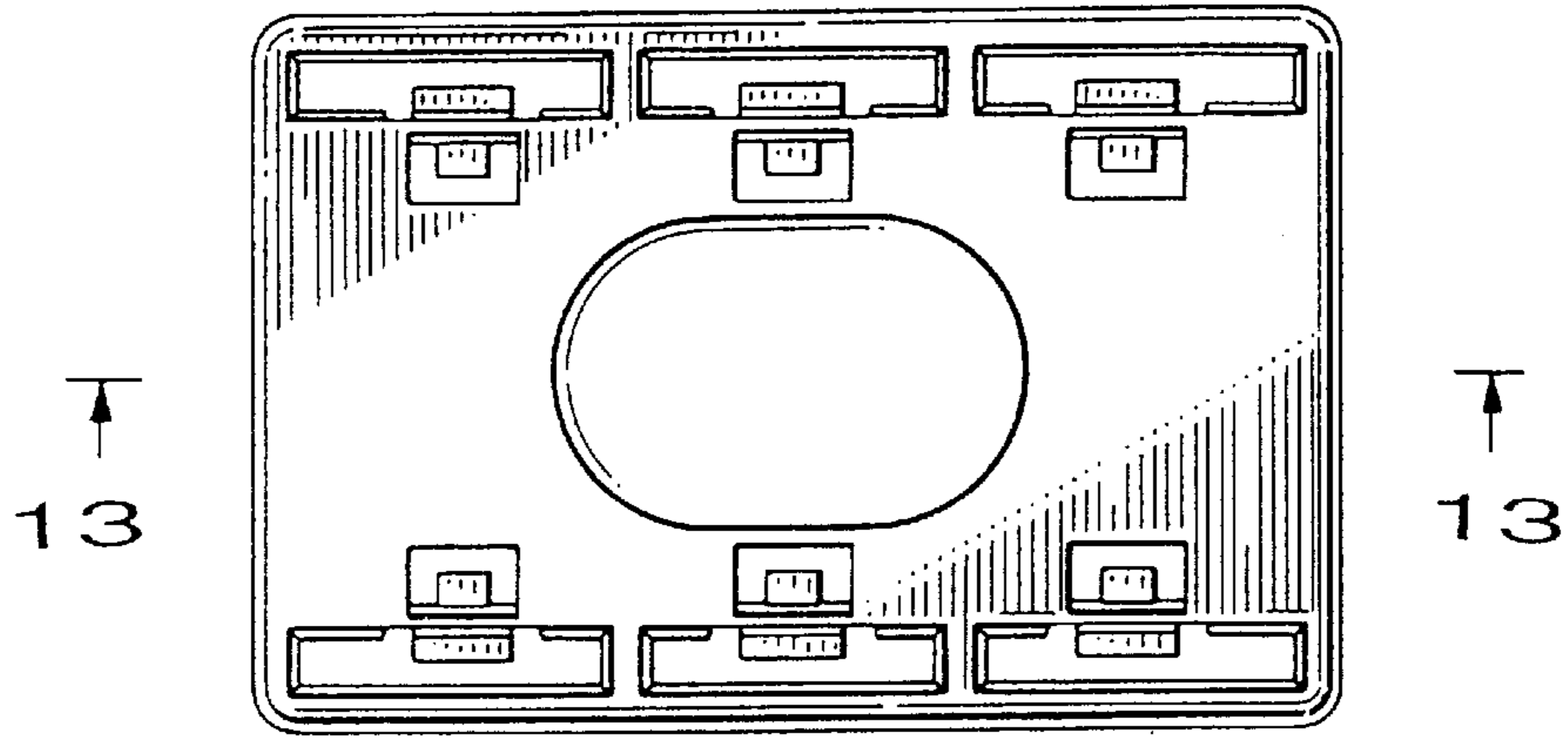

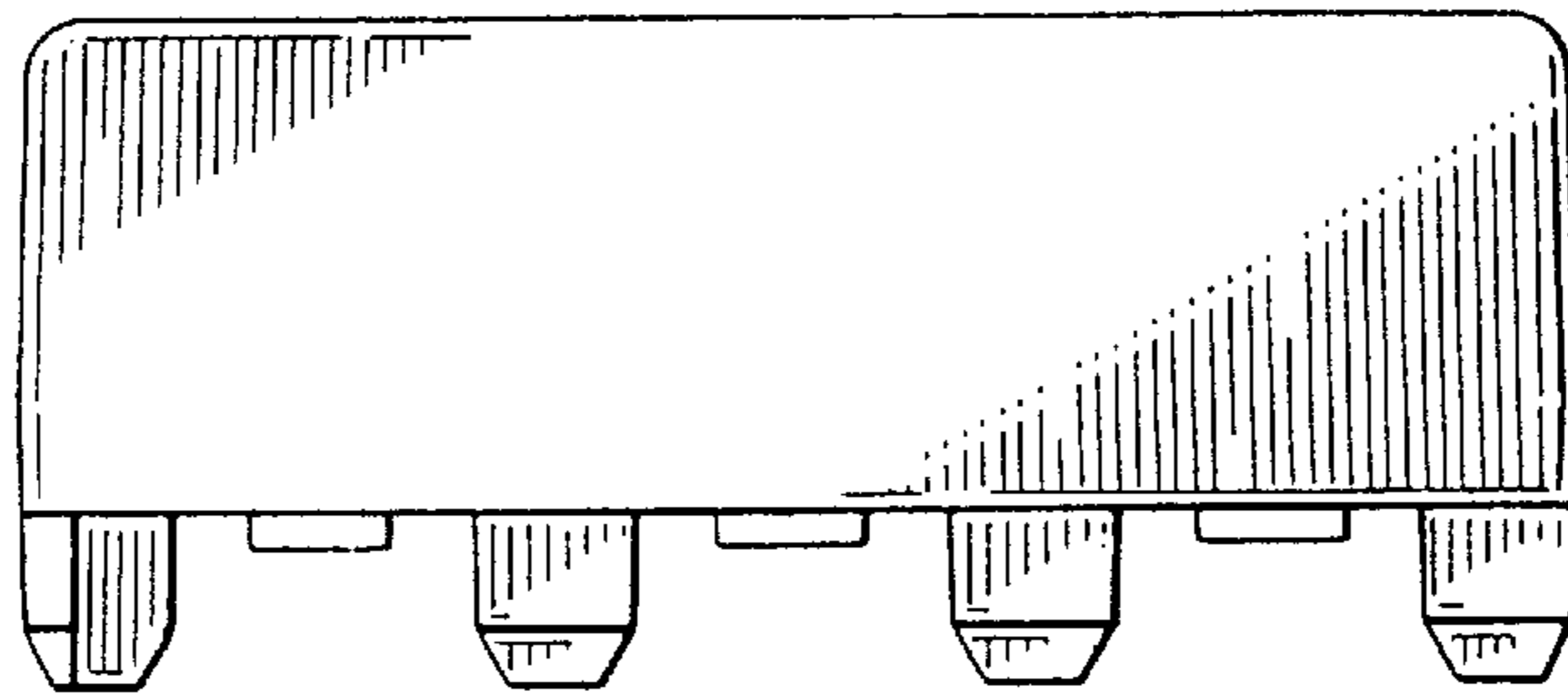

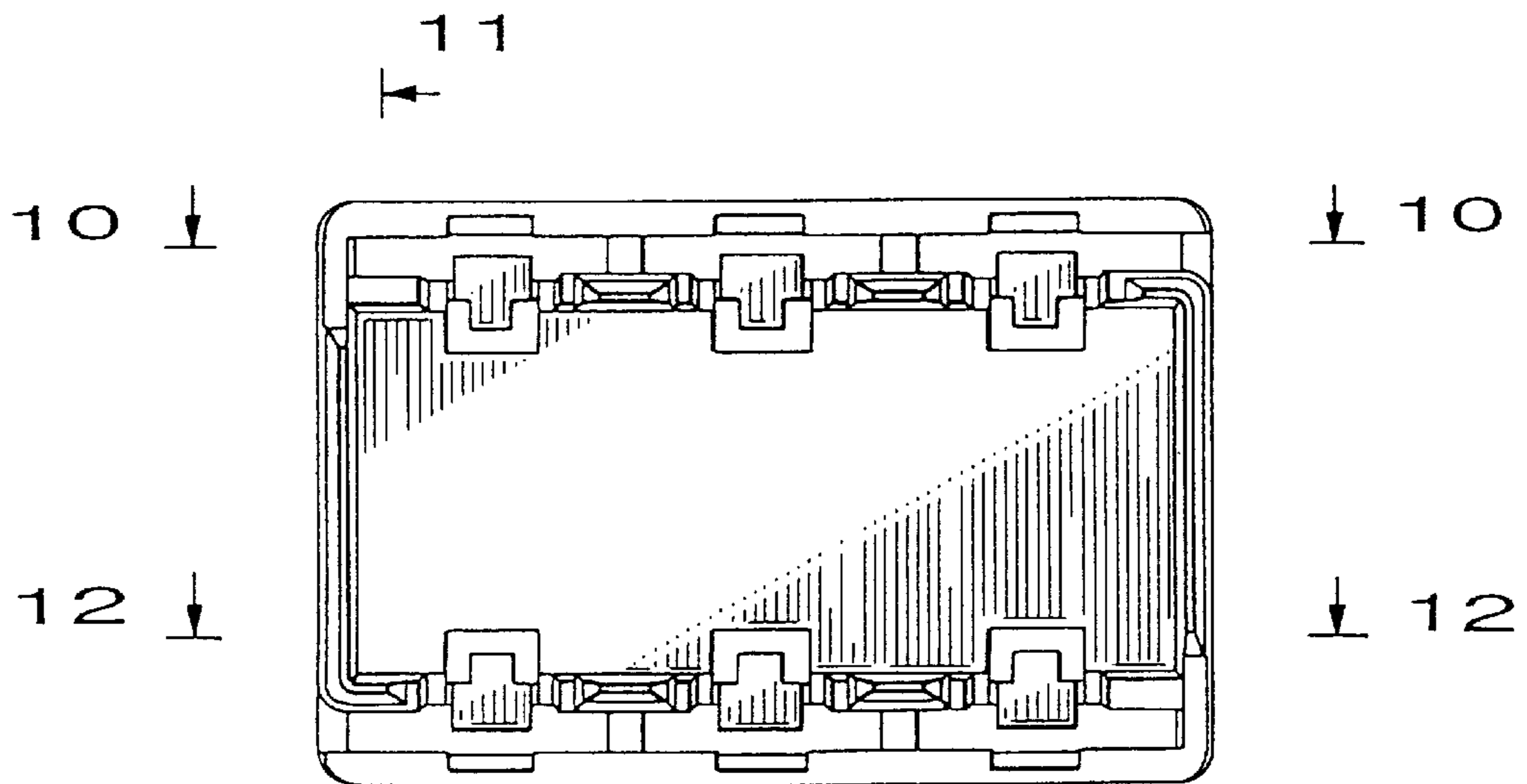

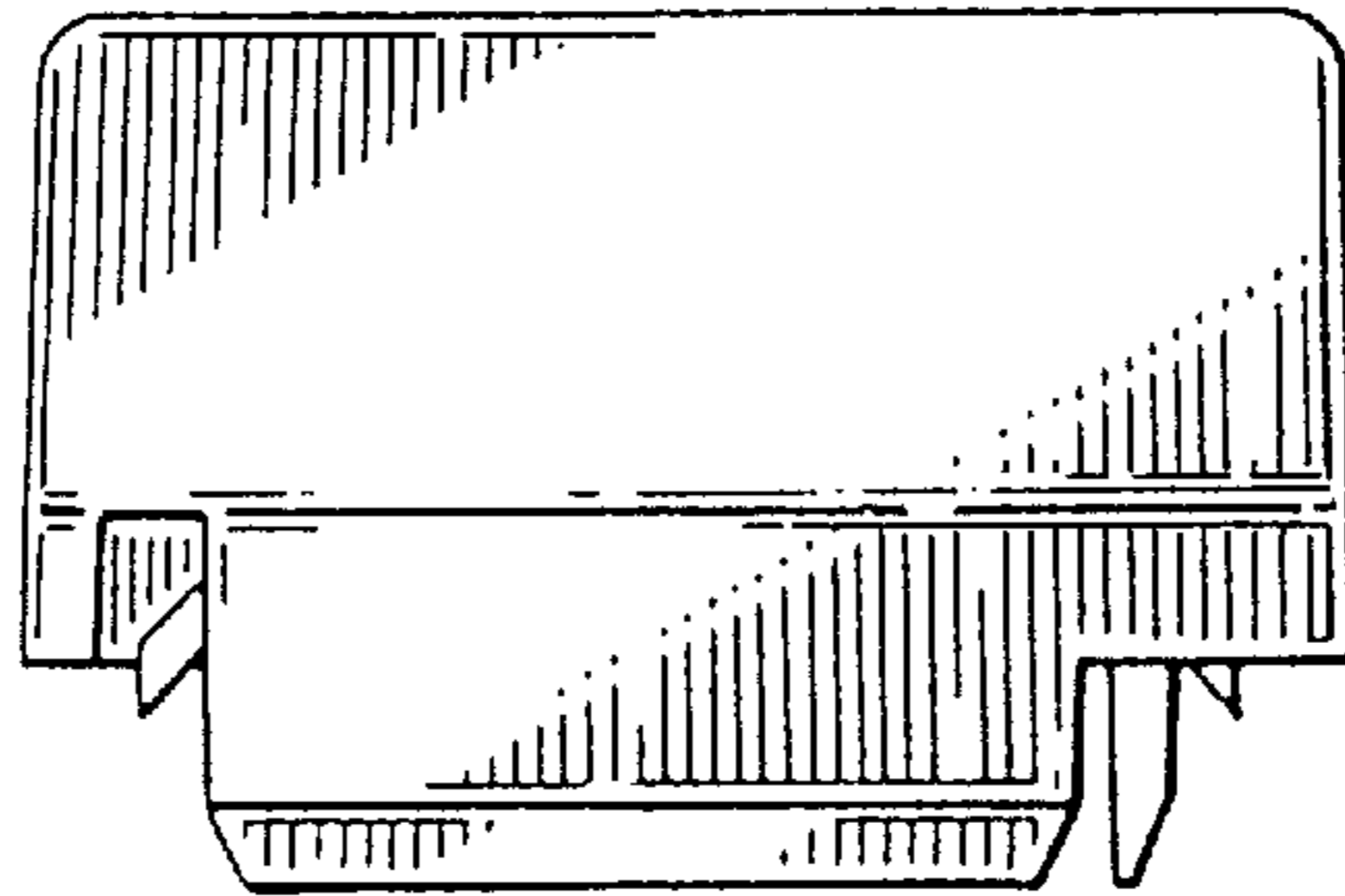

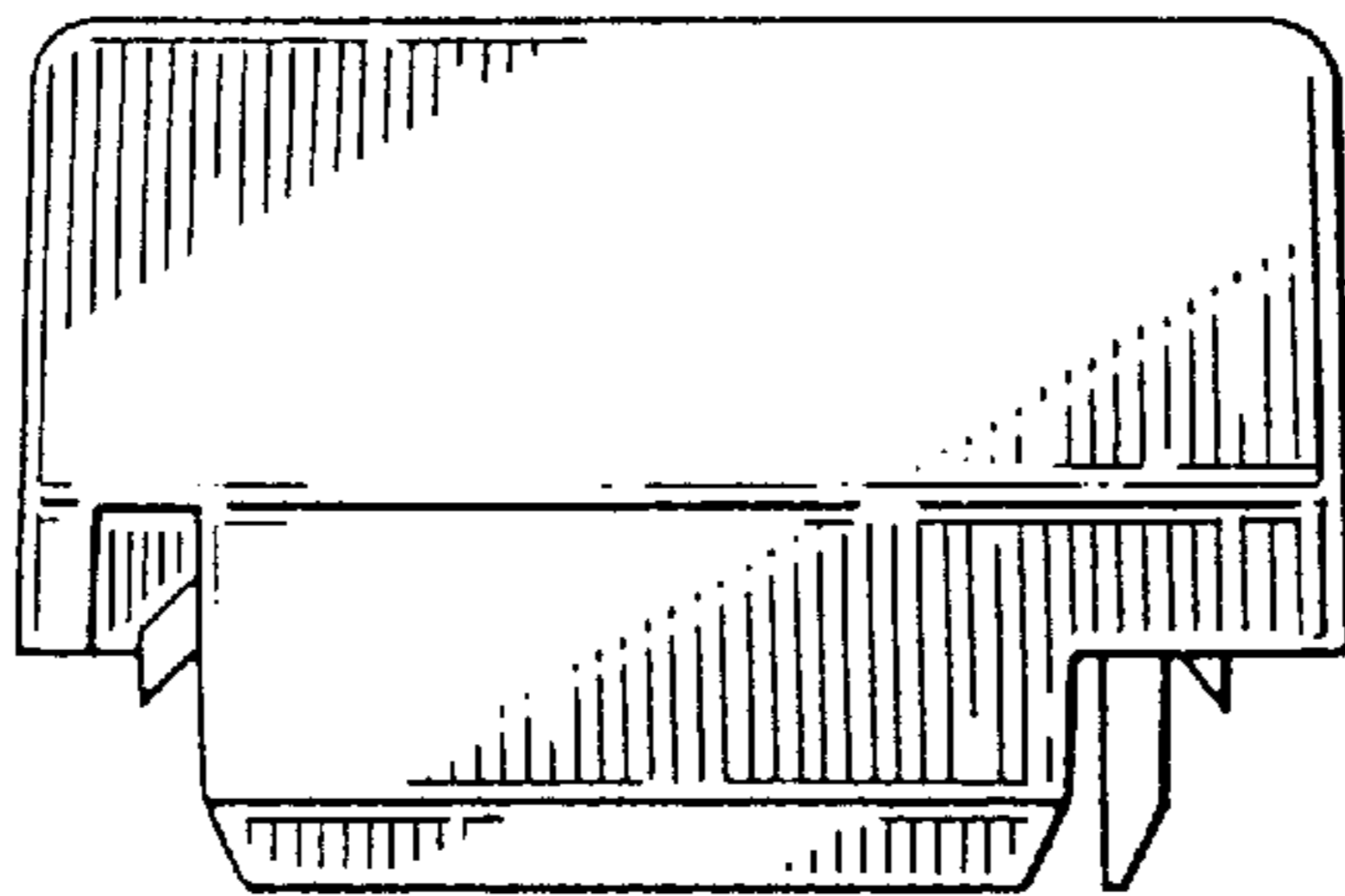

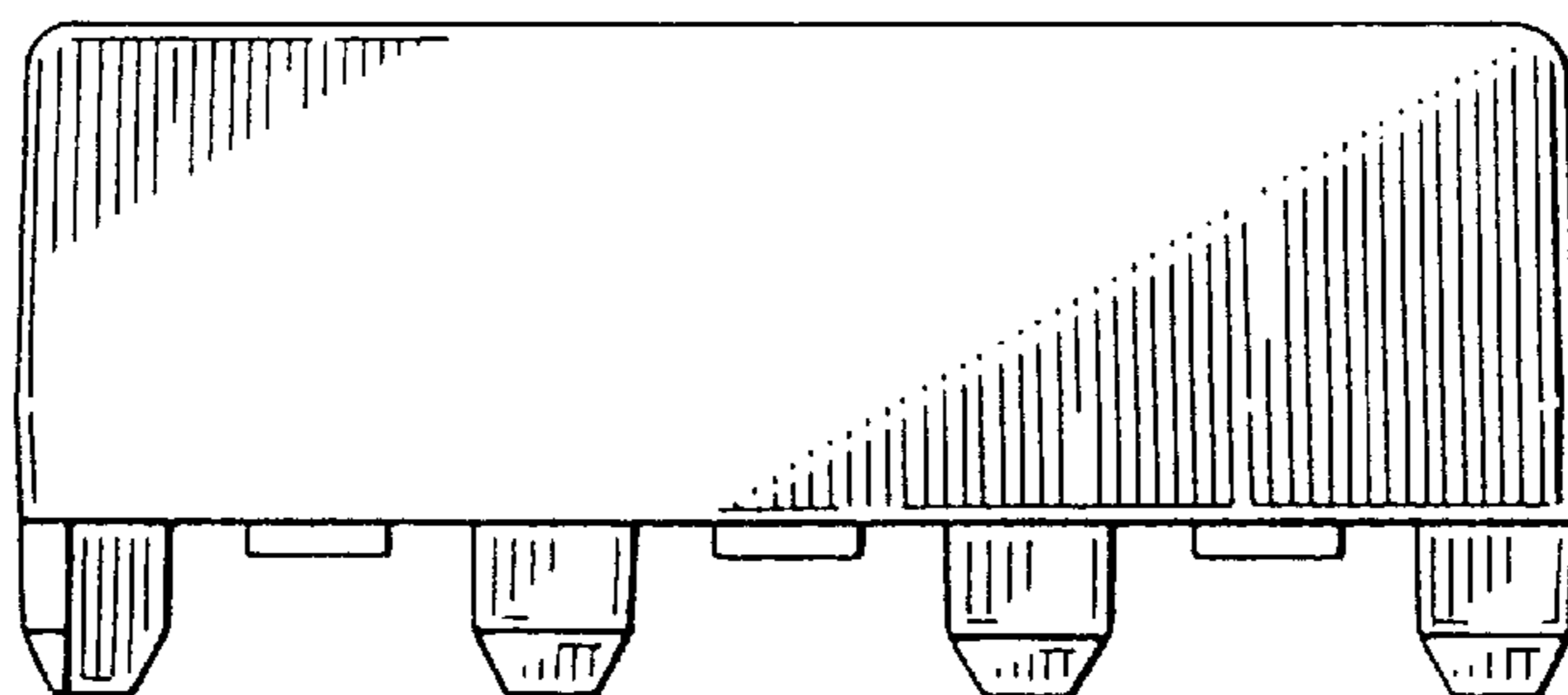

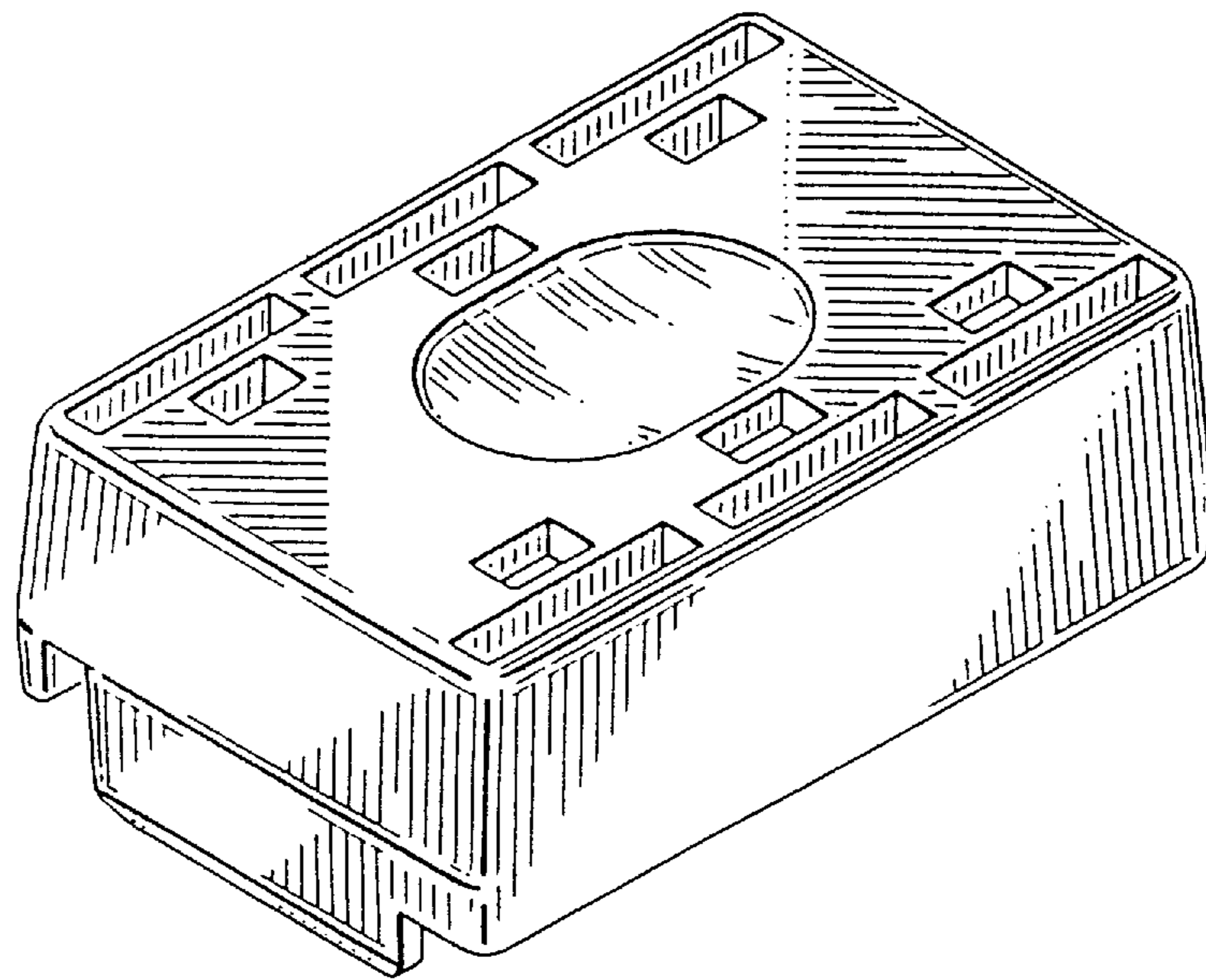

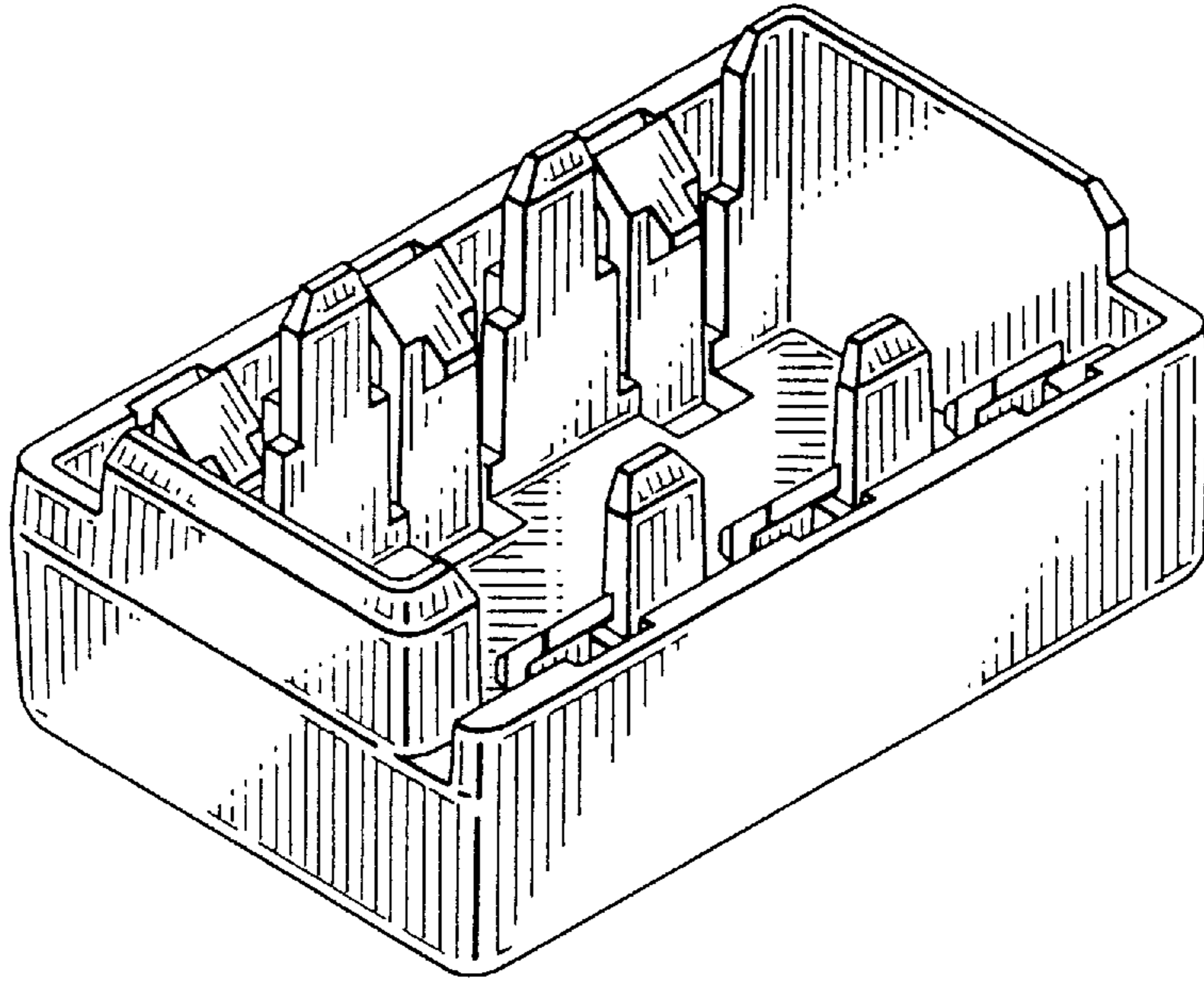

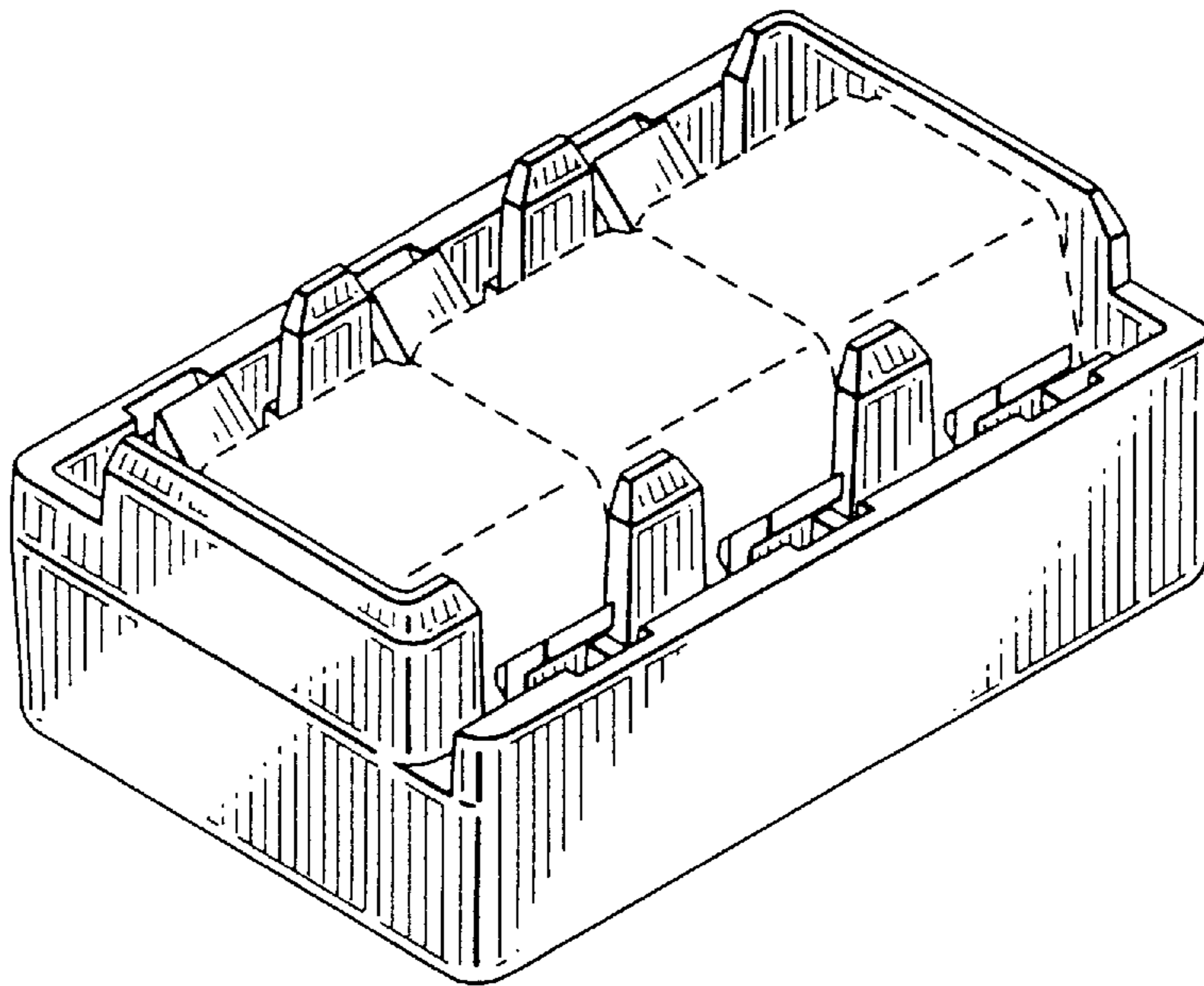

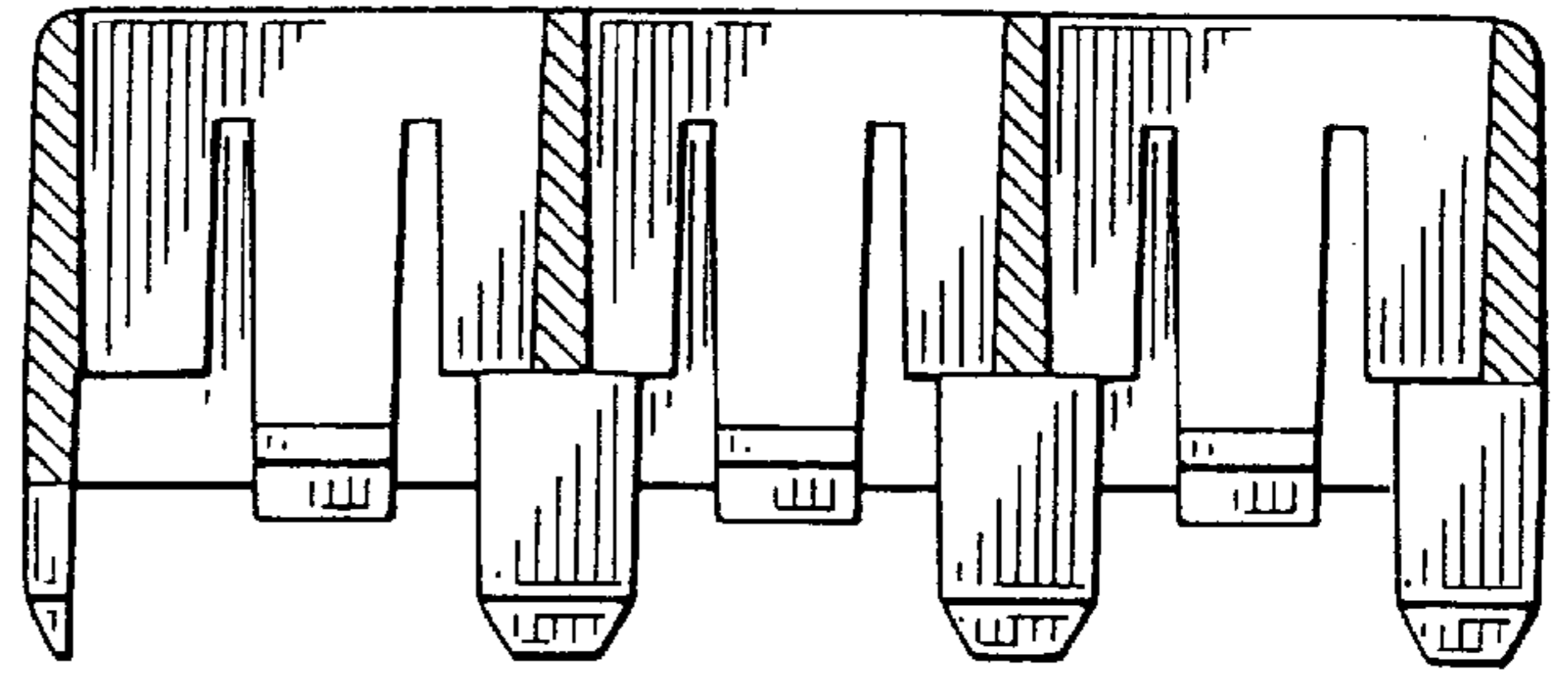

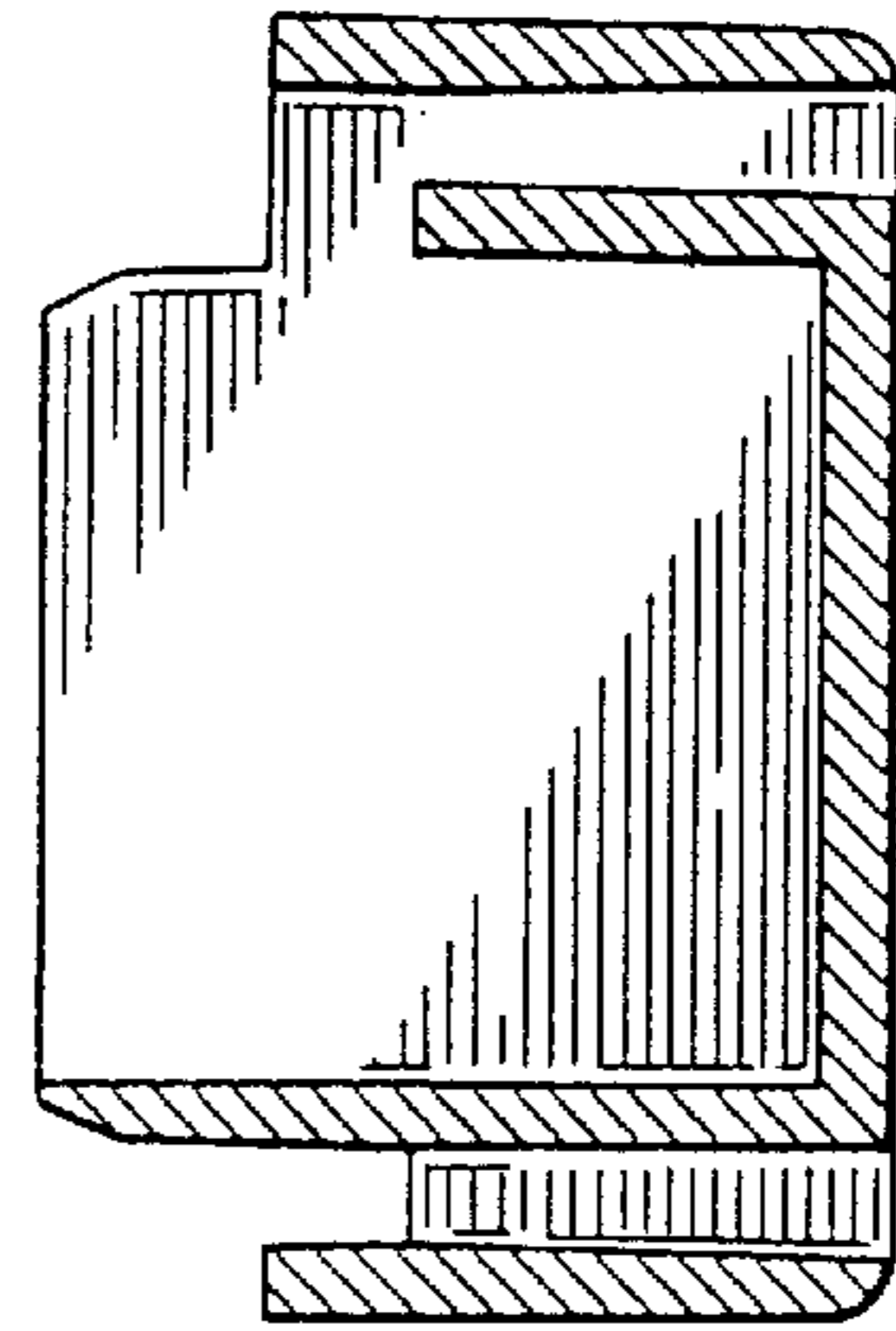

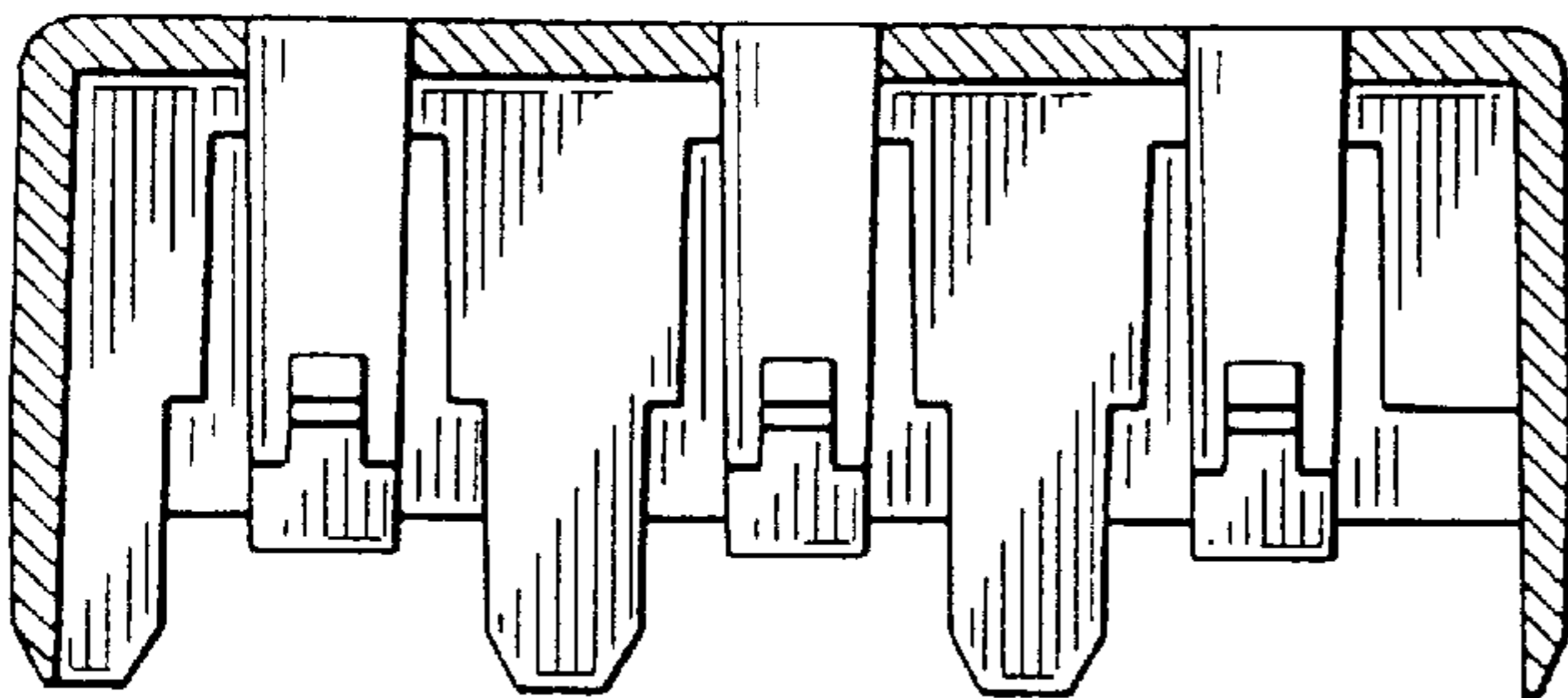

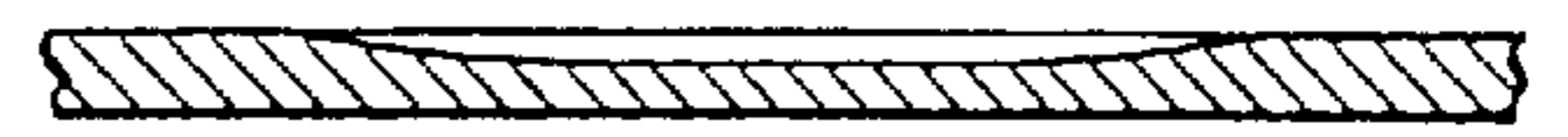

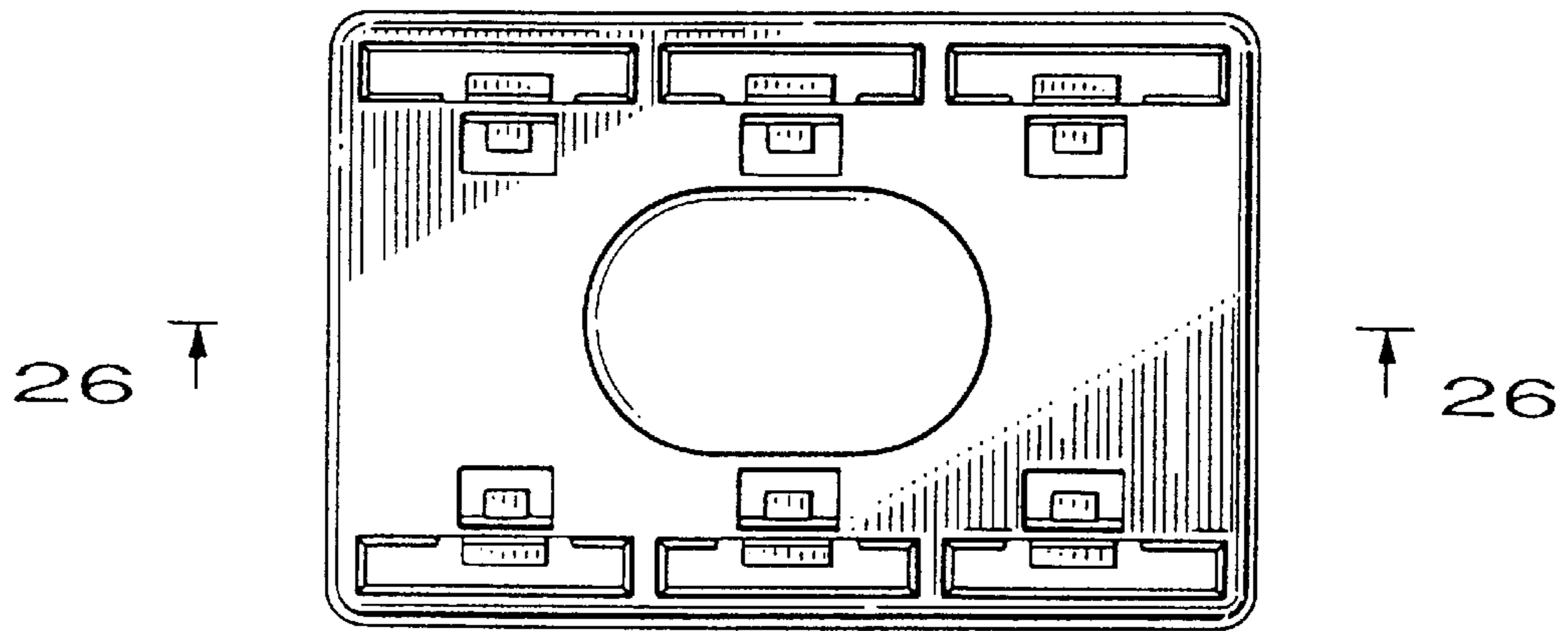

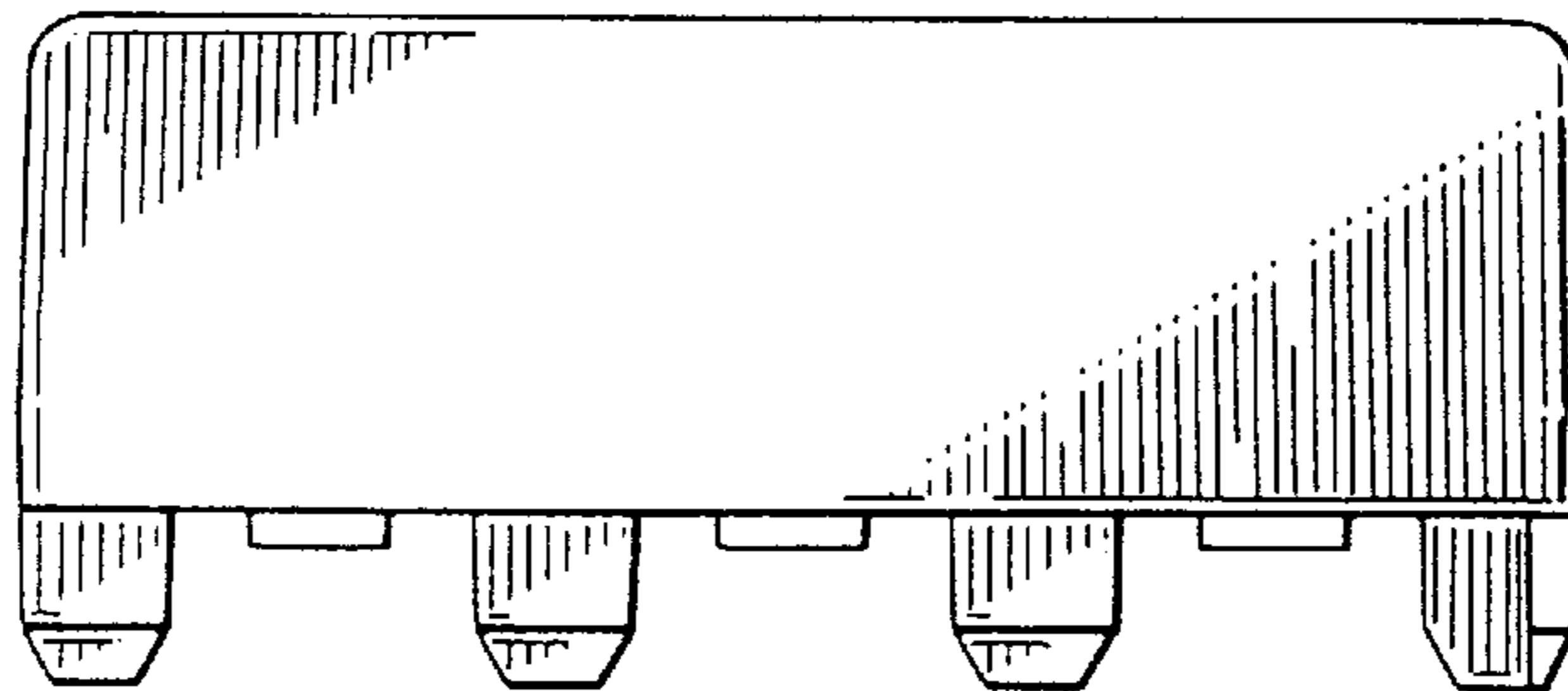

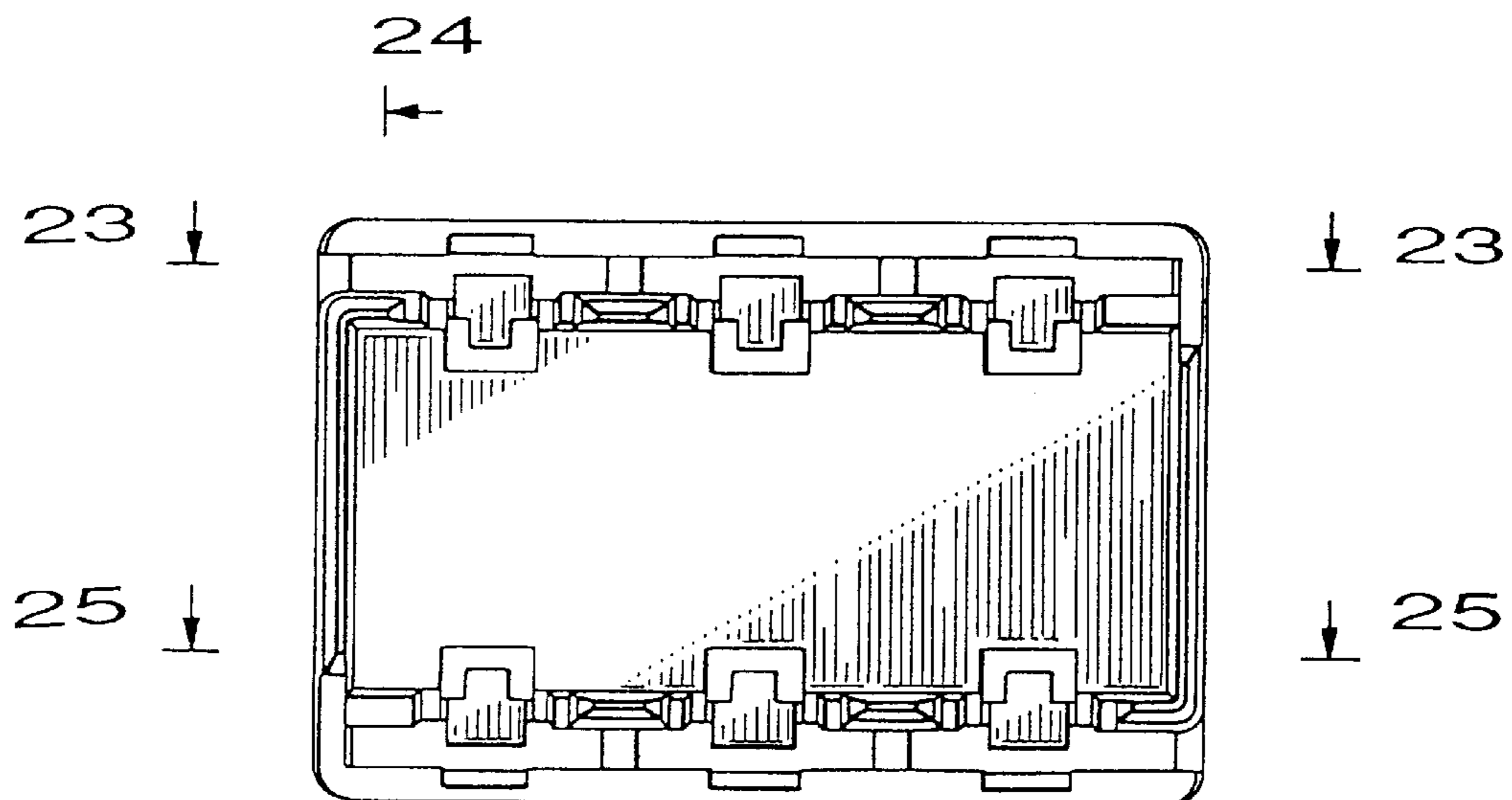

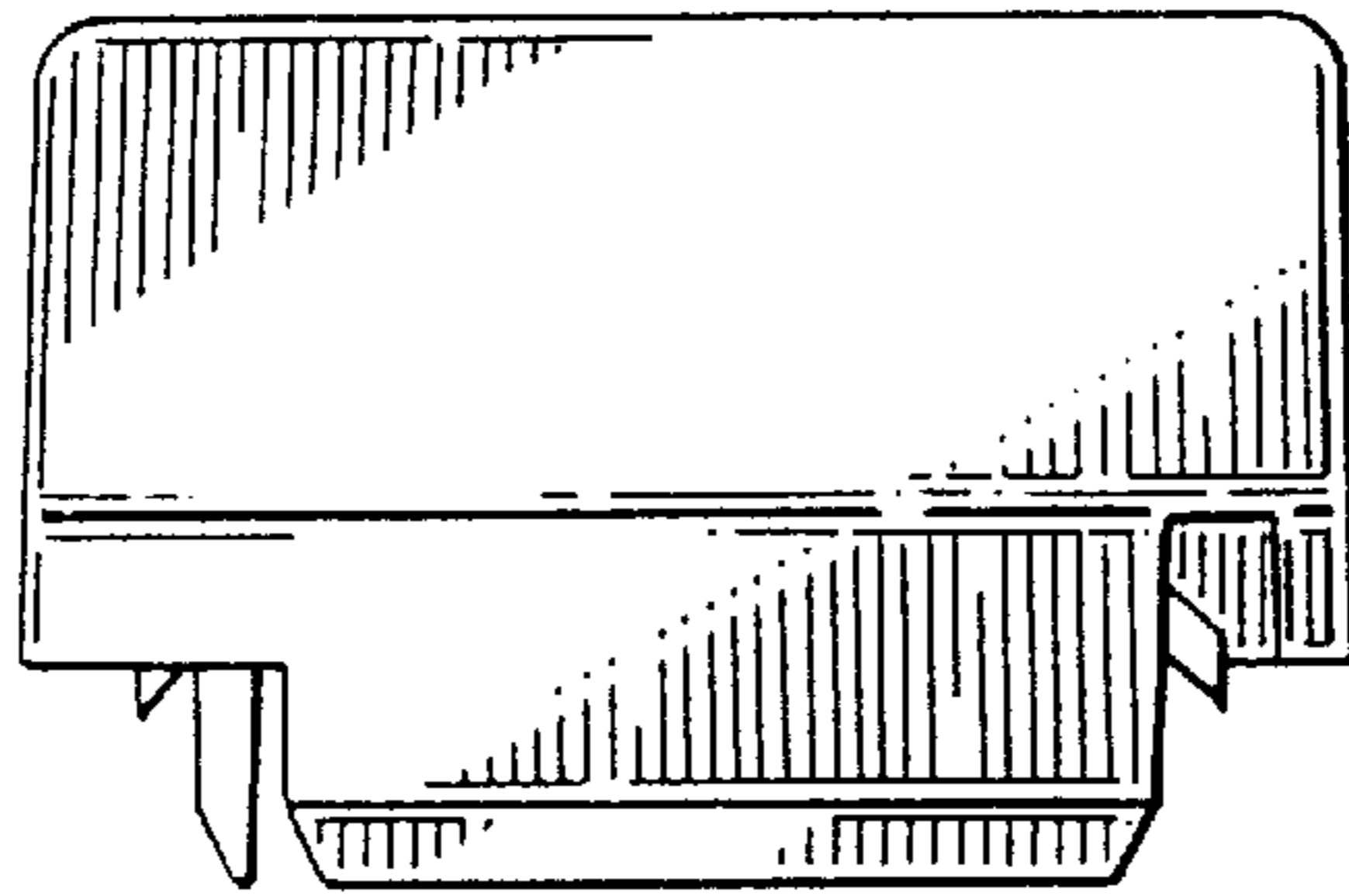

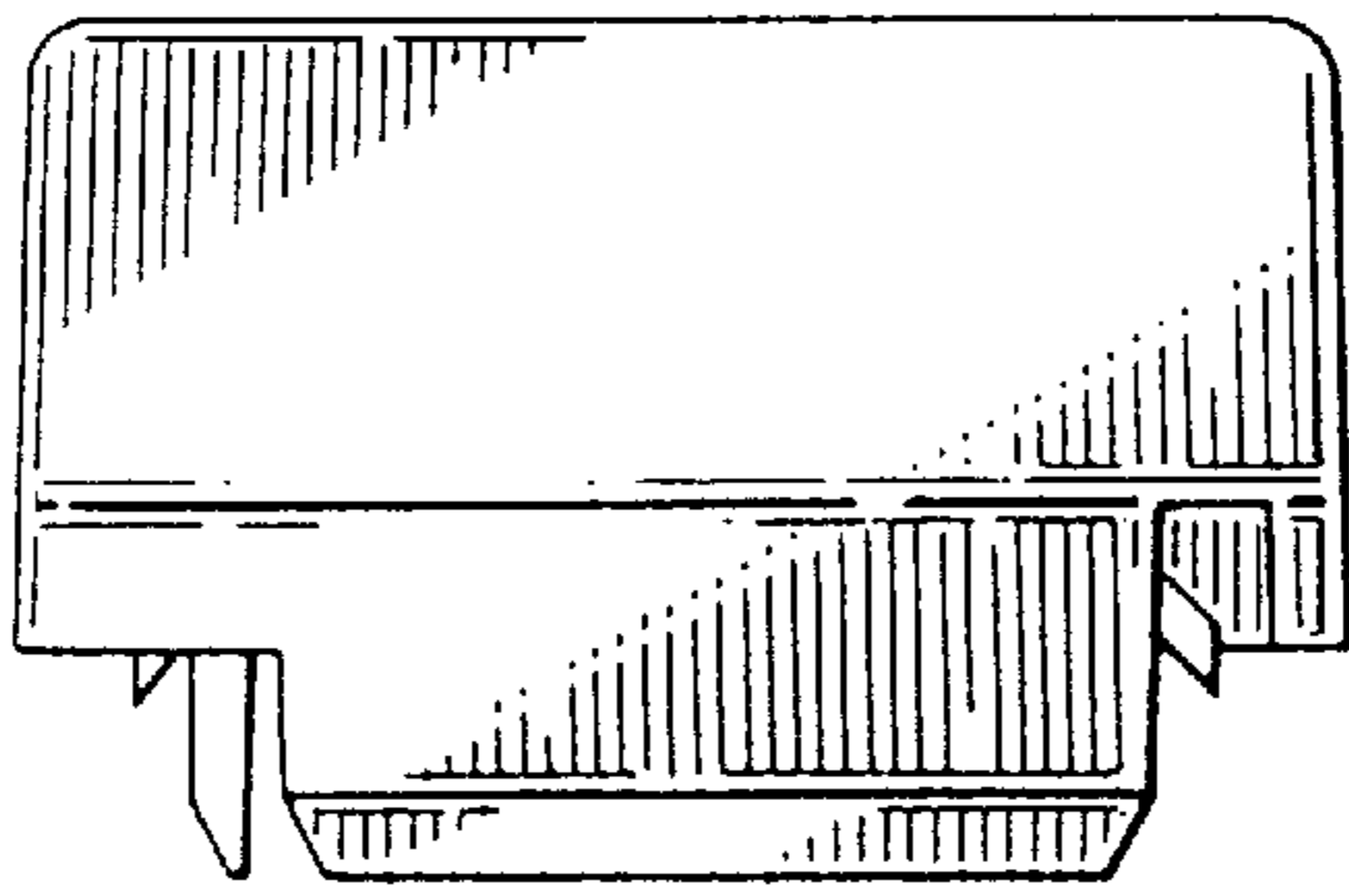

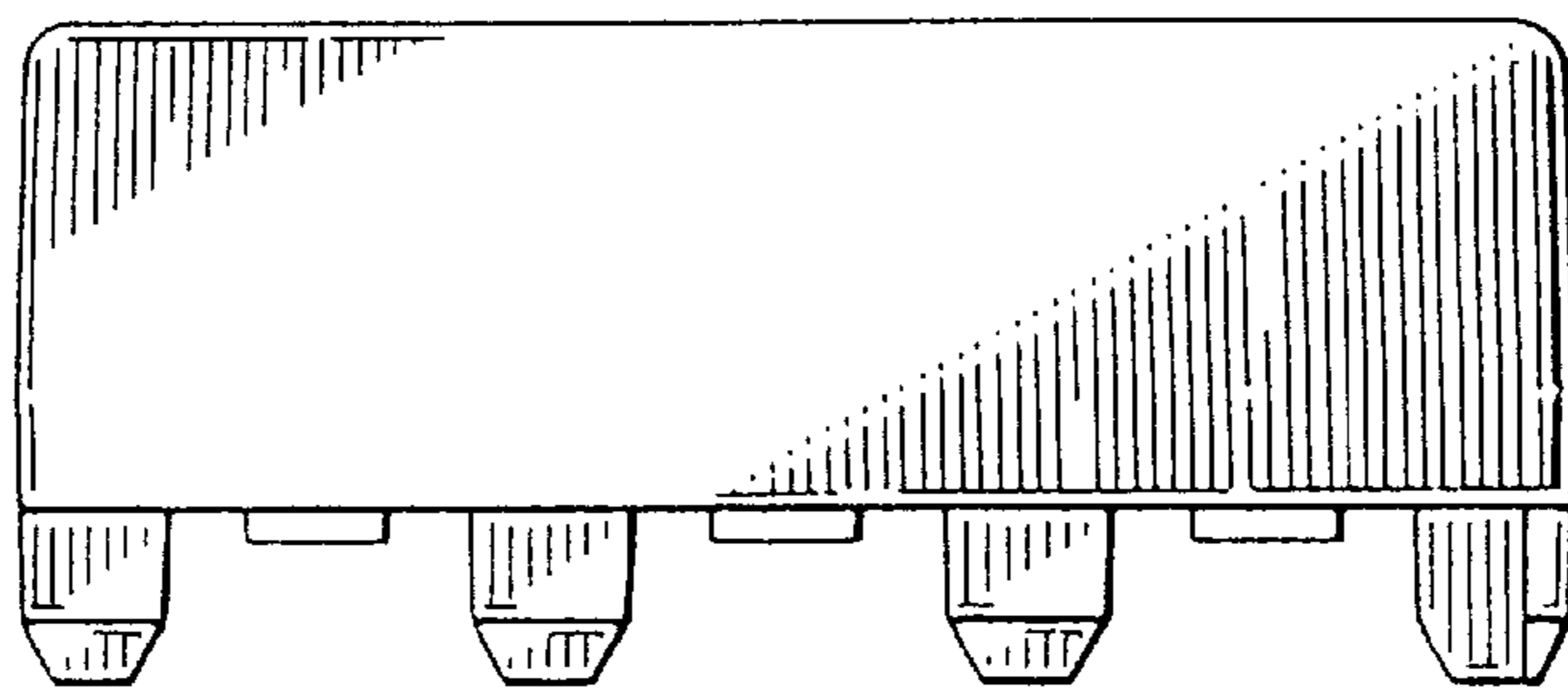

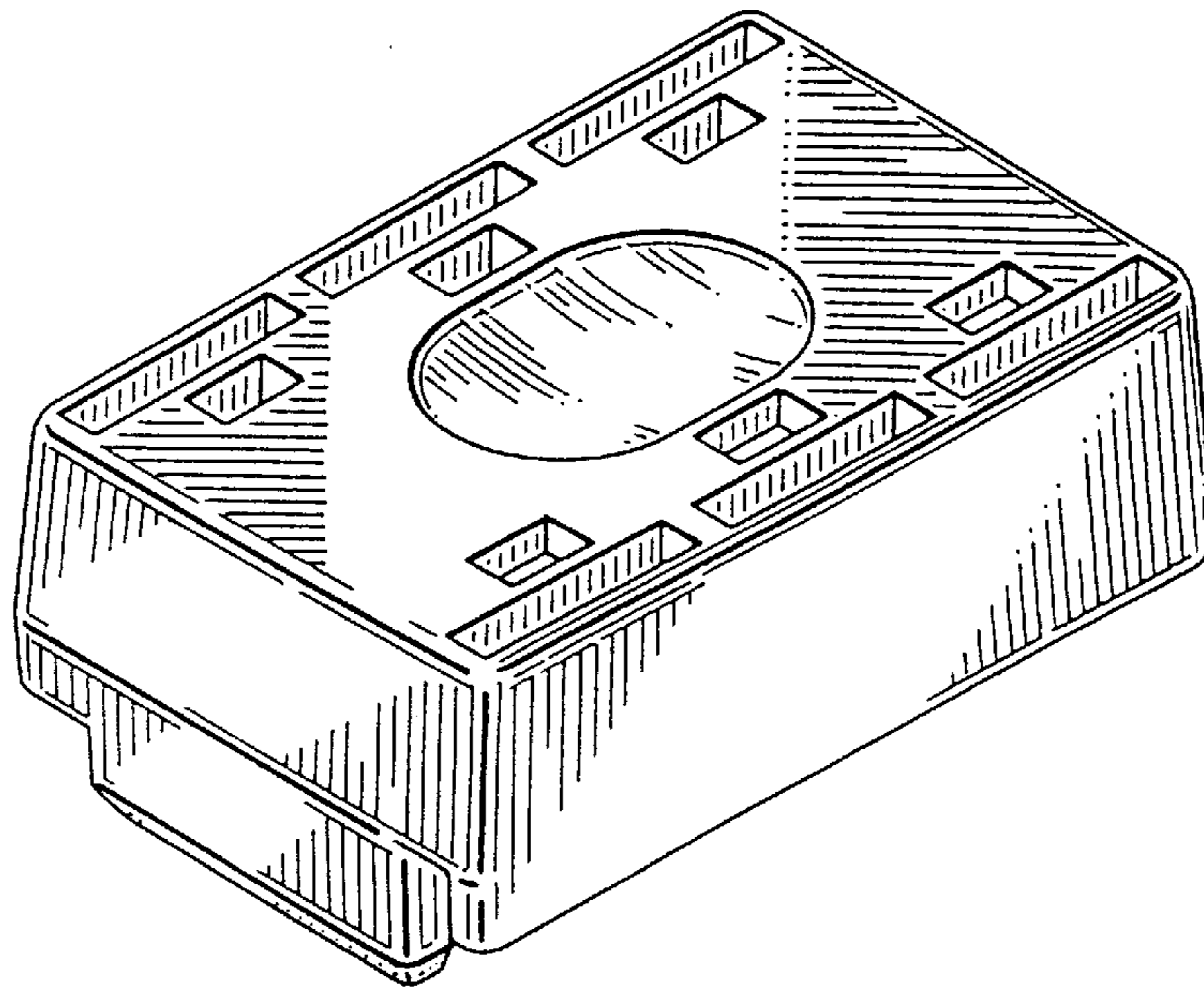

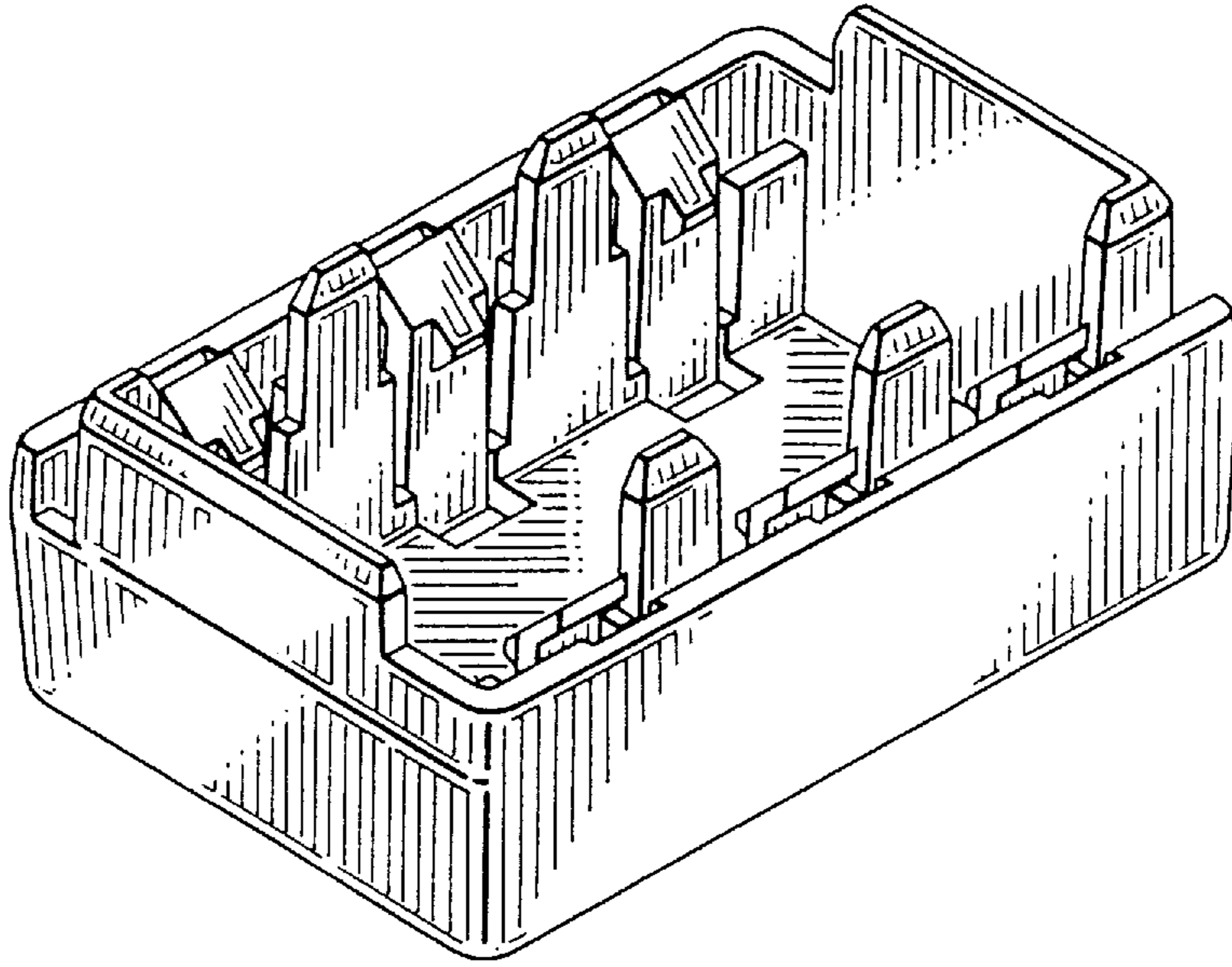

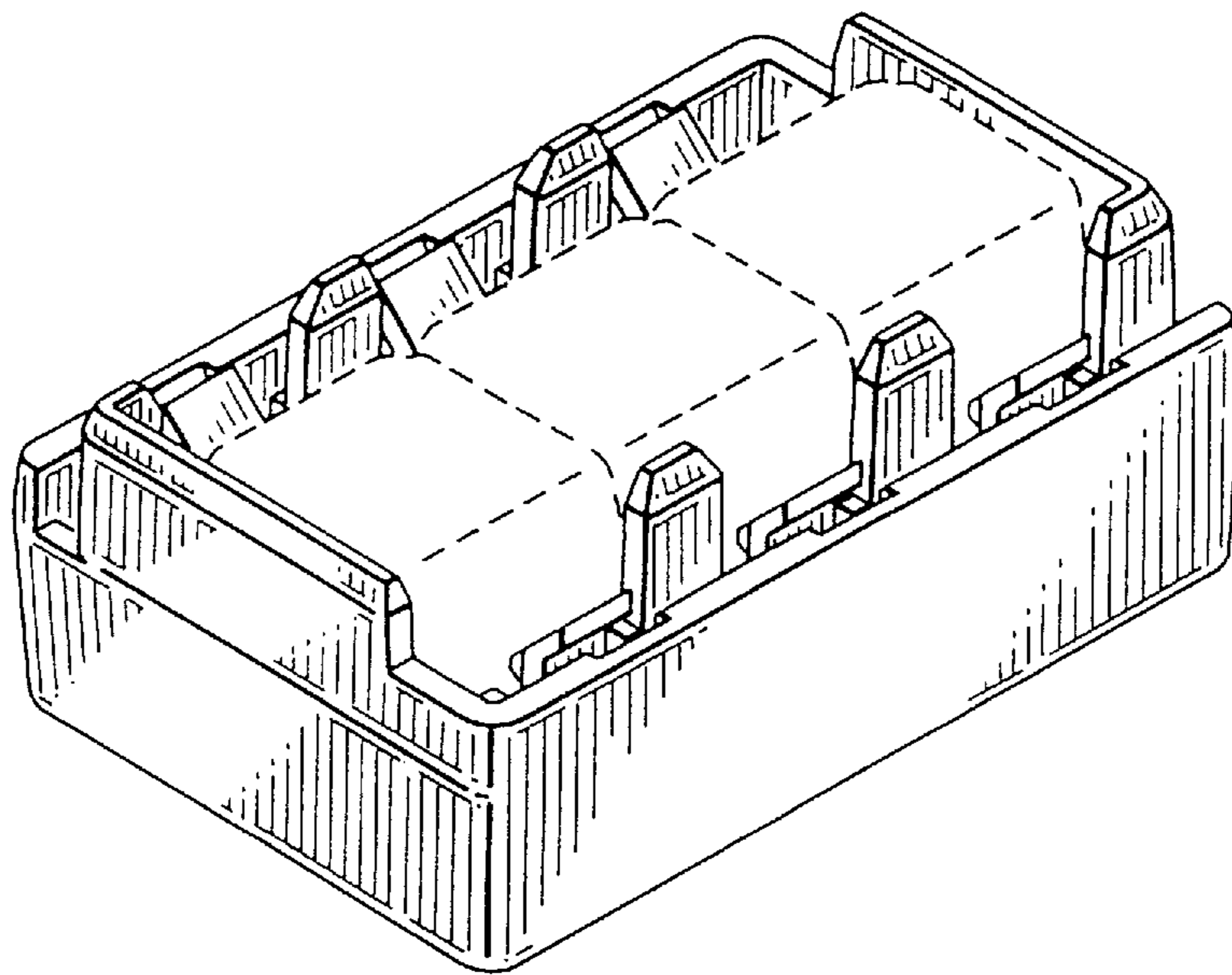

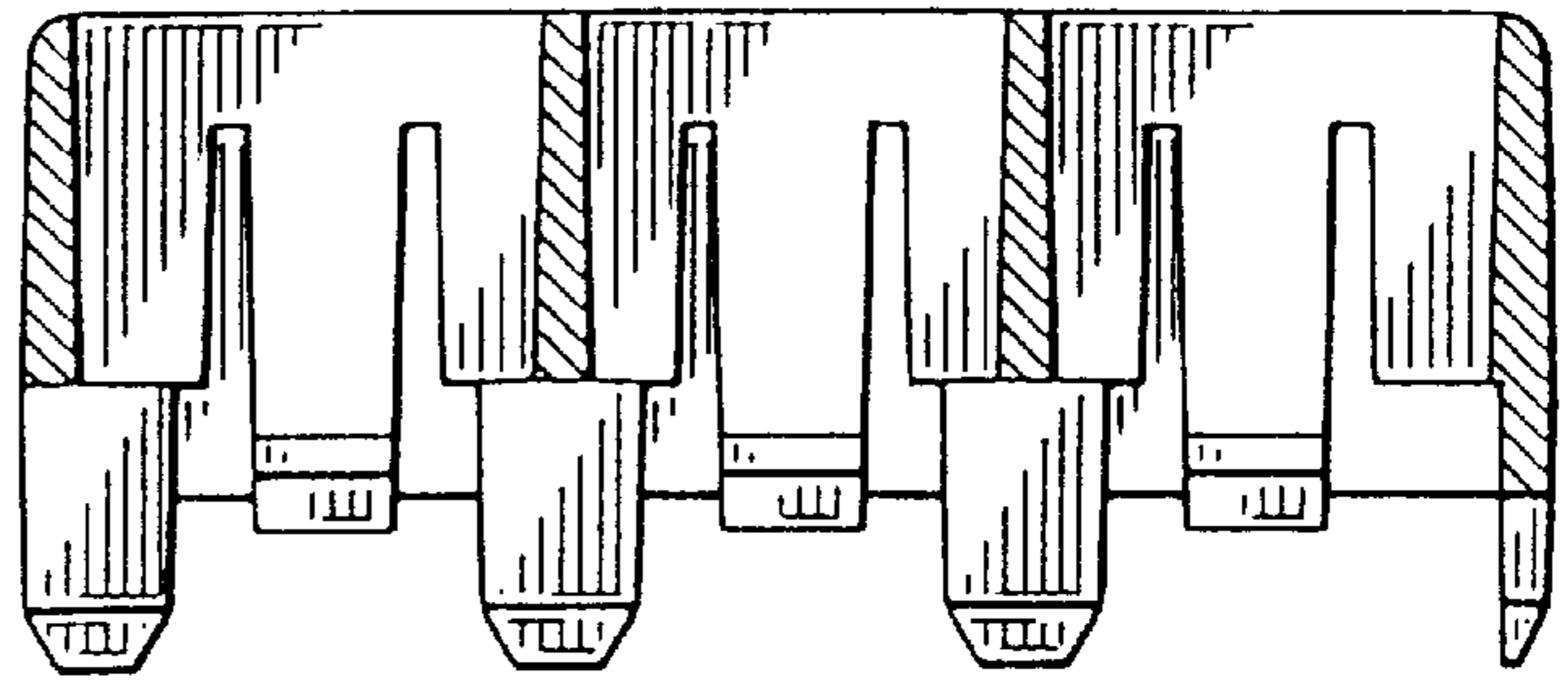

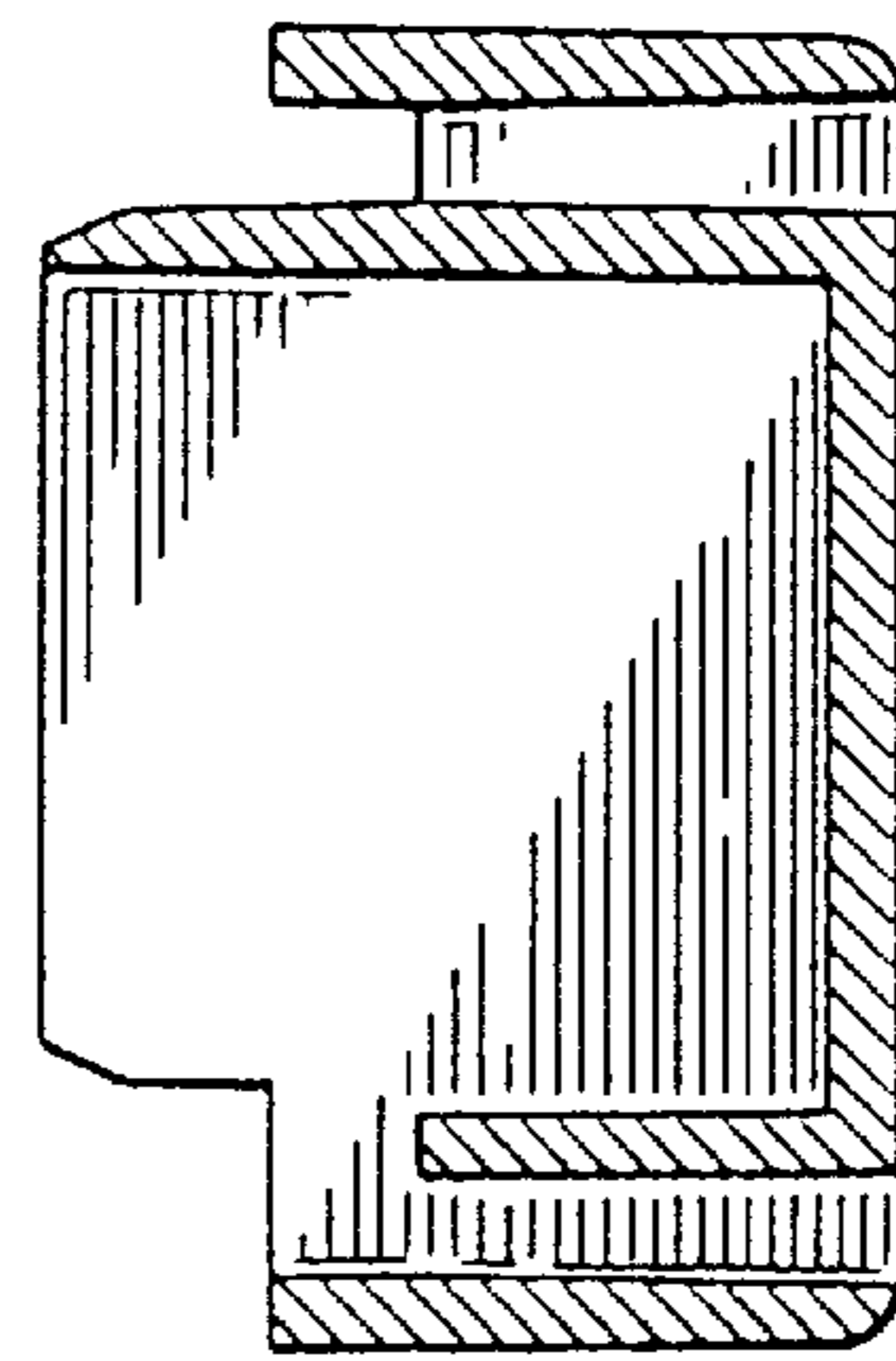

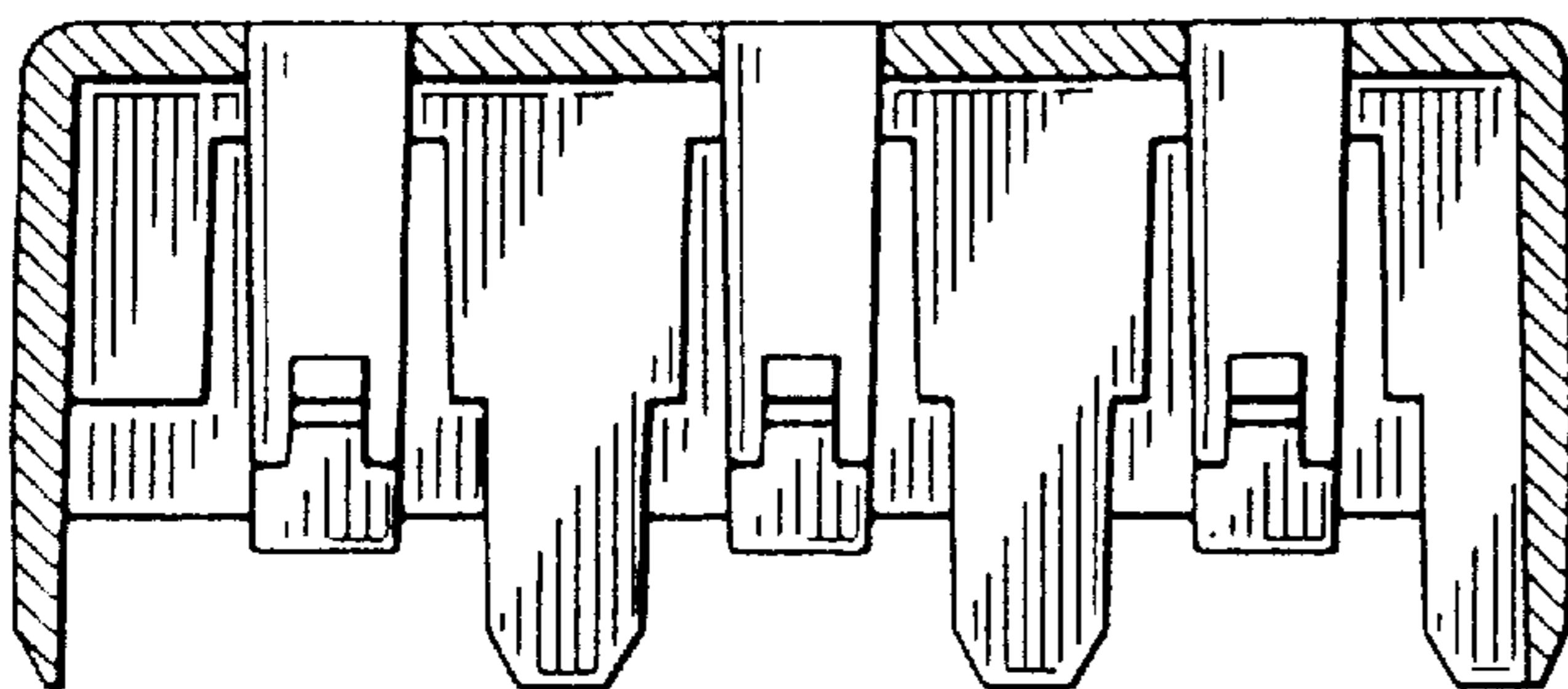

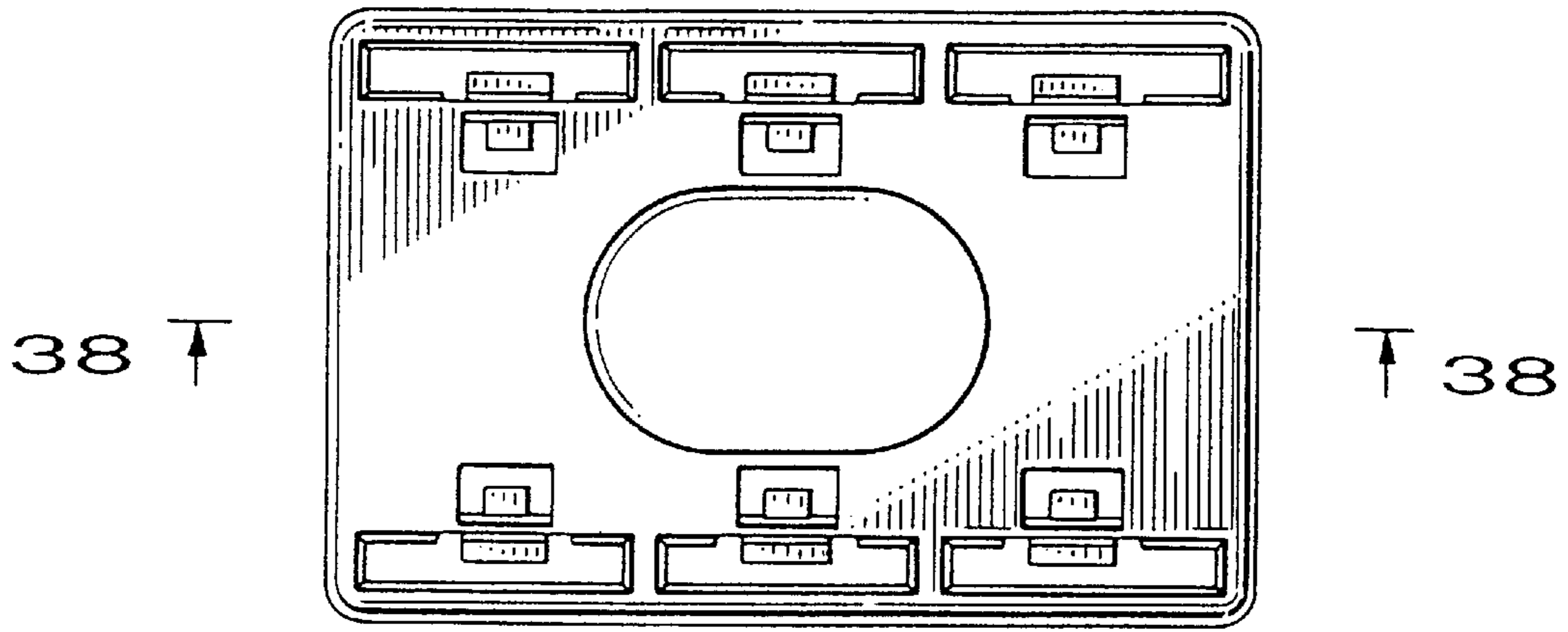

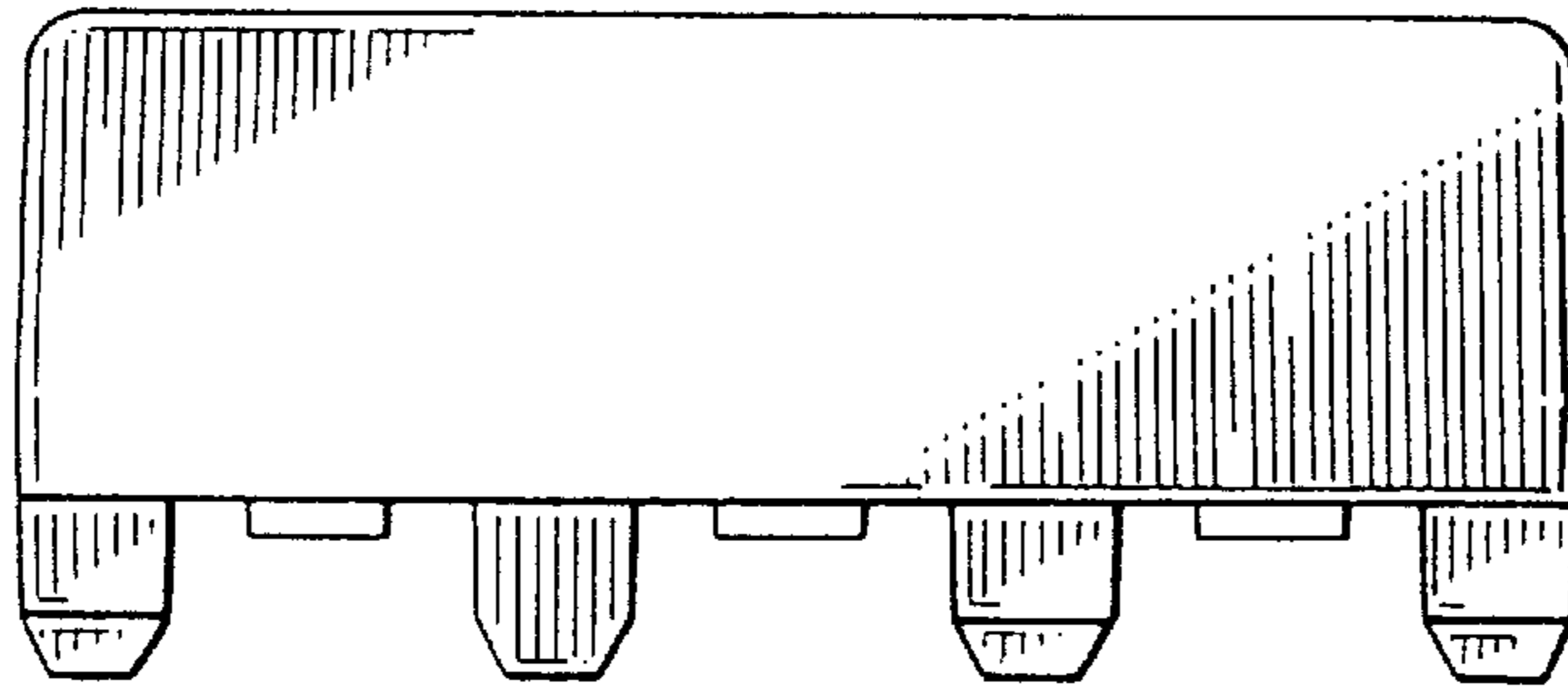

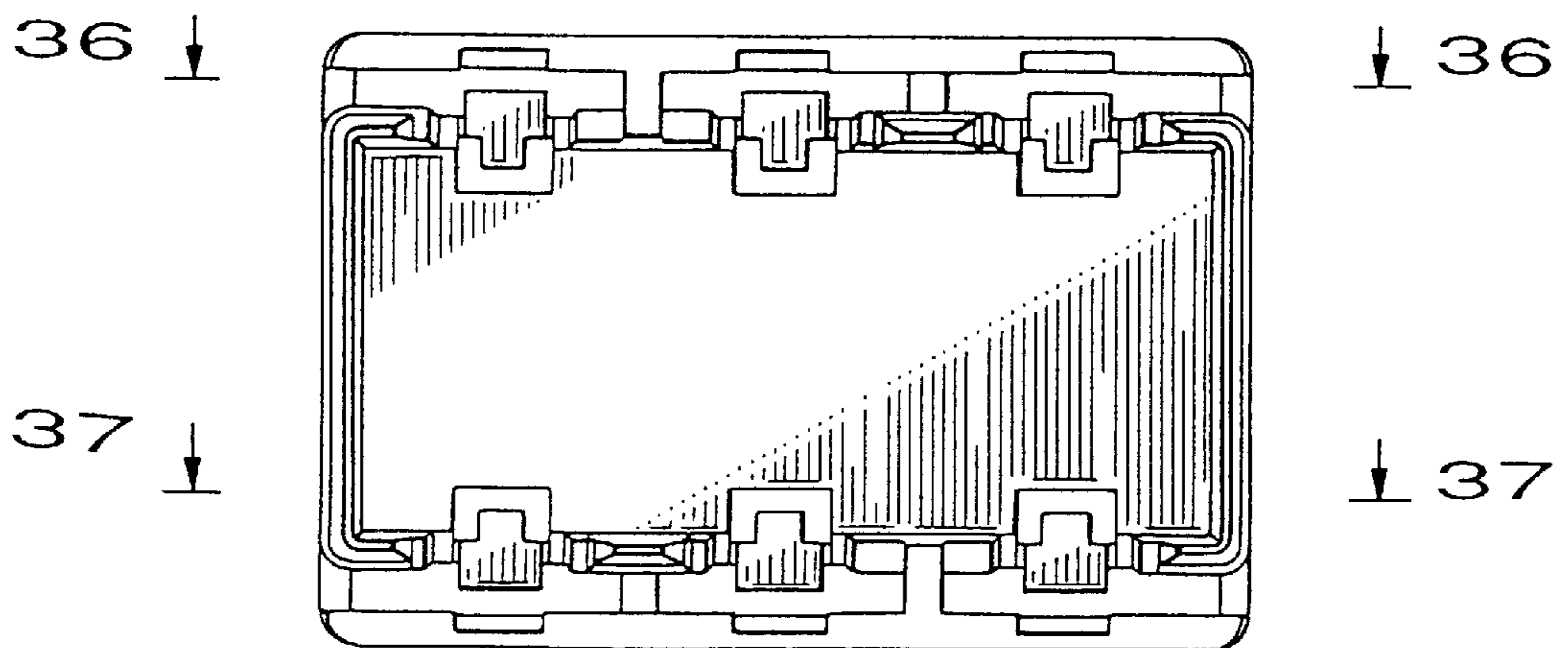

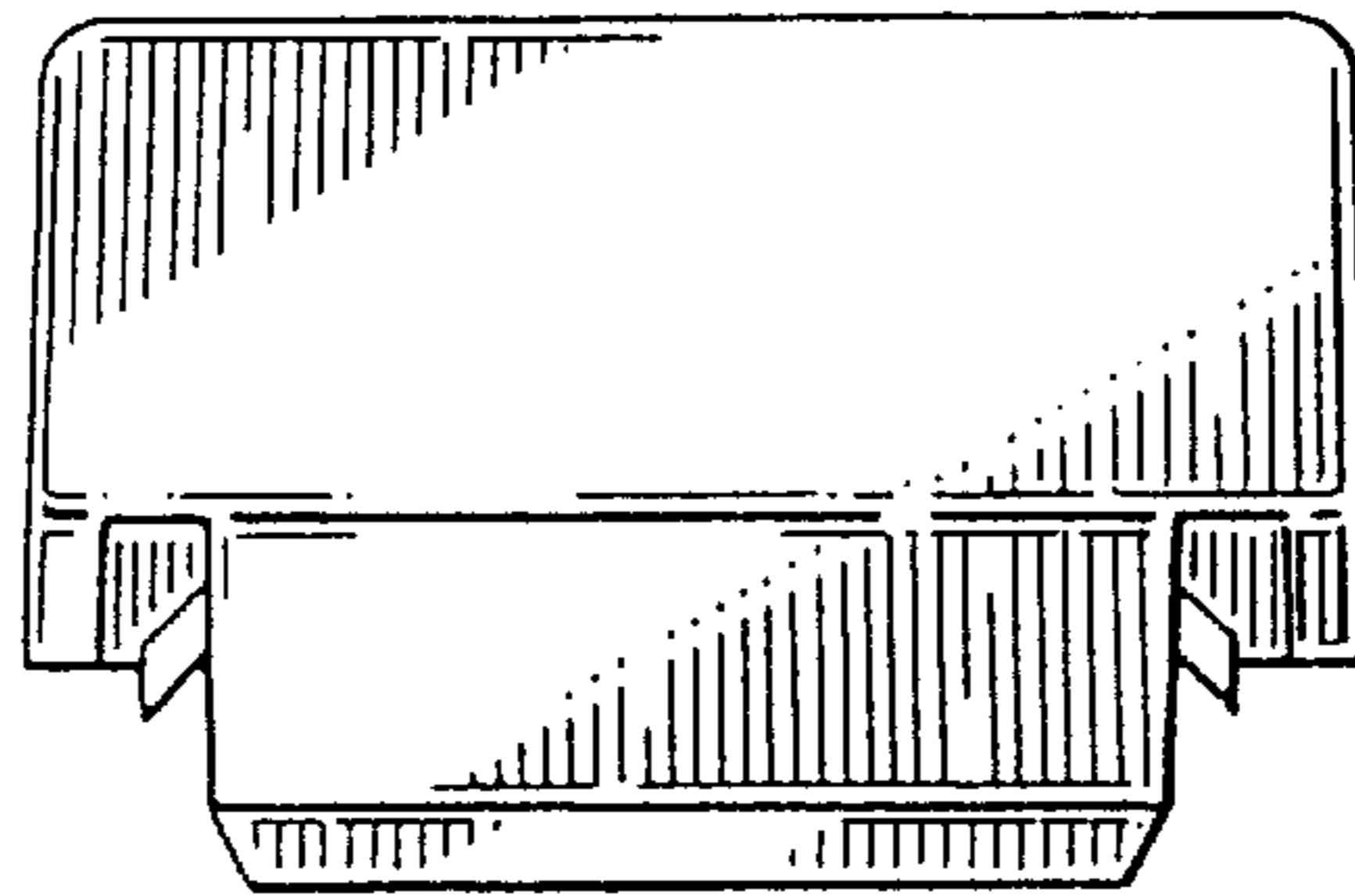

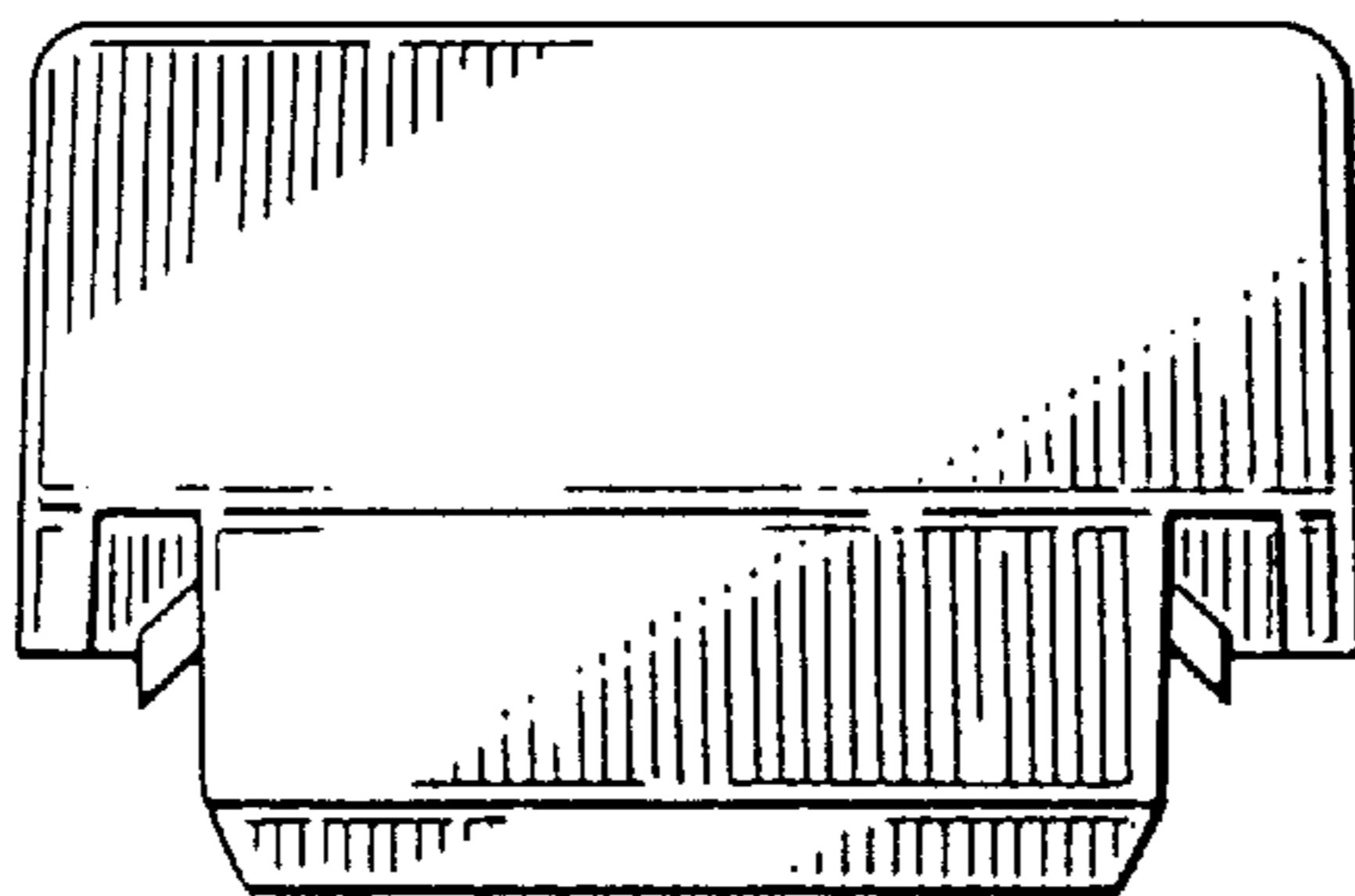

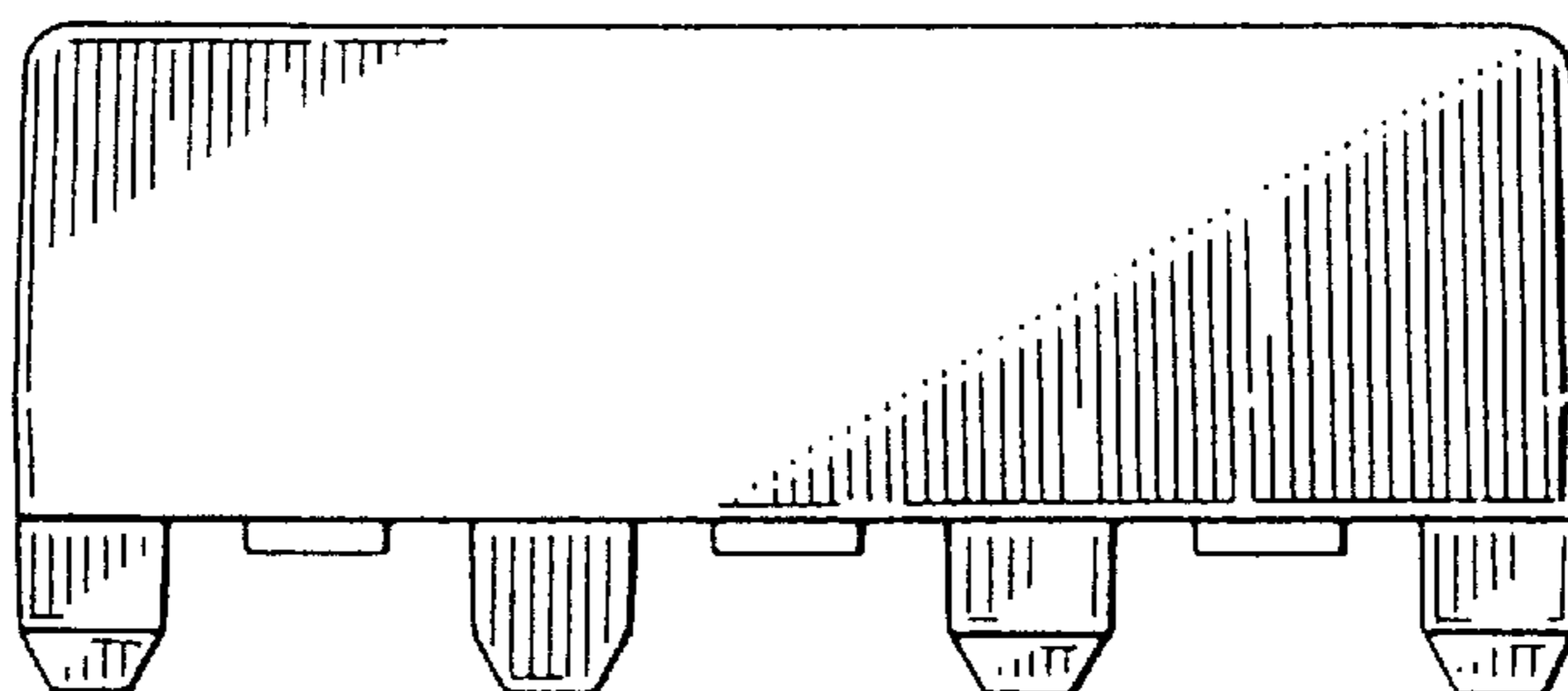

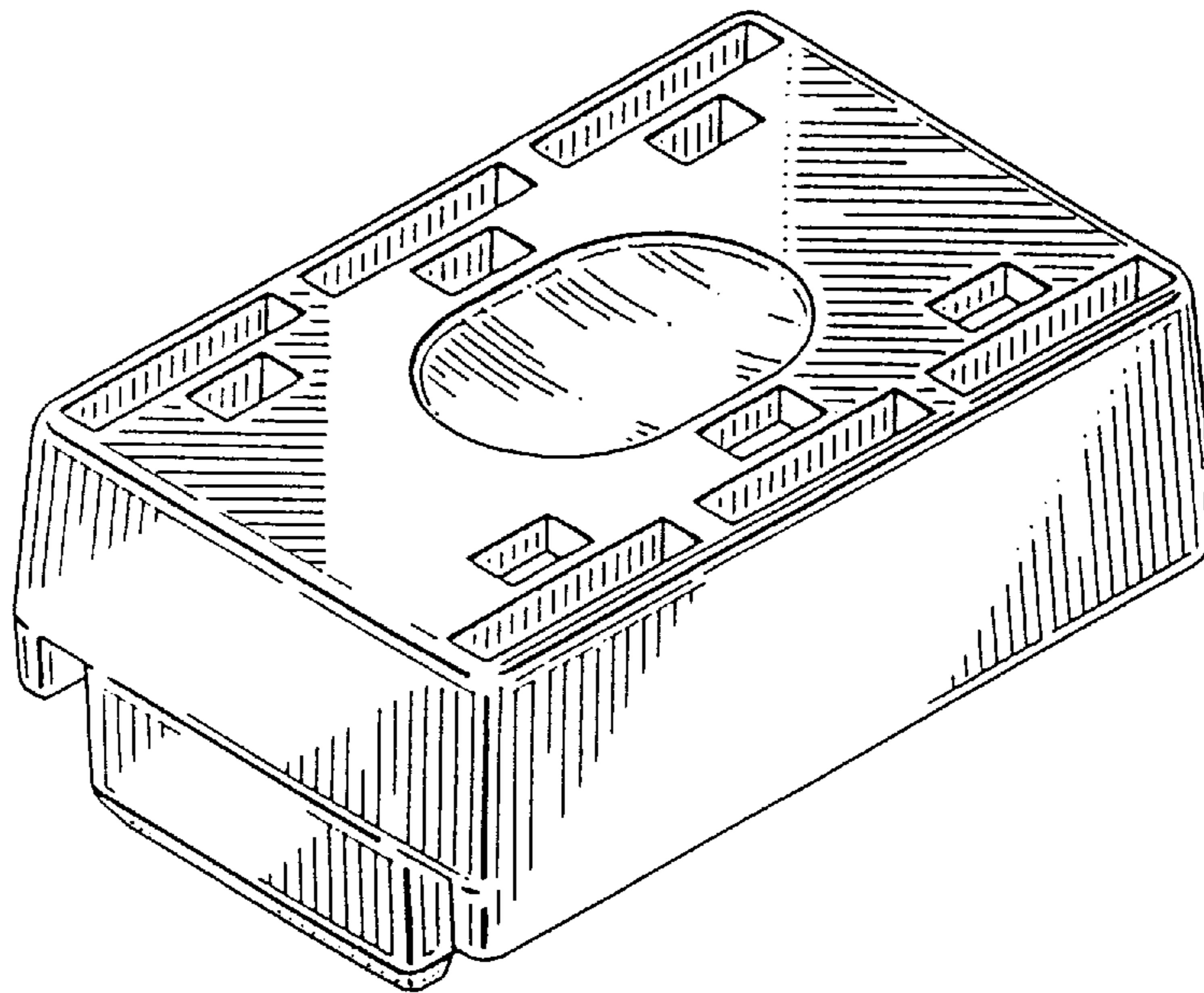

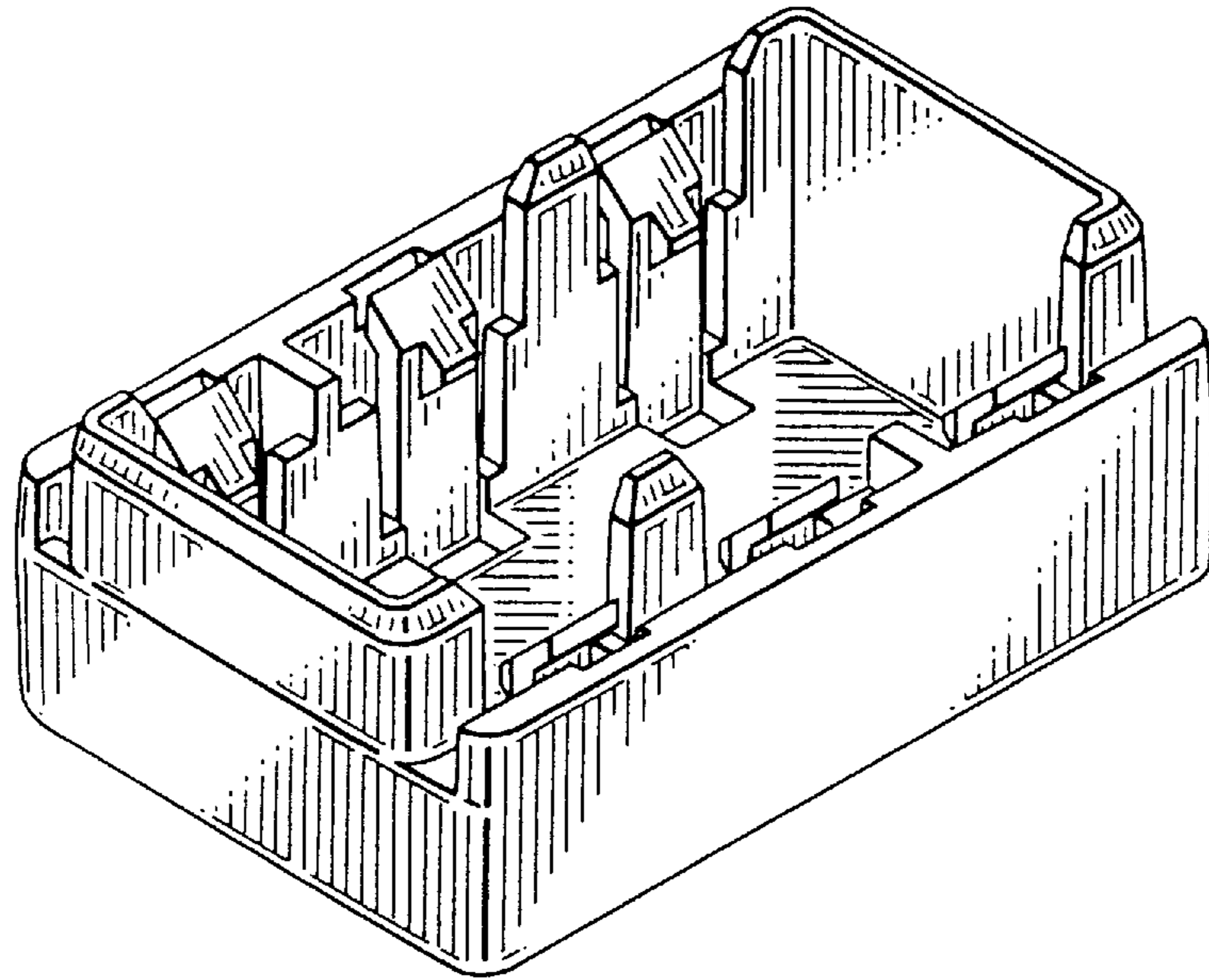

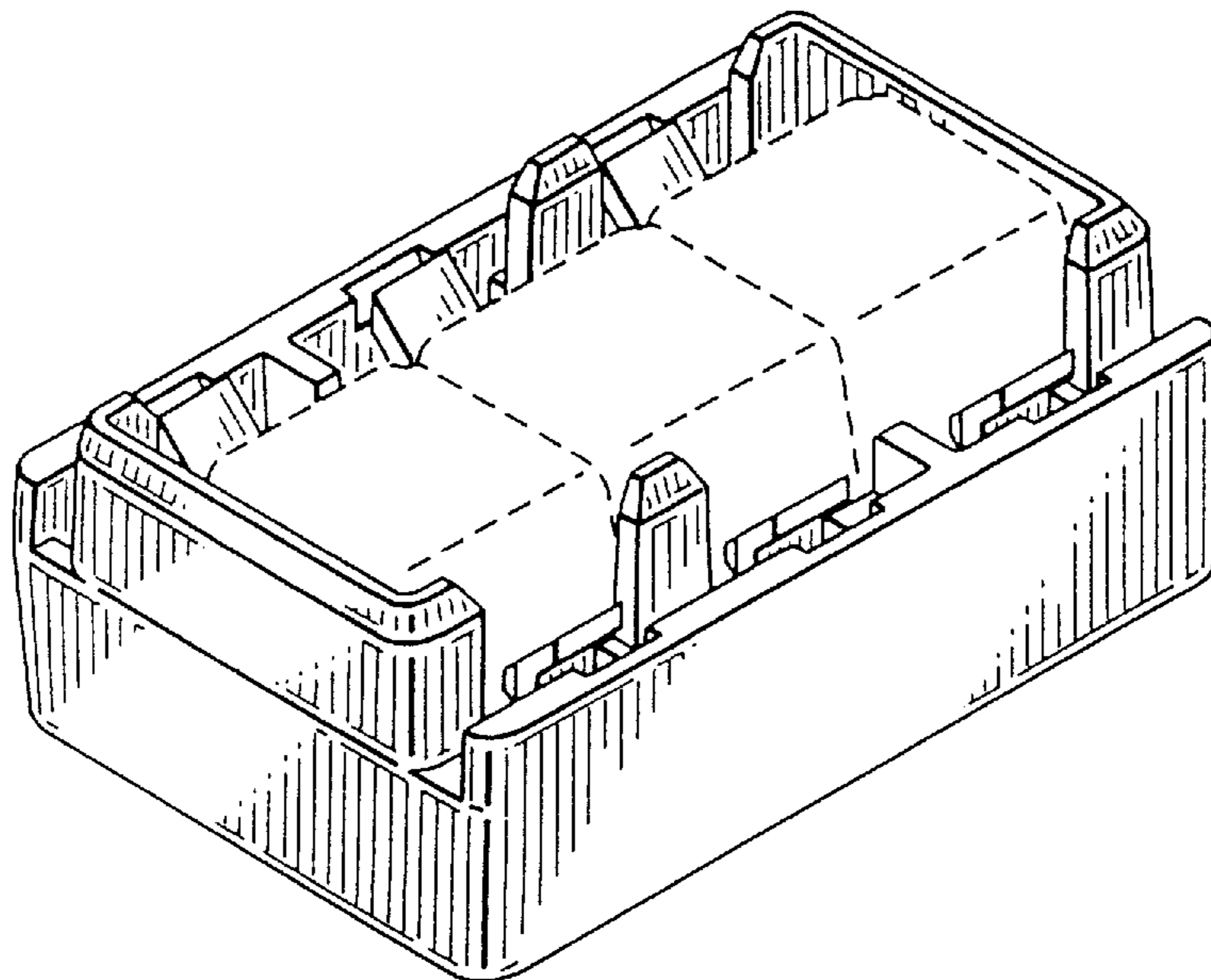

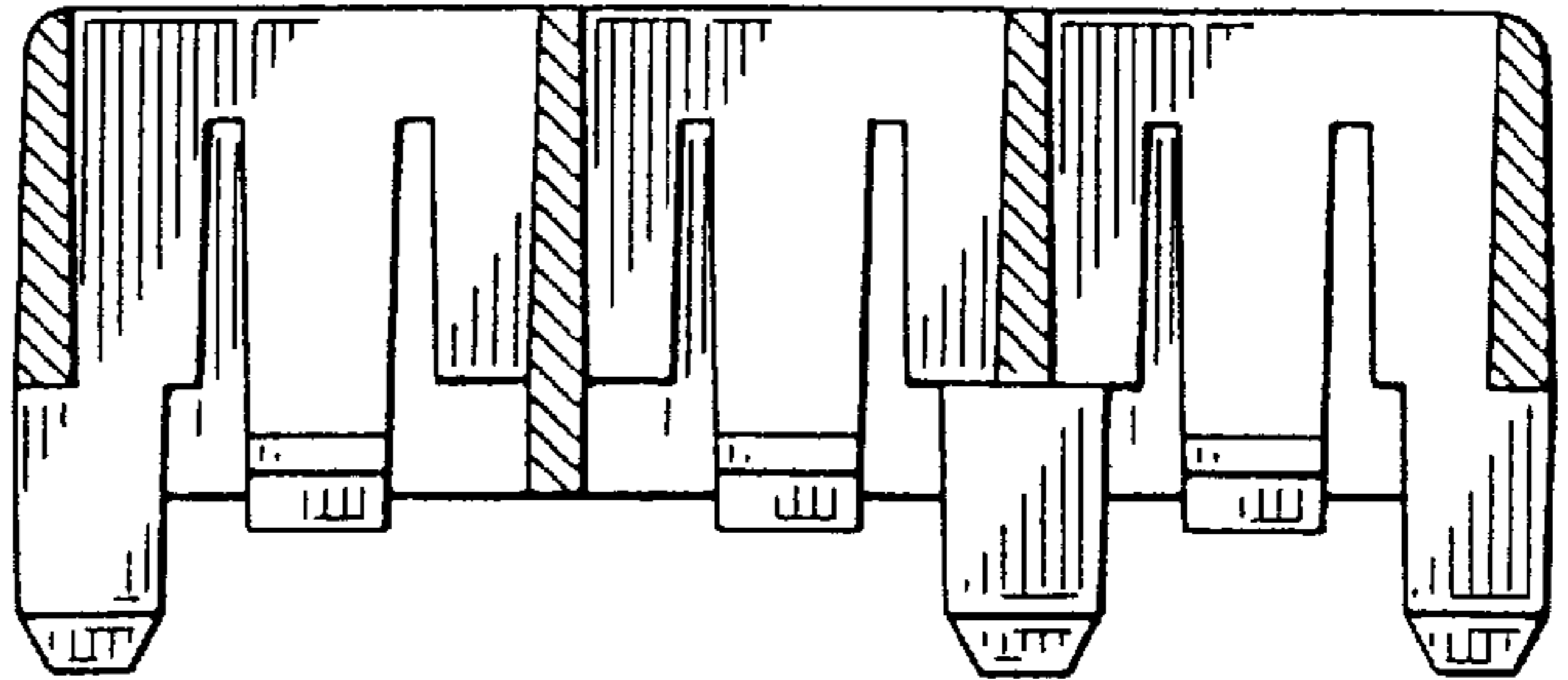

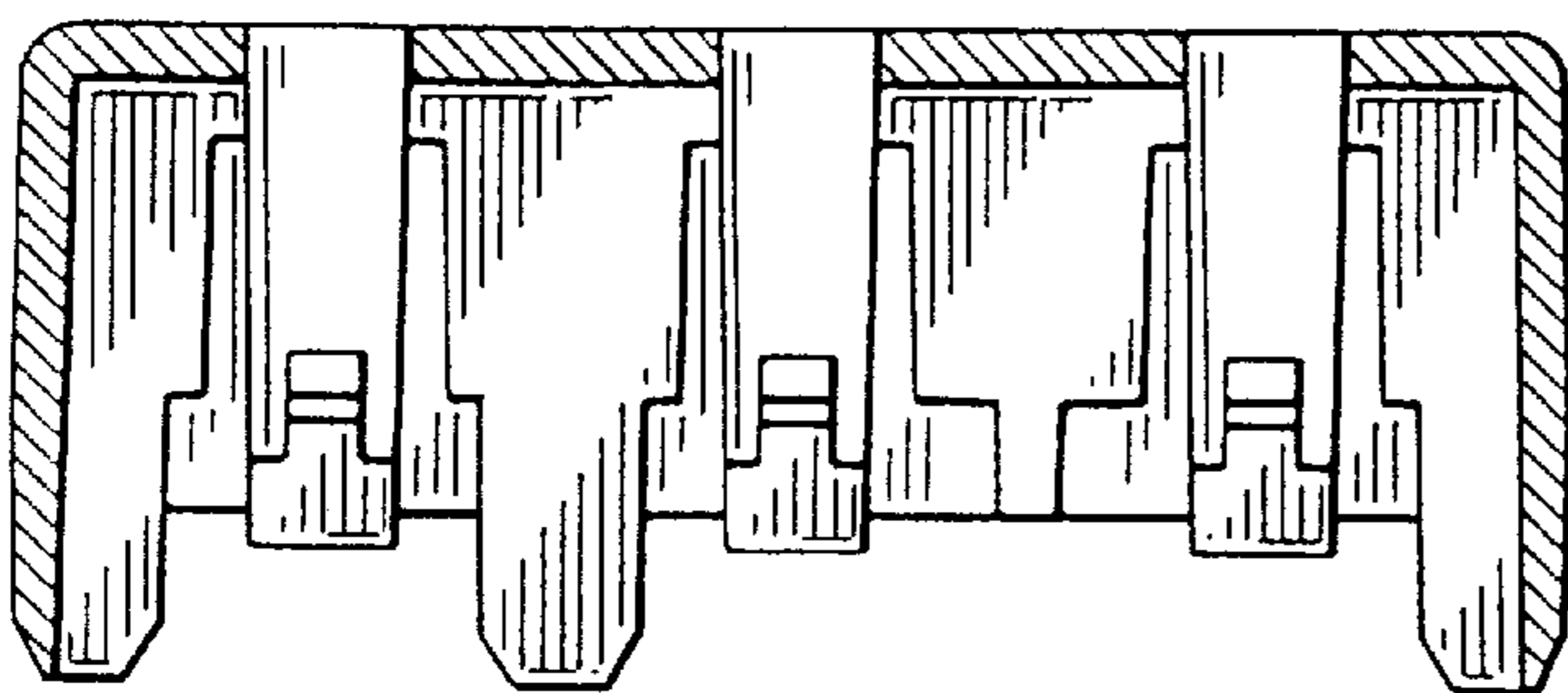
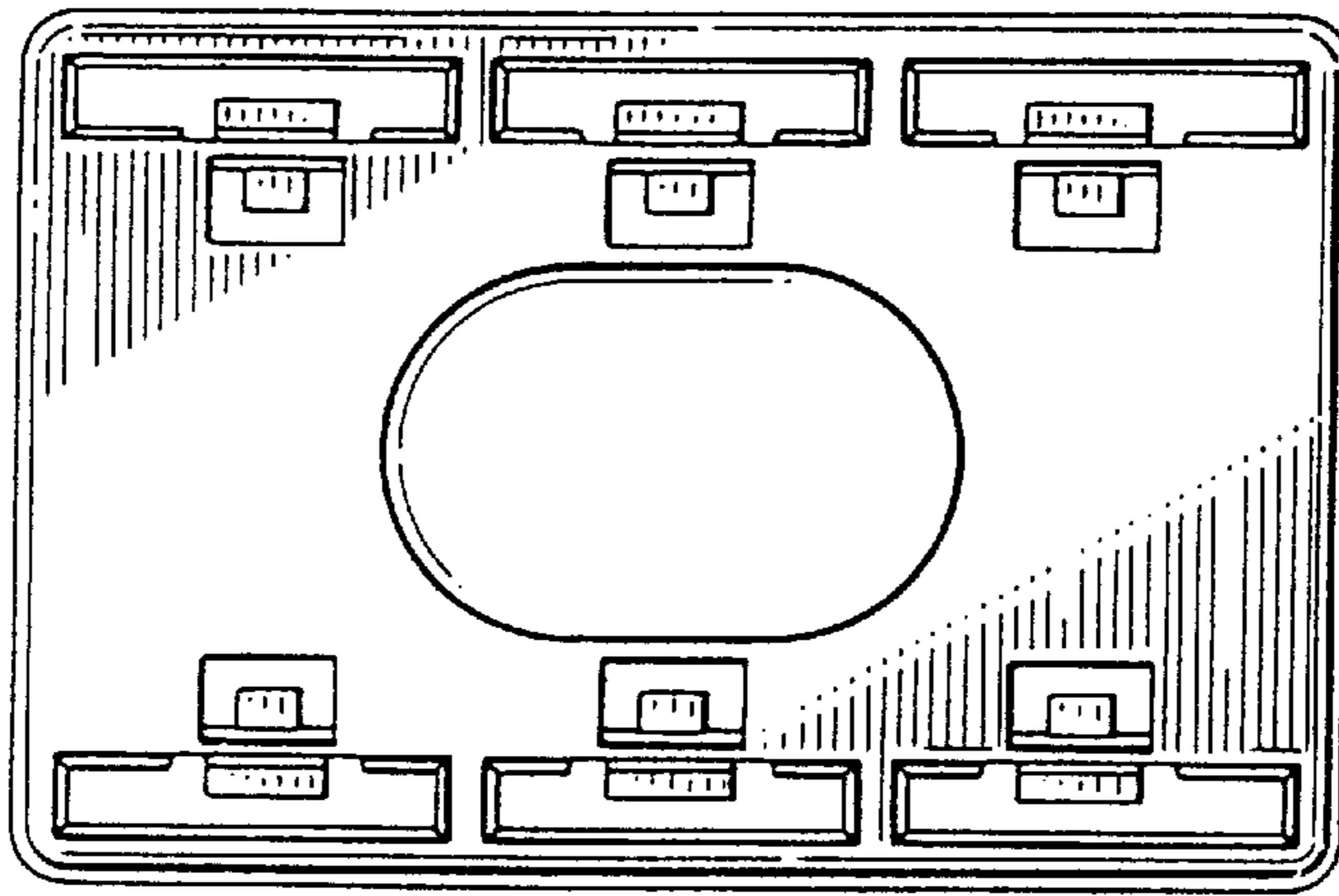

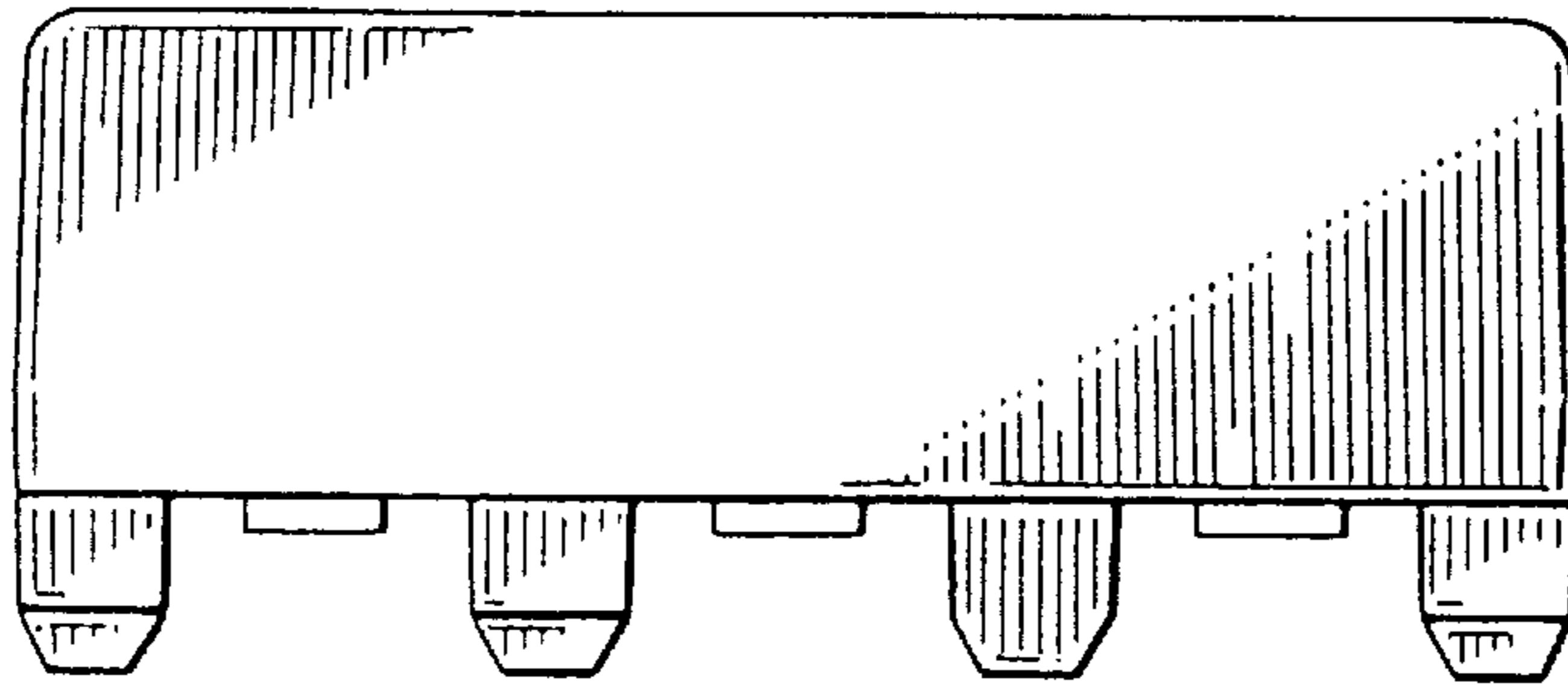
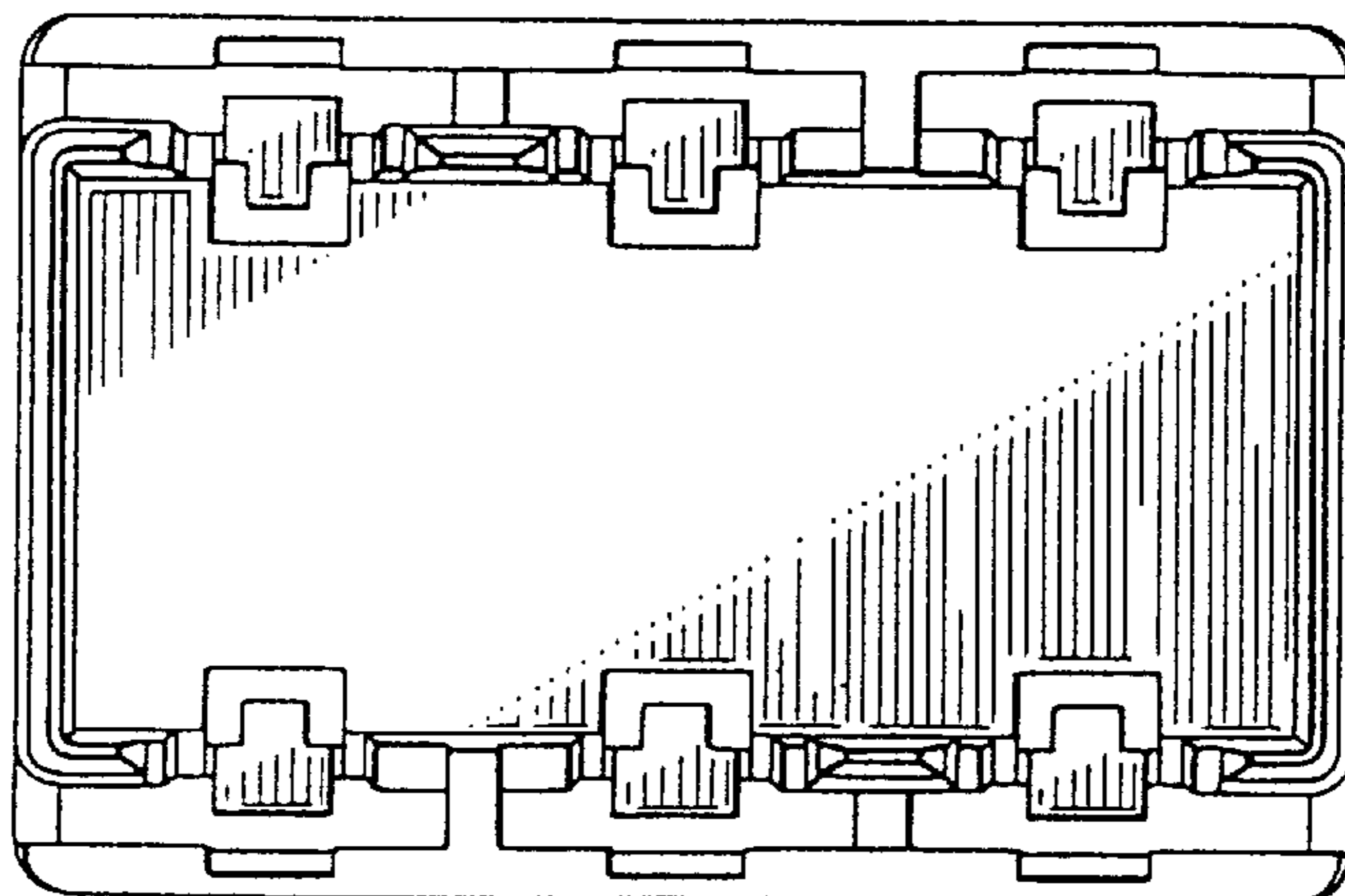

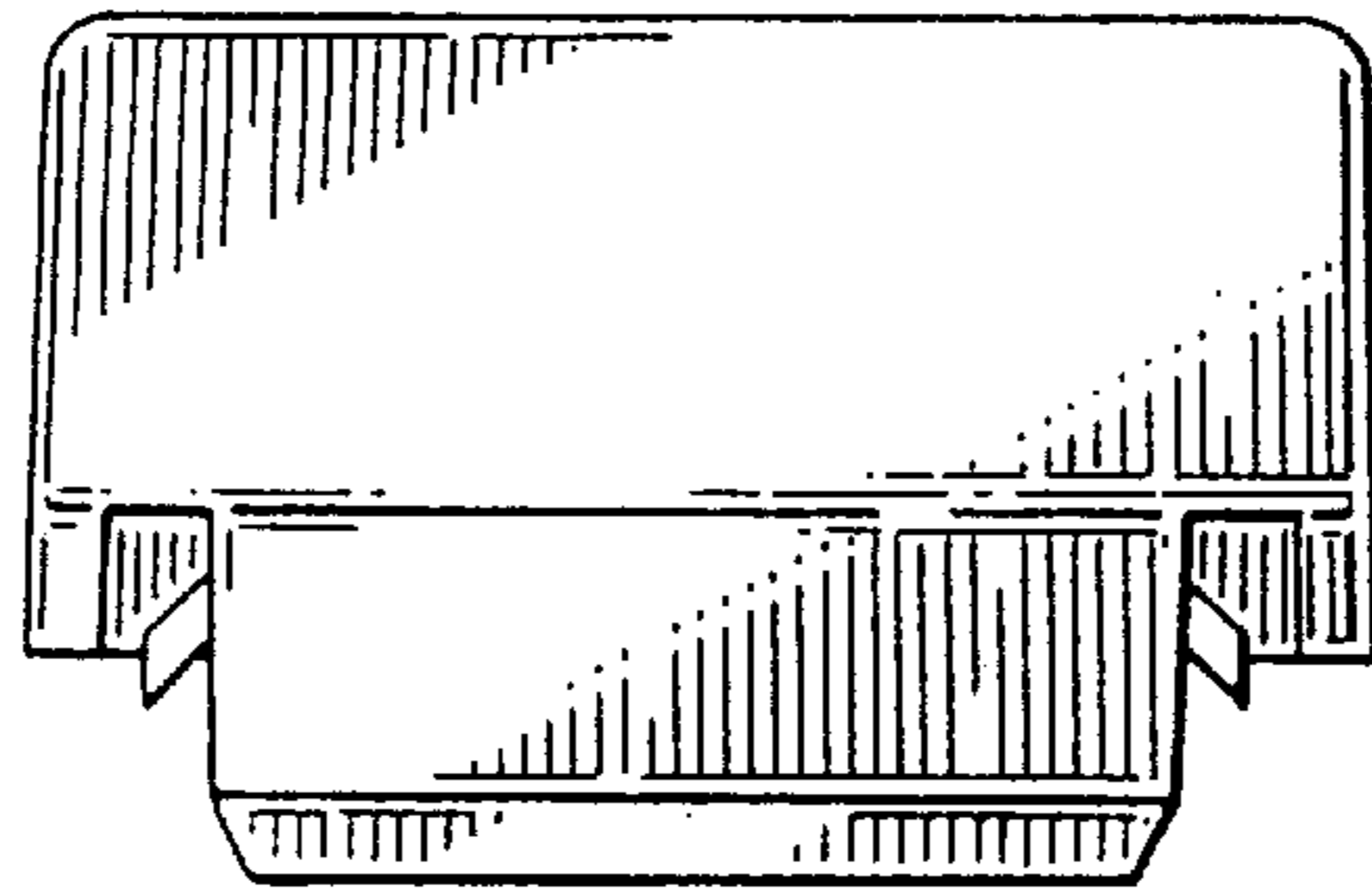

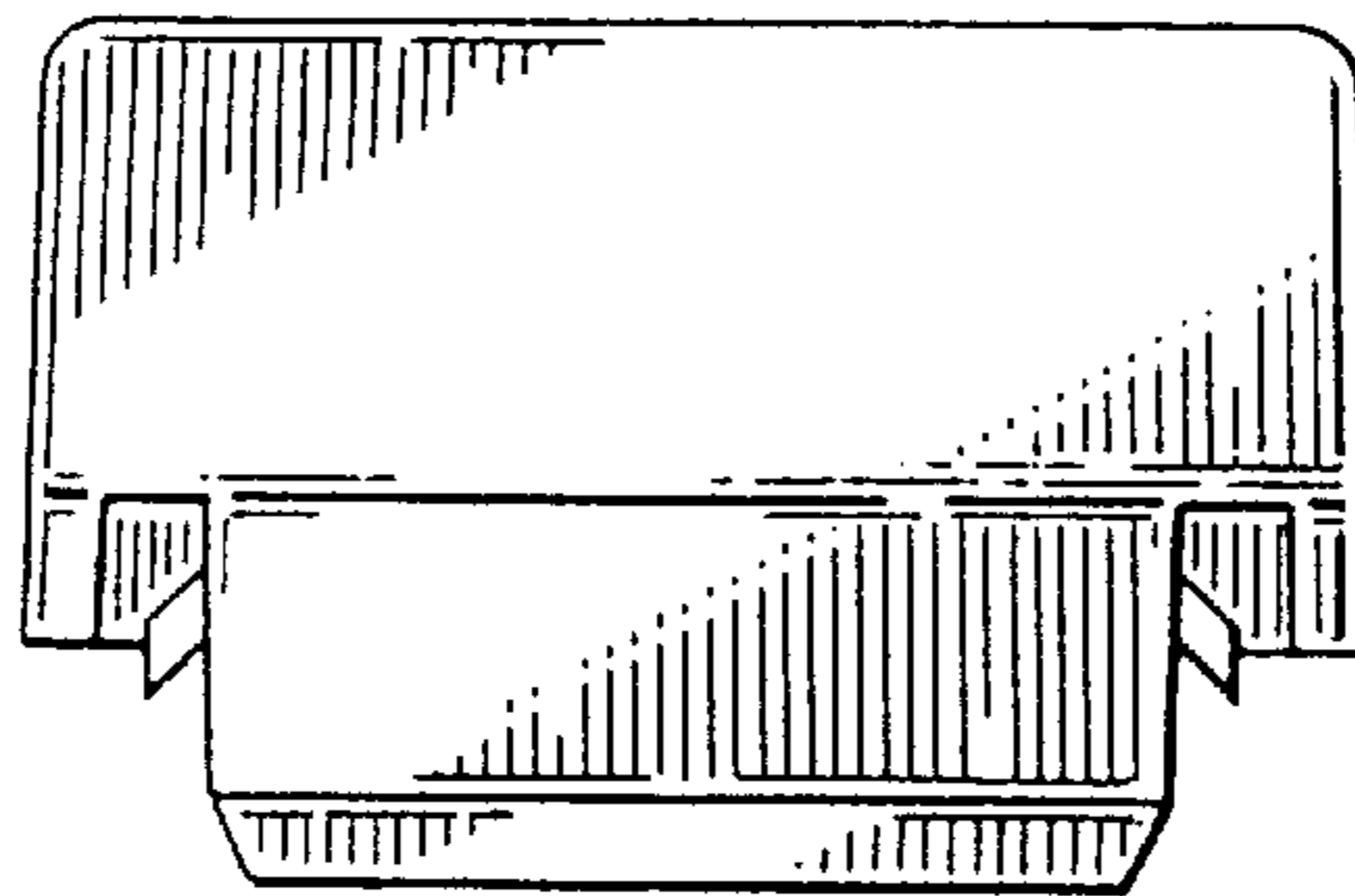

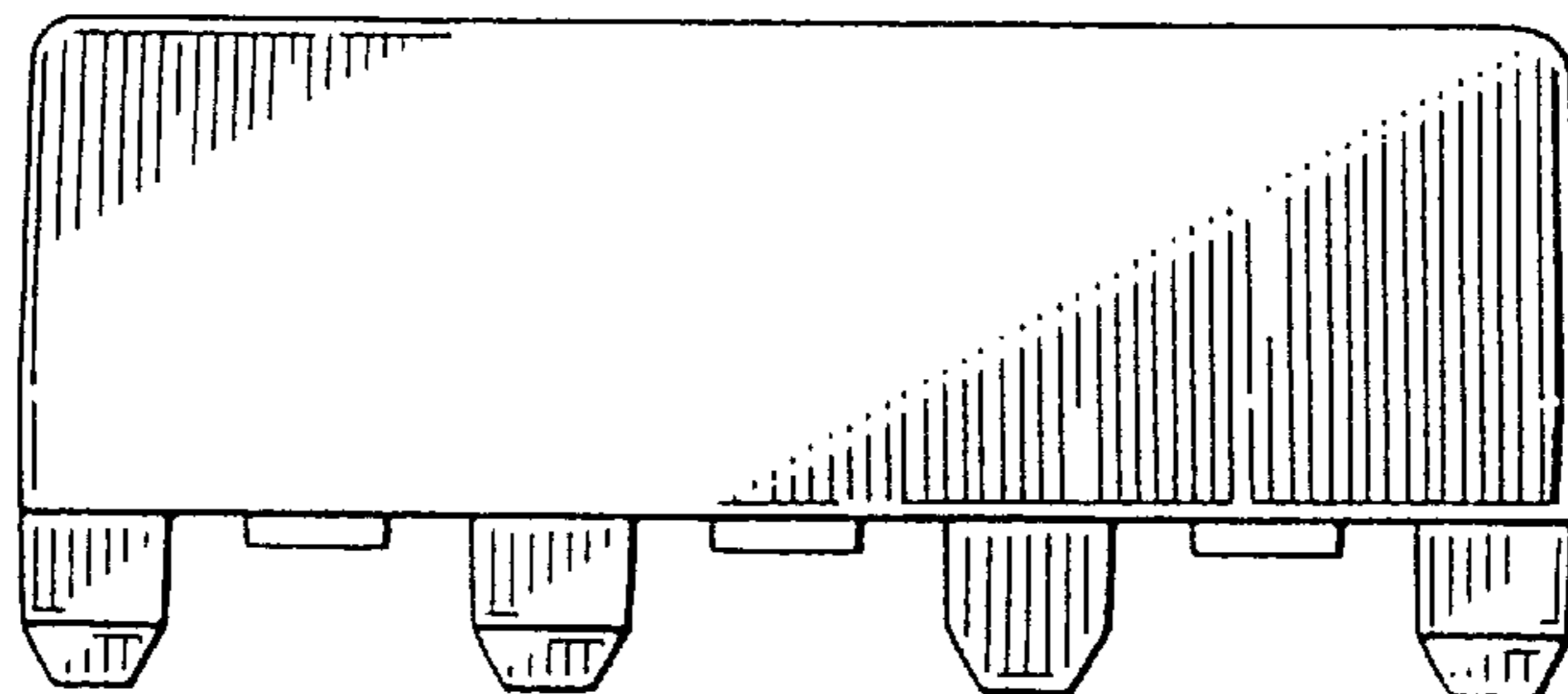

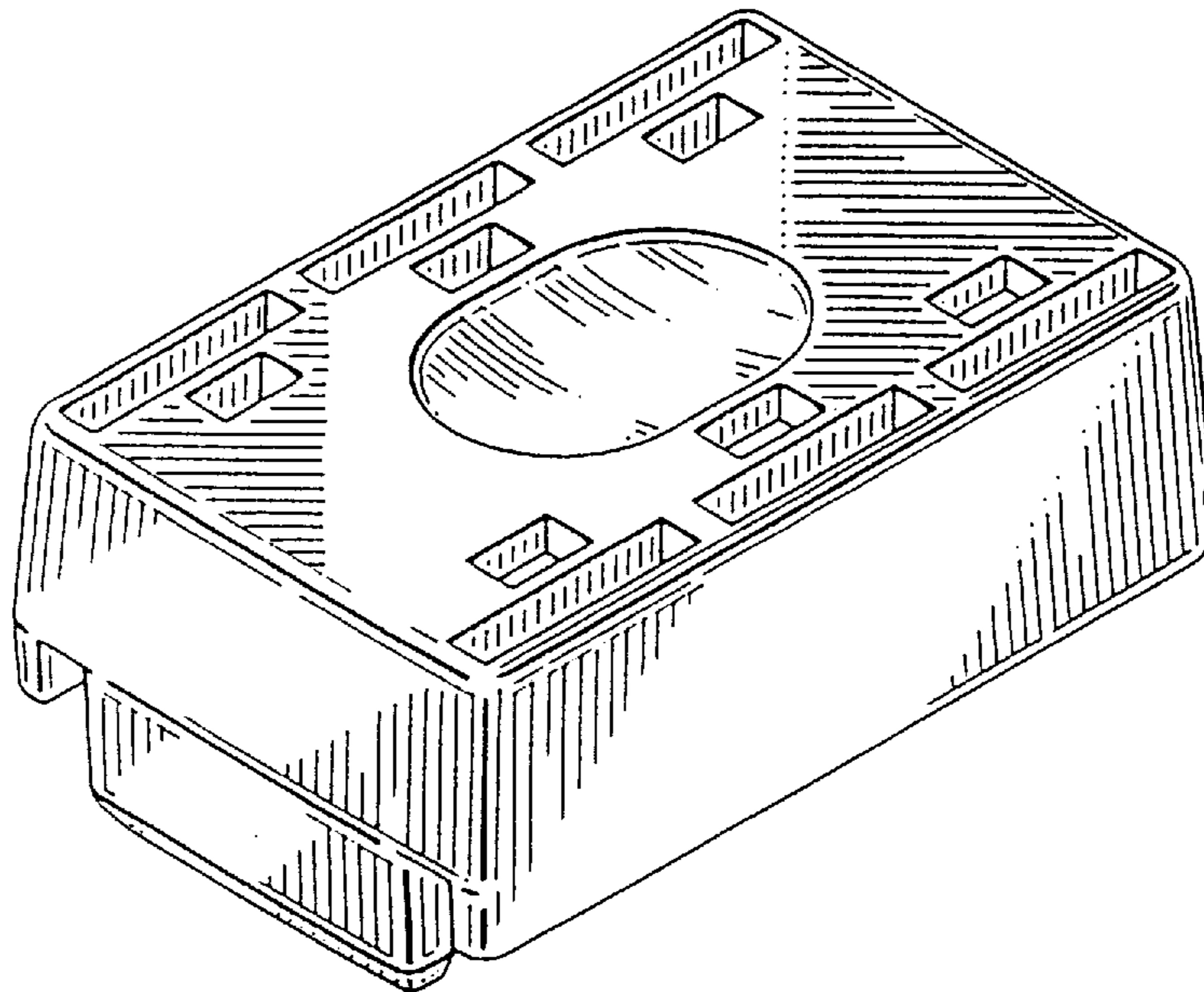

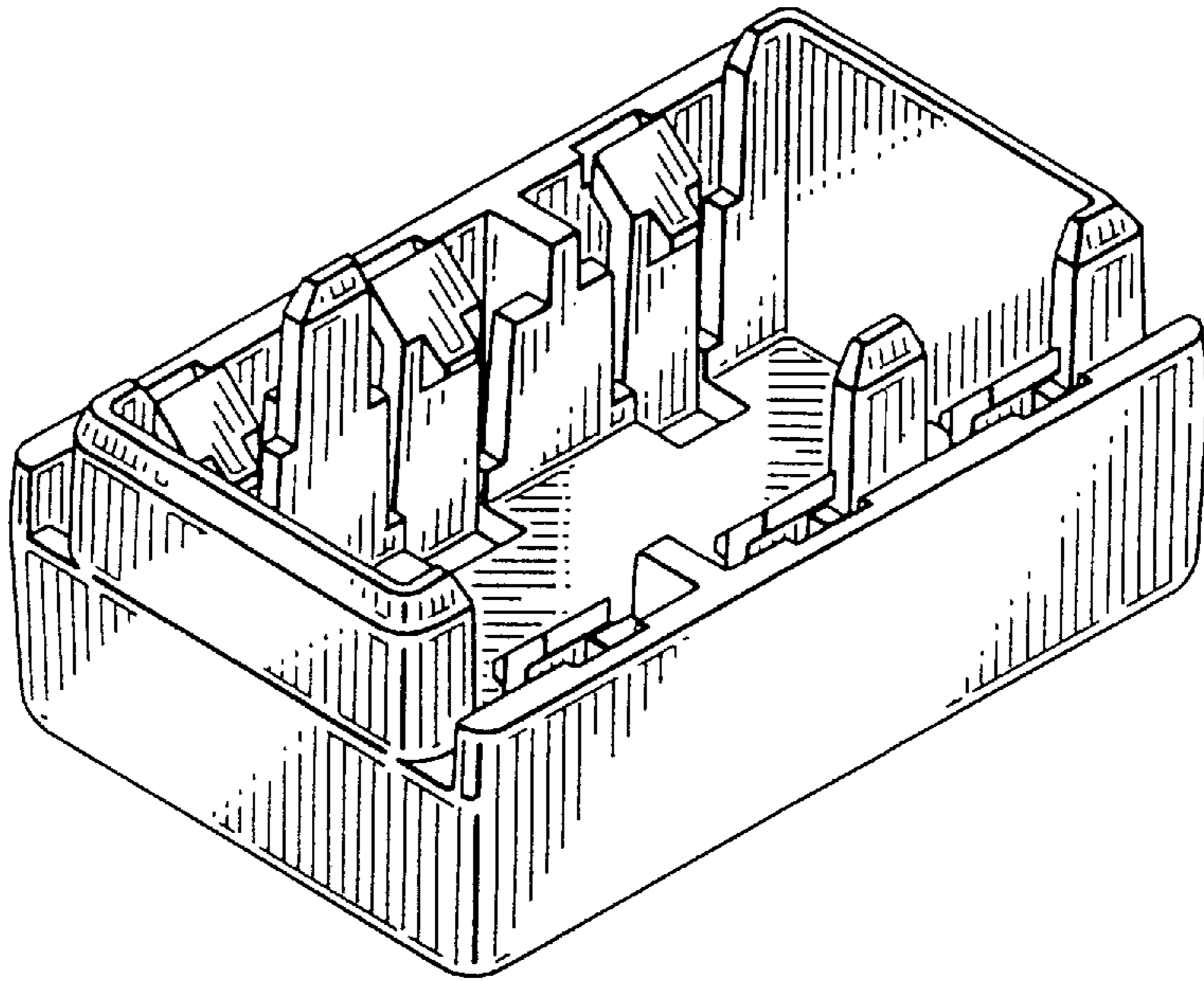

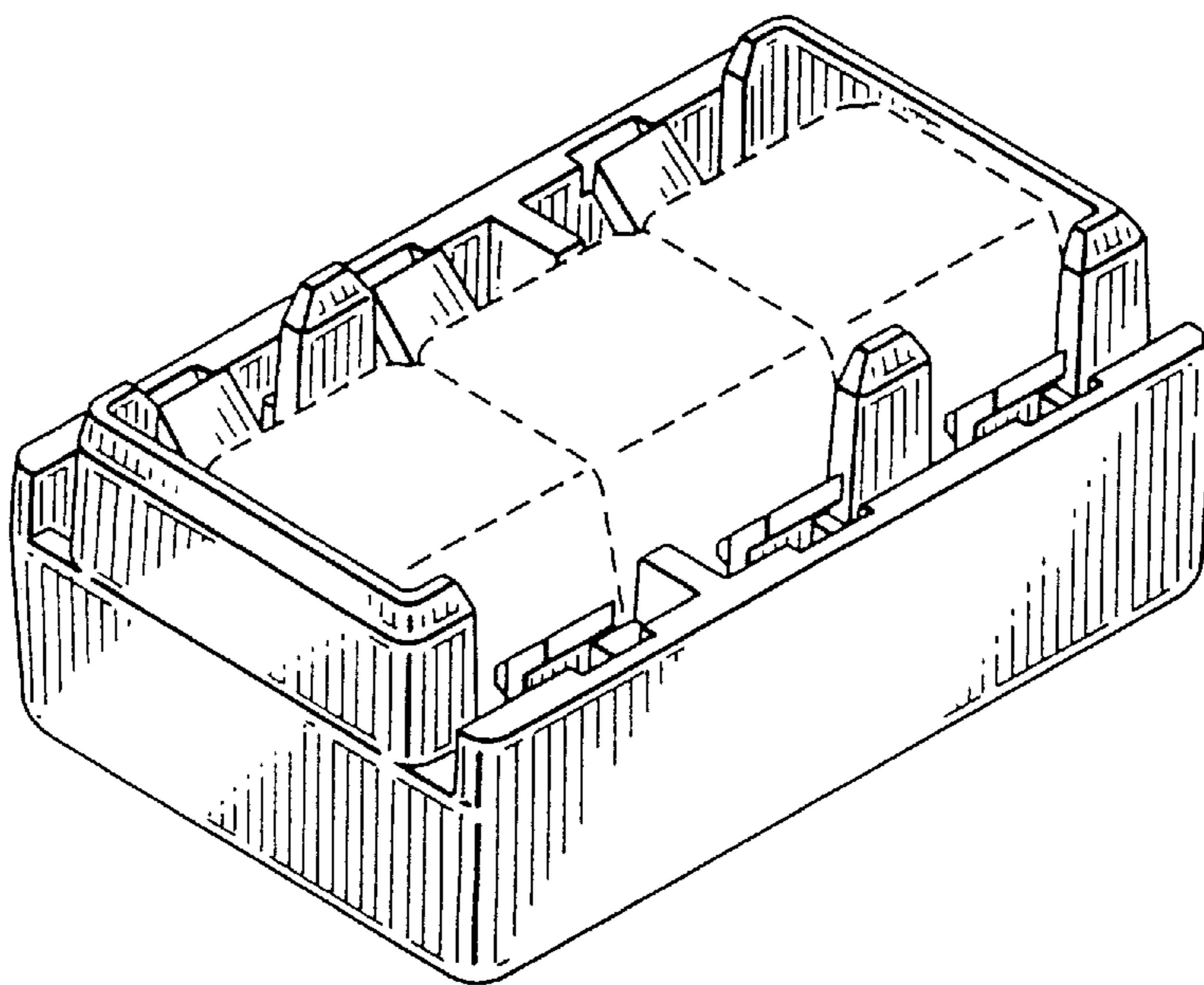

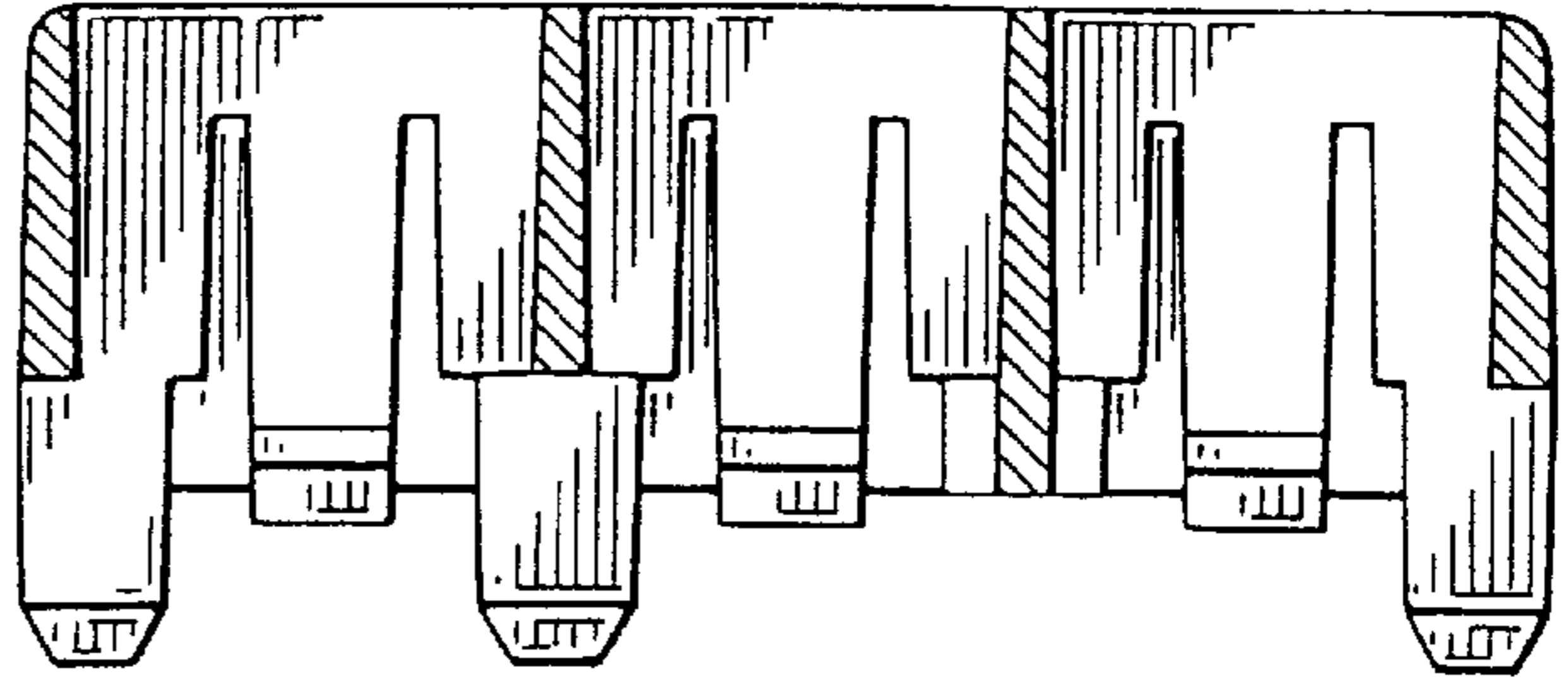

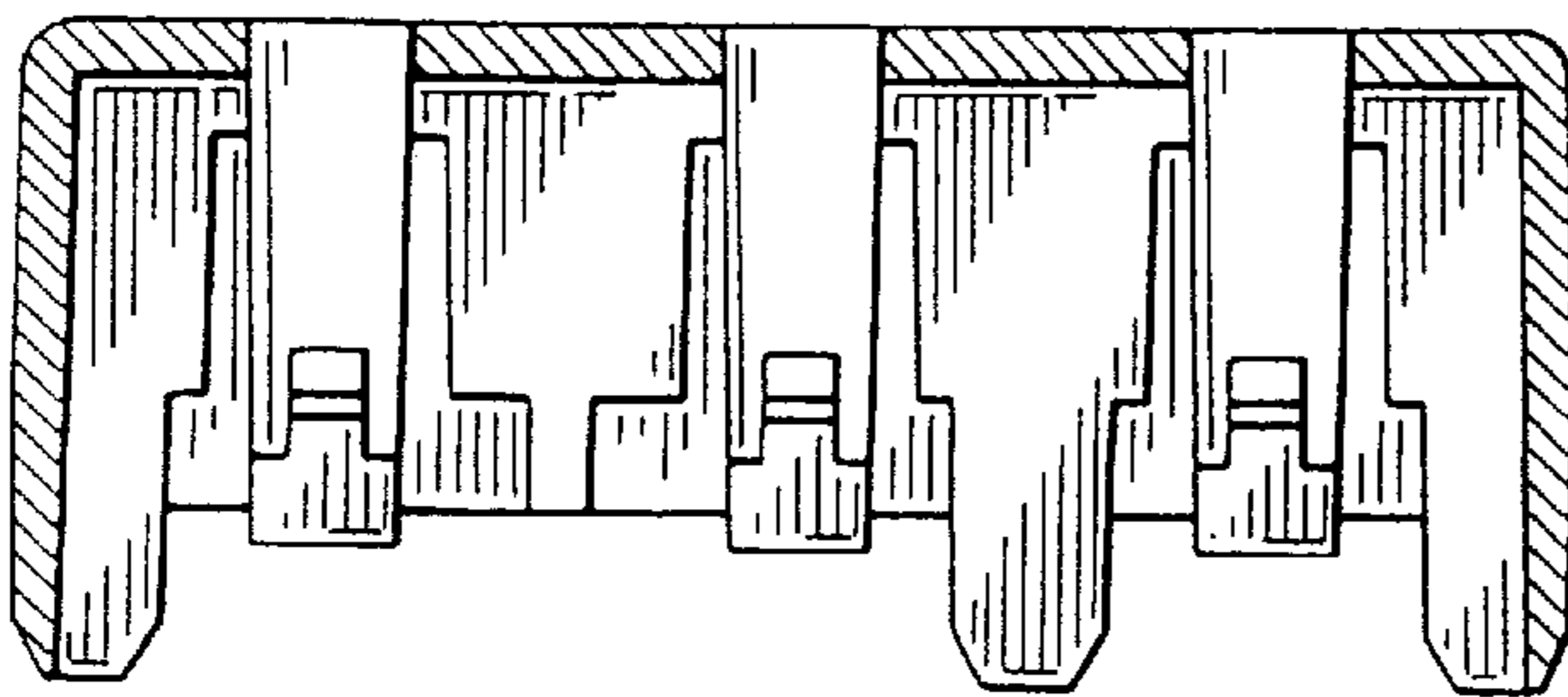
