### [57] CLAIM

The ornamental design for a rear and front frame portions of audio/video storage unit, as shown and described.

### DESCRIPTION

FIG. 1 is a front view of rear and front frame portions of audio/video storage unit showing my new design;

FIG. 2 is a rear view thereof;

FIG. 3 is a left side view thereof, the right side being a mirror image;

FIG. 4 is a front view of a second embodiment showing my new design;

FIG. 5 is a rear view thereof;

FIG. 6 is a left side view thereof, the right side being a mirror image;

FIG. 7 is a perspective view of a third embodiment showing my new design;

FIG. 8 is a front view thereof;

FIG. 9 rear view thereof;

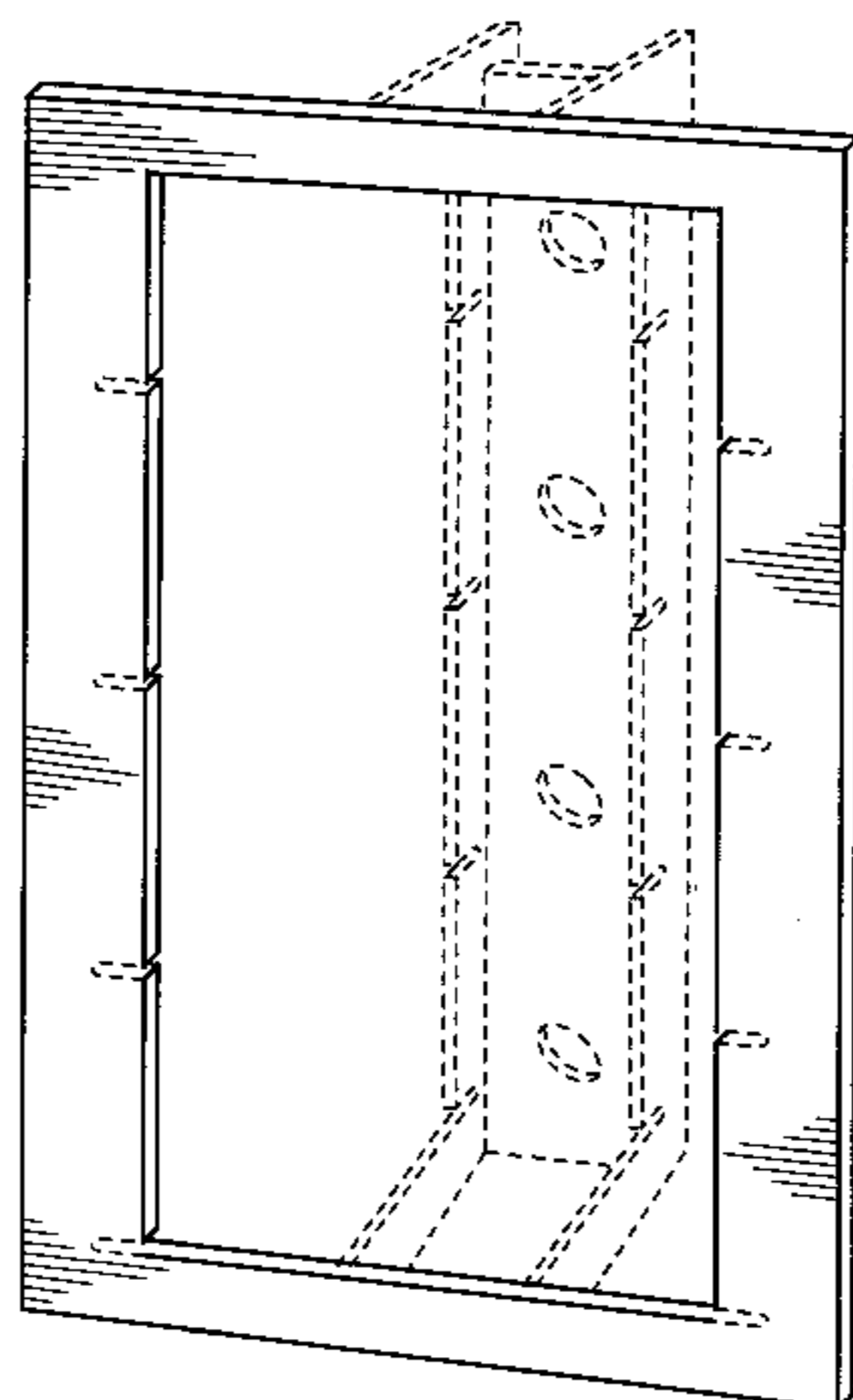


FIG. 10 is a left side view thereof, the right side being a mirror image;

FIG. 11 is a top view of the three embodiments of my design shown in FIGS. 1-10; and,

FIG. 12 is a bottom view of the three embodiments of my design shown in FIGS. 1-10.

The dashed brokent lines are shown in the figures for environmental purposes only and form no part of the claimed design. The dashed broken lines in FIG. 7 extending between the claimed rear frame portion and the claimed front frame portion comprise unclaimed left and right

C-shaped frame members. The unclaimed left and right C-shaped frame members are not shown in FIGS. 1, 2, 4, 5, 8 and 9 and the unclaimed left C-shaped frame member is not shown in FIGS. 3, 6 and 10 so as not to obscure any portion of the claimed design. The dotted broken lines, as well as the dashed broken lines on the front frame portion, shown in FIGS. 1, 2, 4, 5, 7, 8 and 9, define the boundaries of the claimed design and form no part thereof.

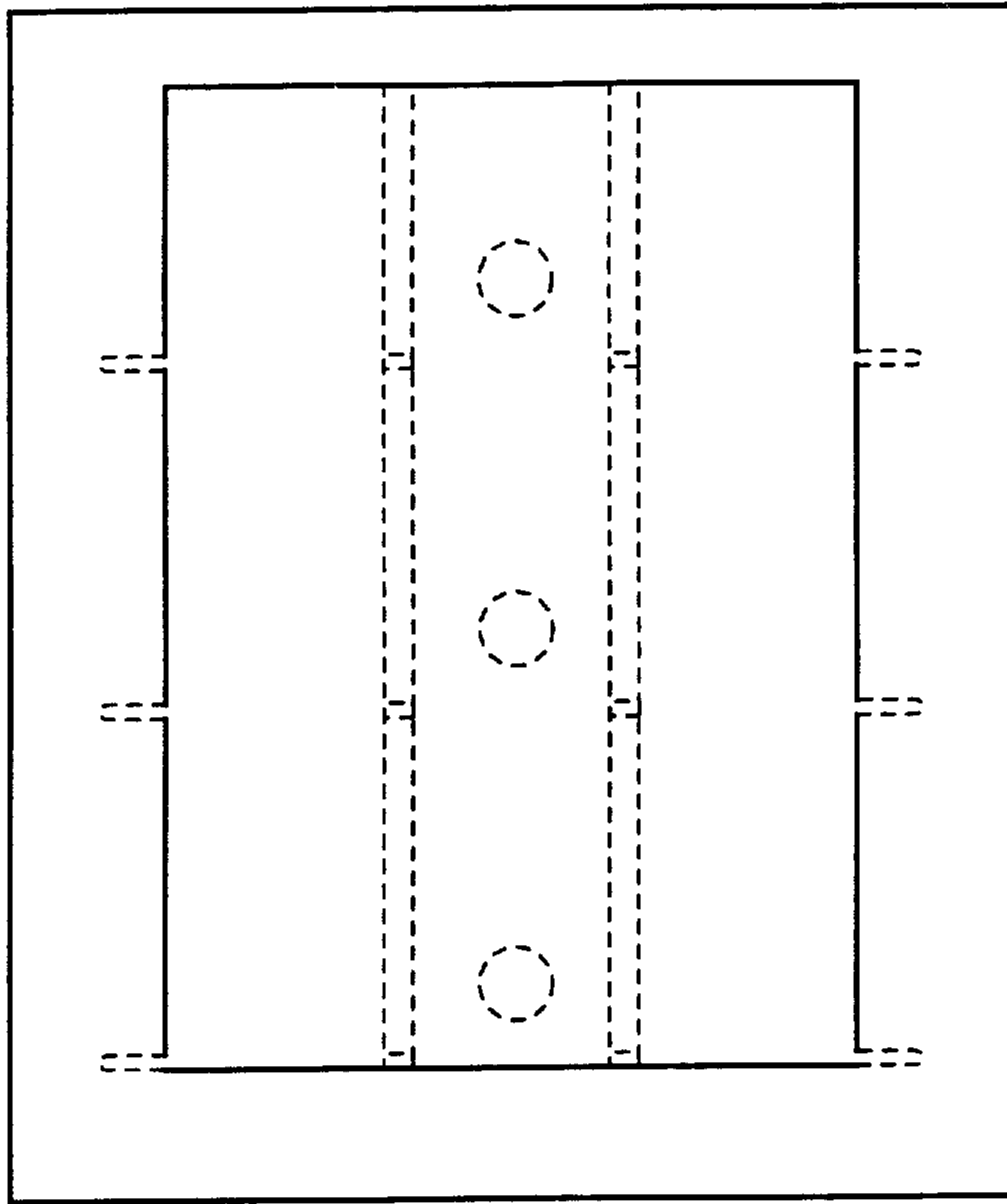

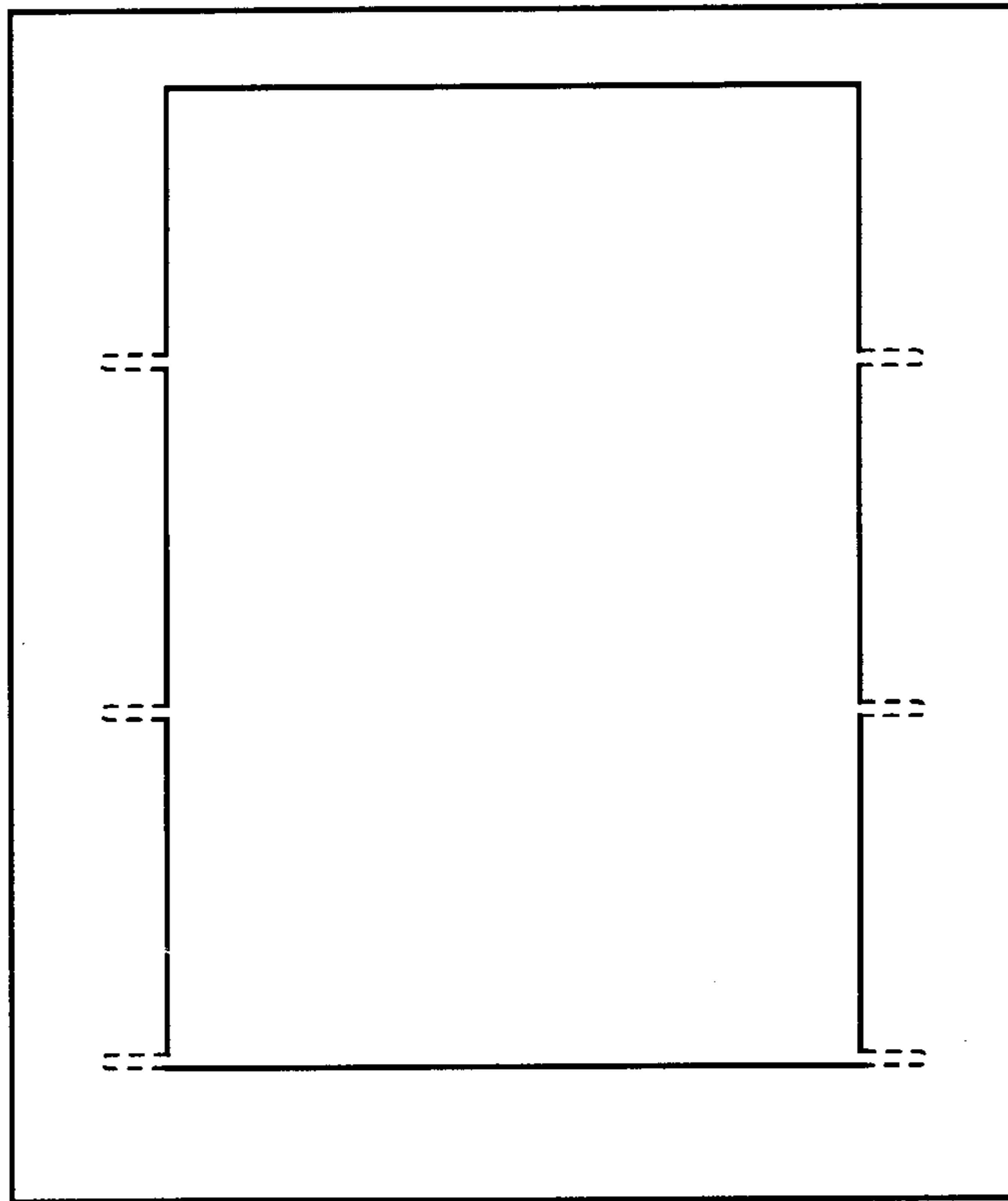

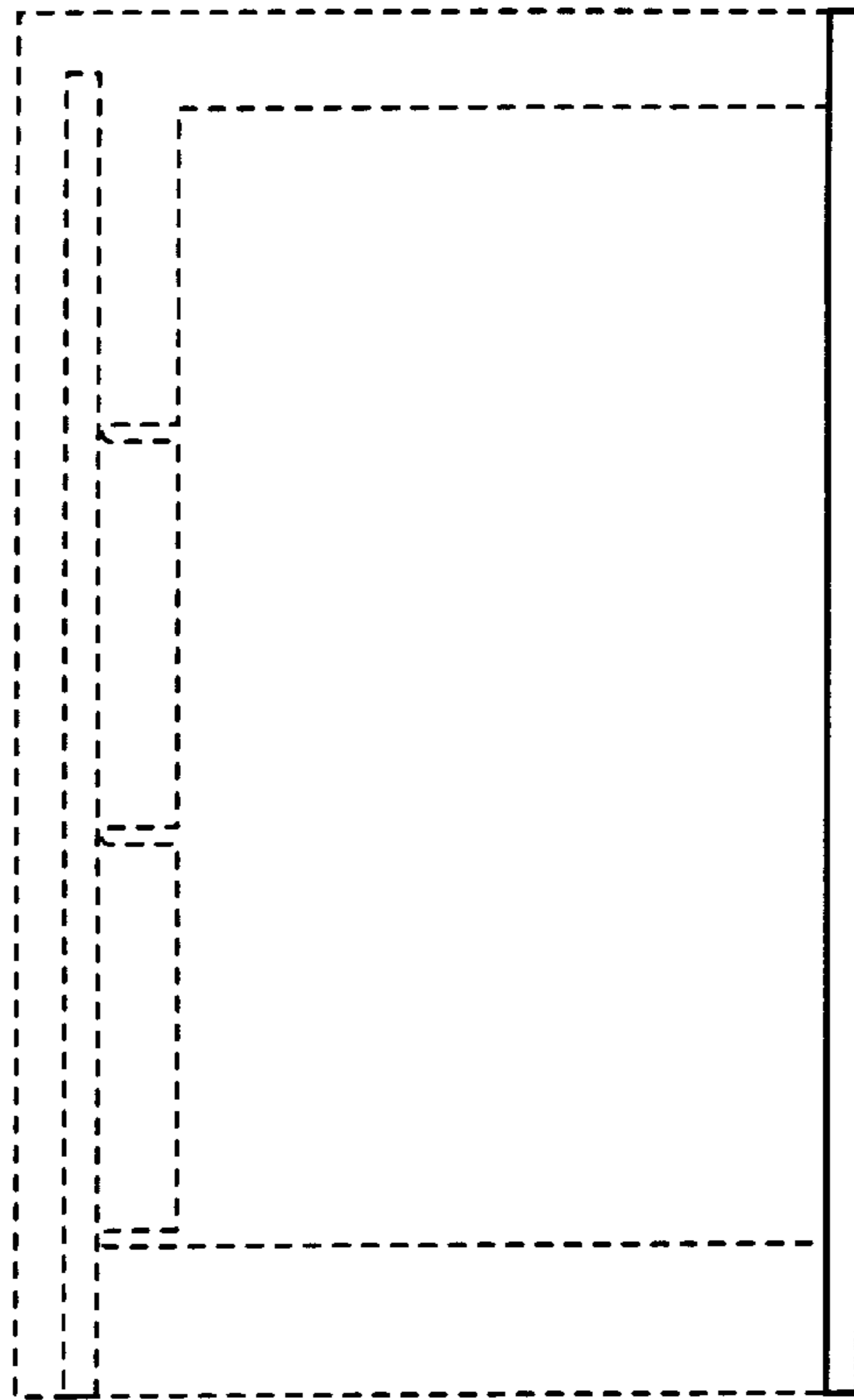

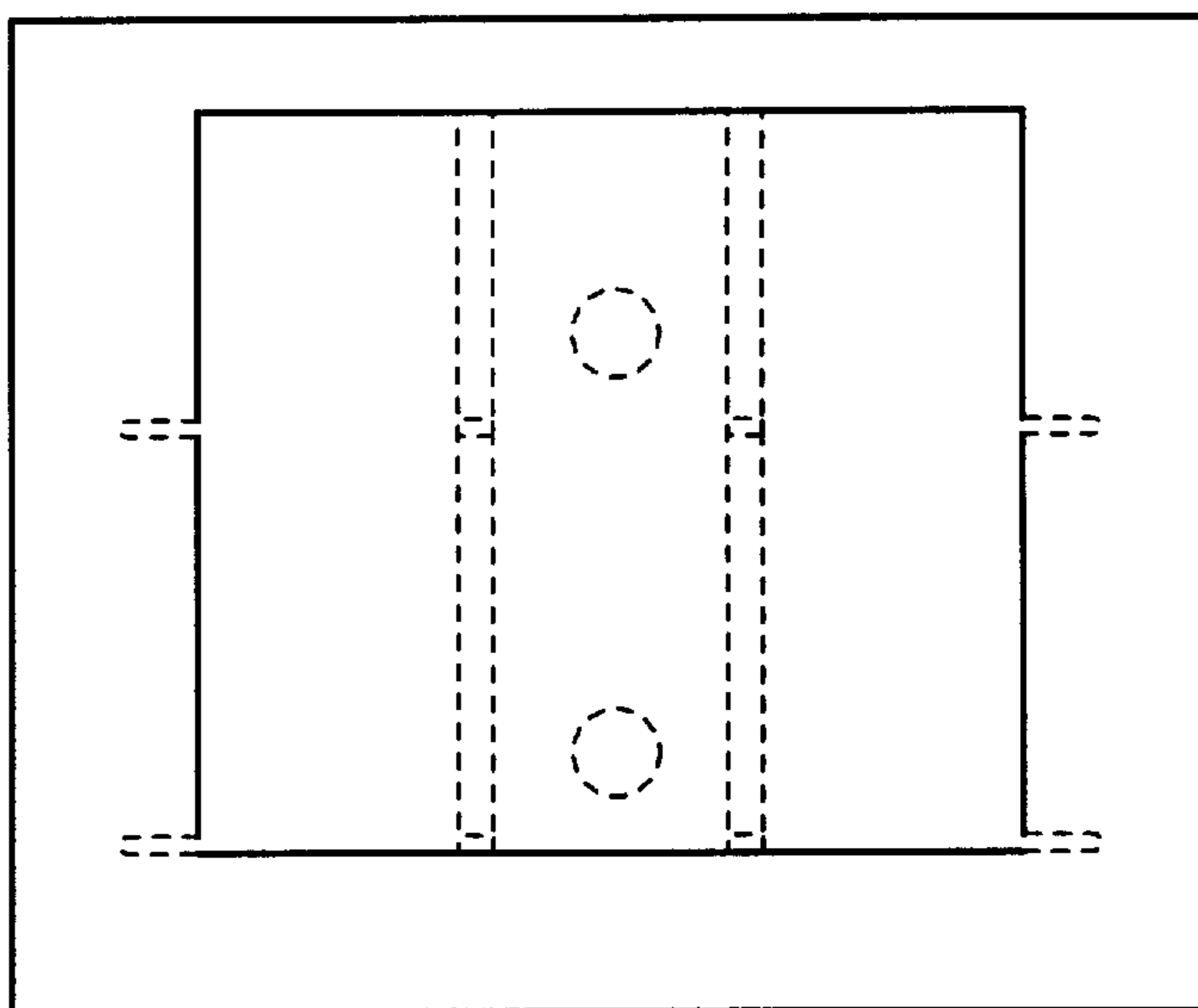

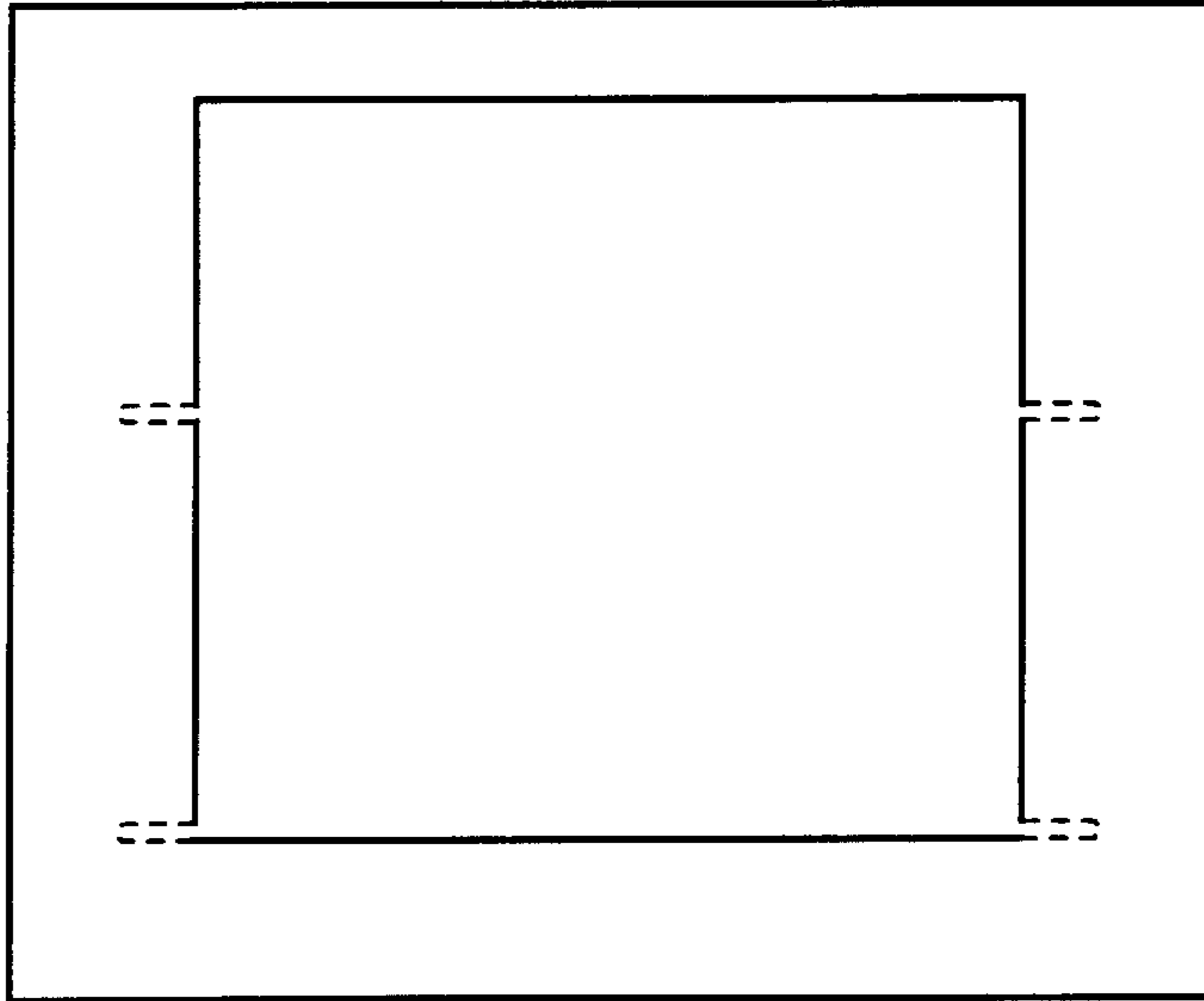
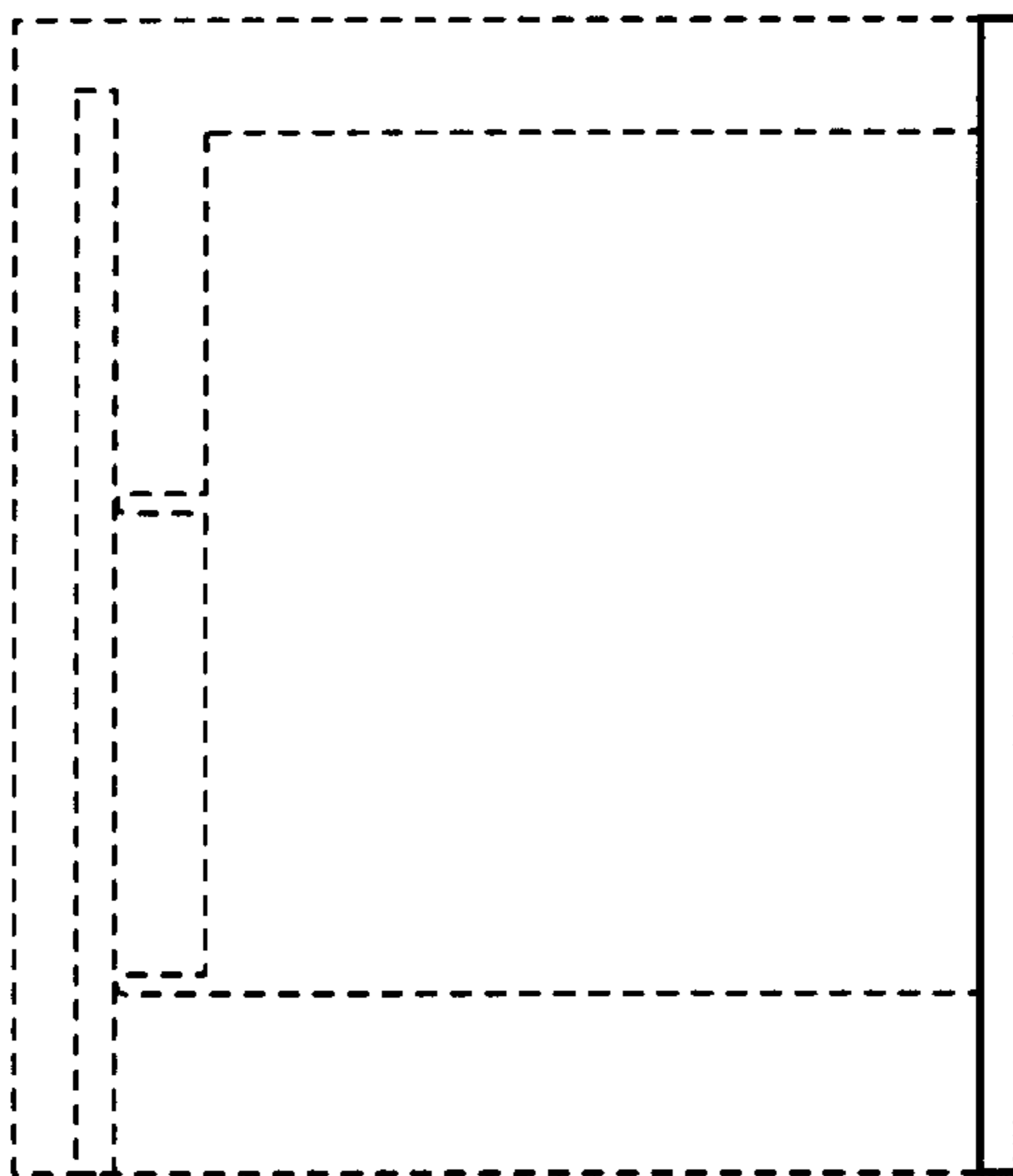

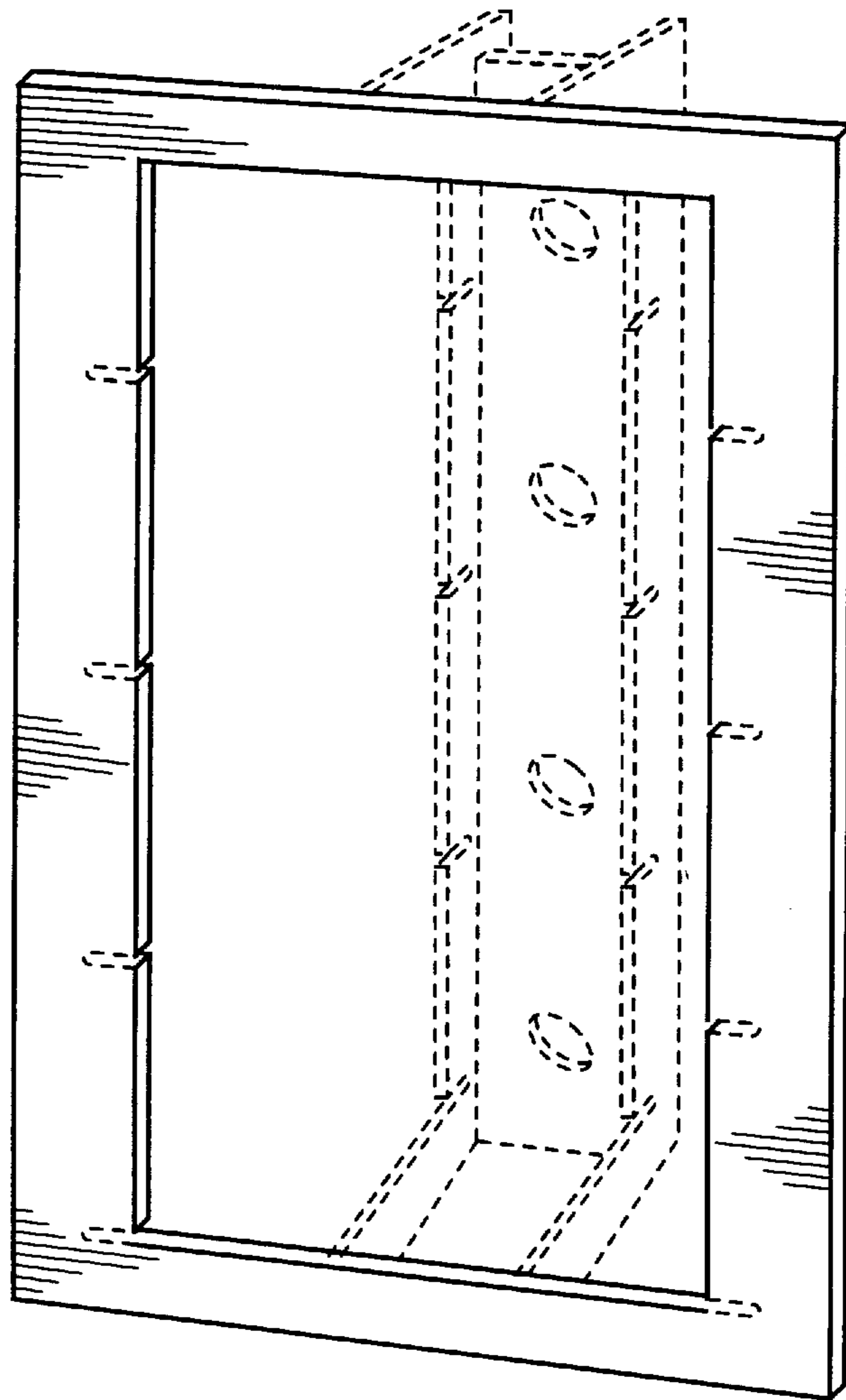

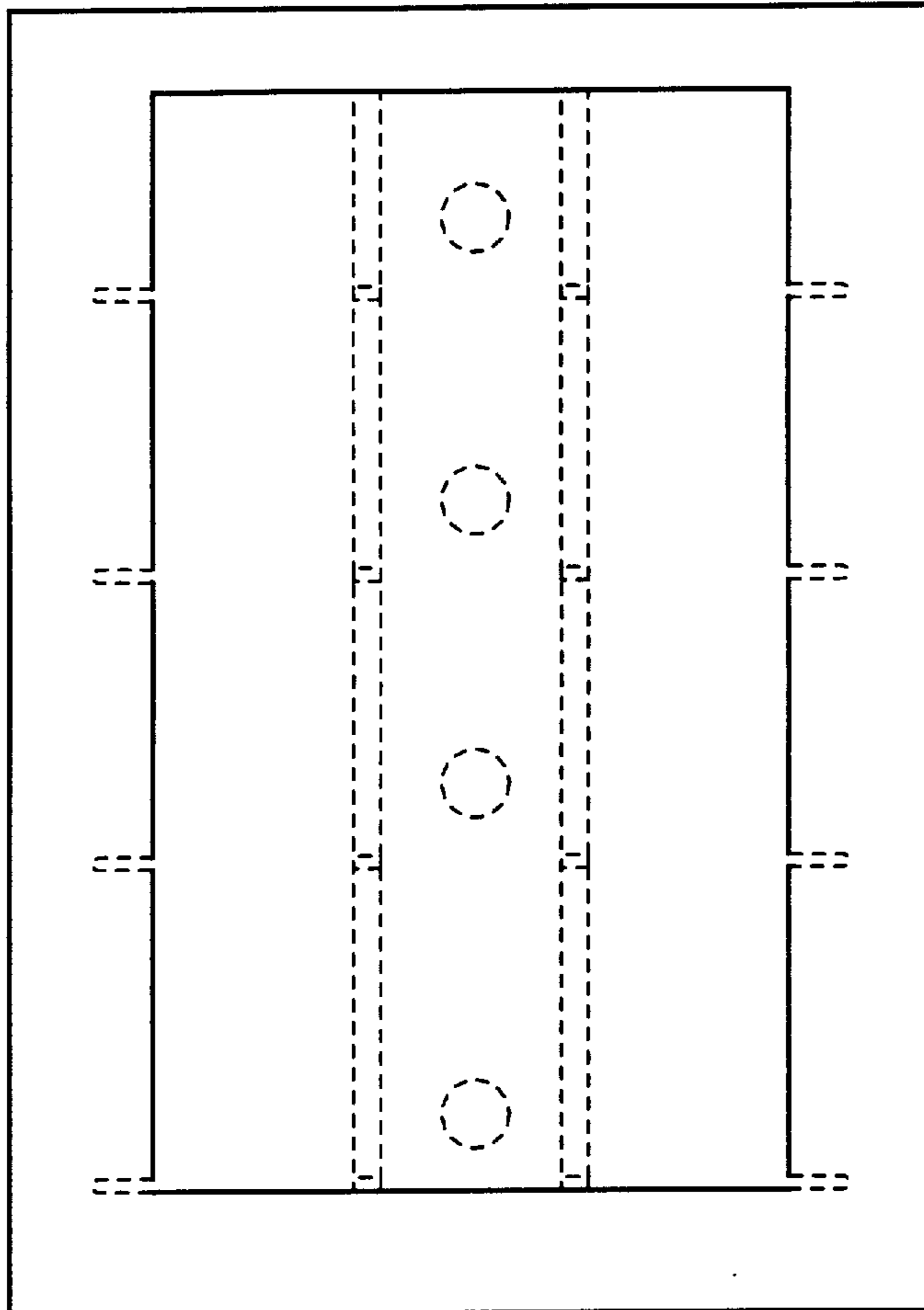

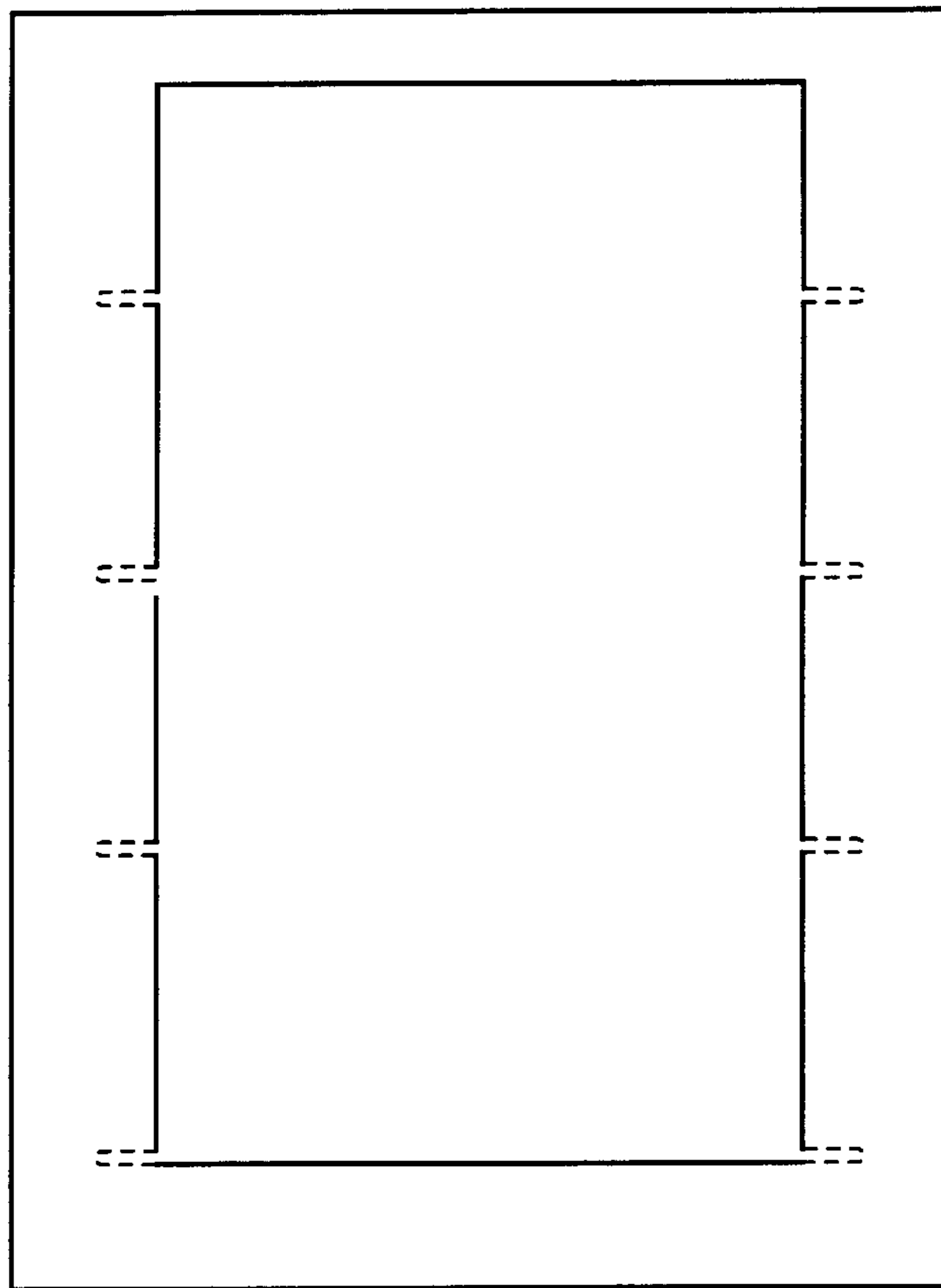

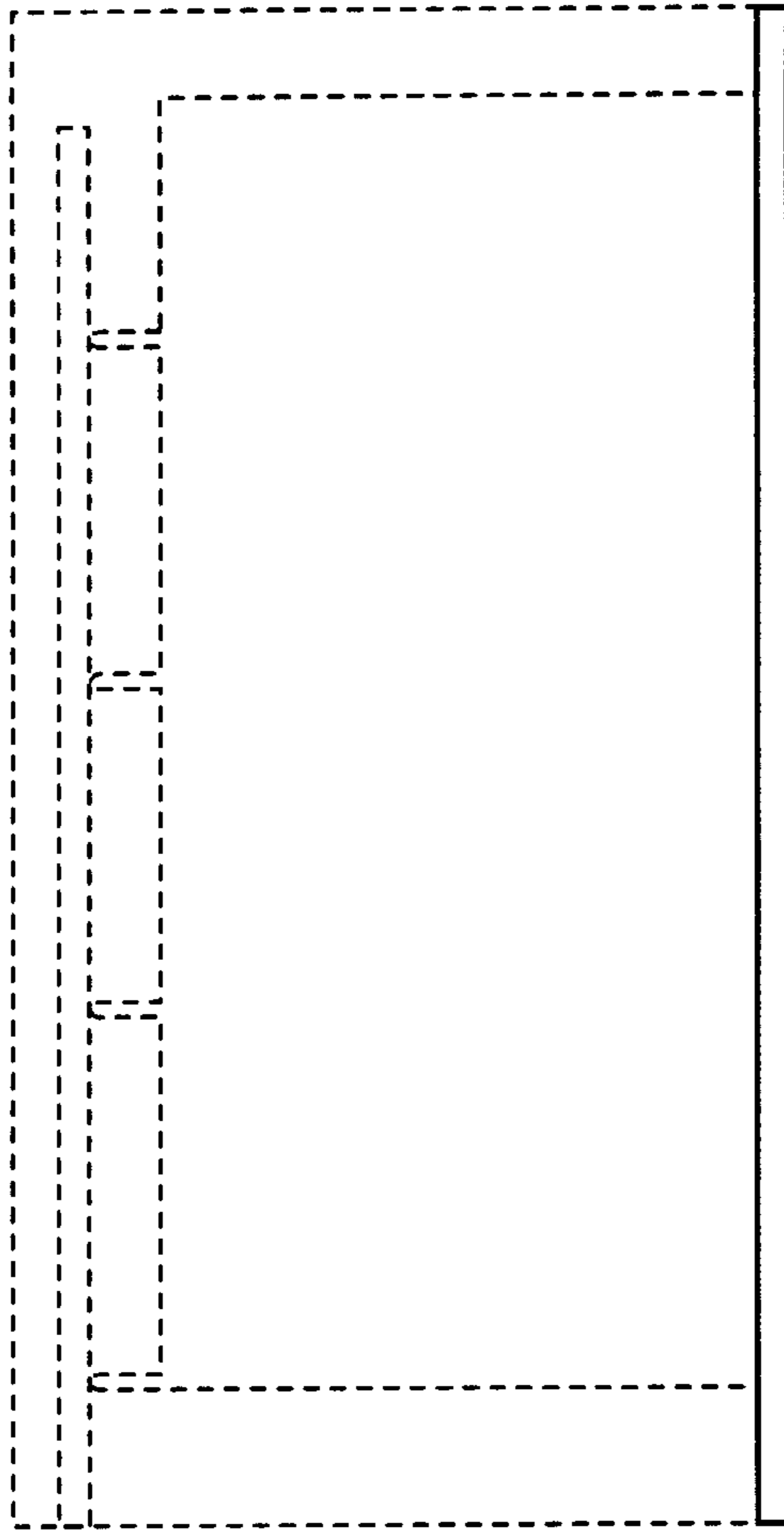

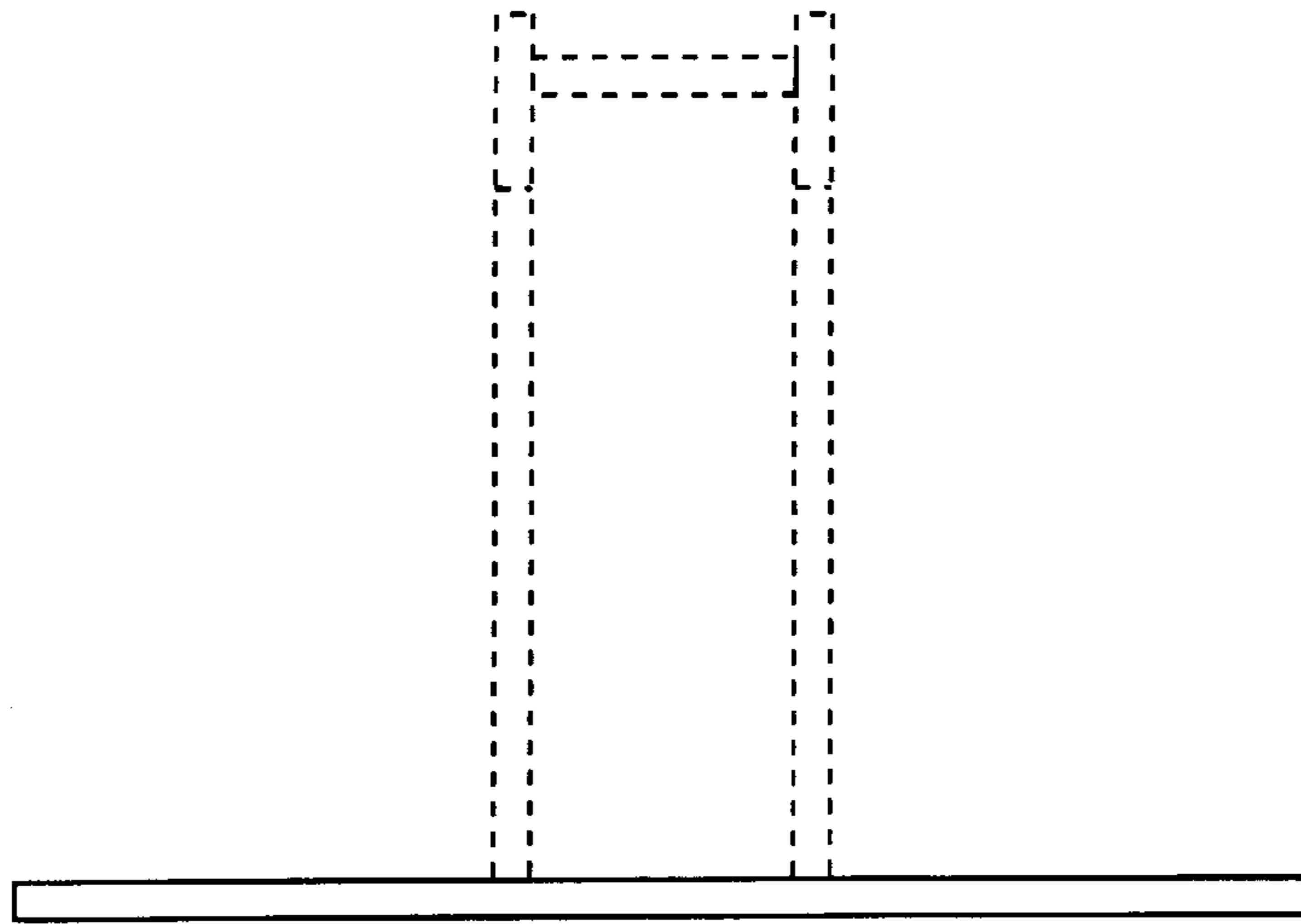

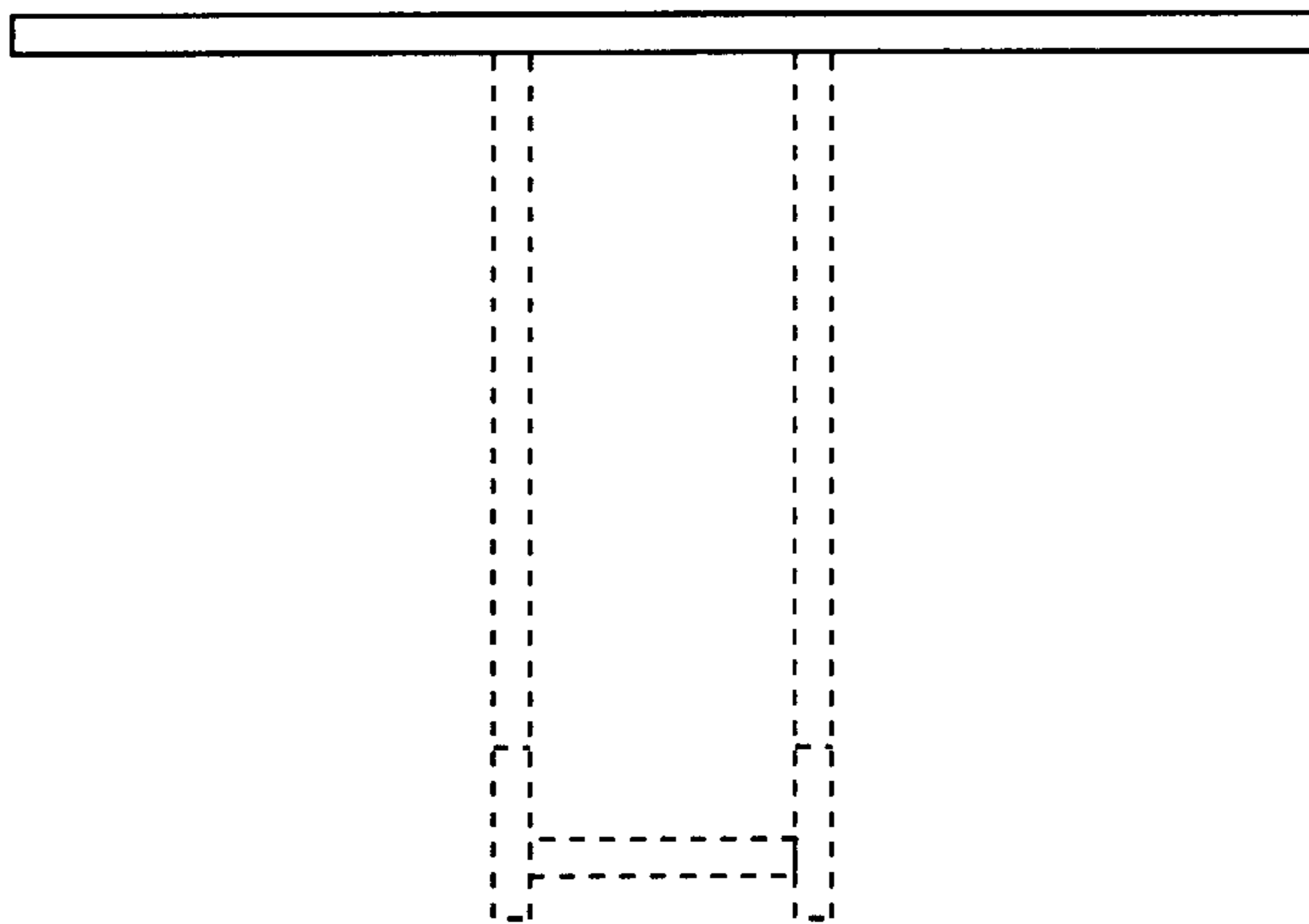

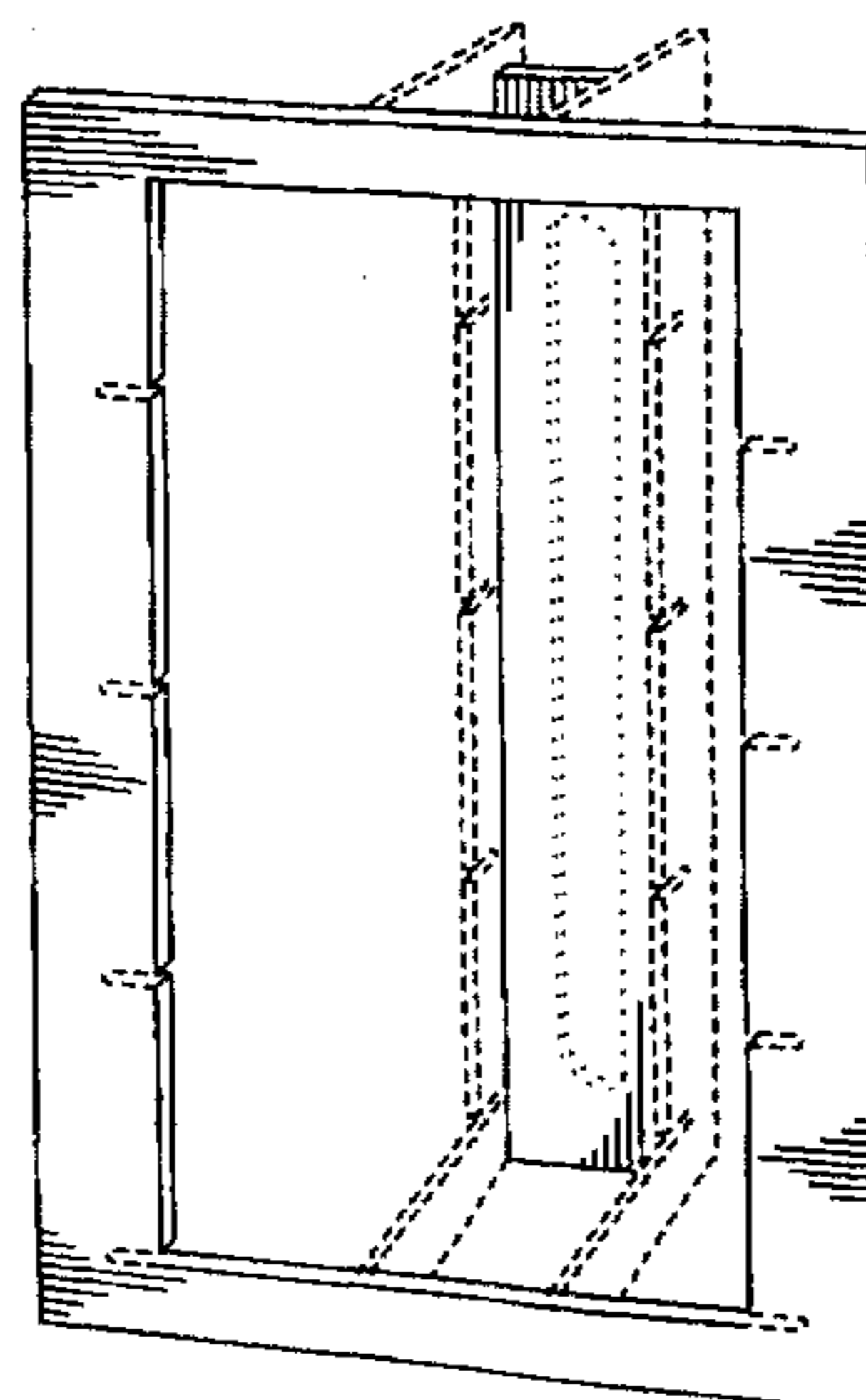

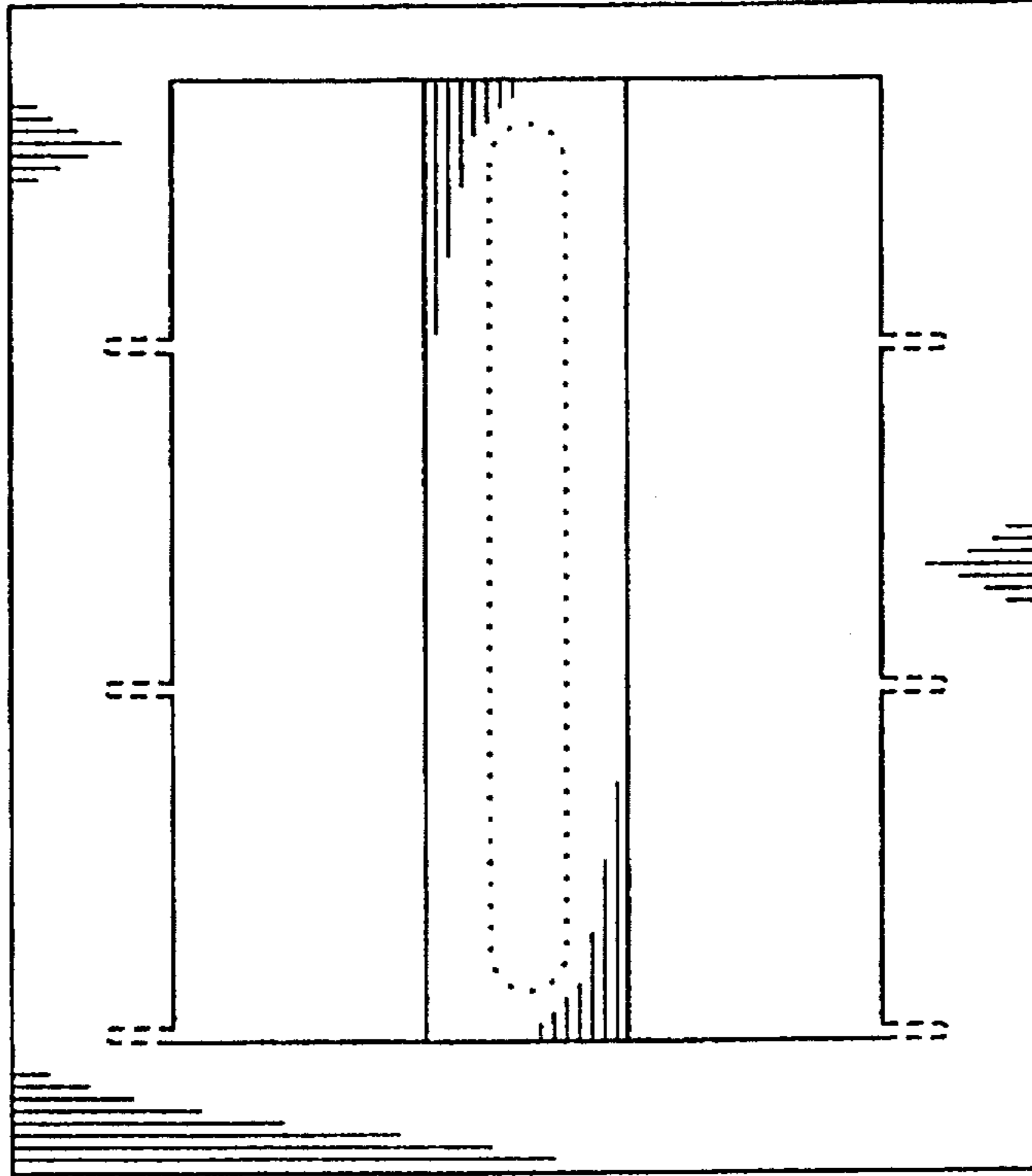

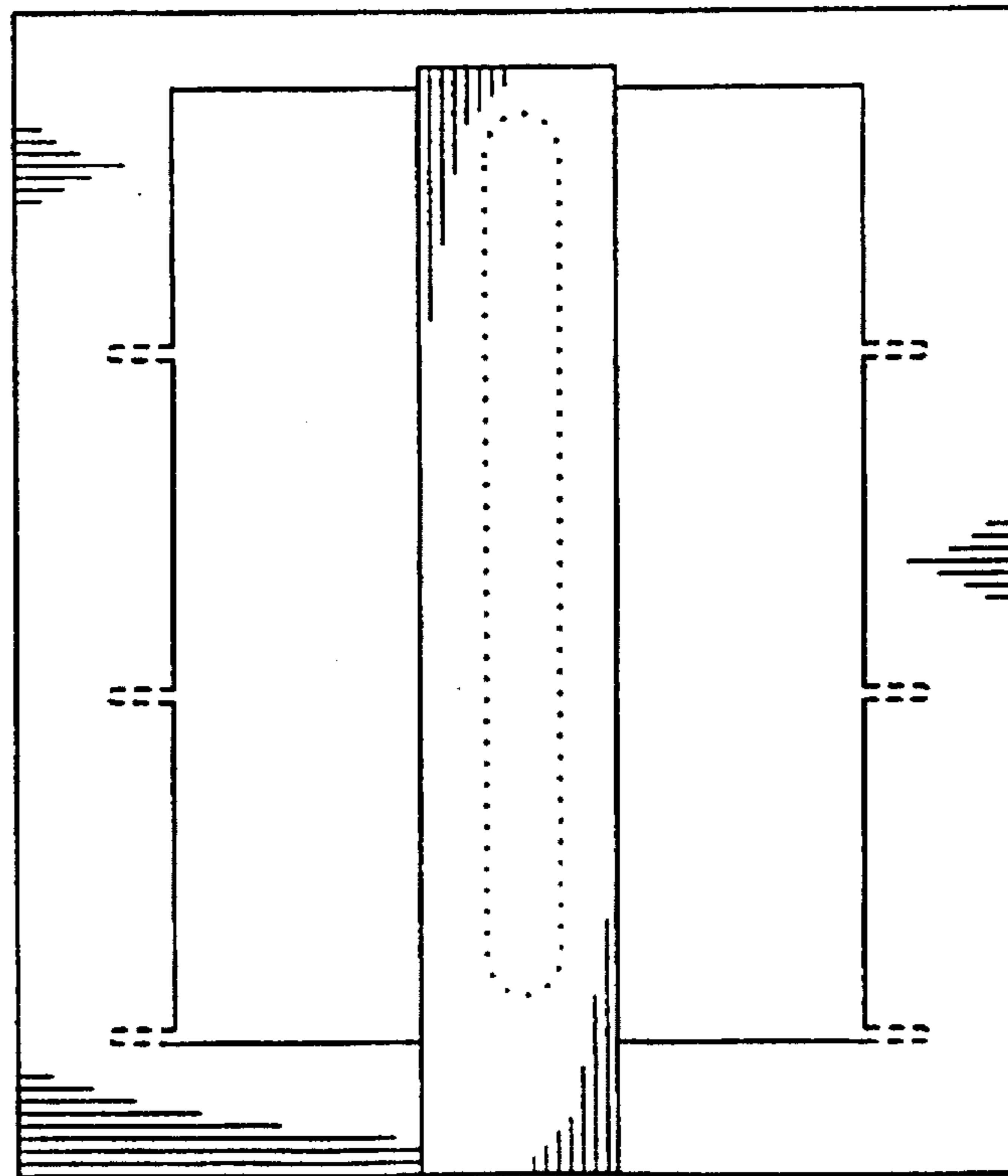

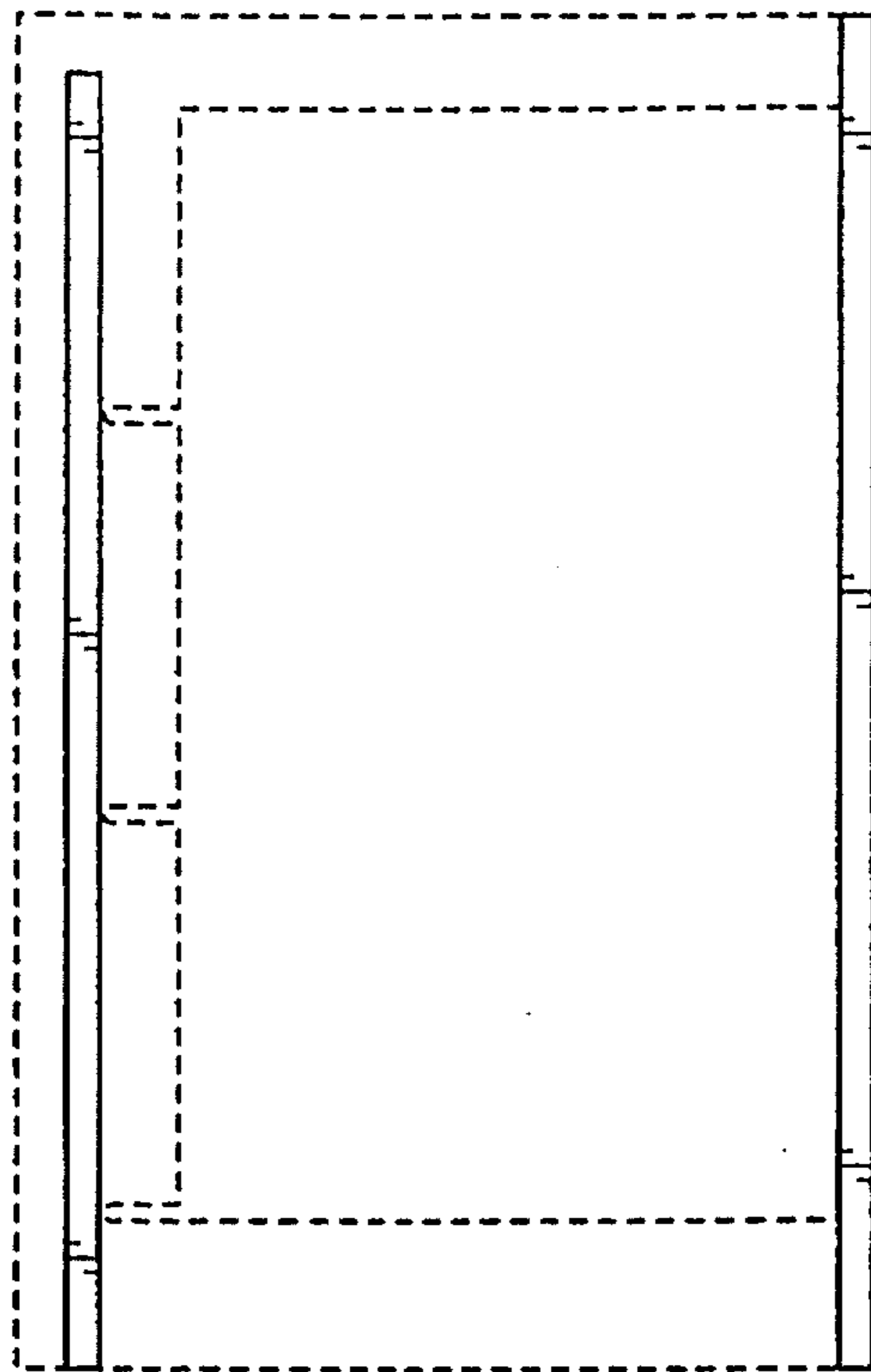

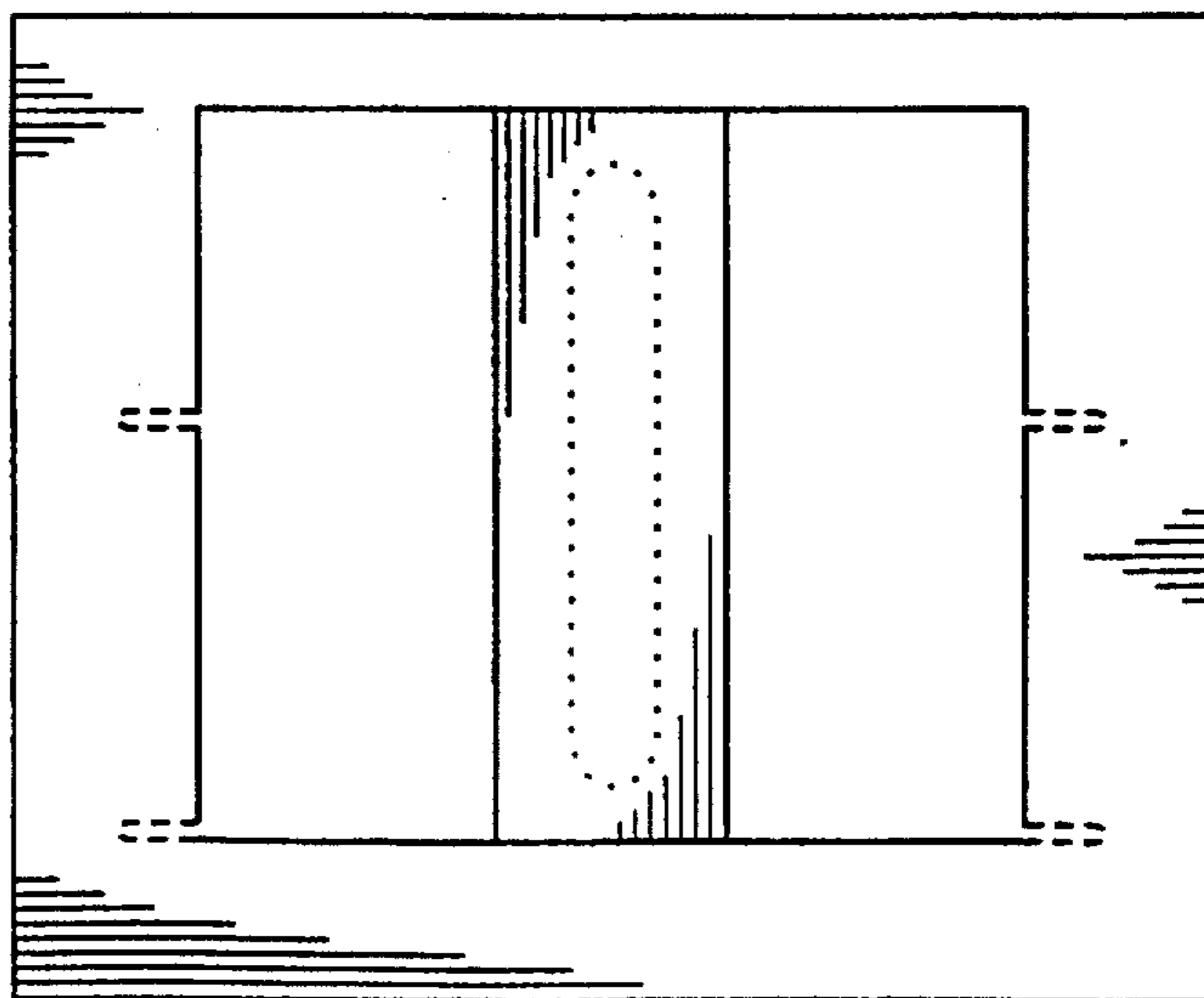

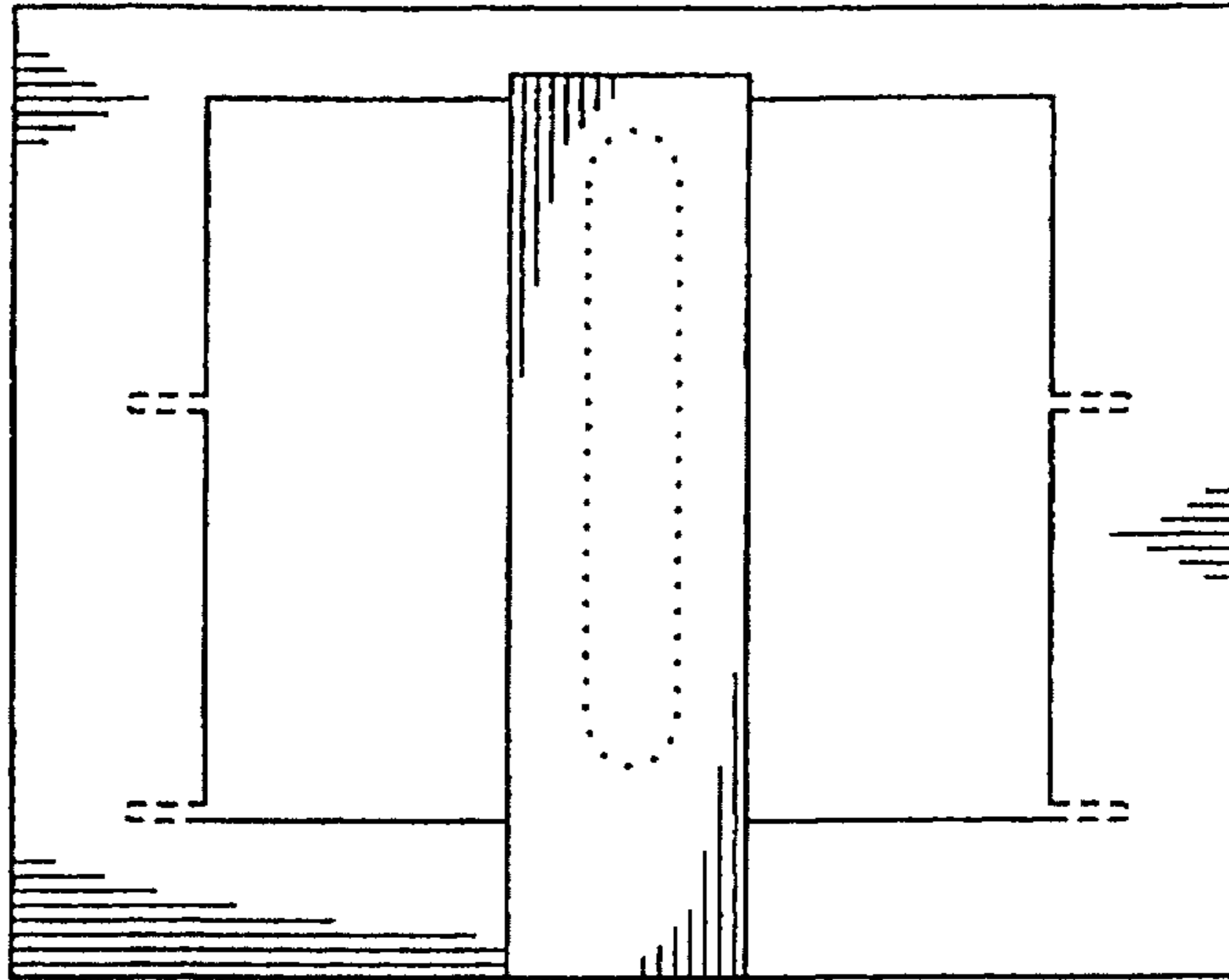
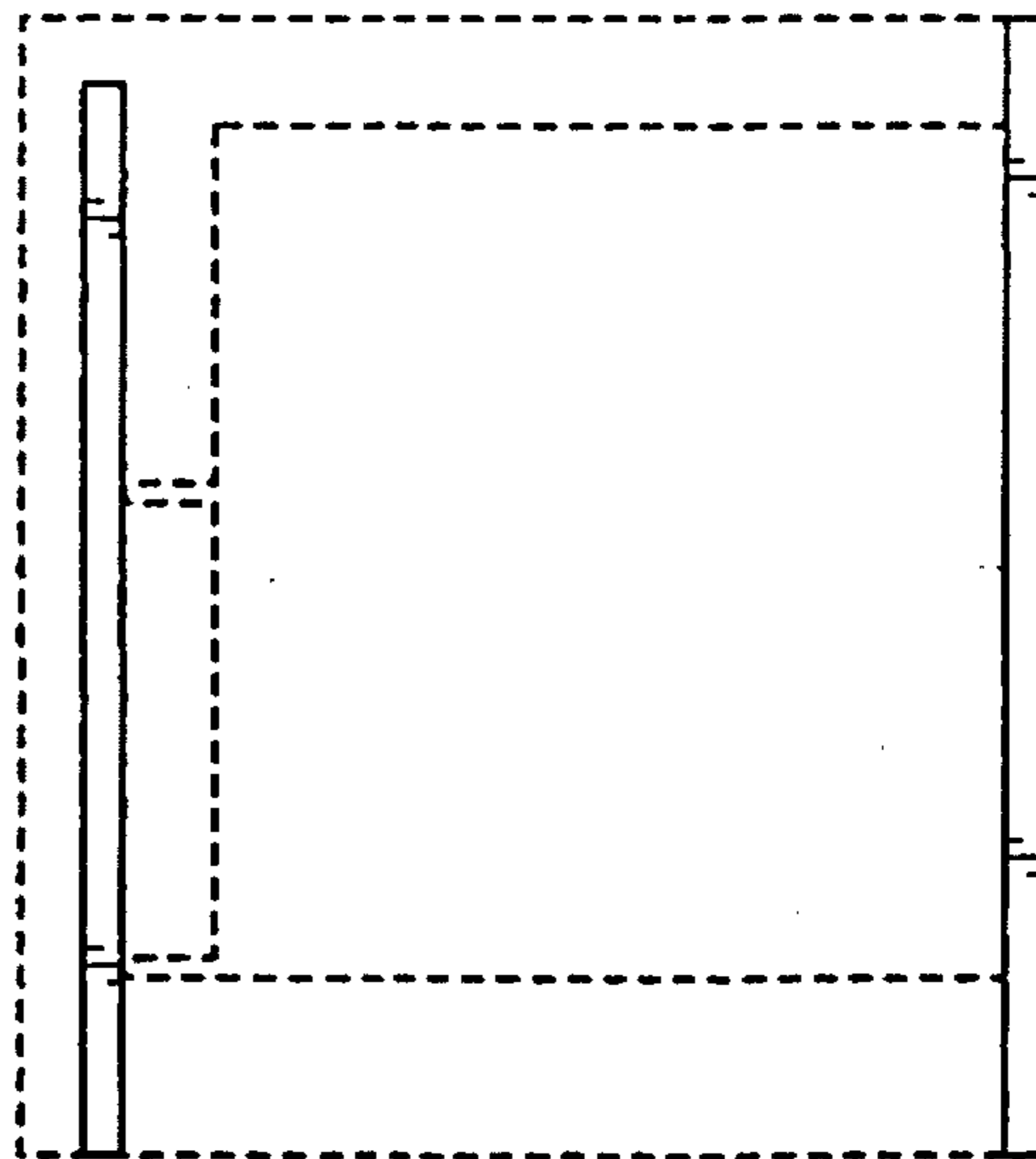

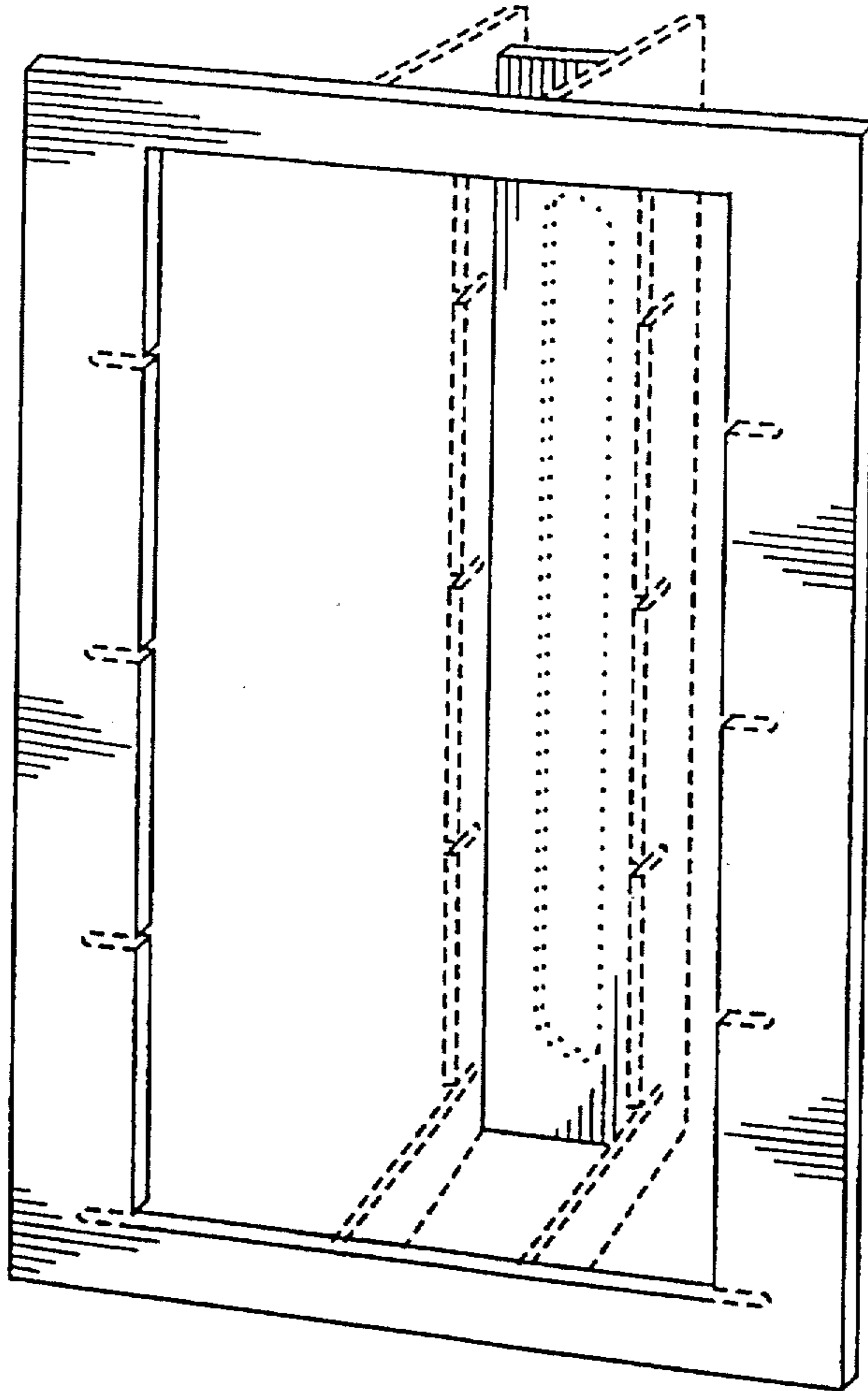

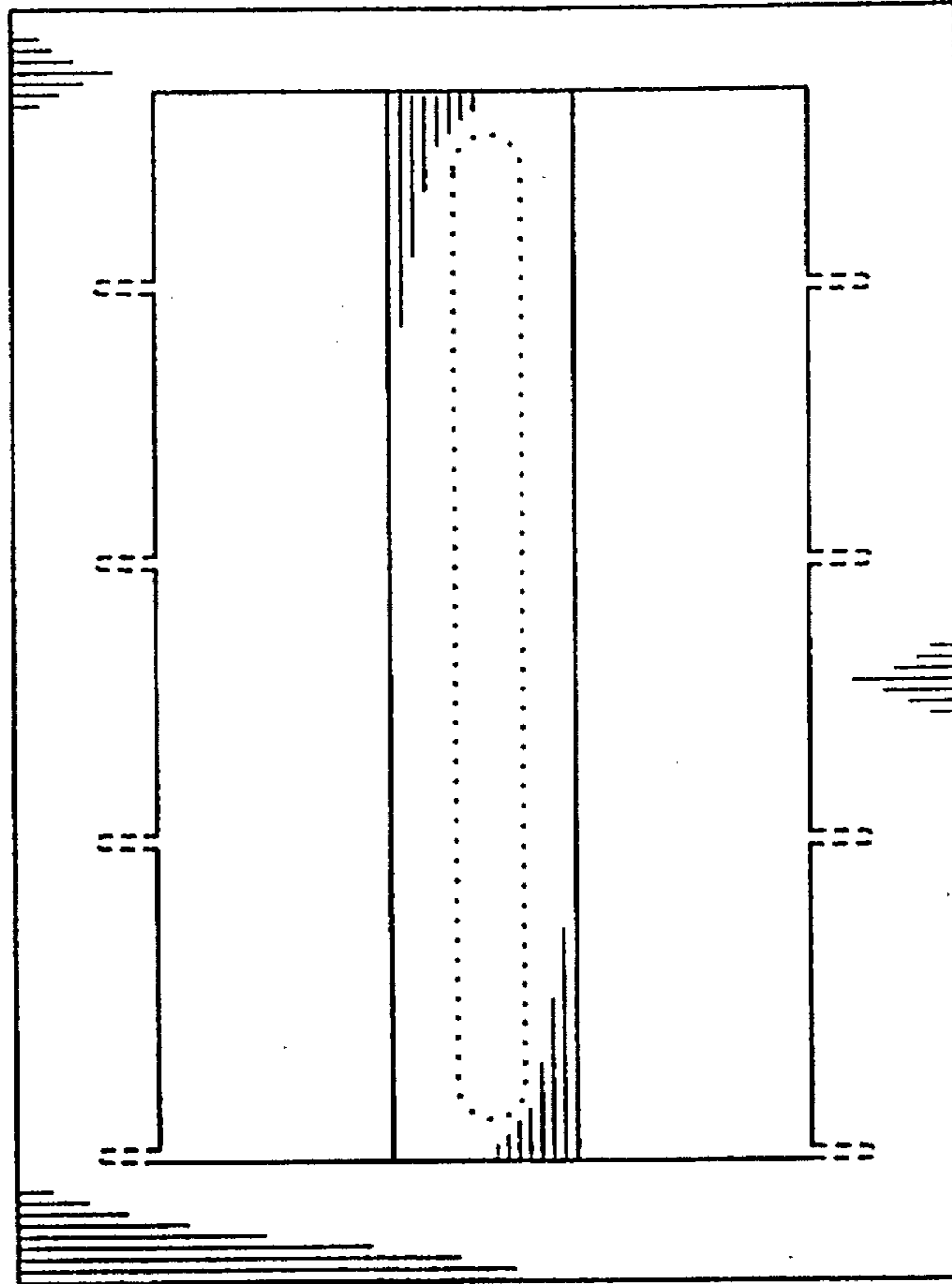

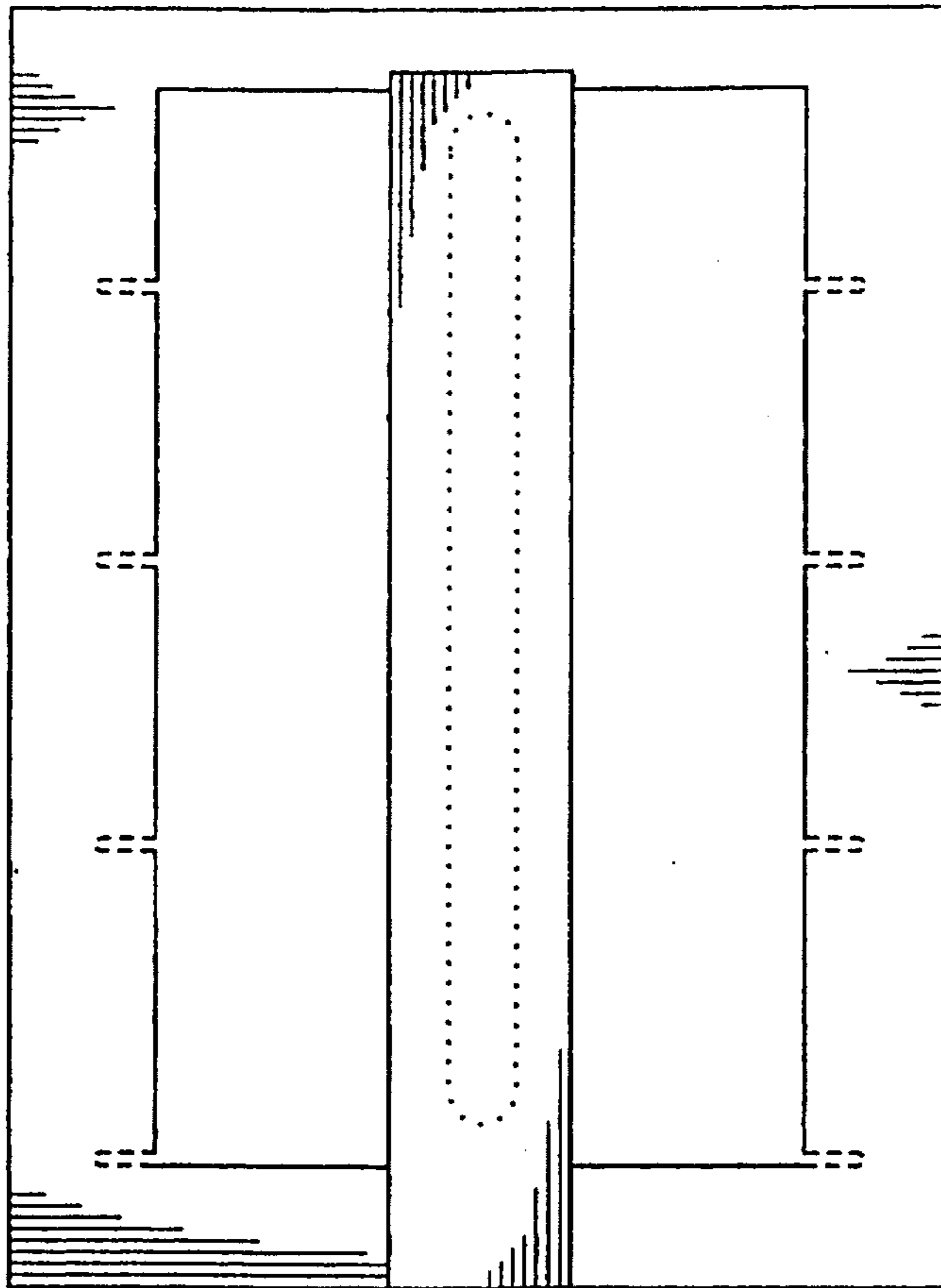

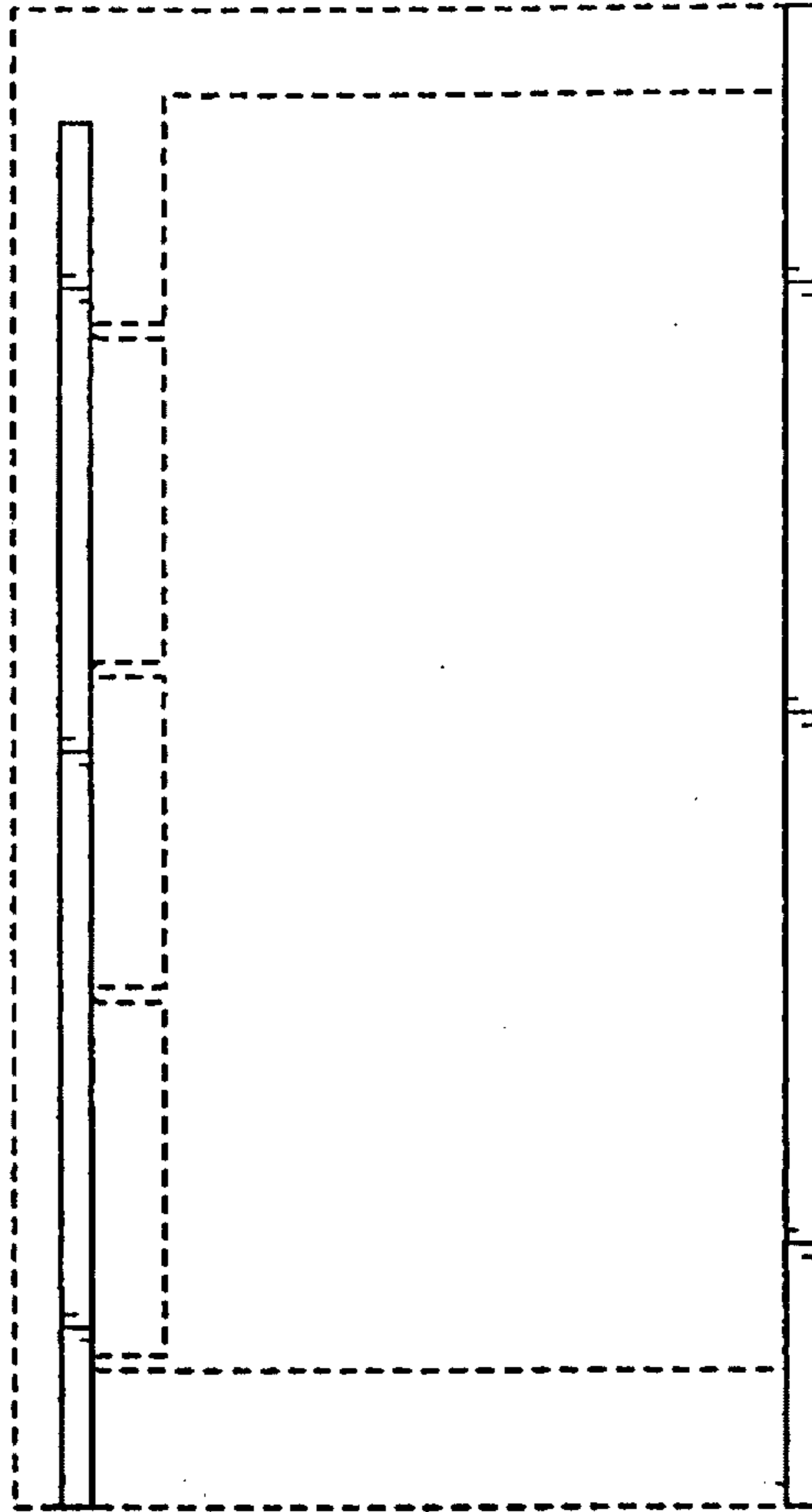

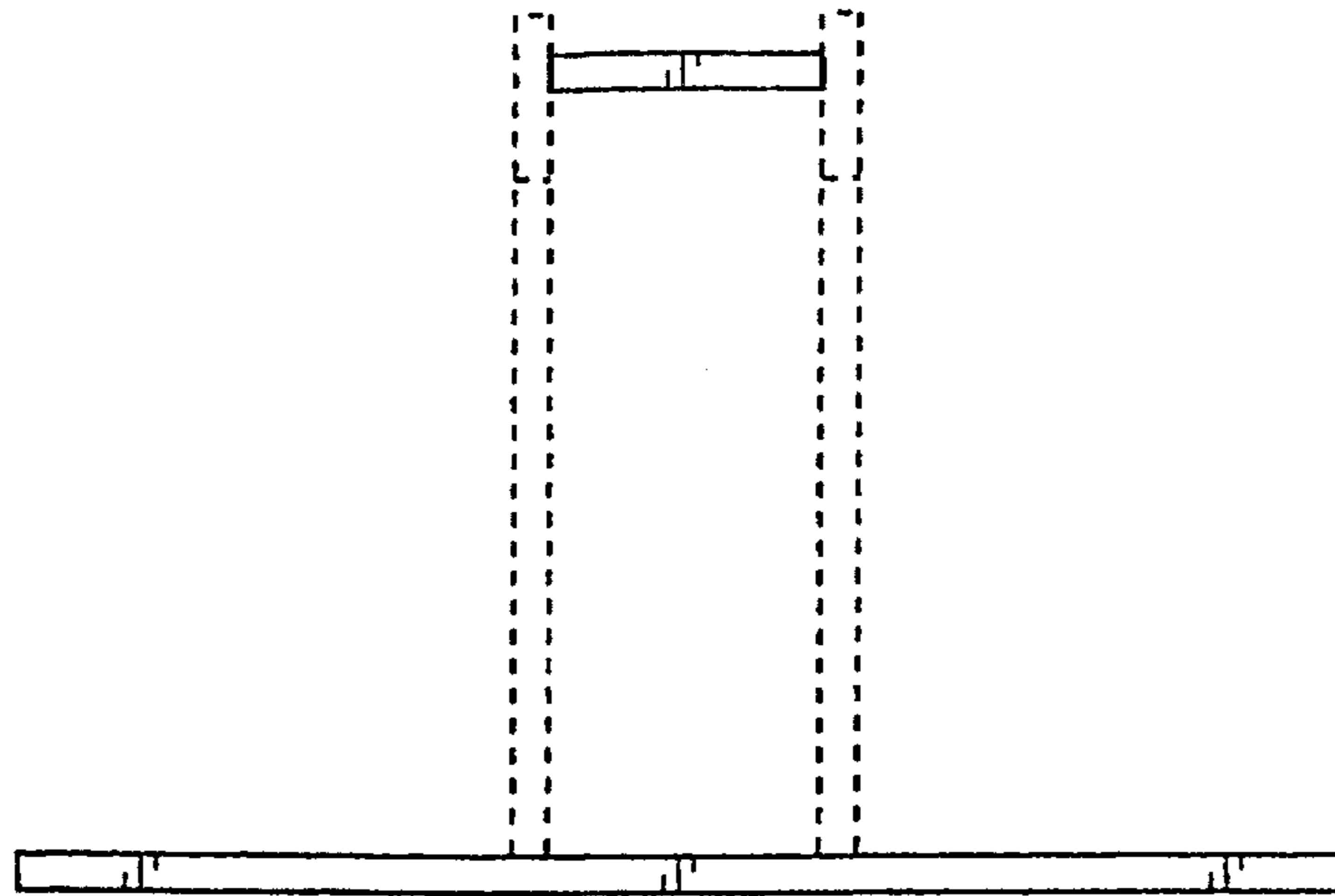

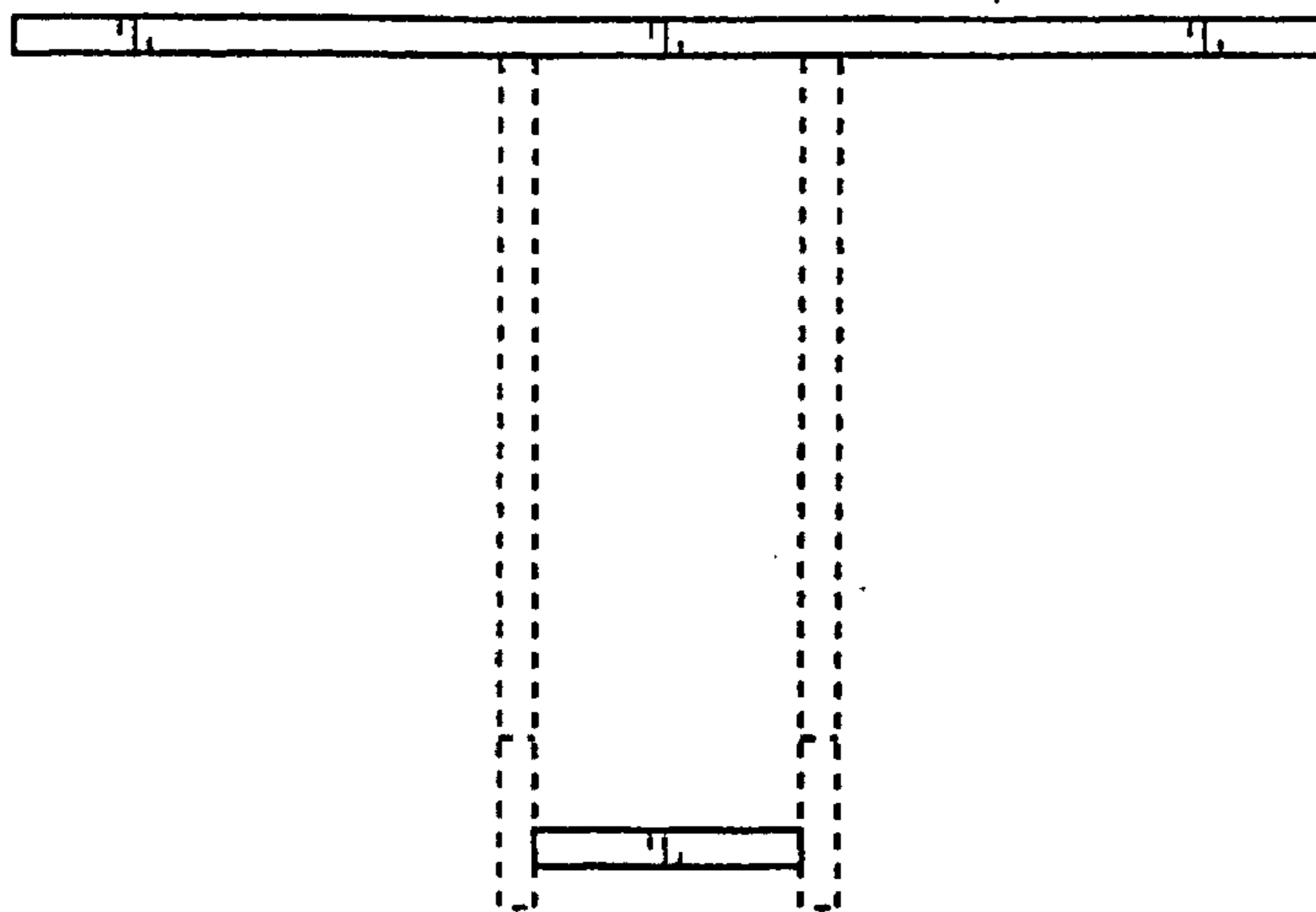
