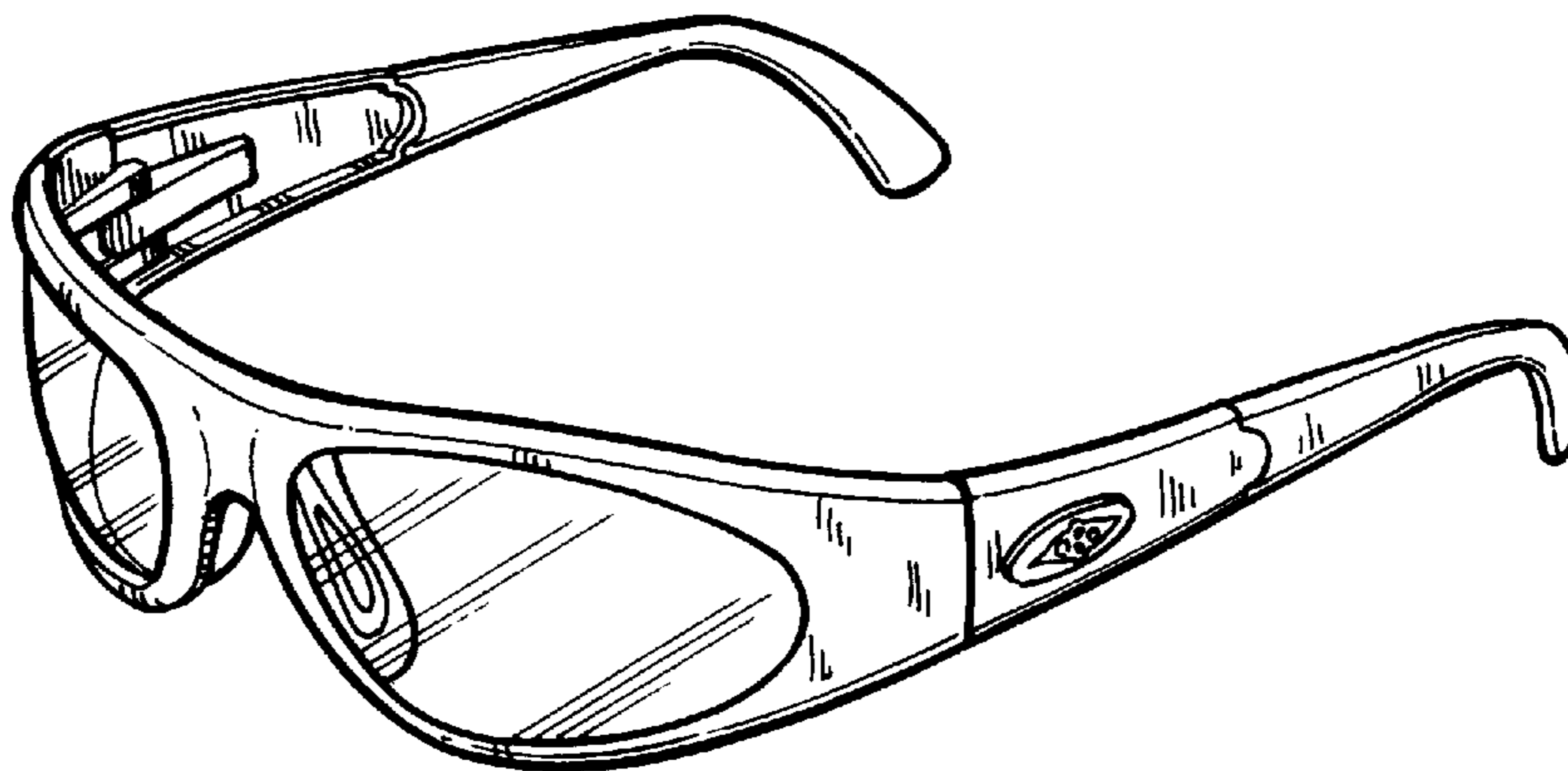

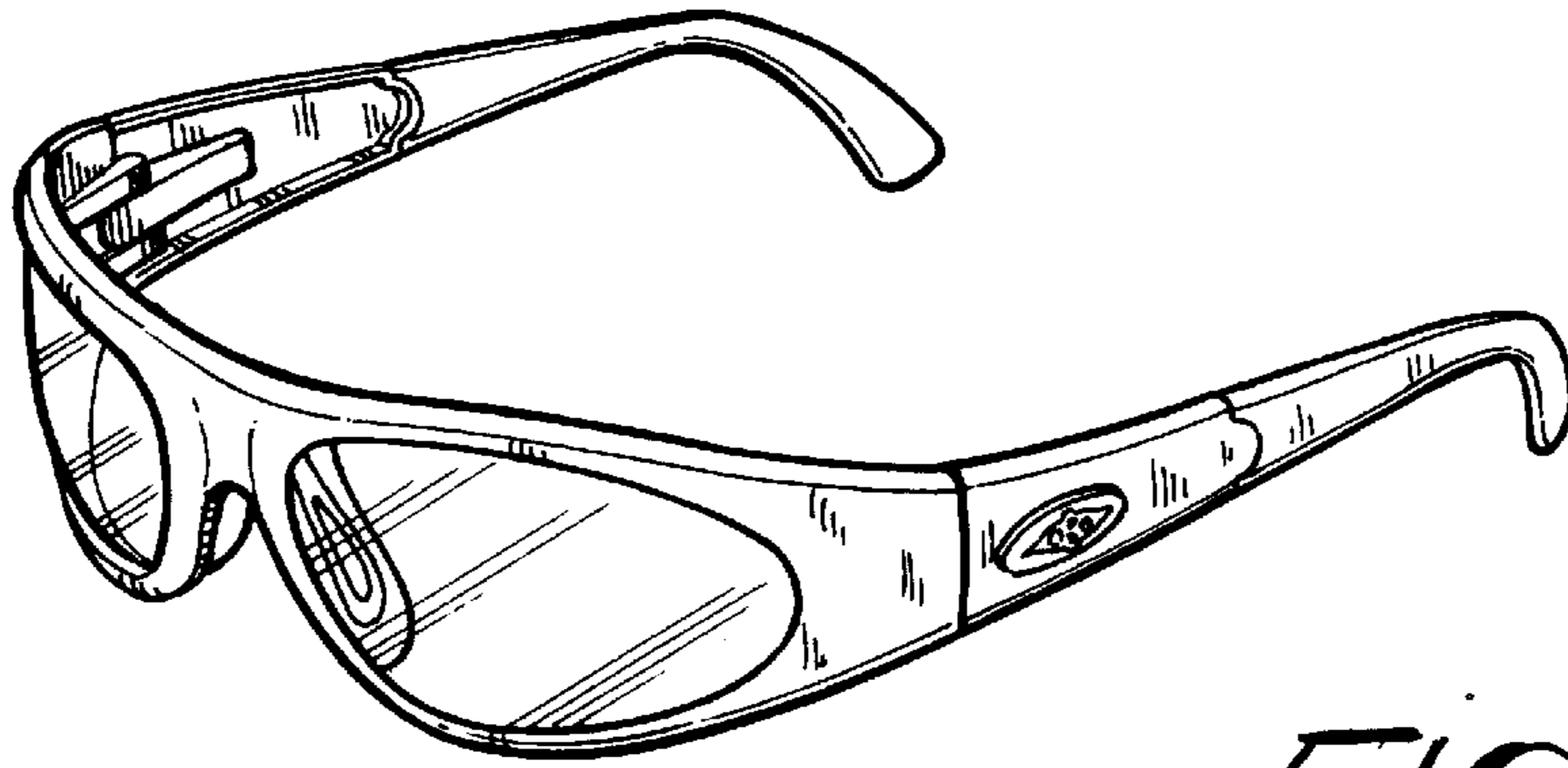
The ornamental design for eyewear, as shown and described.

### DESCRIPTION

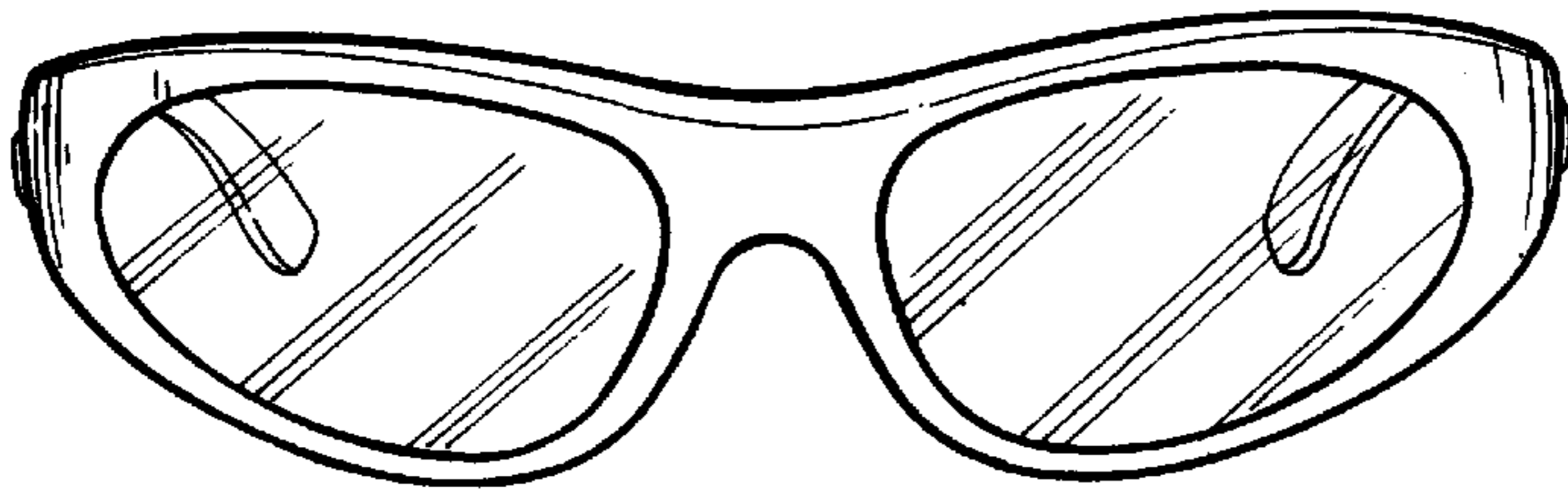
FIG. 1 is a front perspective view of eyewear showing my

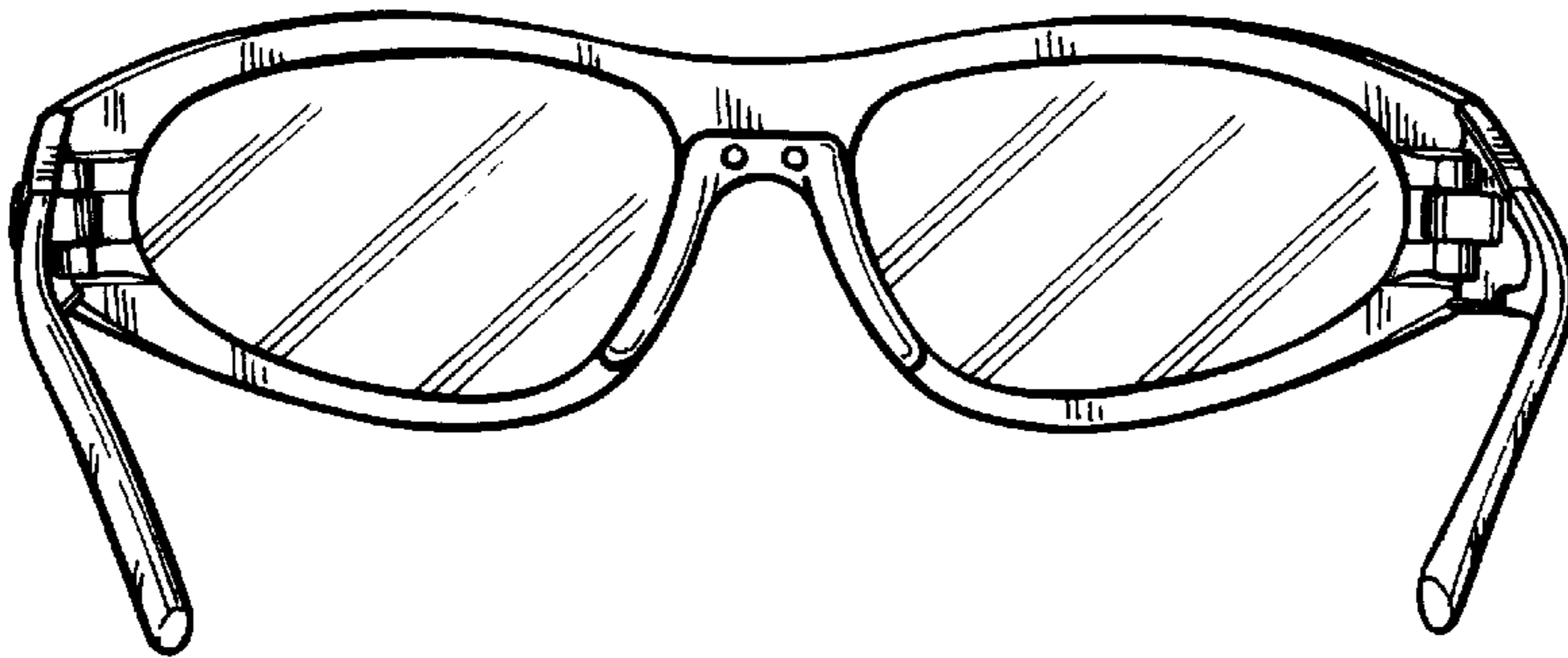




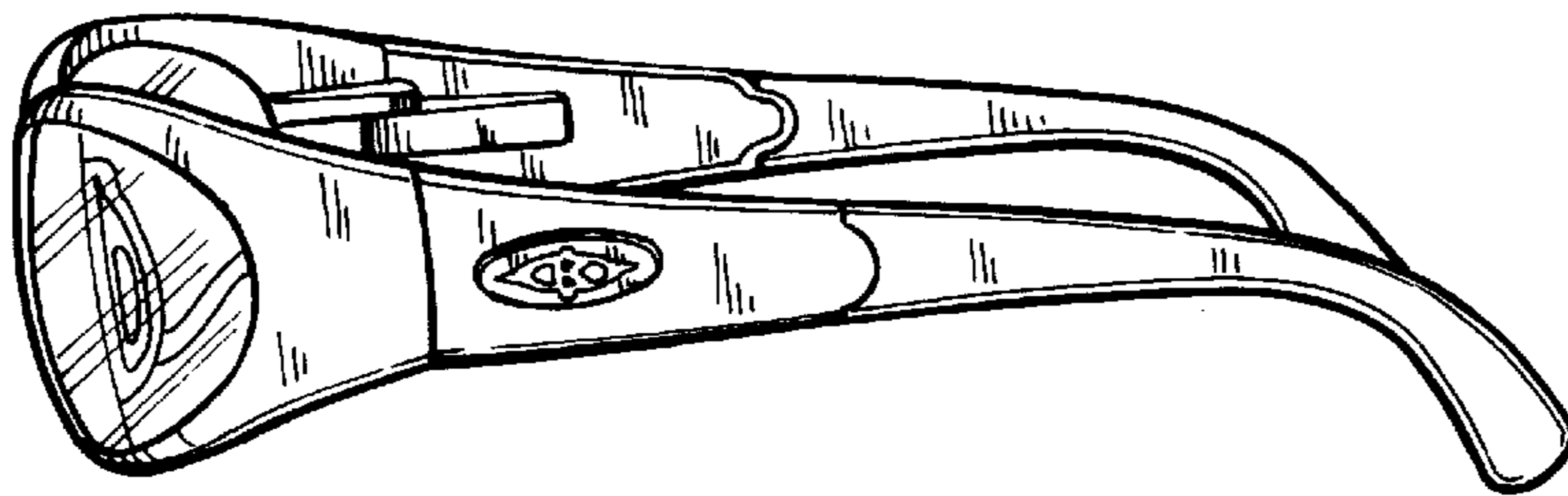

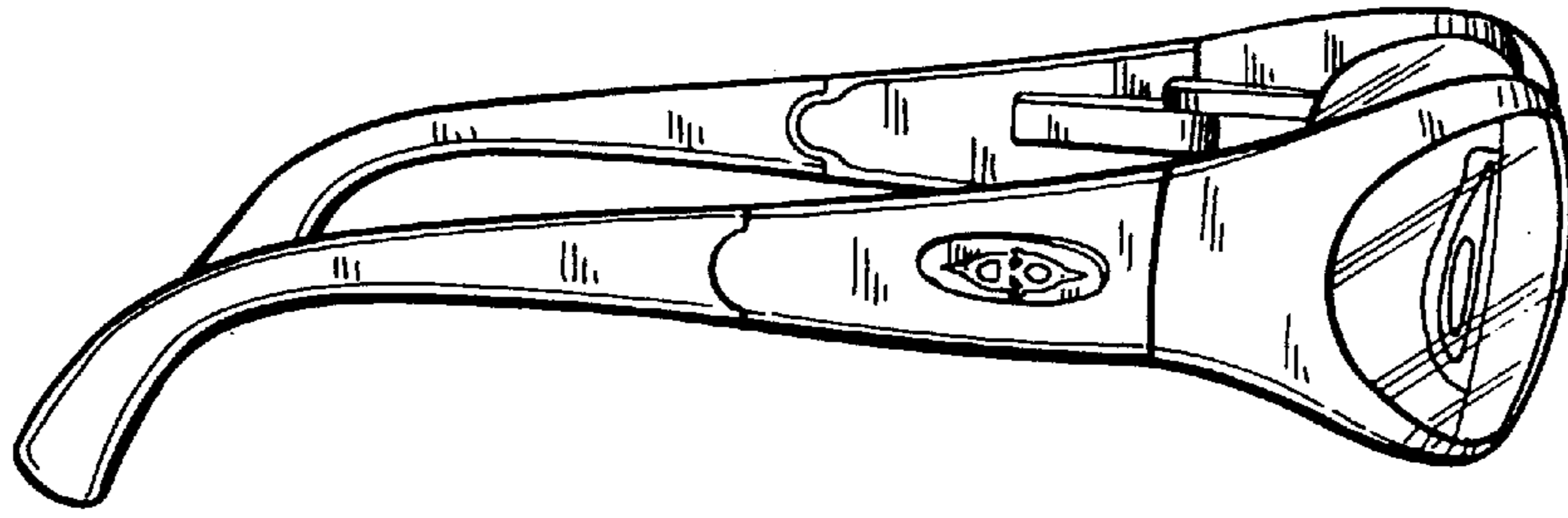

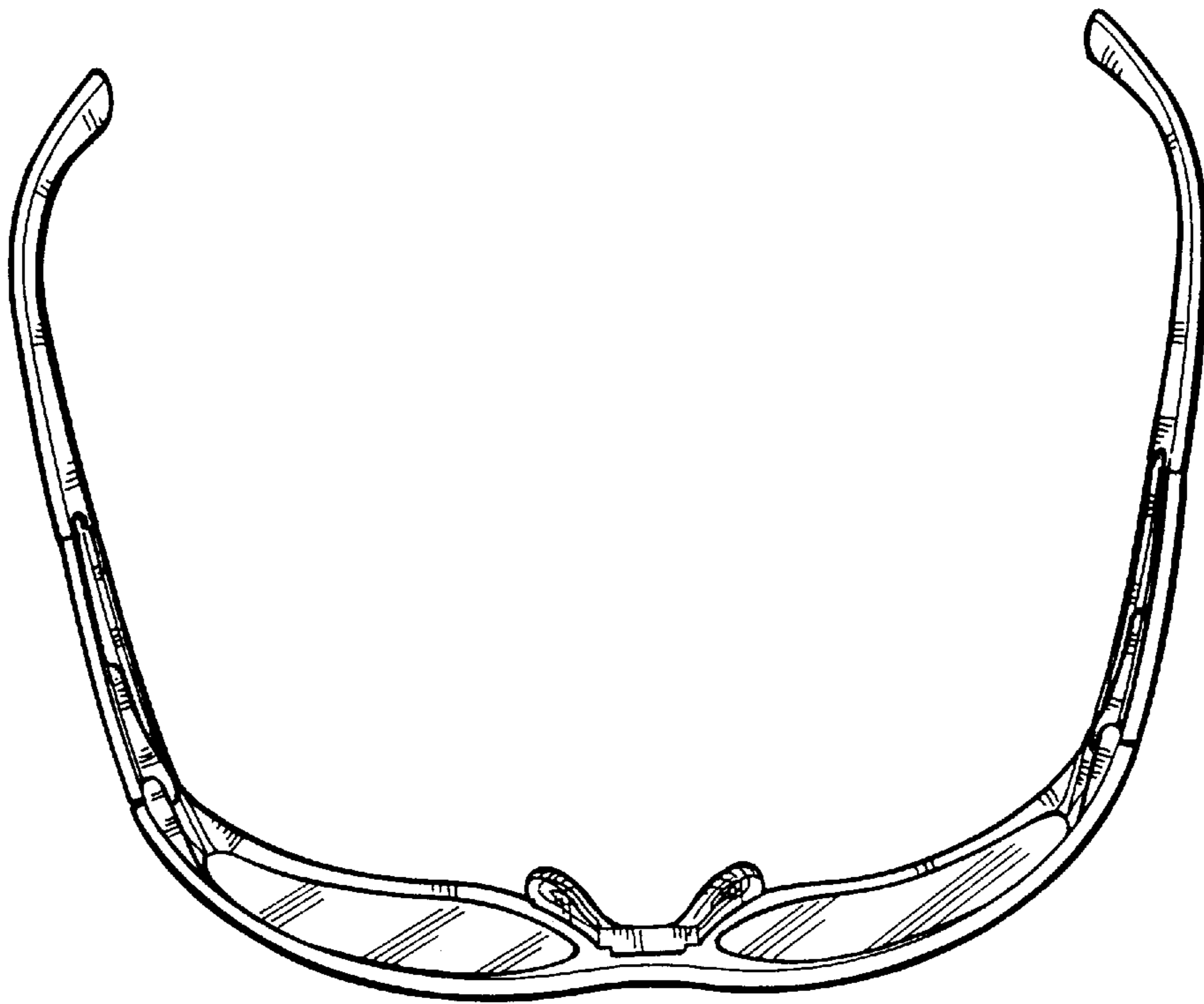

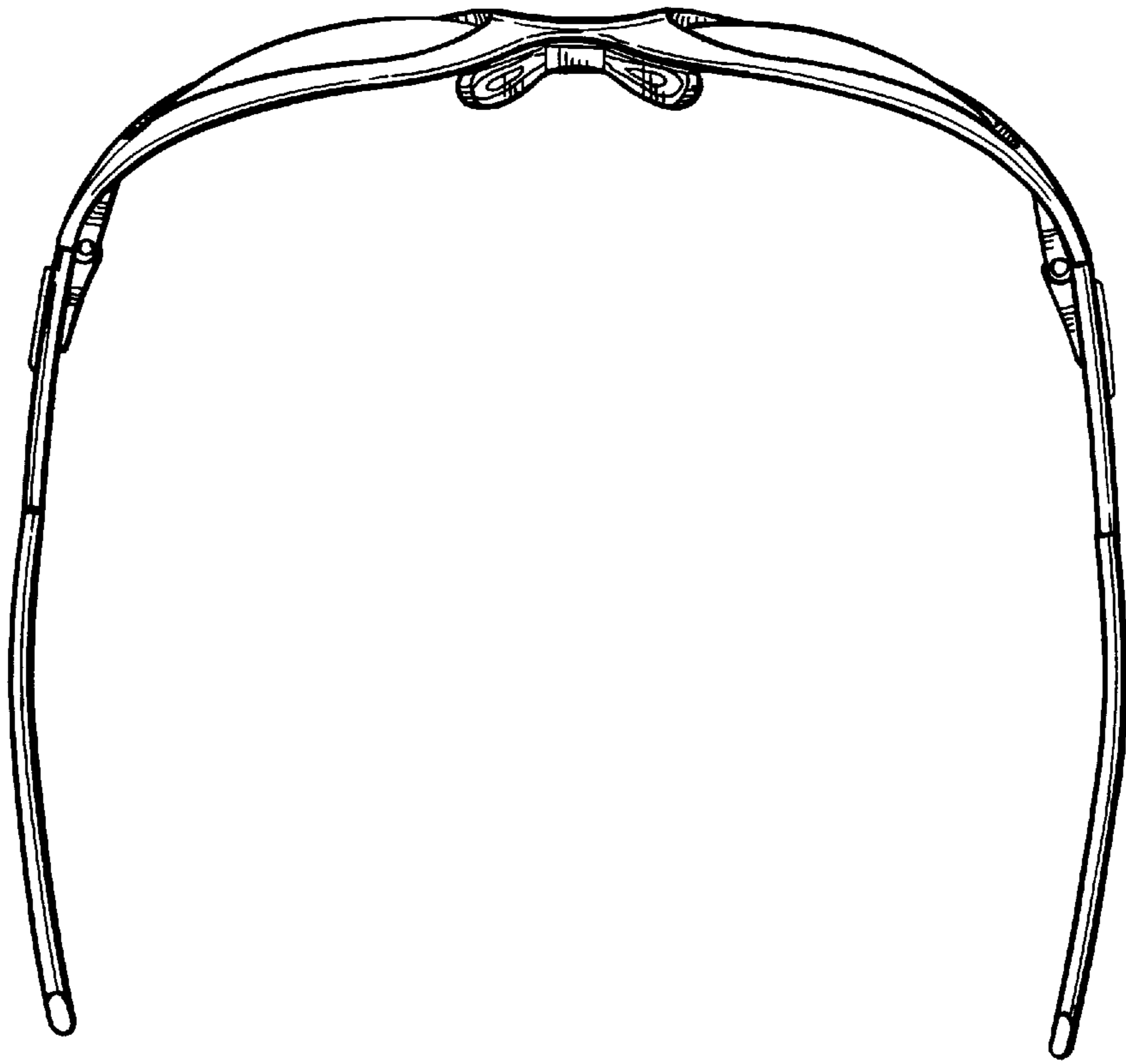
