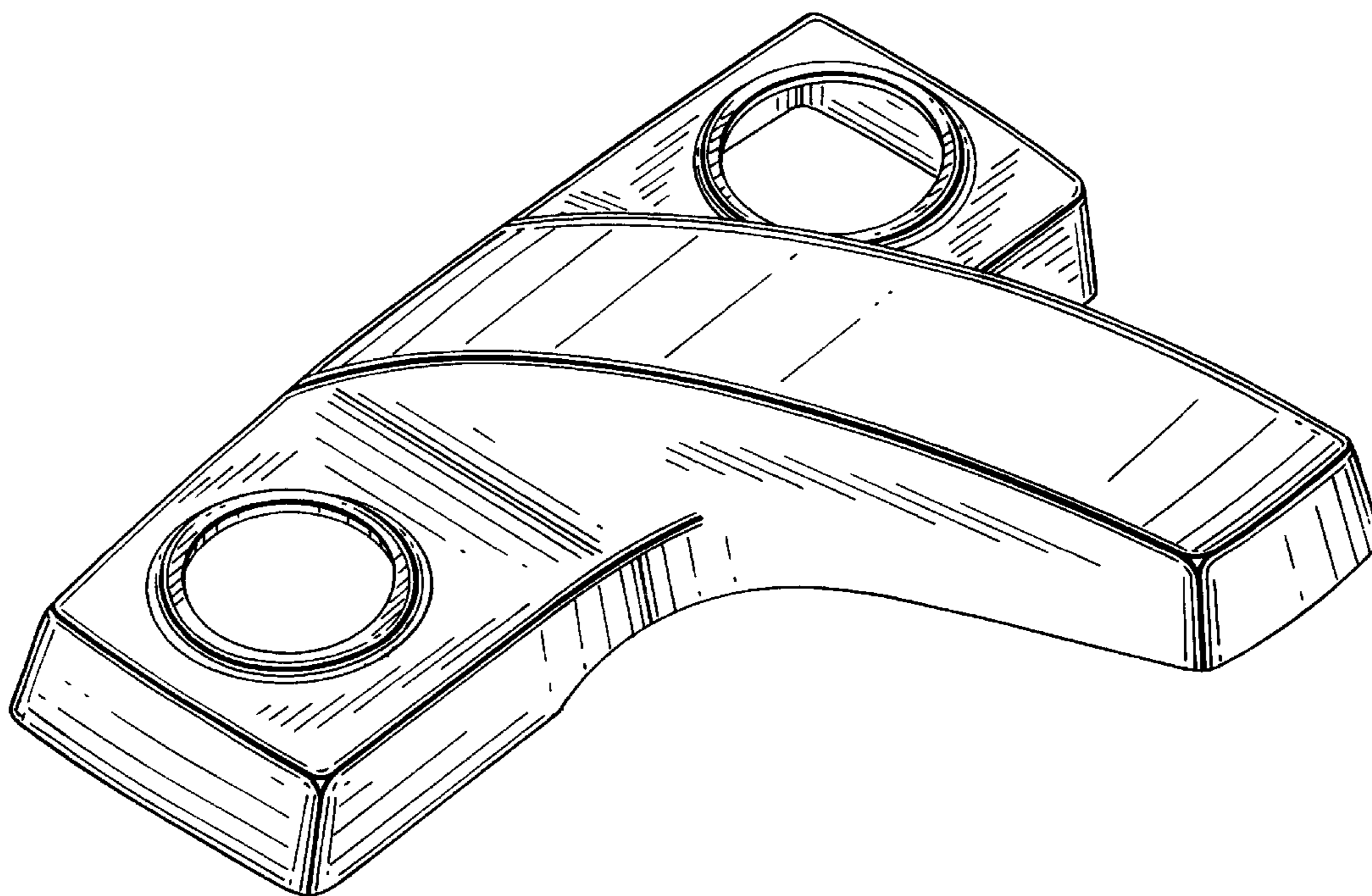

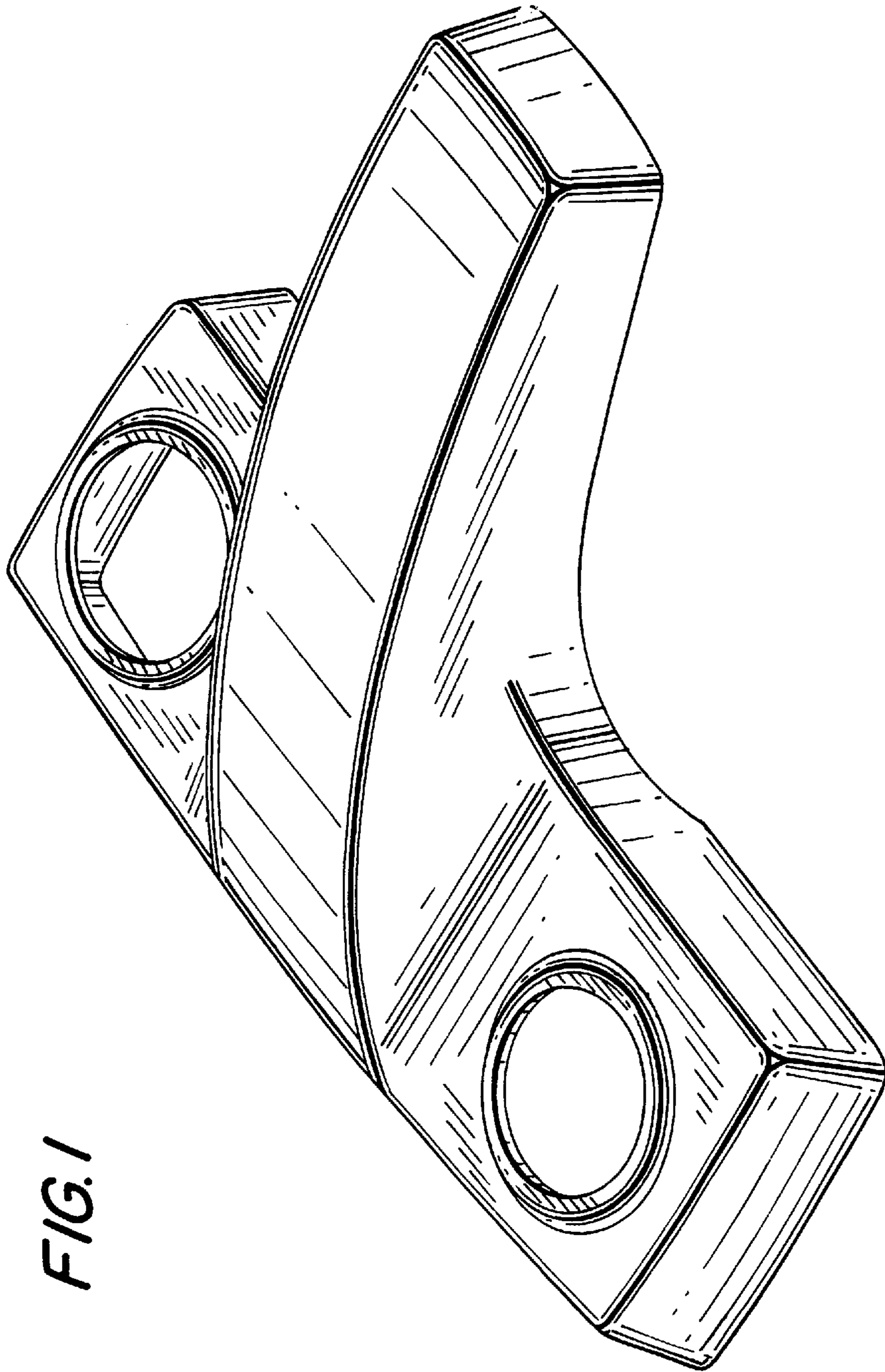
The ornamental design for a faucet body, as shown and described.

**DESCRIPTION**

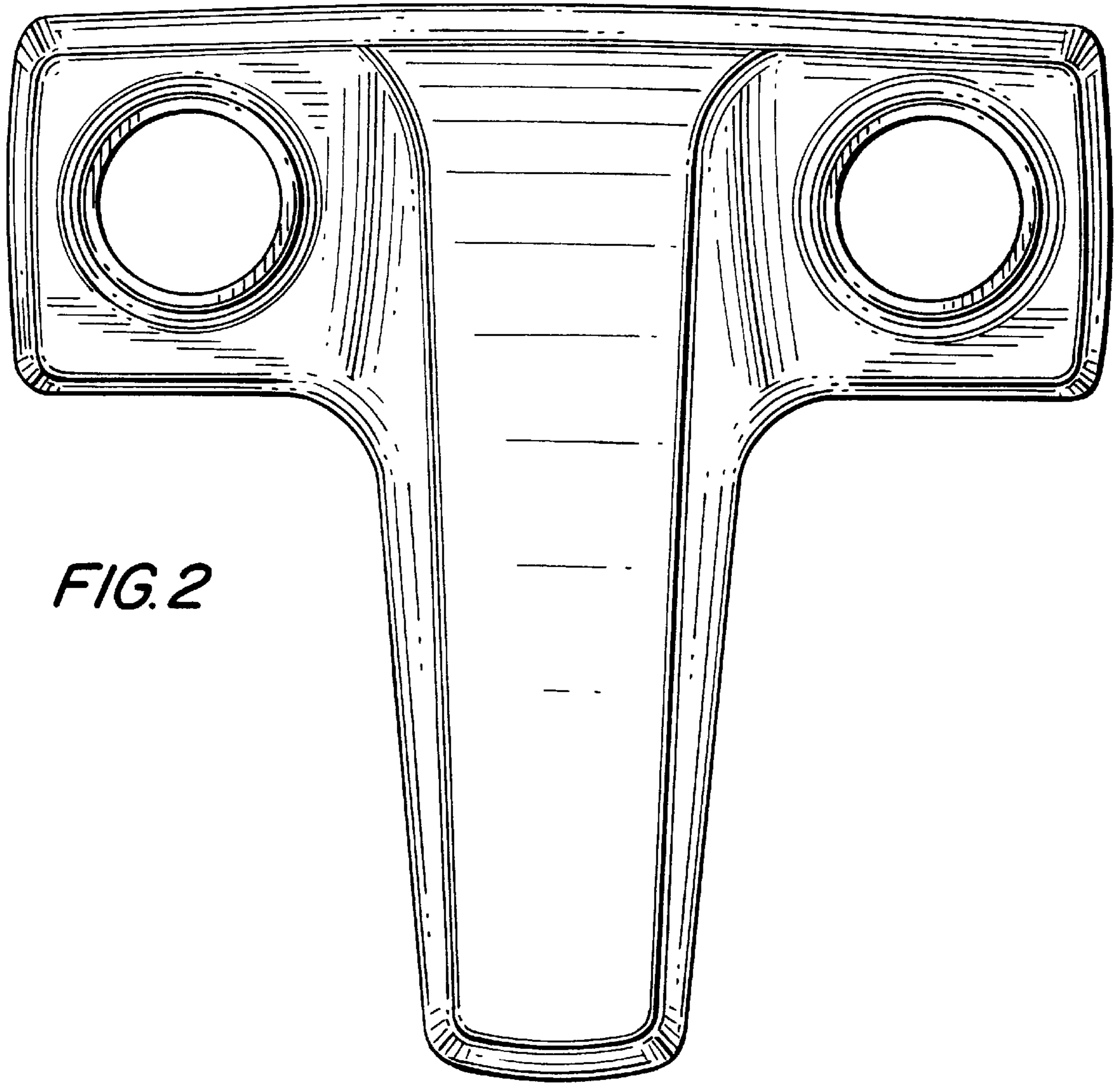
FIG. 1 is a top, front and left side perspective view of a faucet body showing my new design;

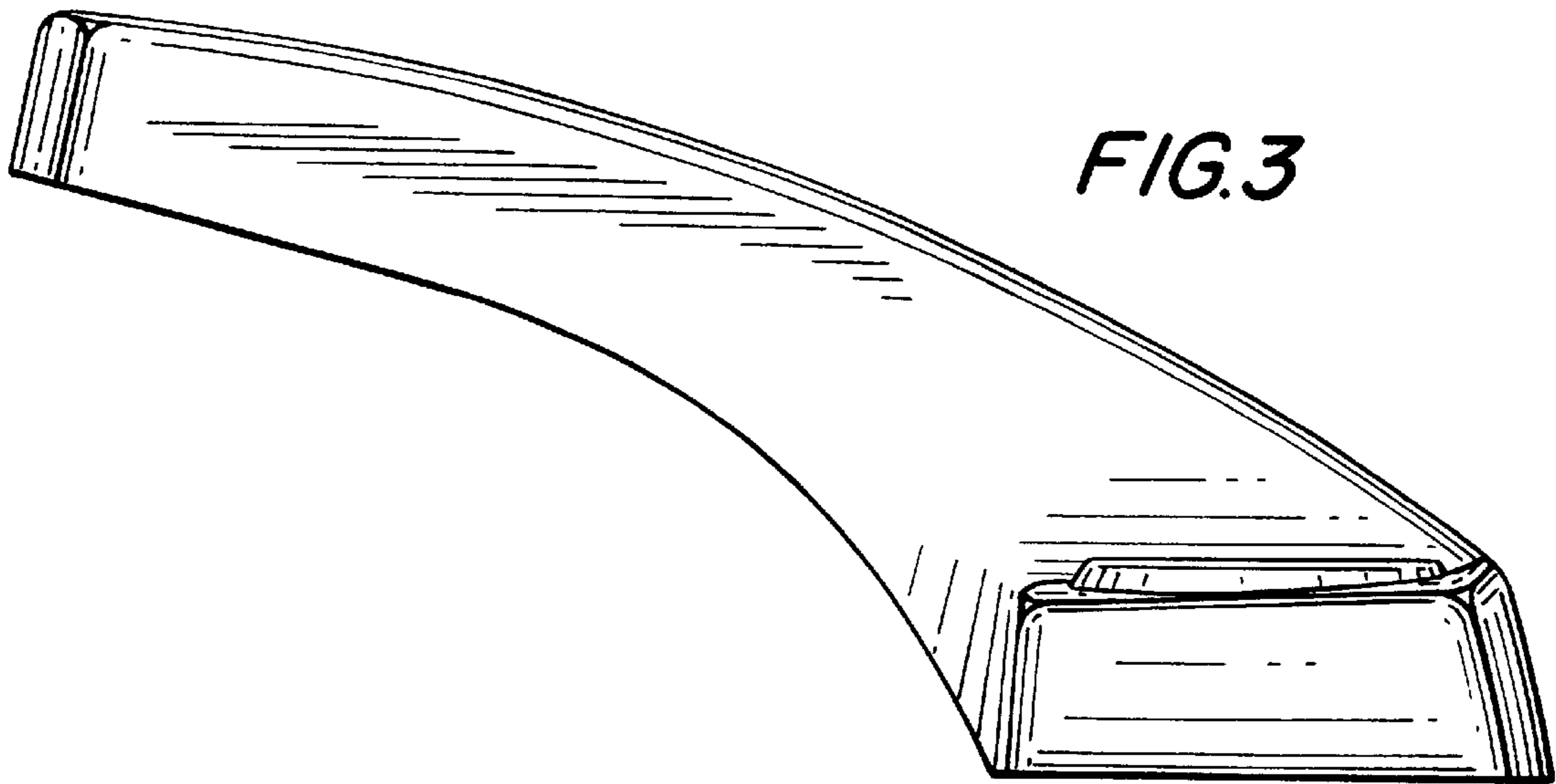

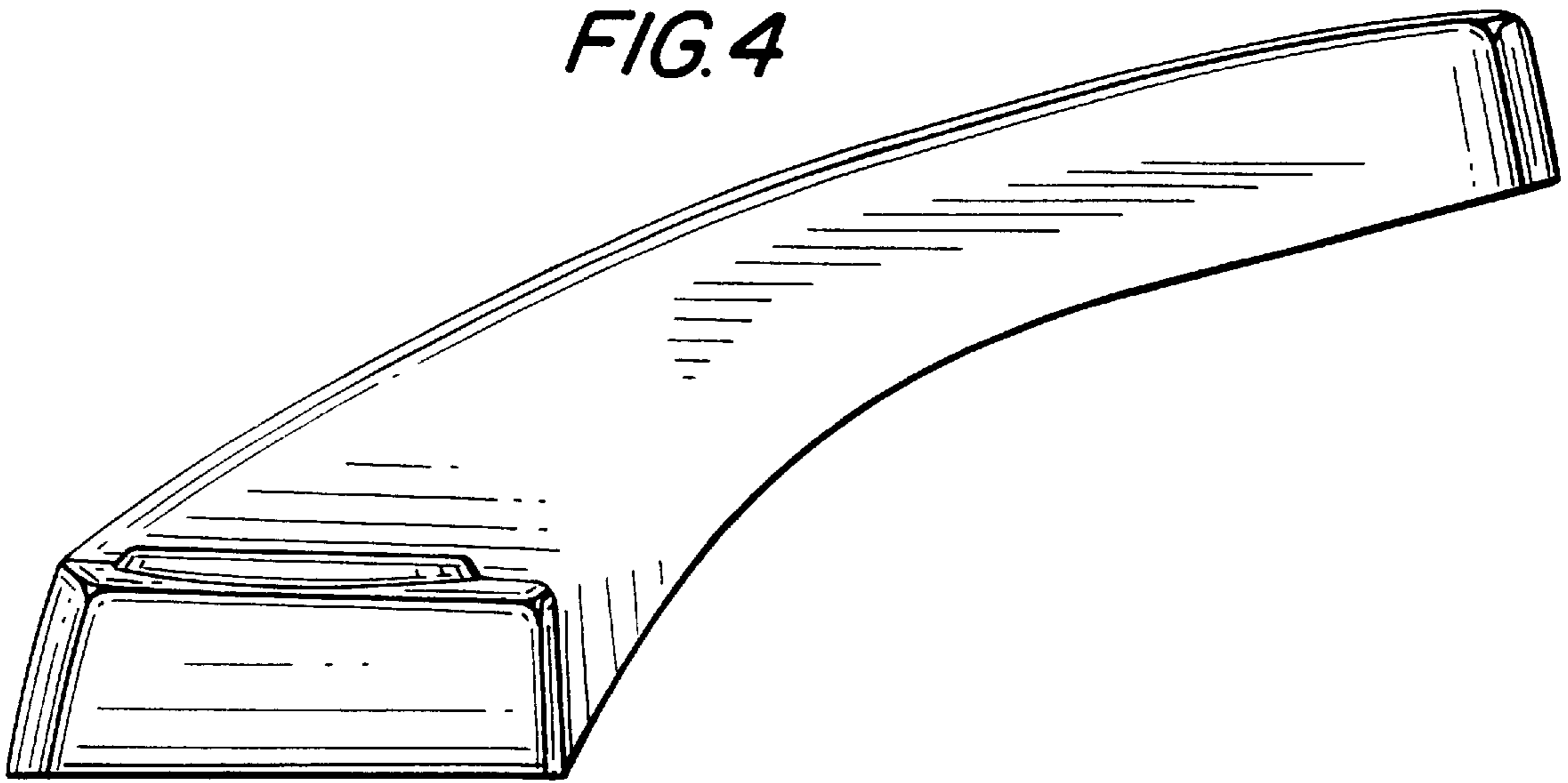

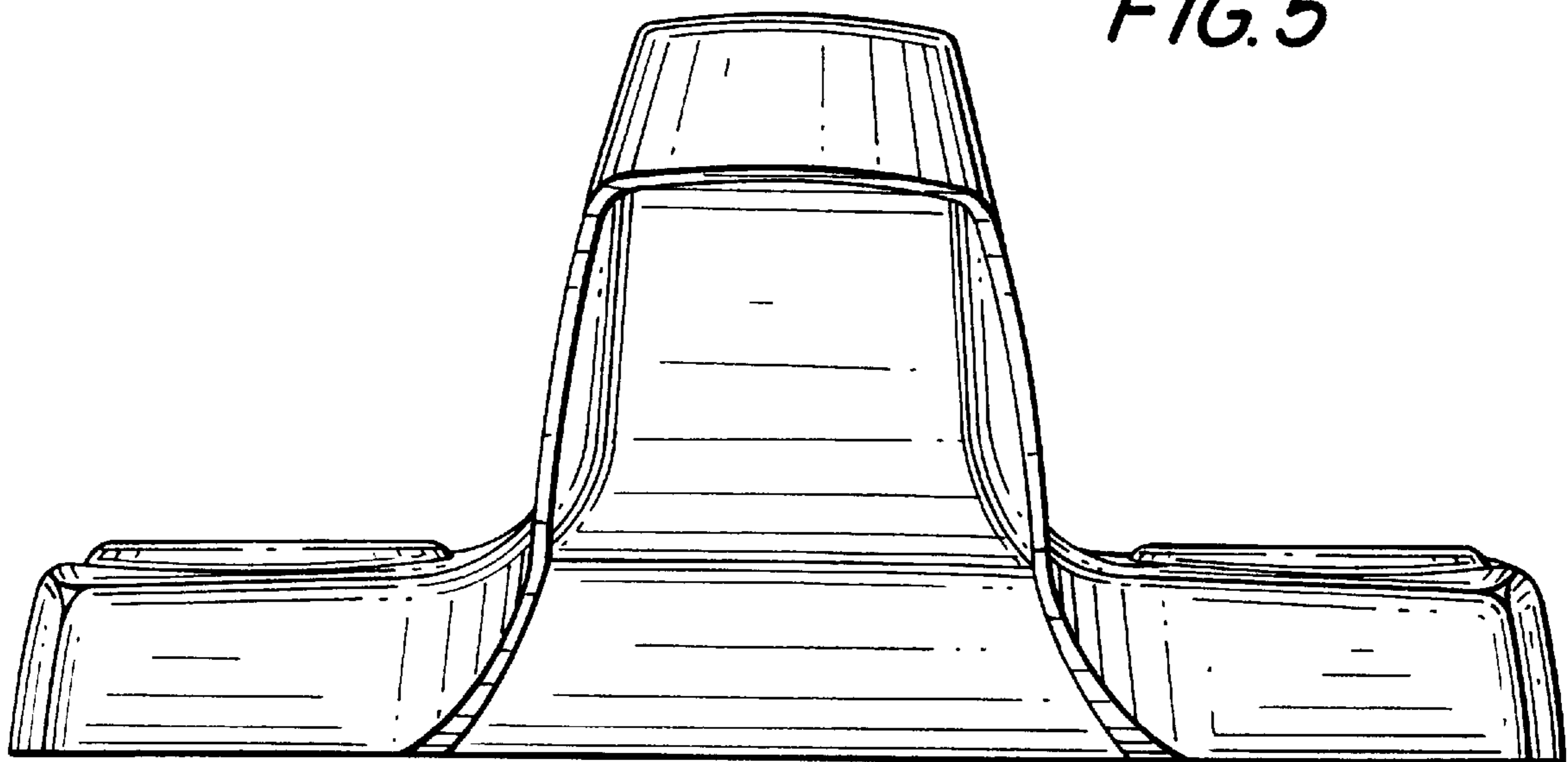

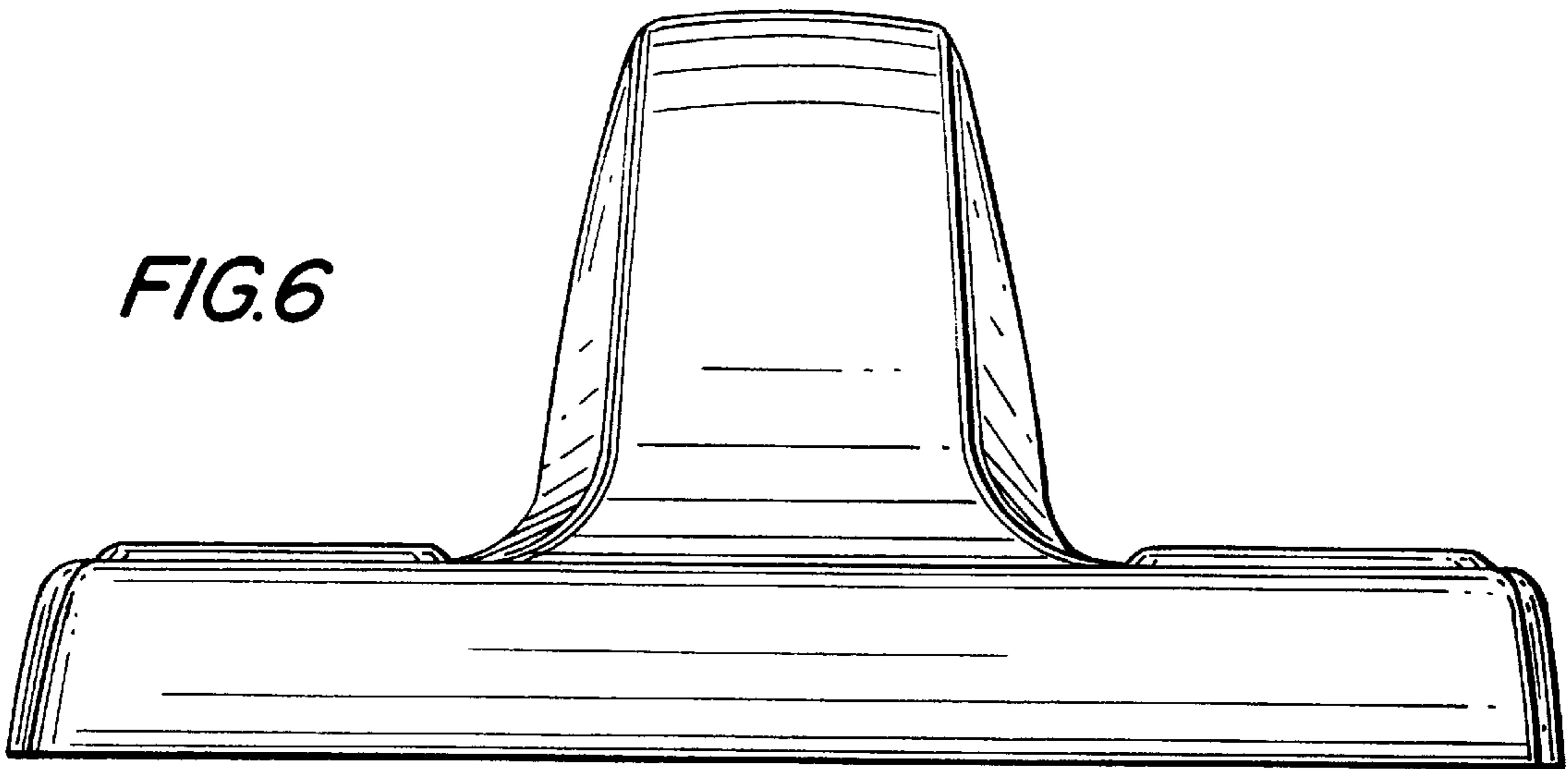
