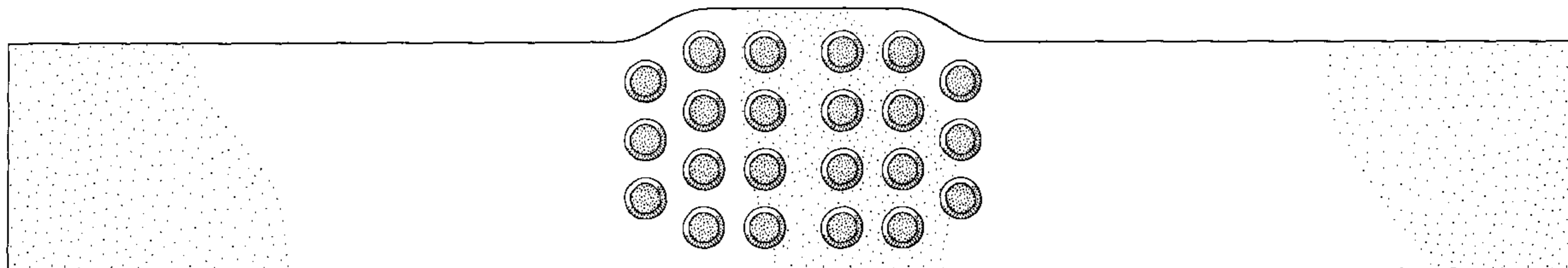
[57] **CLAIM**

The ornamental design for a back wrap having thermal cells, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a back wrap having thermal cells, embodying our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof; and  
FIG. 4 is a left side elevational view thereof; the right side elevational view thereof being a mirror image; and  
FIG. 5 is a bottom view thereof.

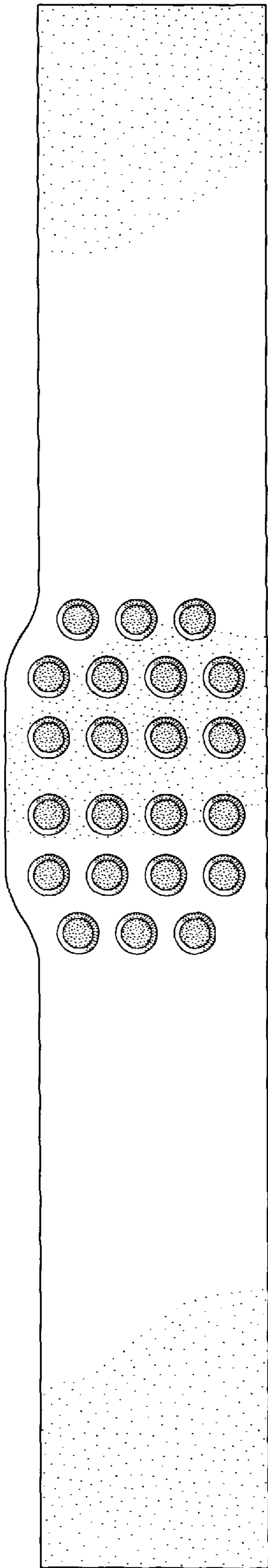

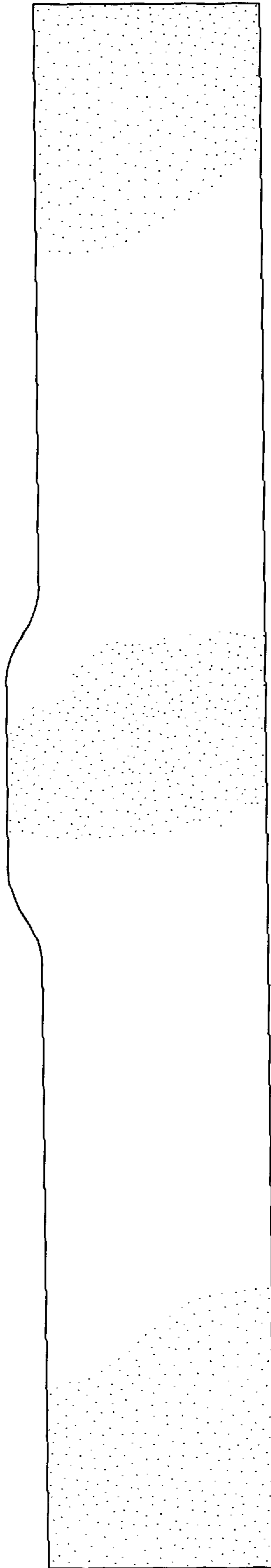
