The ornamental design for a bassinet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bassinet showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof, the left side view and the rear view being mirror images of the right side view; and,

FIG. 5 is a bottom plan view thereof.

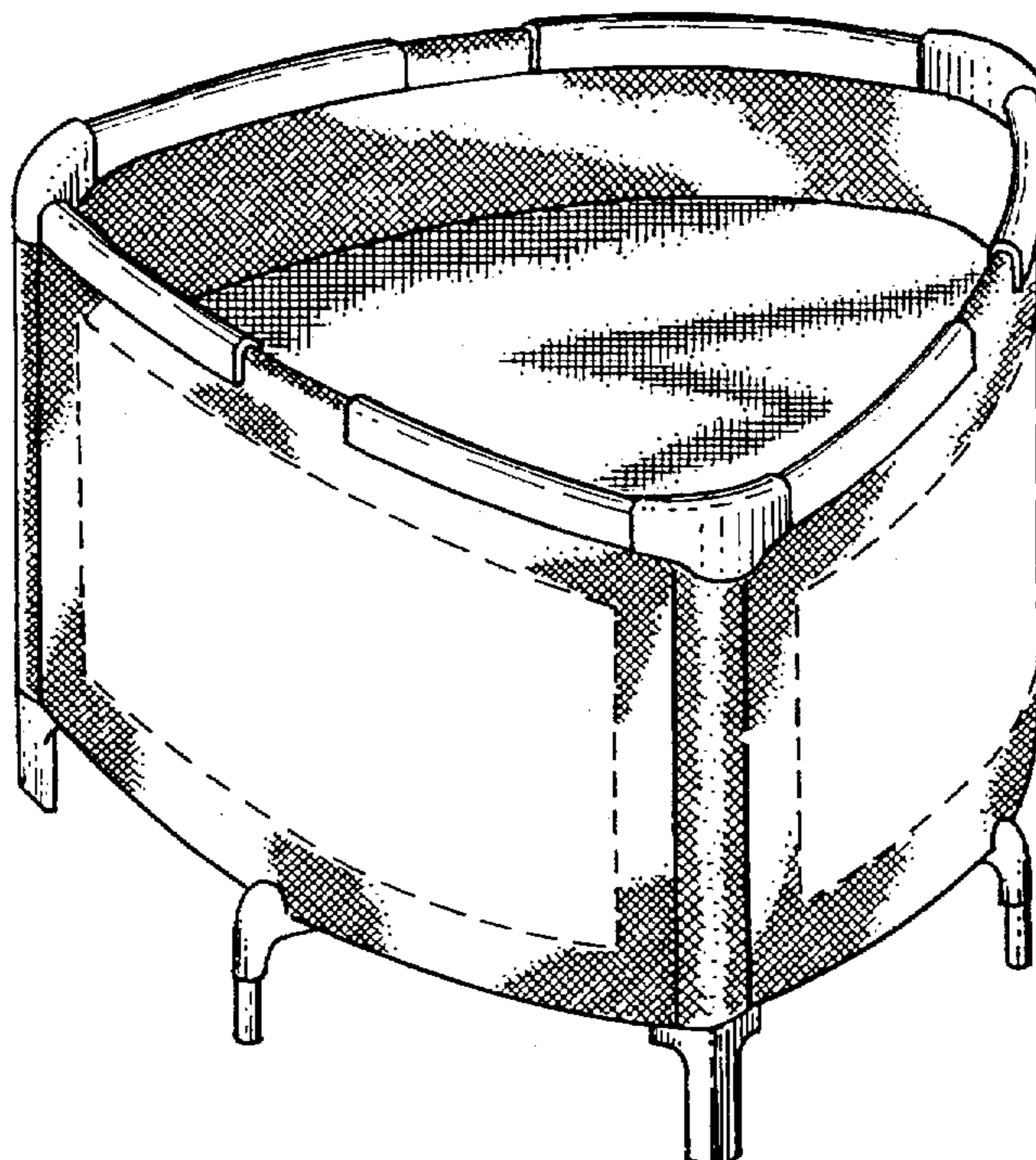

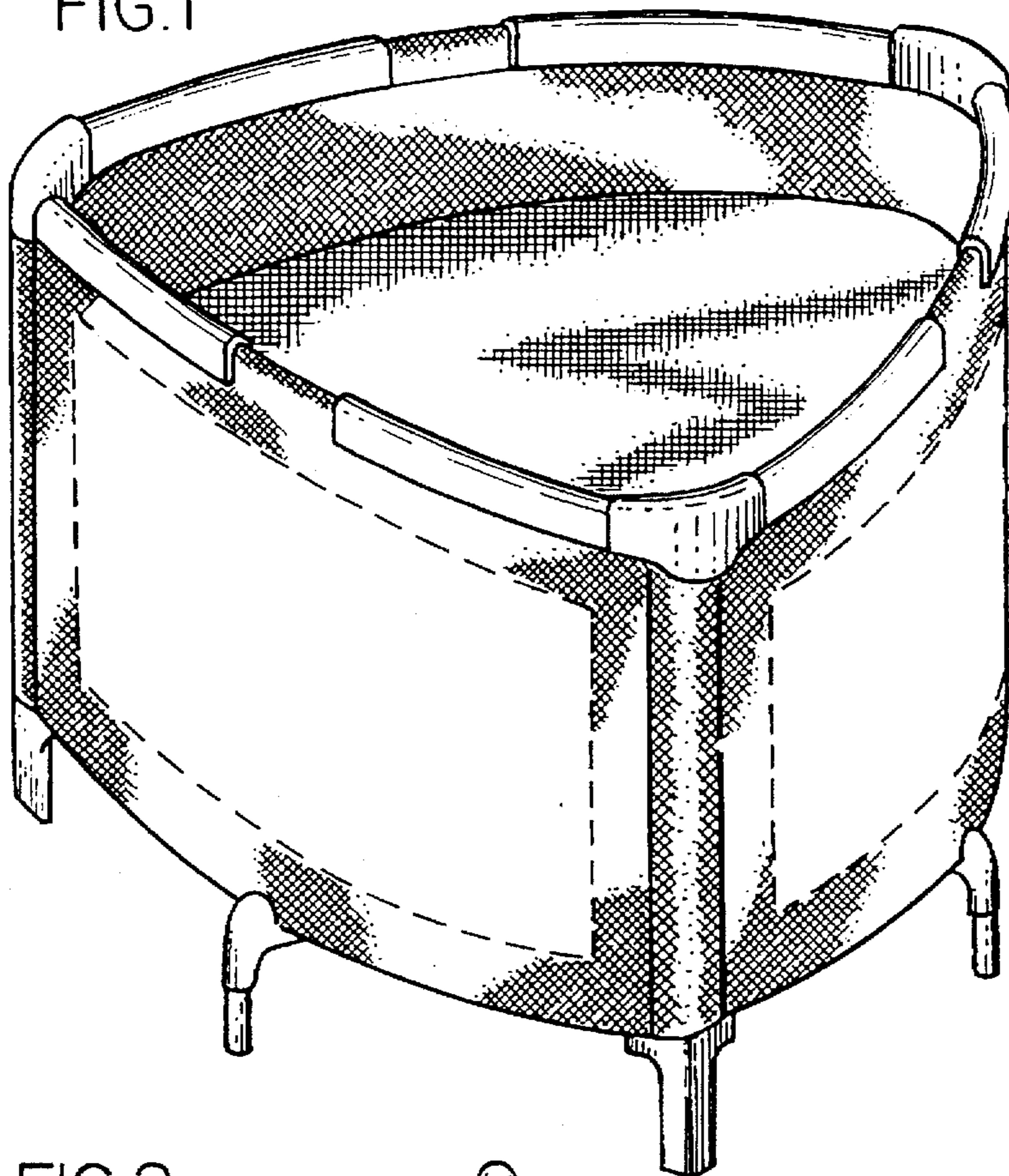

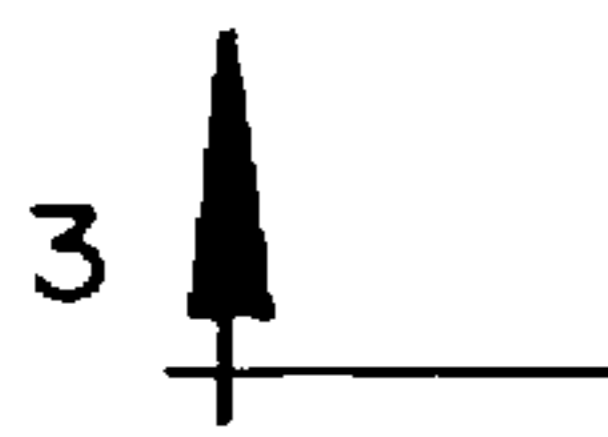
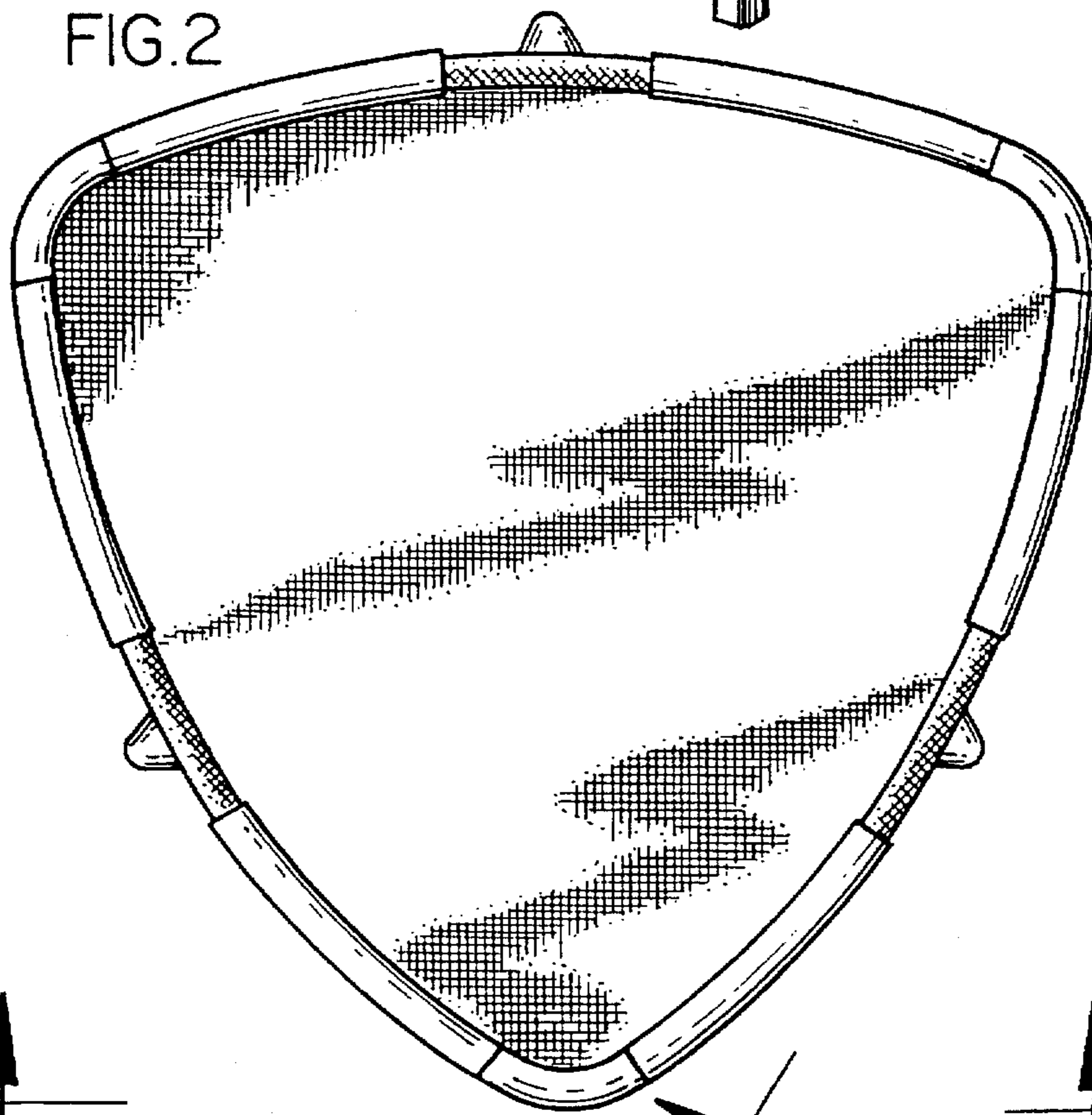

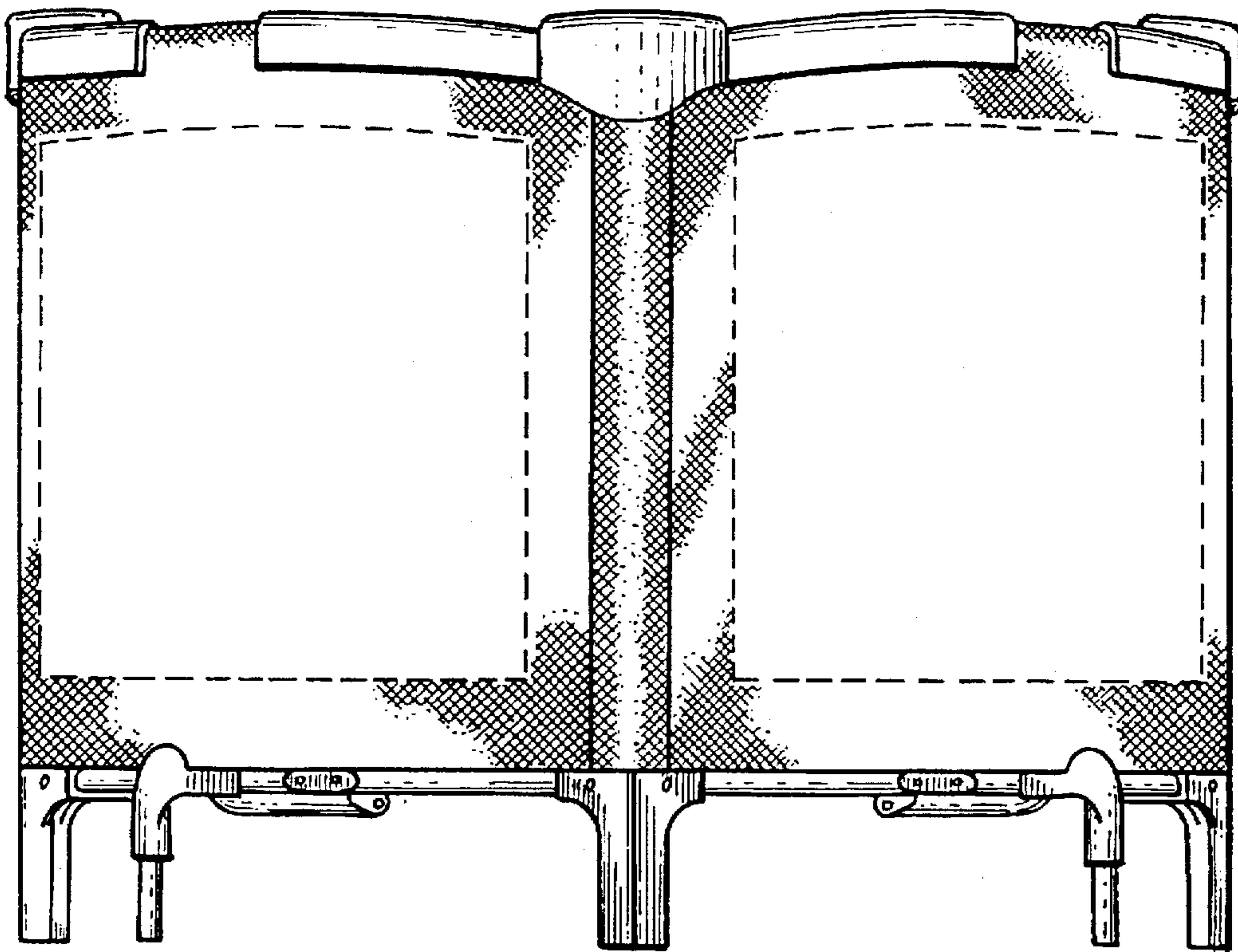

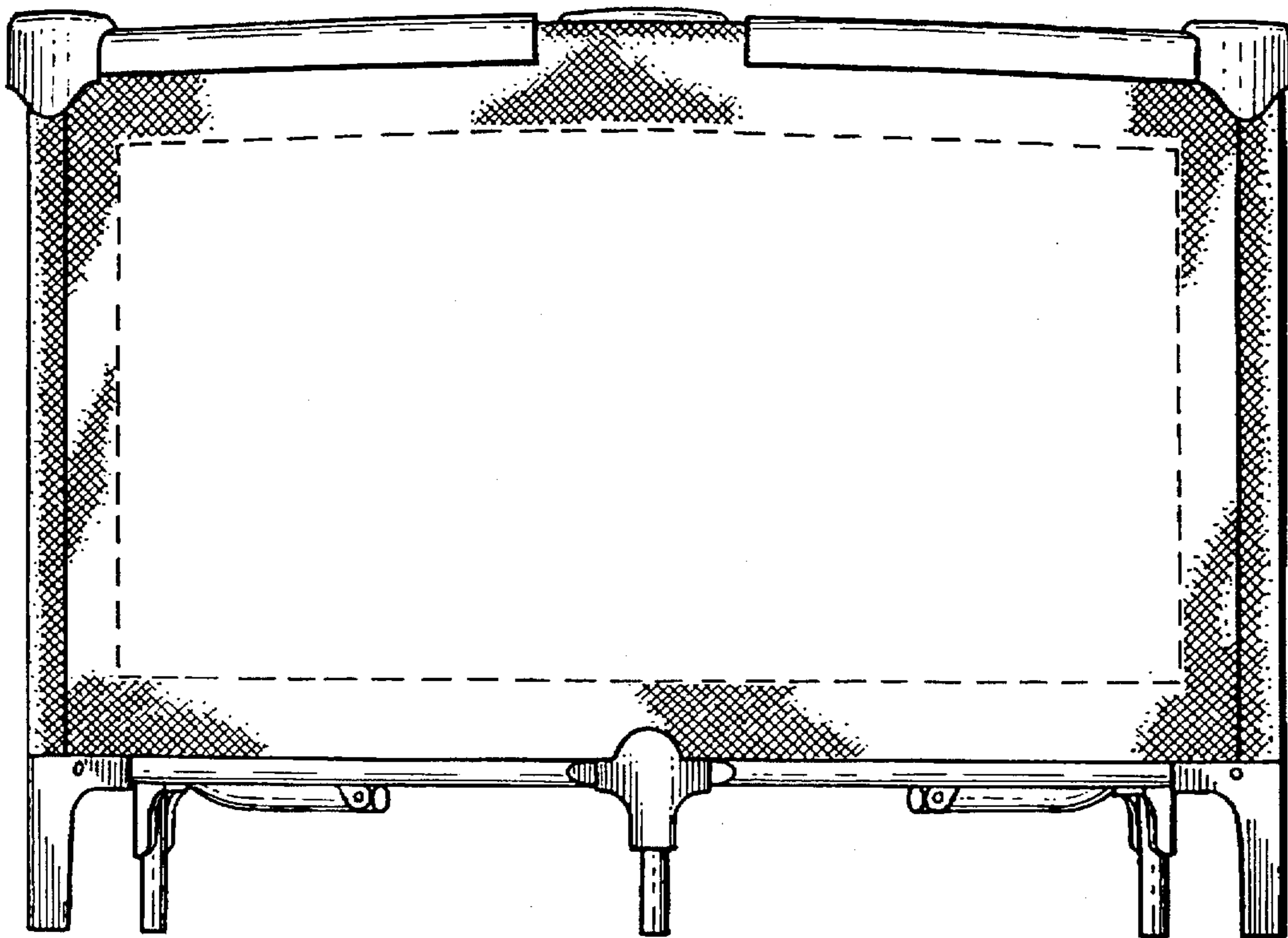
