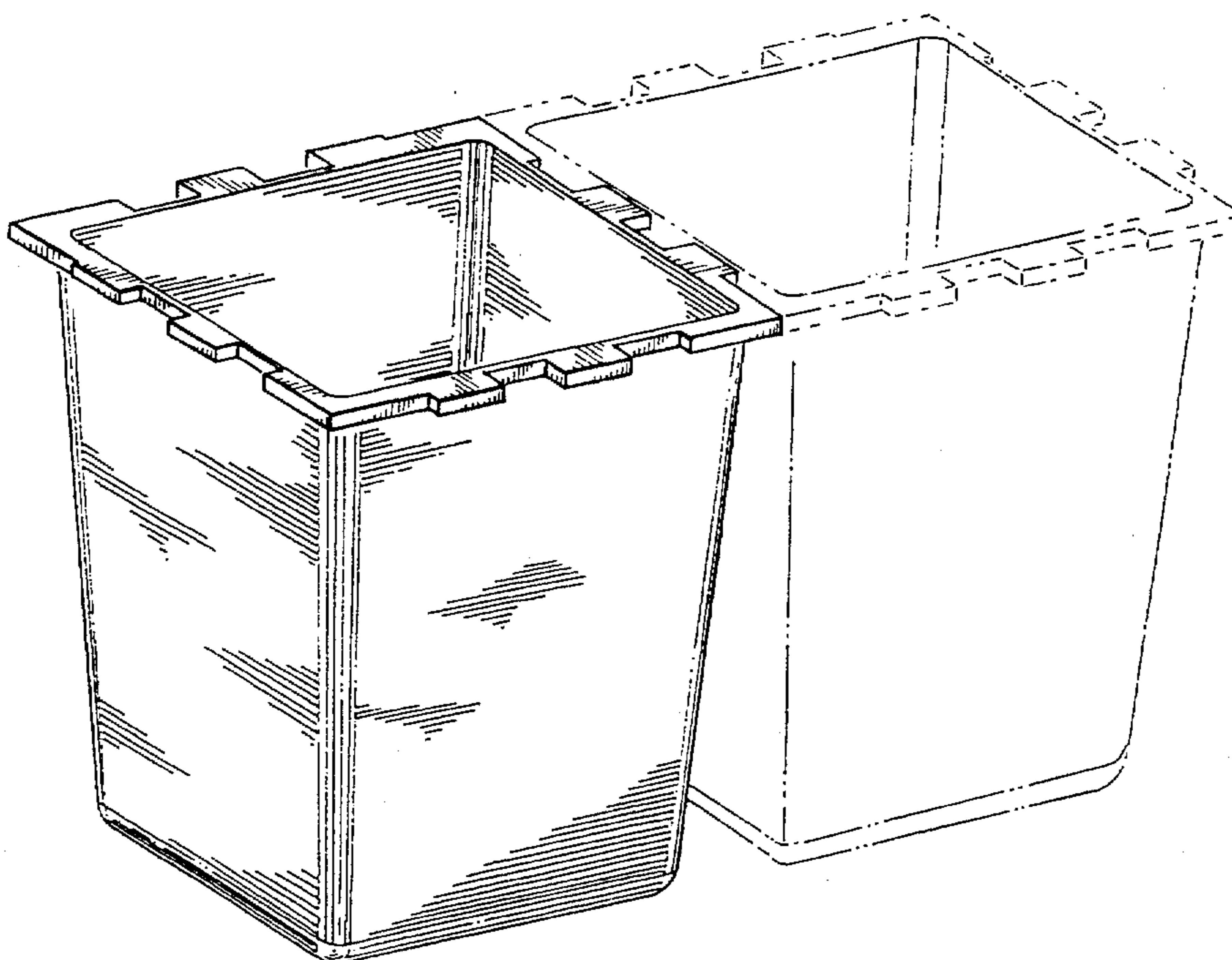
[57] **CLAIM**

The ornamental design for an interlocking drawer organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an interlocking drawer organizer showing my new design, with a second organizer unit shown in broken lines for purposes of illustration only and forming no part of the claimed design; FIG. 2 is a top plan view of the interlocking drawer organizer of FIG. 1; FIG. 3 is a front elevational view thereof, the rear and side elevational views being identical; and, FIG. 4 is a bottom plan view of the interlocking drawer organizer of FIGS. 1 to 3.

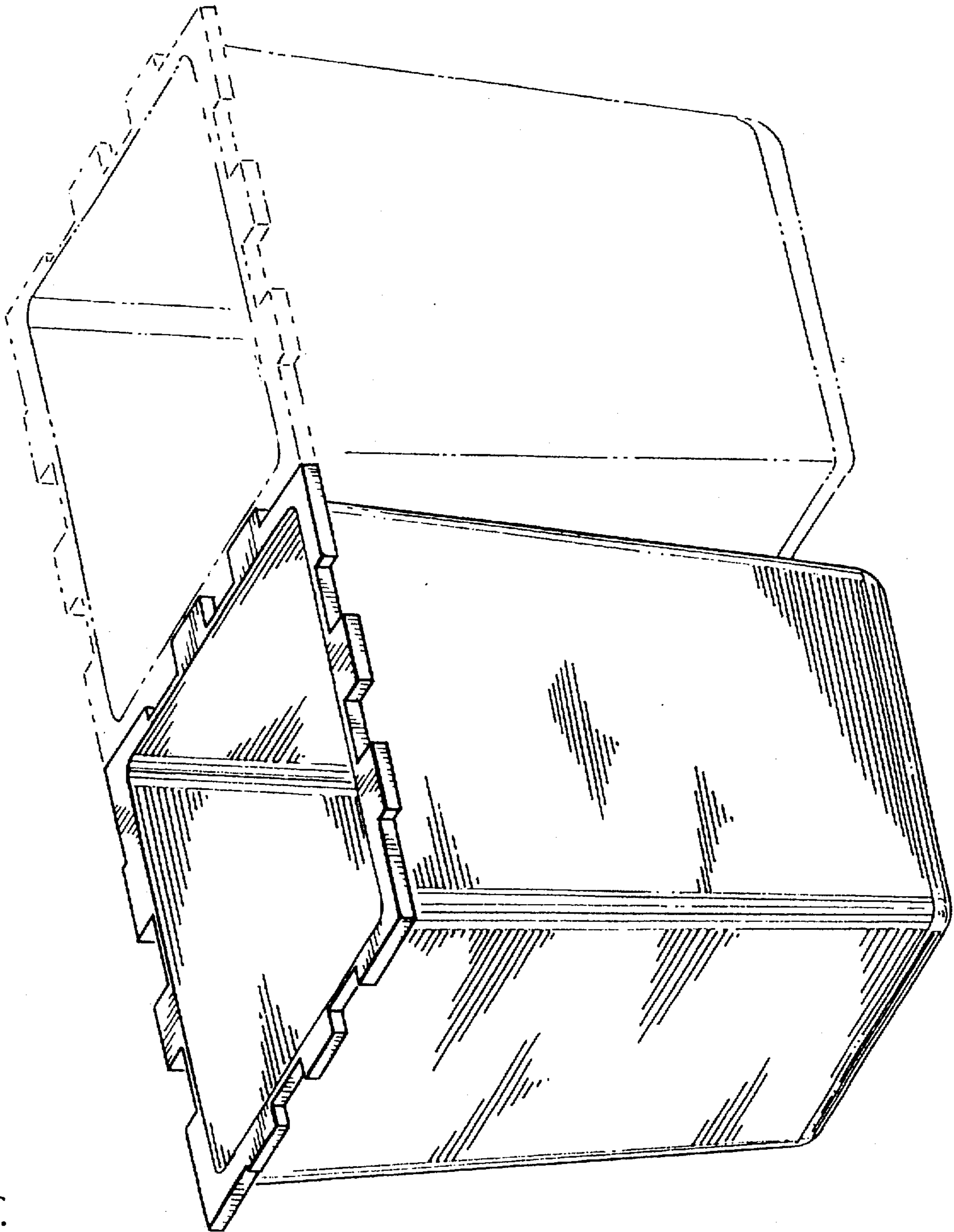

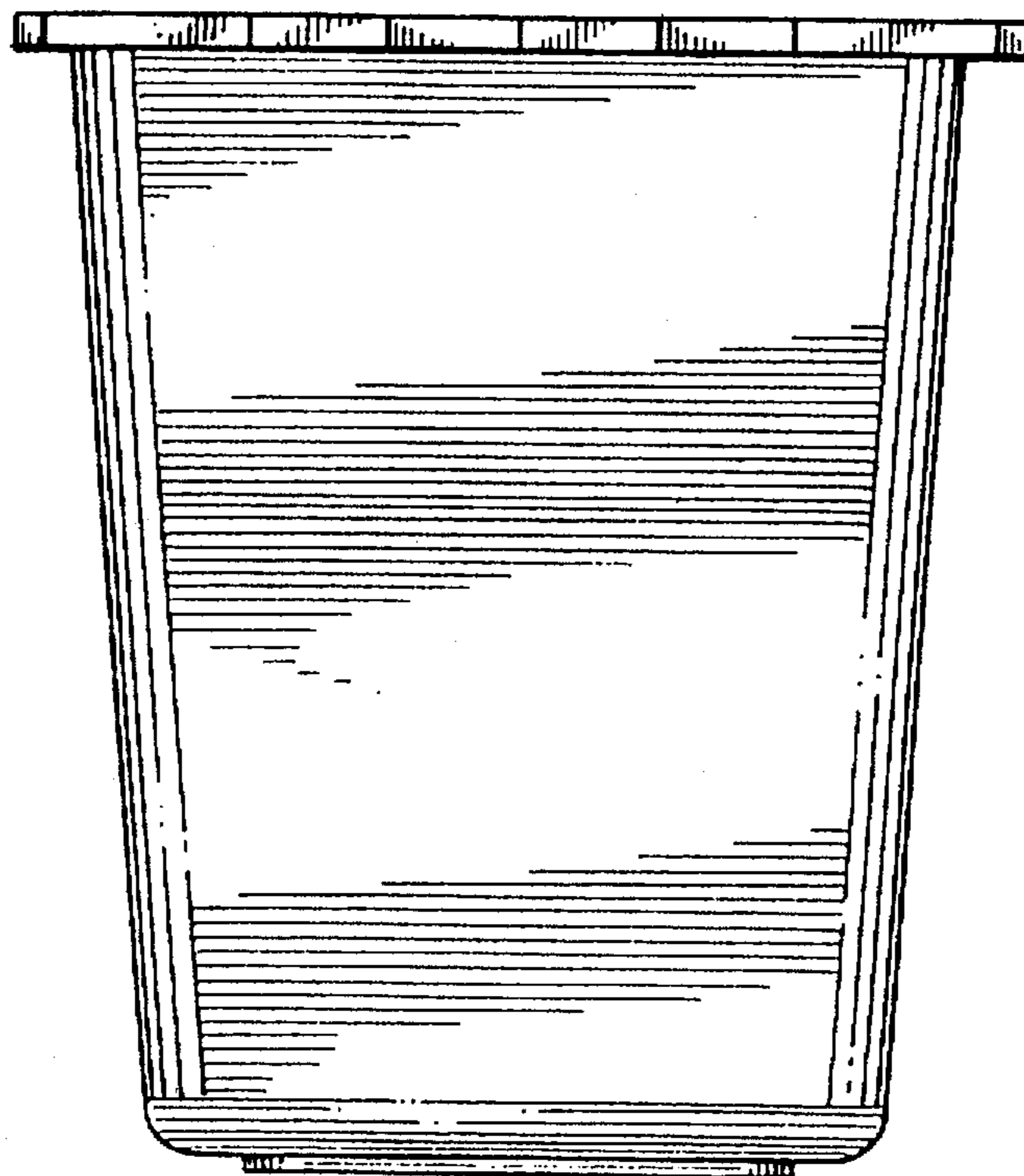
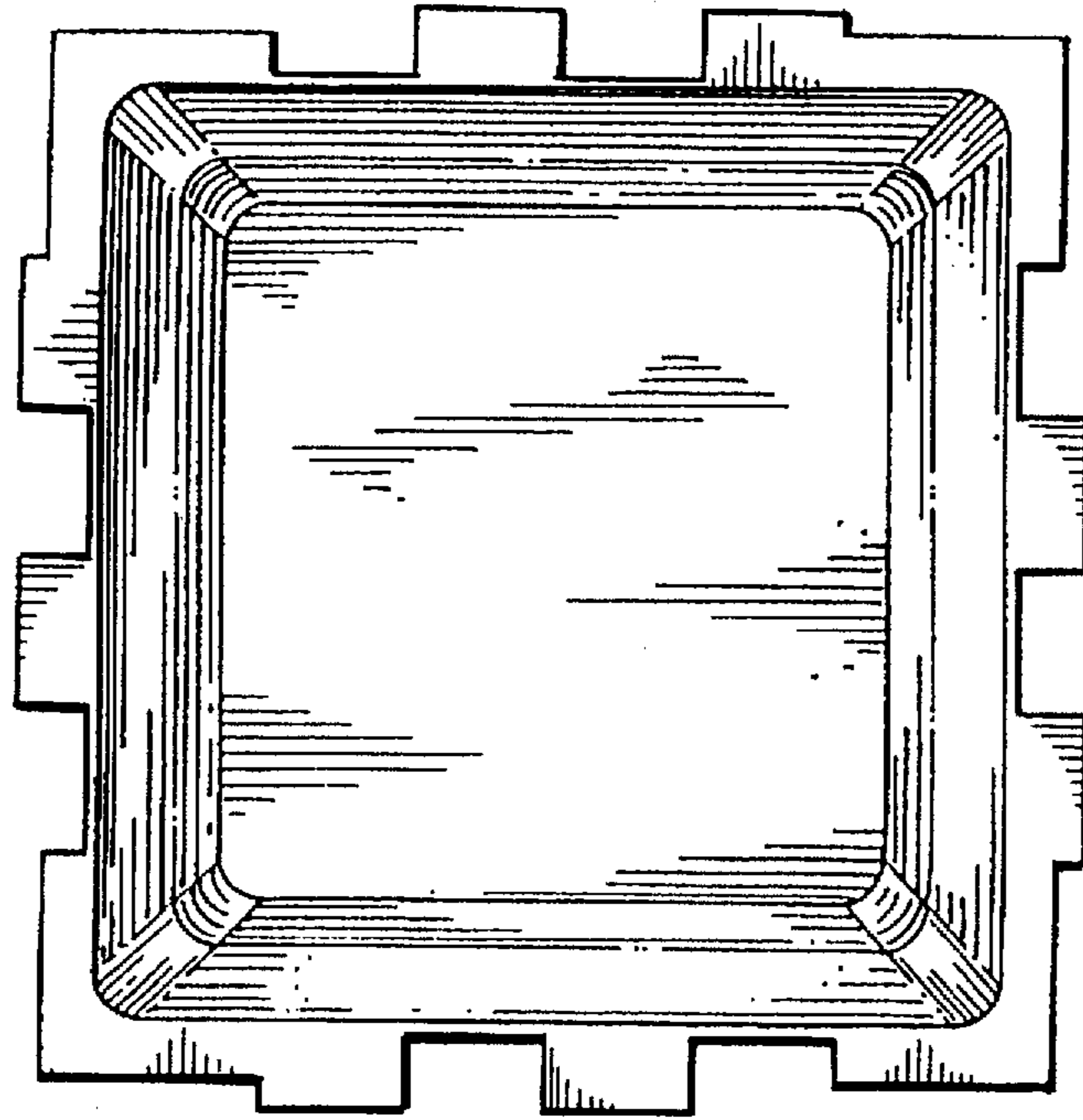

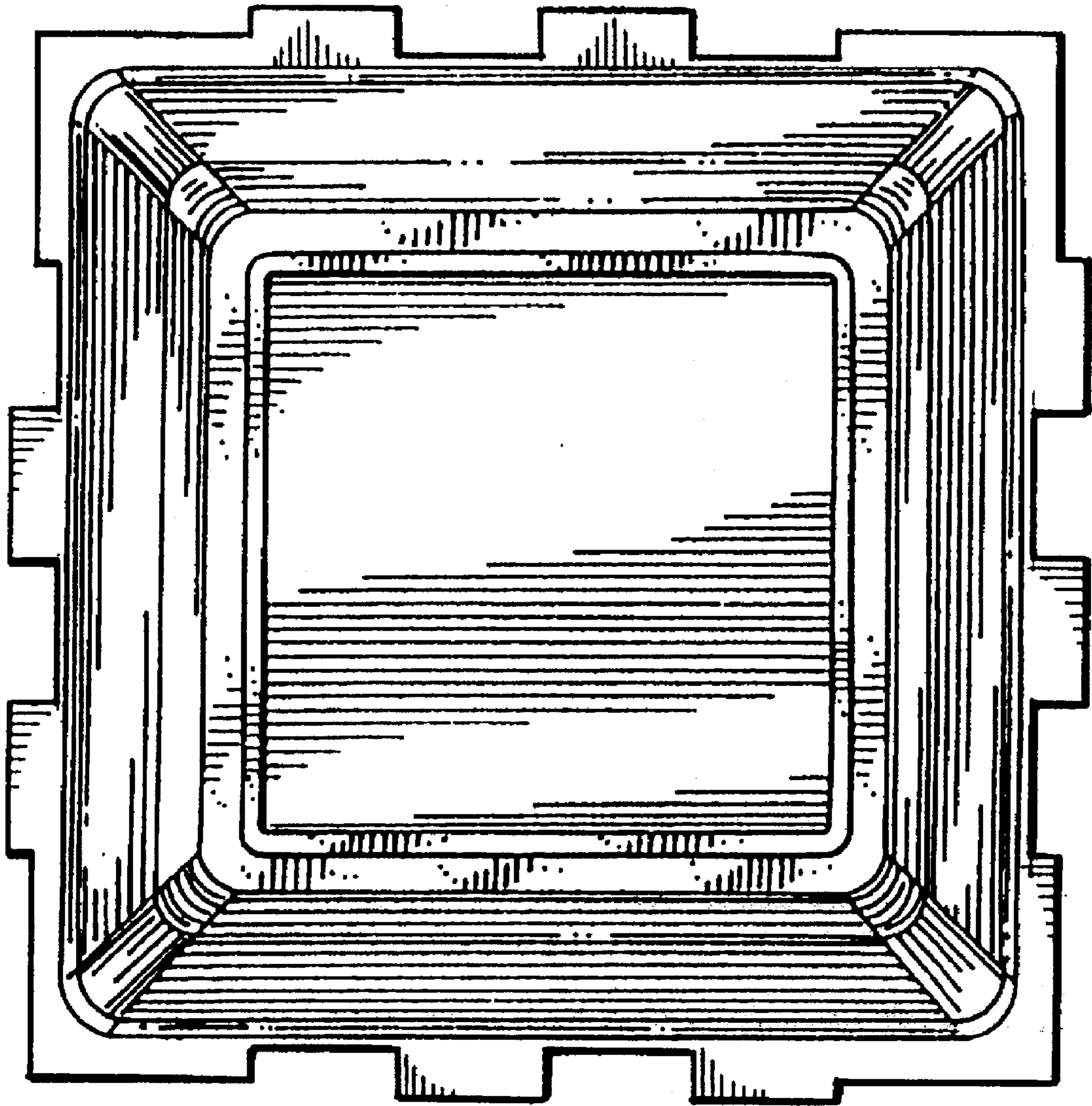
