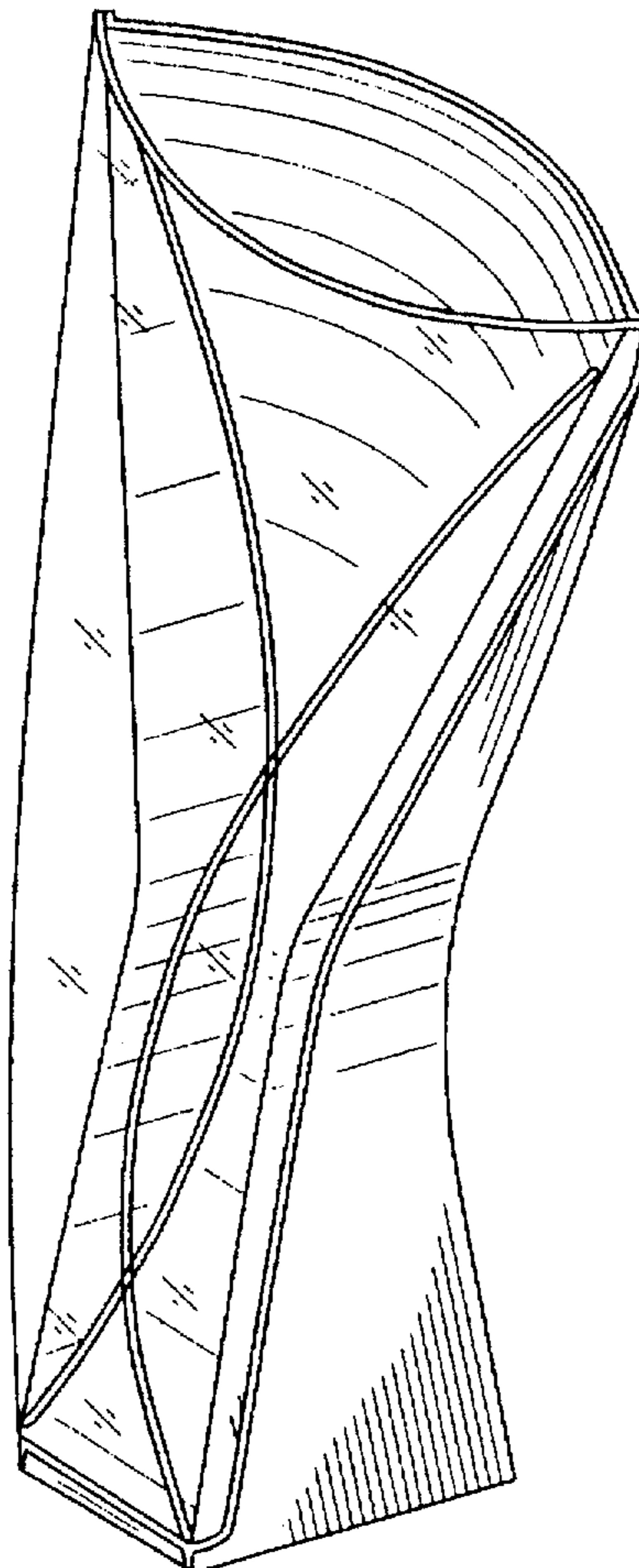
[57] **CLAIM**

The ornamental design for a foldable container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a foldable container showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a front plan view thereof;
 FIG. 5 is a rear plan view thereof;
 FIG. 6 is a right side elevational view thereof, the opposite side being a mirror image;
 FIG. 7 is a front elevational view of the foldable container shown in an unexpanded condition;
 FIG. 8 is a rear elevational view thereof;
 FIG. 9 is a side elevational view of an alternative embodiment of the foldable container; and,
 FIG. 10 is a front elevational view thereof, the opposite side being a mirror image.

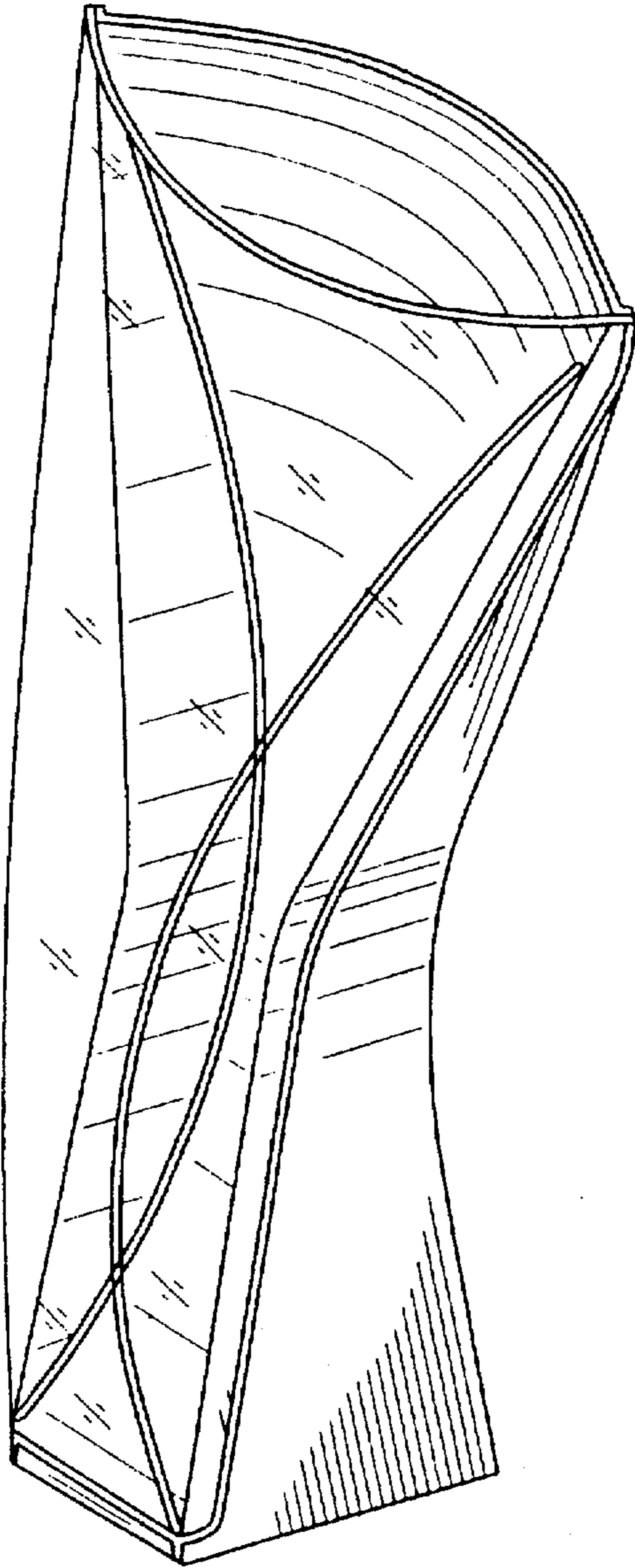

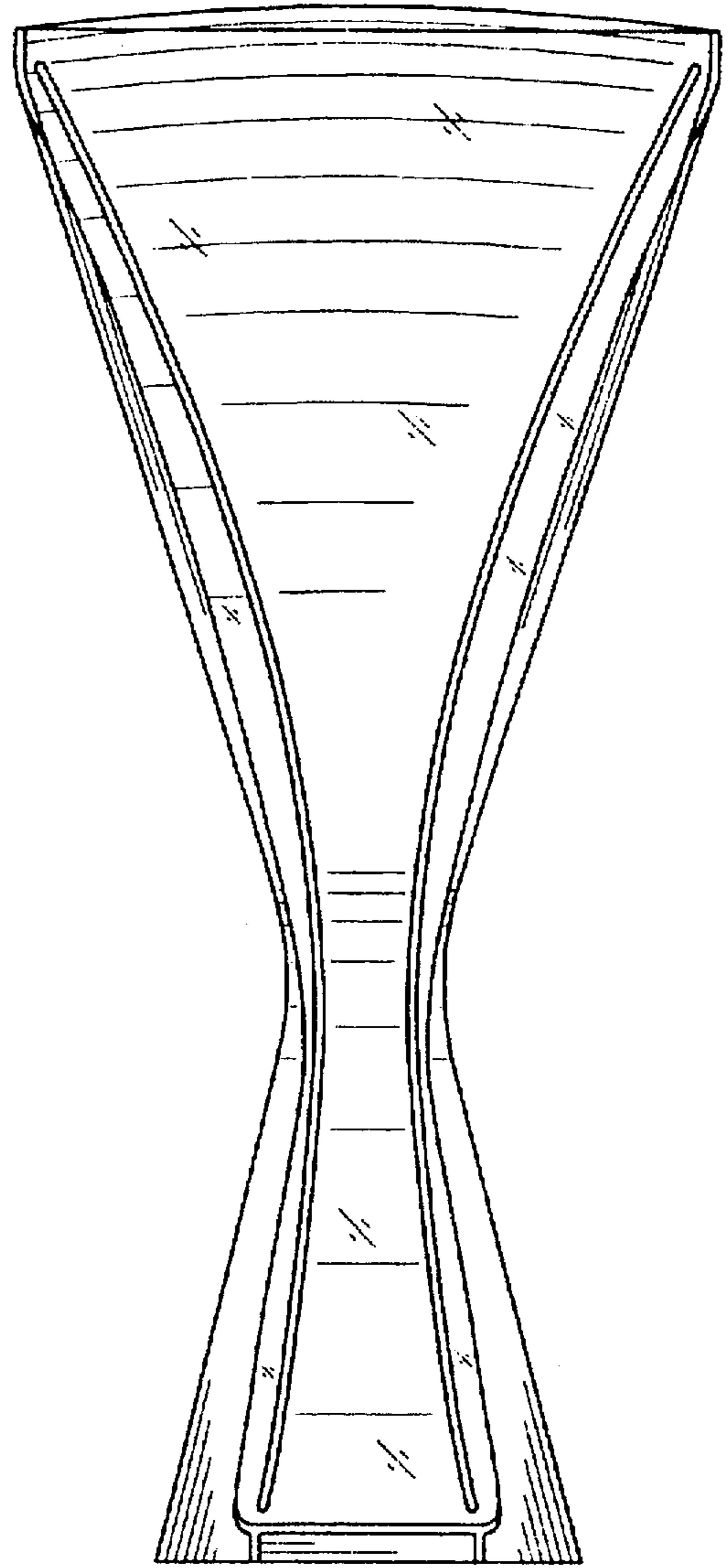

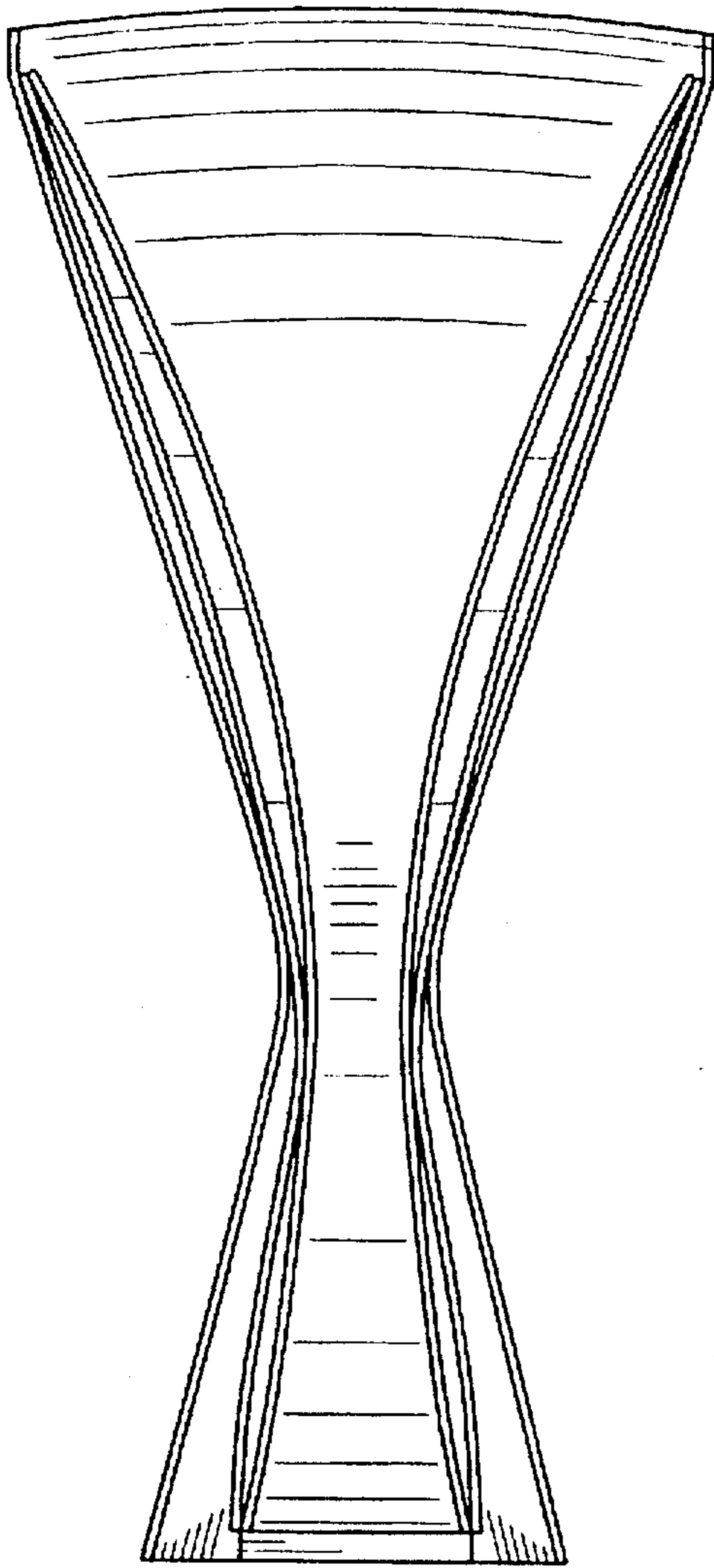

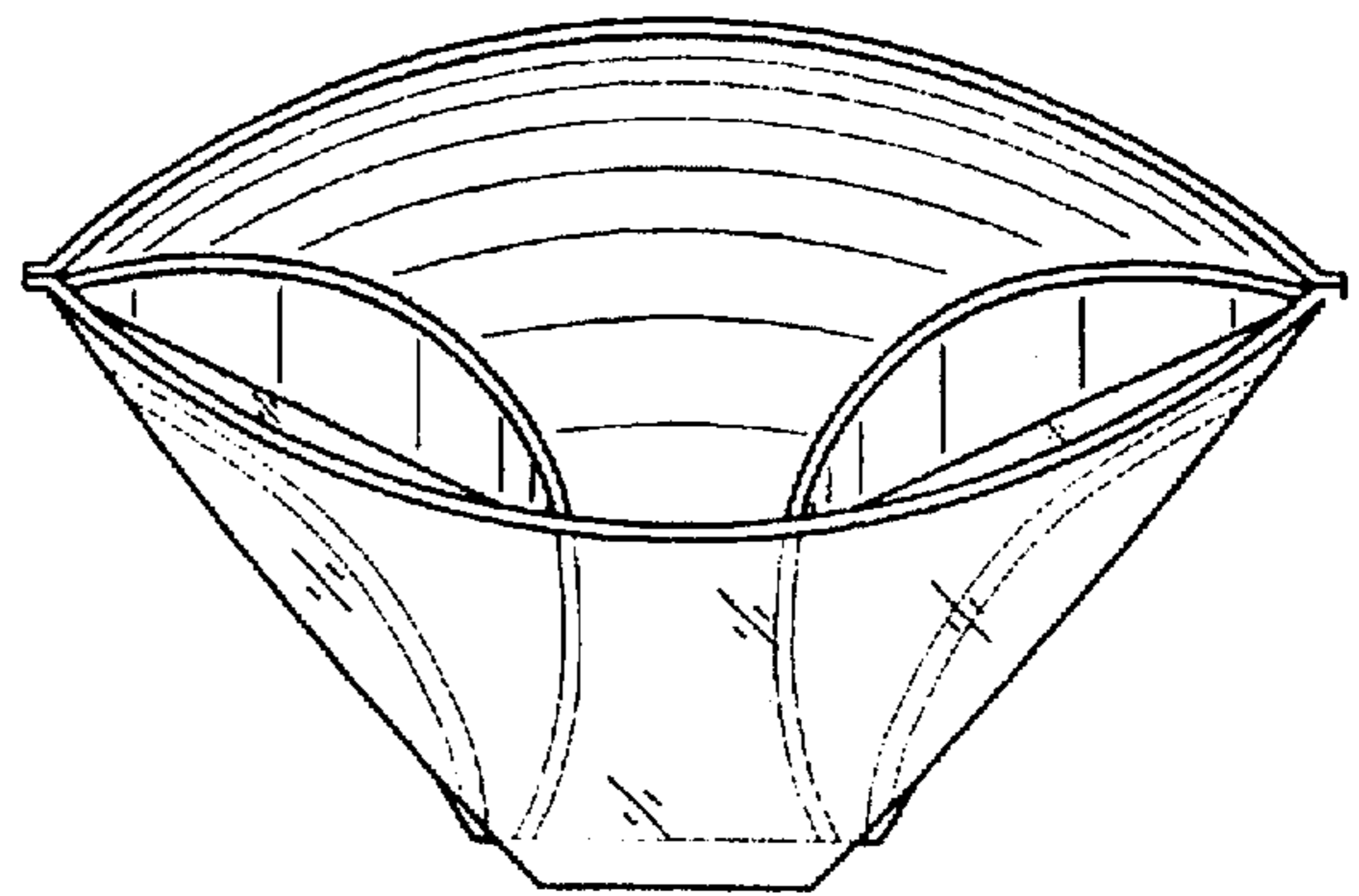

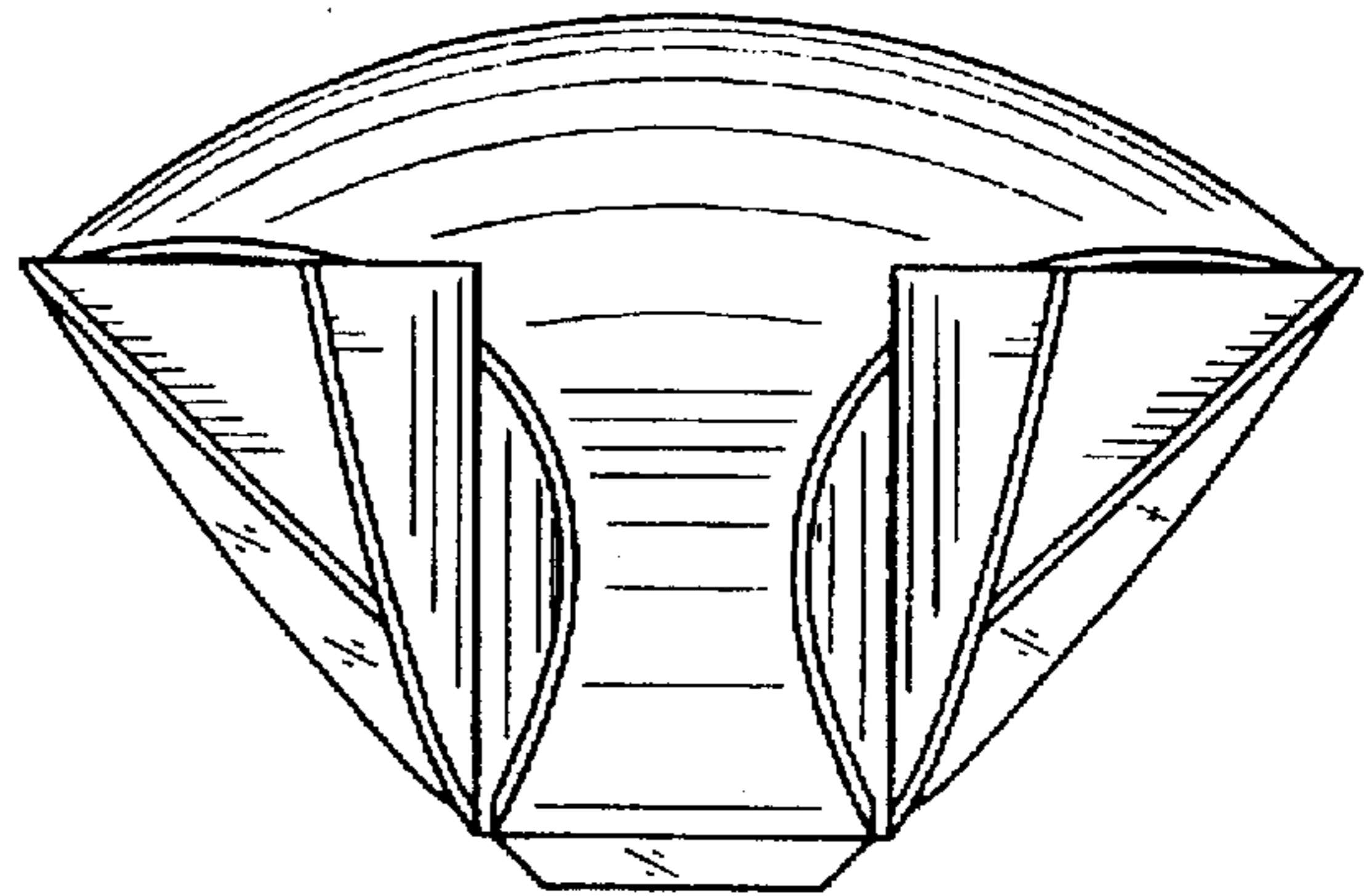

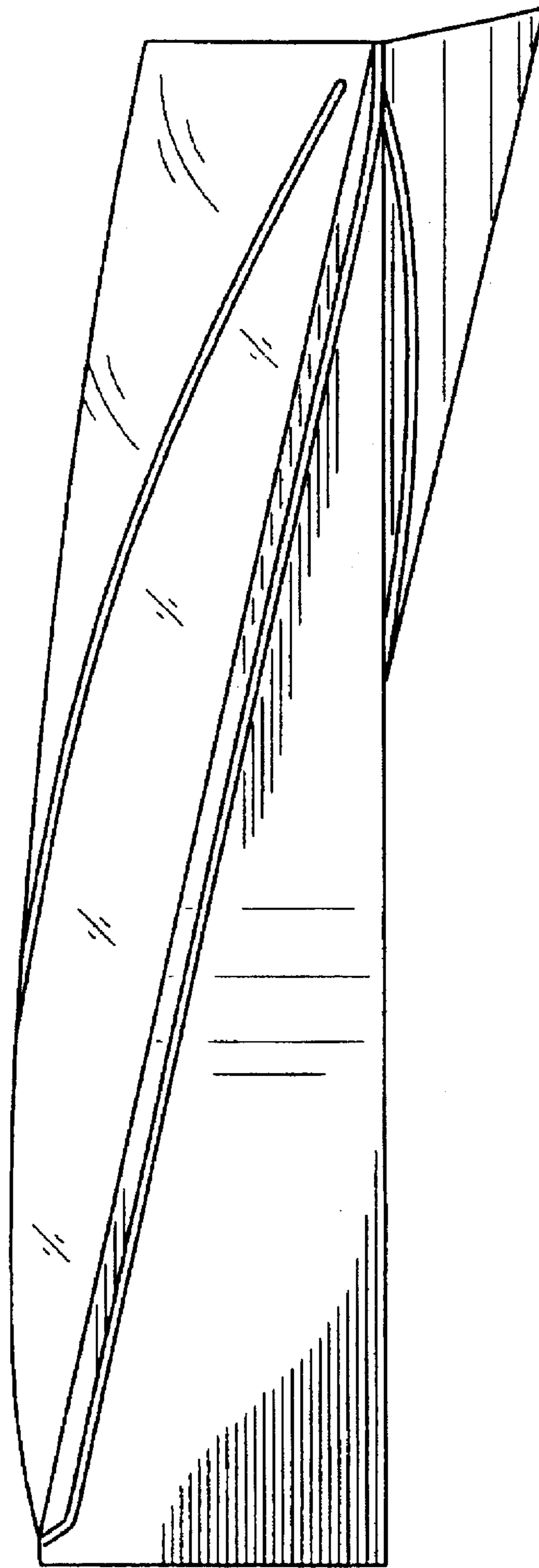

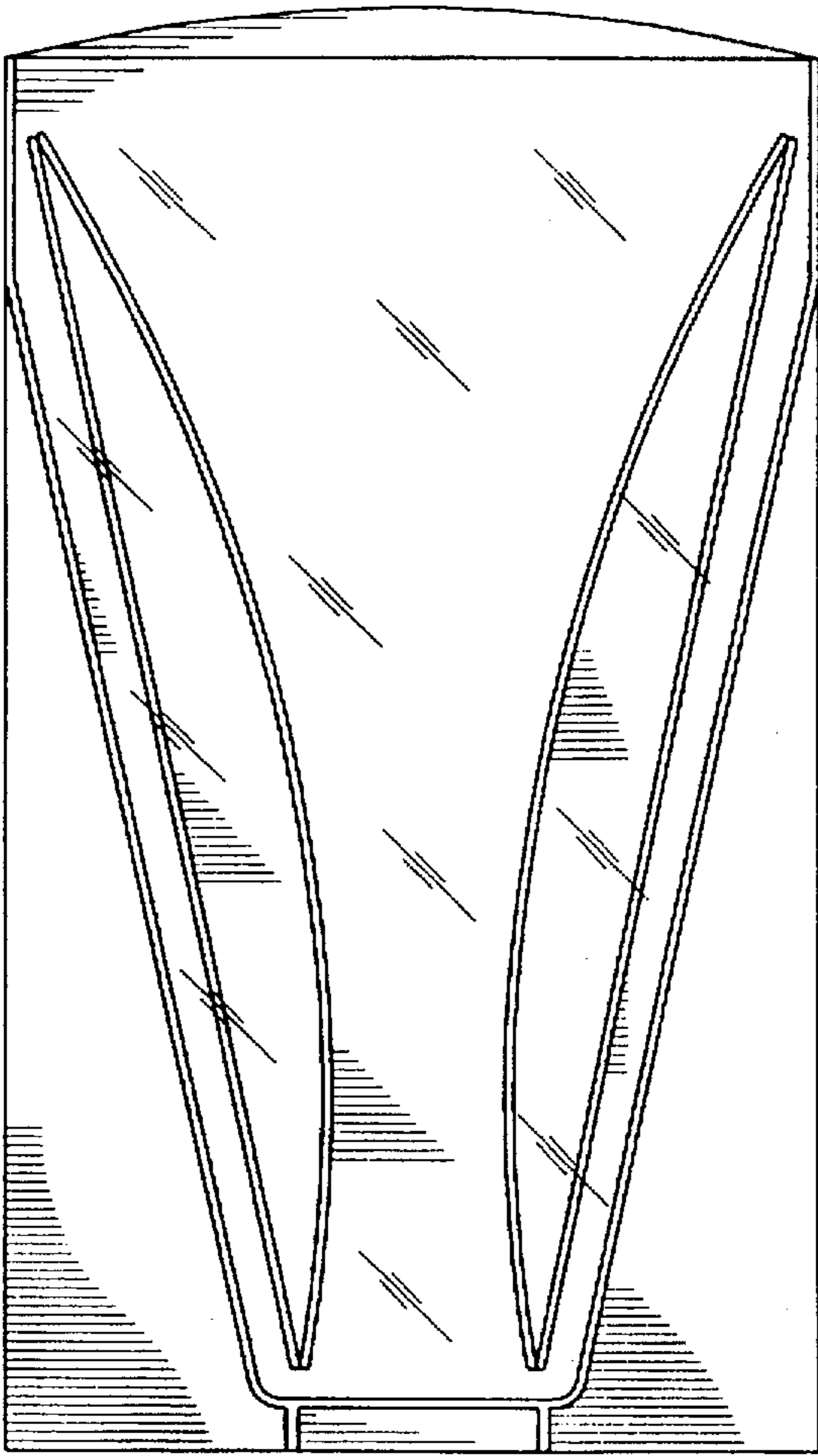

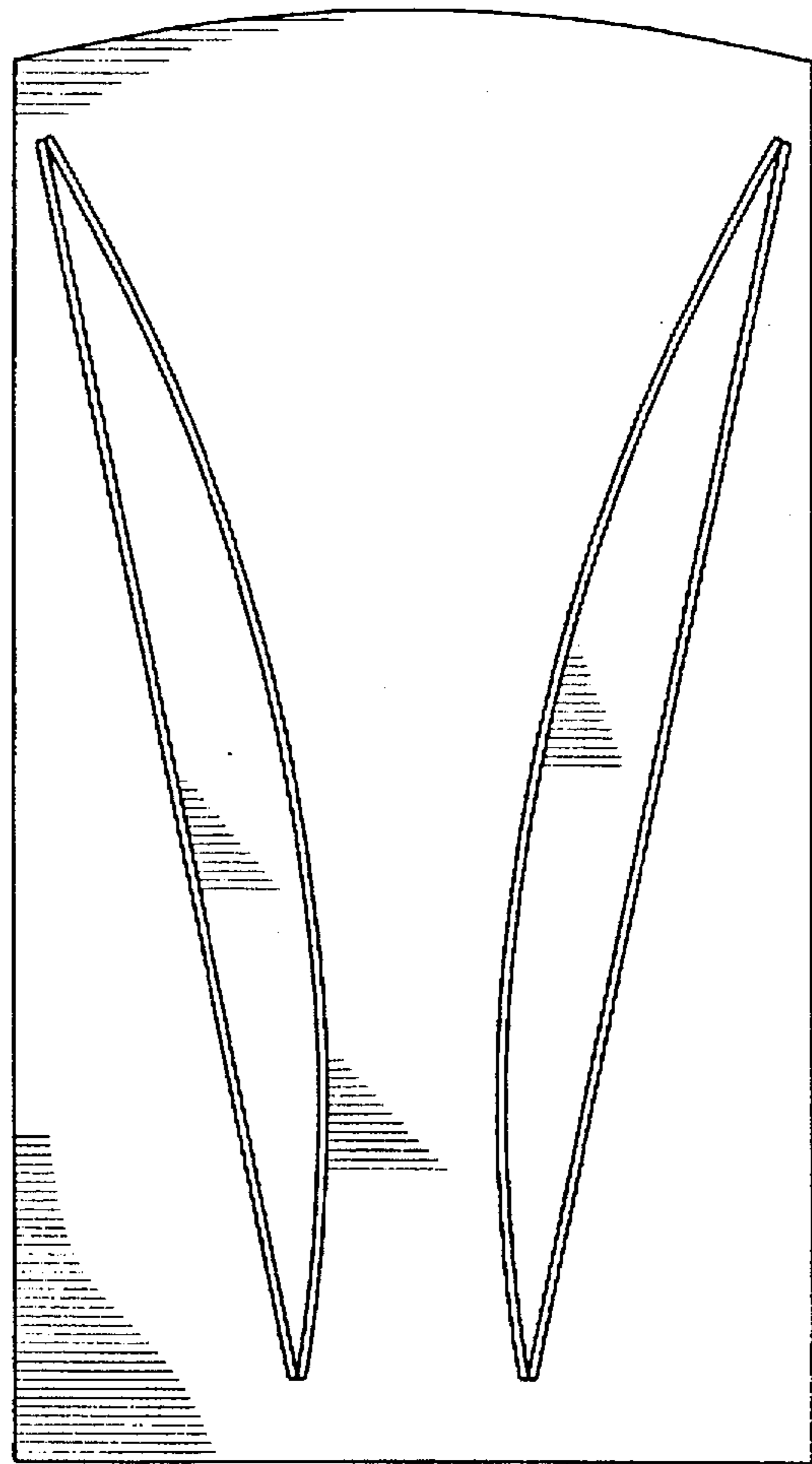

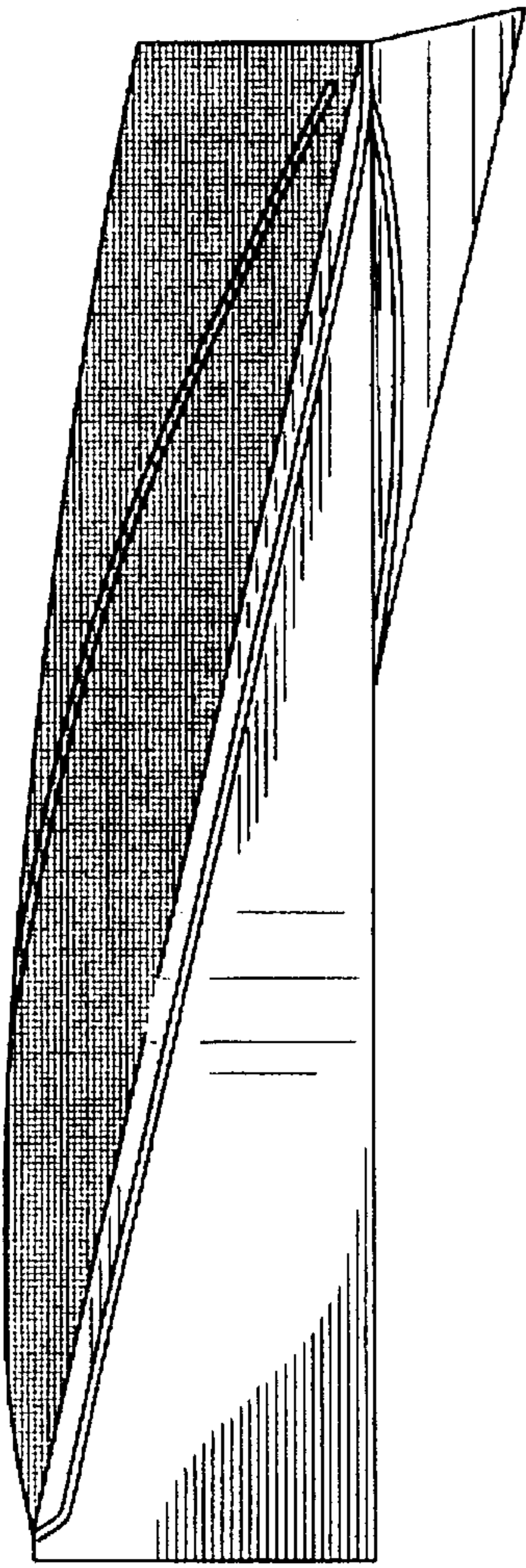

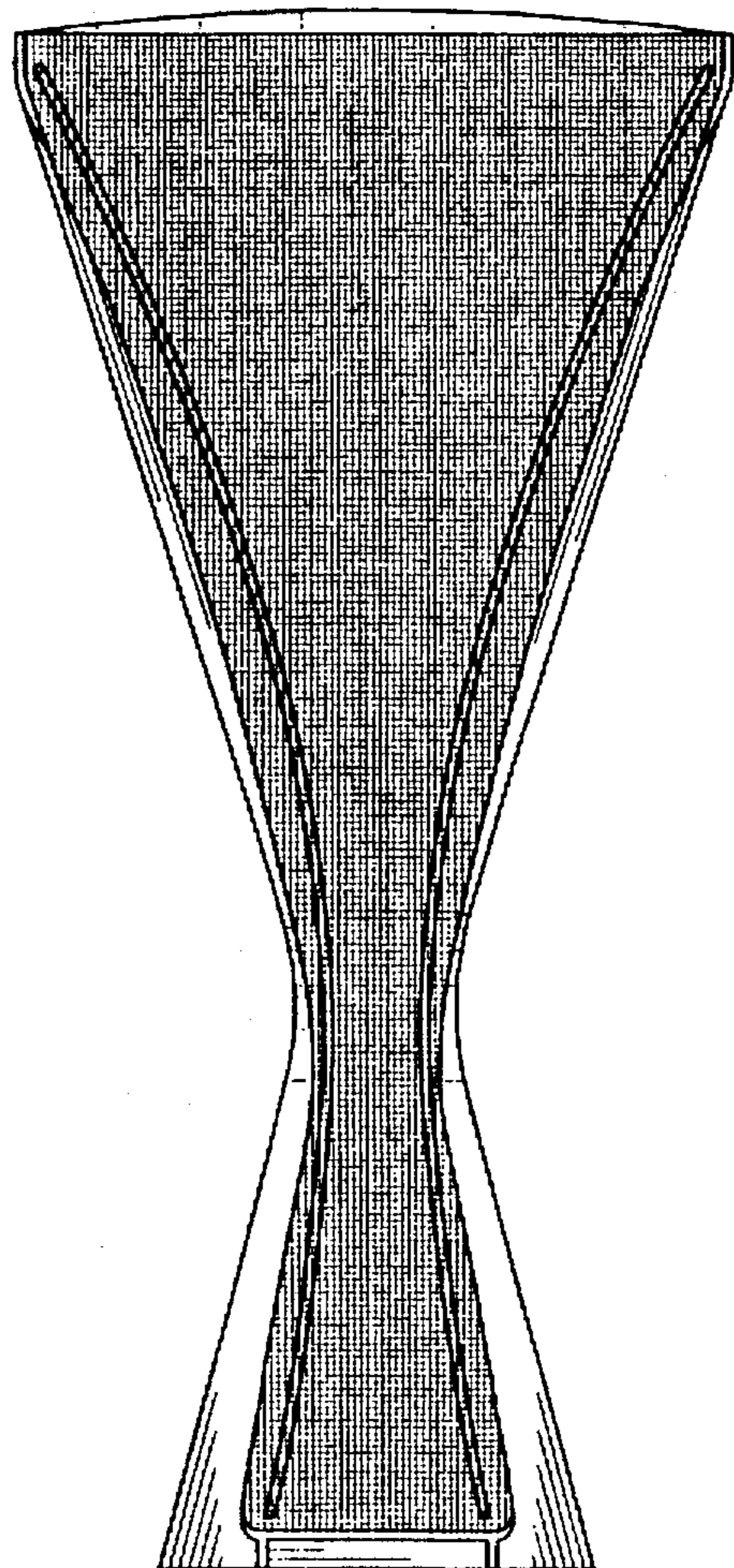
