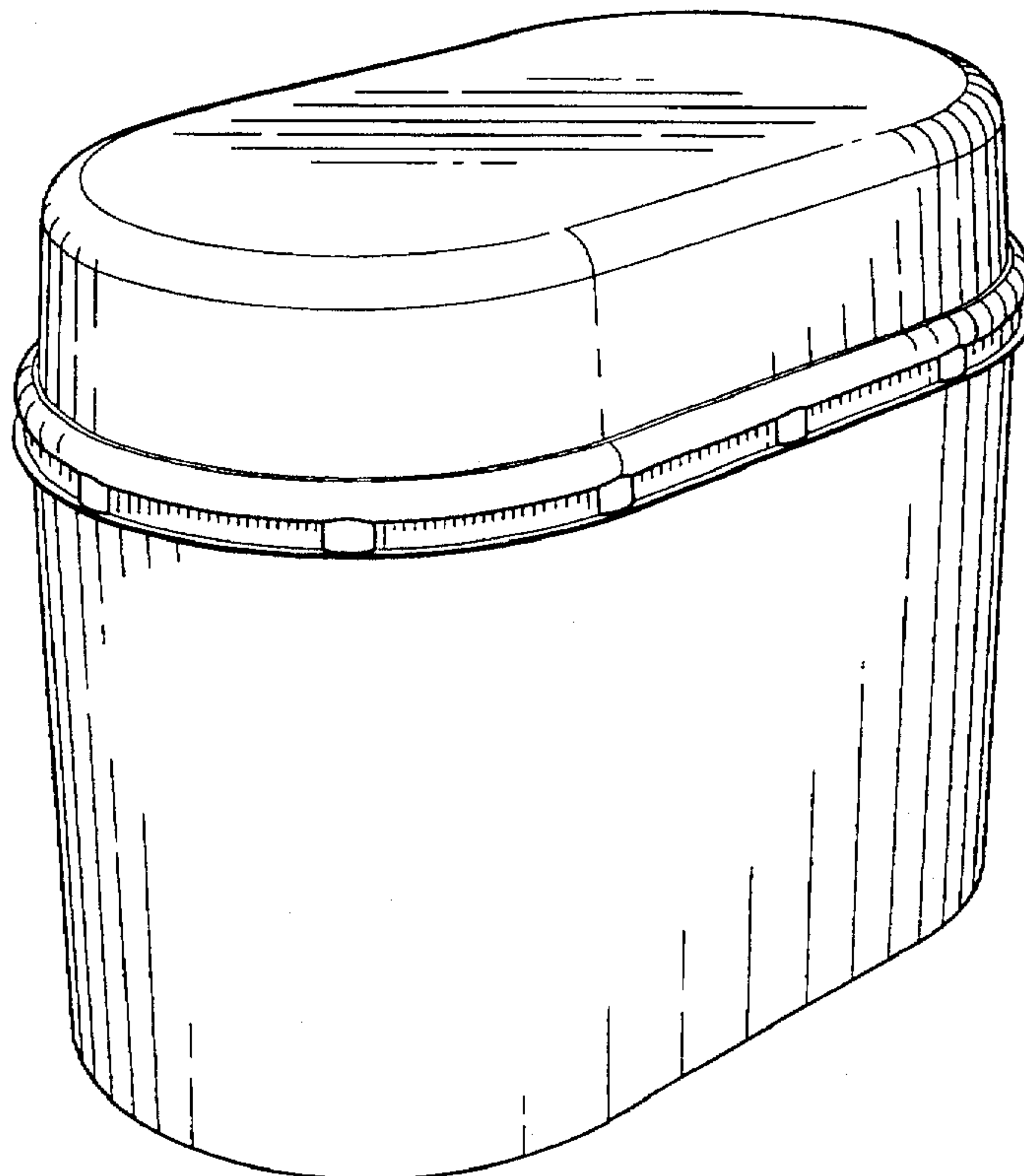
[57] **CLAIM**

The ornamental design for a combined carton and lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined carton and lid, embodying our new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a front view thereof; the rear view thereof being a mirror image thereof;  
FIG. 4 is a right side elevational view thereof; the left side elevational view being a mirror image thereof; and,  
FIG. 5 is a bottom view thereof.

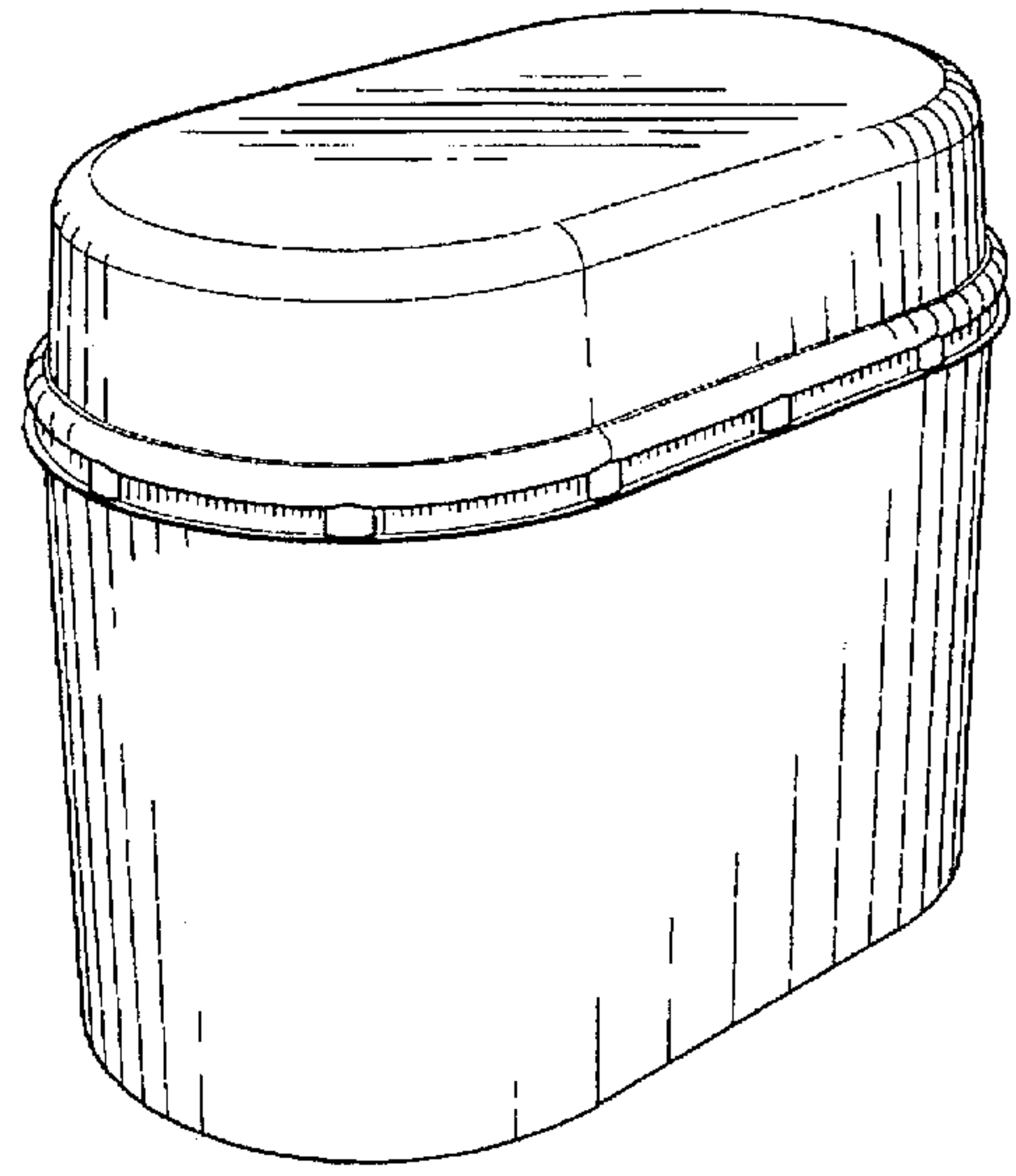

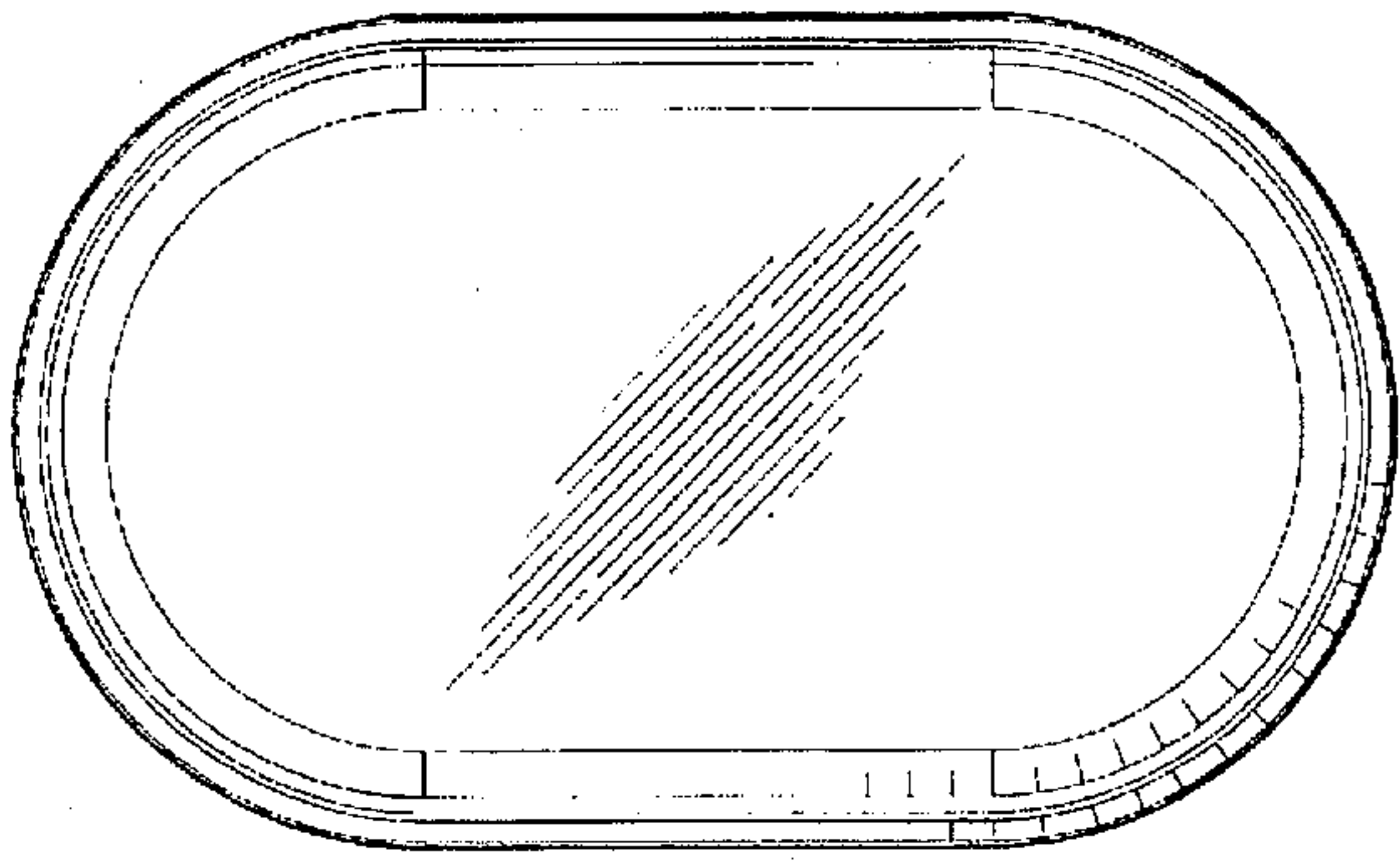

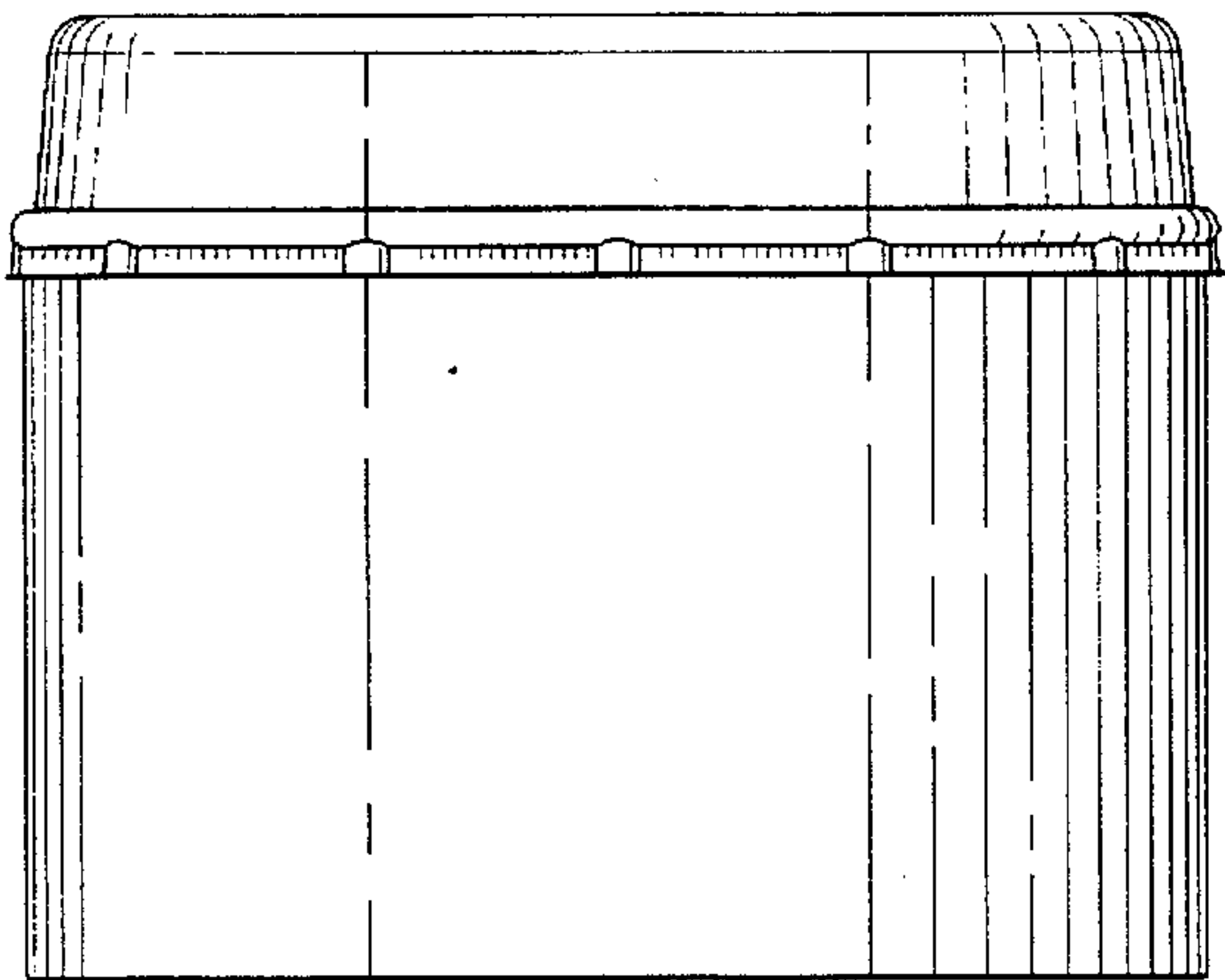

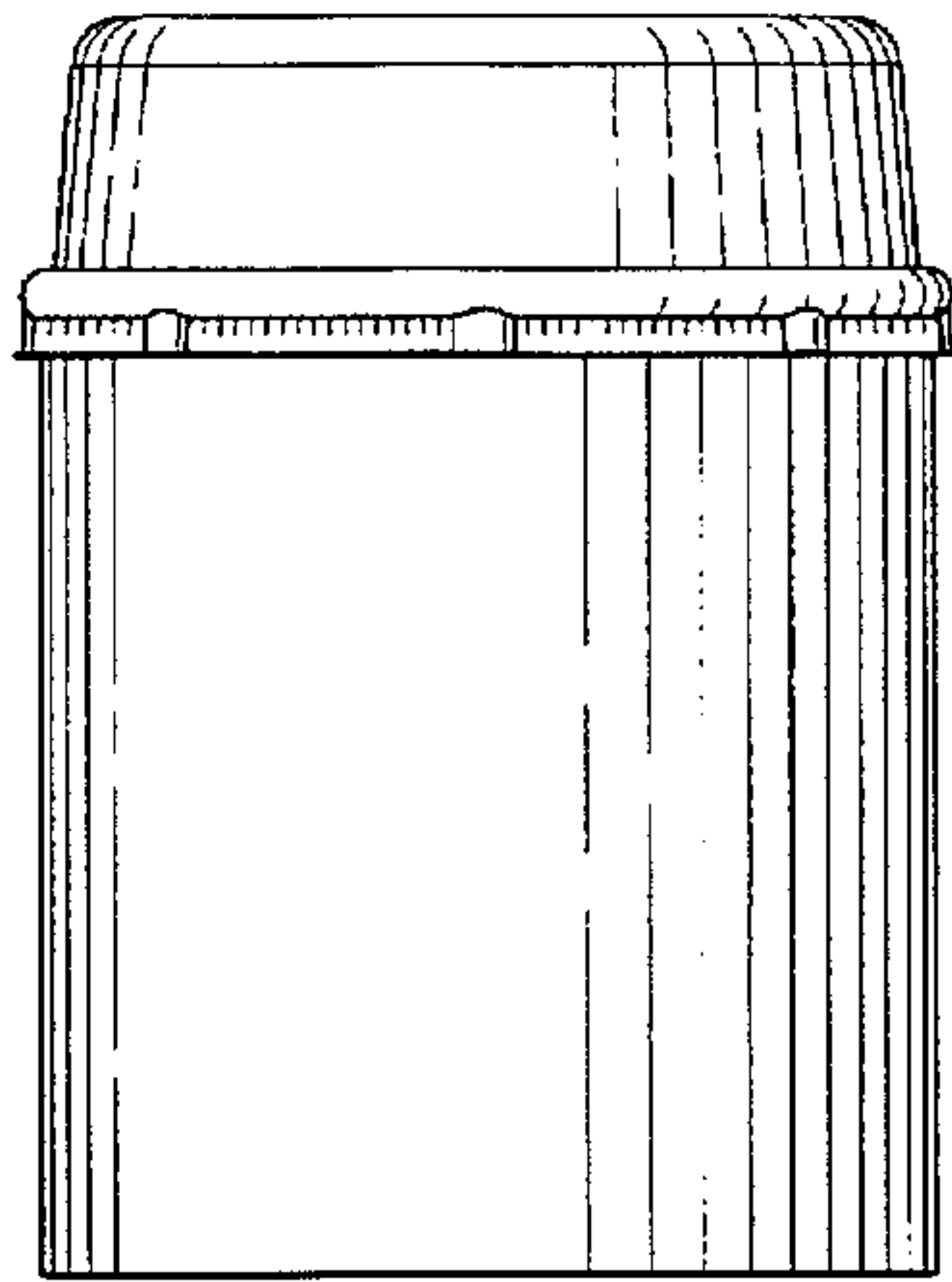

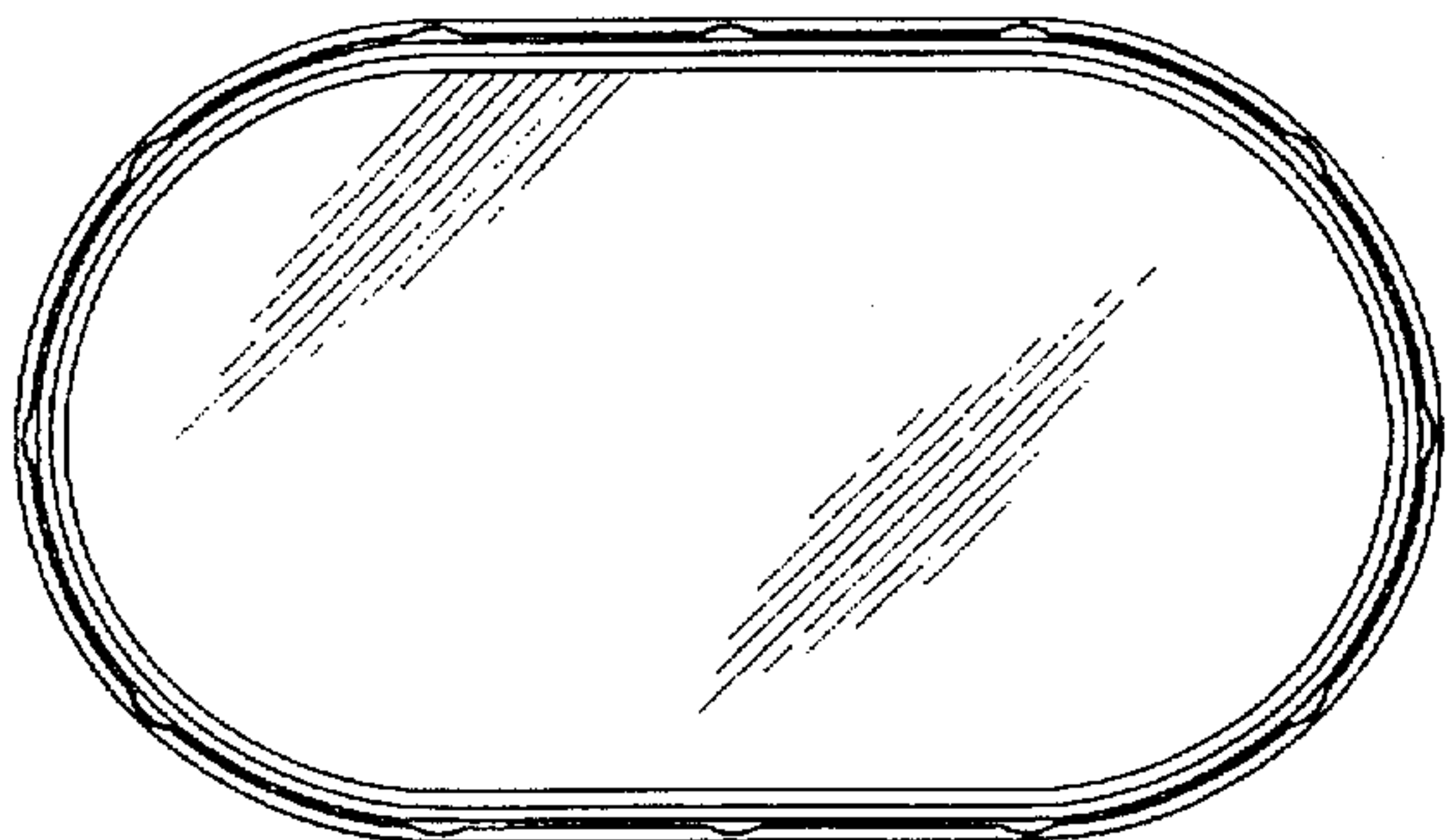
