DESCRIPTION

FIG. 1 is a diagrammatic perspective view of the step planter in full lines with steps in broken lines representing environmental association matter being for illustrative purposes only and forming no part of the claimed invention.

FIG. 2 is a diagrammatic perspective view of the step planter in full lines with flowers and dirt in broken lines representing environmental association matter being for illustrative purposes only and forming no part of the claimed invention.

FIG. 3 is a front elevational view of the step planter.

FIG. 4 is a rear elevational view thereof.

FIG. 5 is a top plan view thereof.

FIG. 6 is a bottom plan view thereof. and,

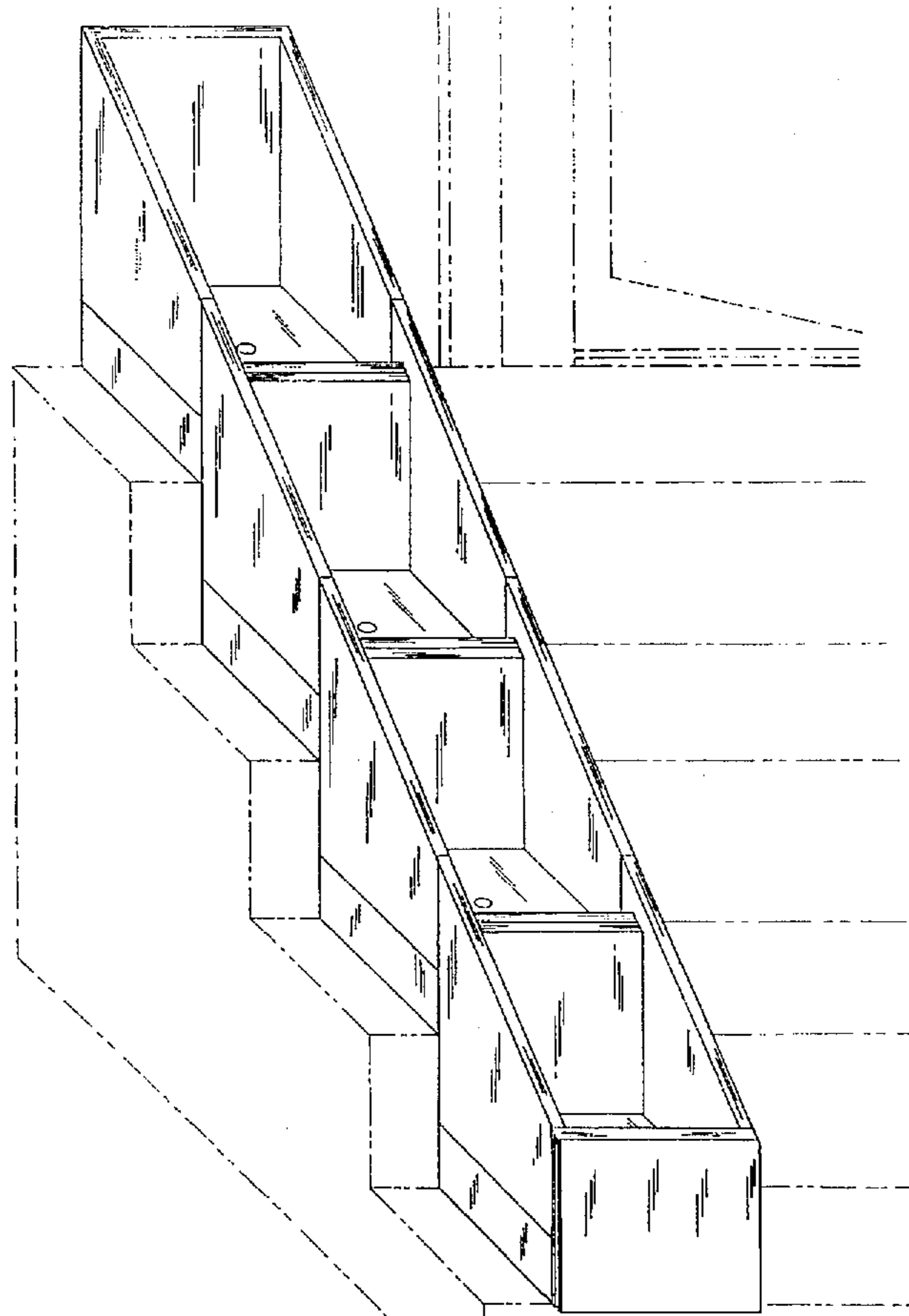
FIG. 7 is a right side elevational view of the step planter, the left side view being a mirror image of the right side view.

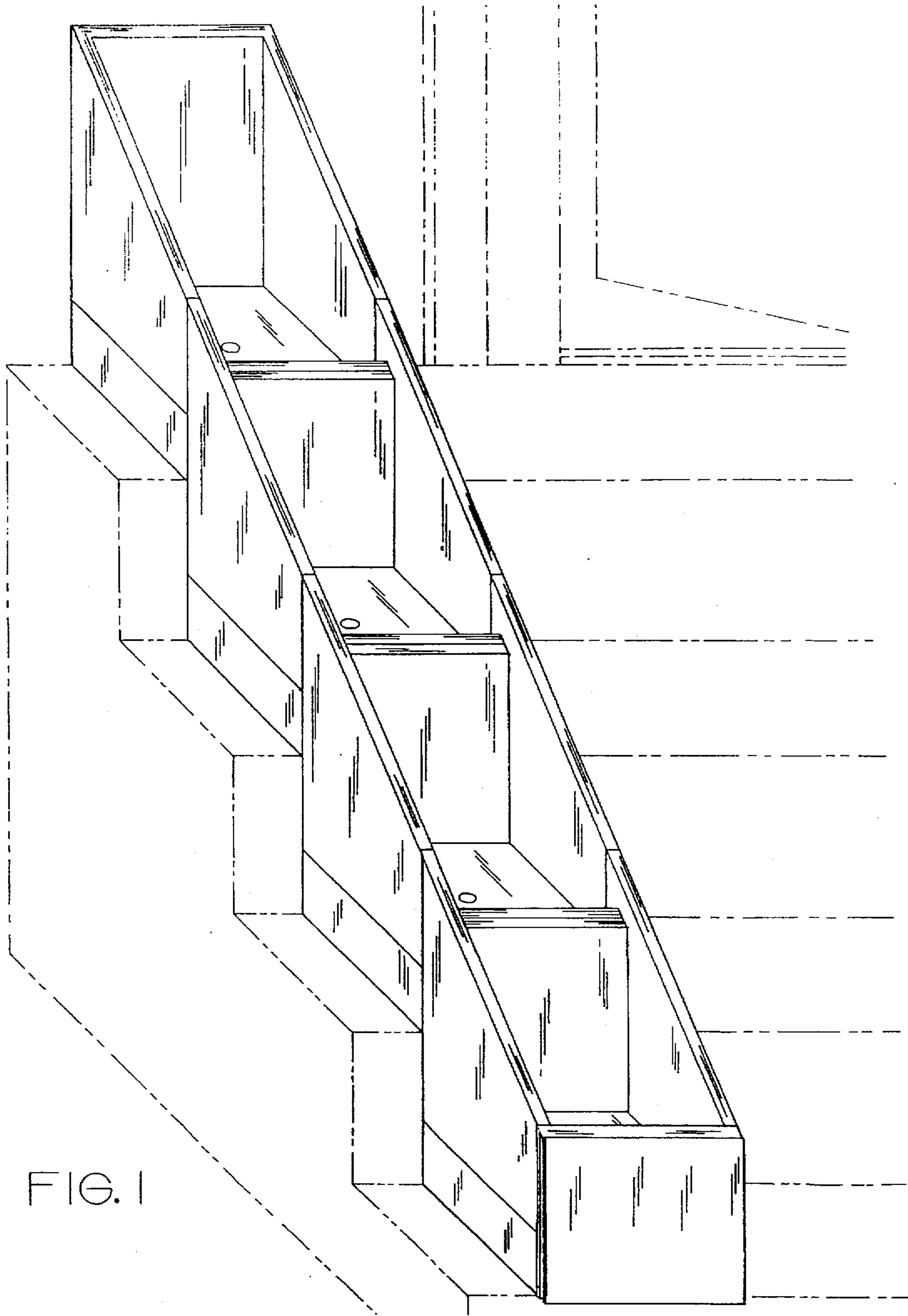

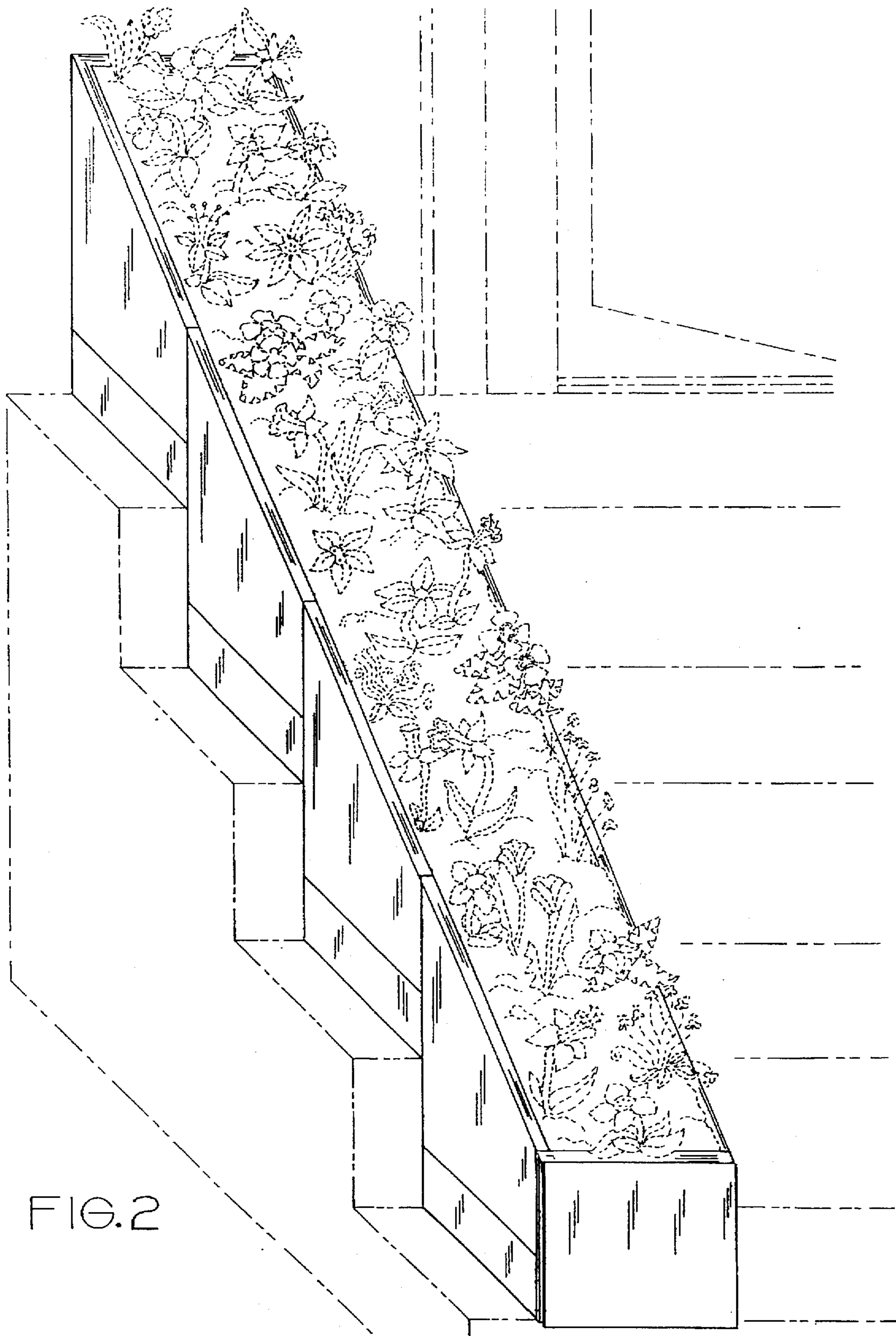

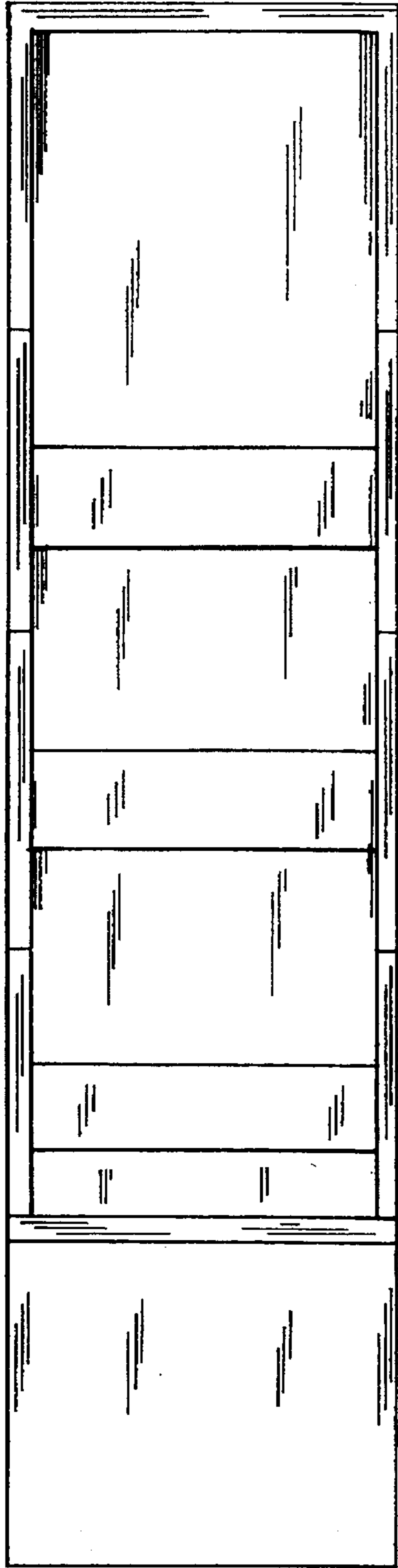

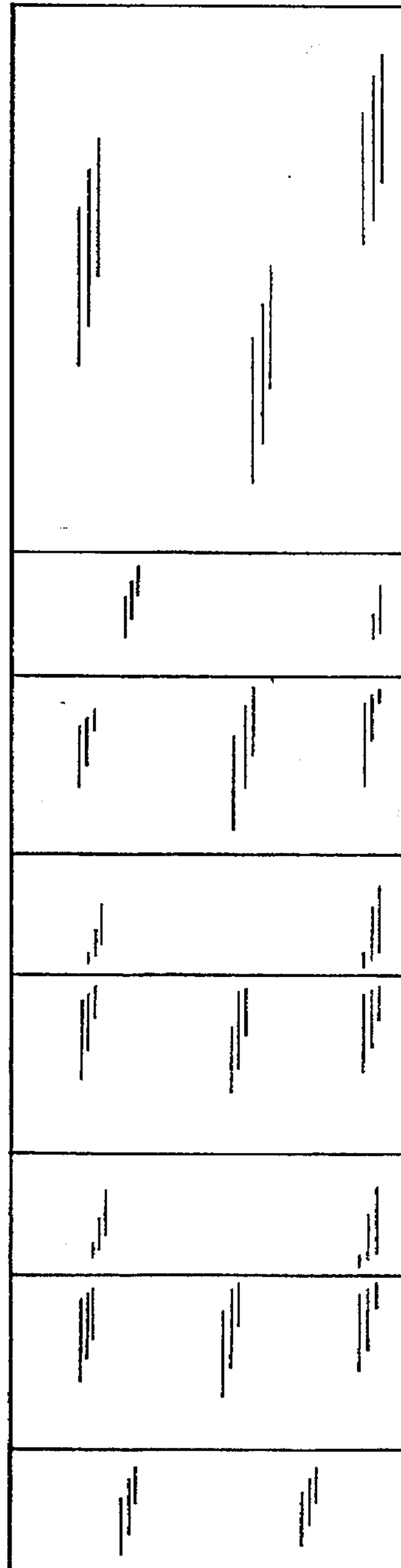

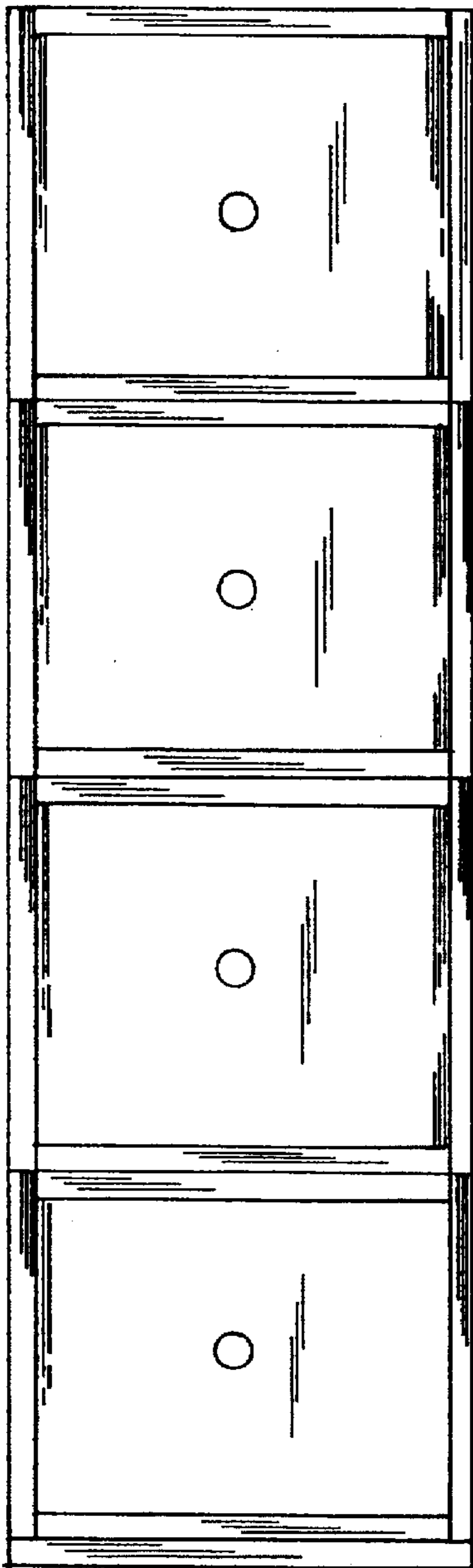

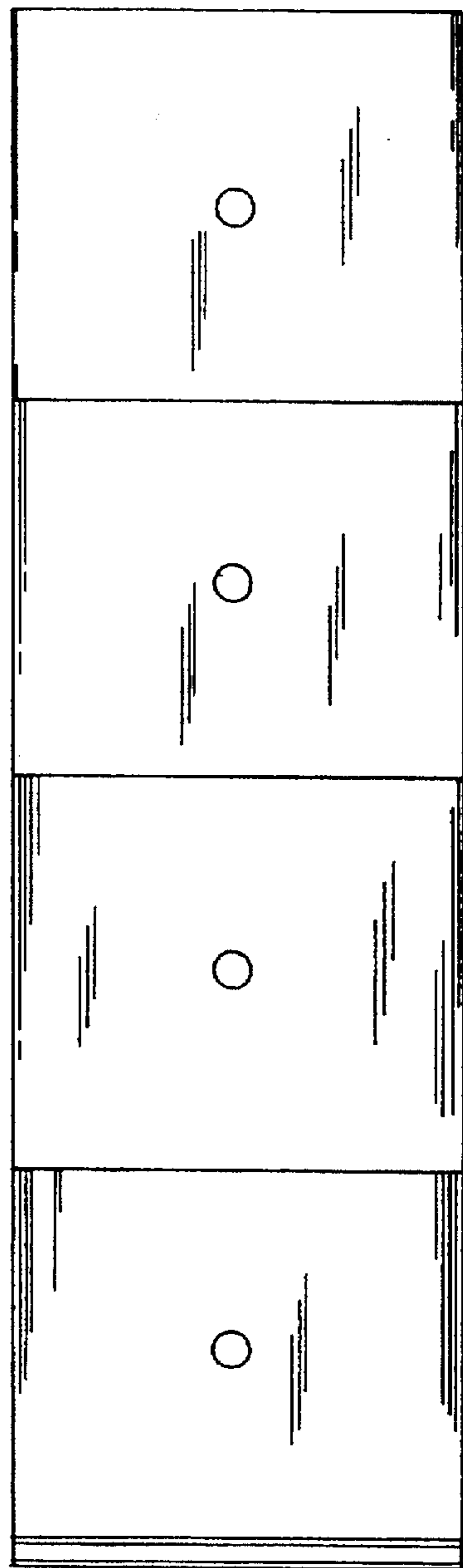
