DESCRIPTION

FIG. 1 is a front elevational view of a carrying case showing our new design;

FIG. 2 is a rear elevational view thereof;

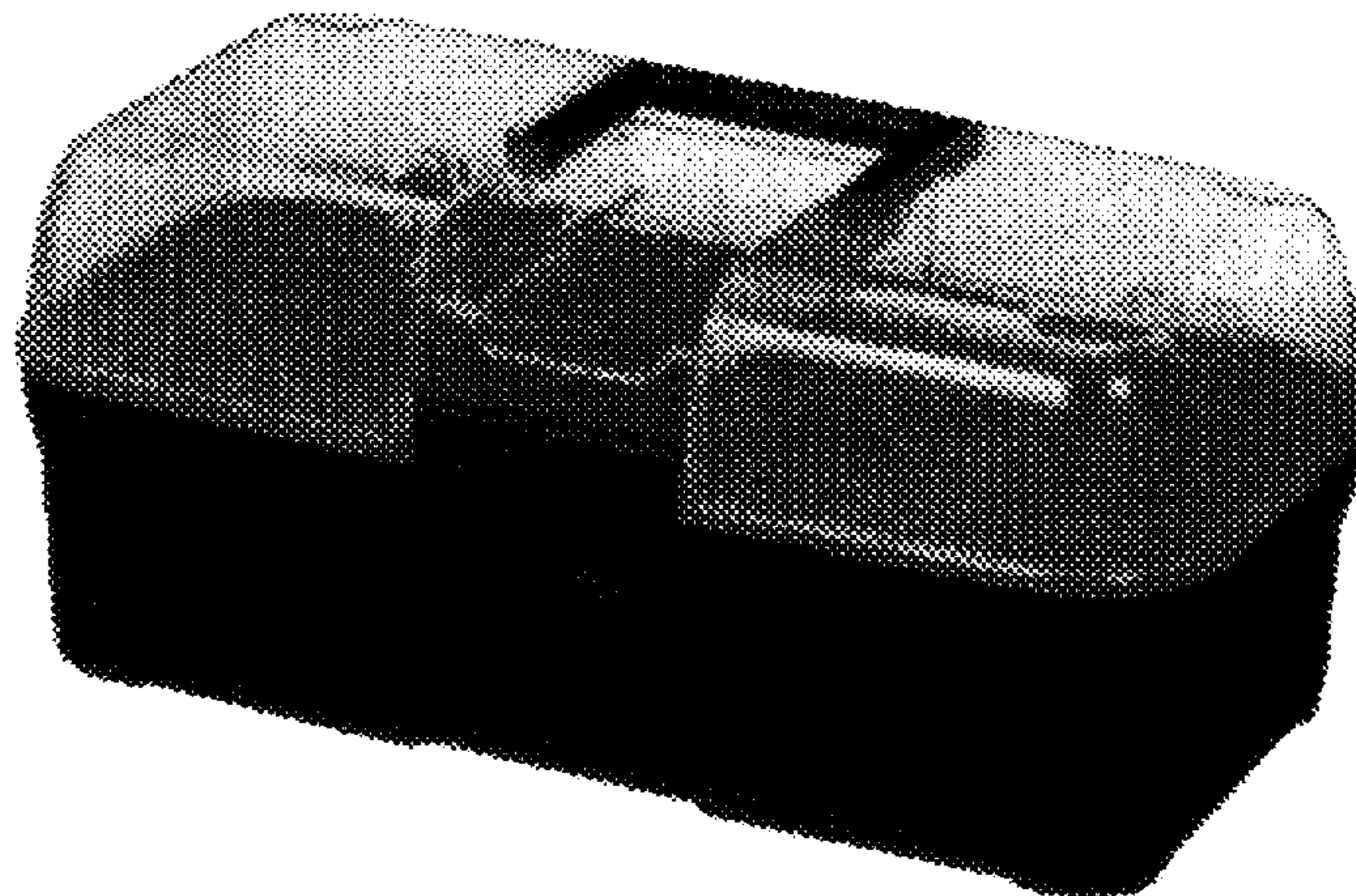

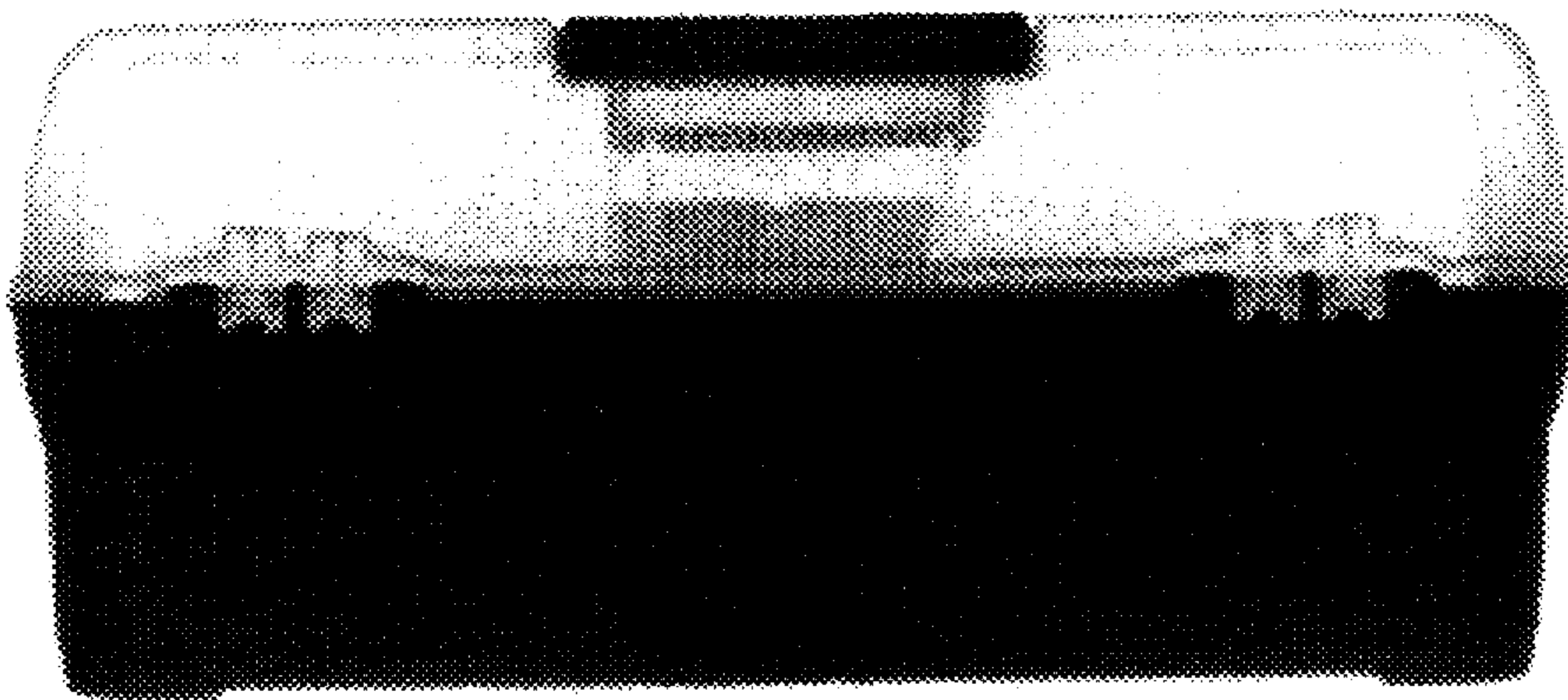

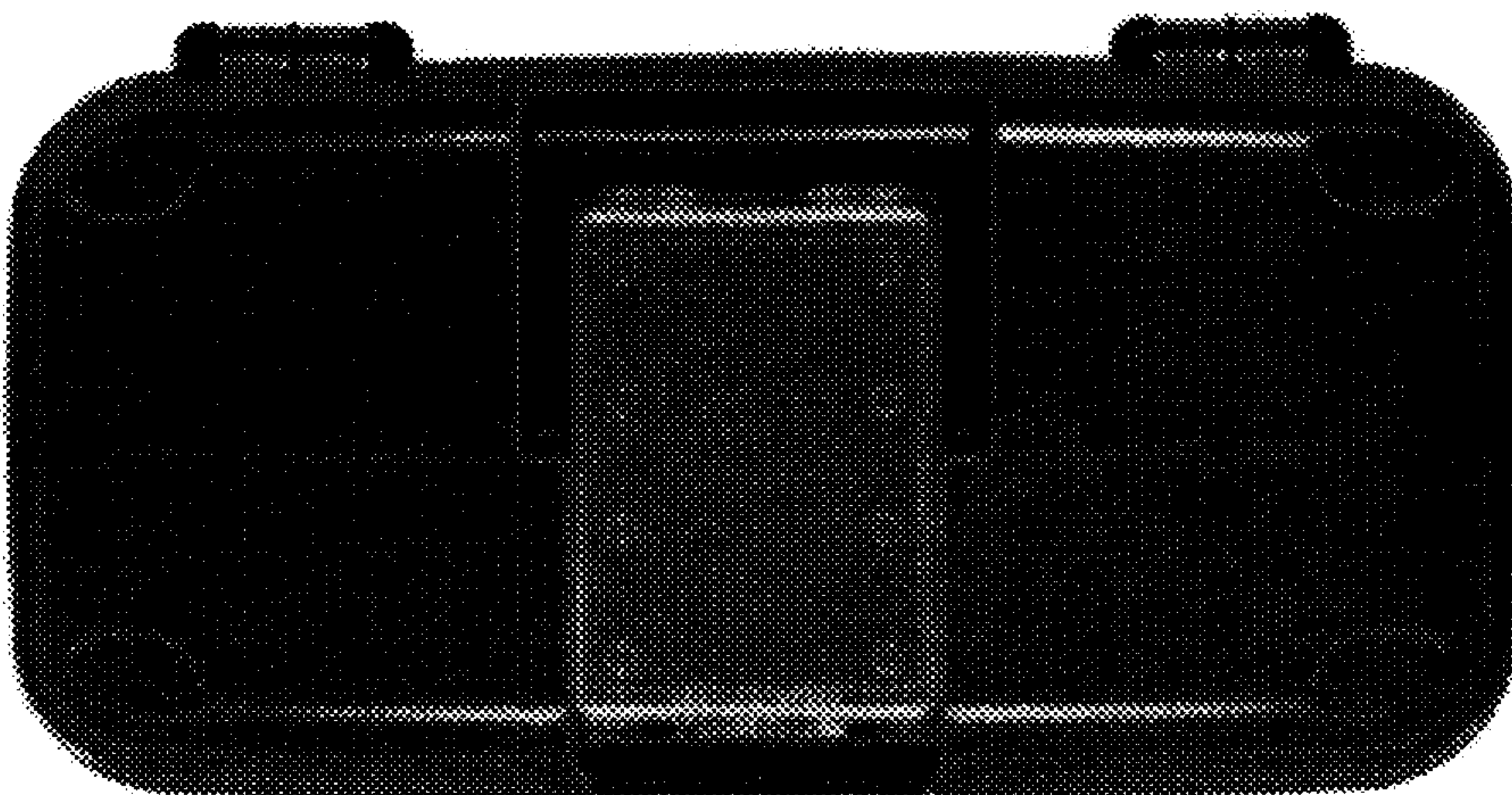

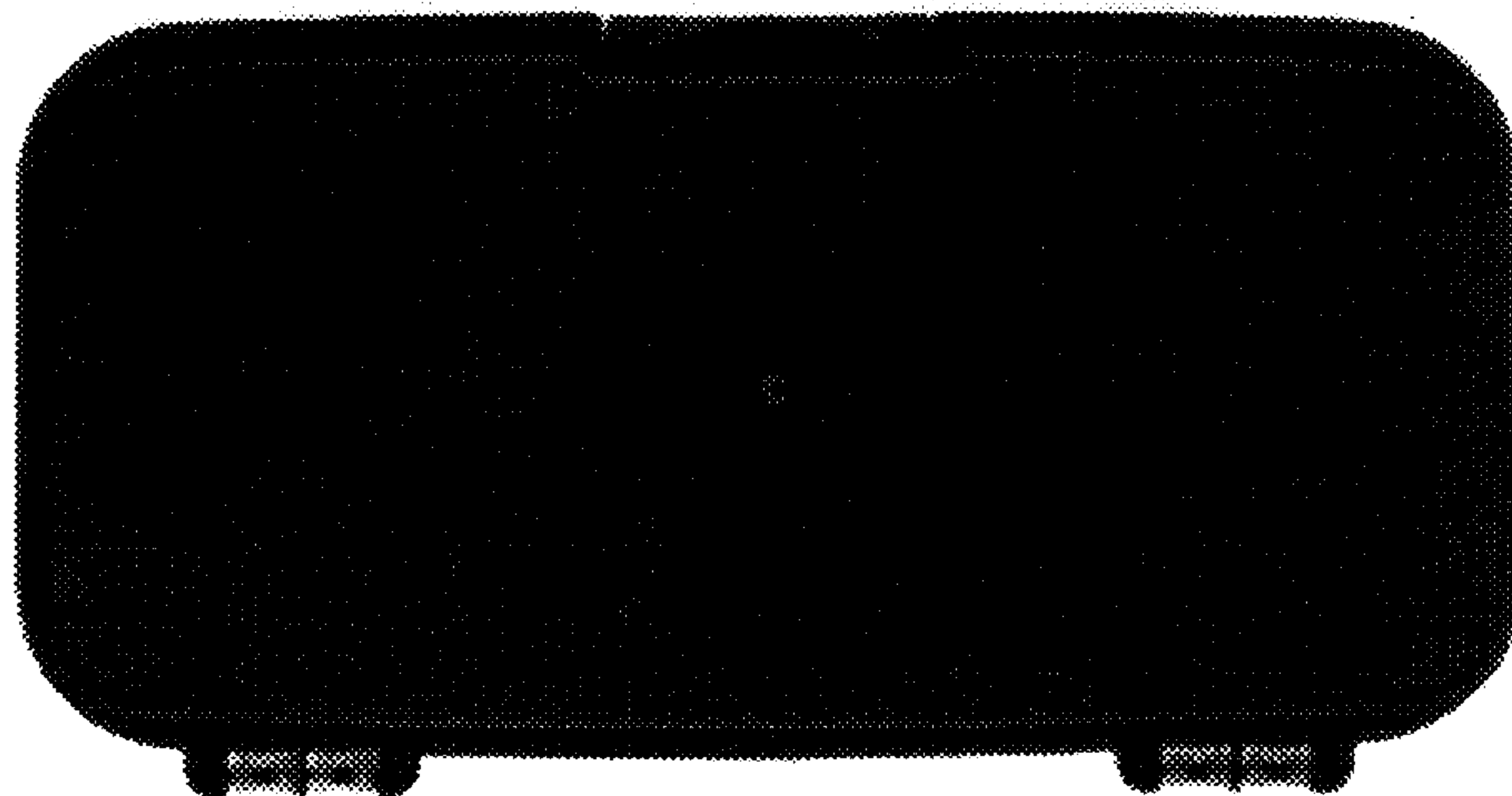

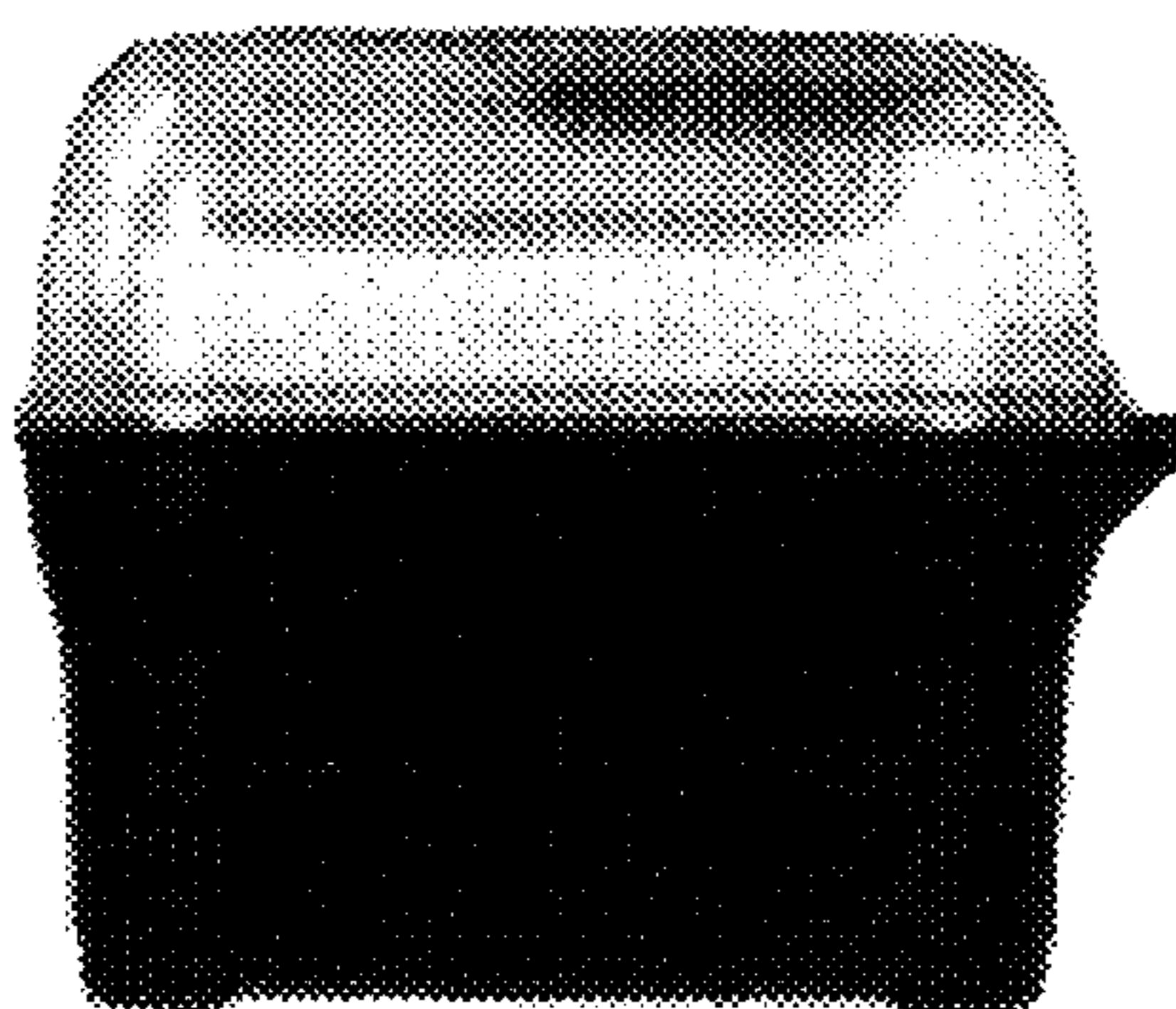

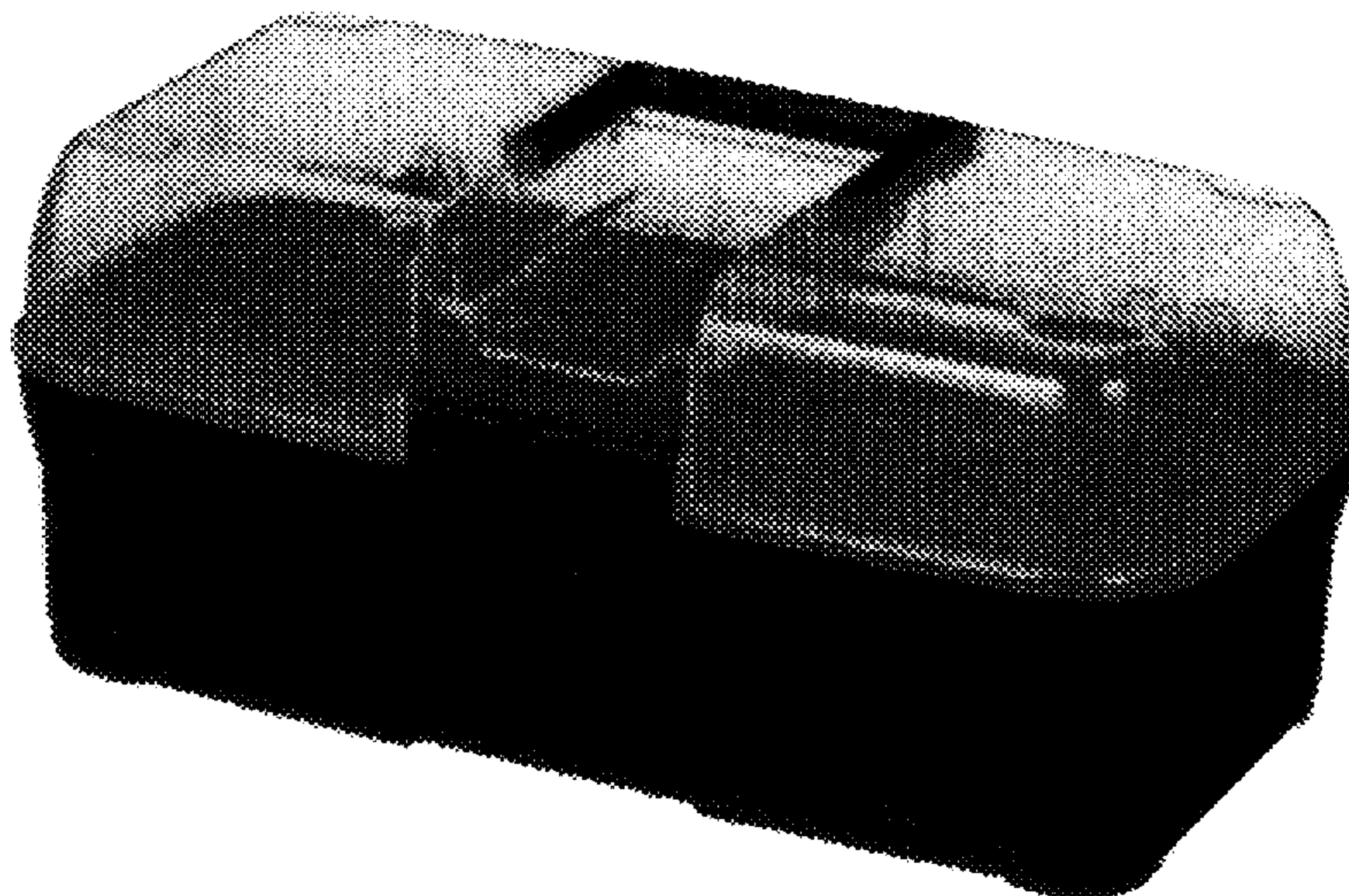
