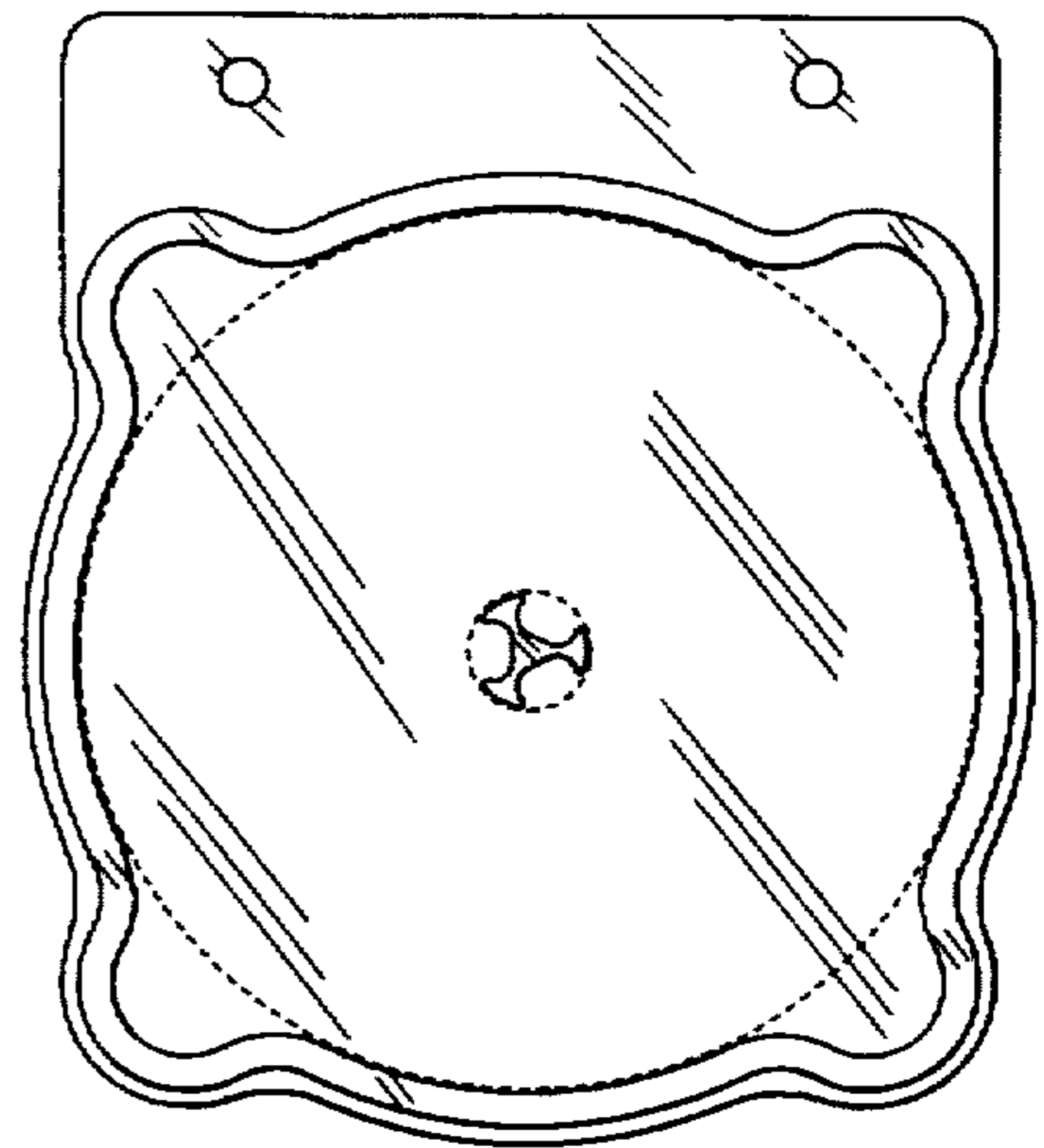
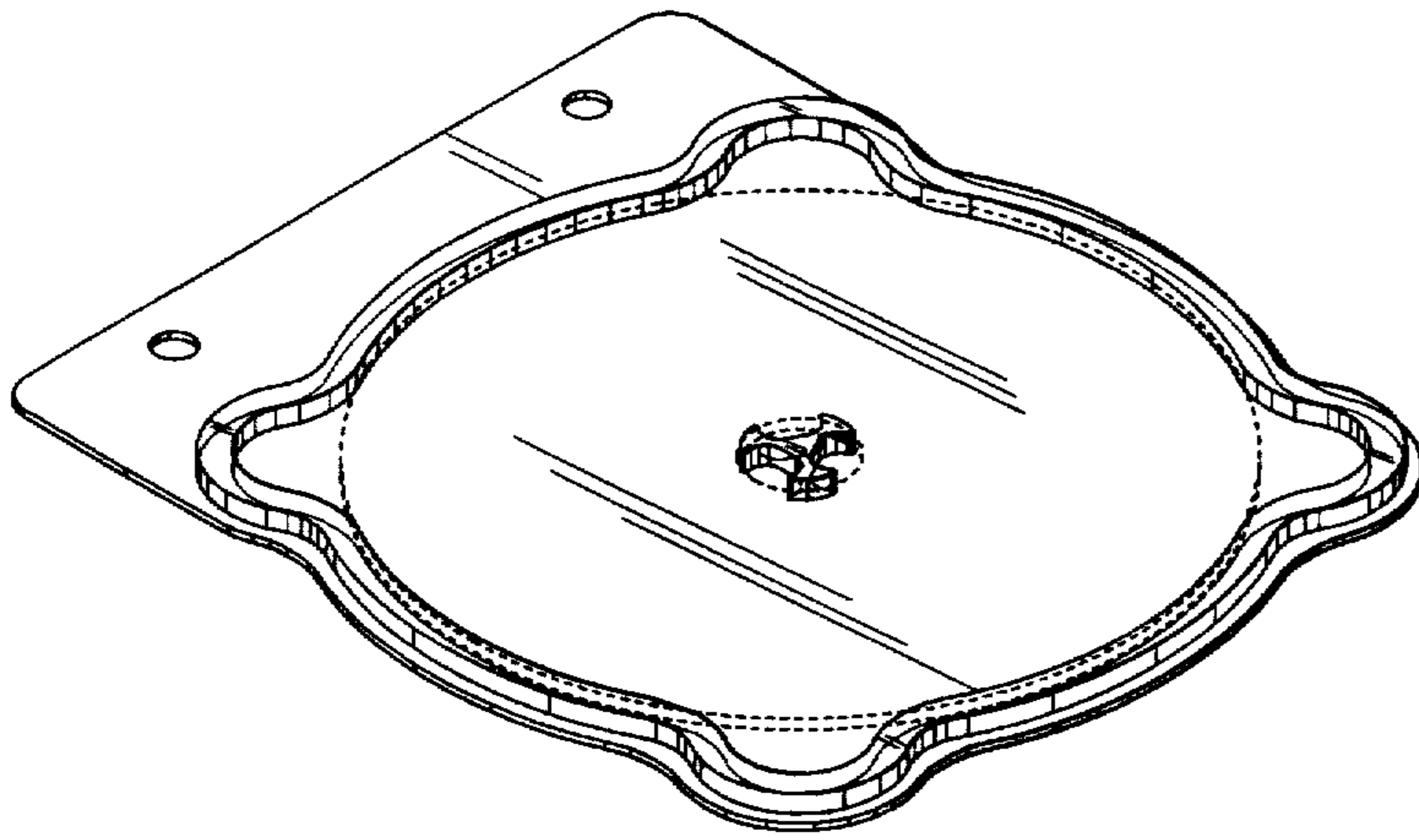
[57] **CLAIM**

The ornamental design for the compact disc holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a compact disc holder showing my new design, the broken lines showing a disc in the first two views being for illustrative purposes only and forming no part of the claimed design; FIG. 2 is a front view thereof; FIG. 3 is a top view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a back view thereof; FIG. 6 is a bottom view thereof; and, FIG. 7 is a right side view thereof.

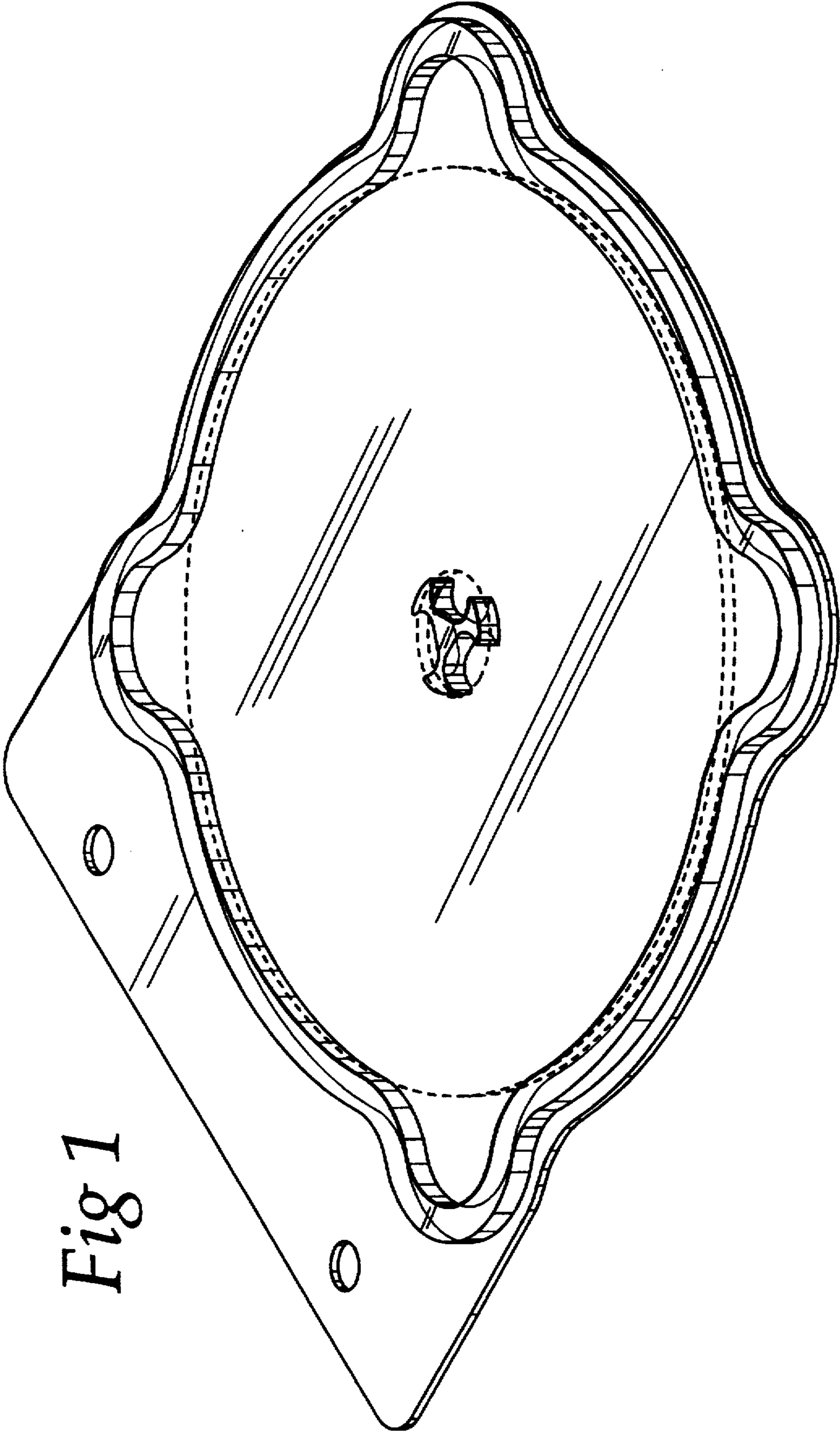
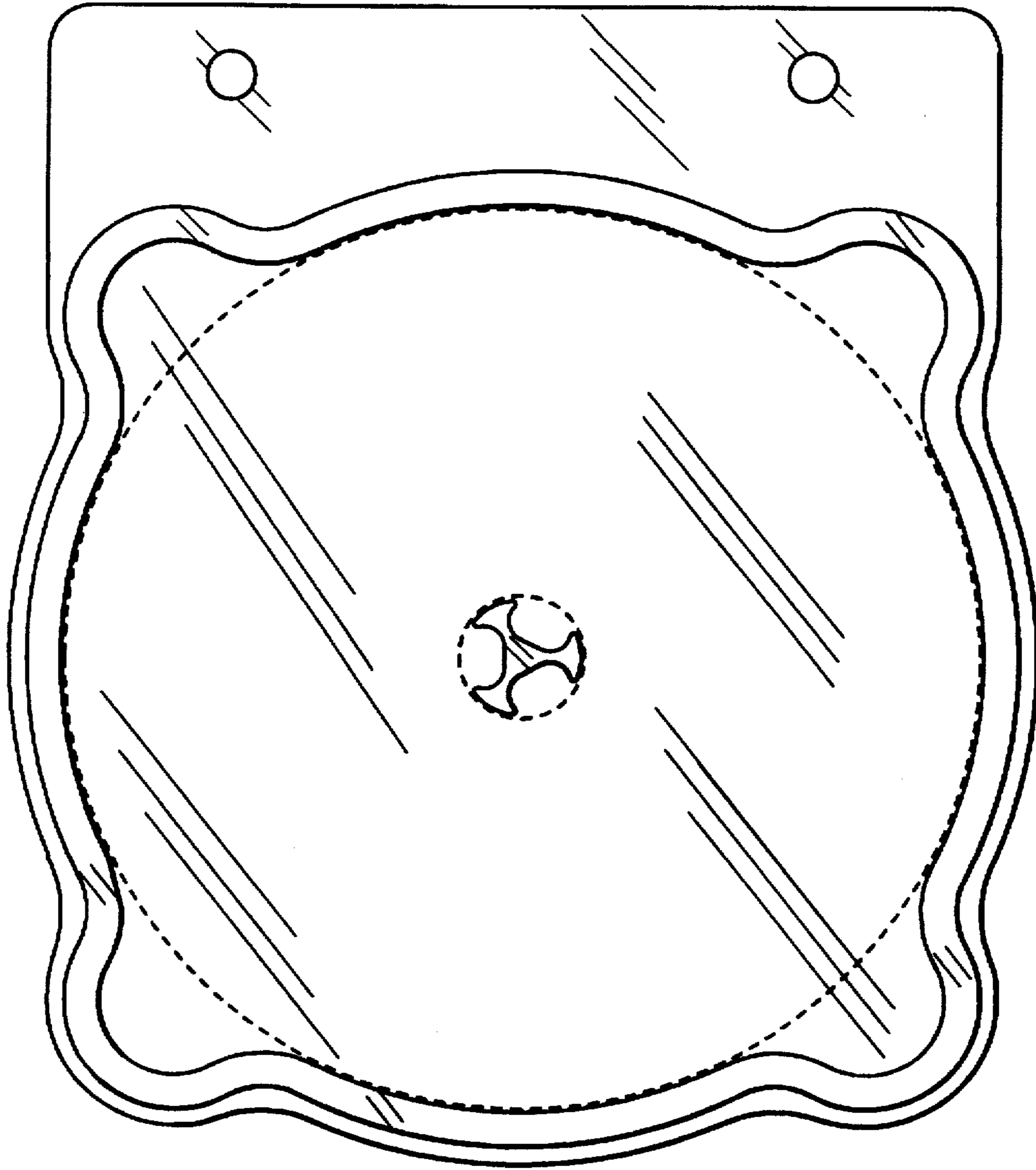

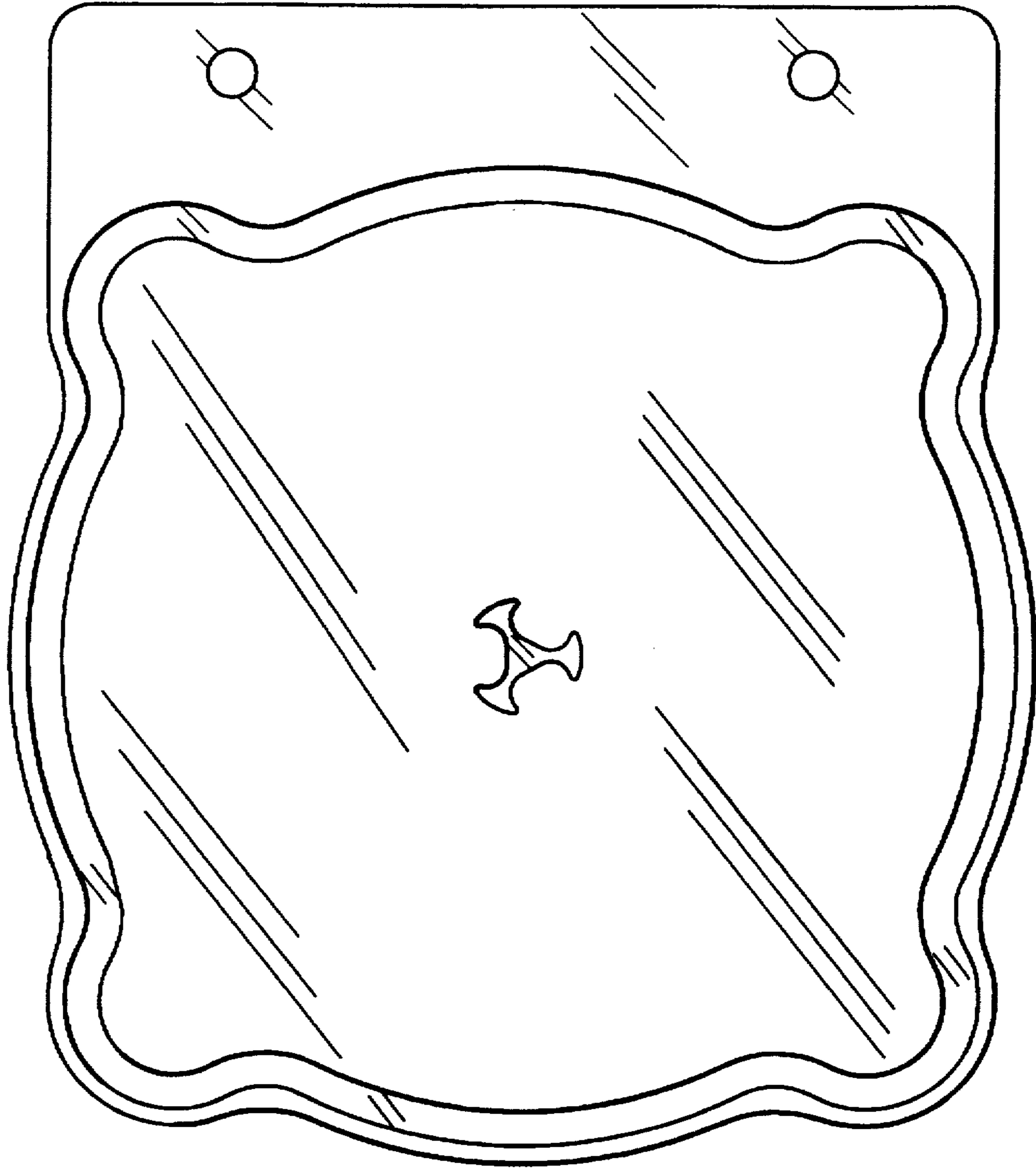
