### [57] CLAIM

The ornamental design for a combined plant guard and waterer, as shown and described.

FIG. 1 is an environmental perspective view of a combined plant gaurd and waterer showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a cross-sectional view taken along line 3-3 of FIG. 2;  
 FIG. 4 is a top plan view showing the elements detached;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a side elevation view thereof with the opposite and adjacent sides being identical in appearance;  
 FIG. 7 is a top plan view of a second embodiment of the design shown in FIG. 1;  
 FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 7;  
 FIG. 9 is a top plan view of a third embodiment of the design shown in FIG. 1;  
 FIG. 10 is a side elevation view of the third embodiment of FIG. 9 with the opposite and adjacent sides being identical in appearance;  
 FIG. 11 is a side elevation view of the second embodiment of FIG. 7 with the opposite and adjacent sides being identical in appearance; and,  
 FIG. 12 is a cross-sectional view taken along line 10—10 of the third embodiment of FIG. 9.  
 The undisclosed bottom plan views of the second and third embodiments are identical to the bottom plan view of FIG. 5.

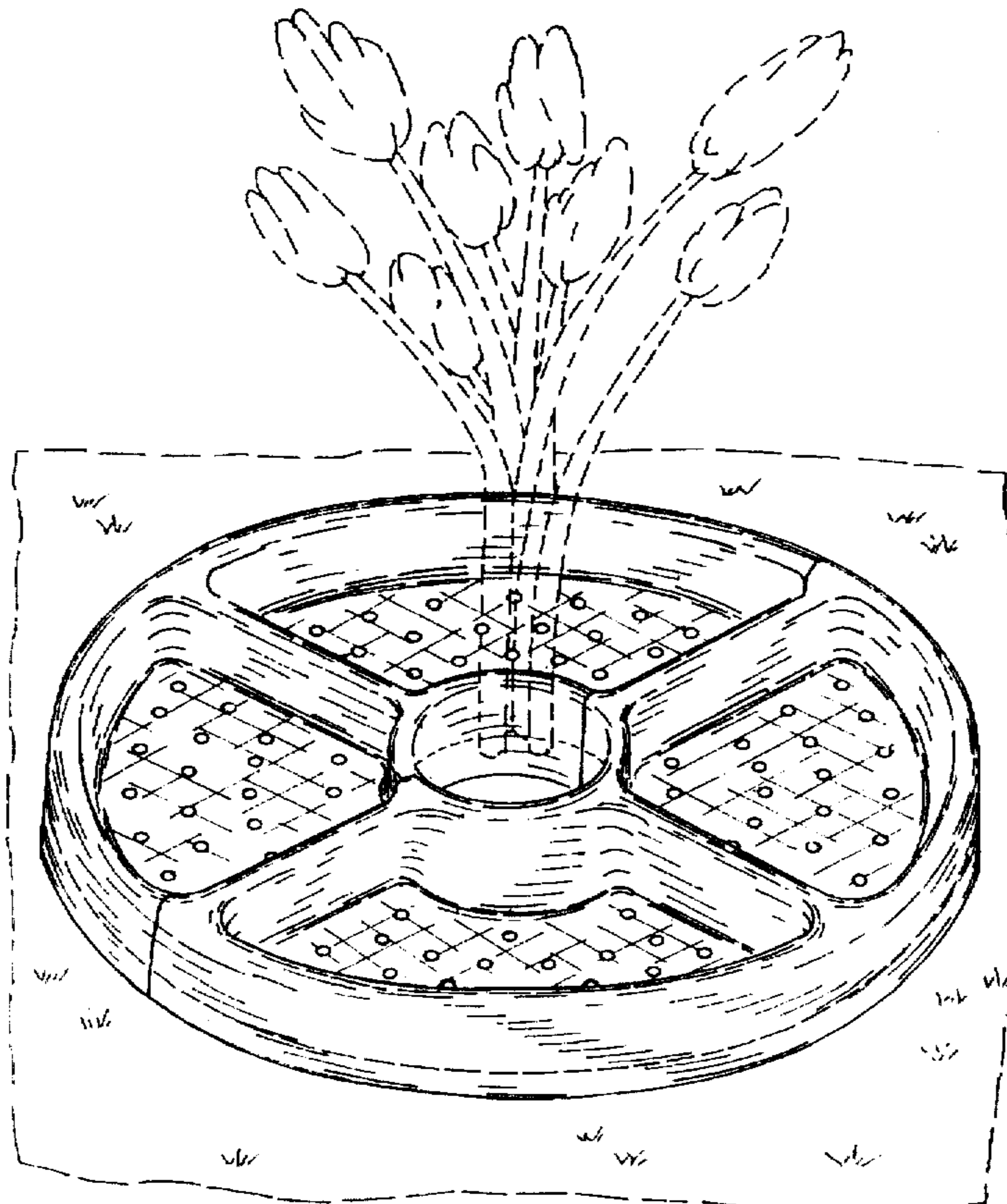

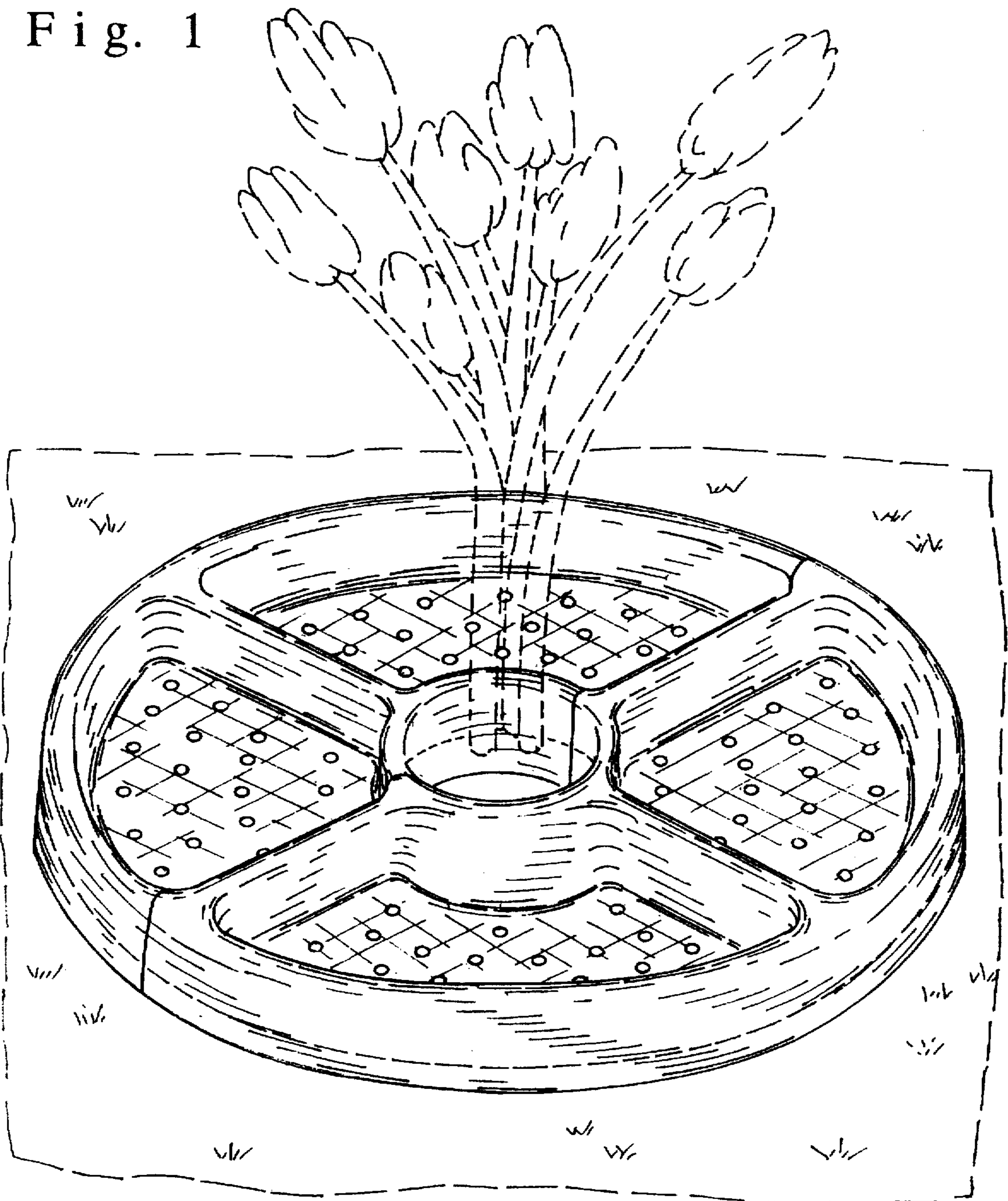

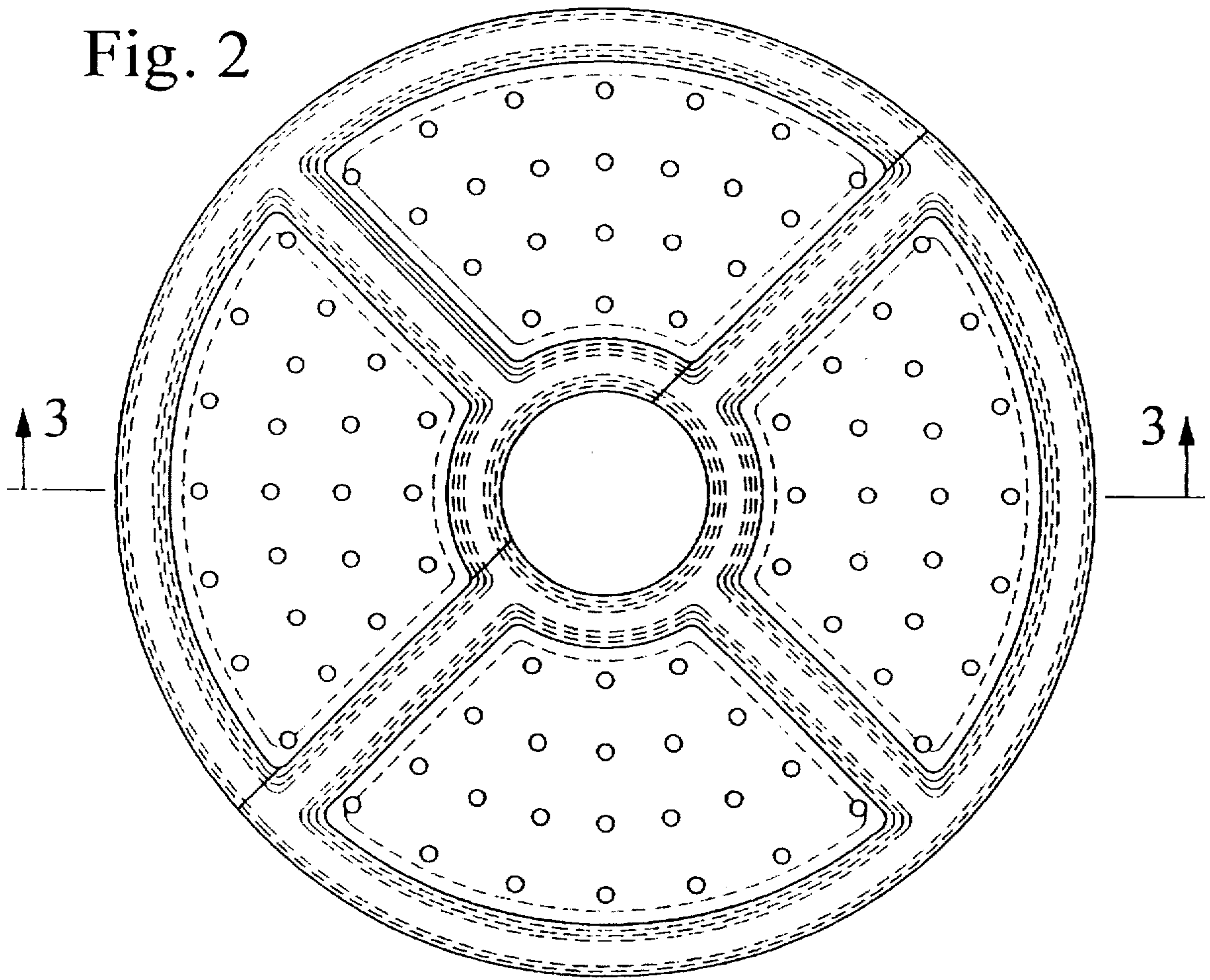

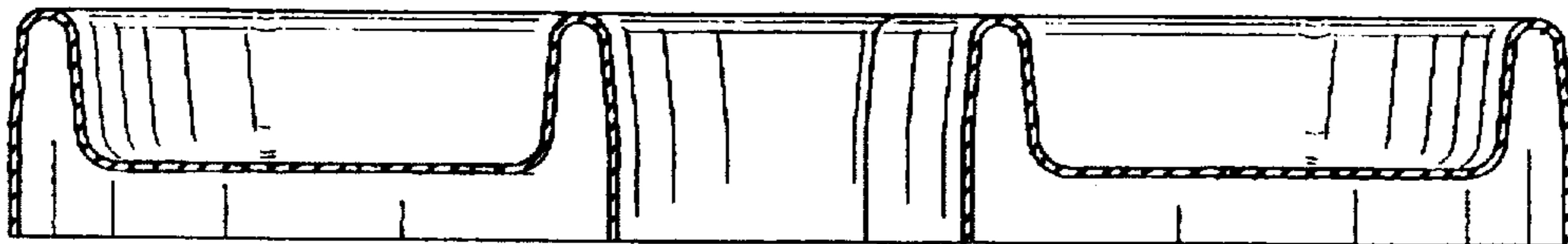

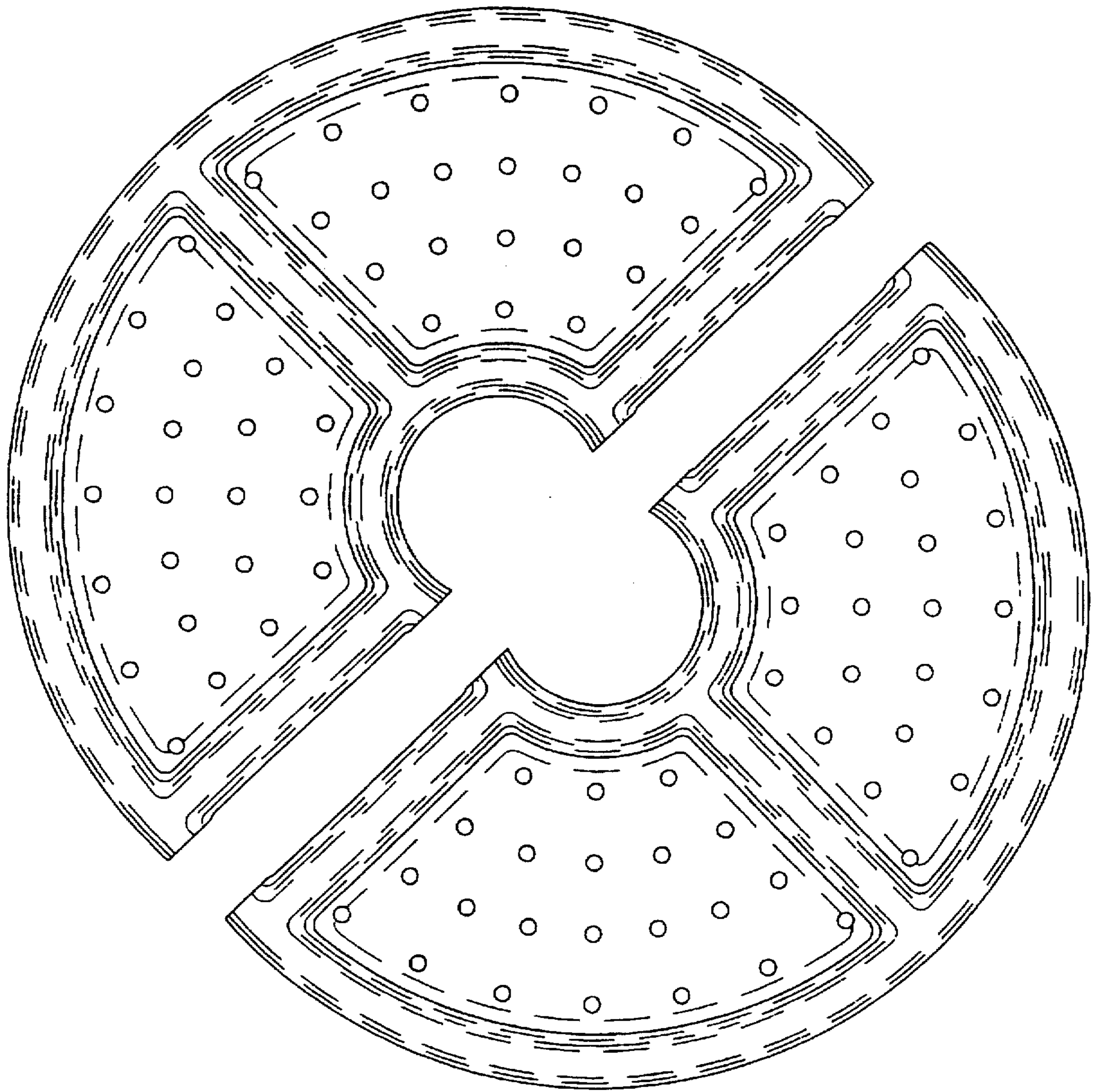

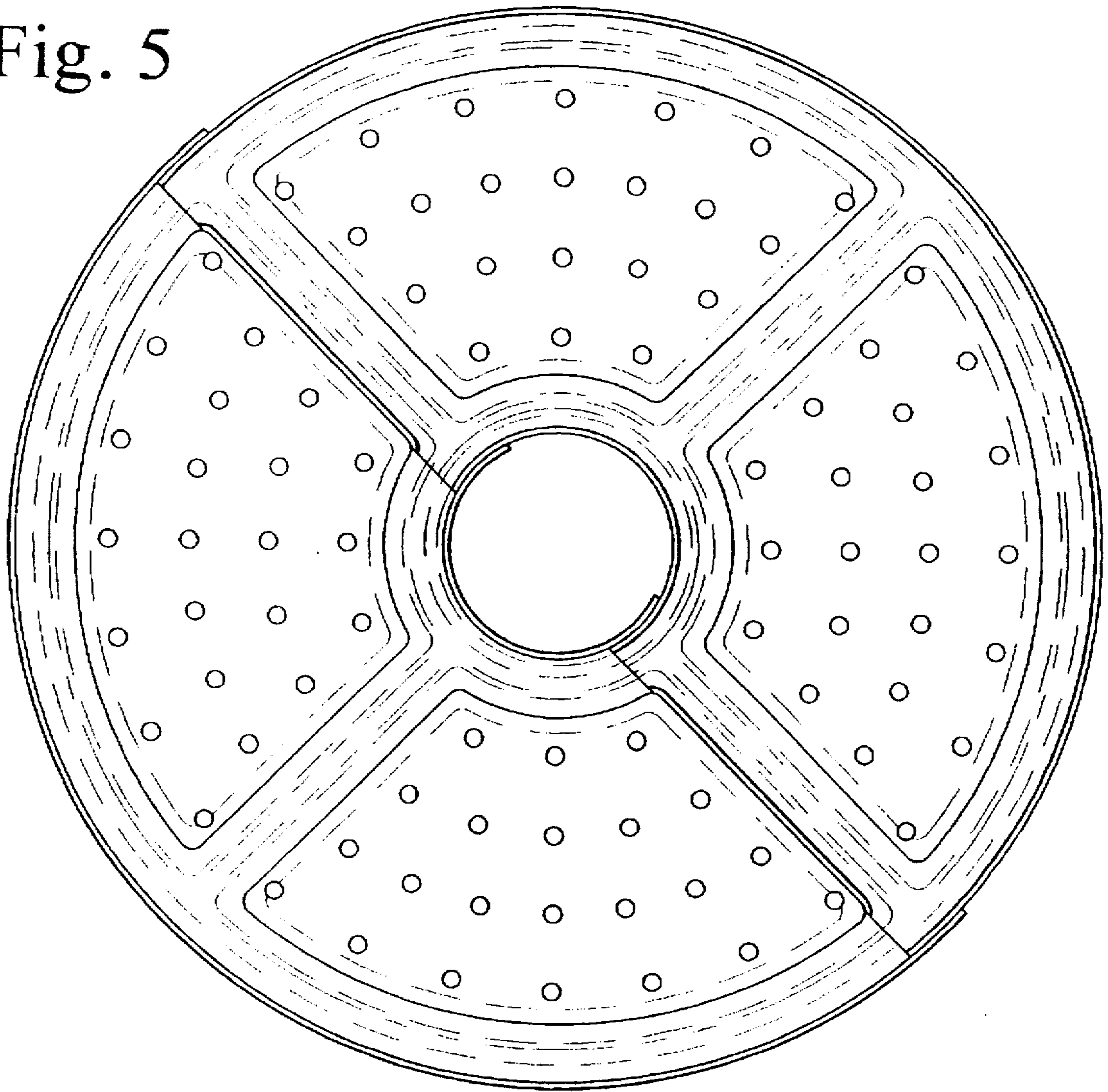

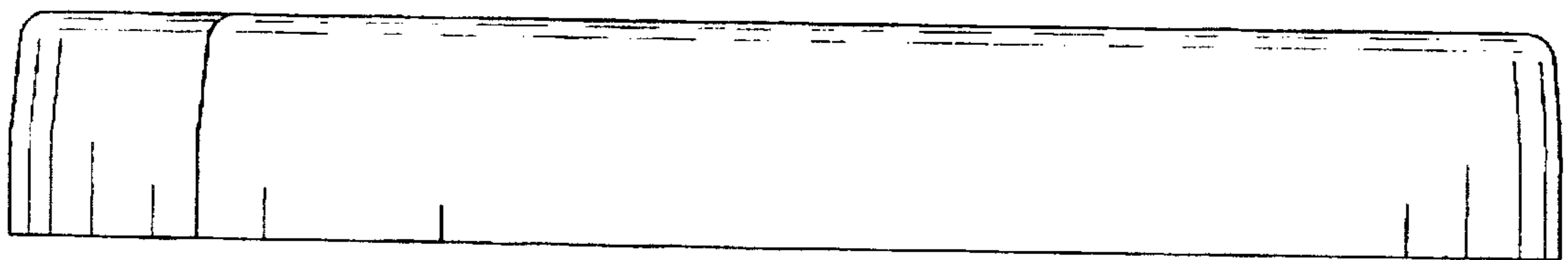

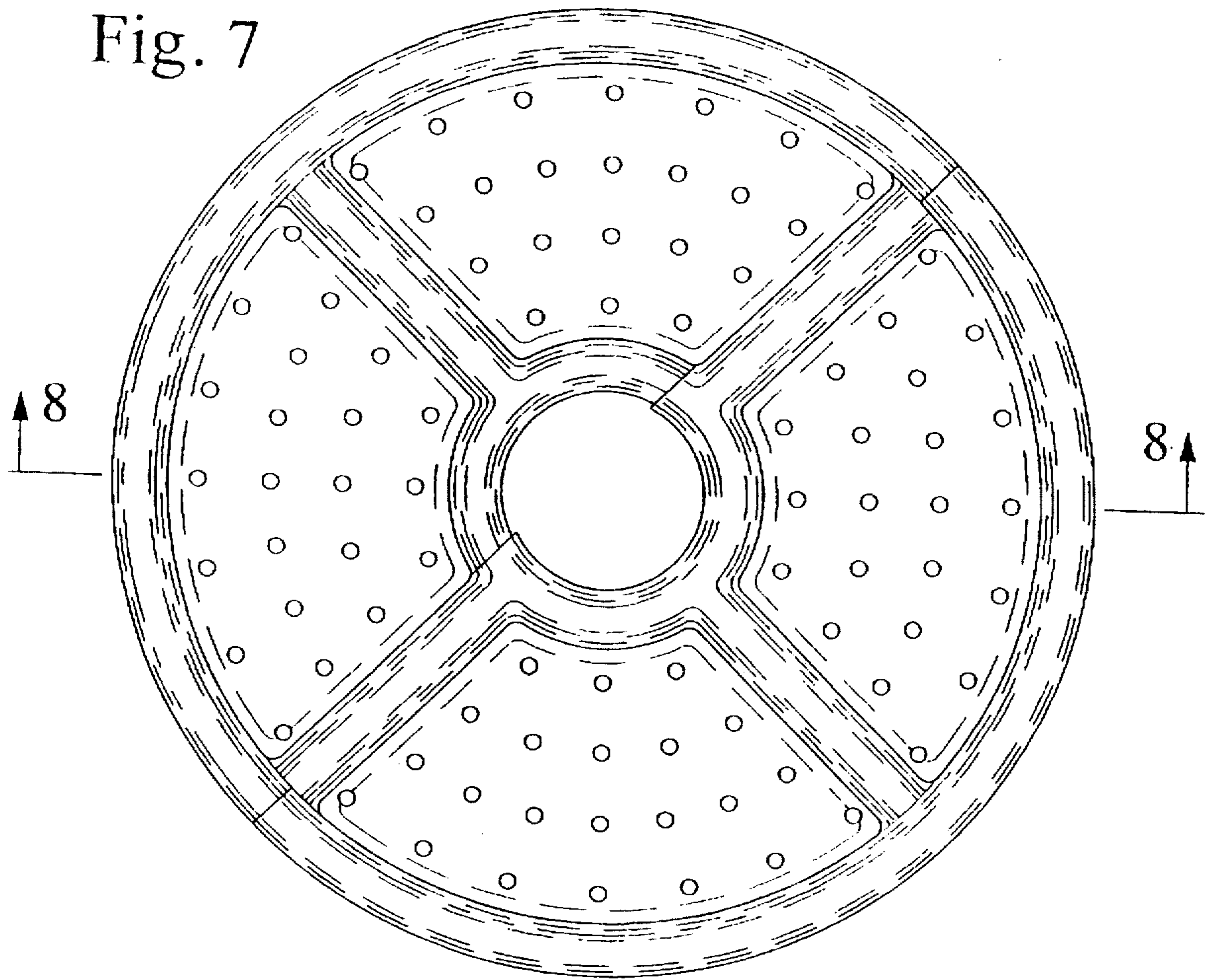

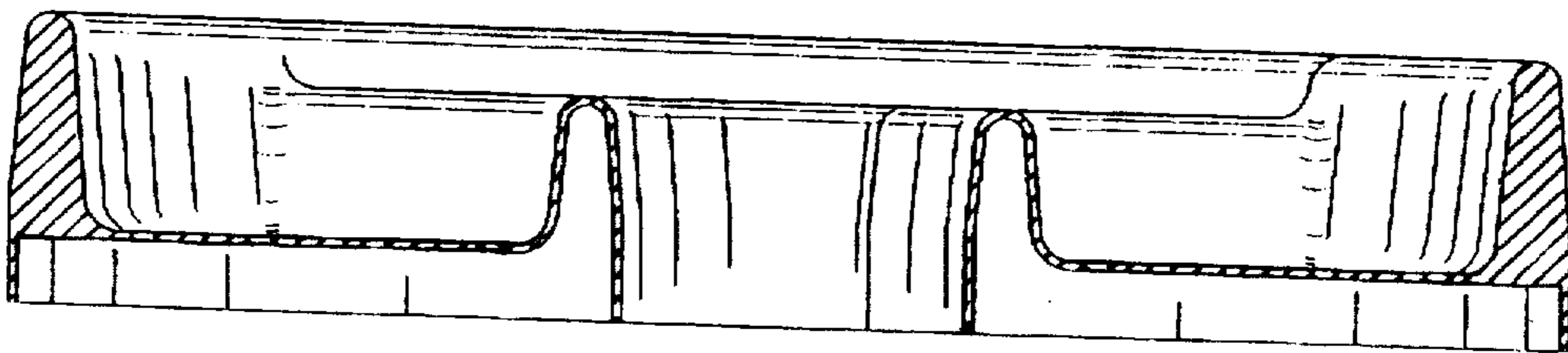

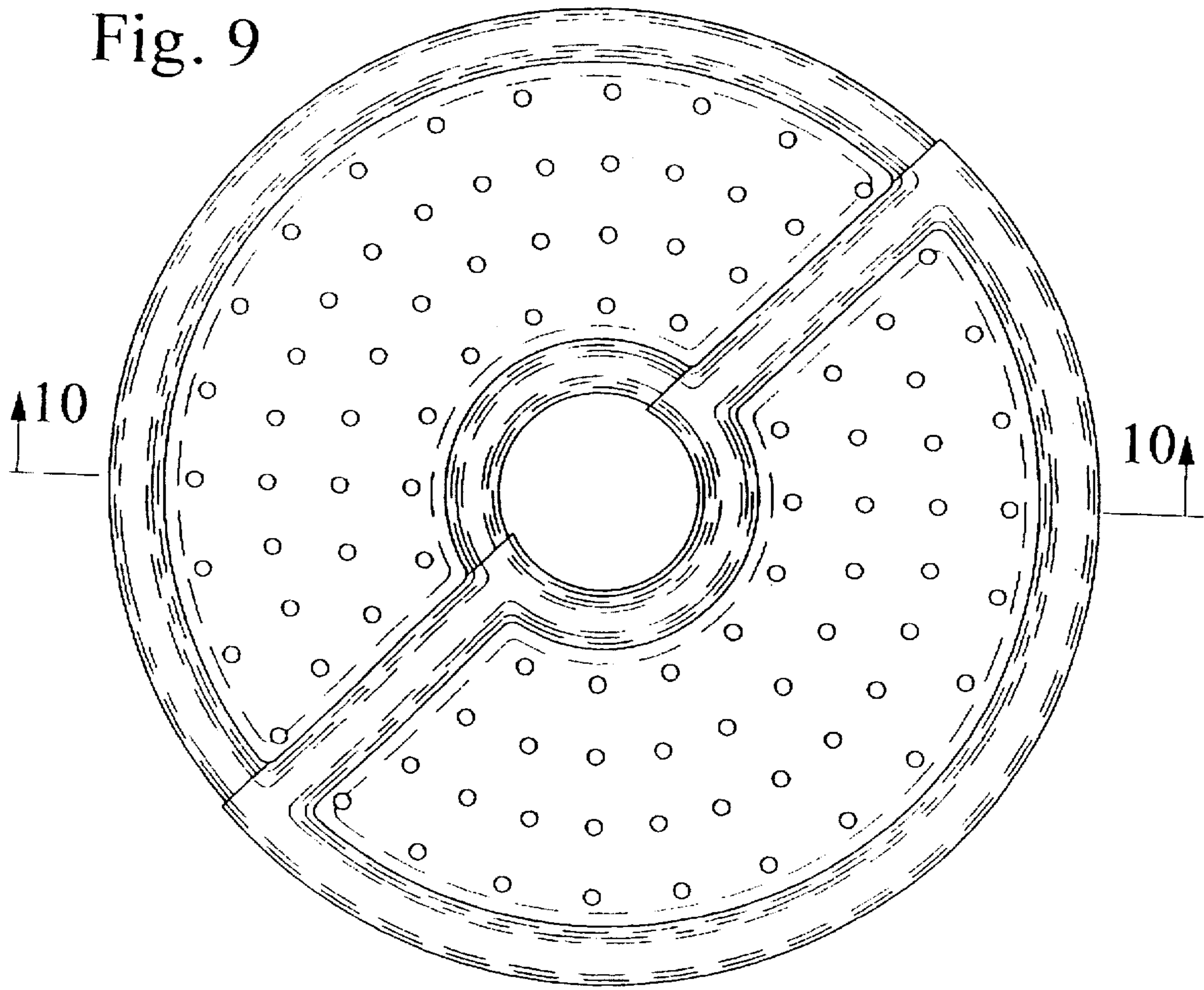

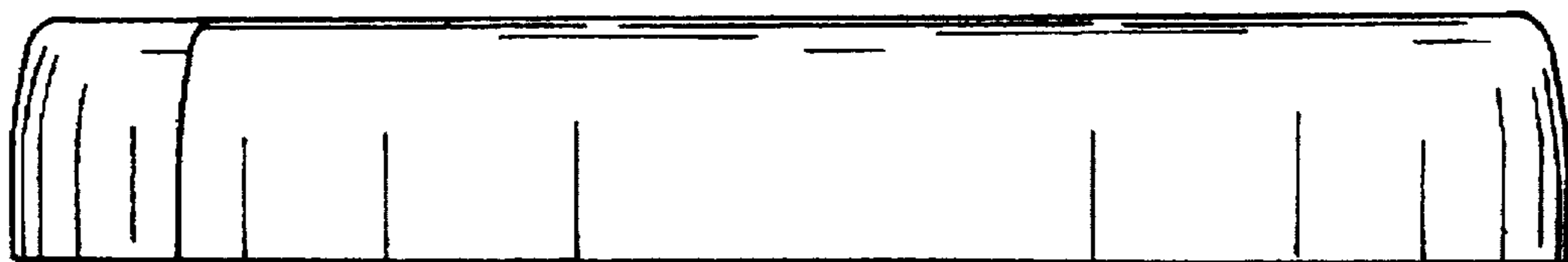

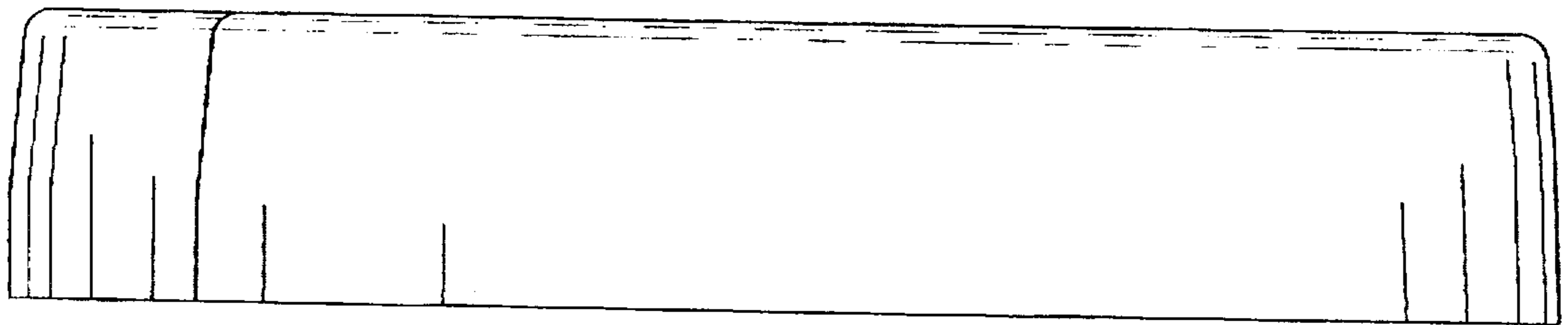
