The ornamental design for a closure, as shown and described.

### DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a first embodiment of the invention.

FIG. 2 is a top view of the first embodiment of invention.

FIG. 3 is a side view of the first embodiment of the invention, it being understood that all side elevations thereof are substantially identical thereto.

FIG. 4 is a bottom view of the first embodiment of the invention.

FIG. 5 is a bottom perspective view of the first embodiment of the invention.

FIG. 6 is a top, front, left side perspective view of a second embodiment of the invention.

FIG. 7 is a top view of the second embodiment of invention;

FIG. 8 is a side view of the second embodiment of the invention, it being understood that all side elevations thereof are substantially identical thereto;

FIG. 9 is a bottom view of the second embodiment of the invention; and,

FIG. 10 is a side view of a third embodiment of the invention, it being understood that the top, side and bottom views thereof are substantially identical to the first embodiment except for the shape of the top of the closure.

The broken line showing of a container is for illustrative purposes only and forms no part of the claimed design.

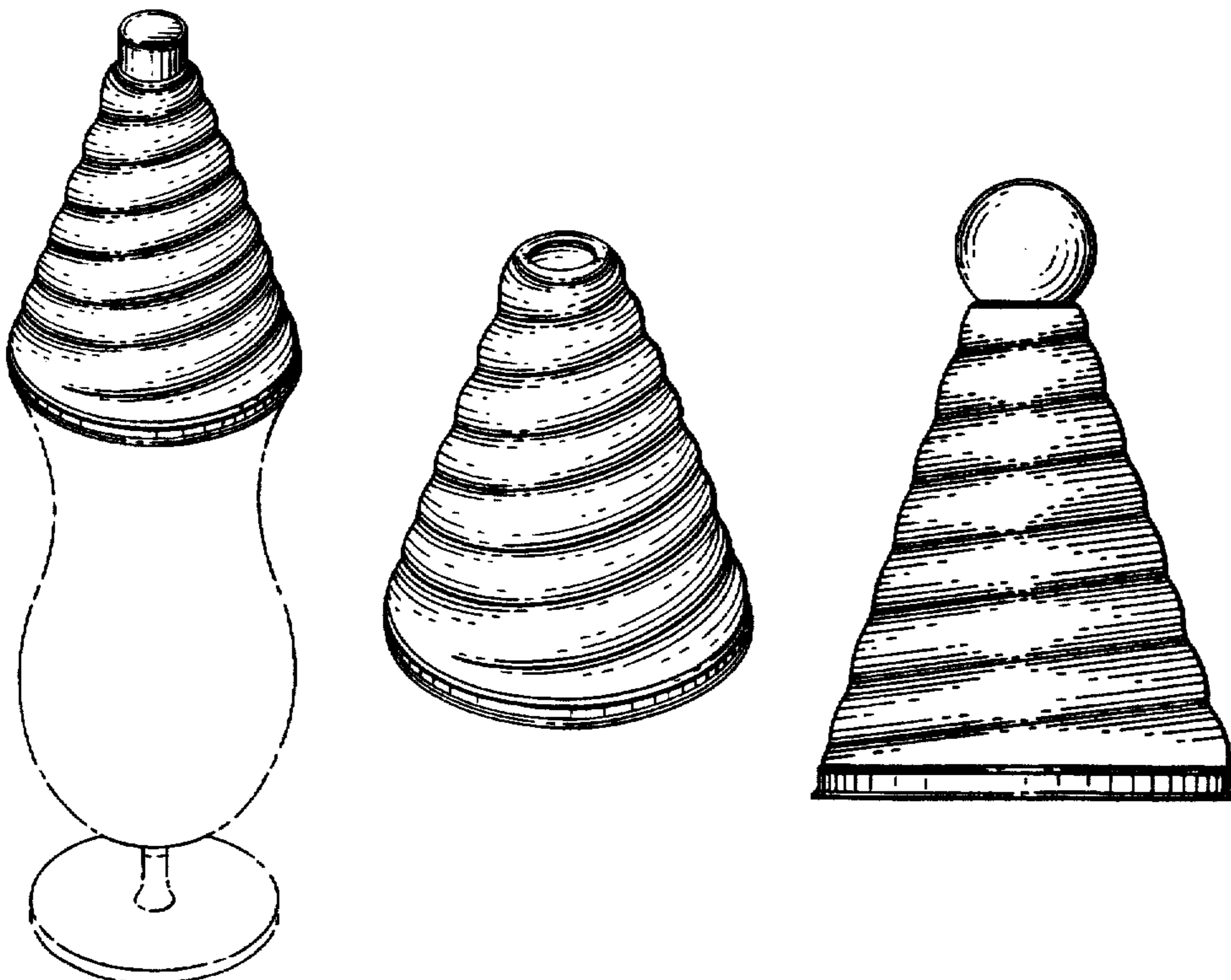

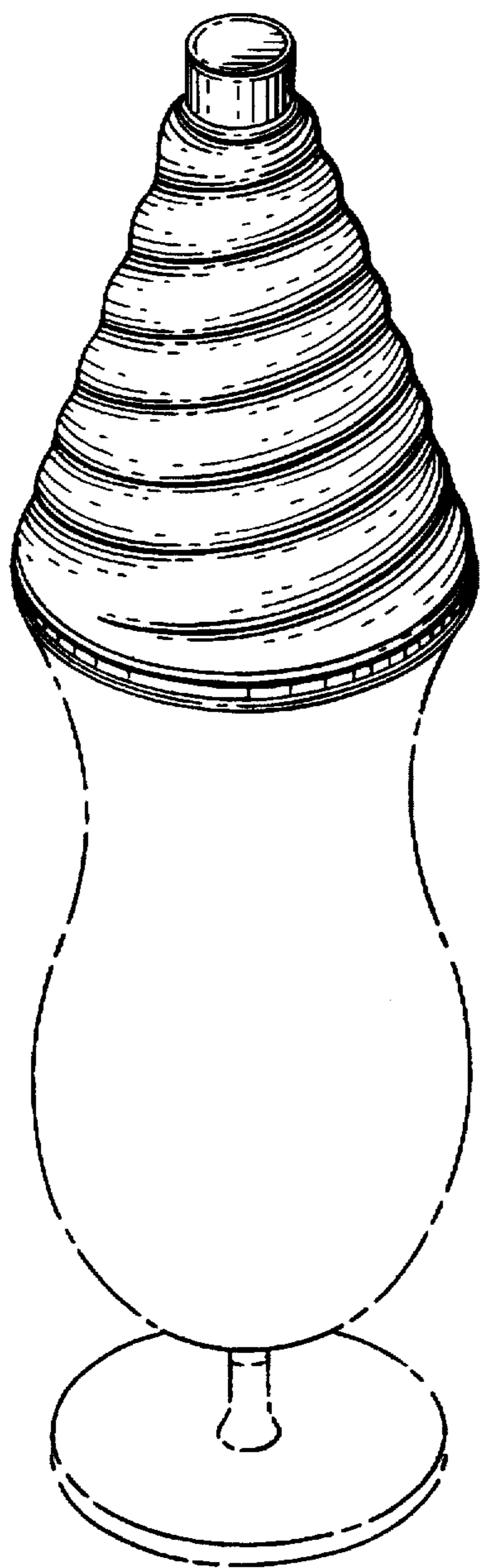
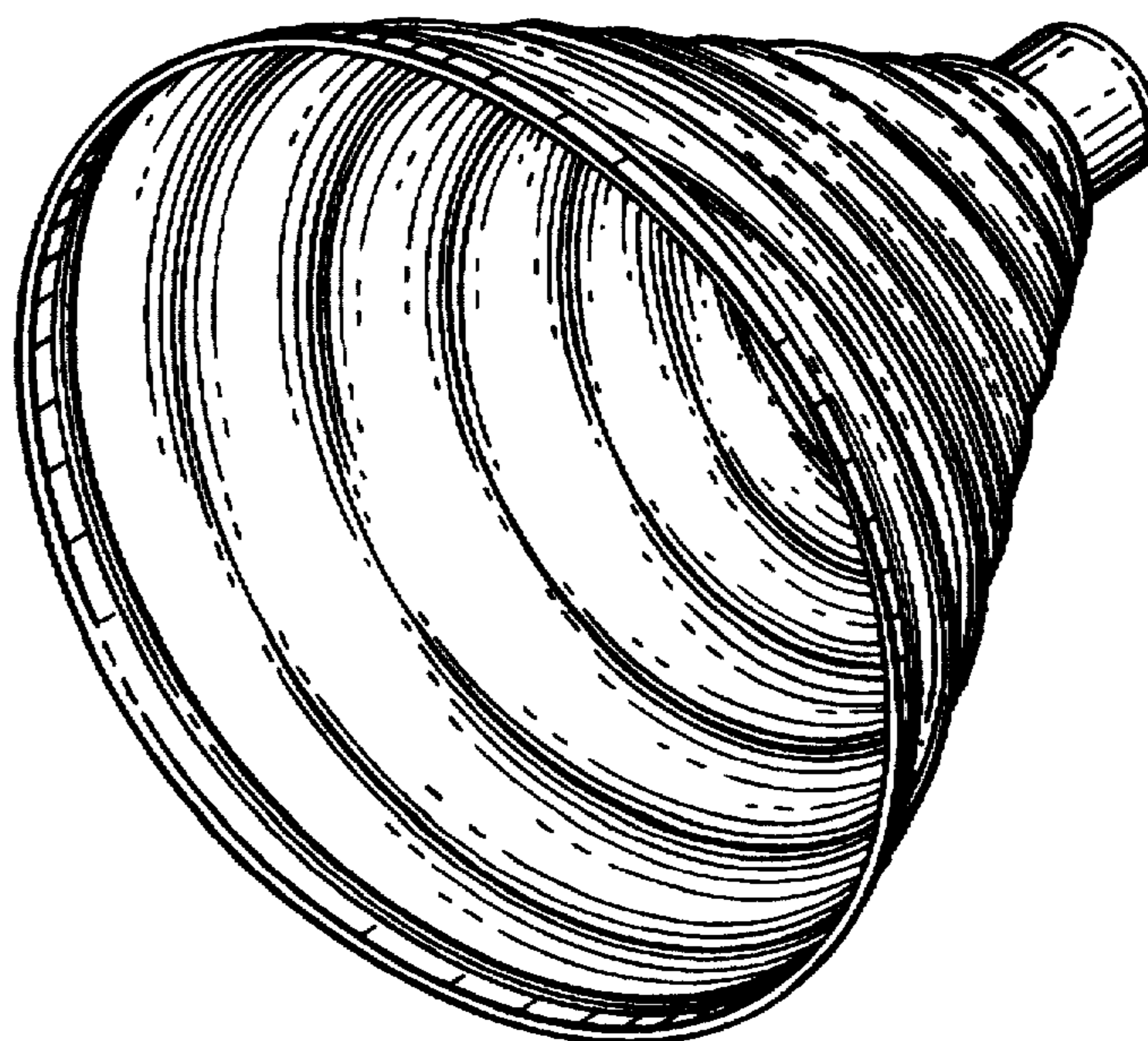

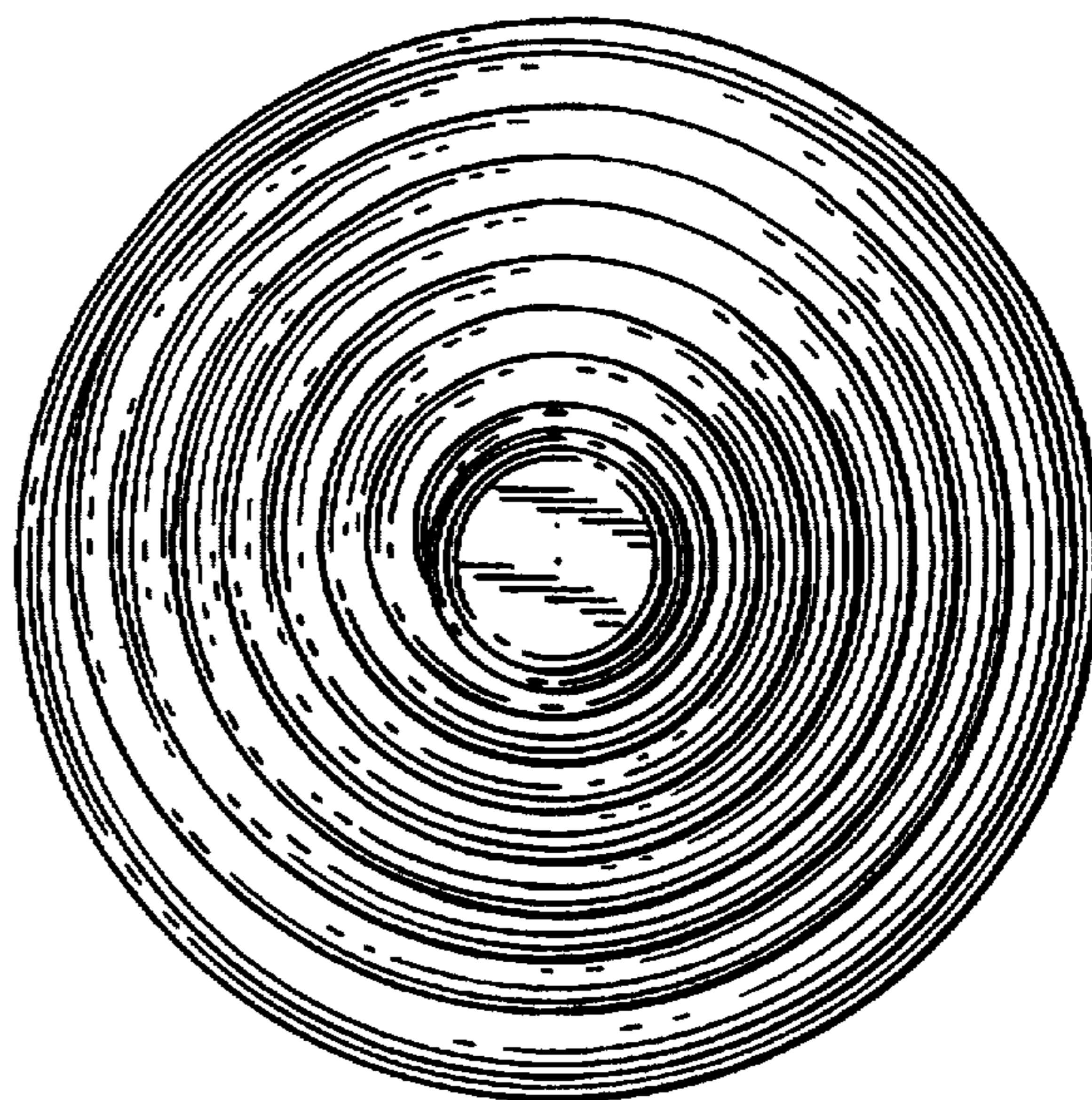

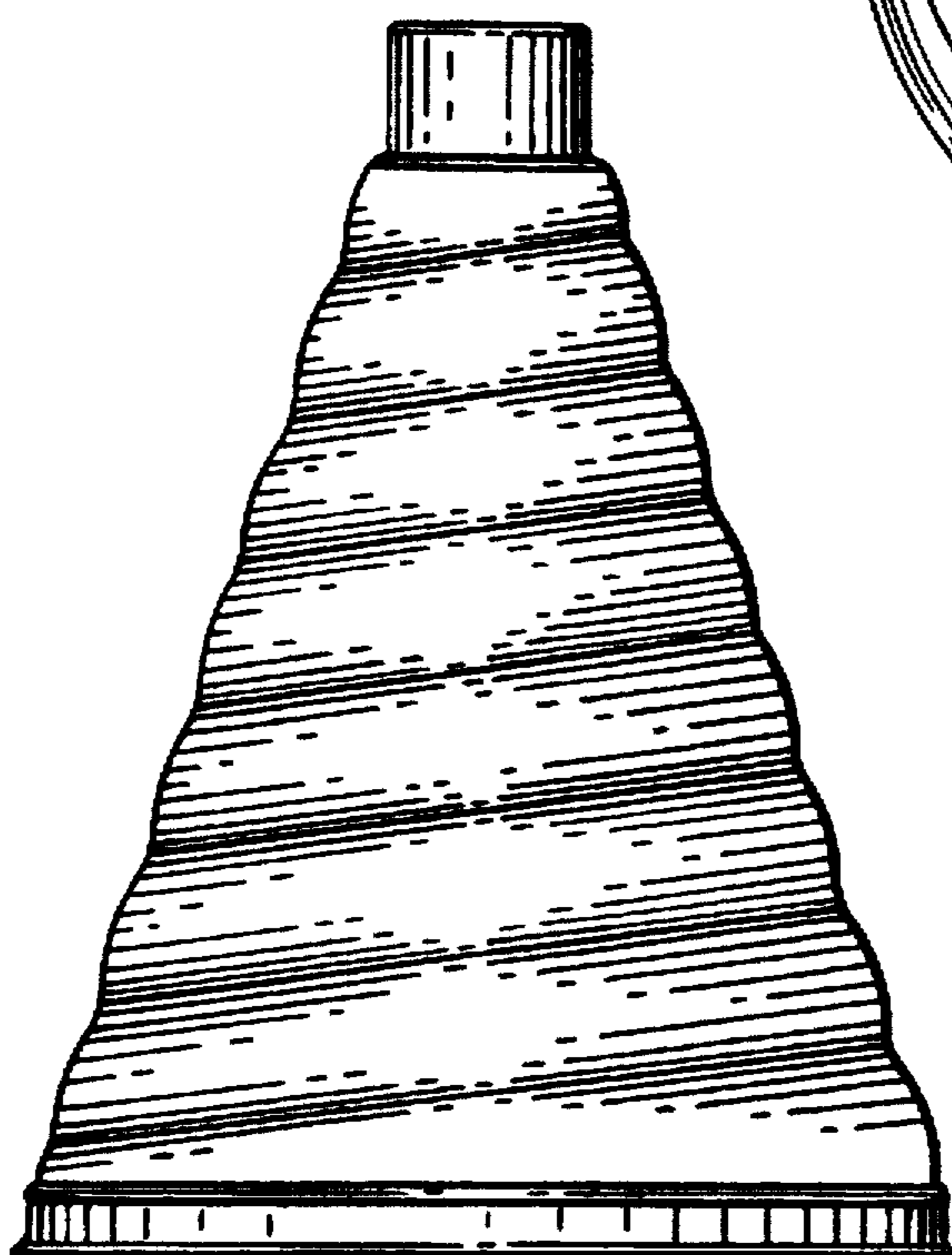

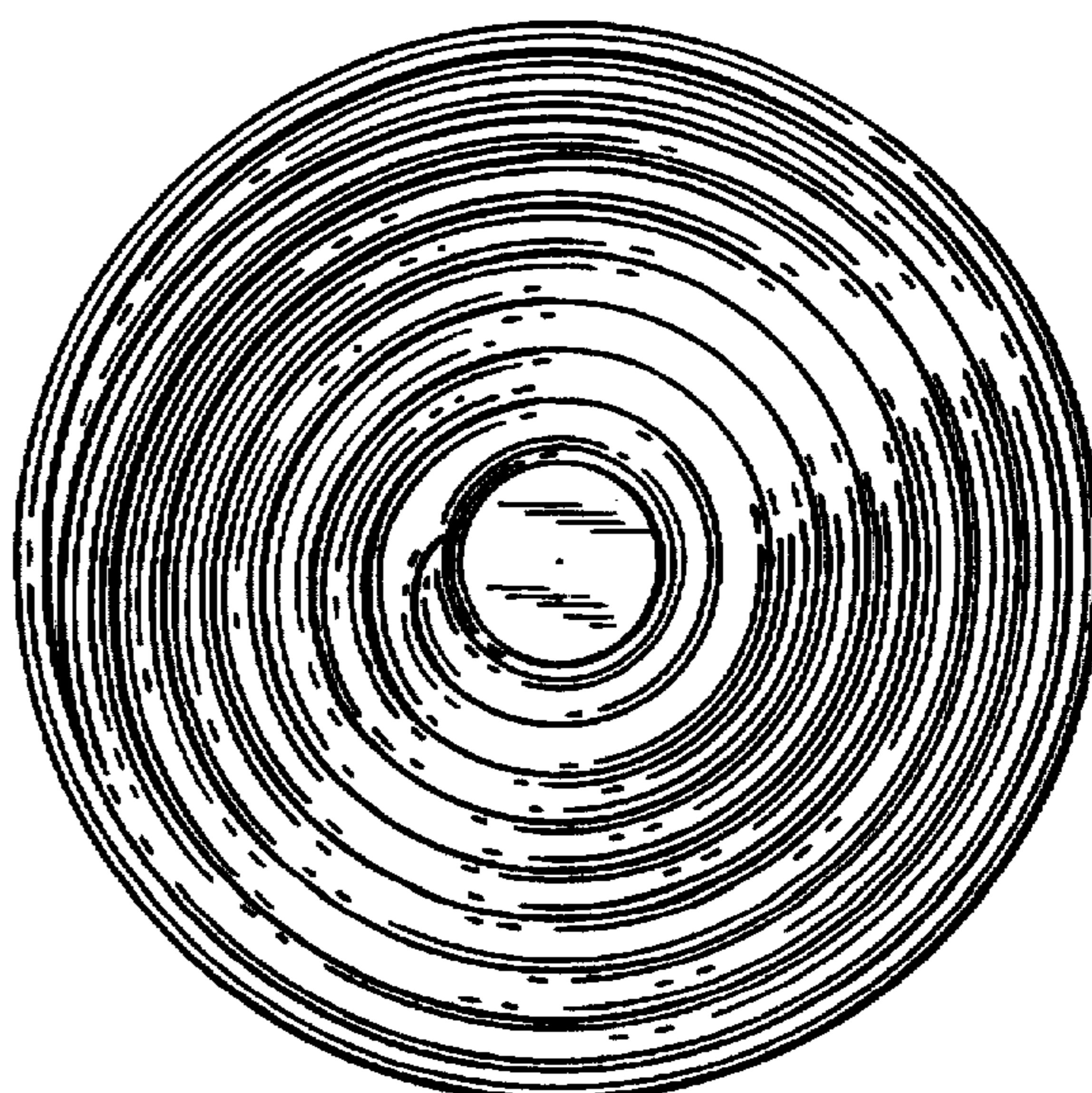

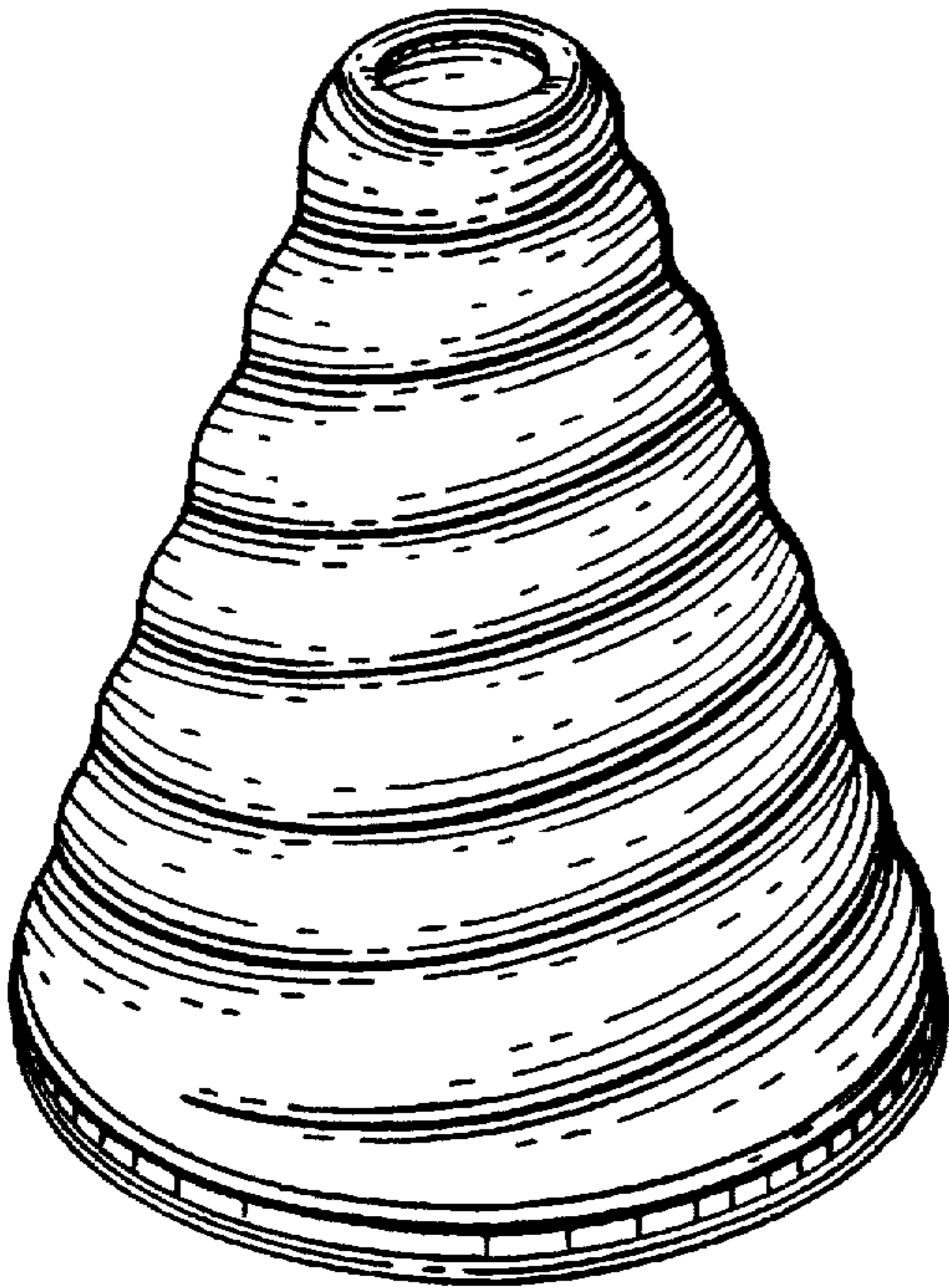

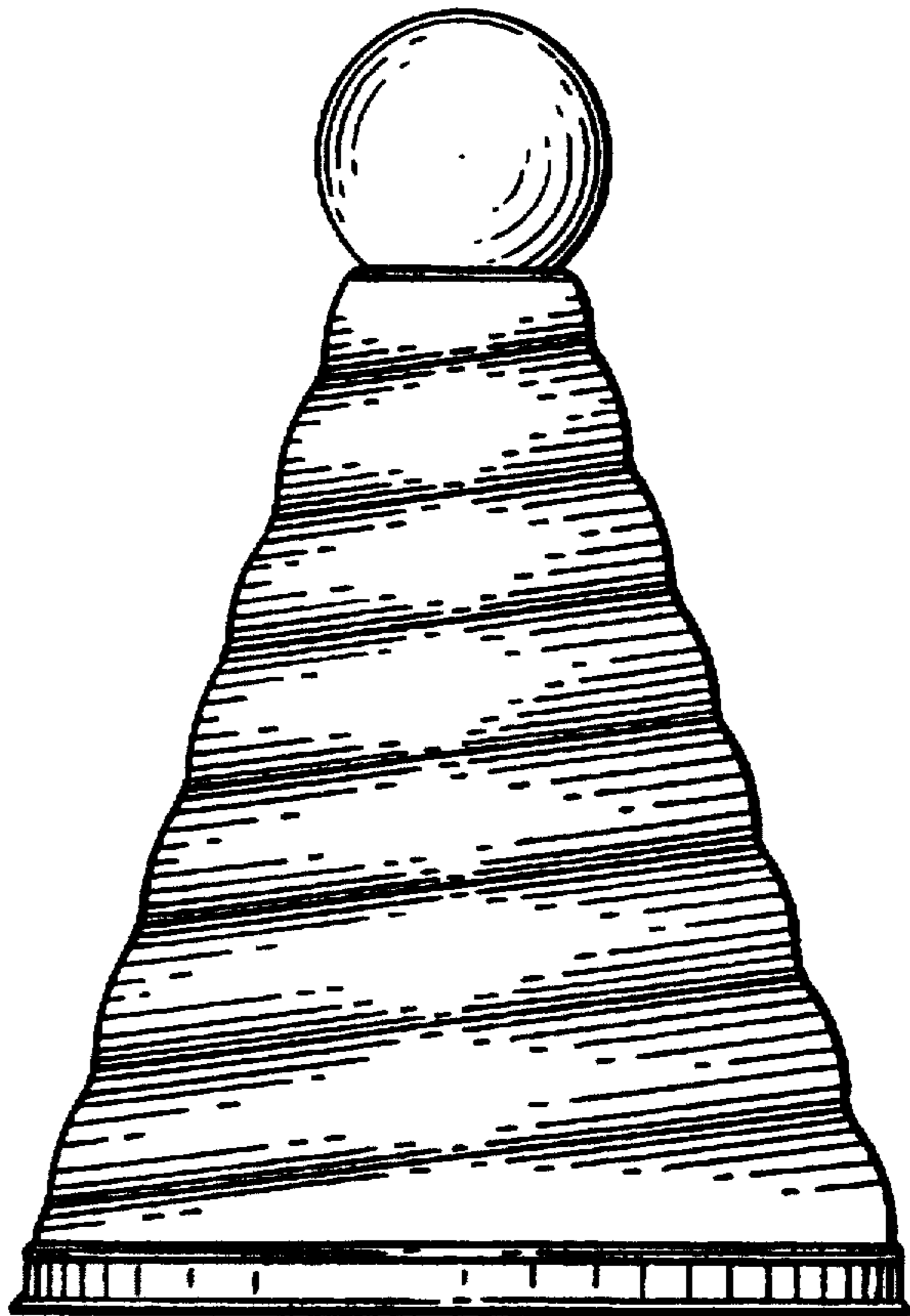

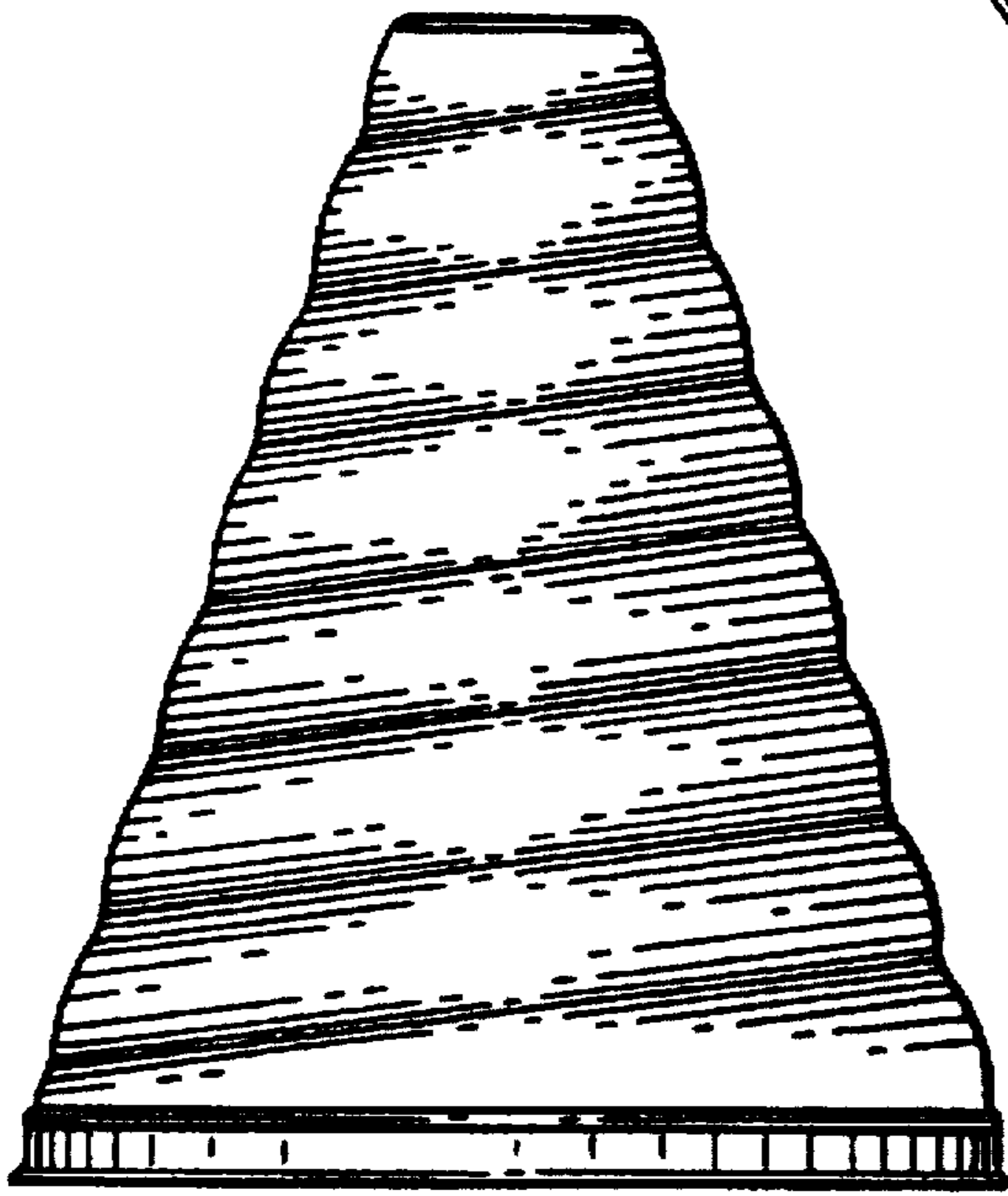
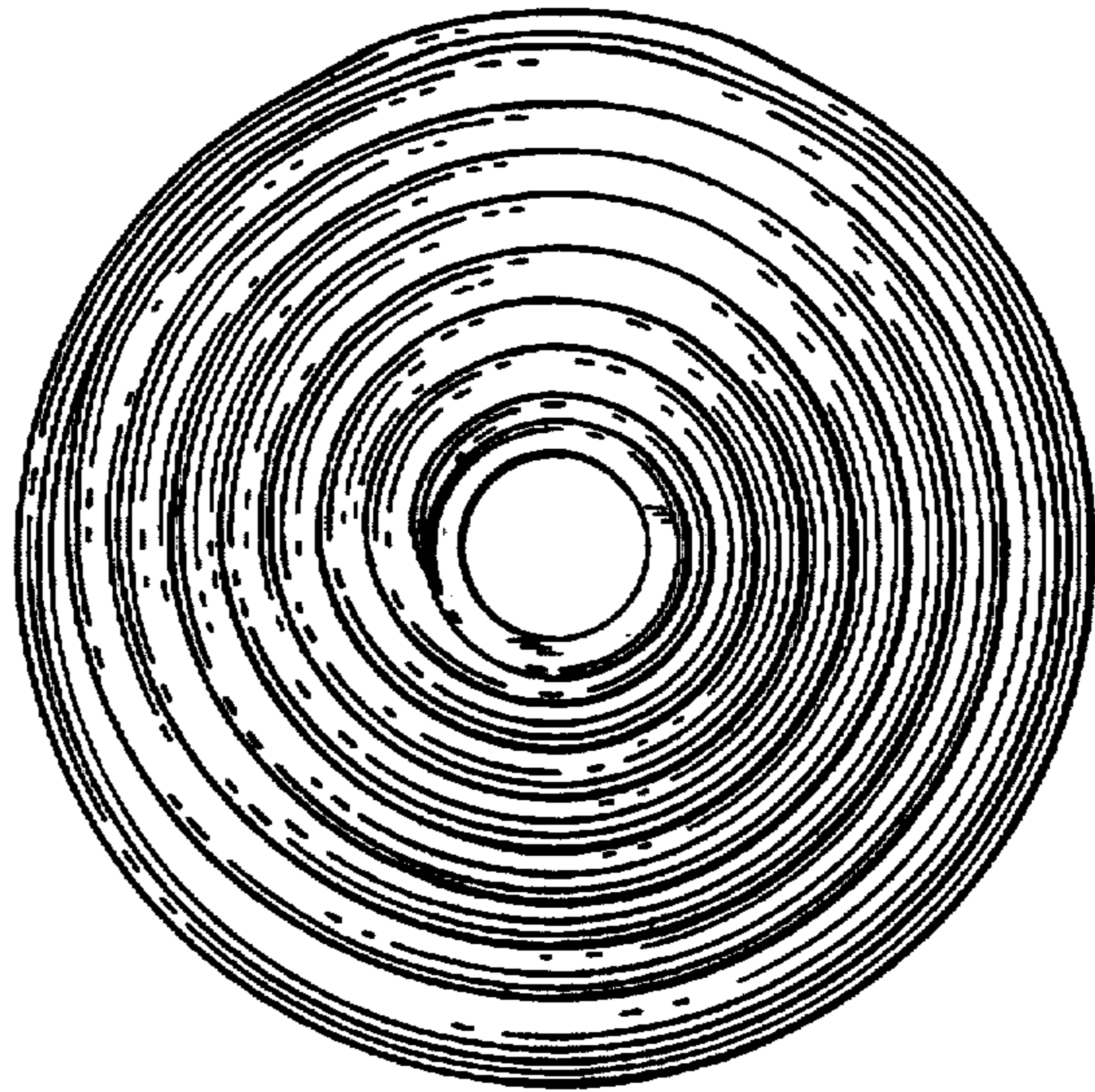

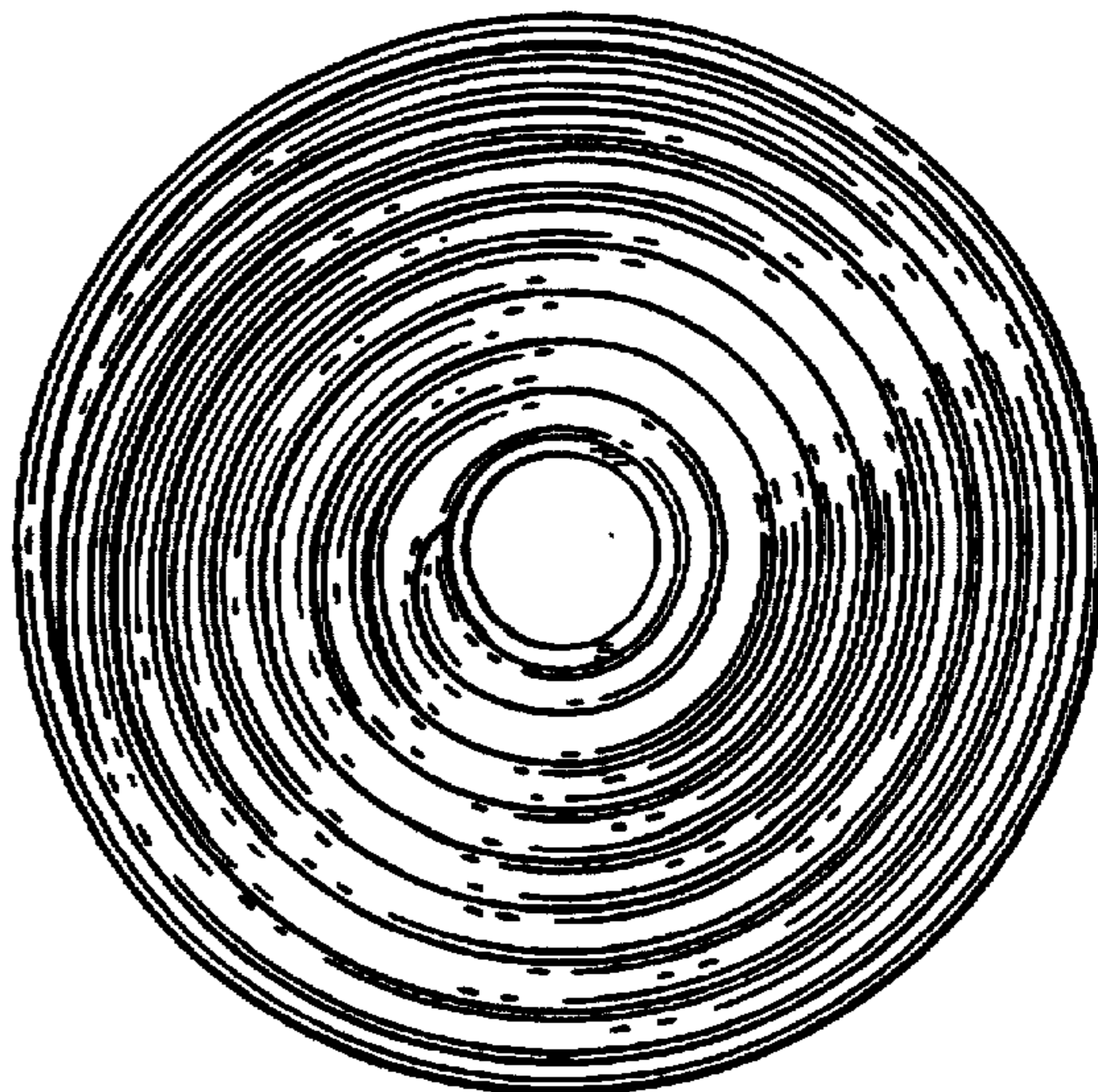
