DESCRIPTION

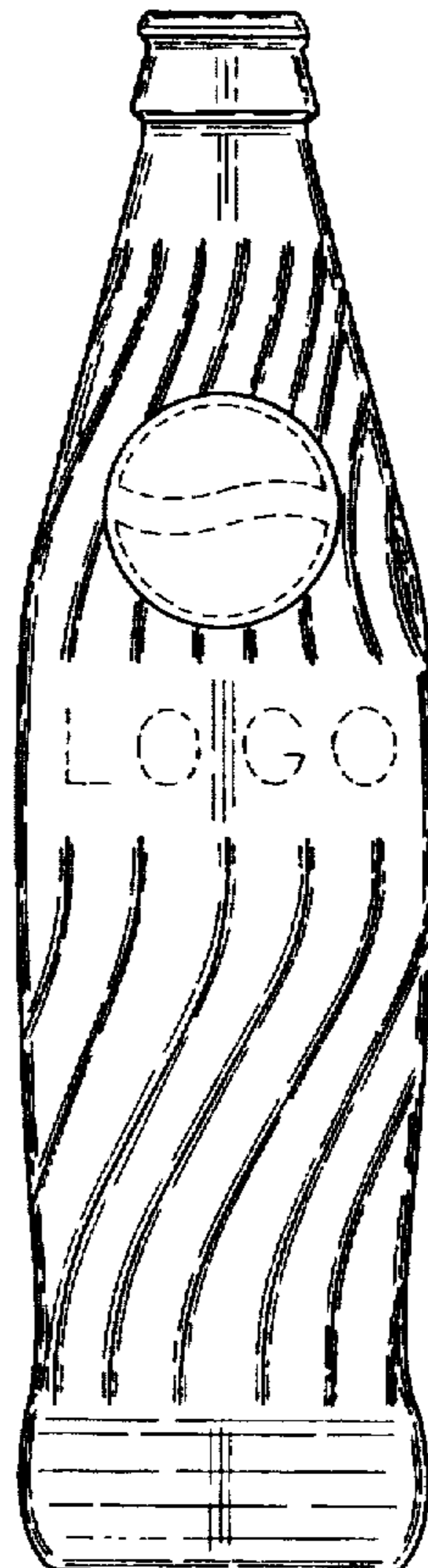
FIG. 1 is a front elevation of a beverage bottle showing our new design, the rear elevation is the same;

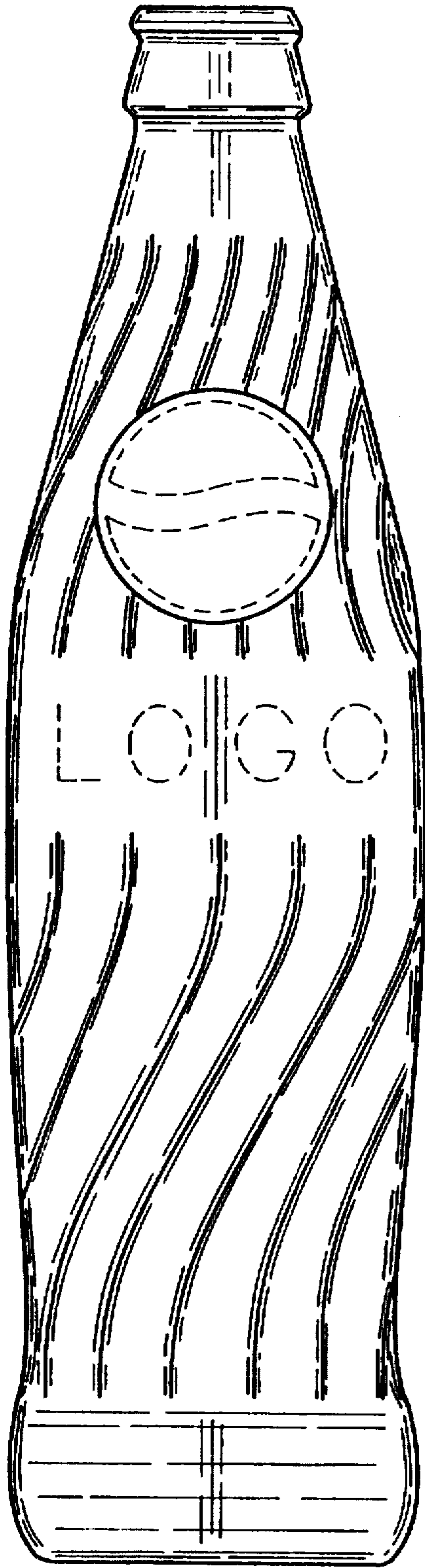

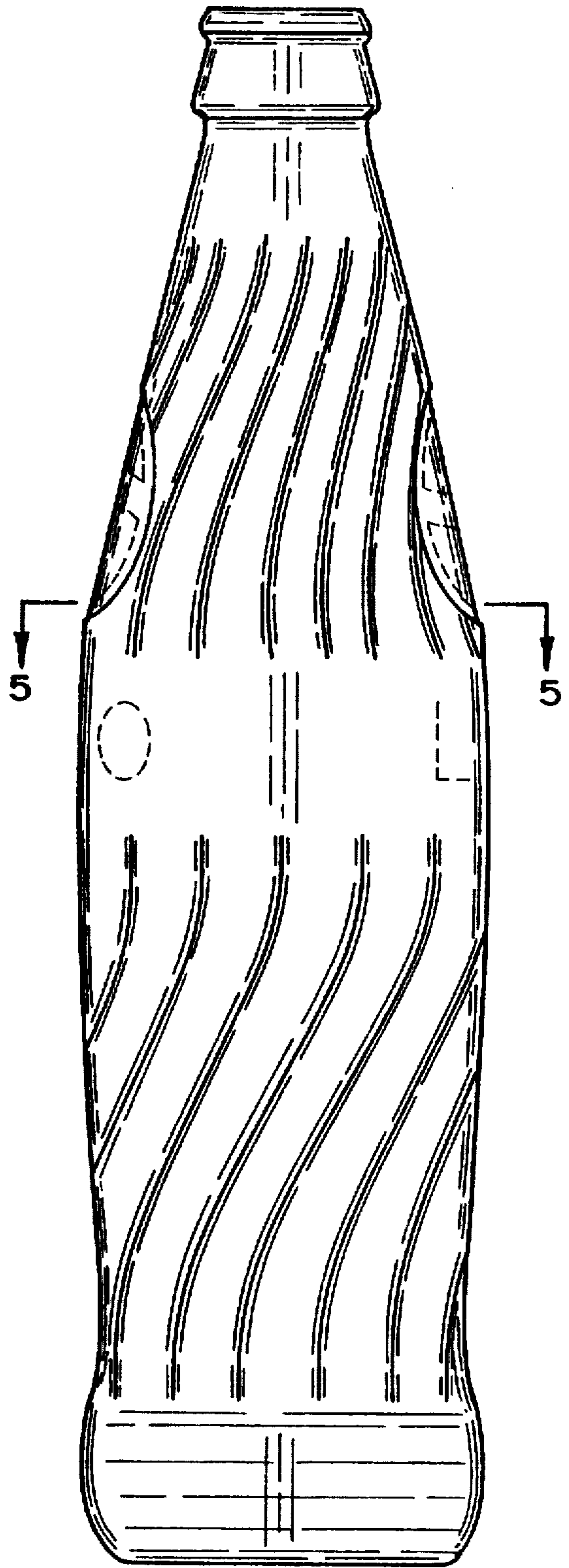

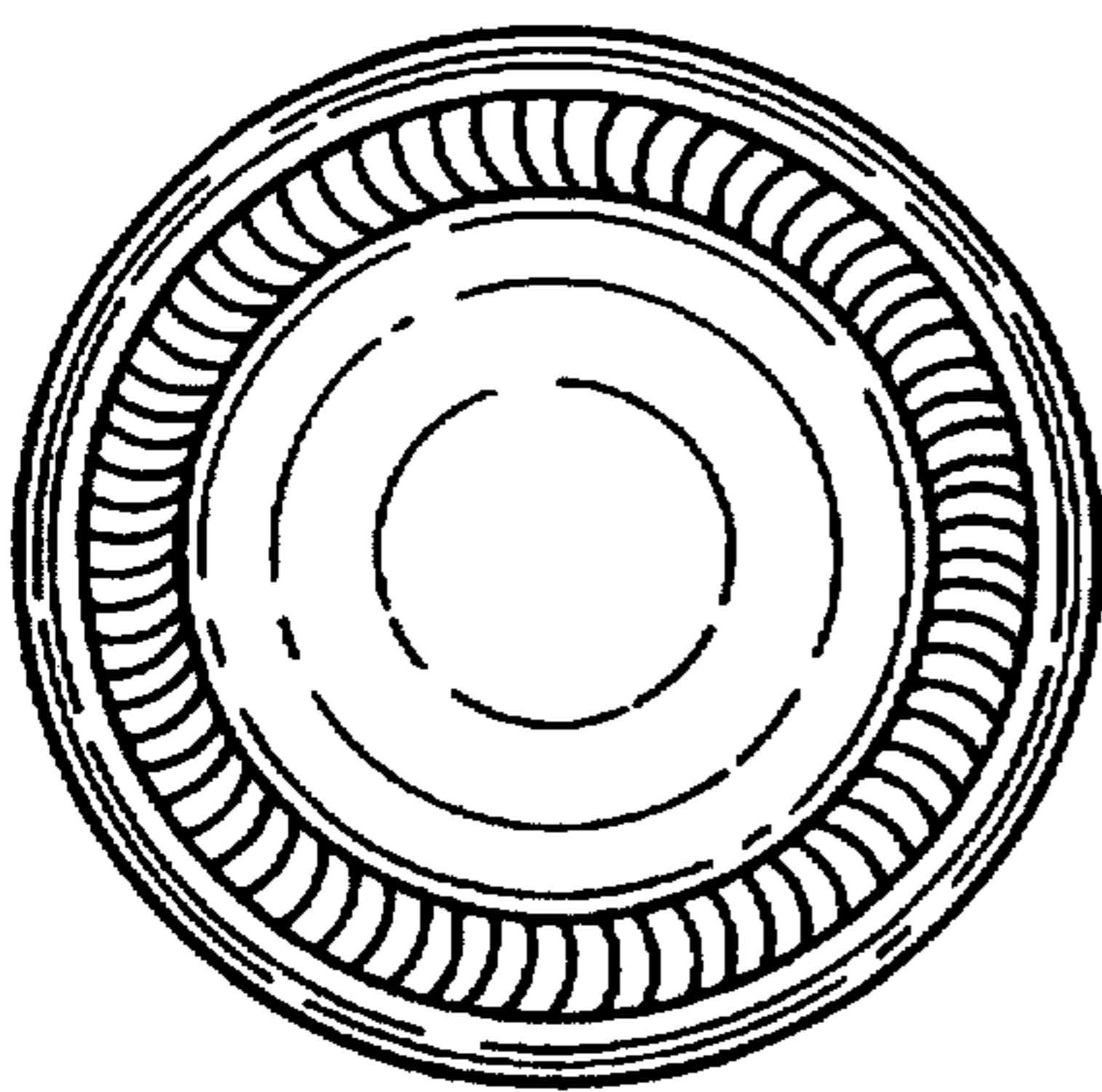

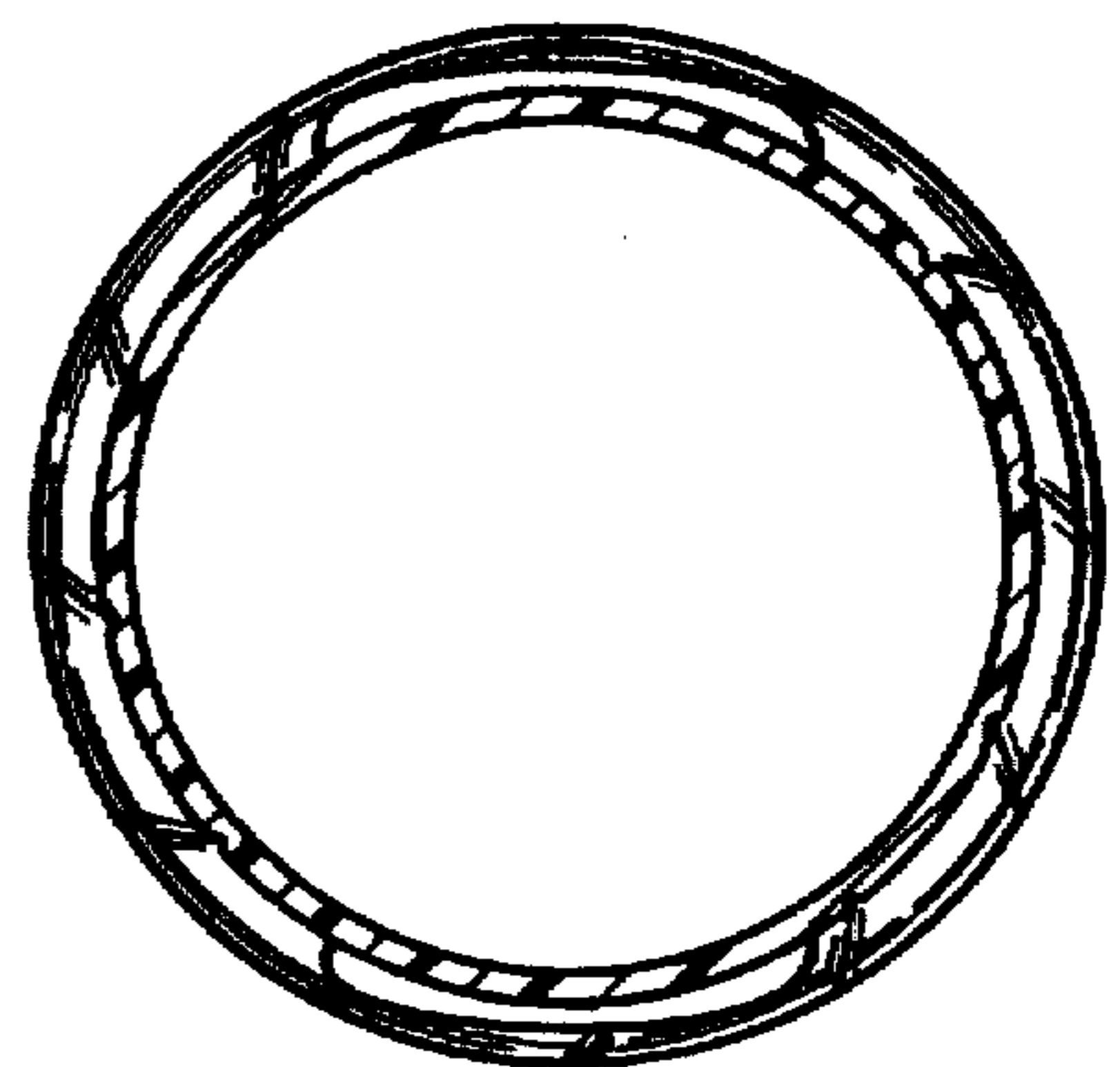
