FIG. 3 is a rear view of the bottle of FIG. 1;

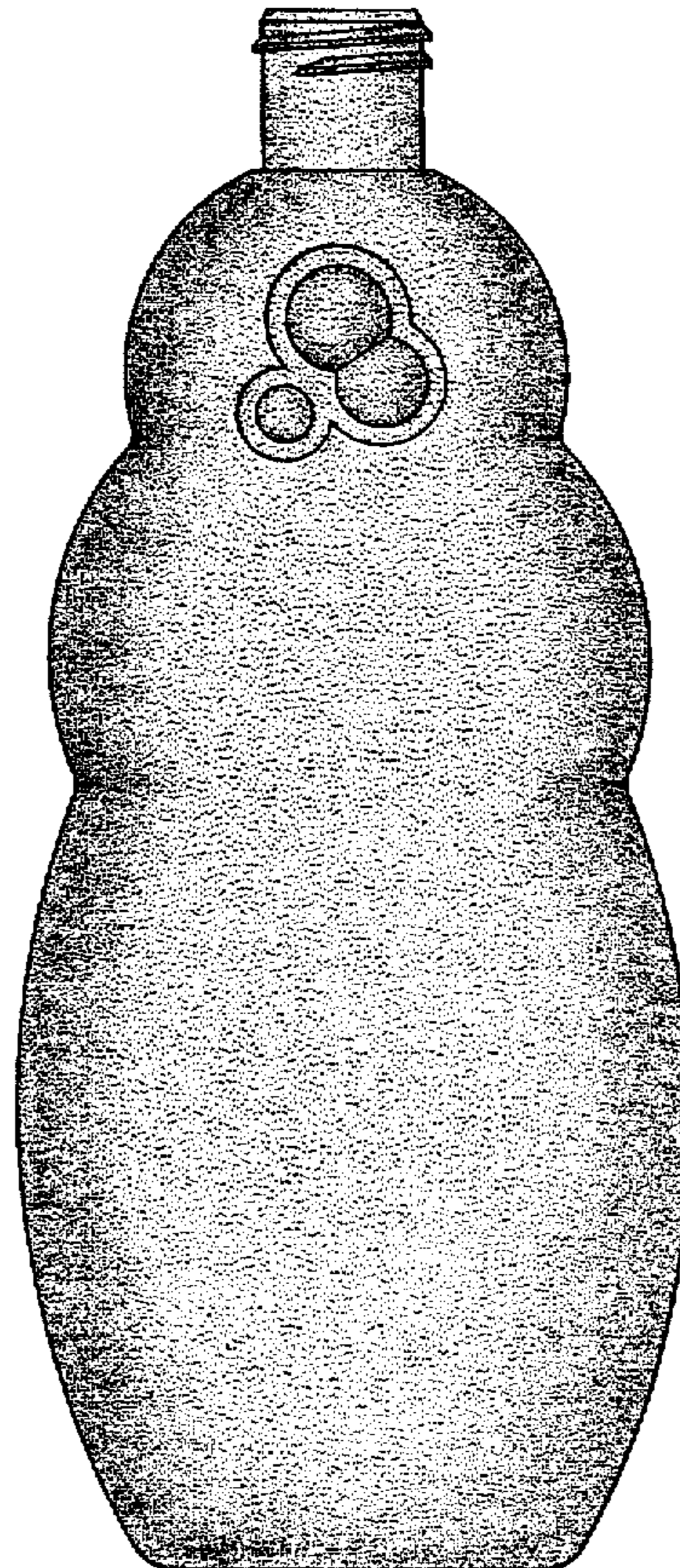
FIG. 4 is a first, right side view of the bottle of FIG. 1;

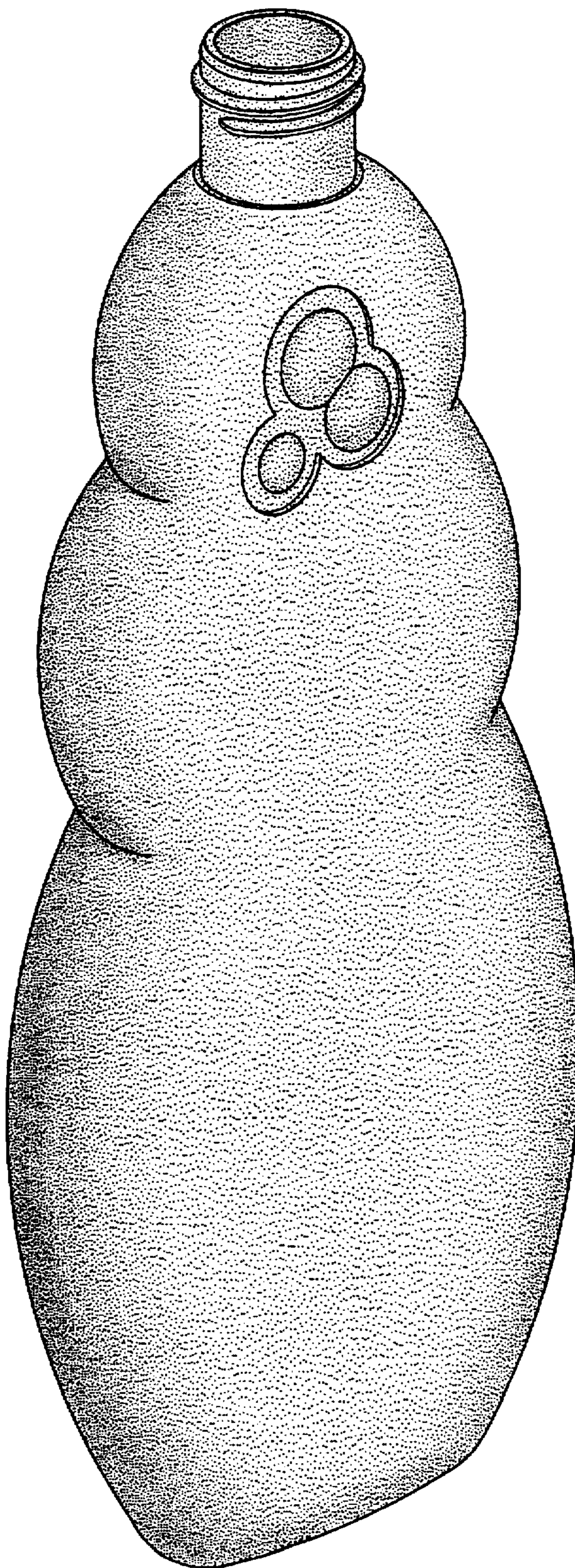

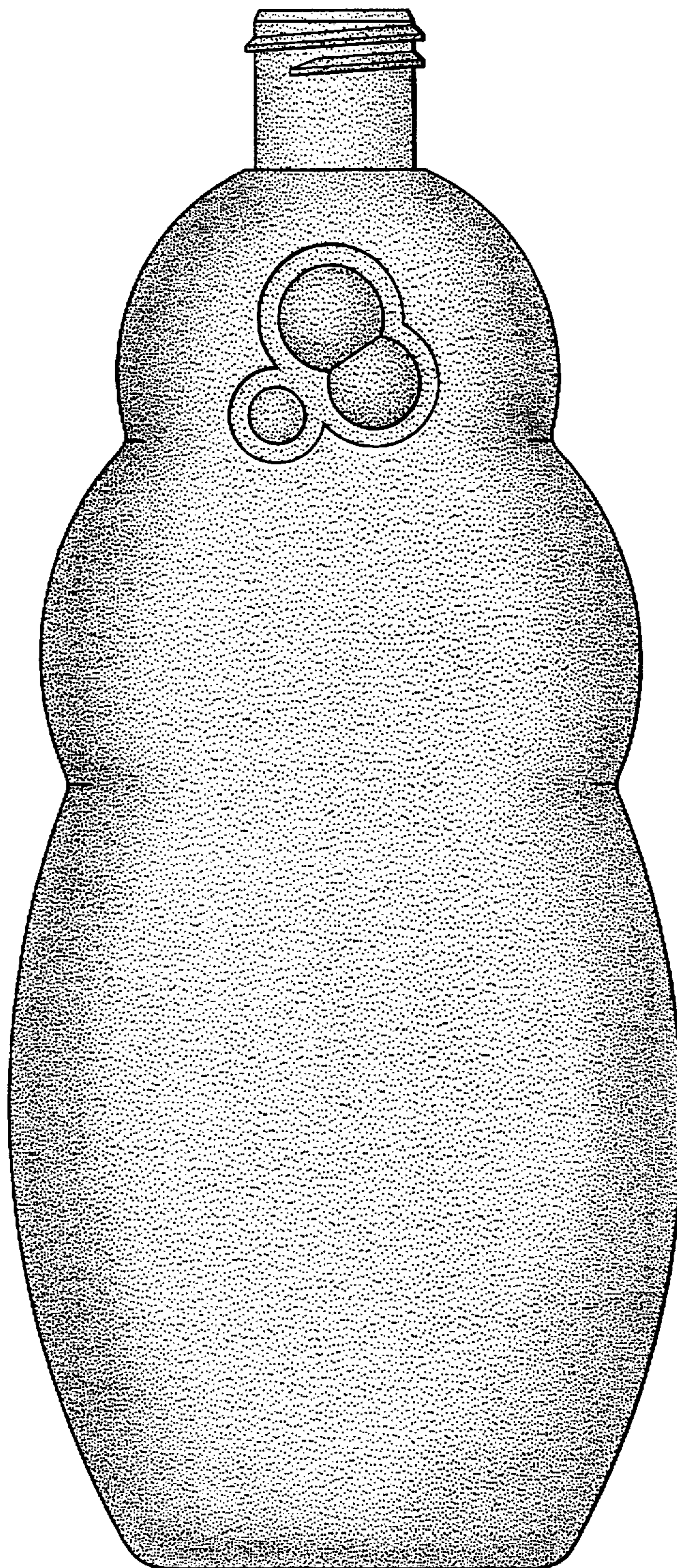

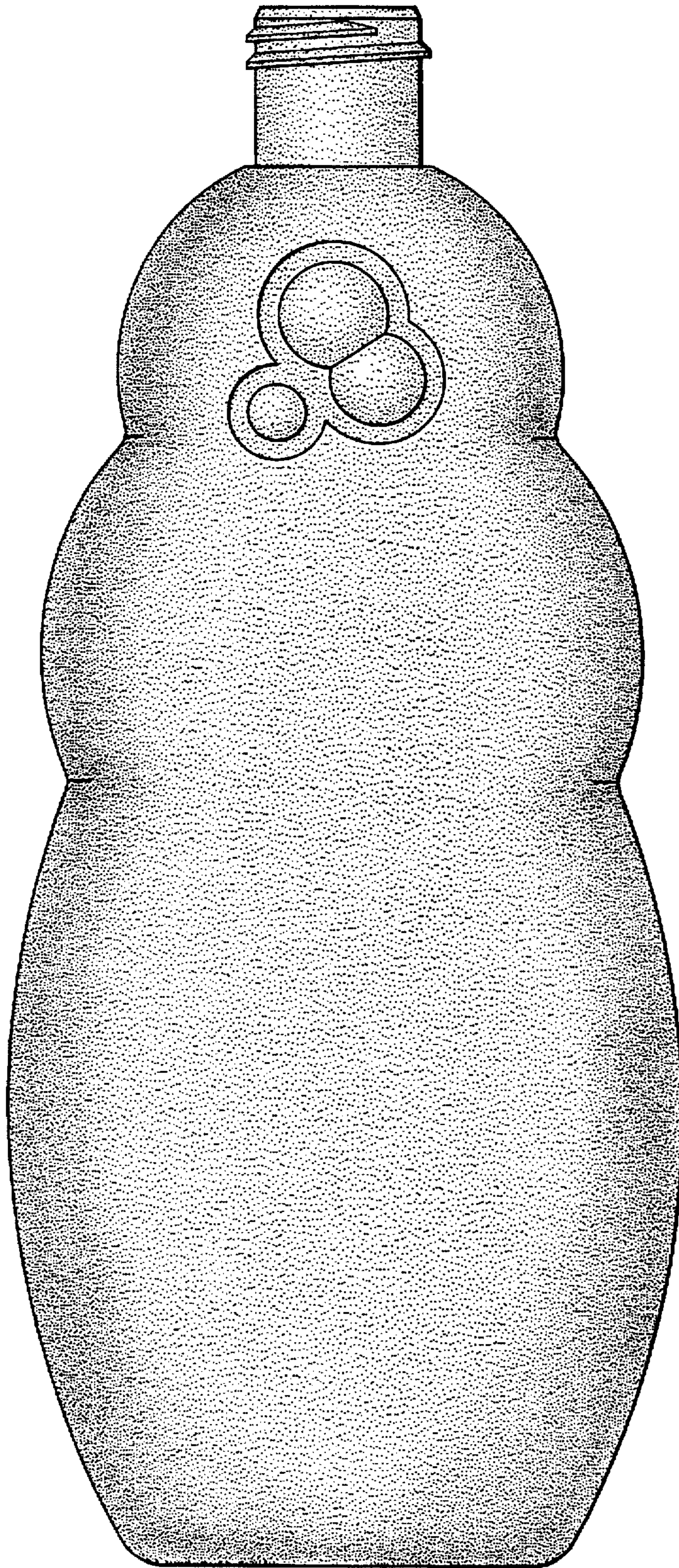

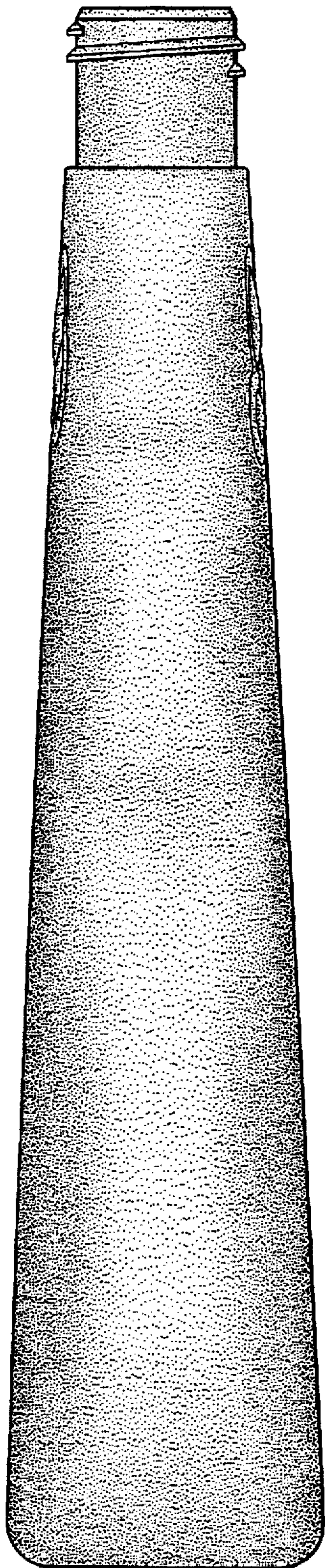

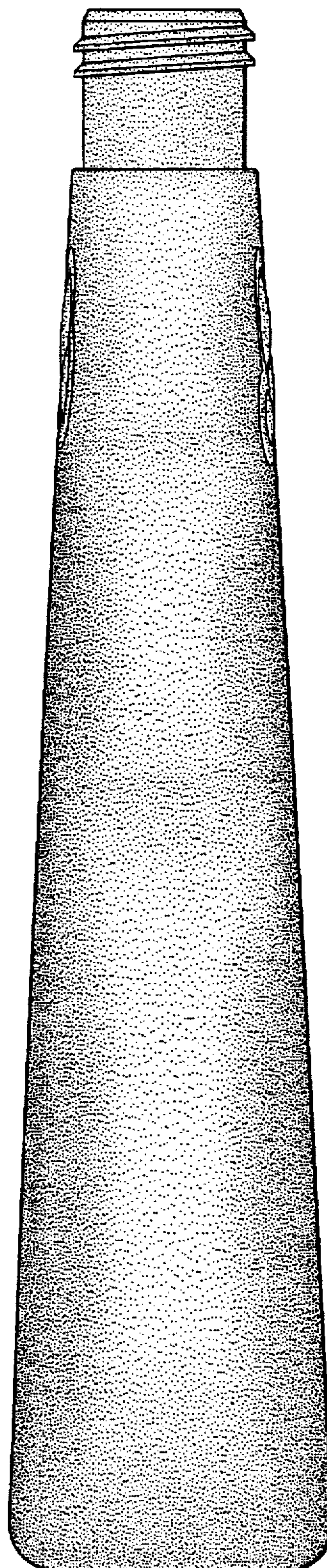

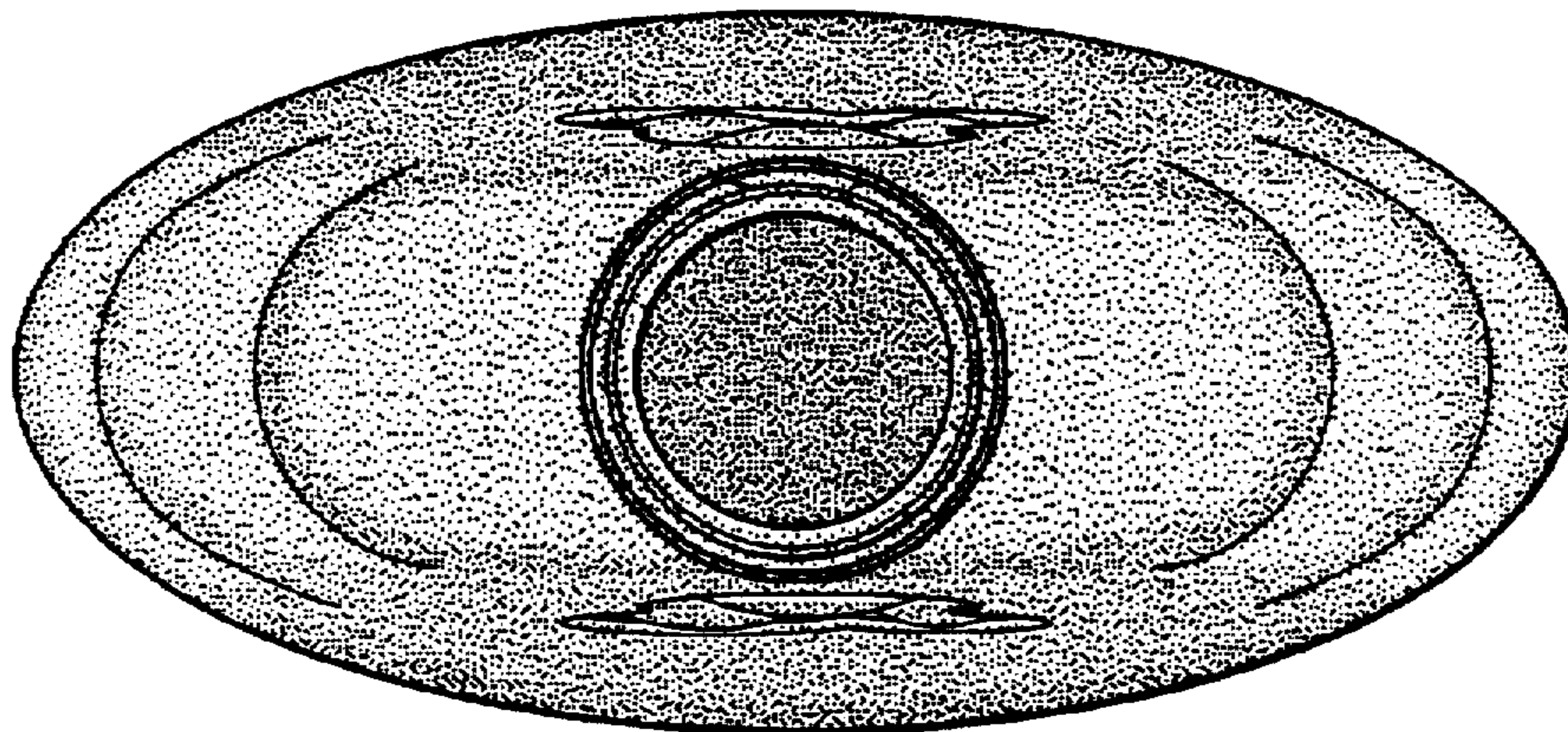

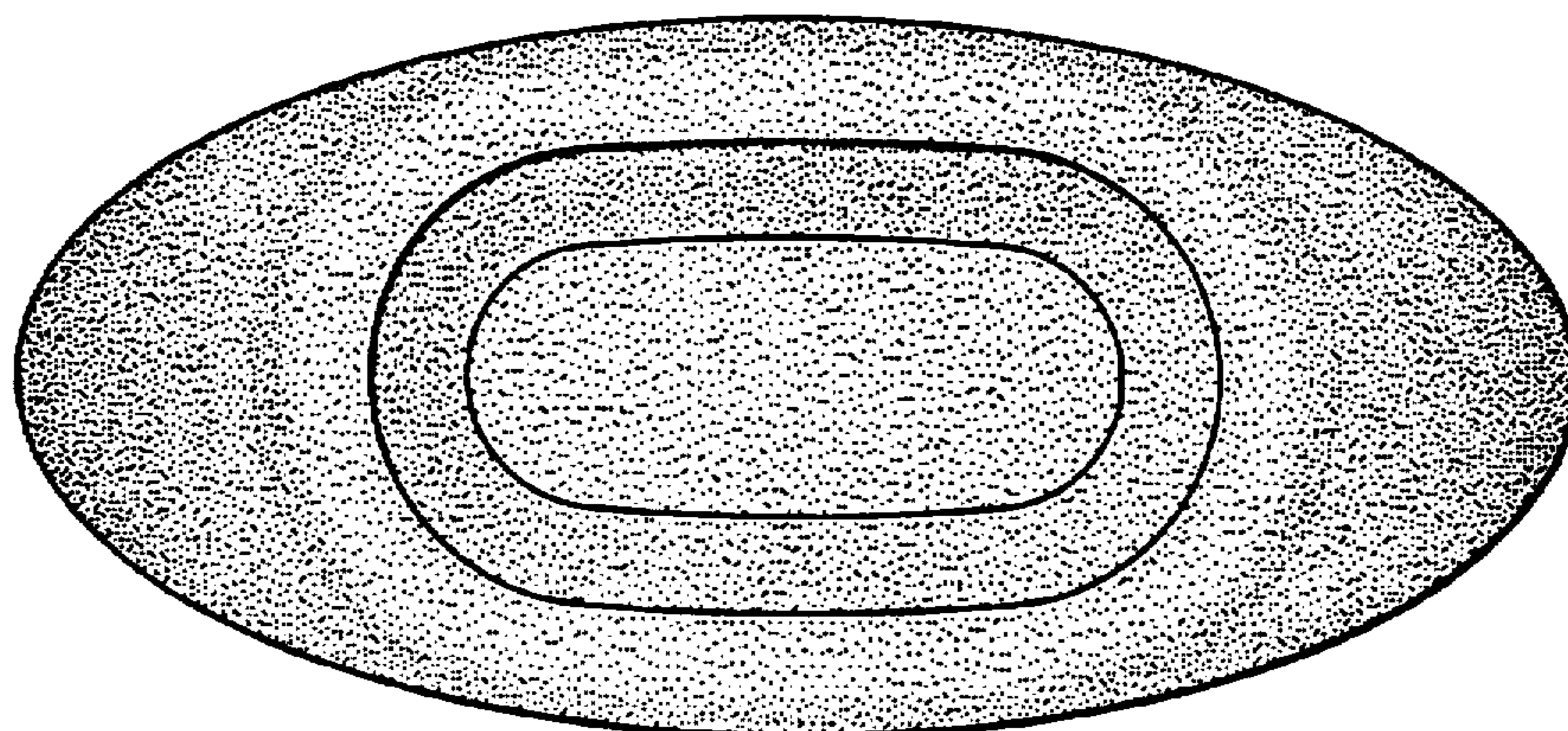
