### DESCRIPTION

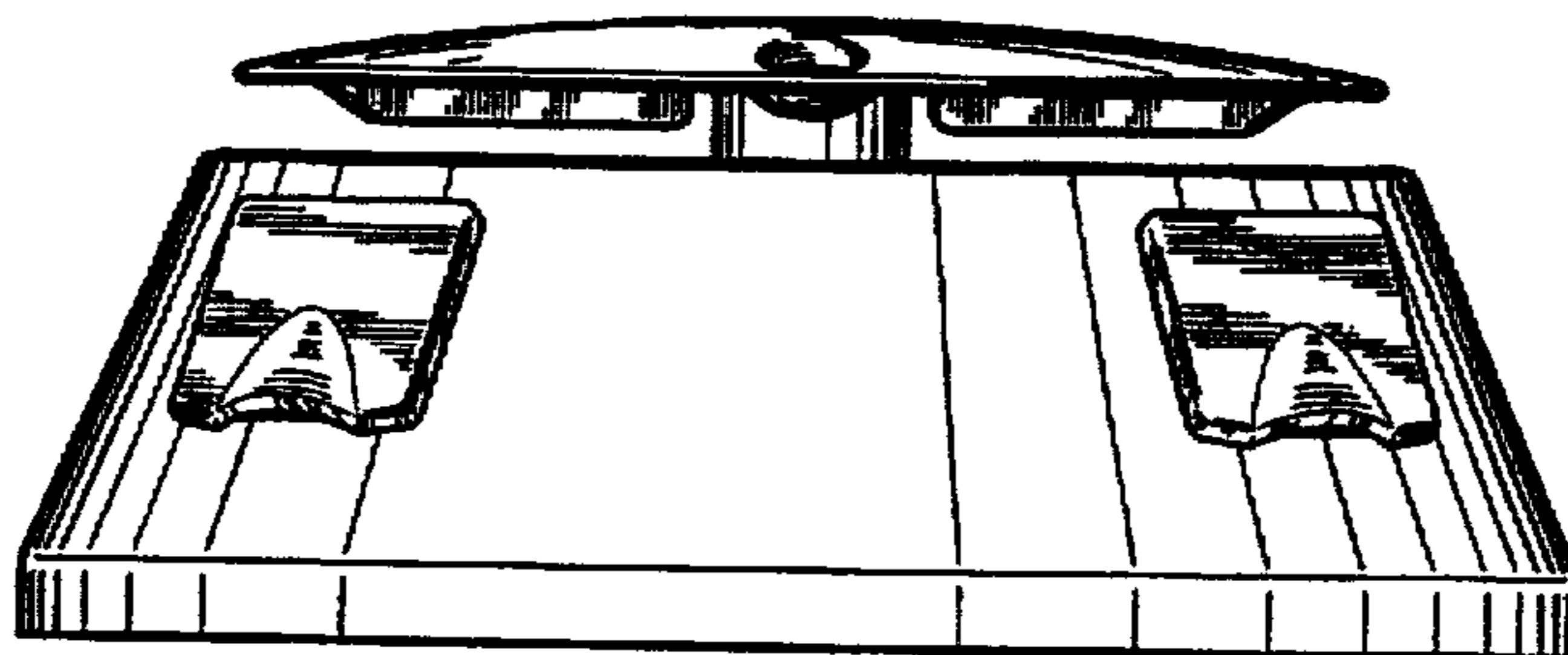
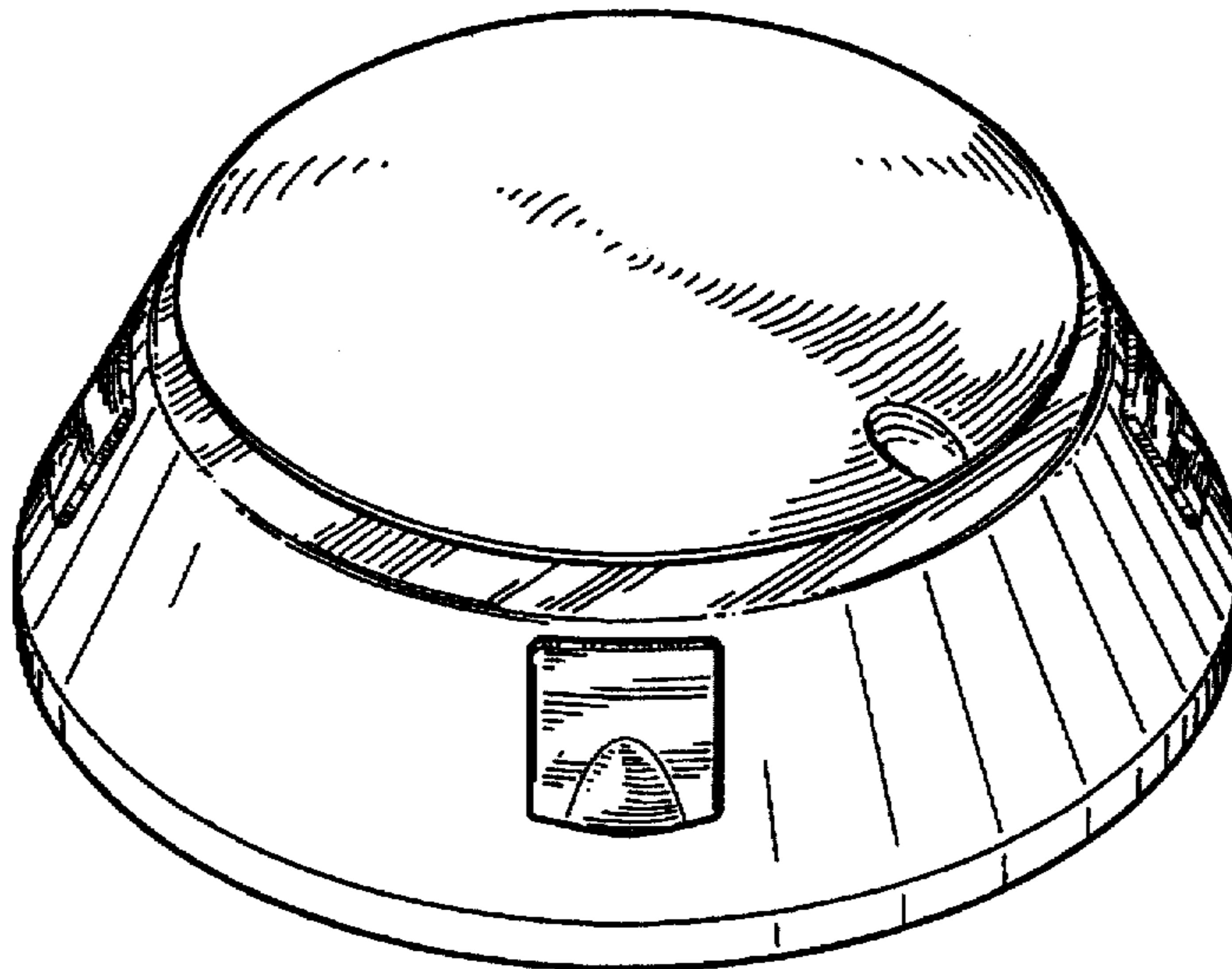
FIG. 1 is a perspective view of a data interface module, showing my new design;

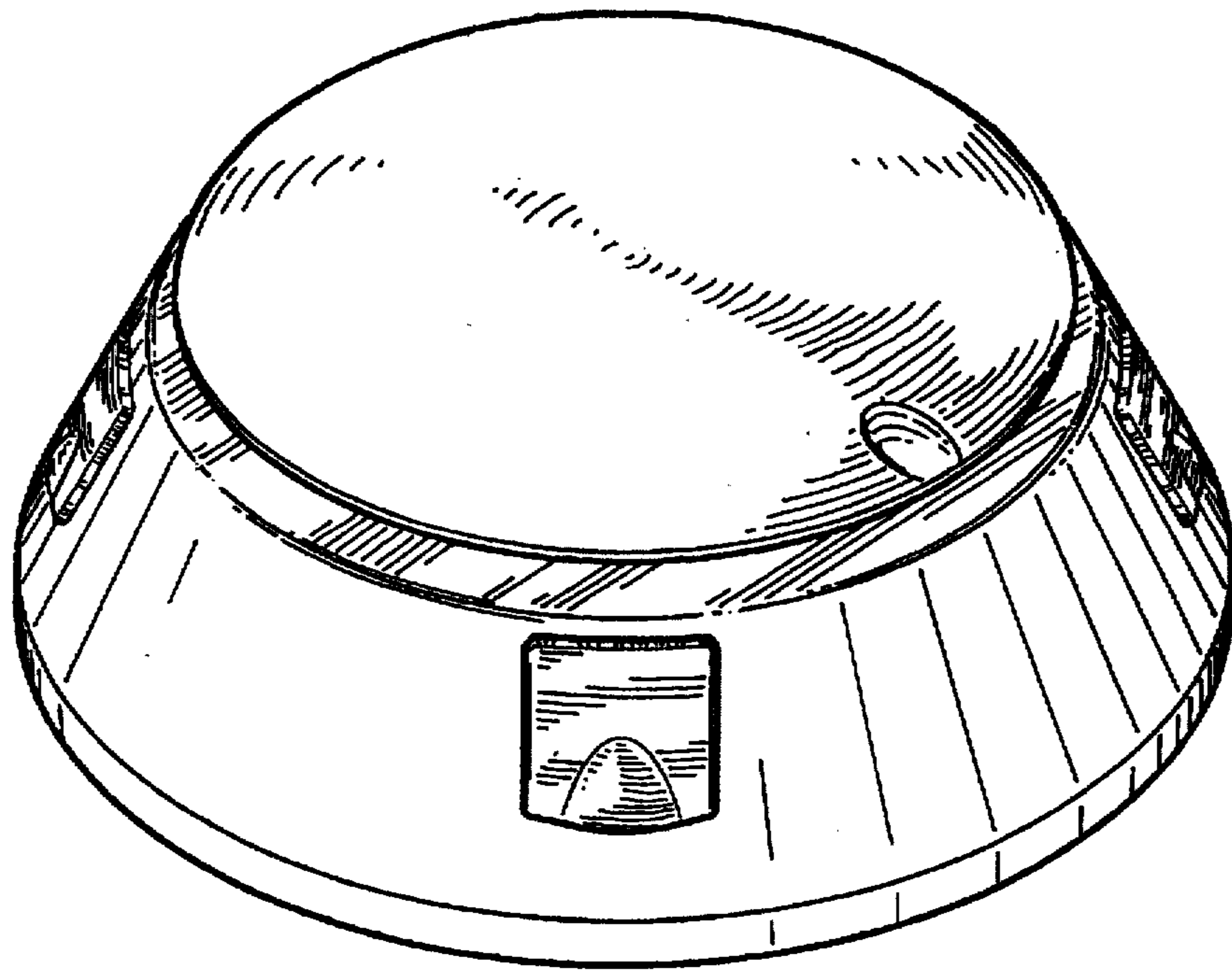

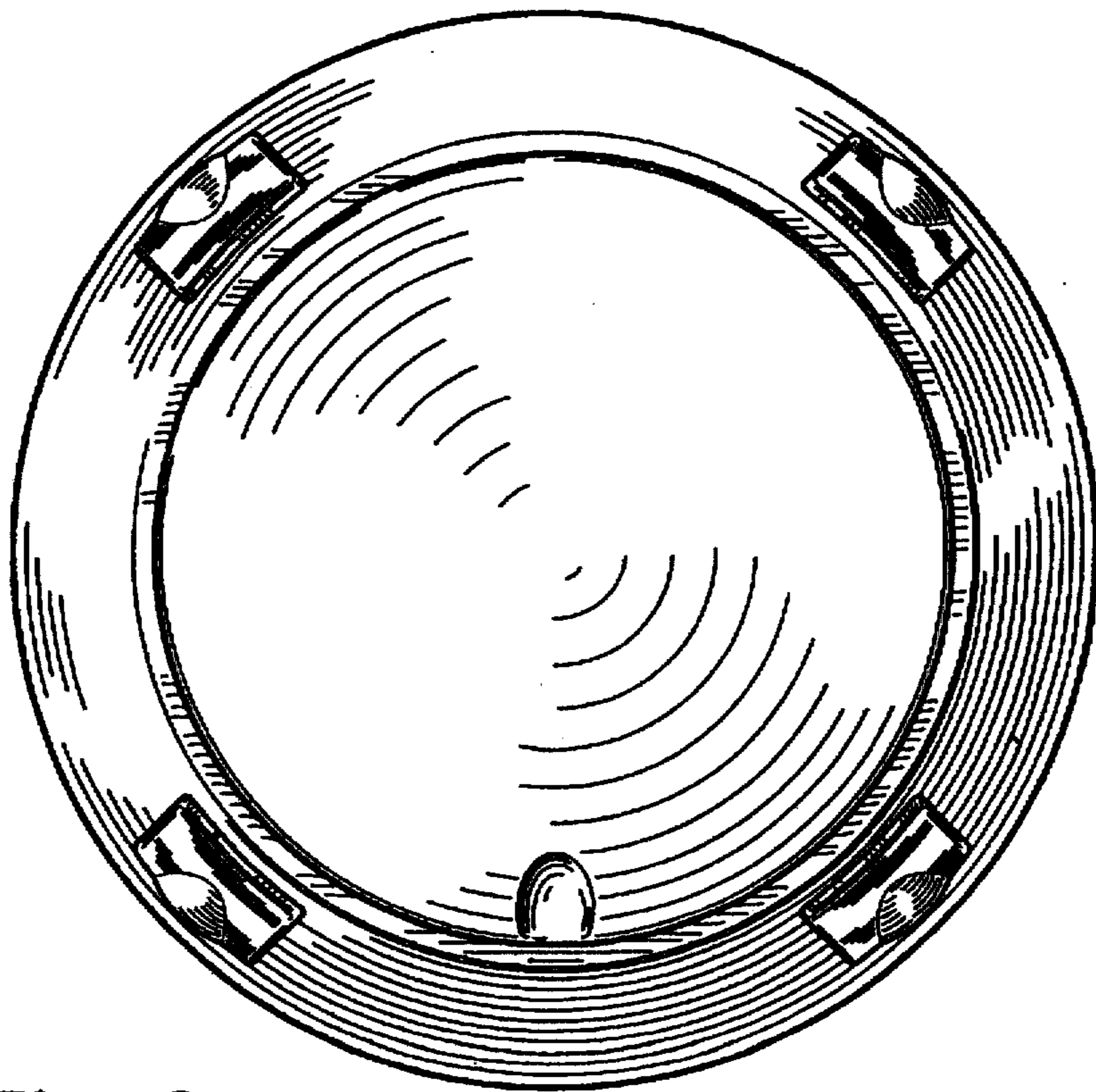

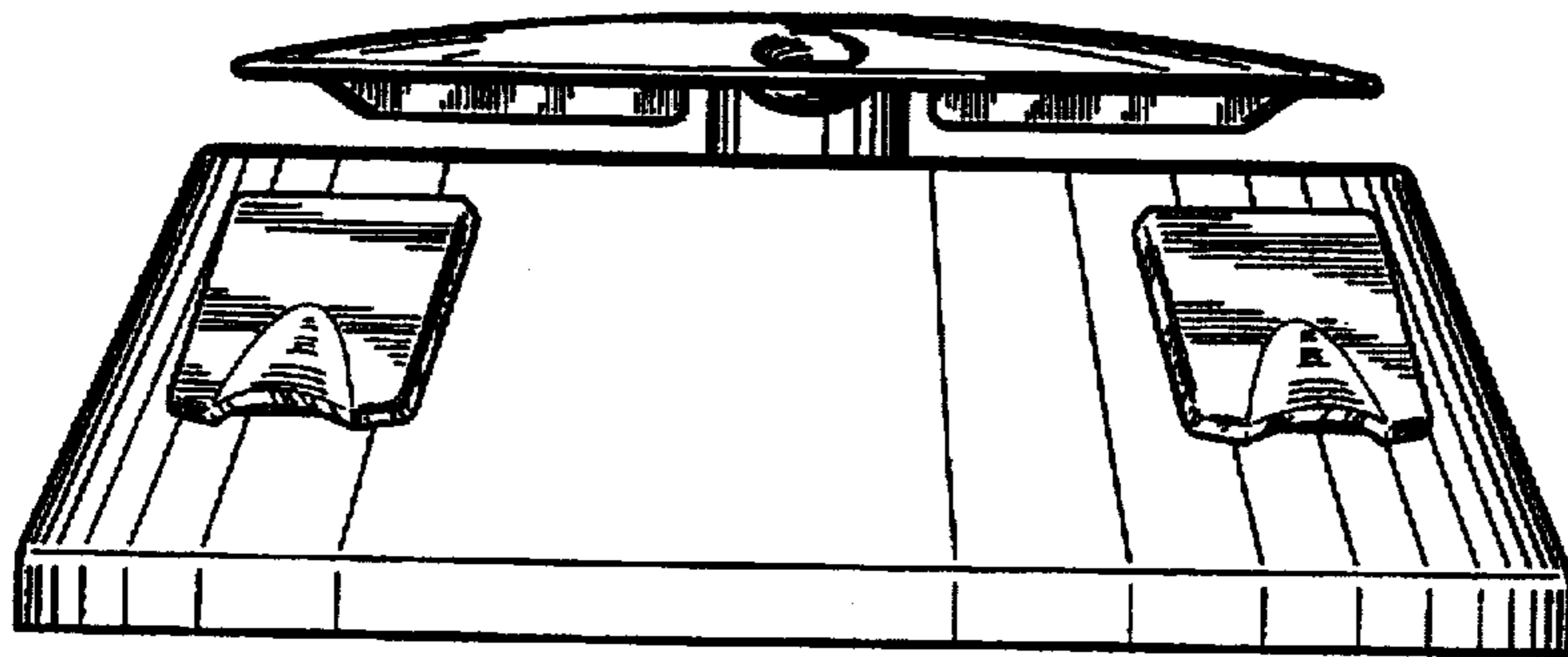

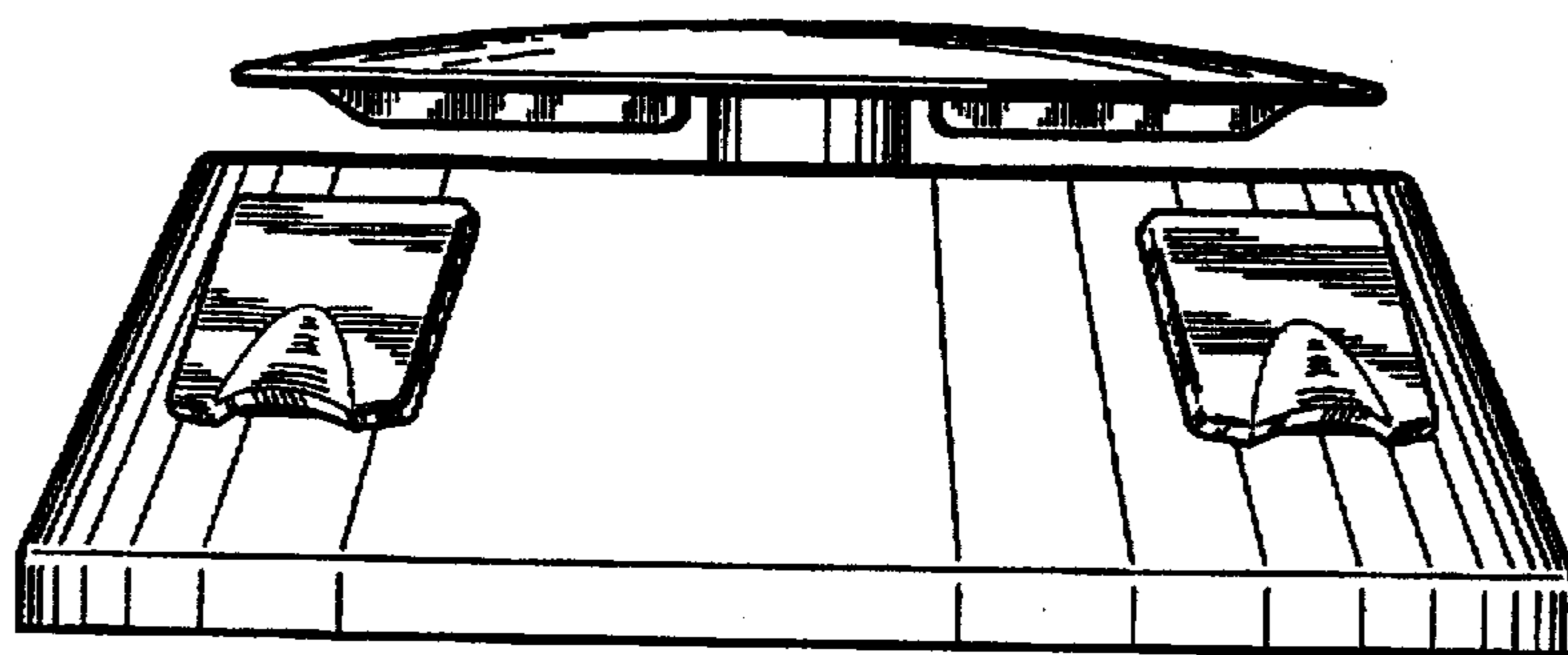

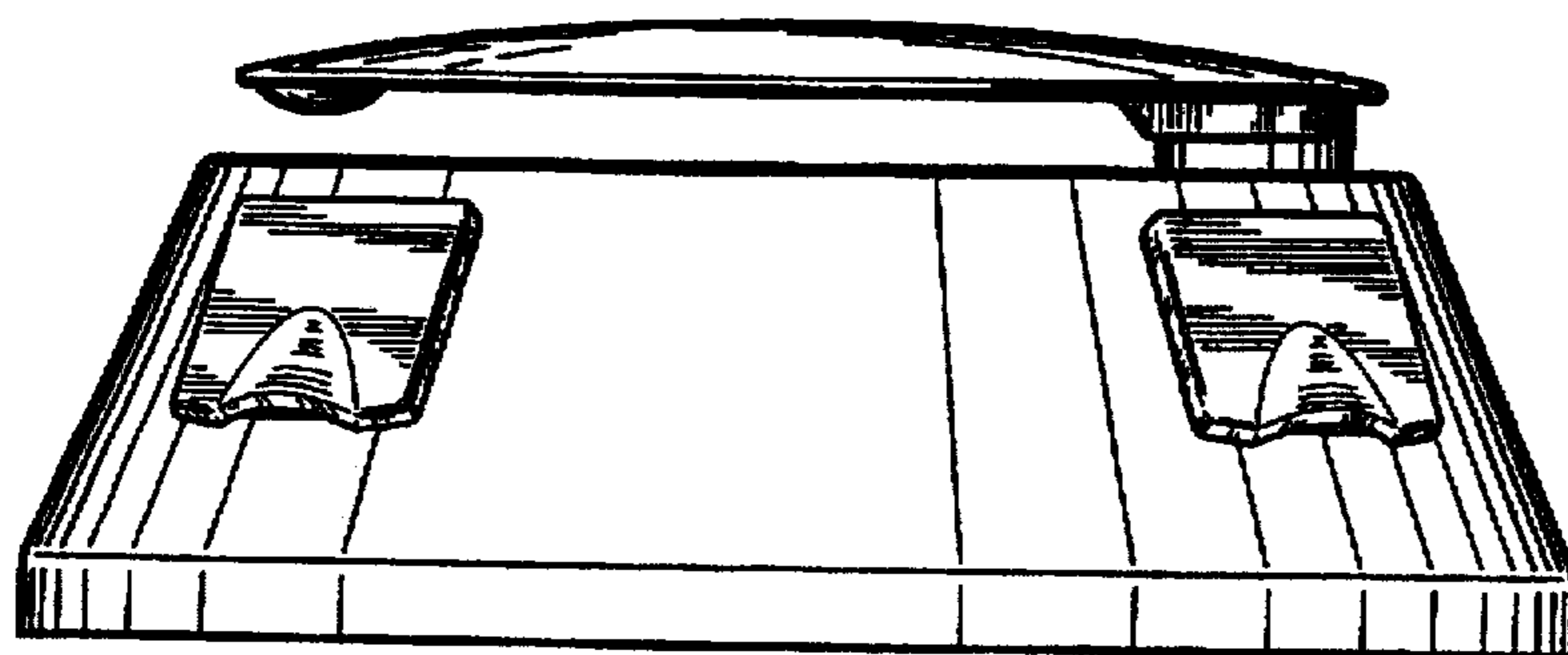
