[57] CLAIM

The ornamental design for a charger for a wireless telephone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a portion of a charger for a wireless telephone showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a perspective view of a second embodiment of a charger for a wireless telephone showing my new design;
FIG. 8 is a top plan view of the embodiment of FIG. 7;
FIG. 9 is a left side elevational view of the embodiment of FIG. 7;
FIG. 10 is a front elevational view of the embodiment of FIG. 7;
FIG. 11 is a bottom plan view of the embodiment of FIG. 7;
FIG. 12 is a right side elevational view of the embodiment of FIG. 7; and,
FIG. 13 is a rear elevational view of the embodiment of FIG. 7.

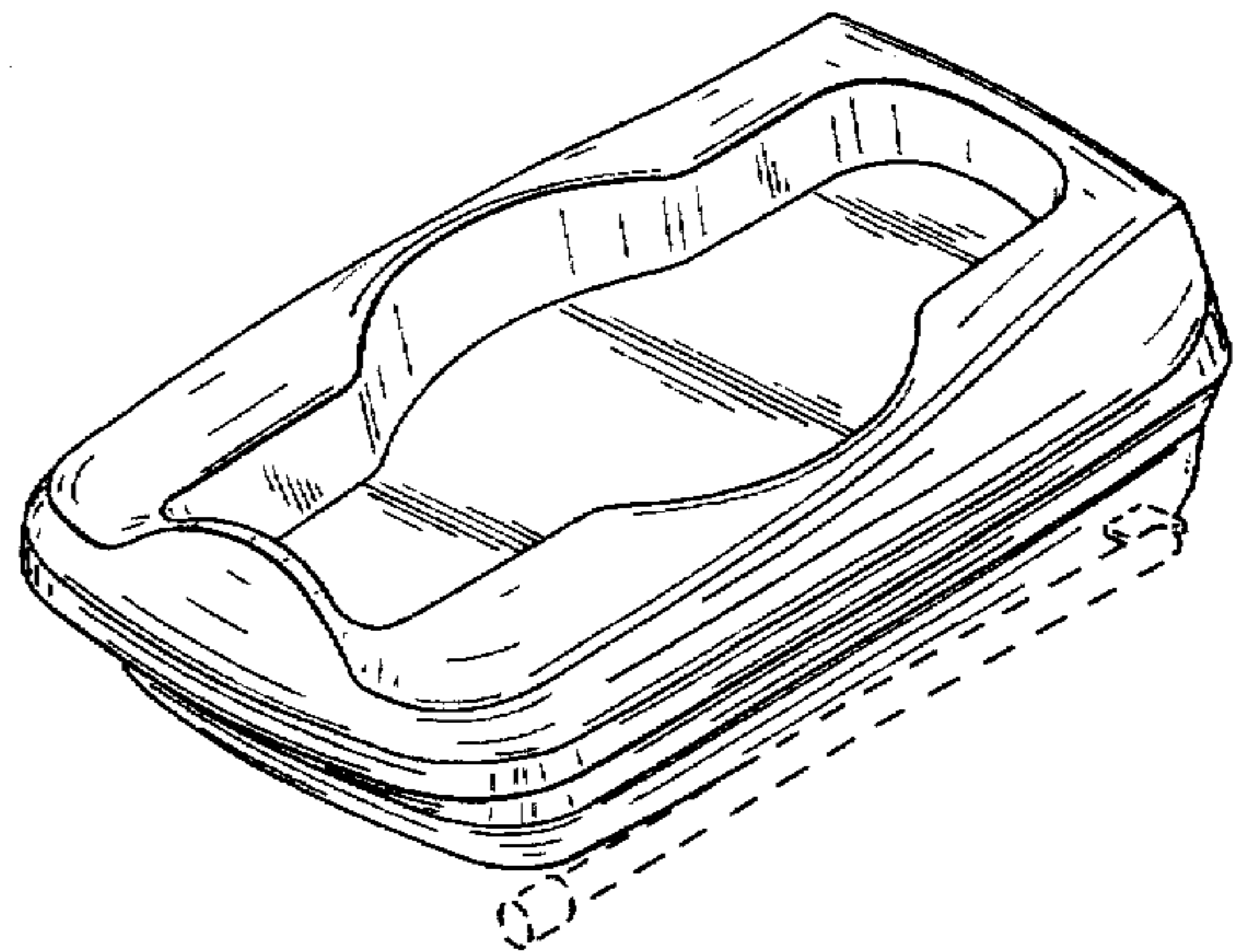
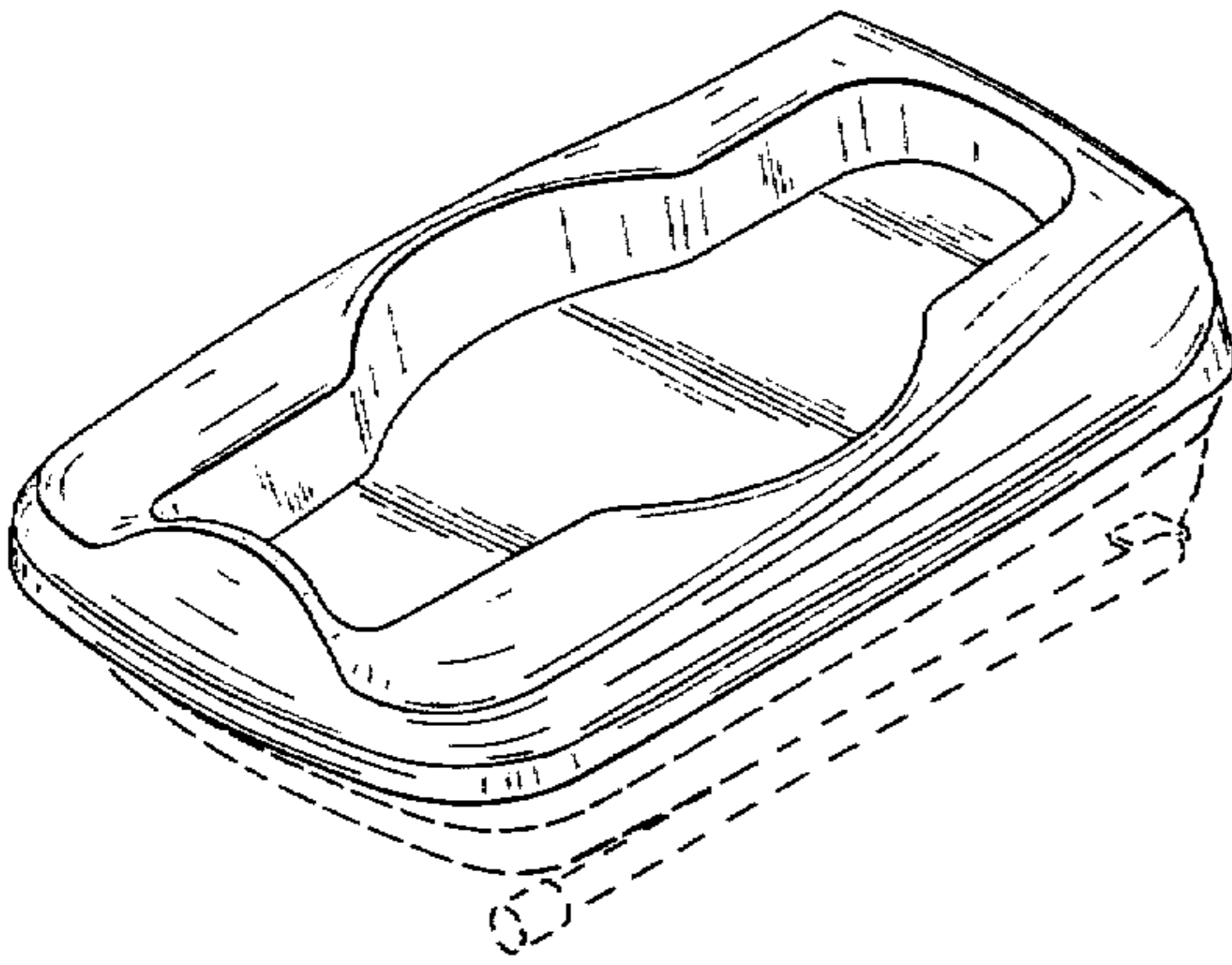

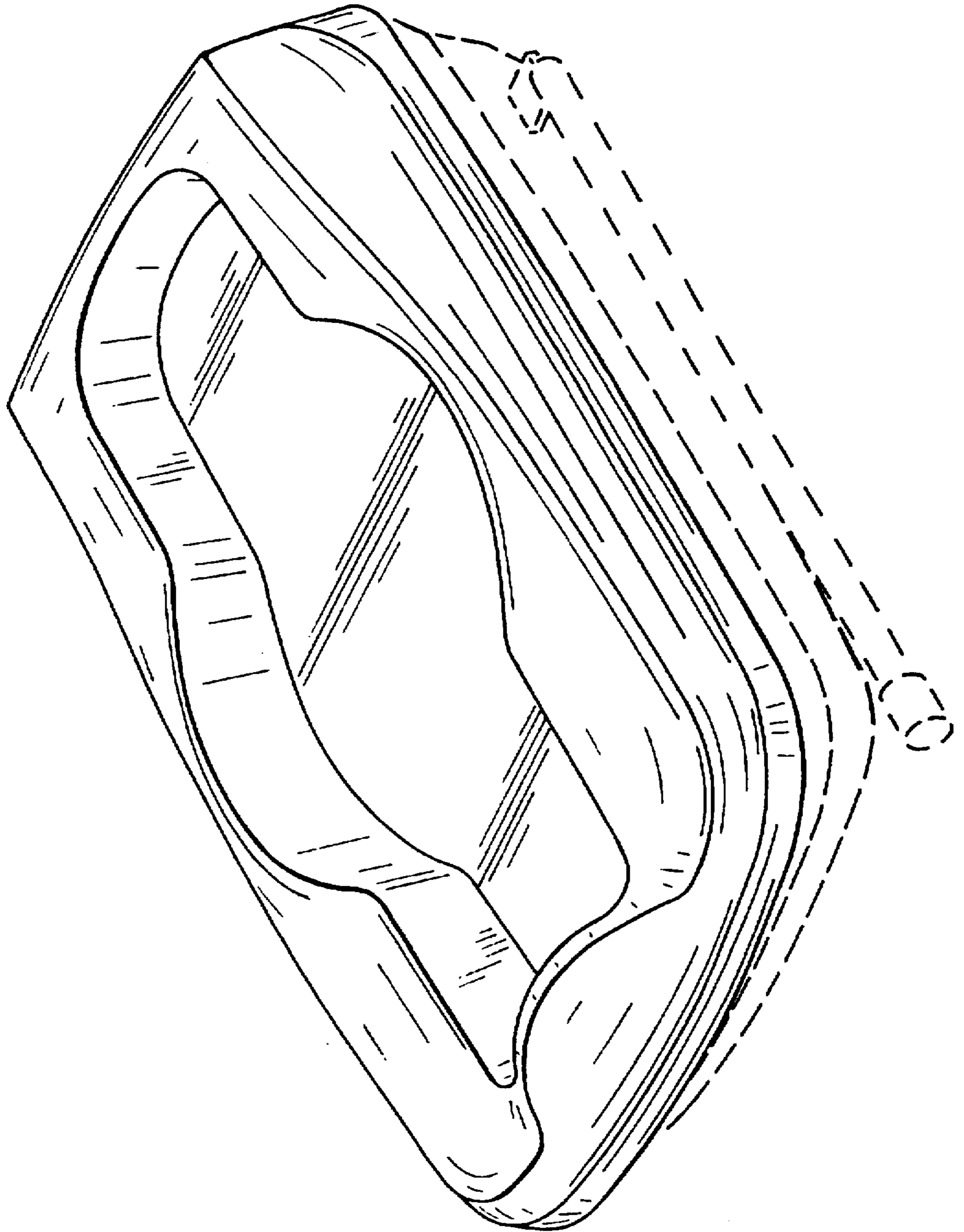

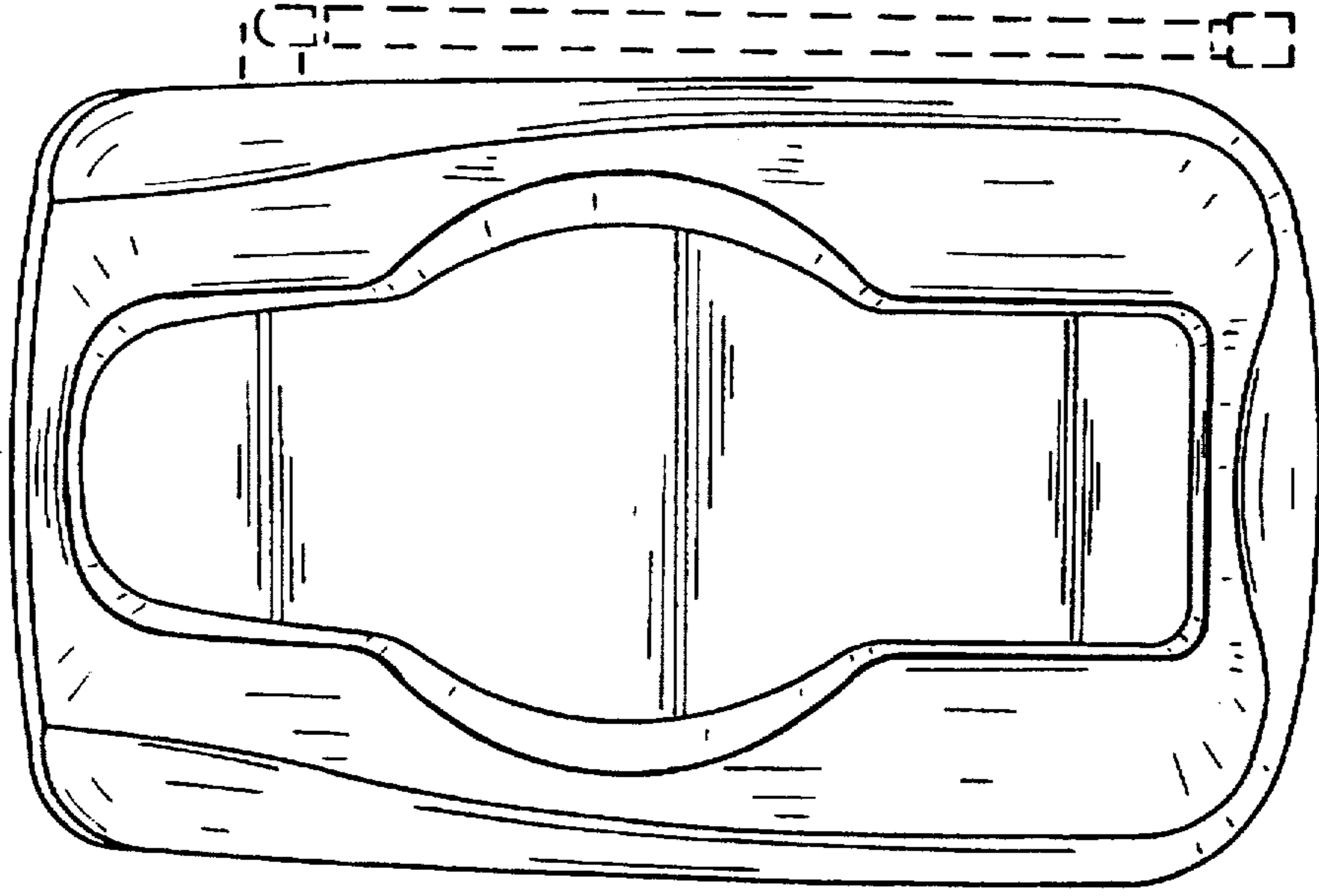

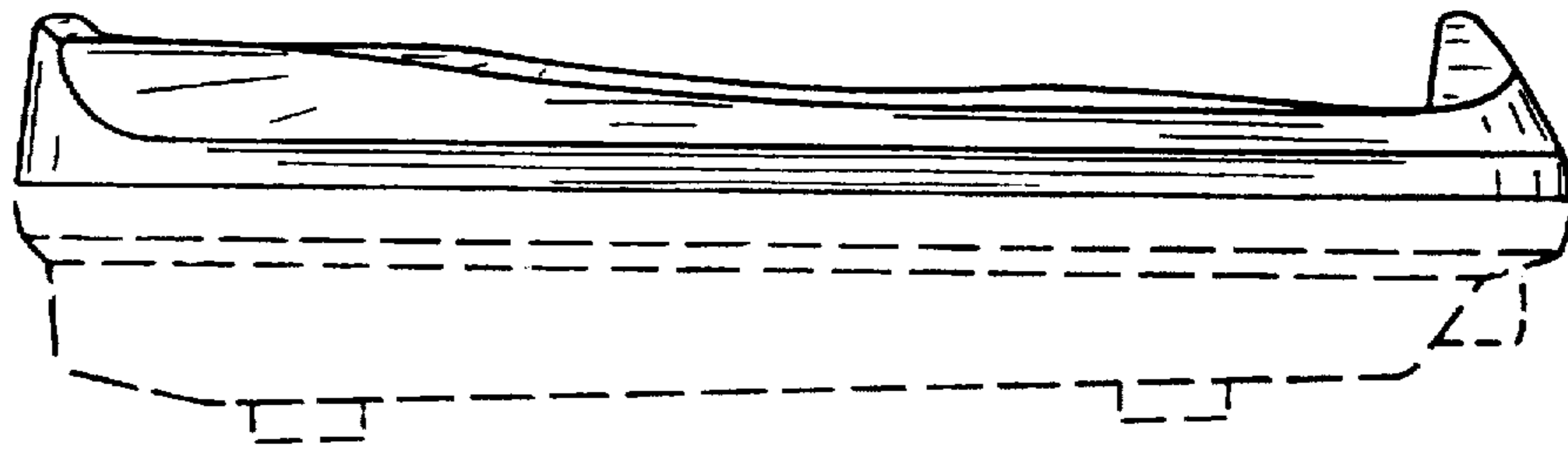

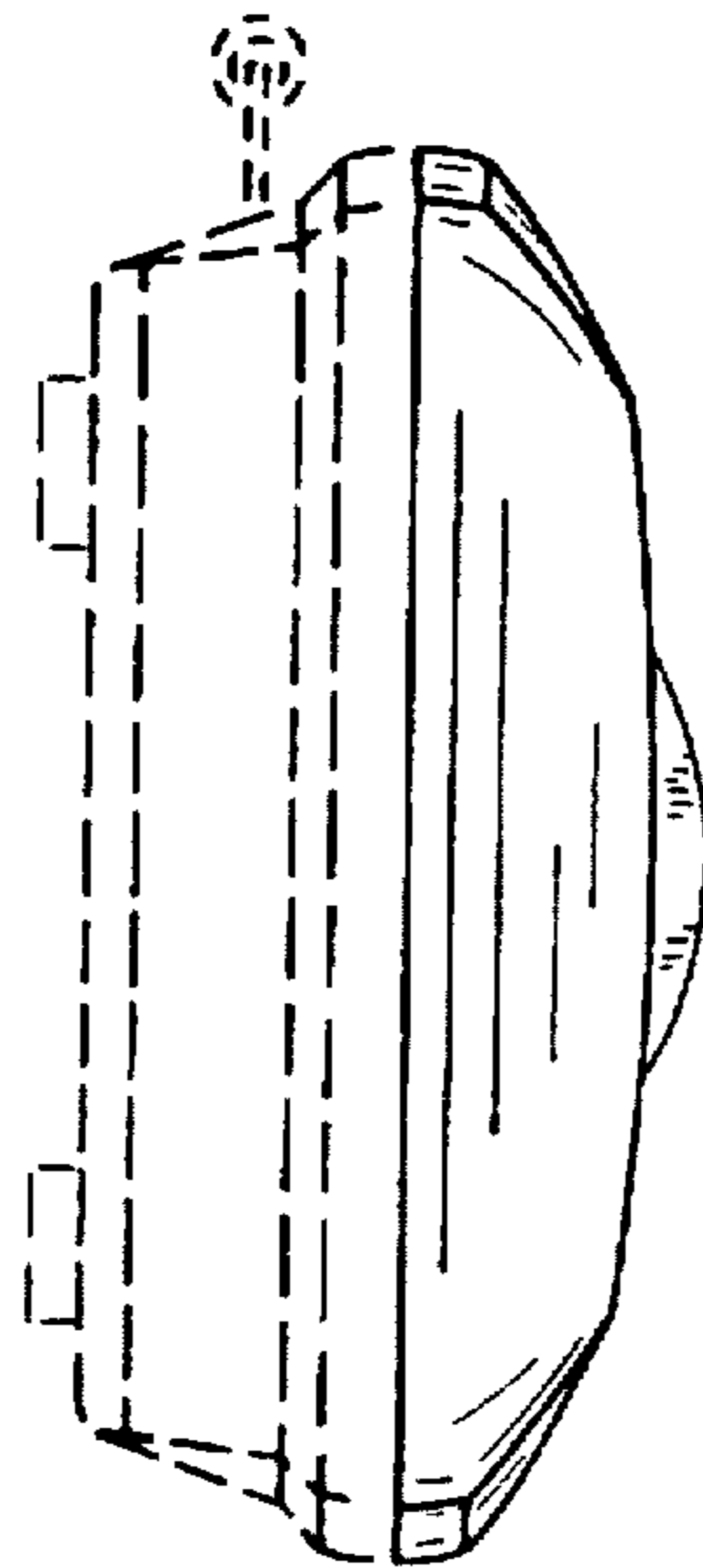

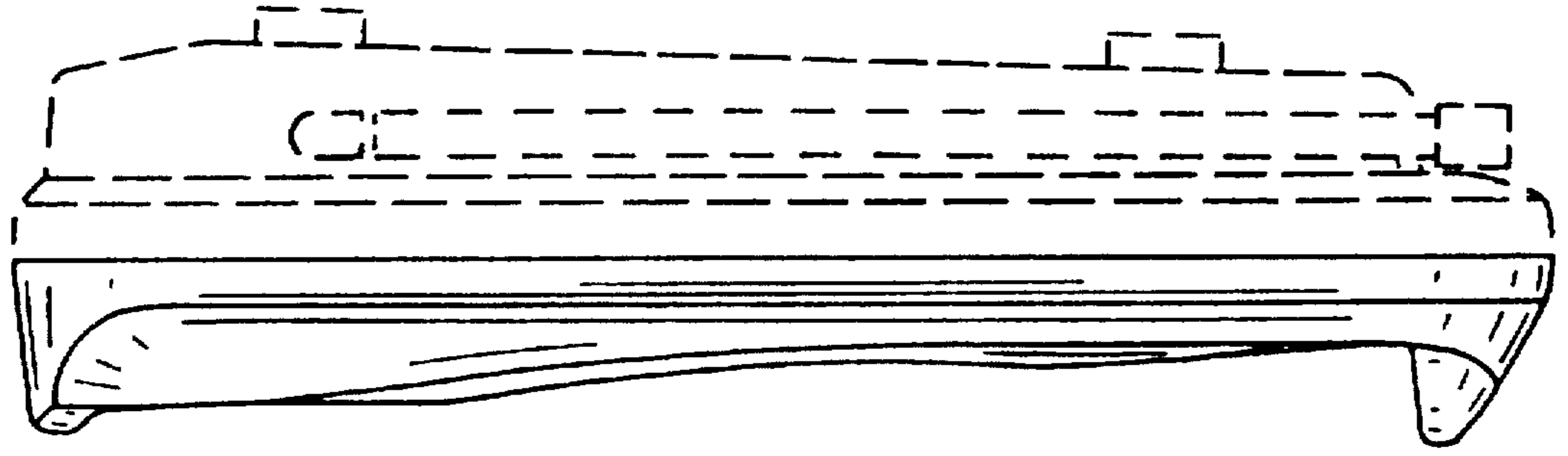

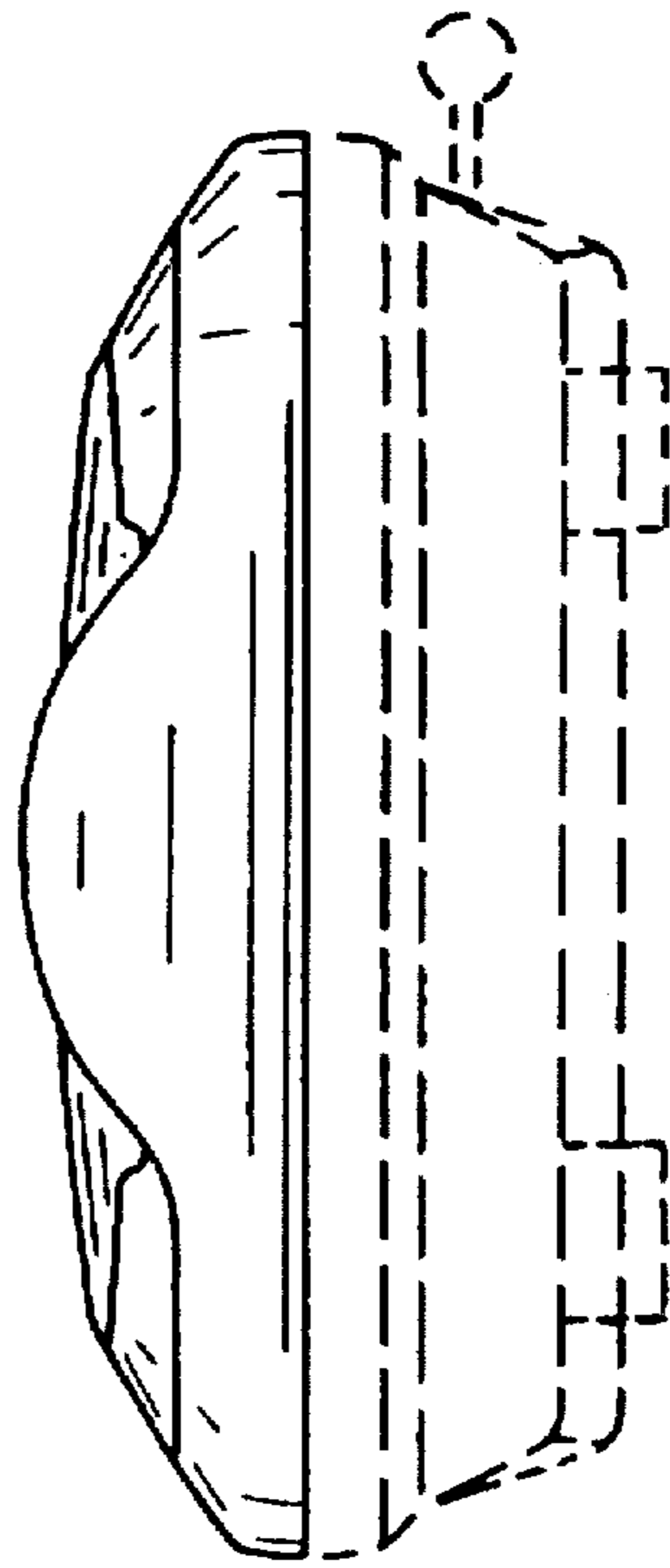

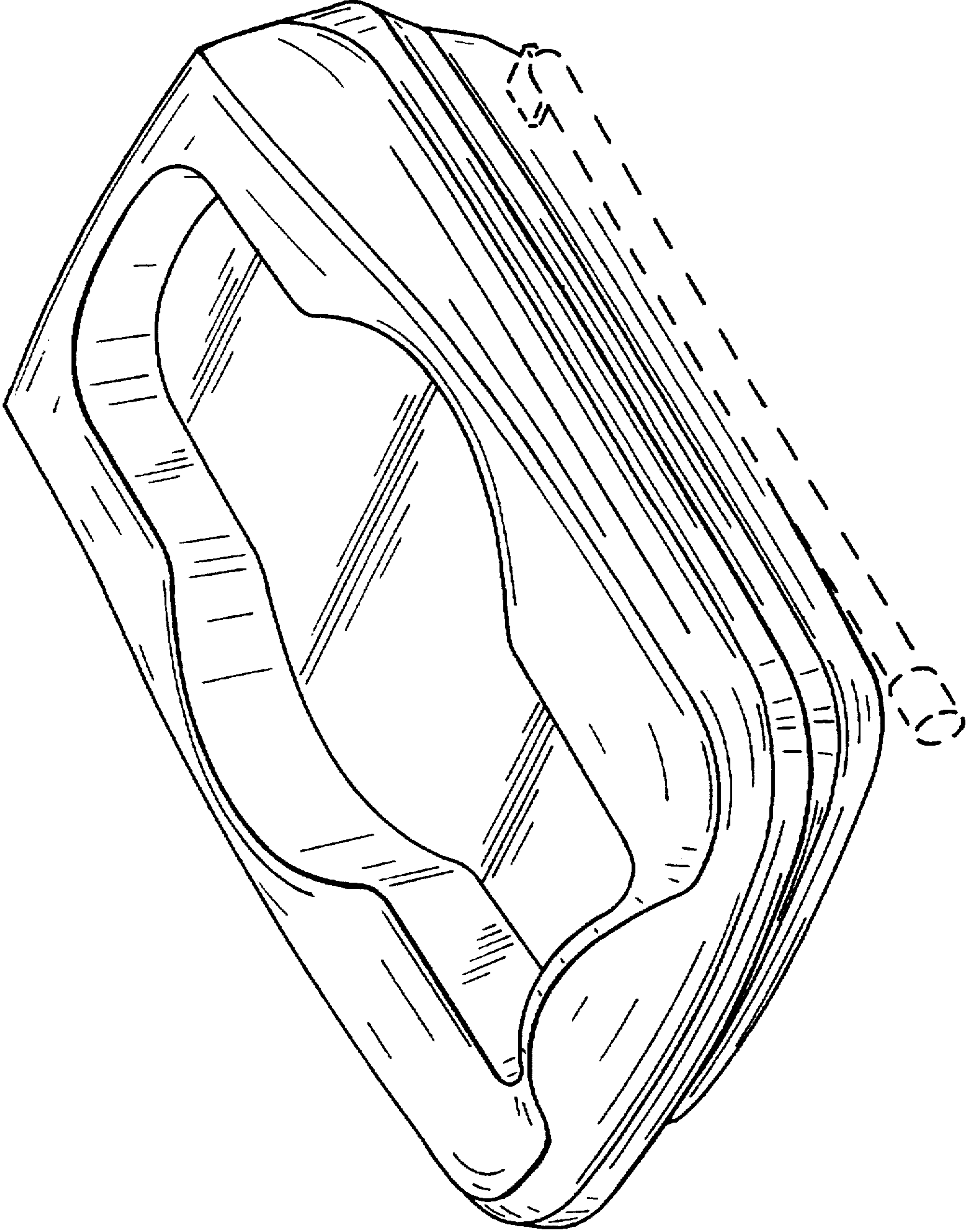

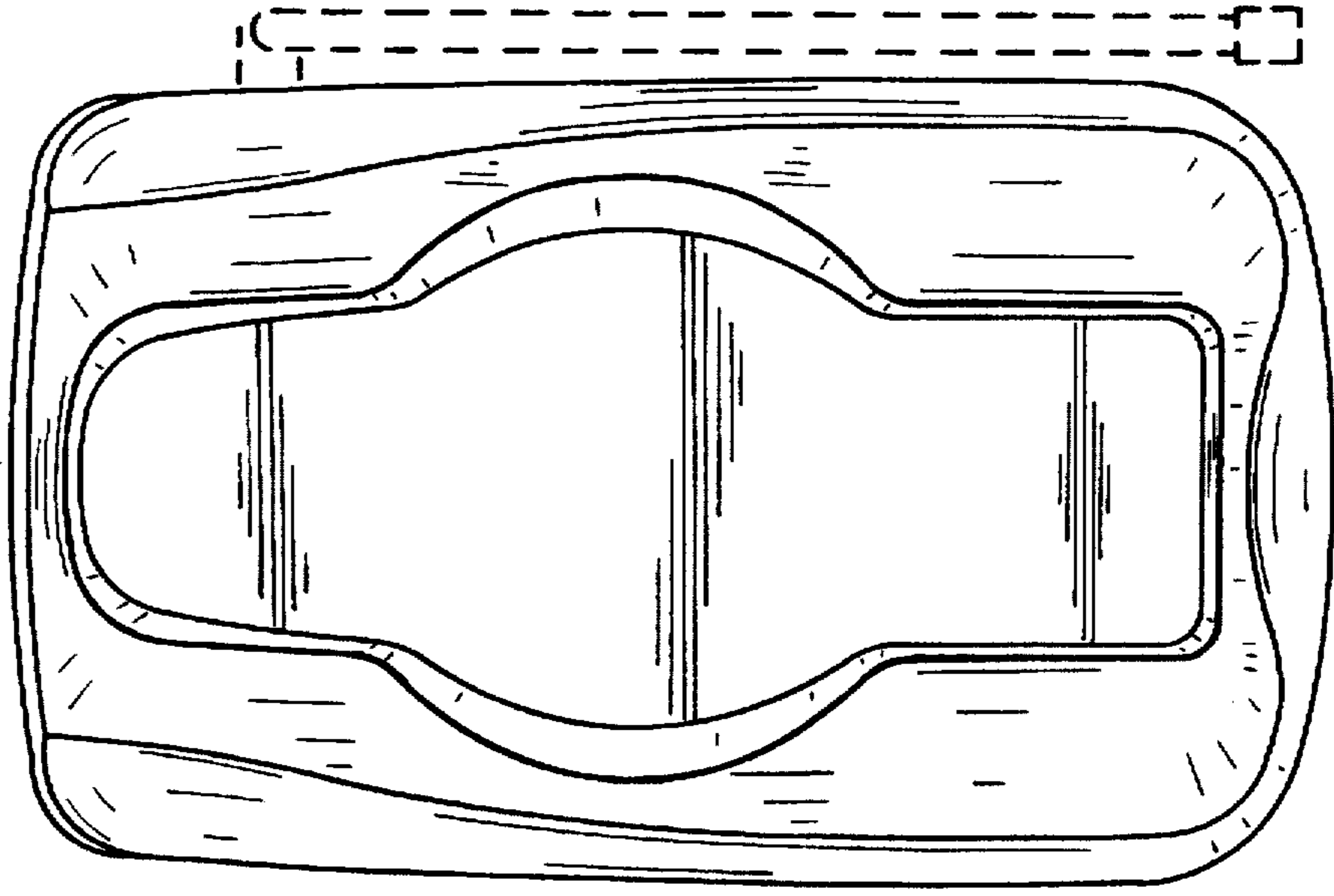

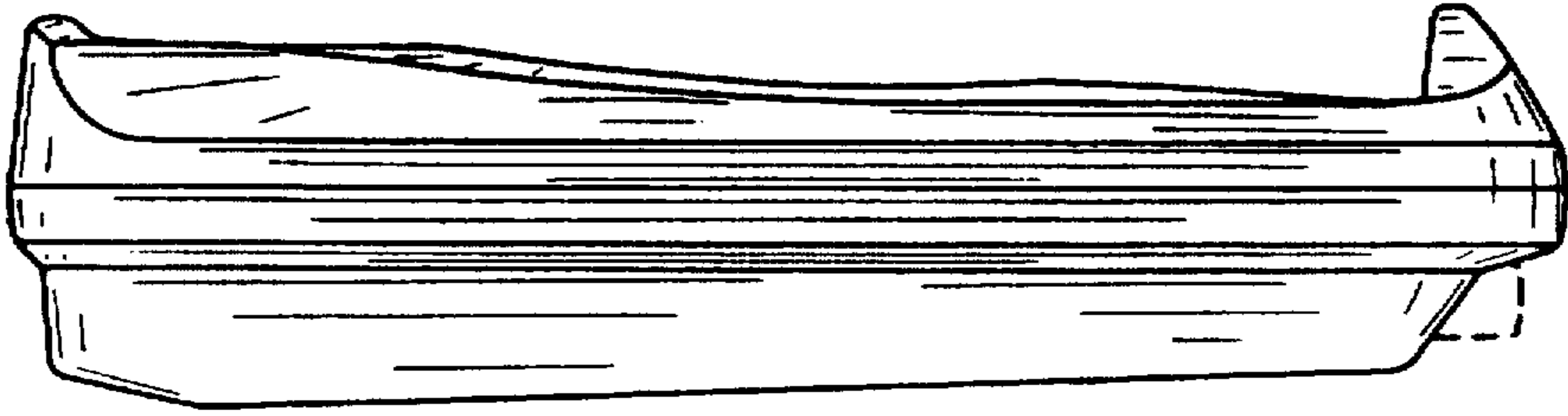

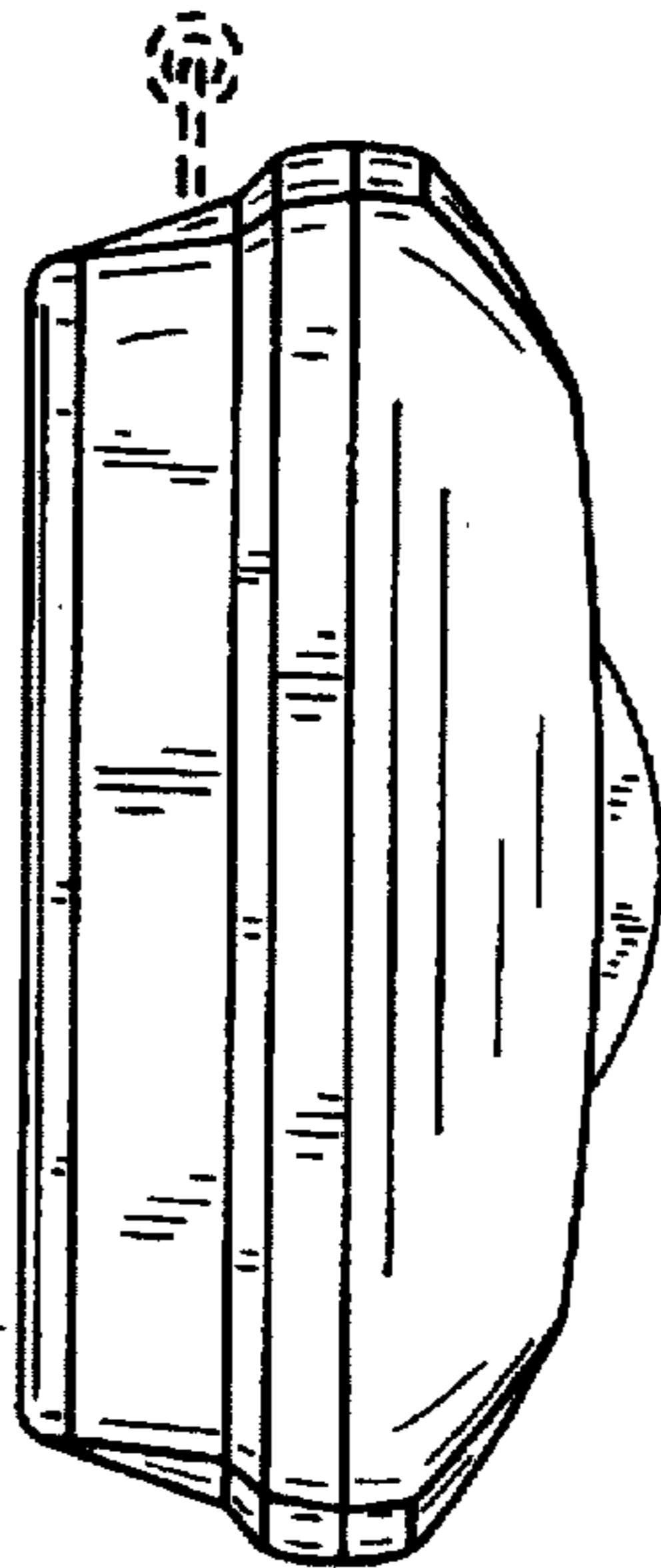

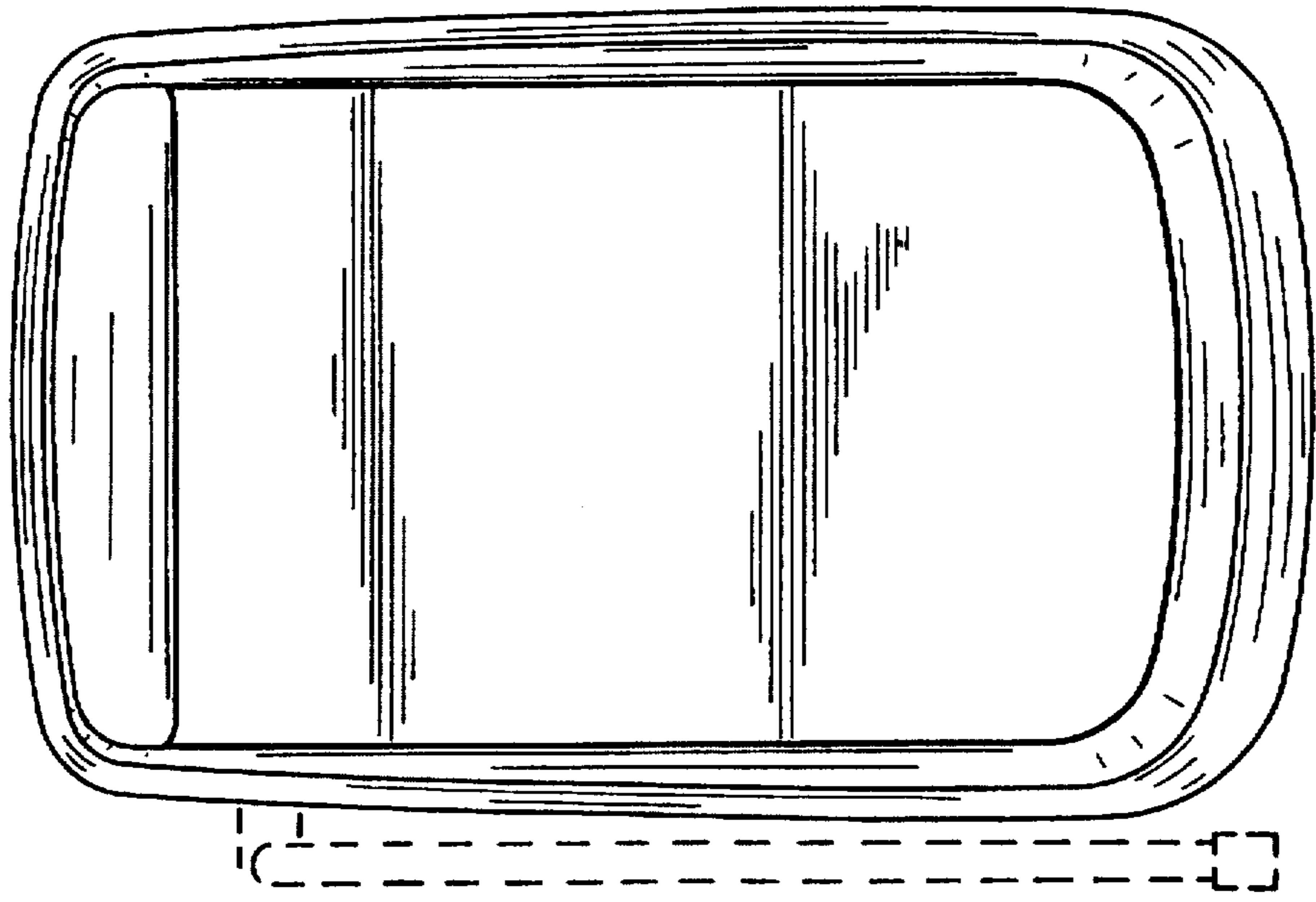

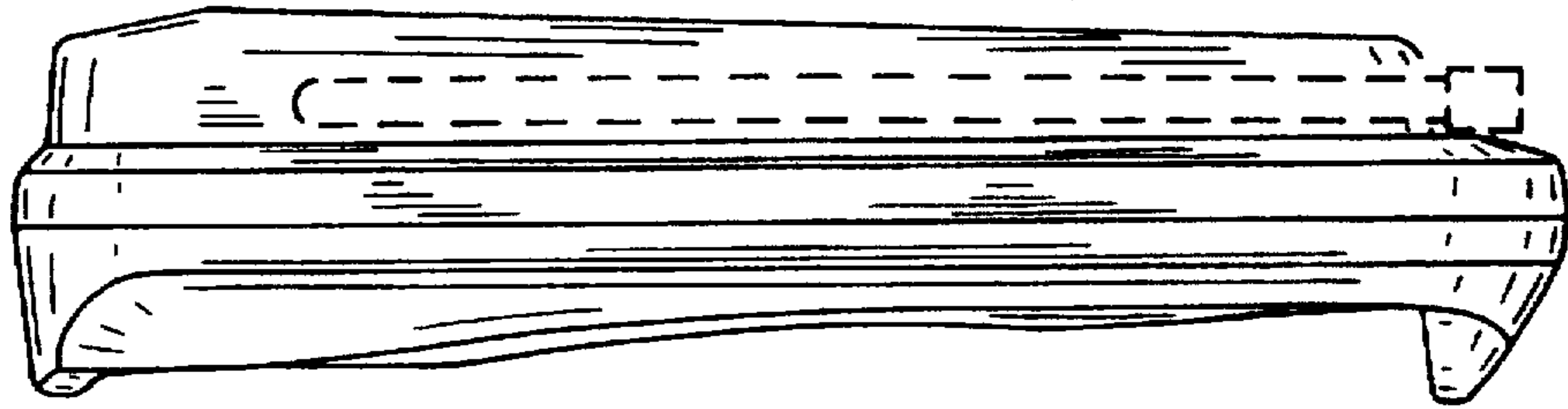
