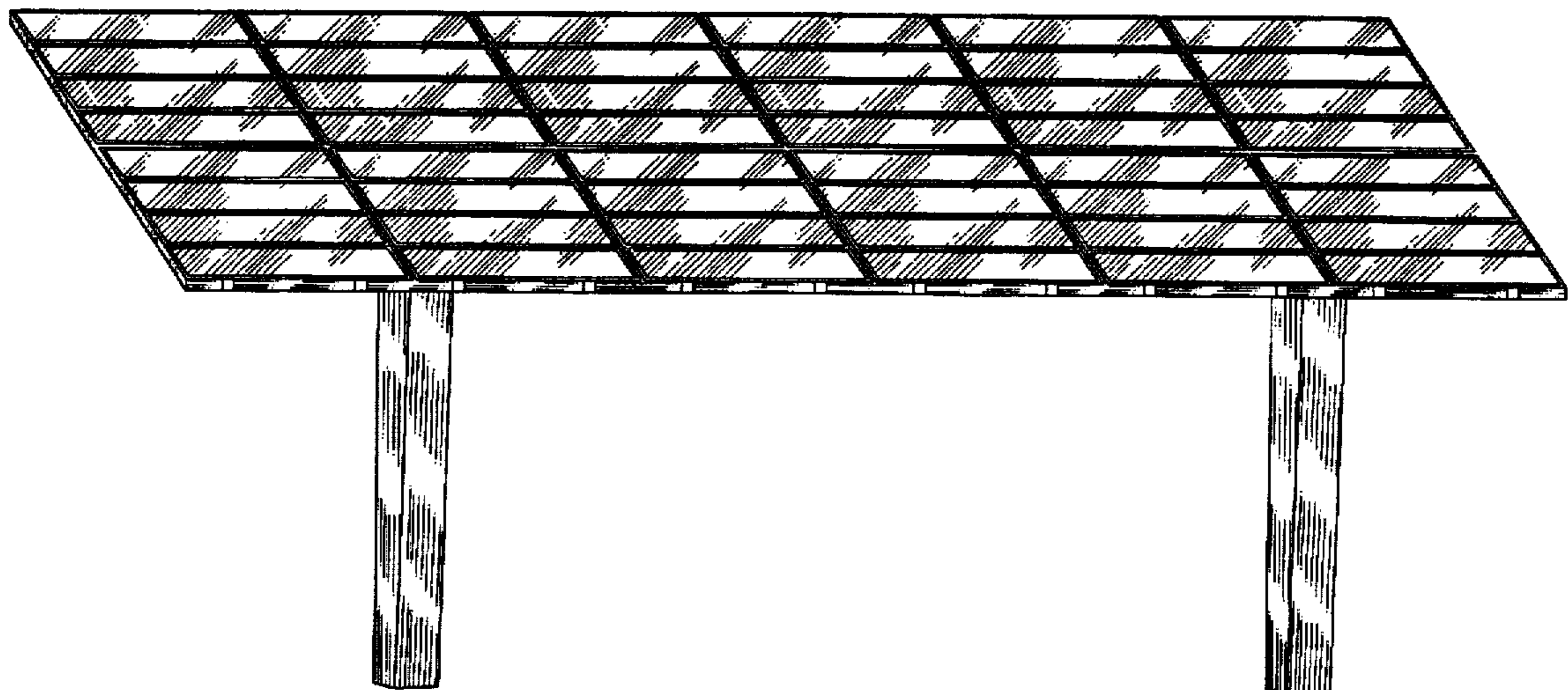
[57] **CLAIM**

The ornamental design for a solar electric shade system, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a solar electric shade system showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof; and,  
FIG. 6 is a right side elevational view; the left side elevational view being a mirror image thereof.

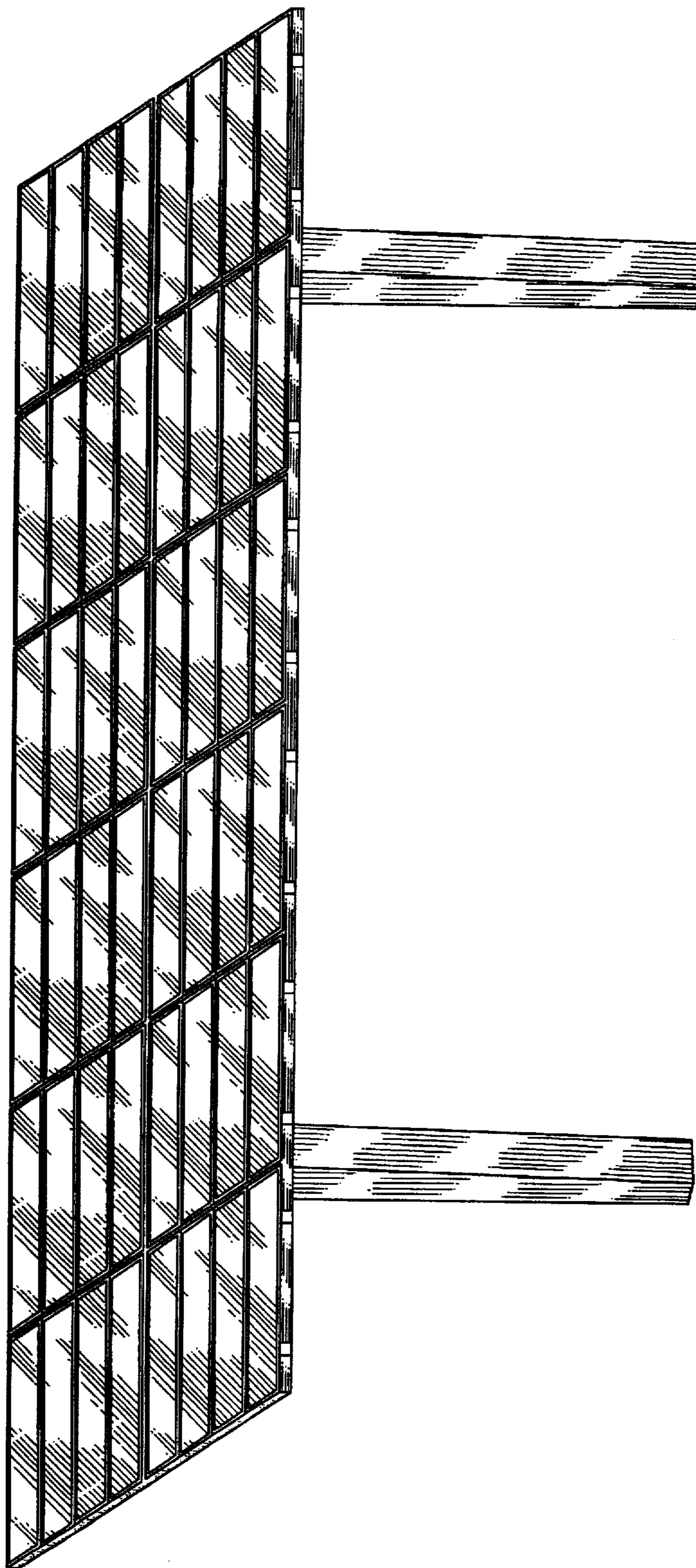

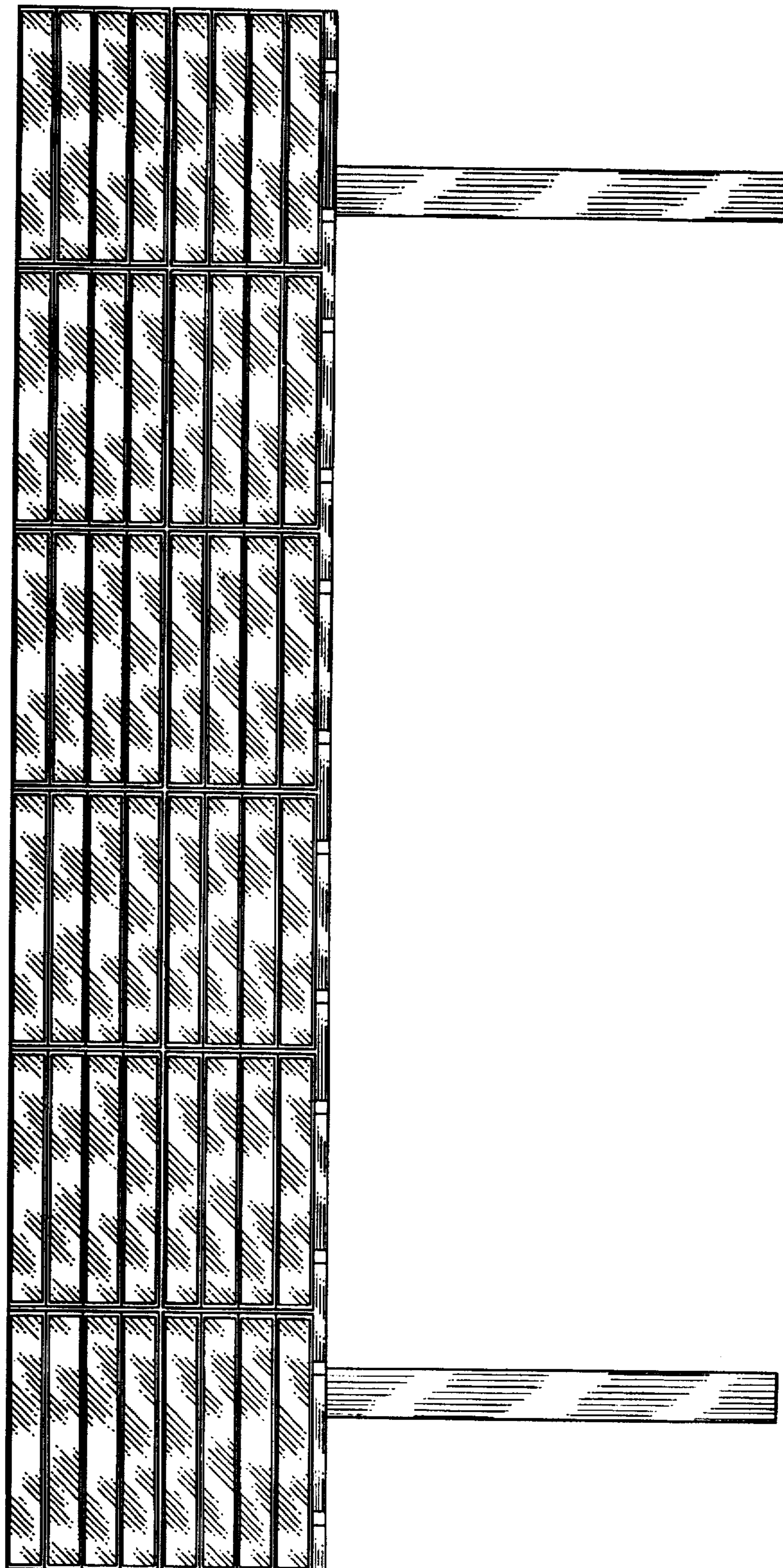

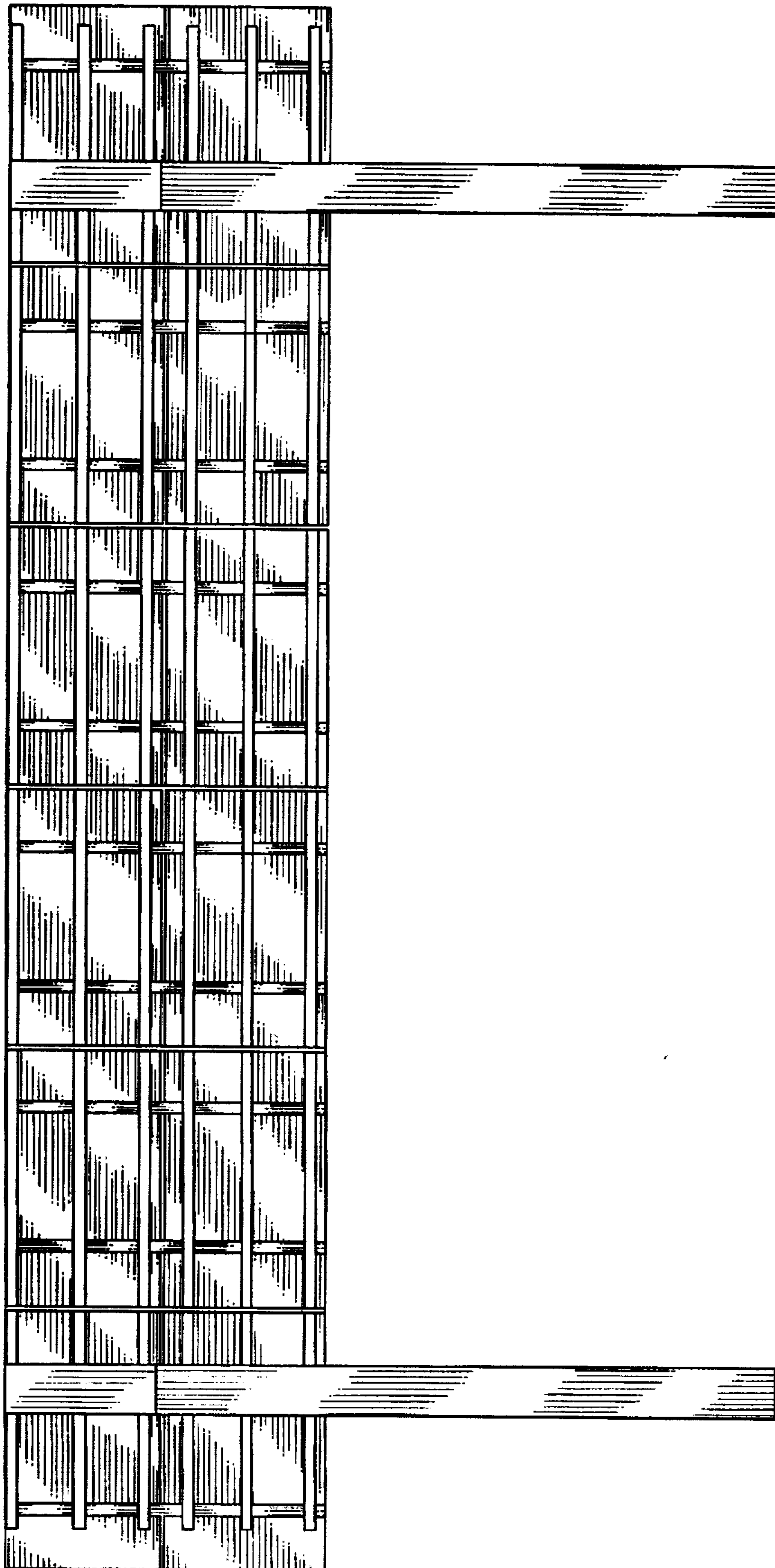

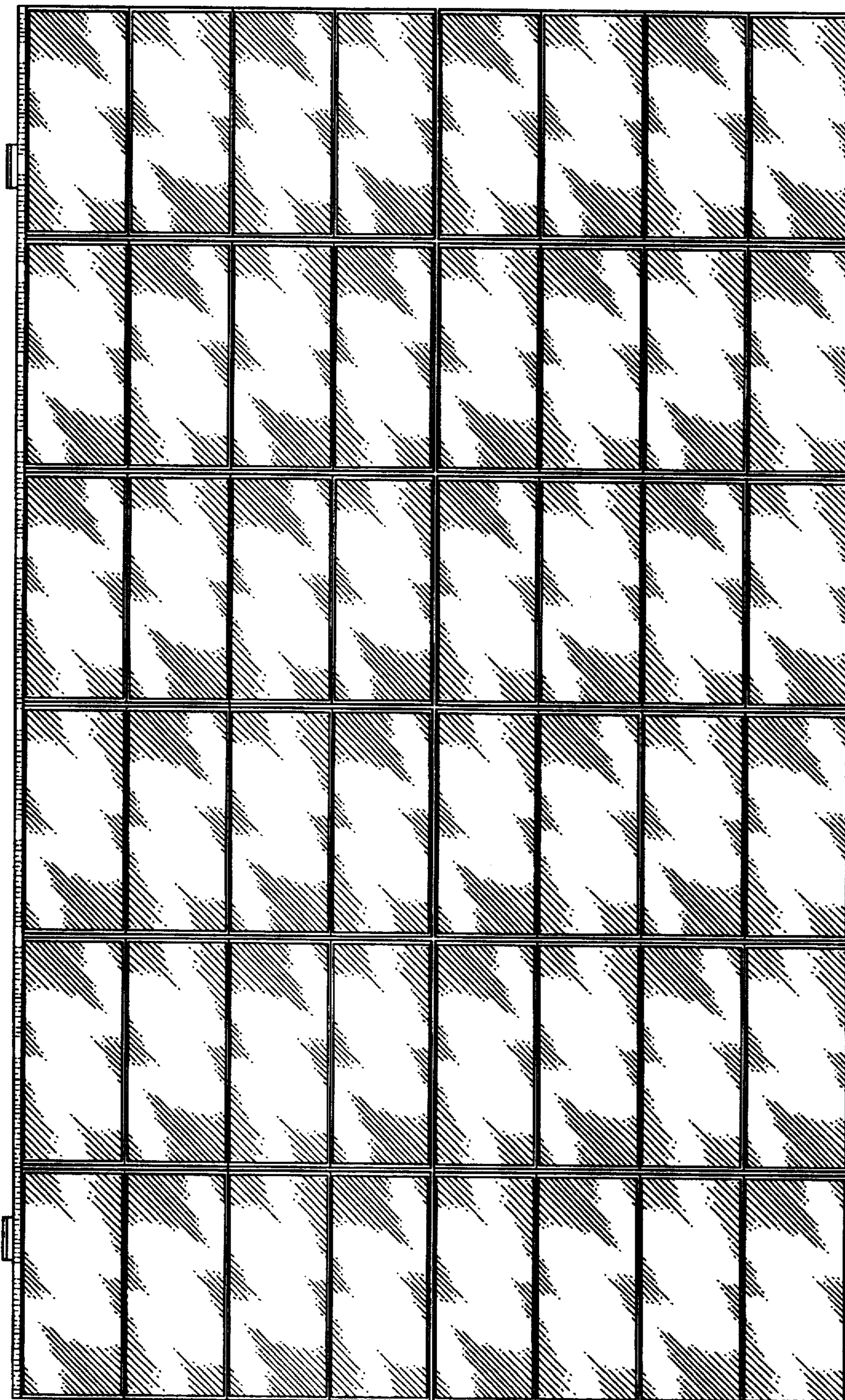

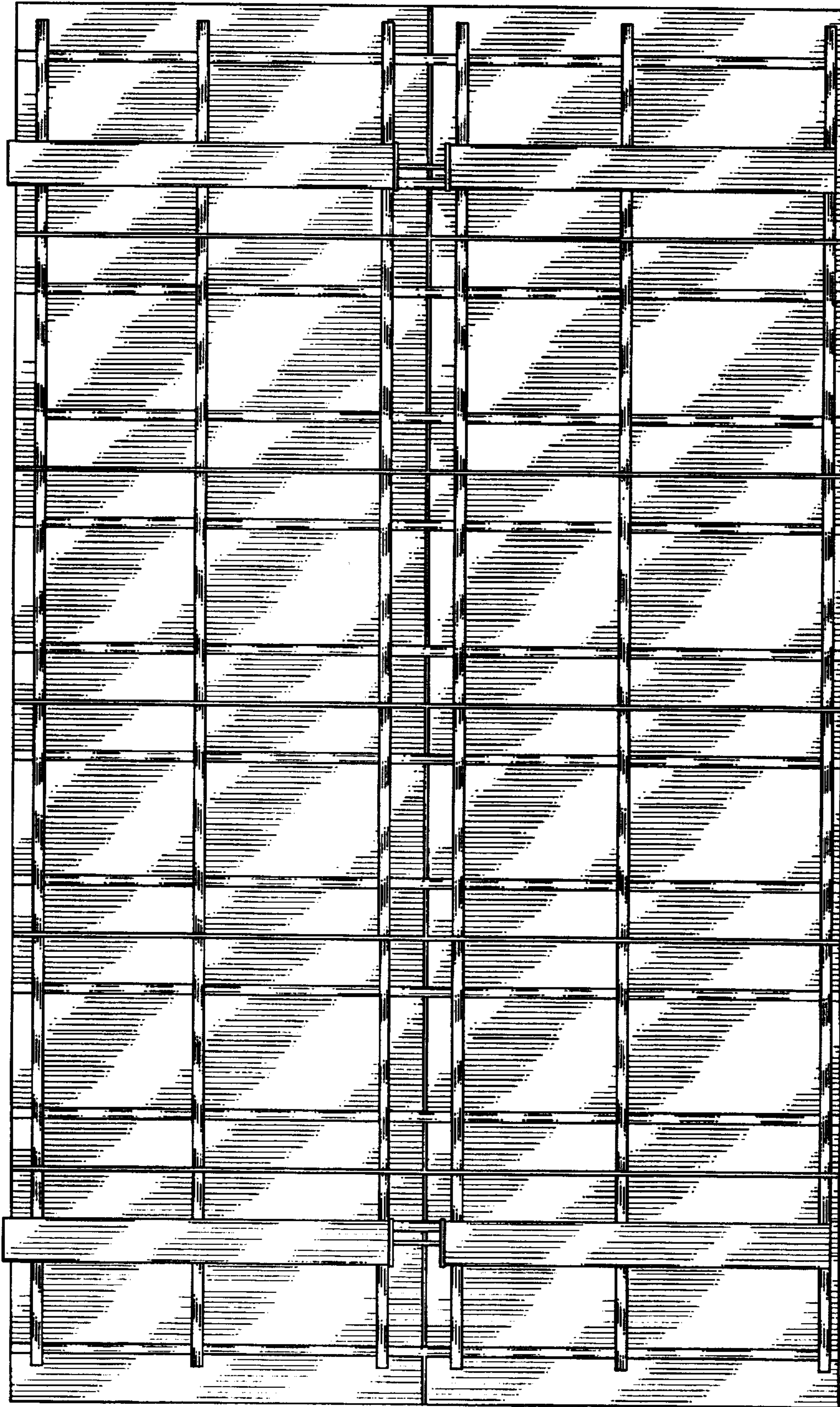

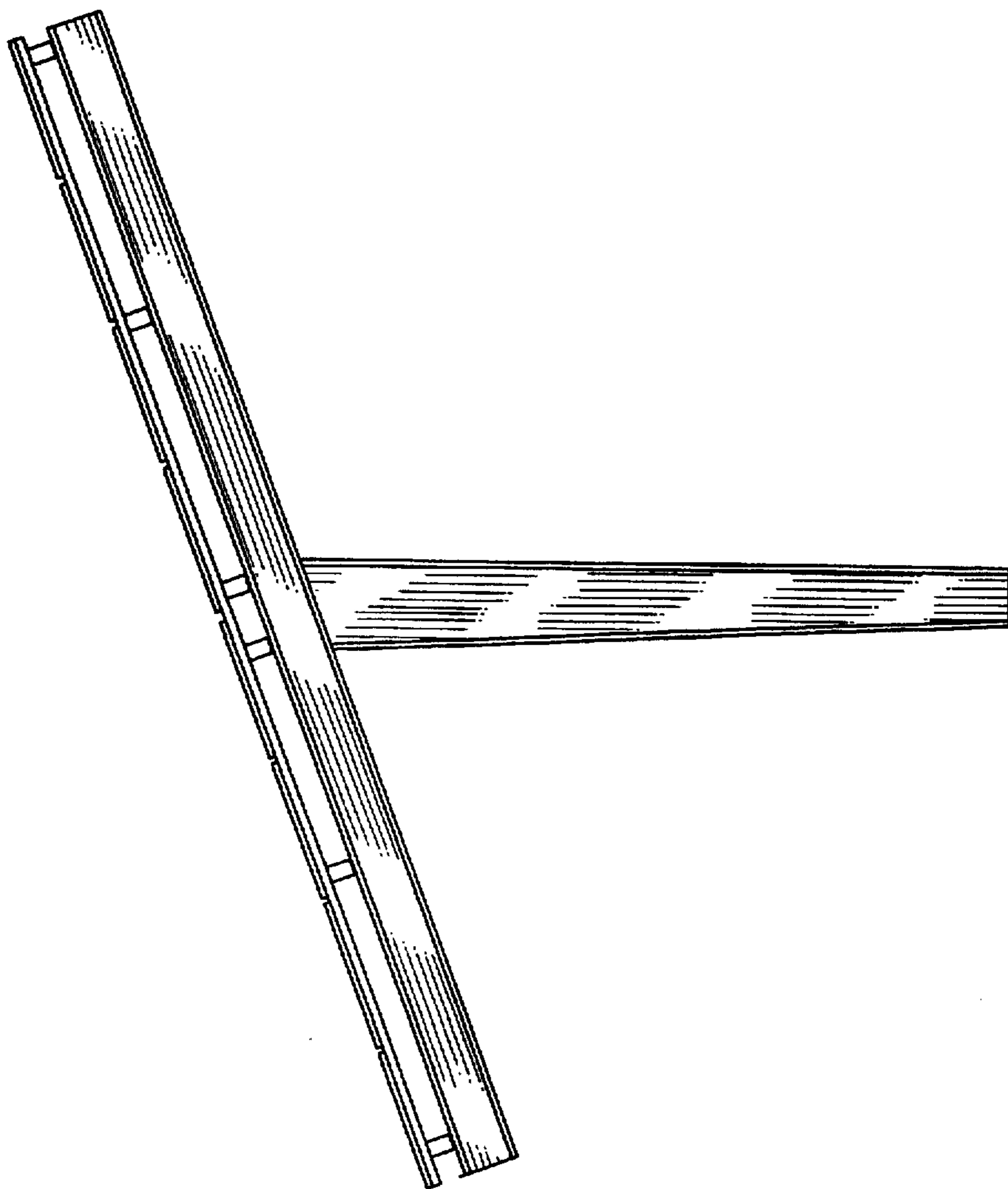
